The ornamental design for a golf training aid, as shown and described.

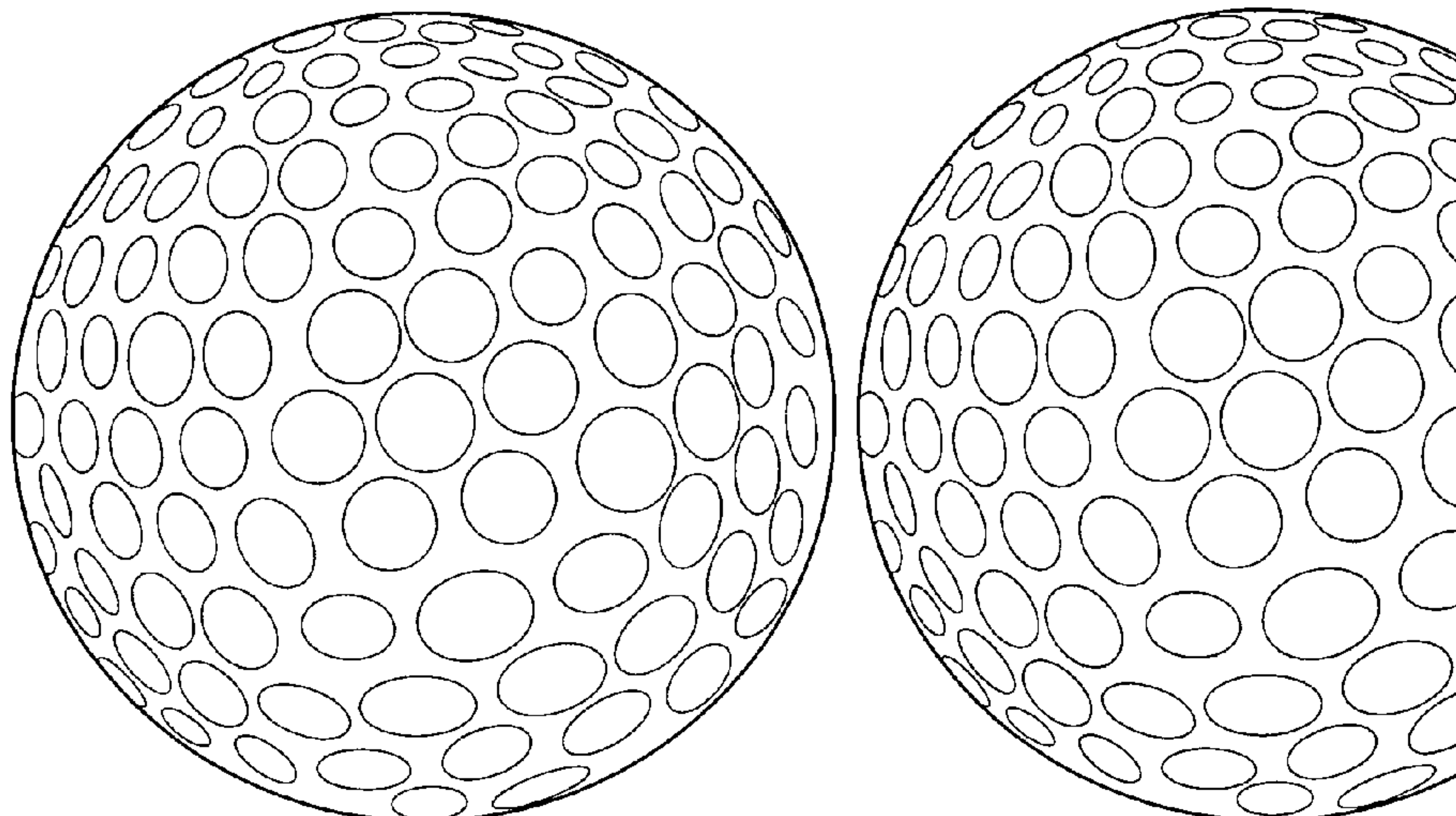
DESCRIPTION

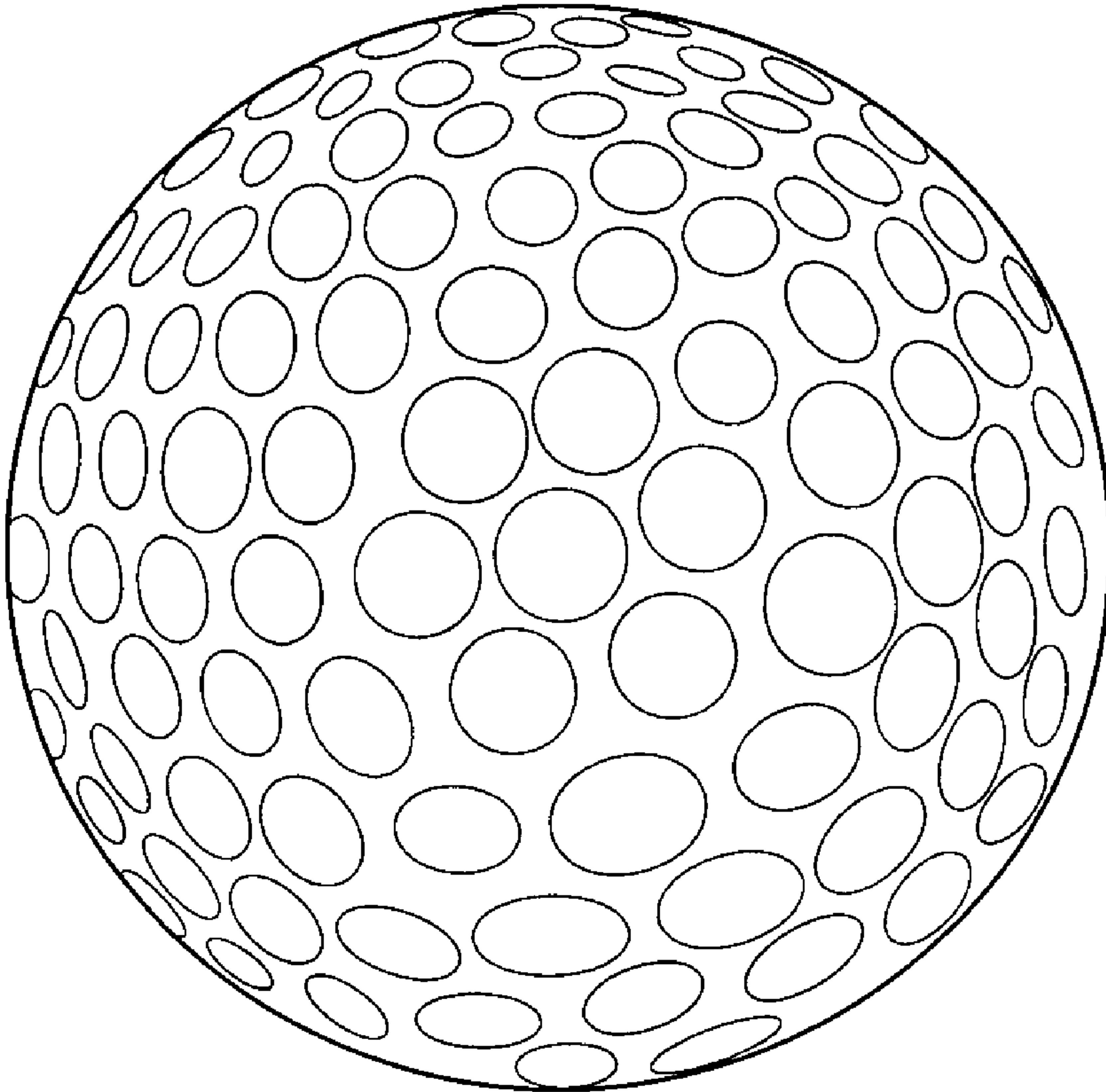

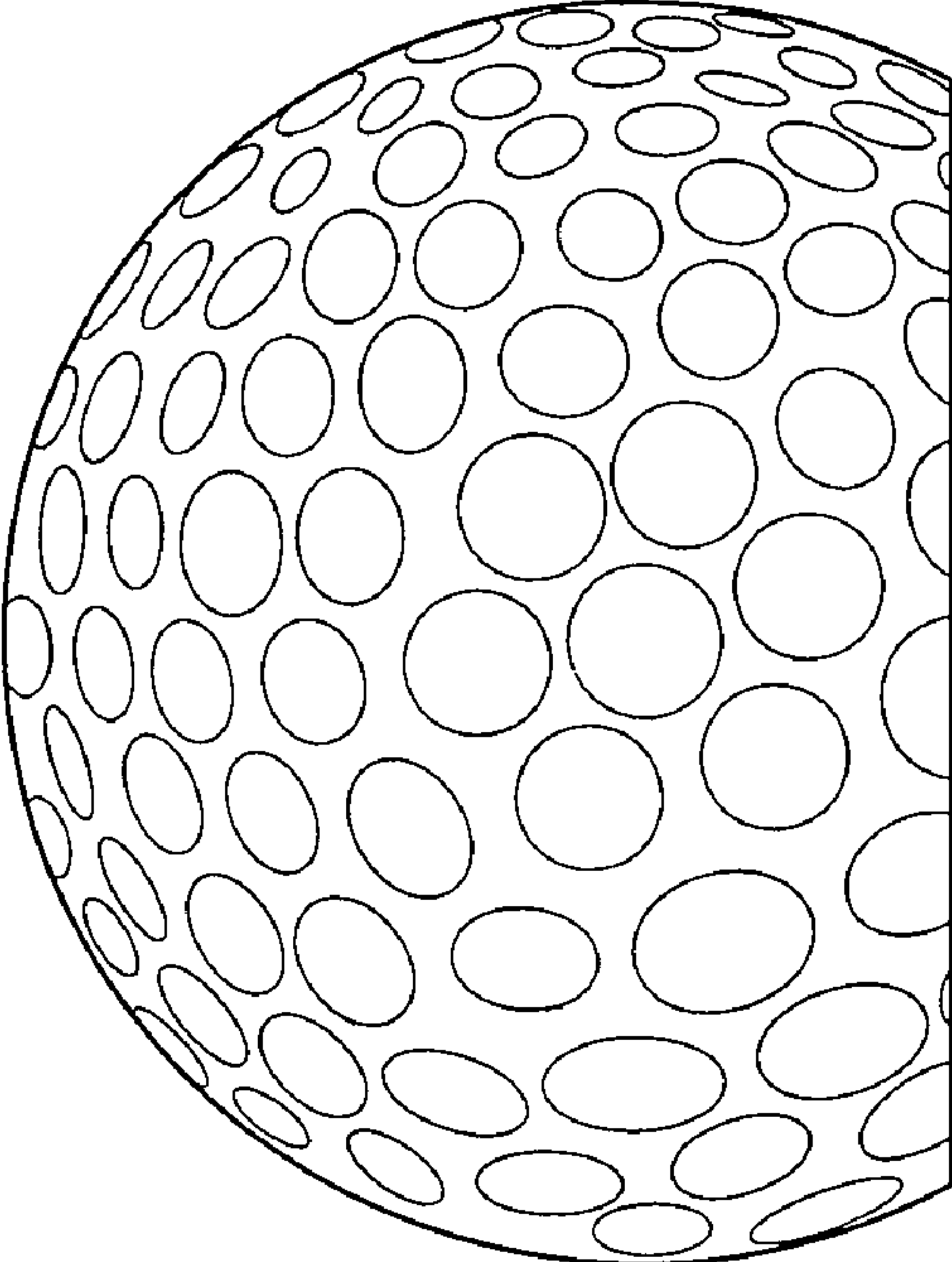

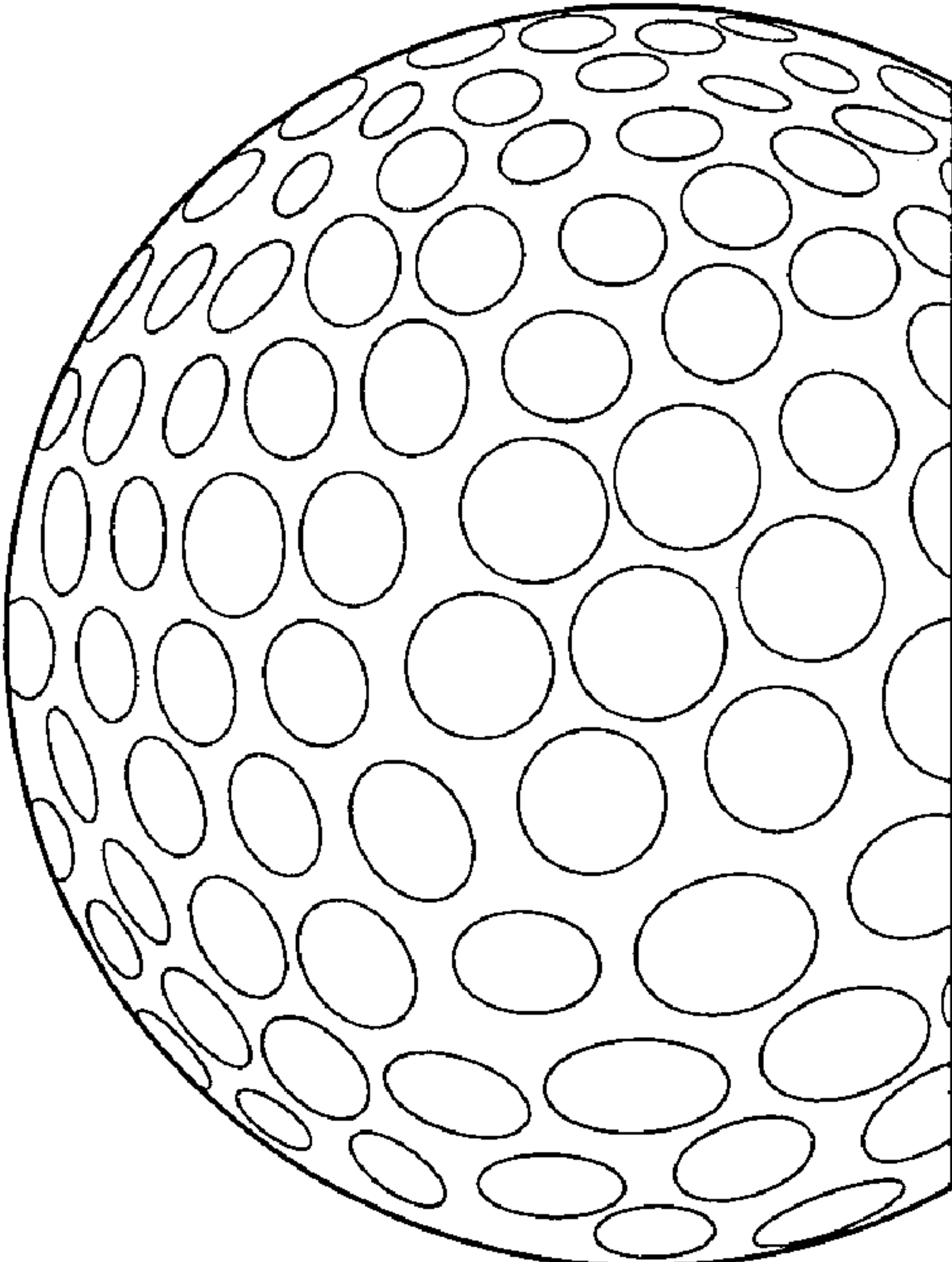
