(57) **CLAIM**

The ornamental design for a cabinet for a commercial aircraft passenger cabin lavatory, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view, taken from a front, right side, showing a cabinet for a commercial aircraft passenger cabin lavatory according to a first embodiment of our design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a right side elevation view thereof;

FIG. 4 is a left side elevation view thereof;

FIG. 5 is a perspective view, taken from a front, right side, showing a cabinet for a commercial aircraft passenger cabin lavatory according to a second embodiment of our design;

FIG. 6 is a front elevation view thereof;

FIG. 7 is a right side elevation view thereof;

FIG. 8 is a left side elevation view thereof;

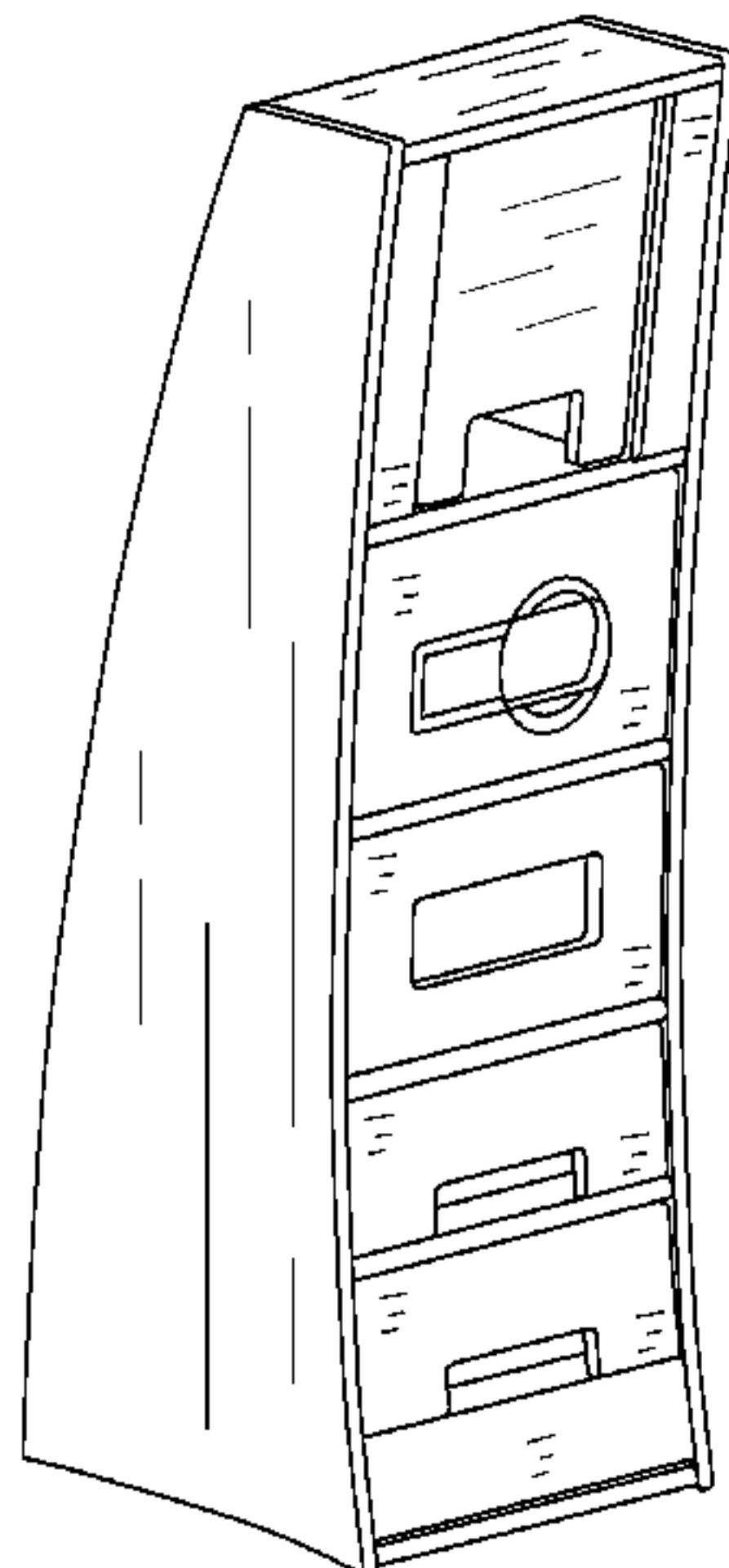
FIG. 9 is a perspective view, taken from a front, right side, showing a cabinet for a commercial aircraft passenger cabin lavatory according to a third embodiment of our design;

FIG. 10 is a right side elevation view thereof, a left side elevation view being a mirror image thereof;

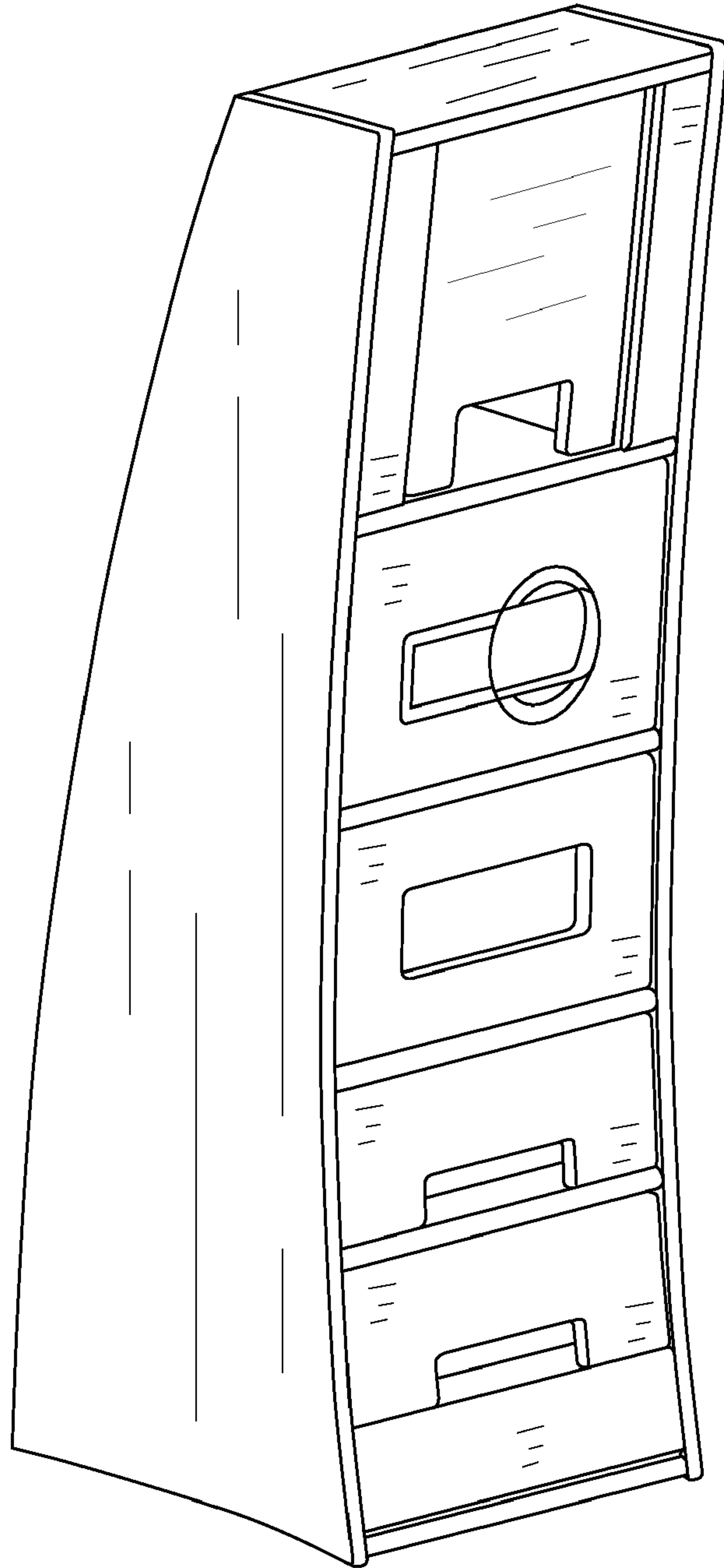

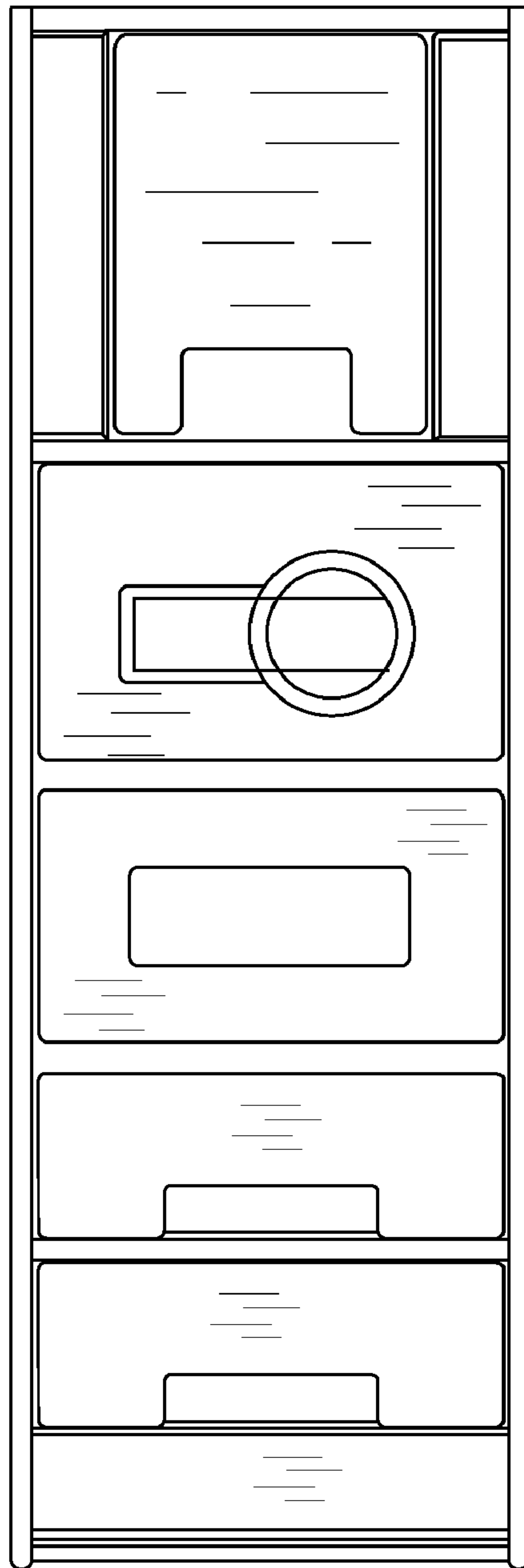

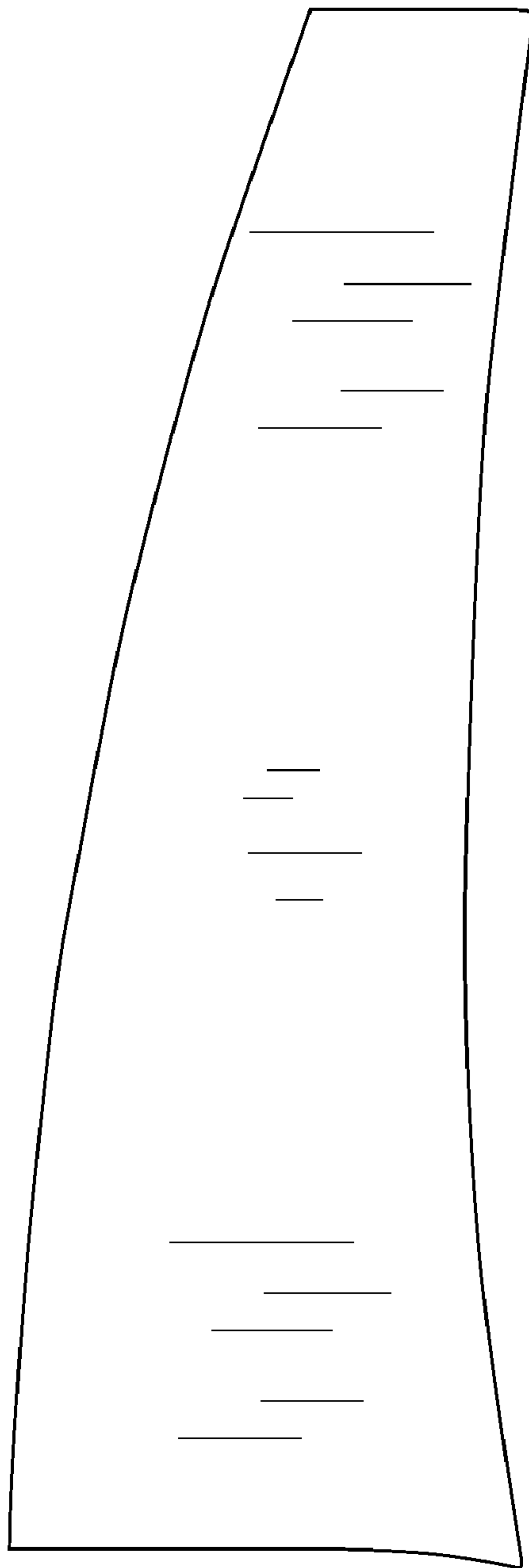

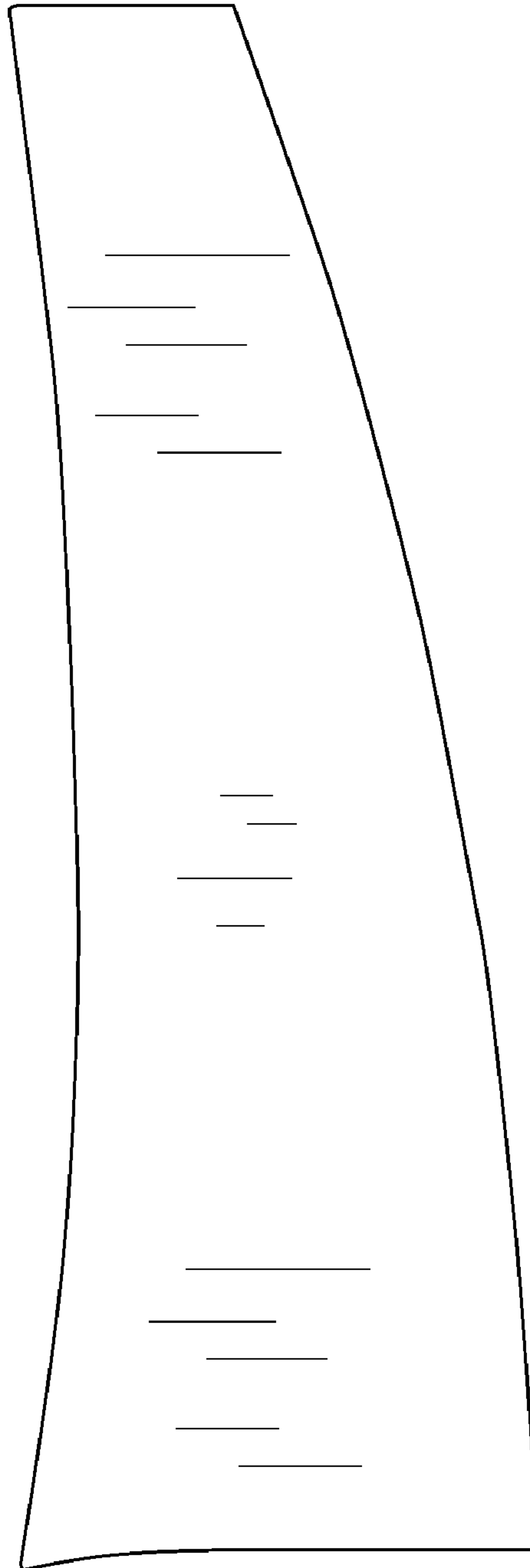

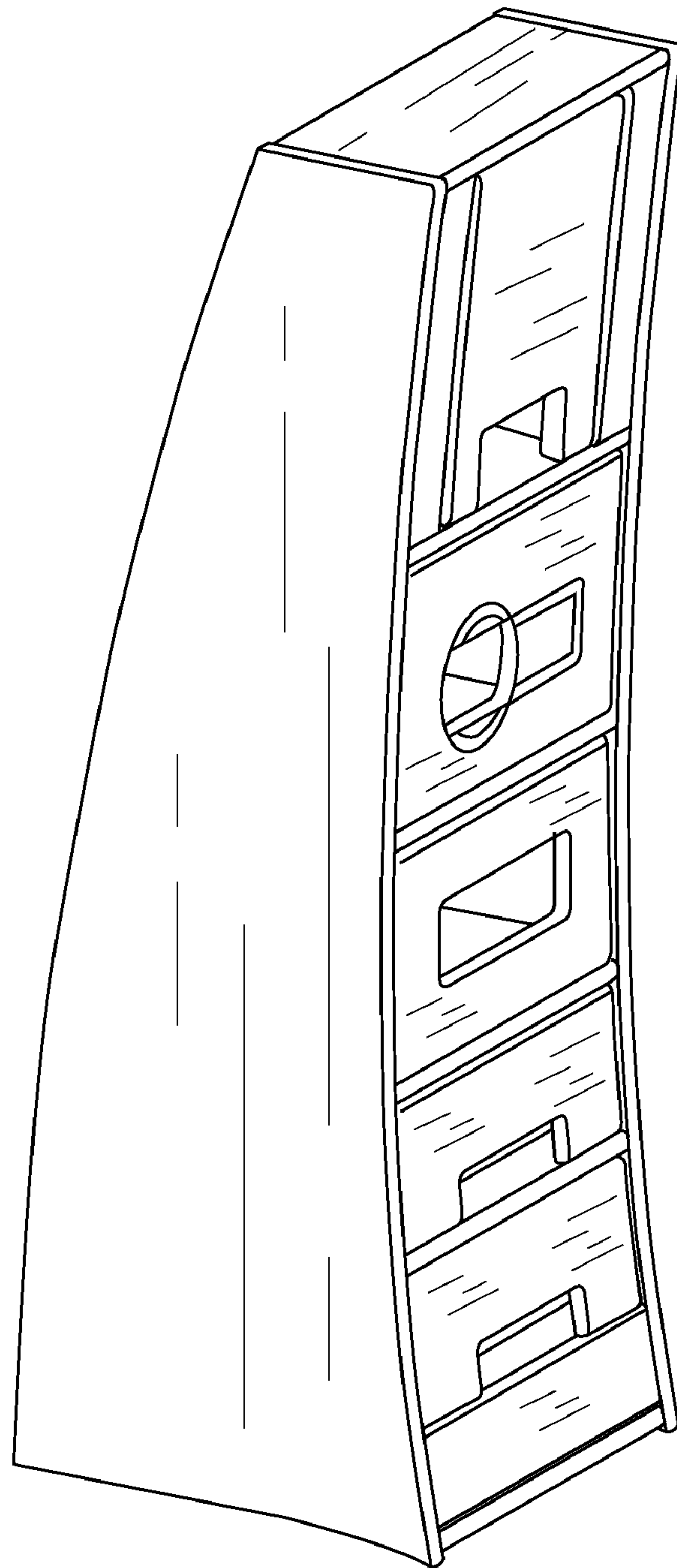

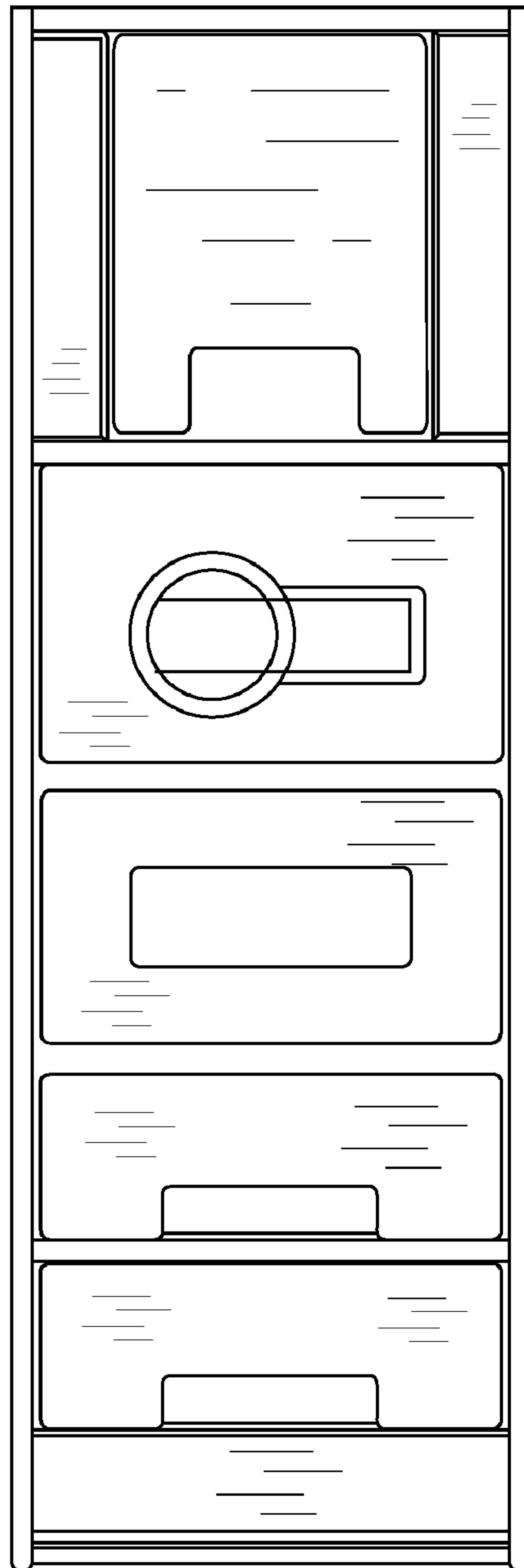

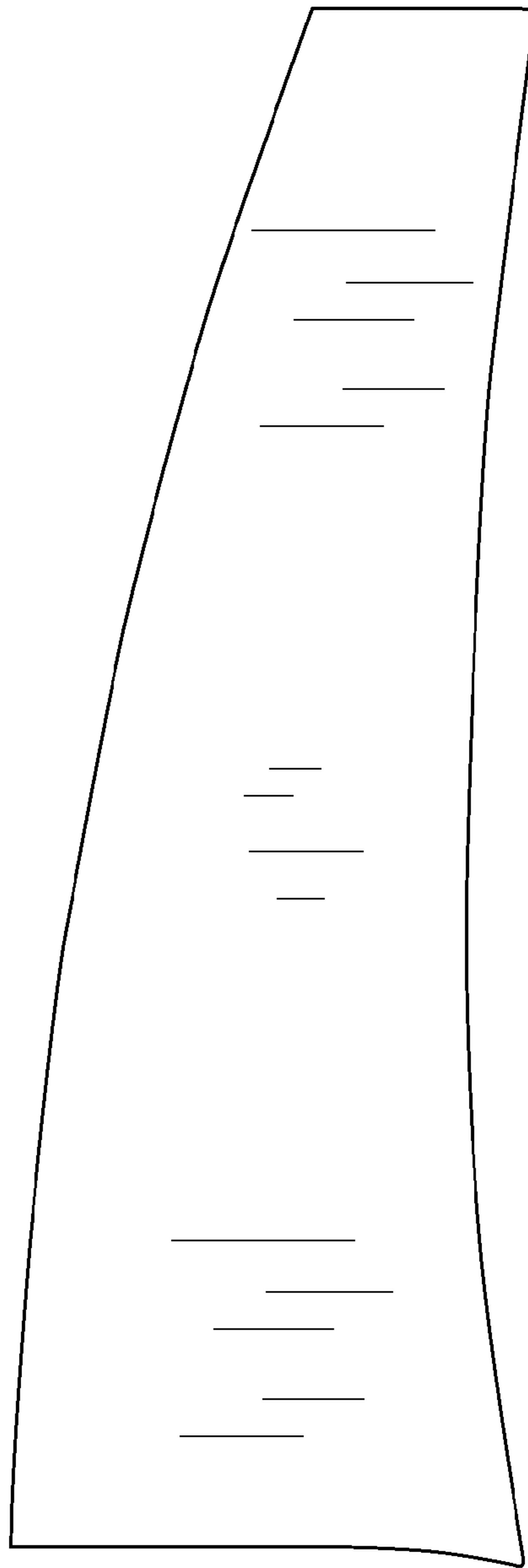

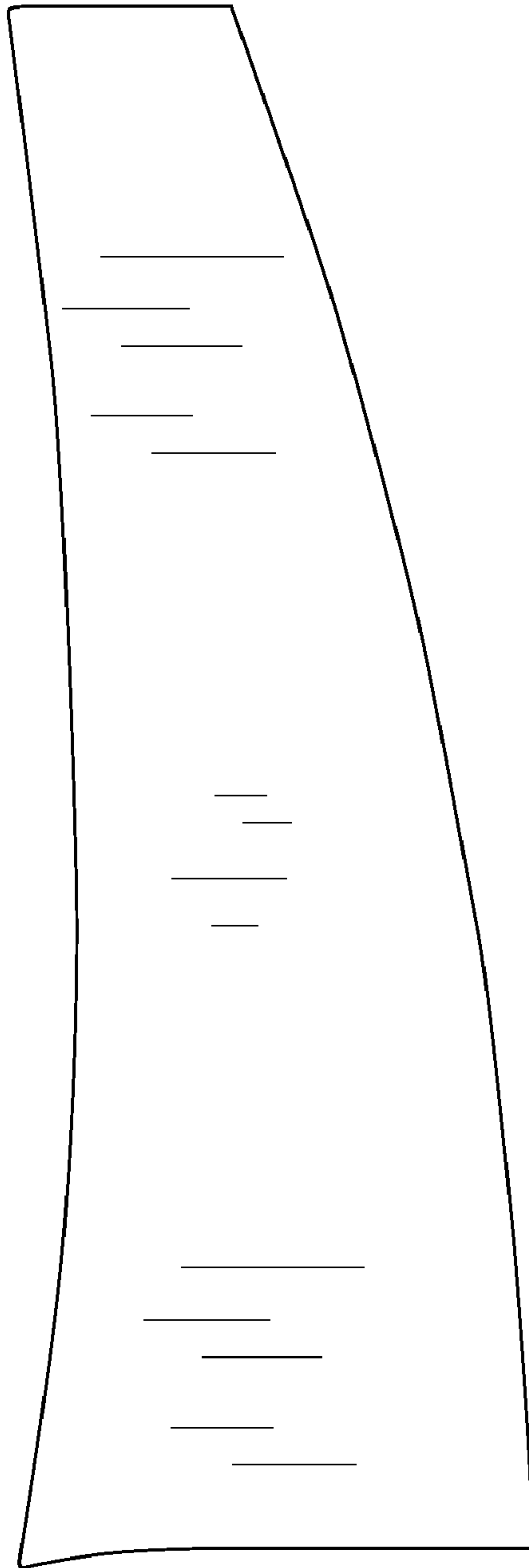

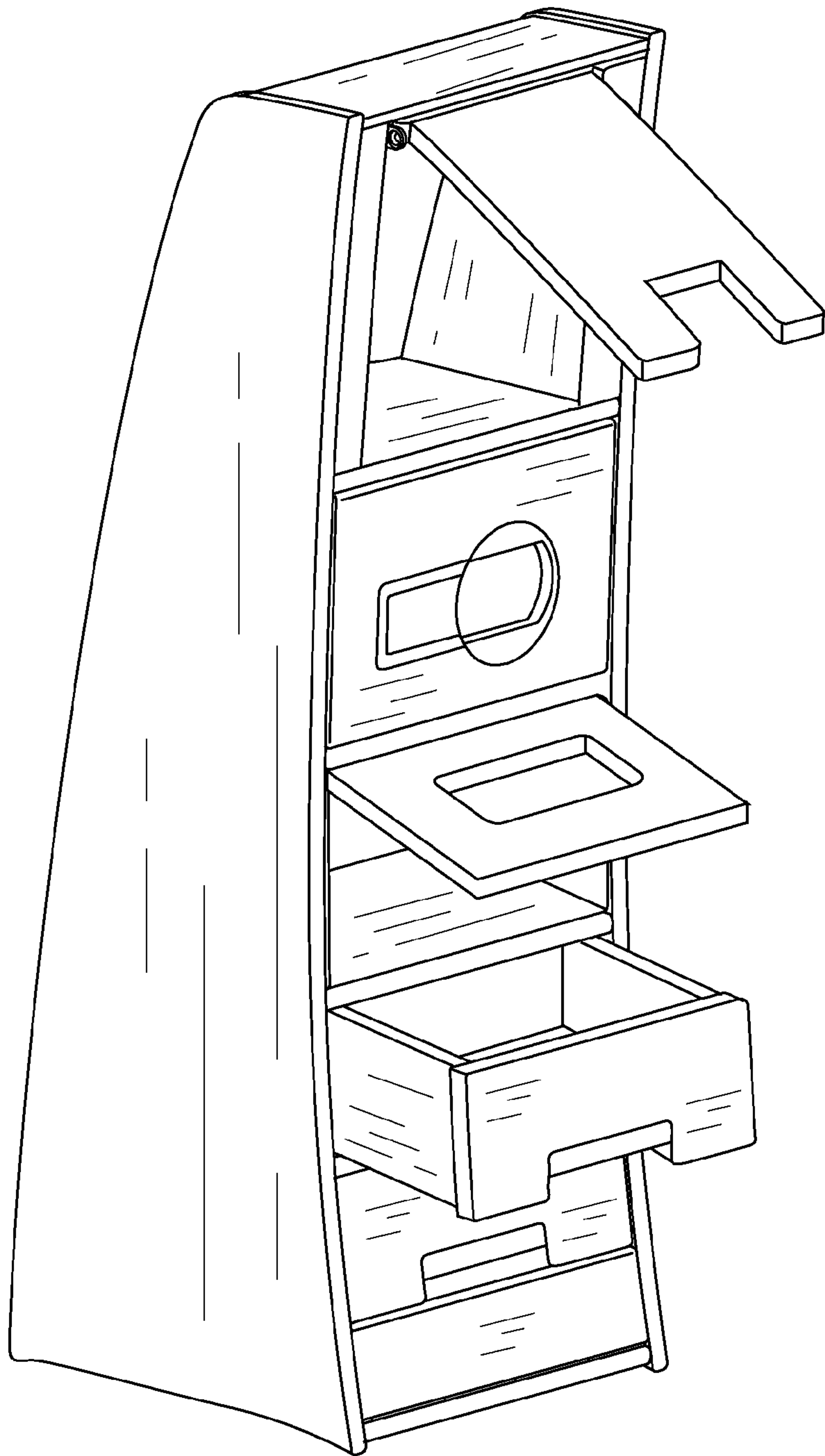




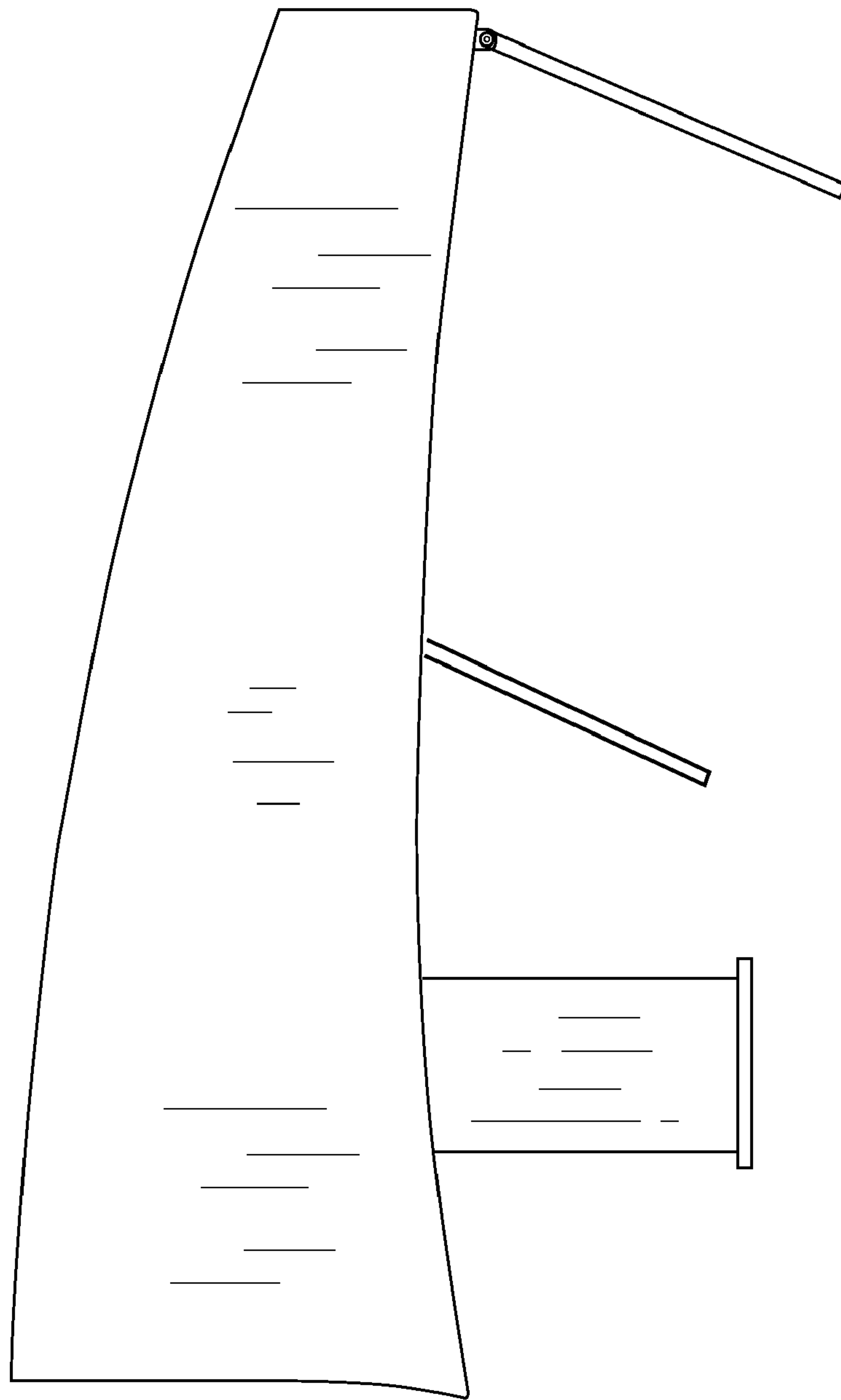

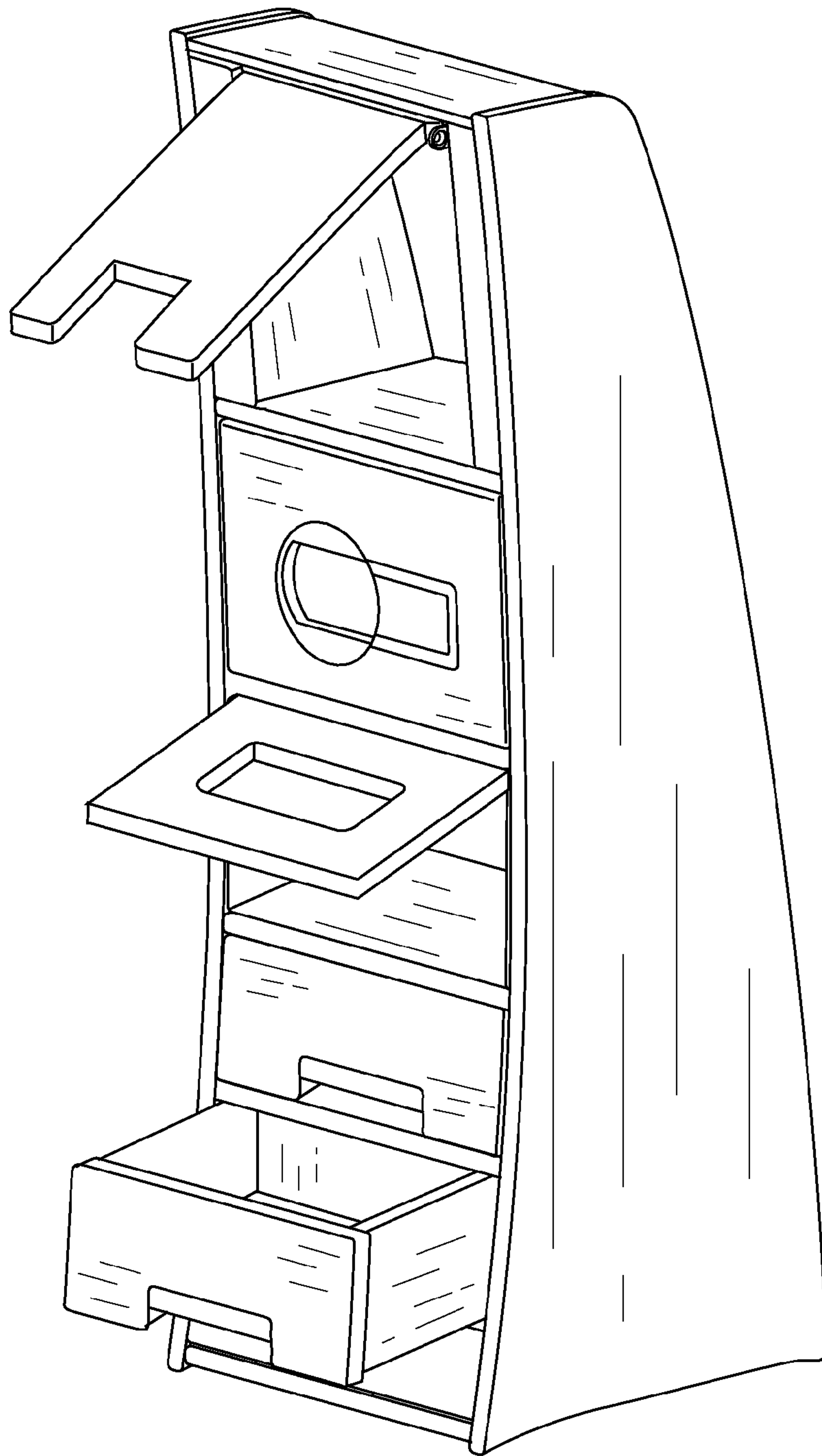

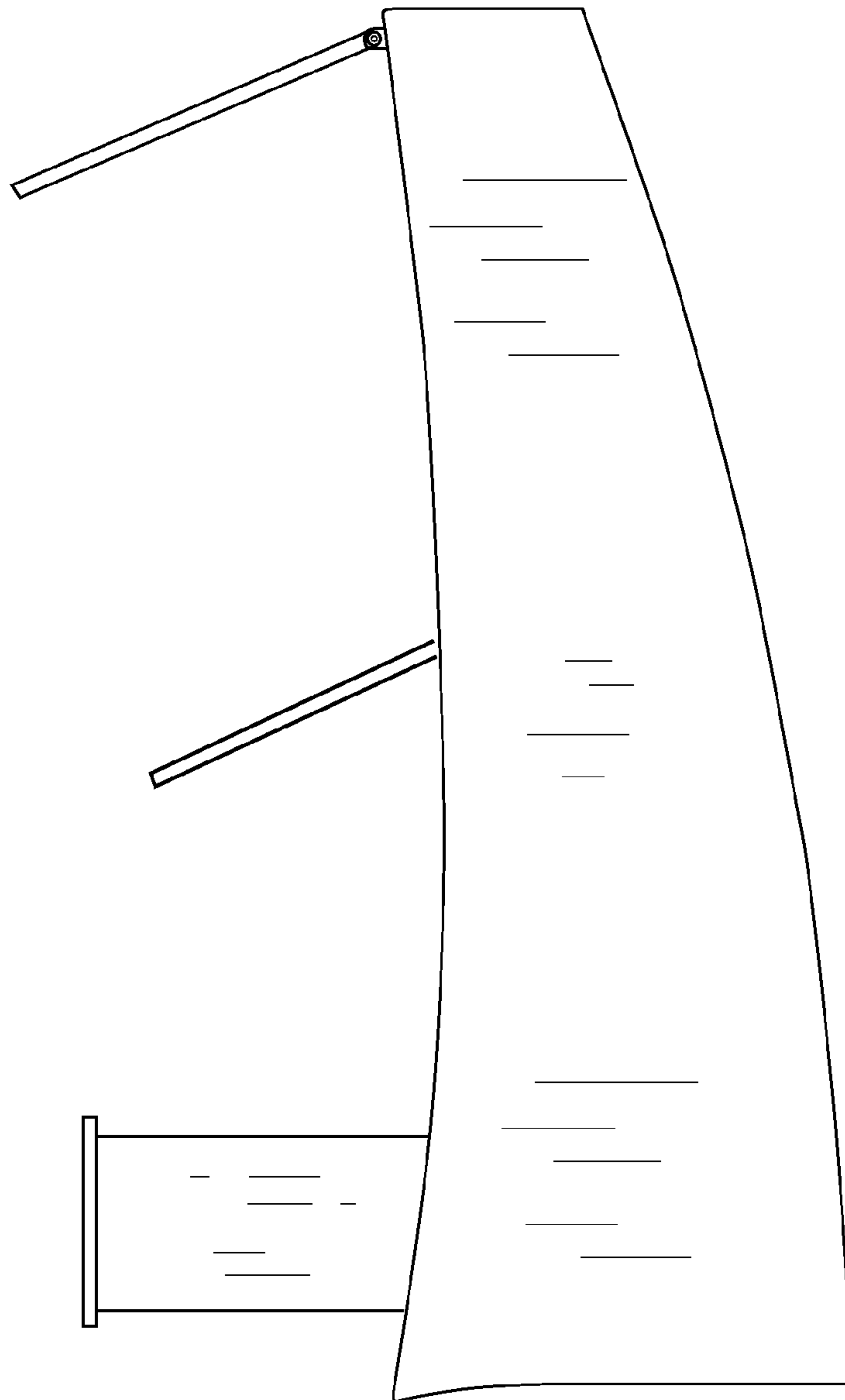
