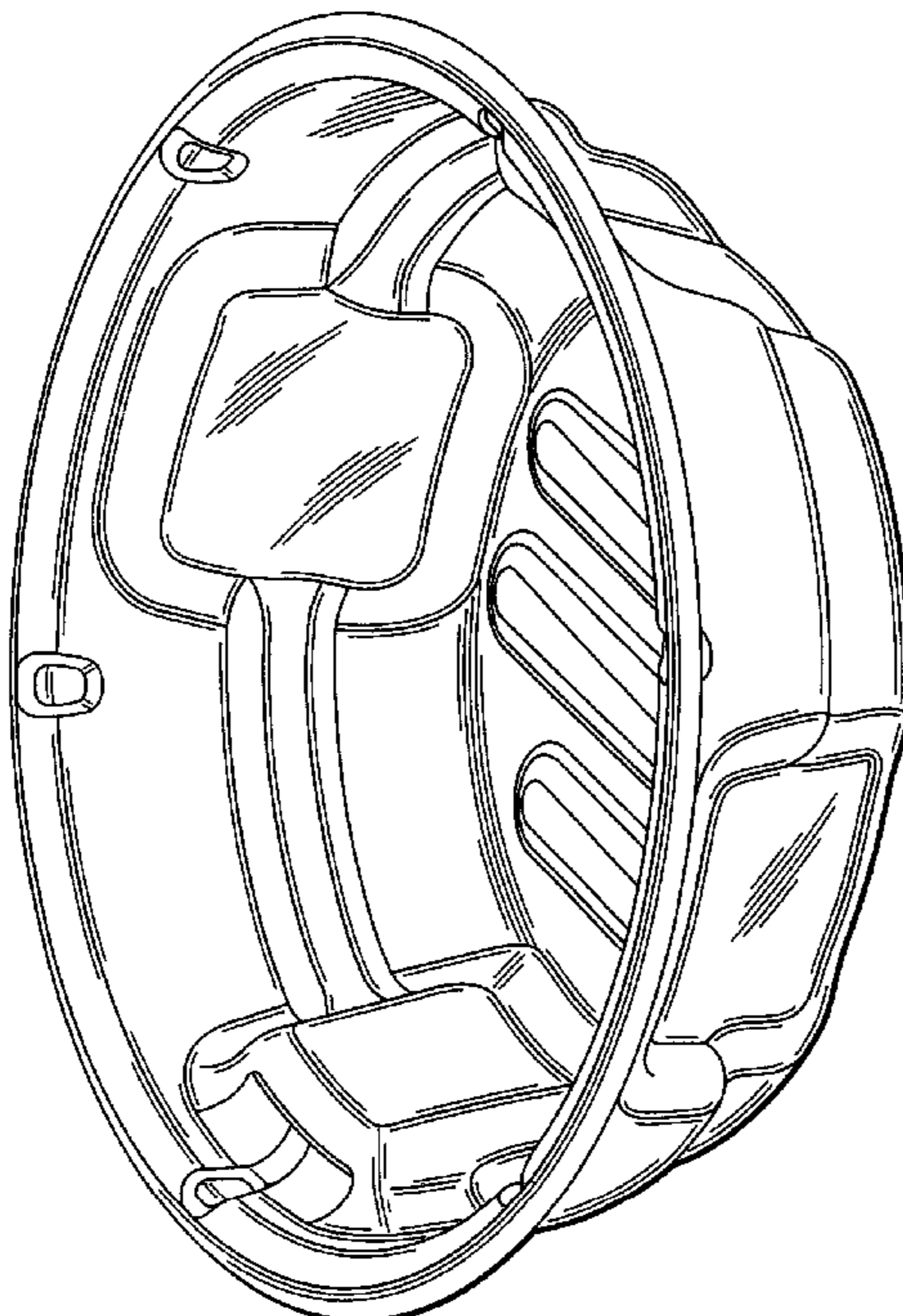

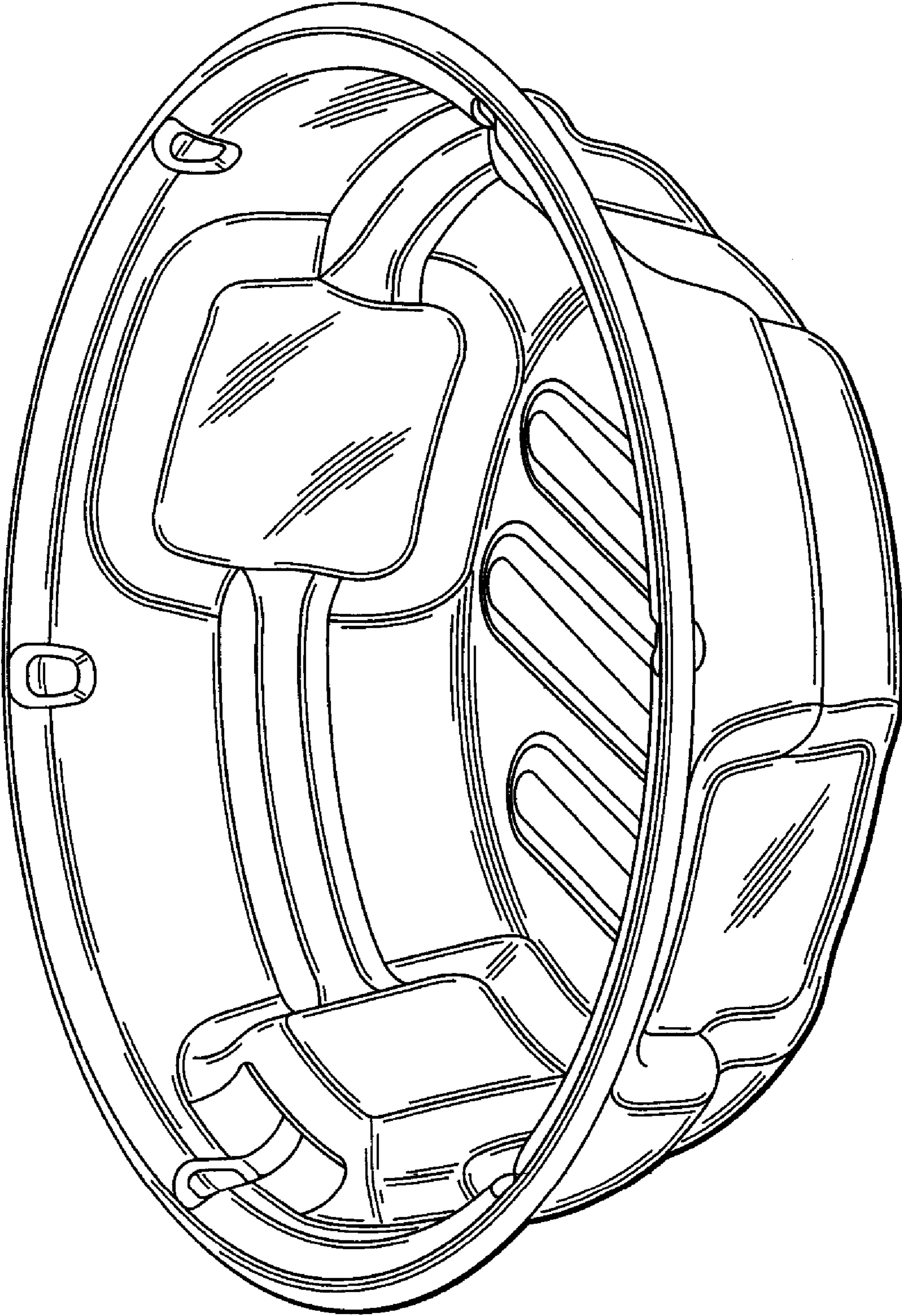
The ornamental design for a disposable bowl, as shown and described.

**DESCRIPTION**

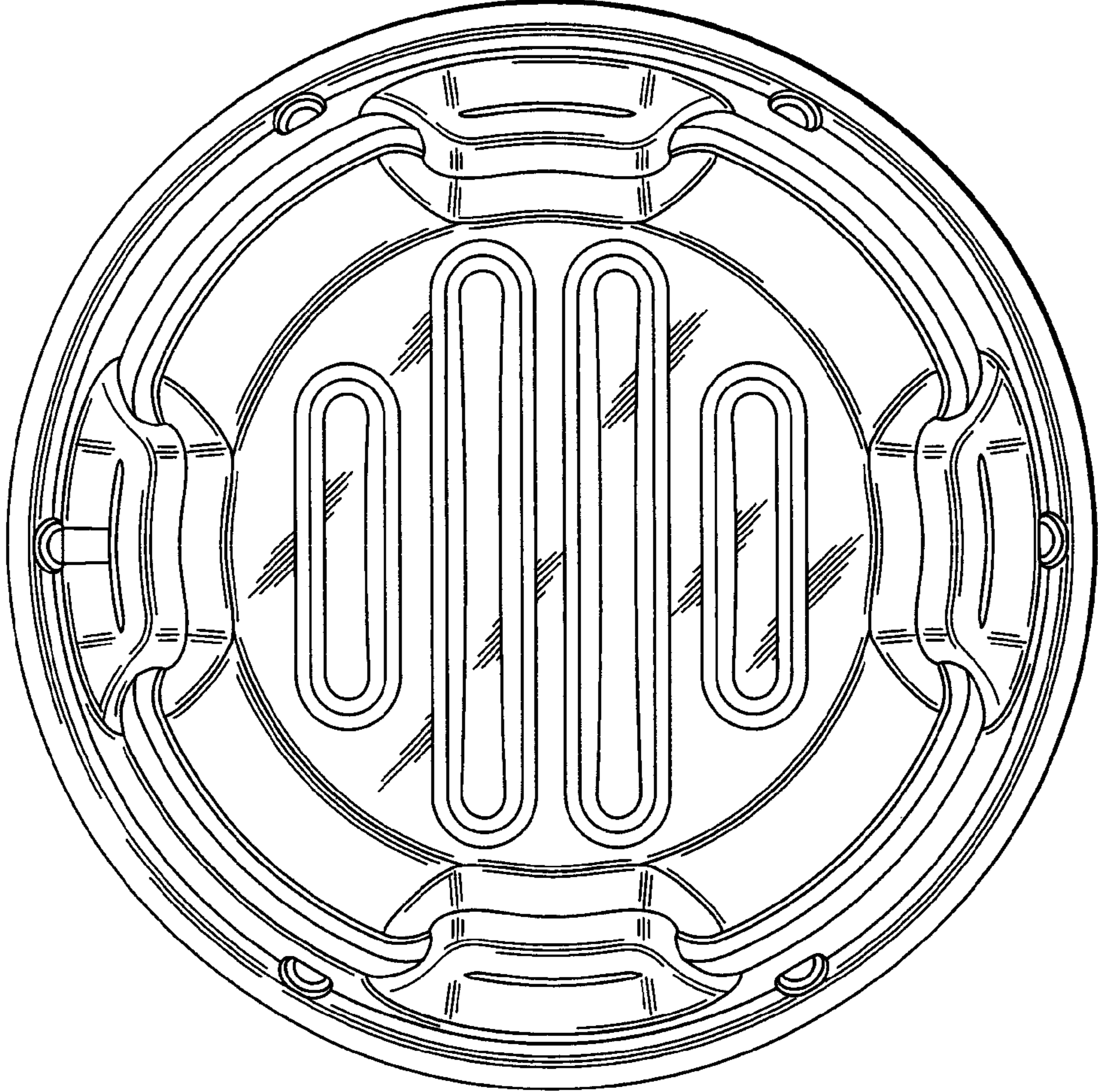
FIG. 1 is a perspective view;

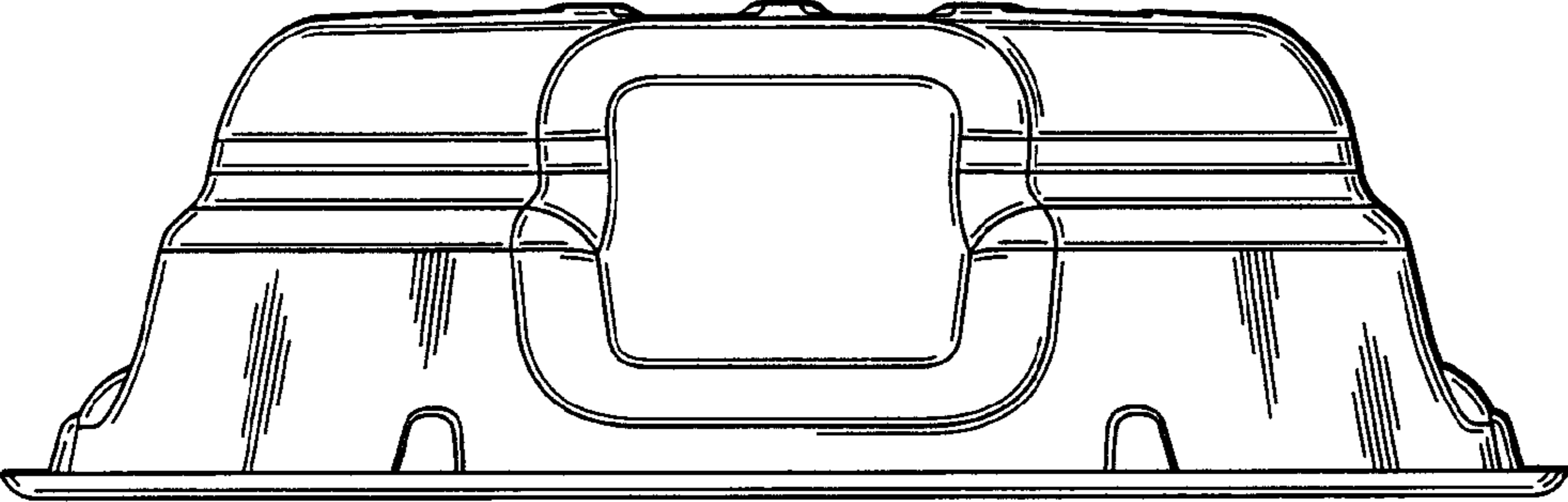
