FIG. 4 is a side elevation thereof;

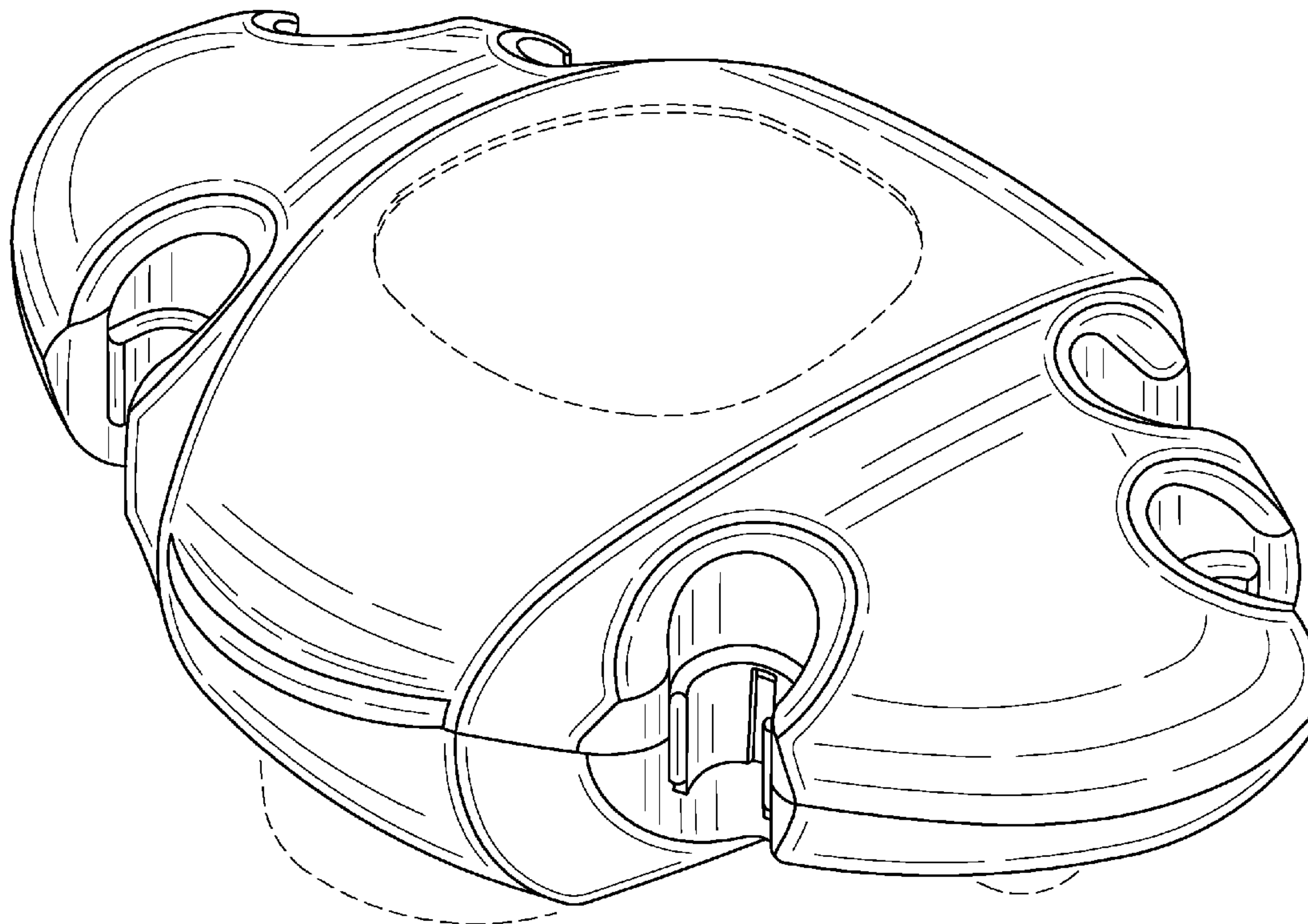
FIG. 5 is a top plan view thereof;

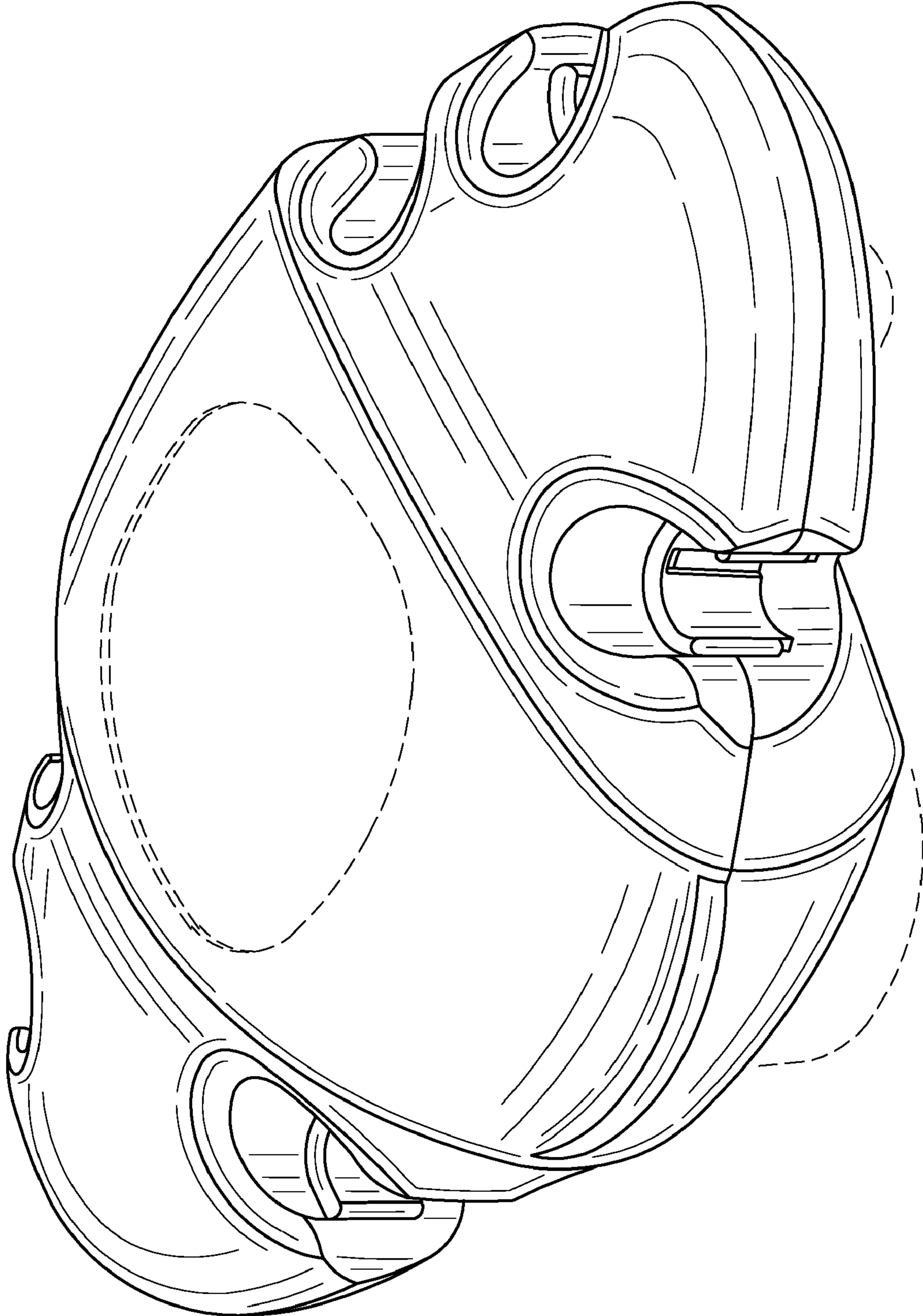

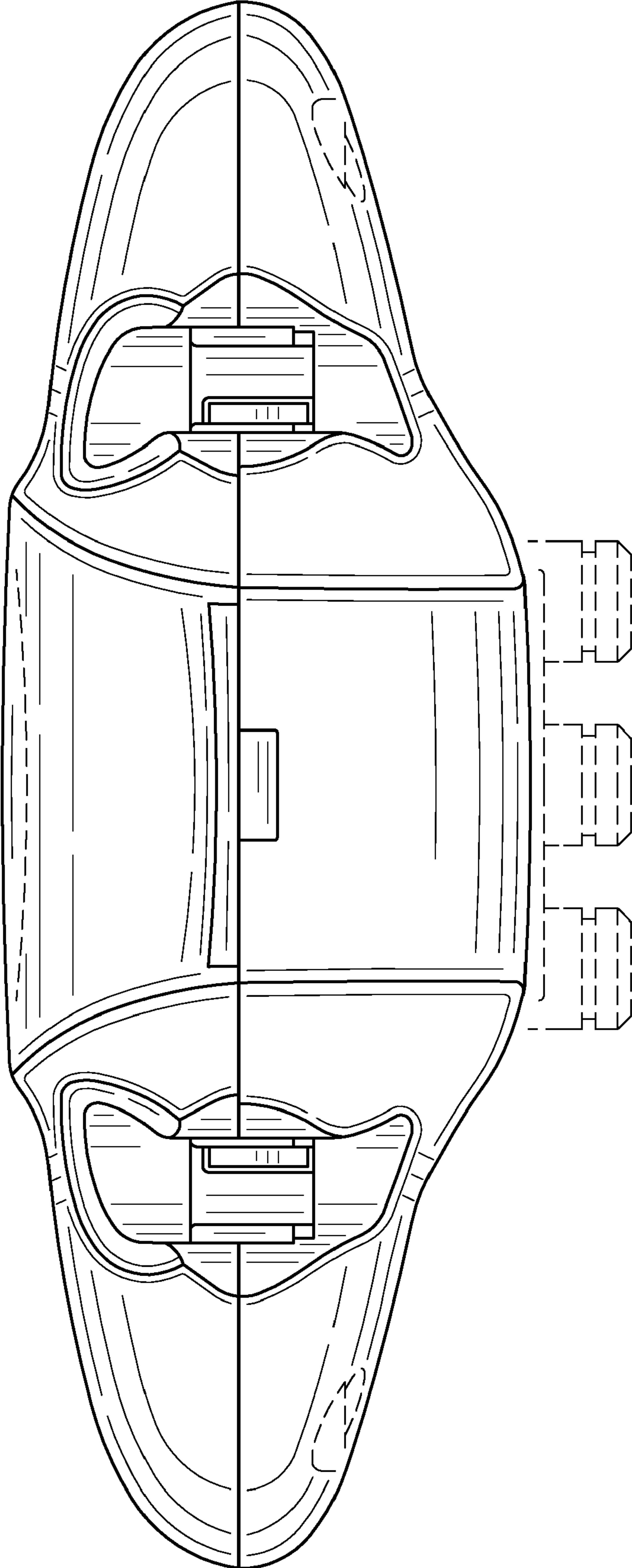

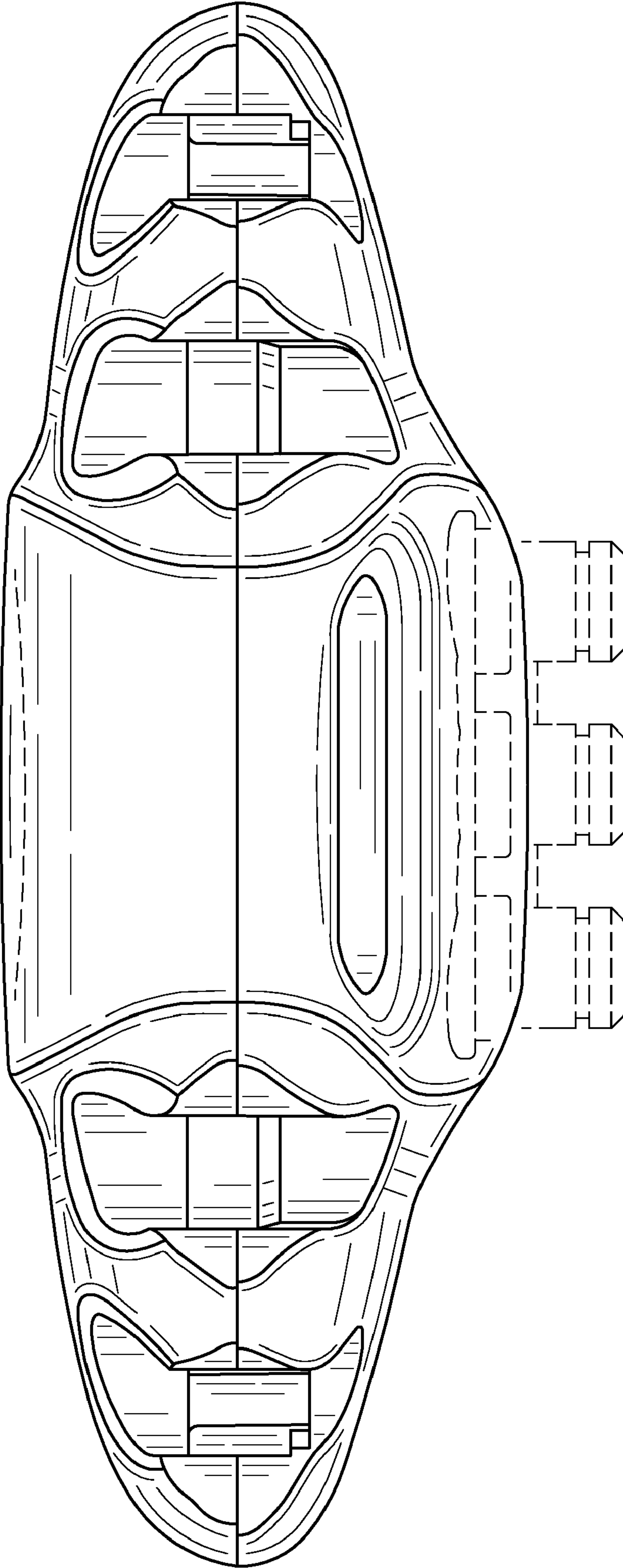

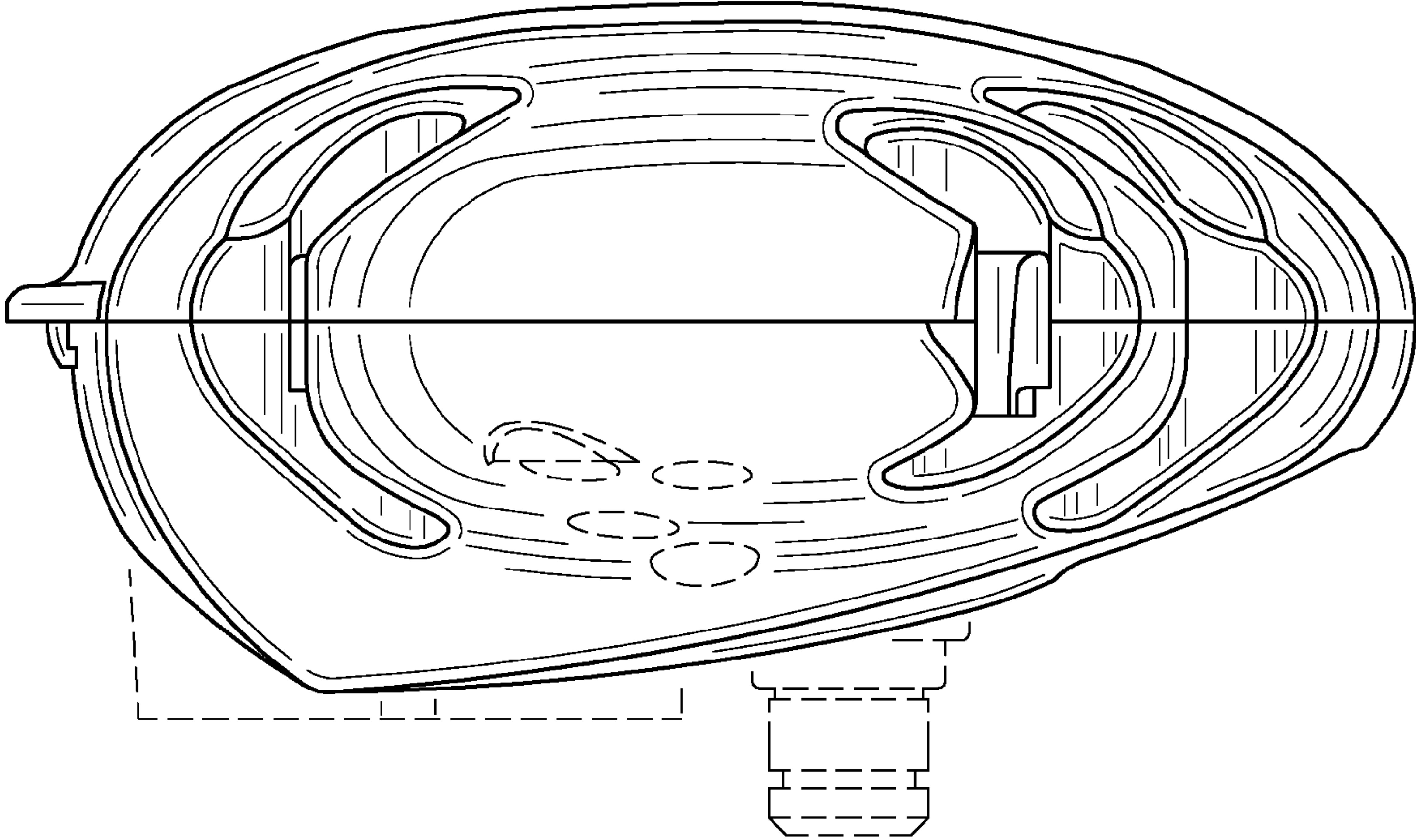

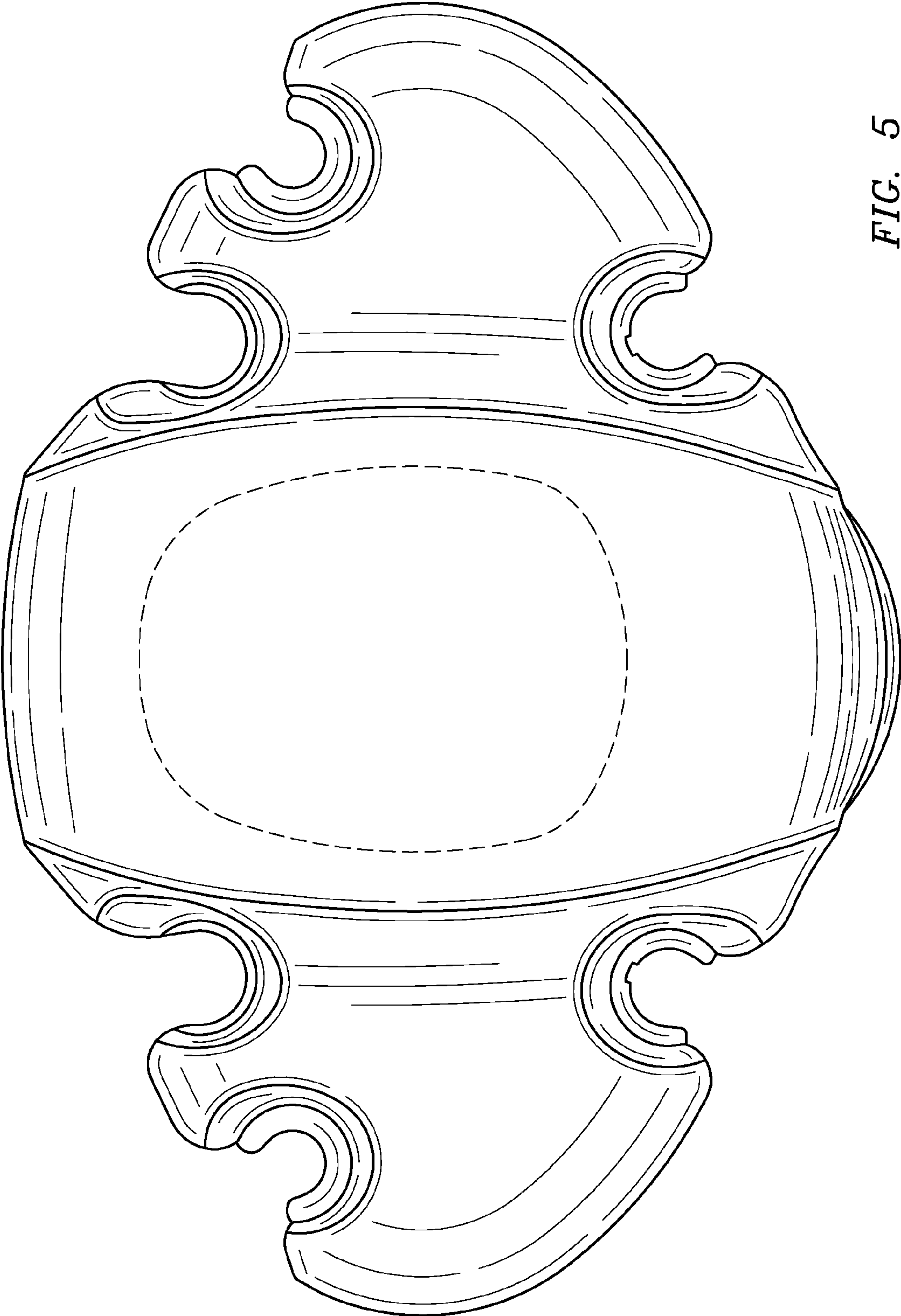

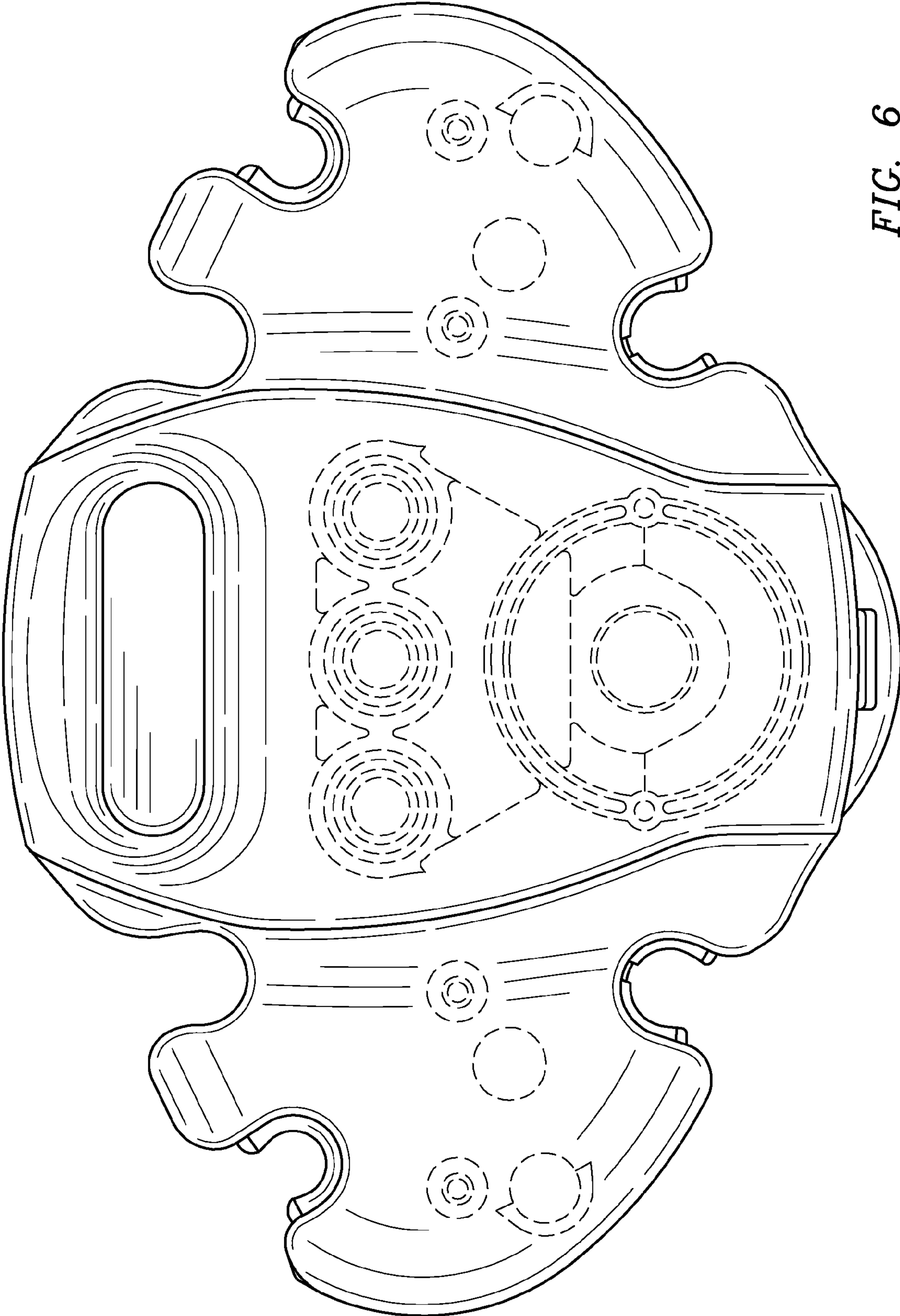
