(57) **CLAIM**

The ornamental design for a load carrying element for a building facing, as shown and described.

**DESCRIPTION**

FIG. 1 is a first embodiment of the load carrying element for a building facing;

FIG. 2 is a Second embodiment of the load carrying element for a building facing;

FIG. 3 is a third embodiment of the load carrying element for a building facing;

FIG. 4 is a fourth embodiment of the load carrying element for a building facing;

FIG. 5 is a perspective view of a first embodiment with structure shown in broken lines to illustrate the environment in use, the broken lines not constituting subject matter of the claimed design; and

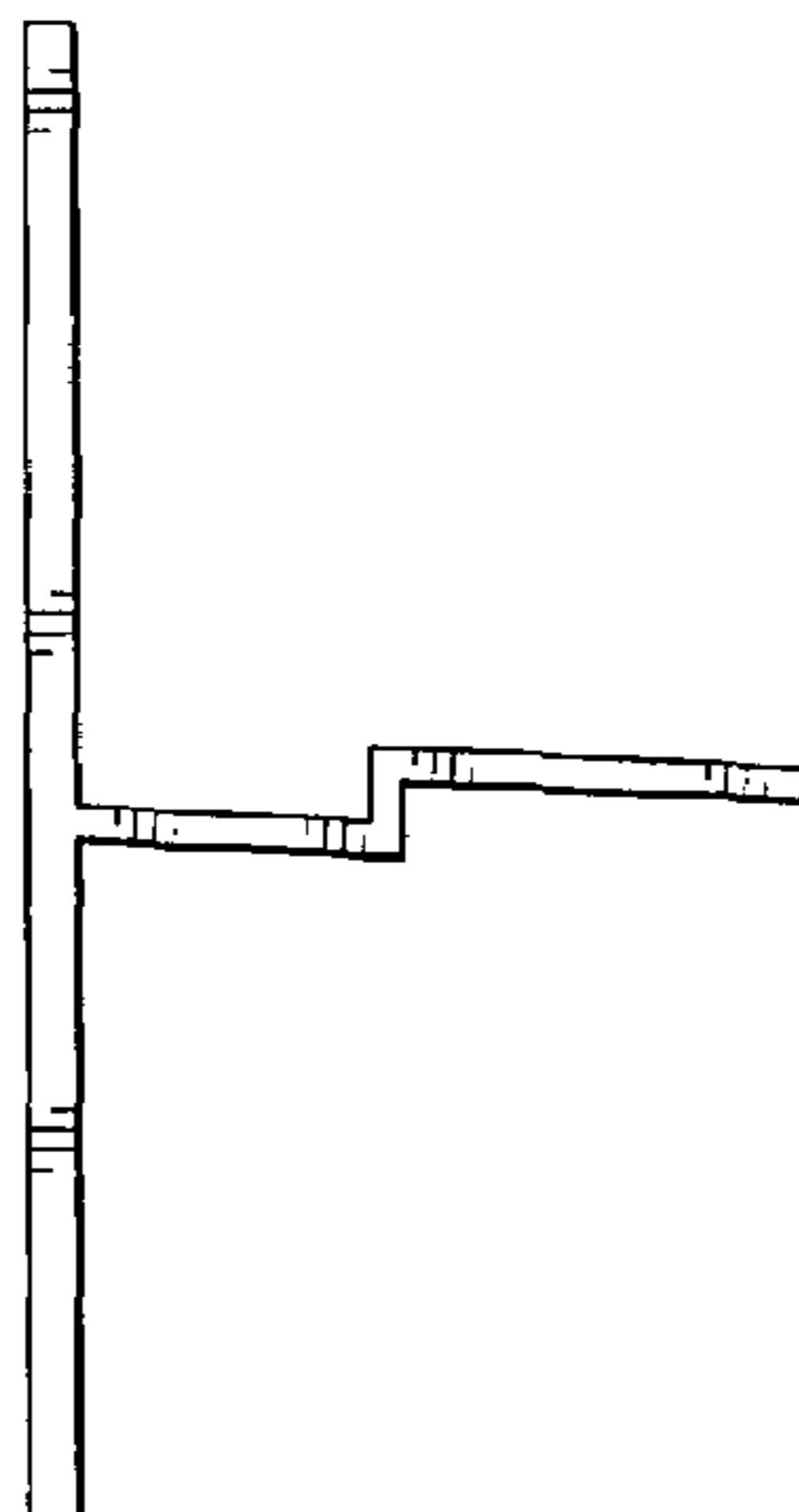
FIG. 6 is a perspective view of a second embodiment with structure shown in broken lines to illustrate the environment in use, the broken lines not constituting subject matter of the claimed design.

FIG. 8 is a perspective view of a fourth embodiment with structure shown in broken lines to illustrate the environment in use, the broken lines not constituting subject matter of the claimed design.

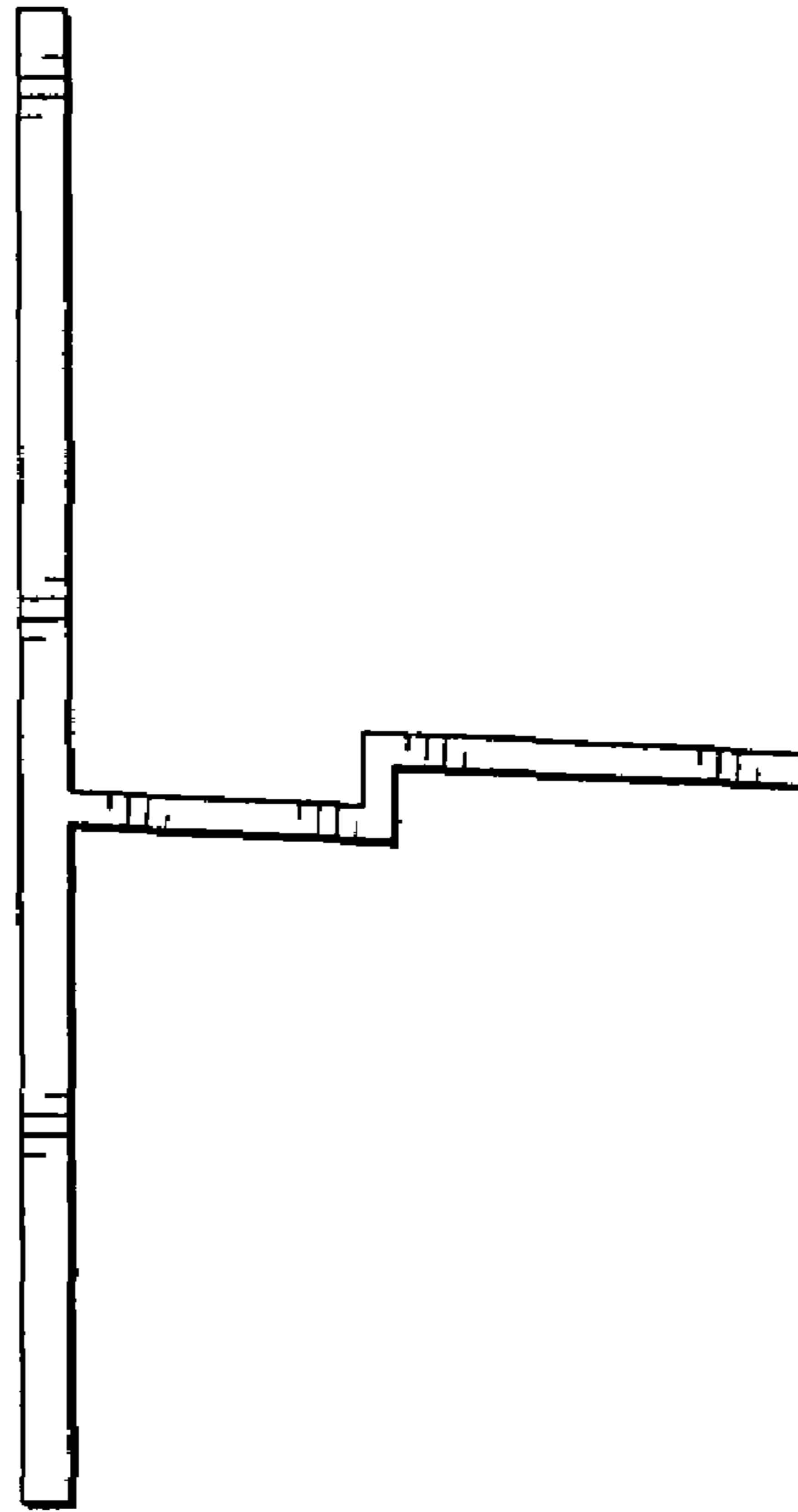

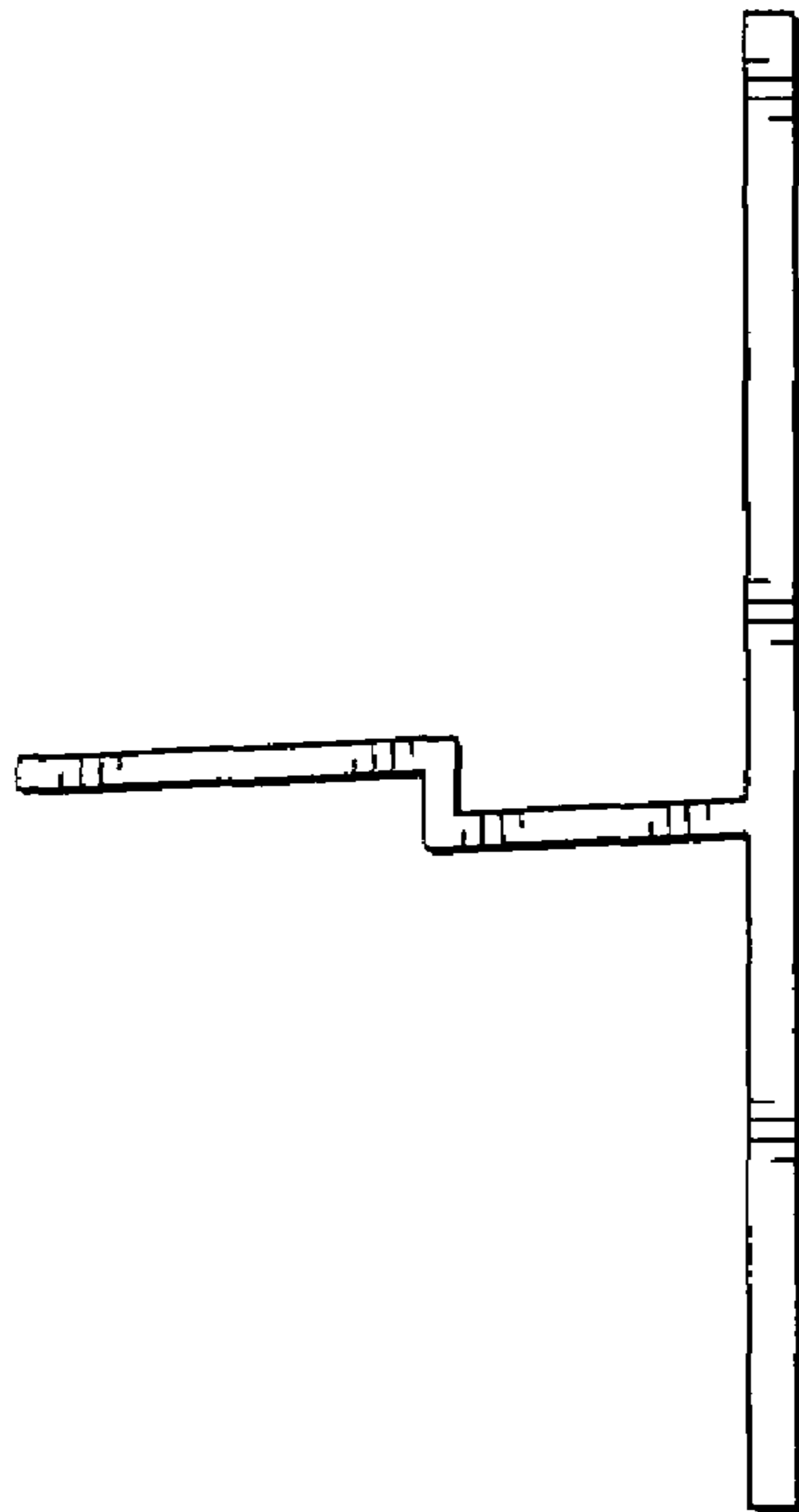

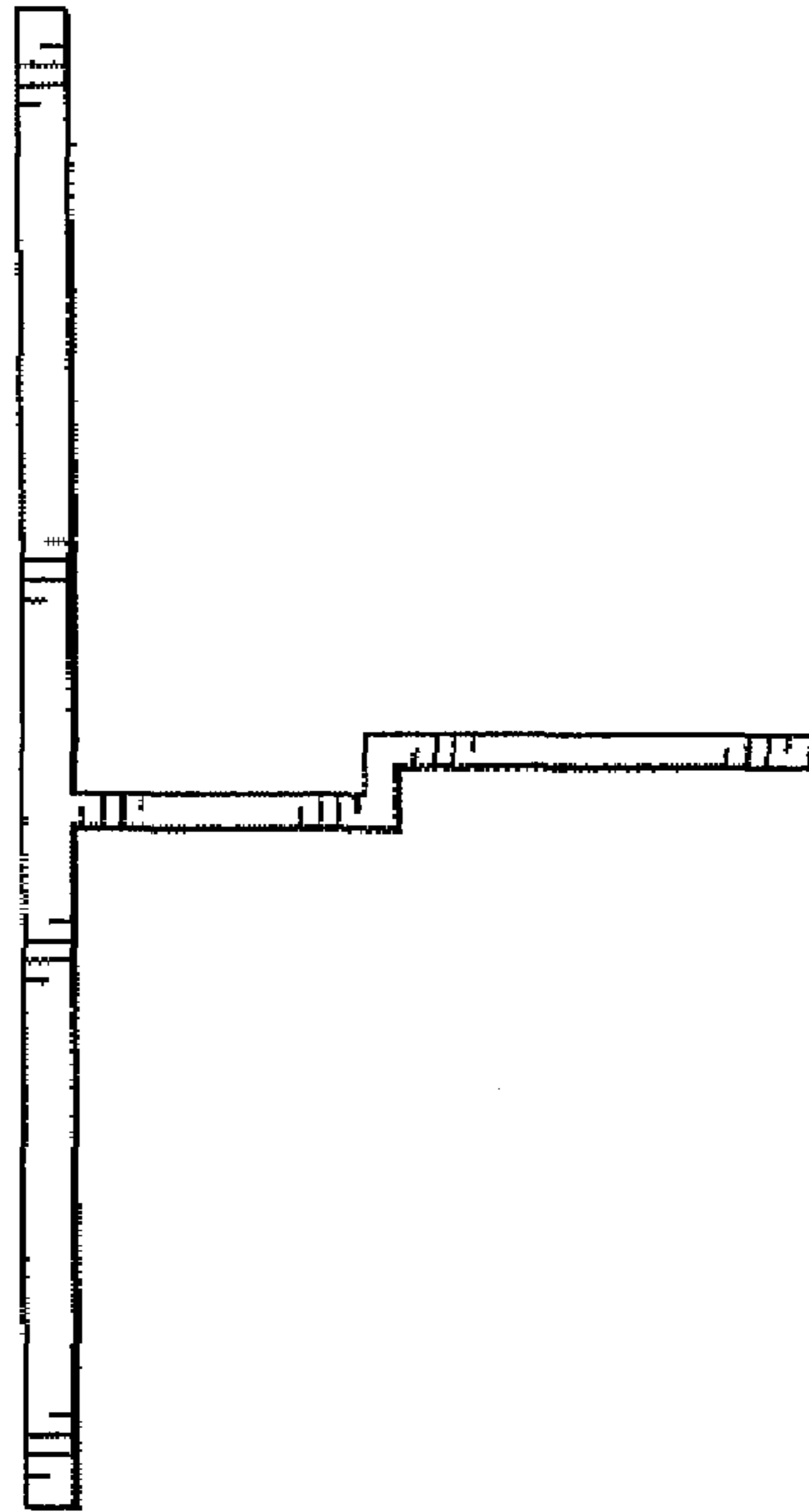

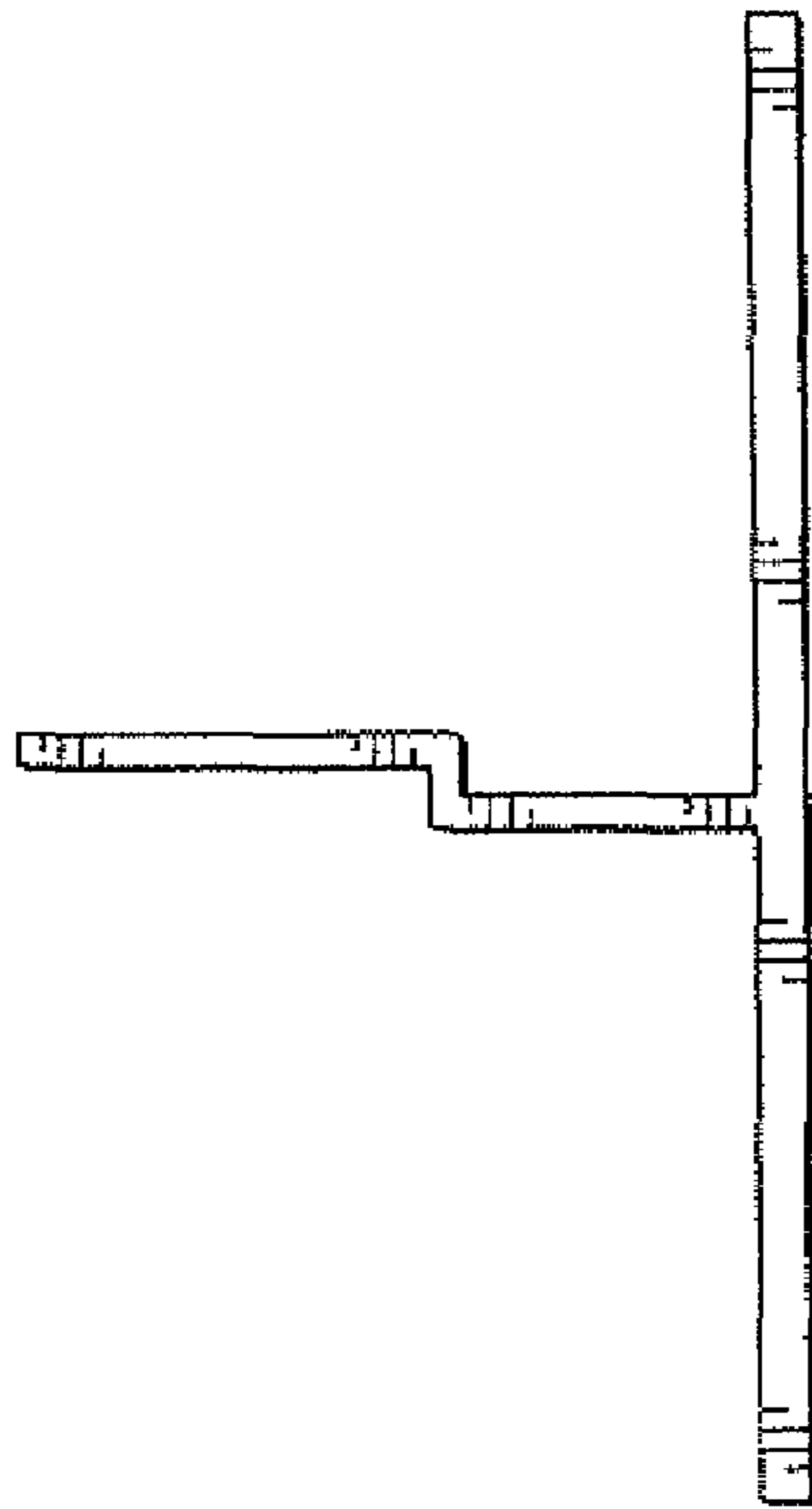

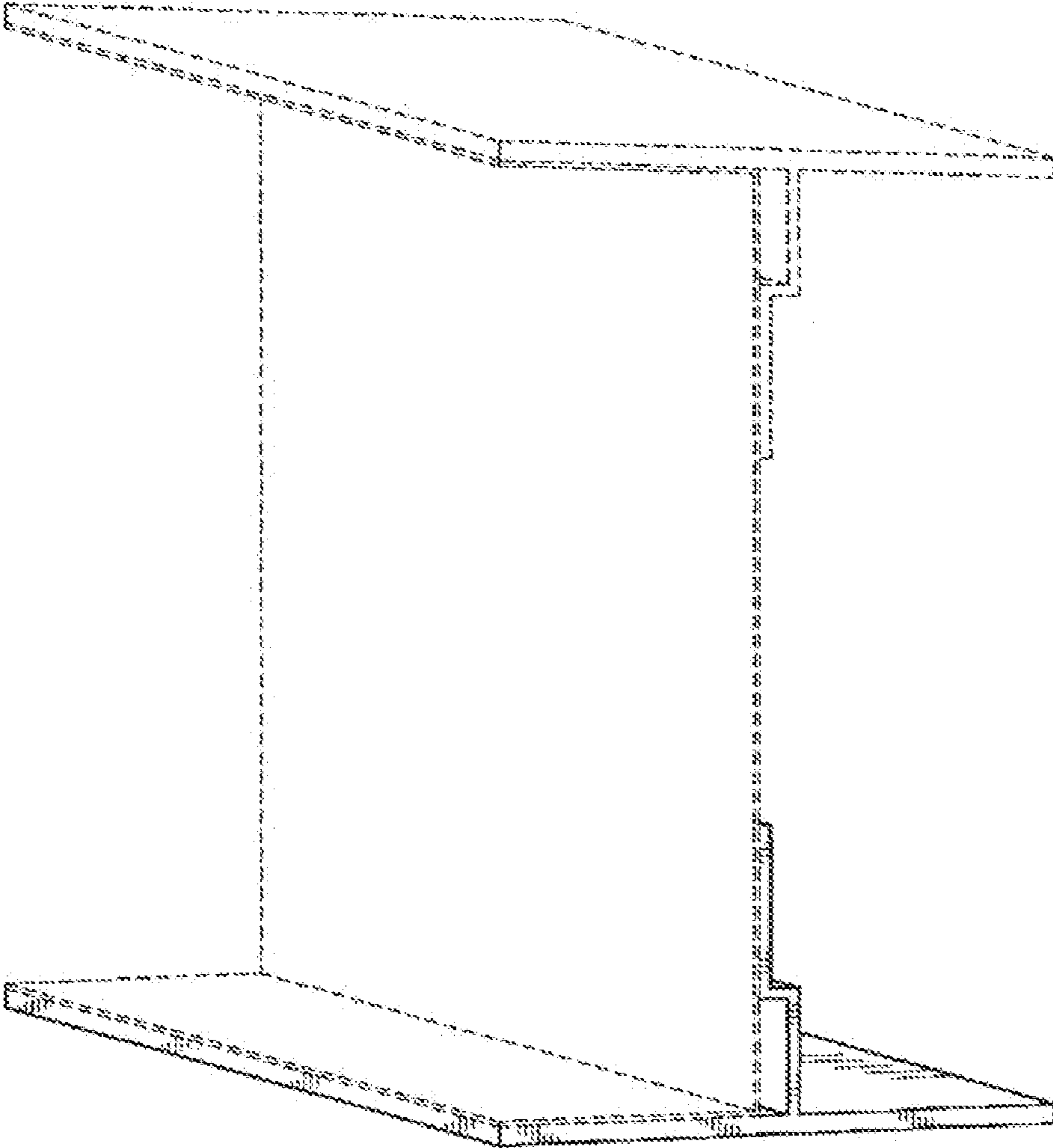

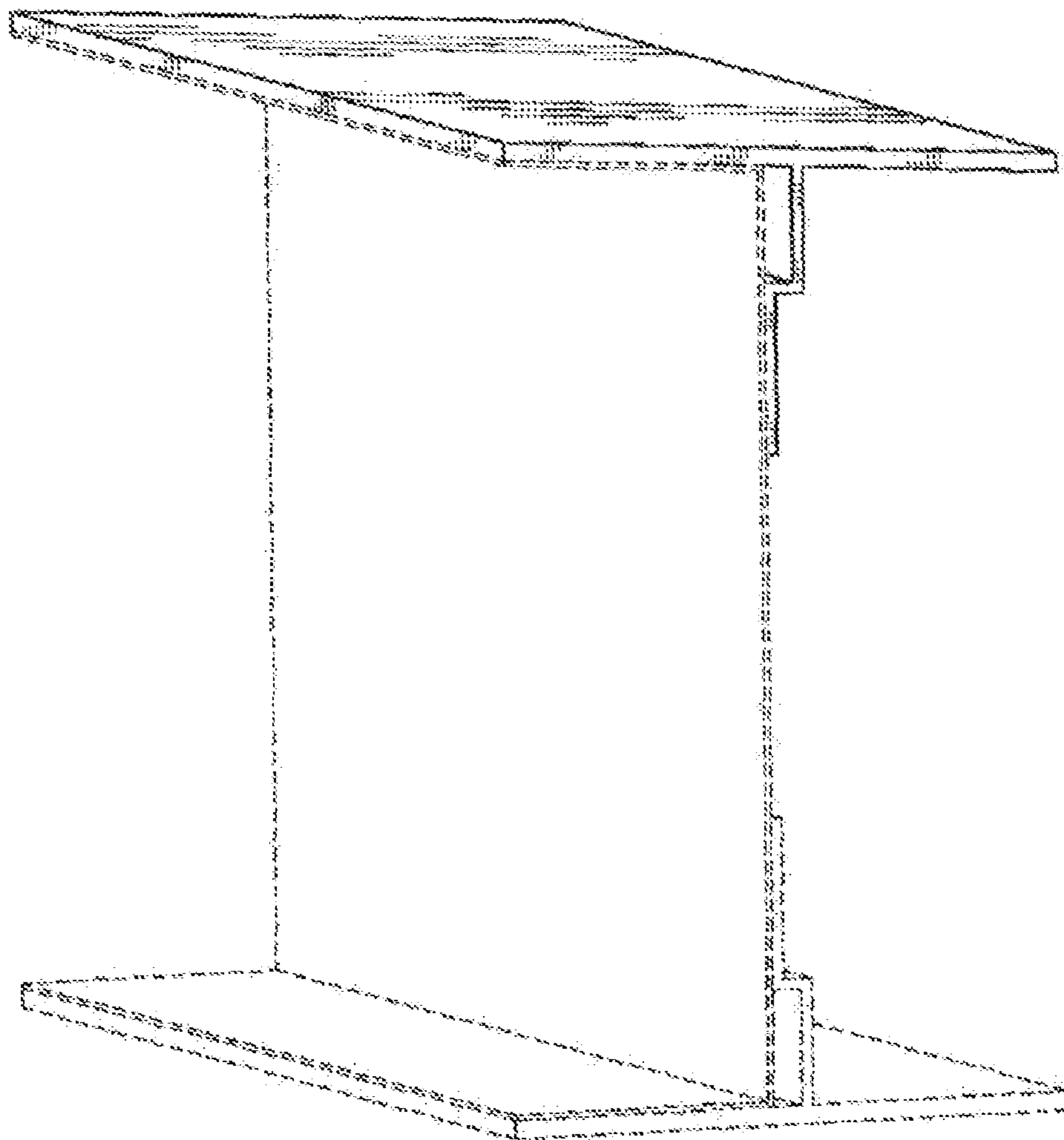

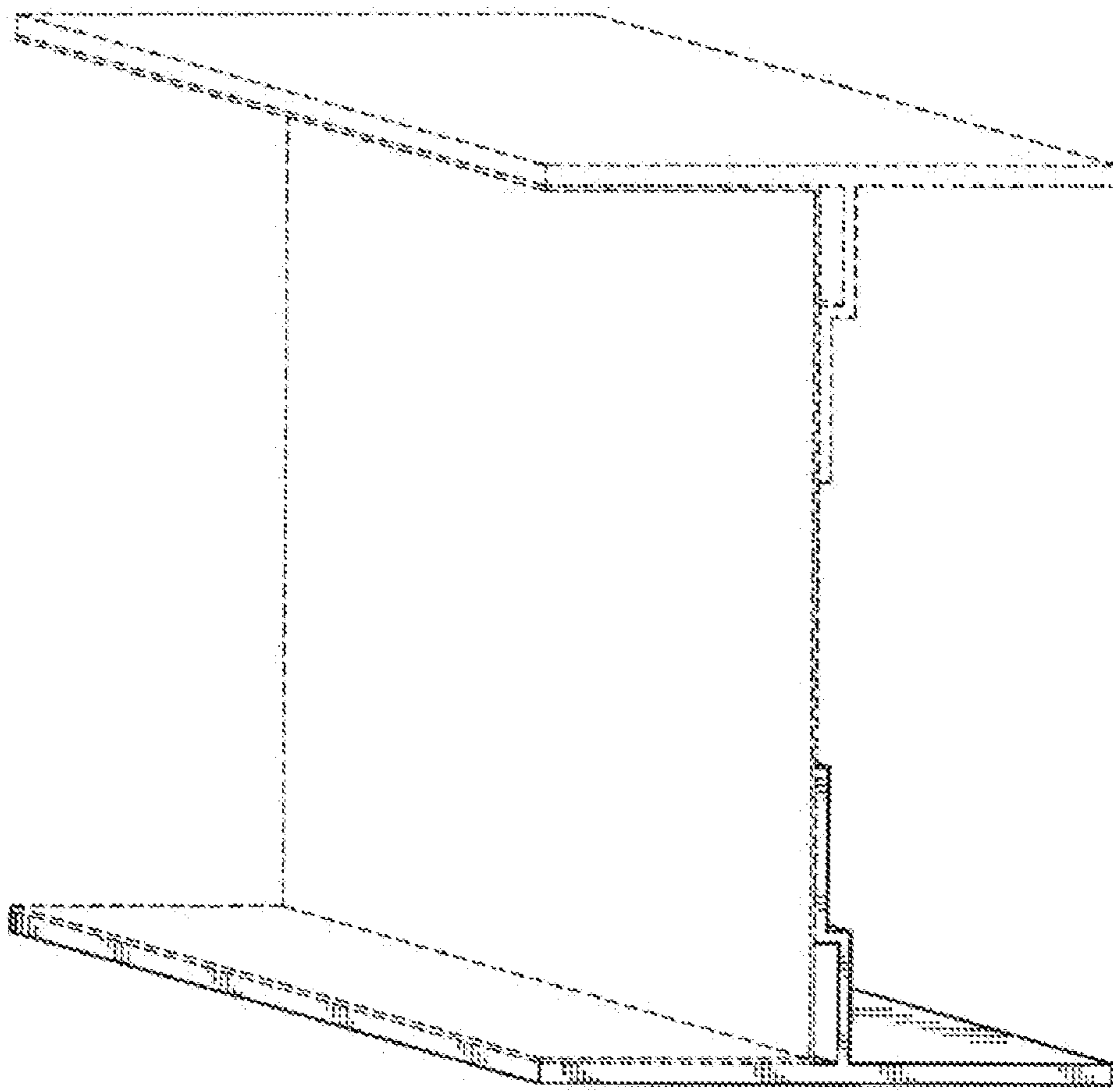

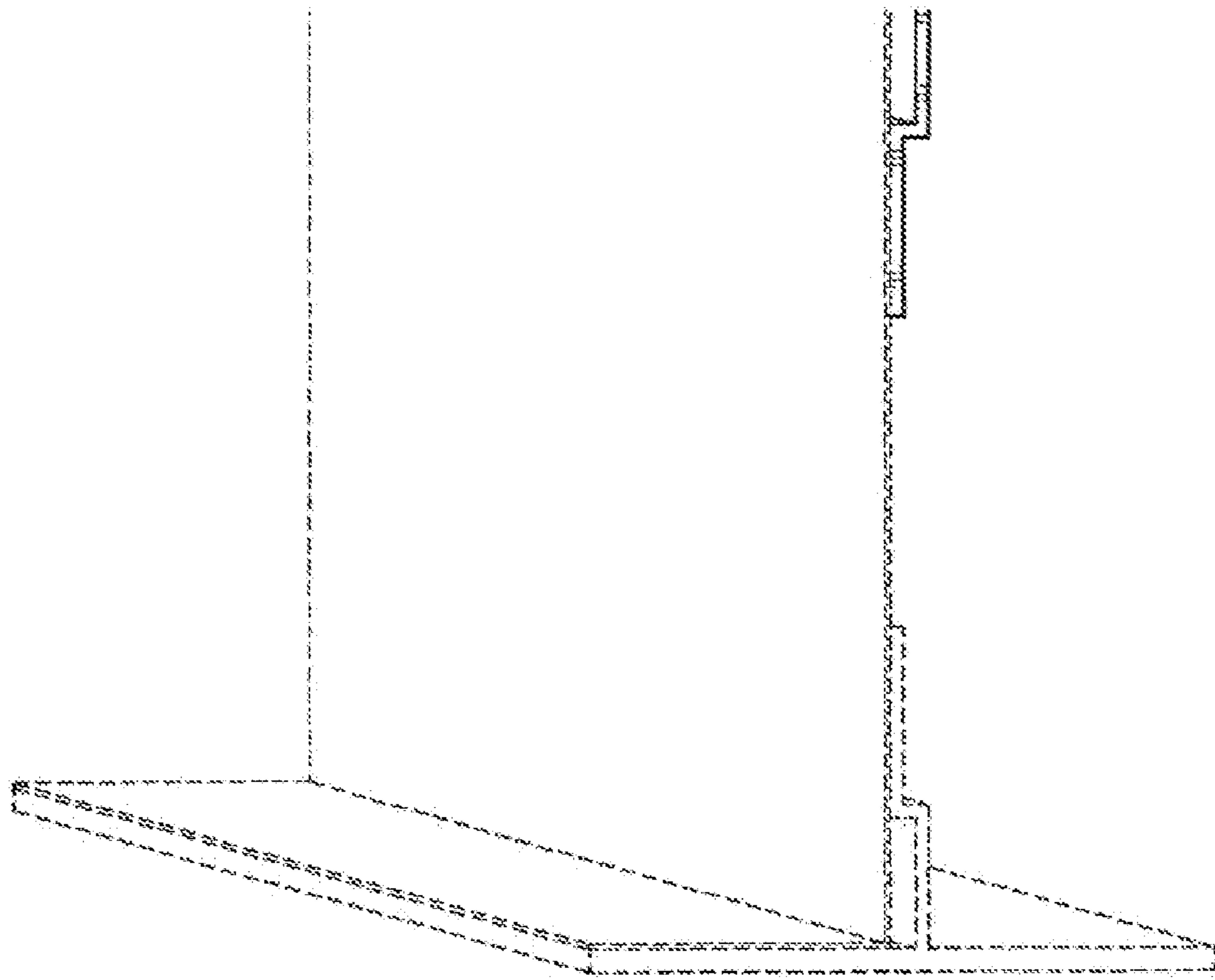

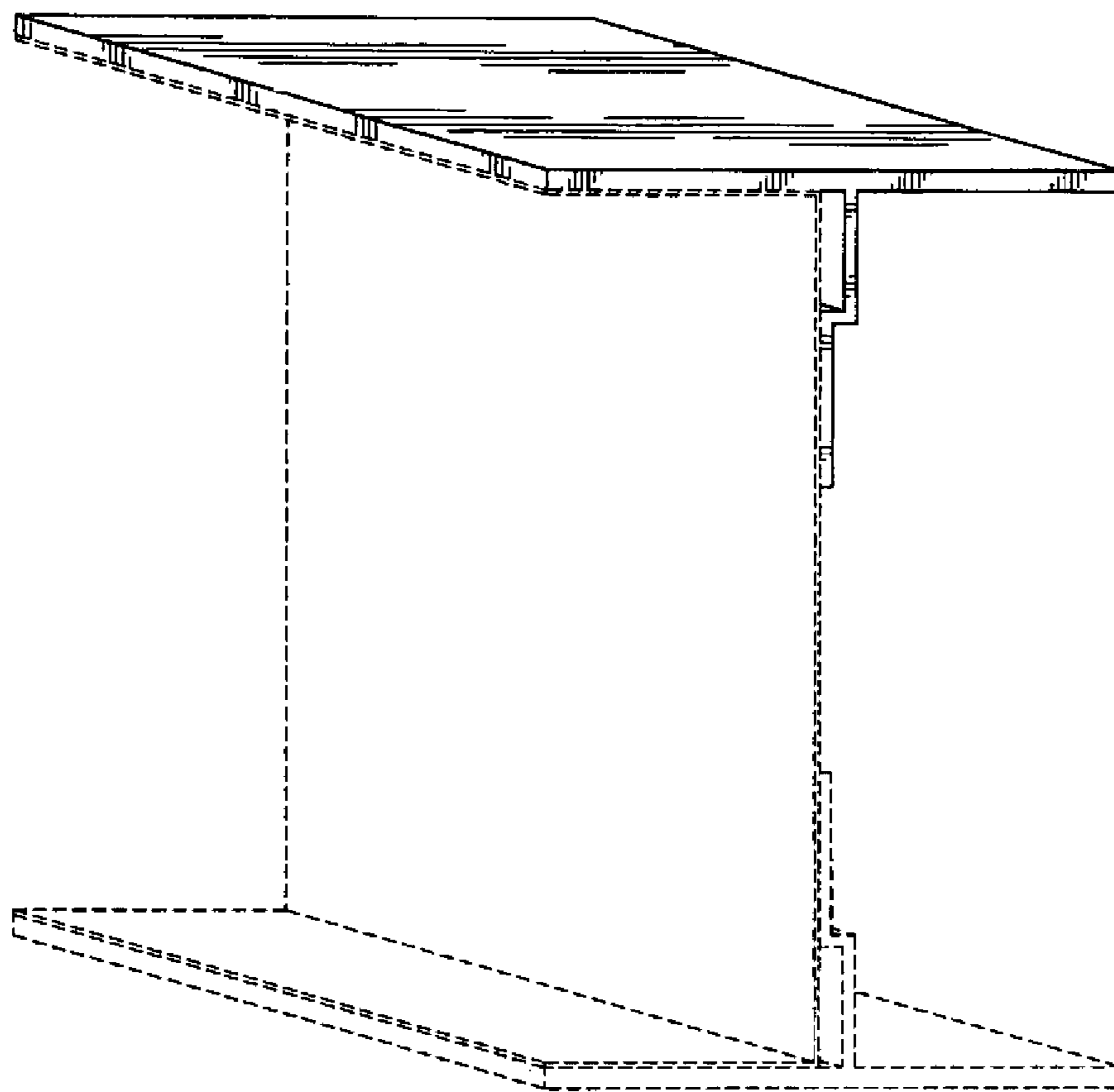
