(57) **CLAIM**

We claim the ornamental design for a soccer ball header, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a soccer ball header showing our new design, the person shown in broken lines forms no part of the claimed design;

FIG. 2 is a front perspective view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a left side elevational view thereof;

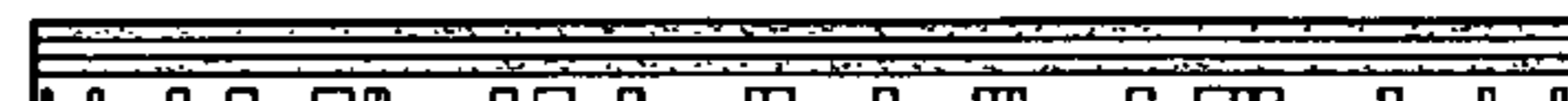
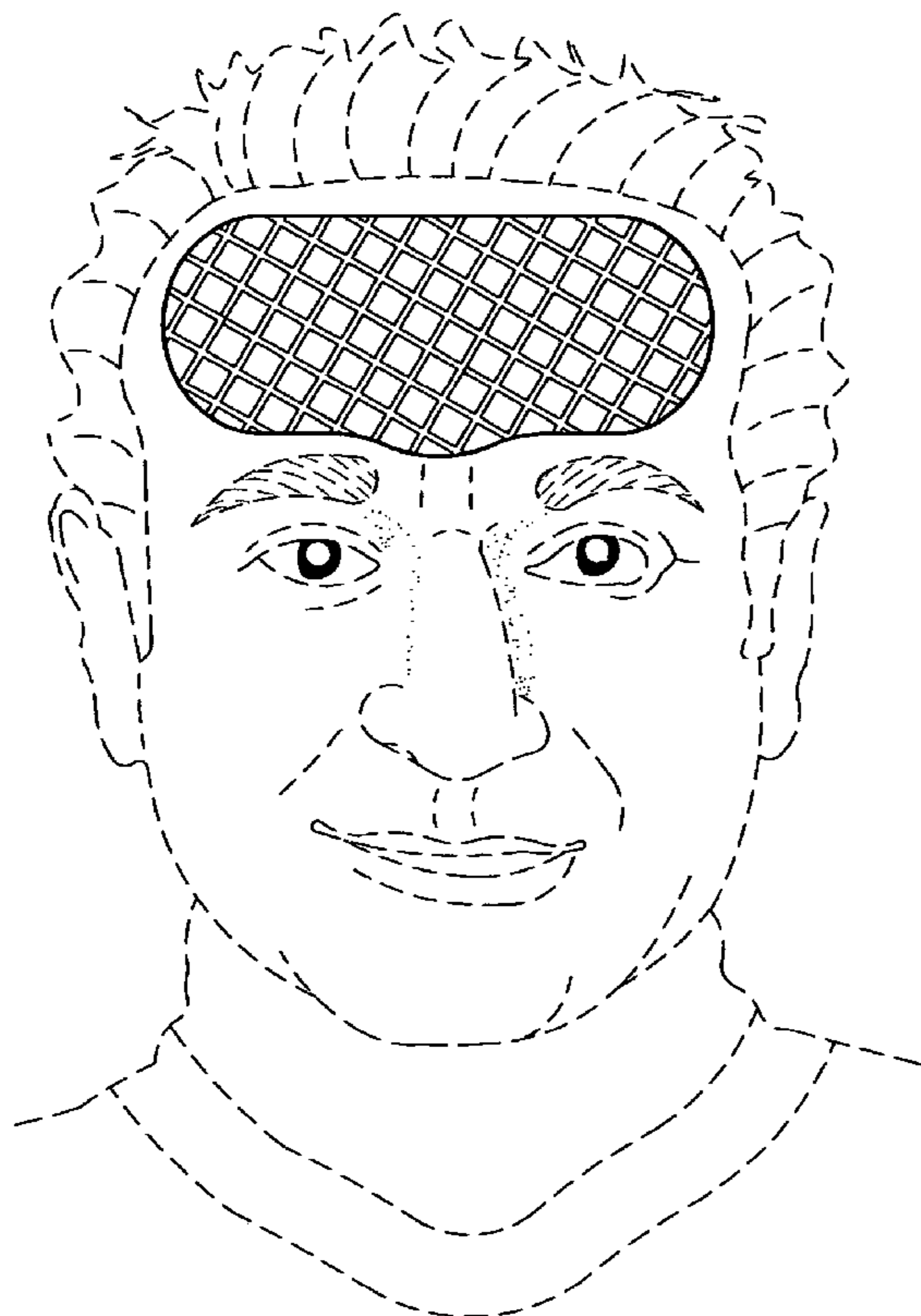
FIG. 5 is a right side elevational view thereof;

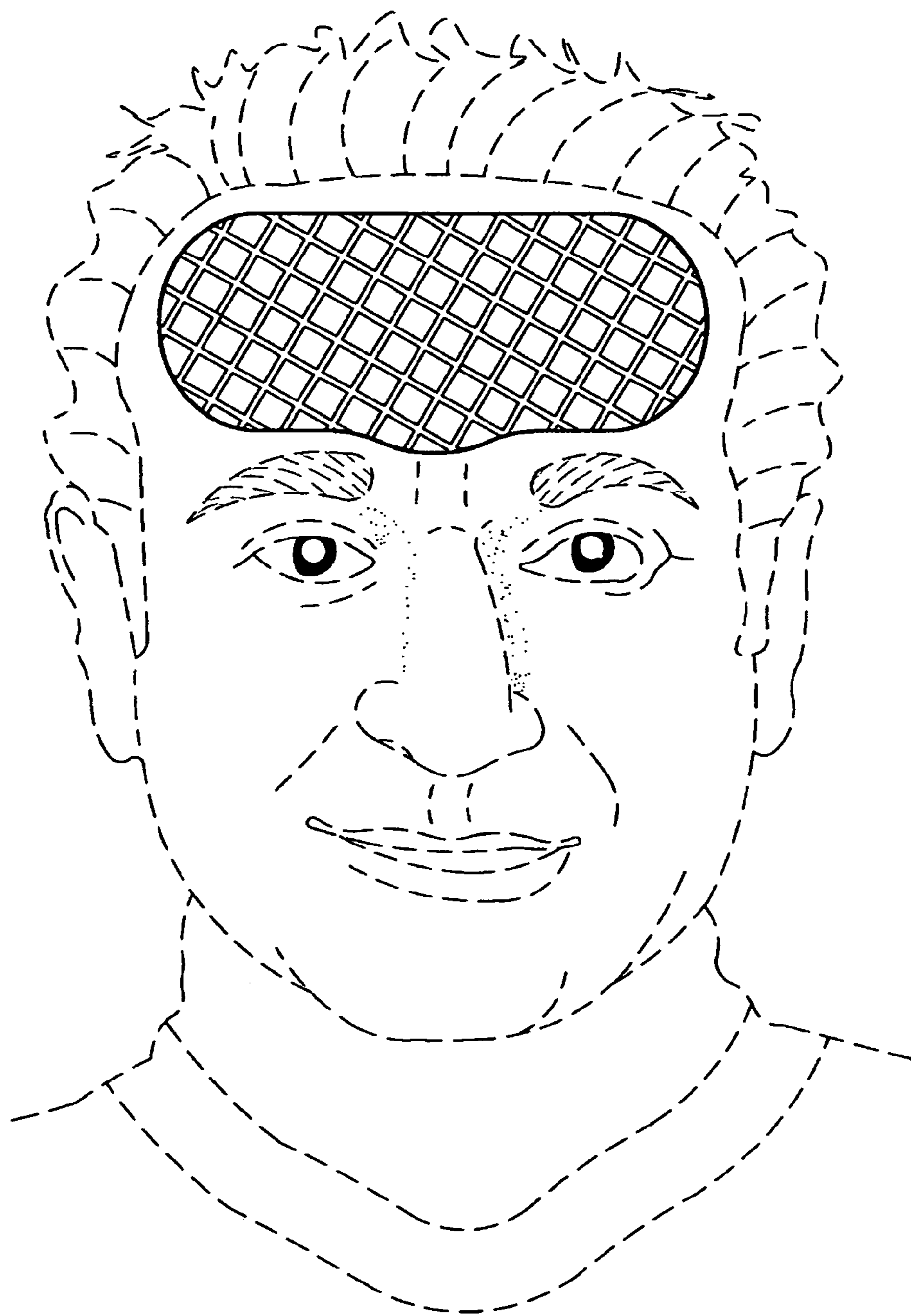

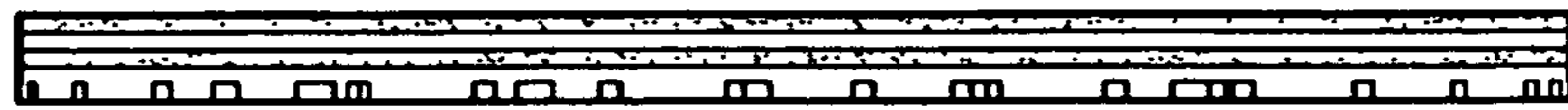

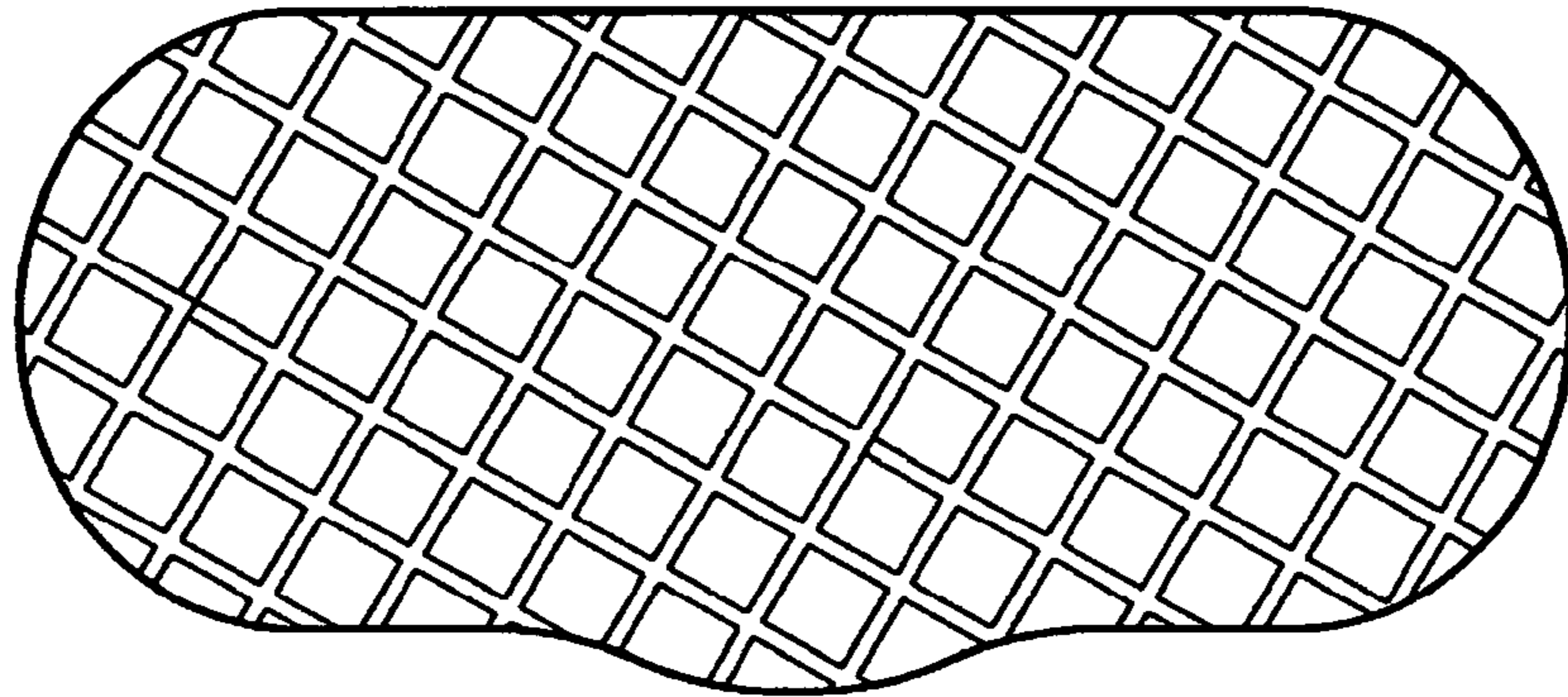

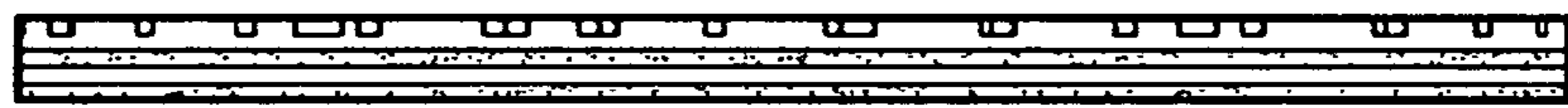

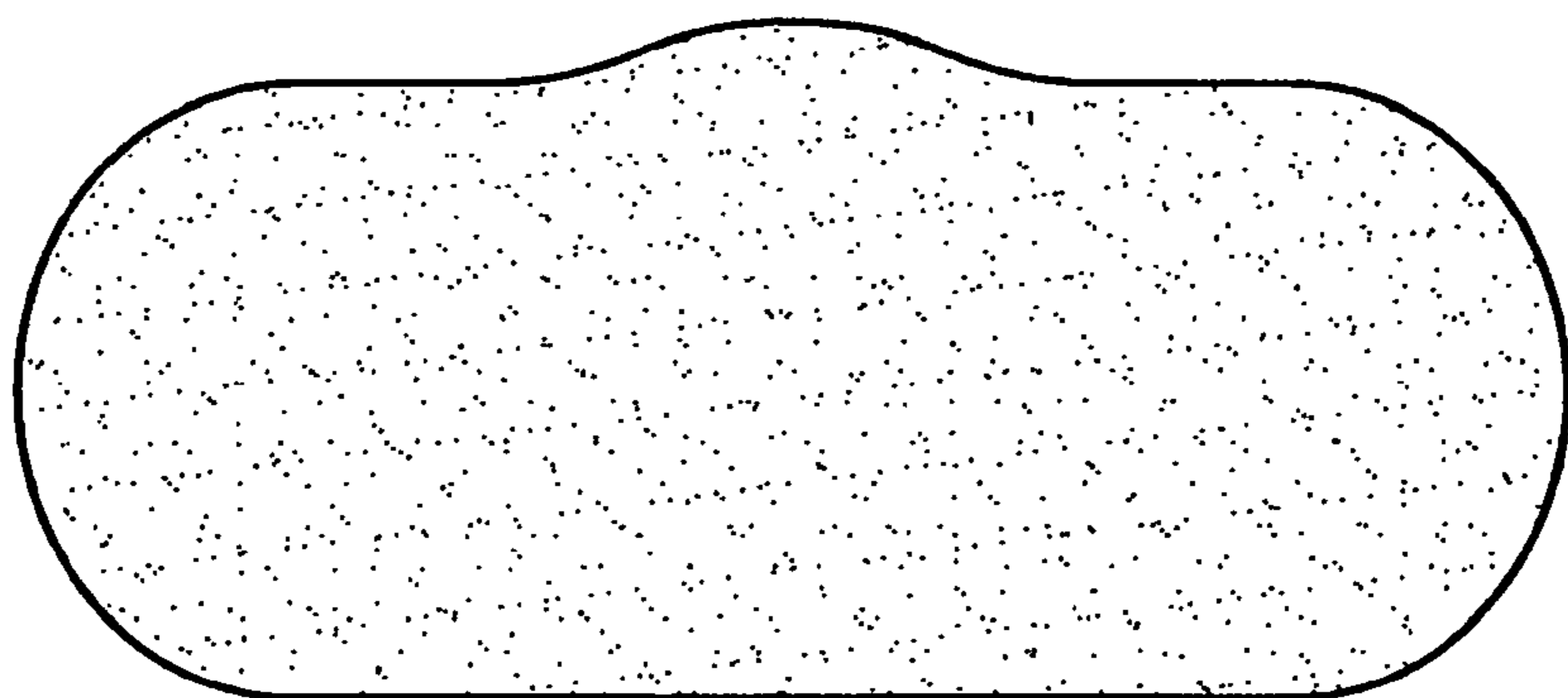

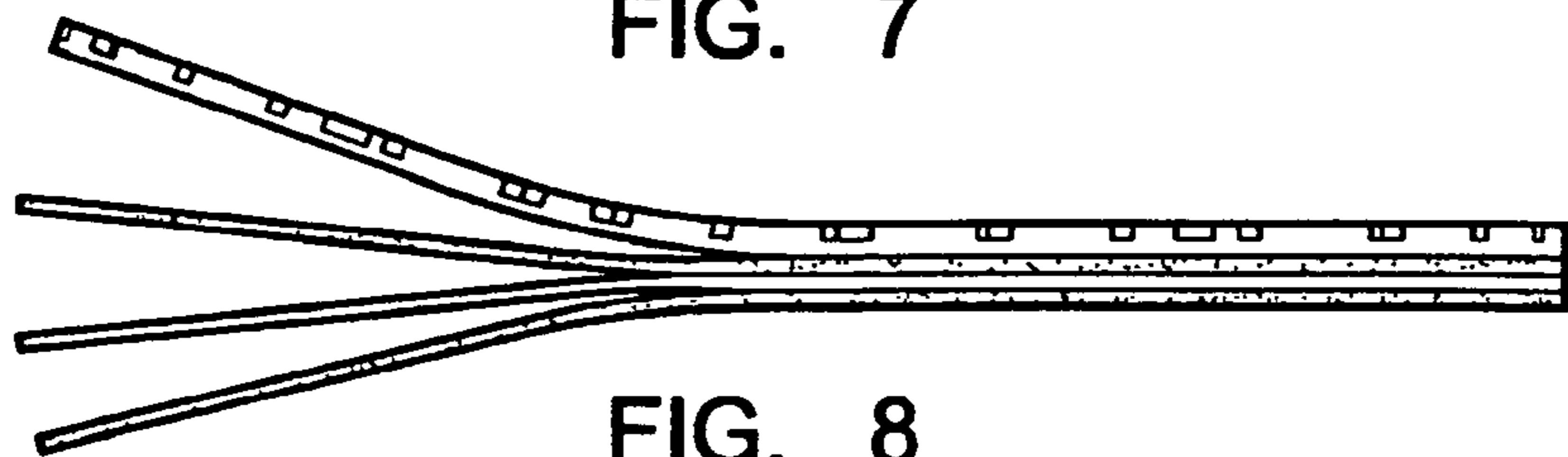
