The ornamental design for footwear sole, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the footwear sole embodying the new design;

FIG. 2 is a bottom view thereof;

FIG. 3 is a right side view thereof;

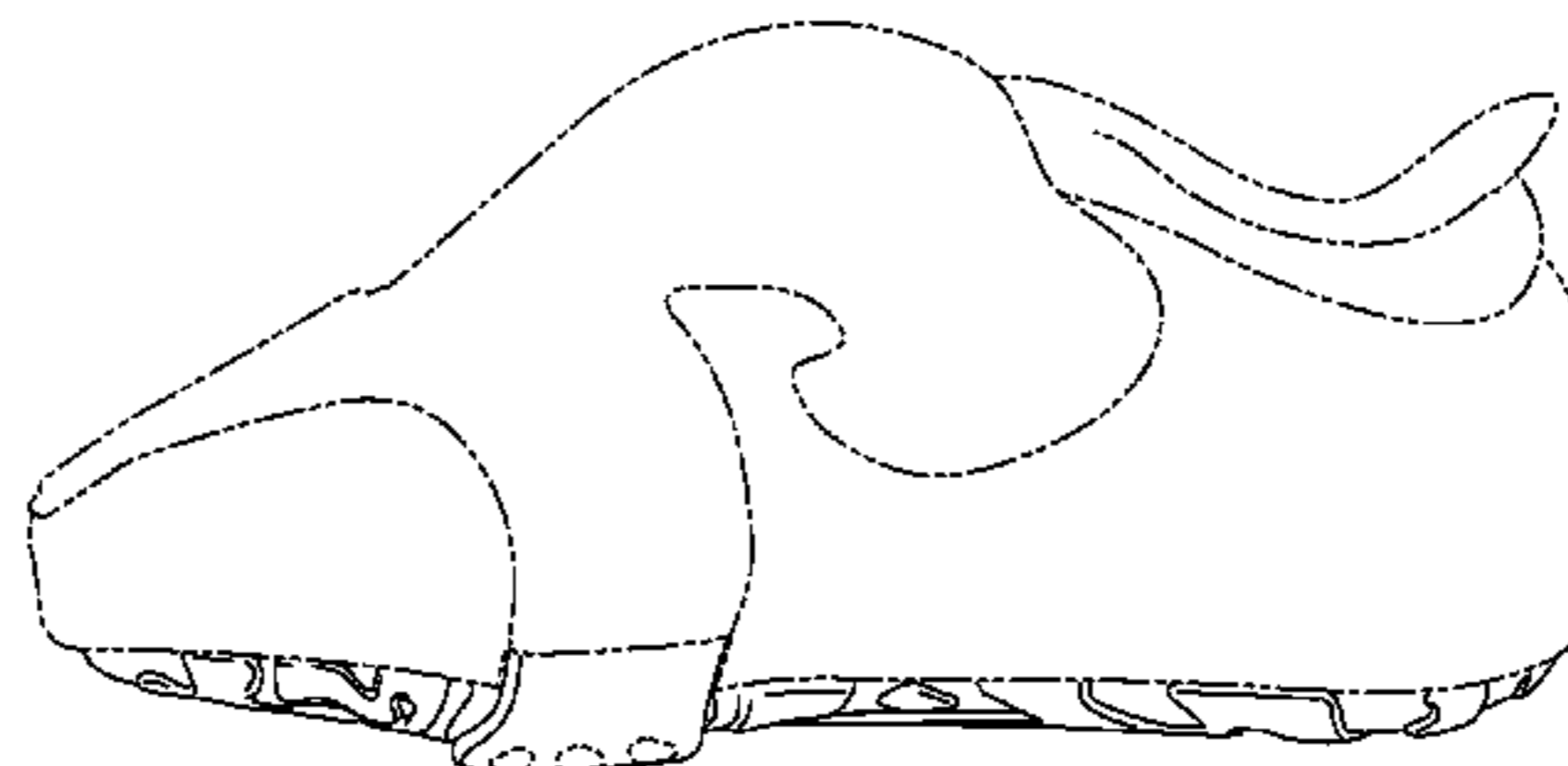
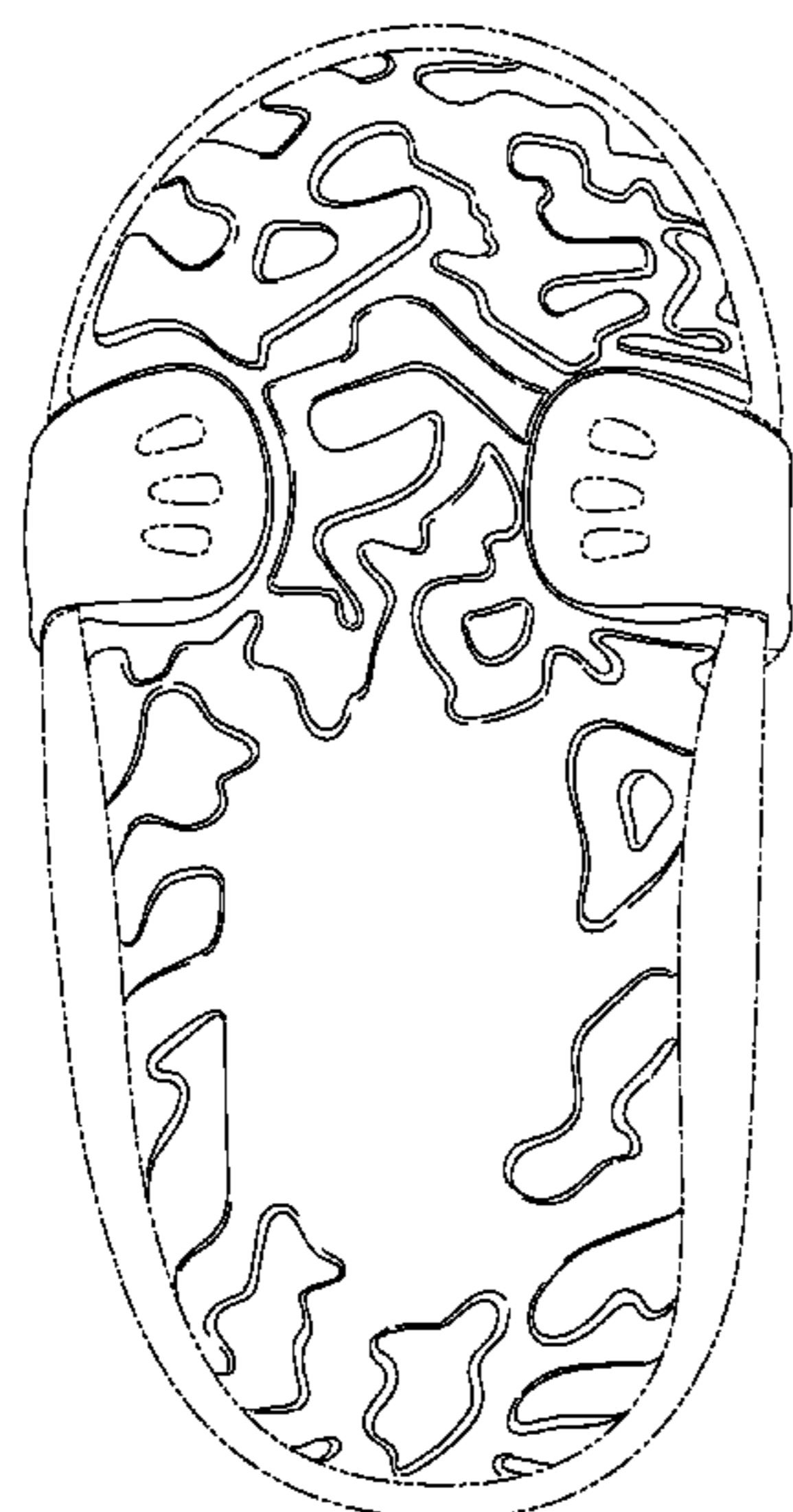
FIG. 4 is a left side view thereof;

Further, the phantom lines immediately adjacent the solid-line portions of the design form the boundary of the design, with the phantom lines forming no part of the claimed design.

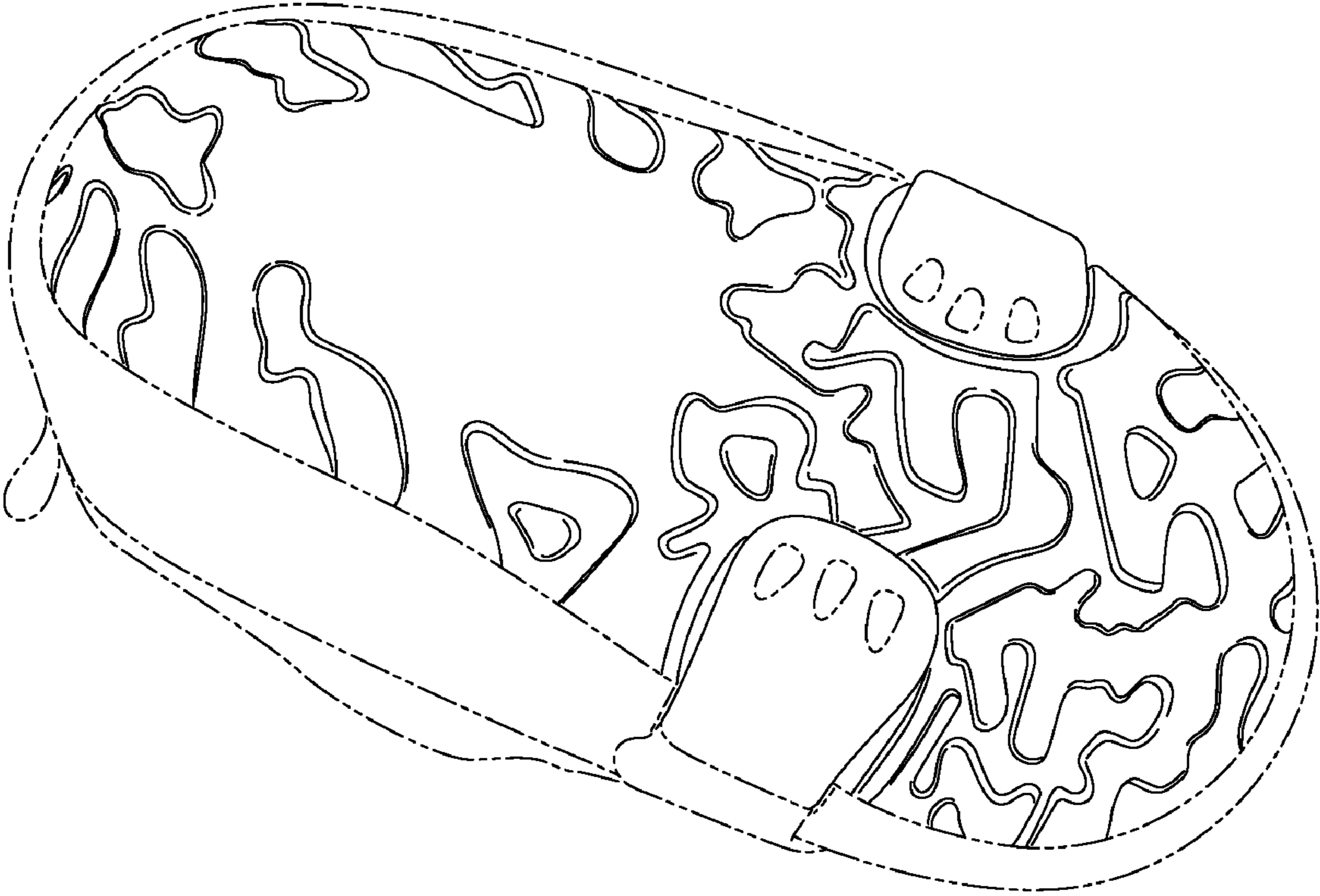

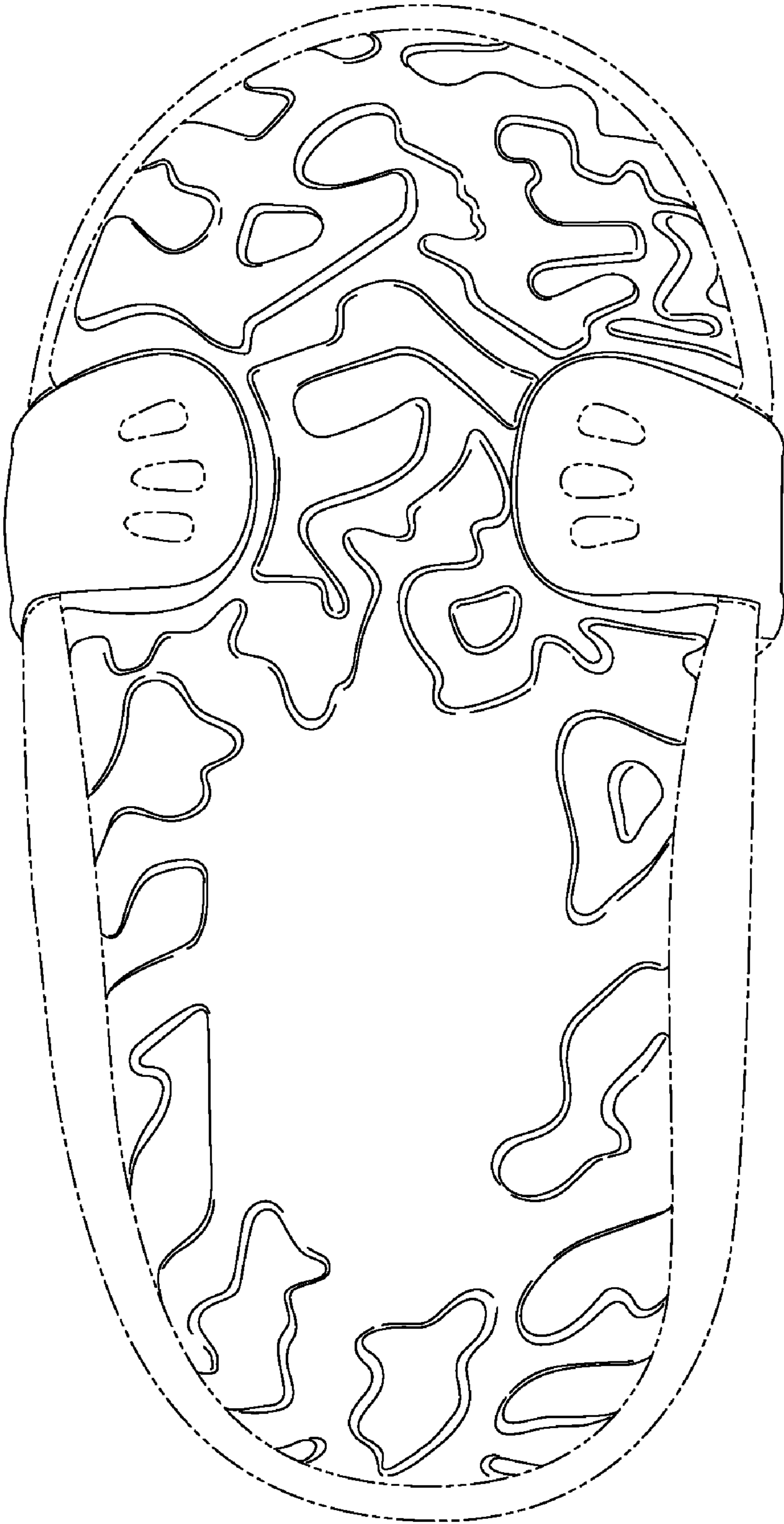

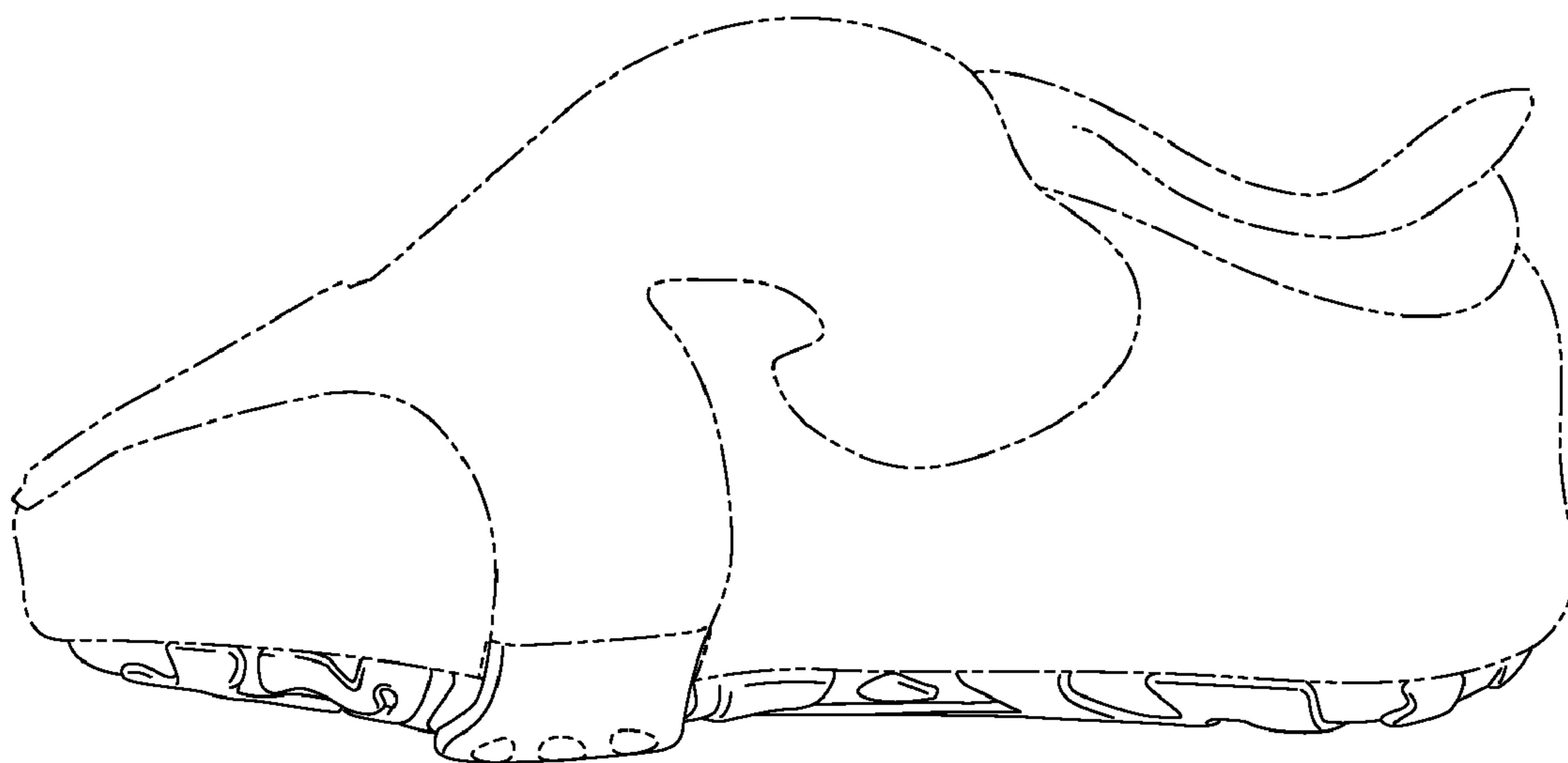

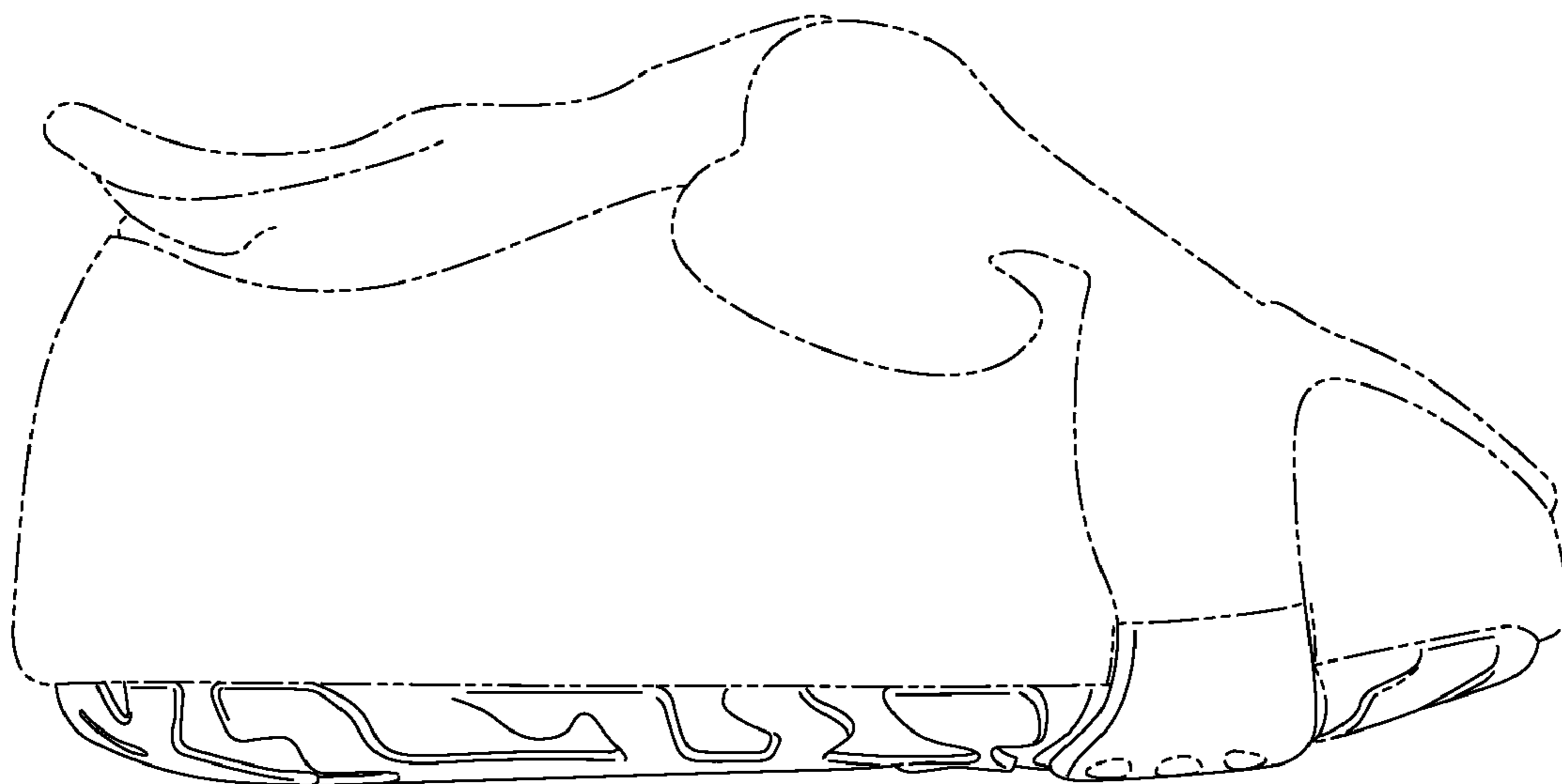

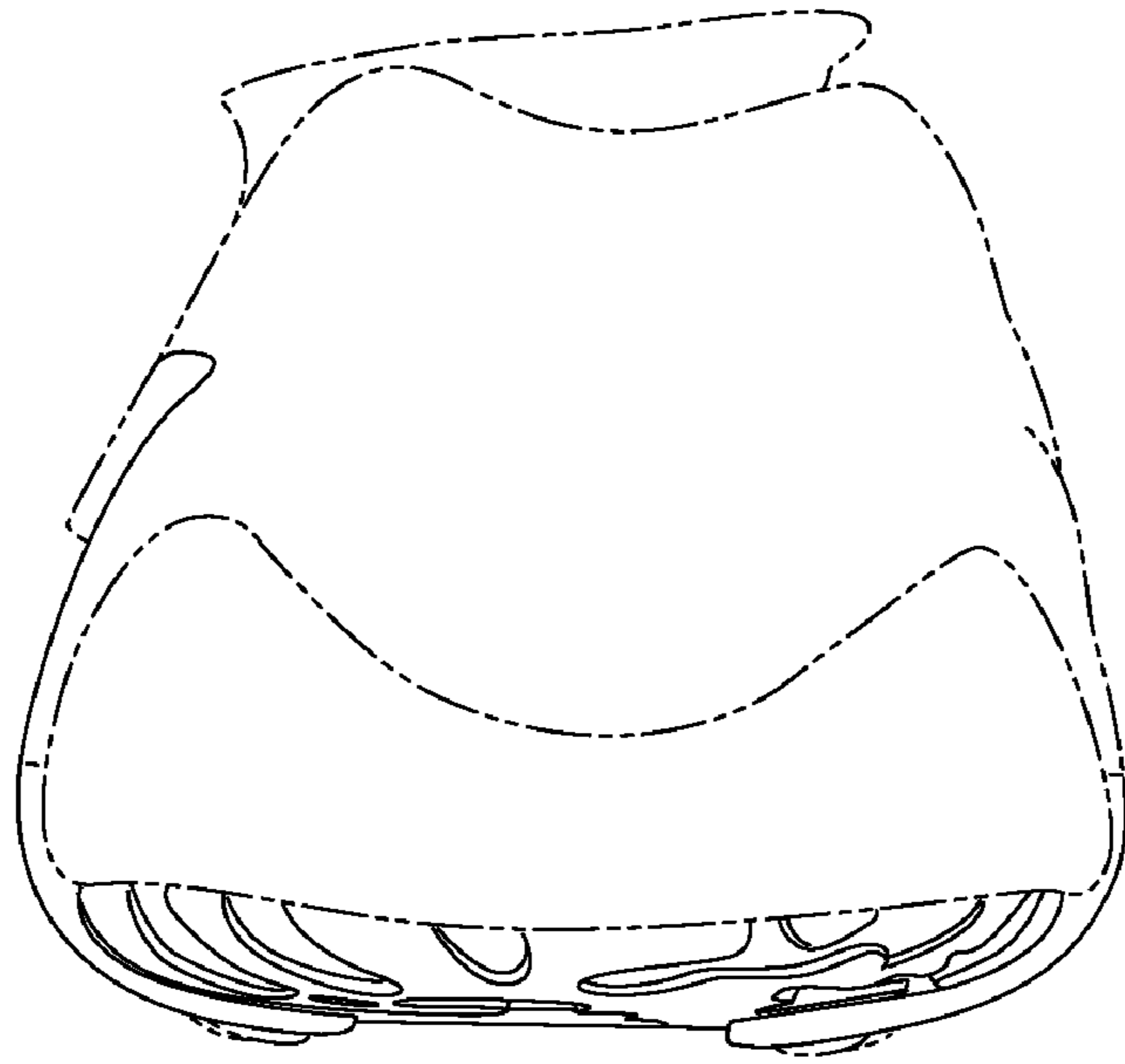

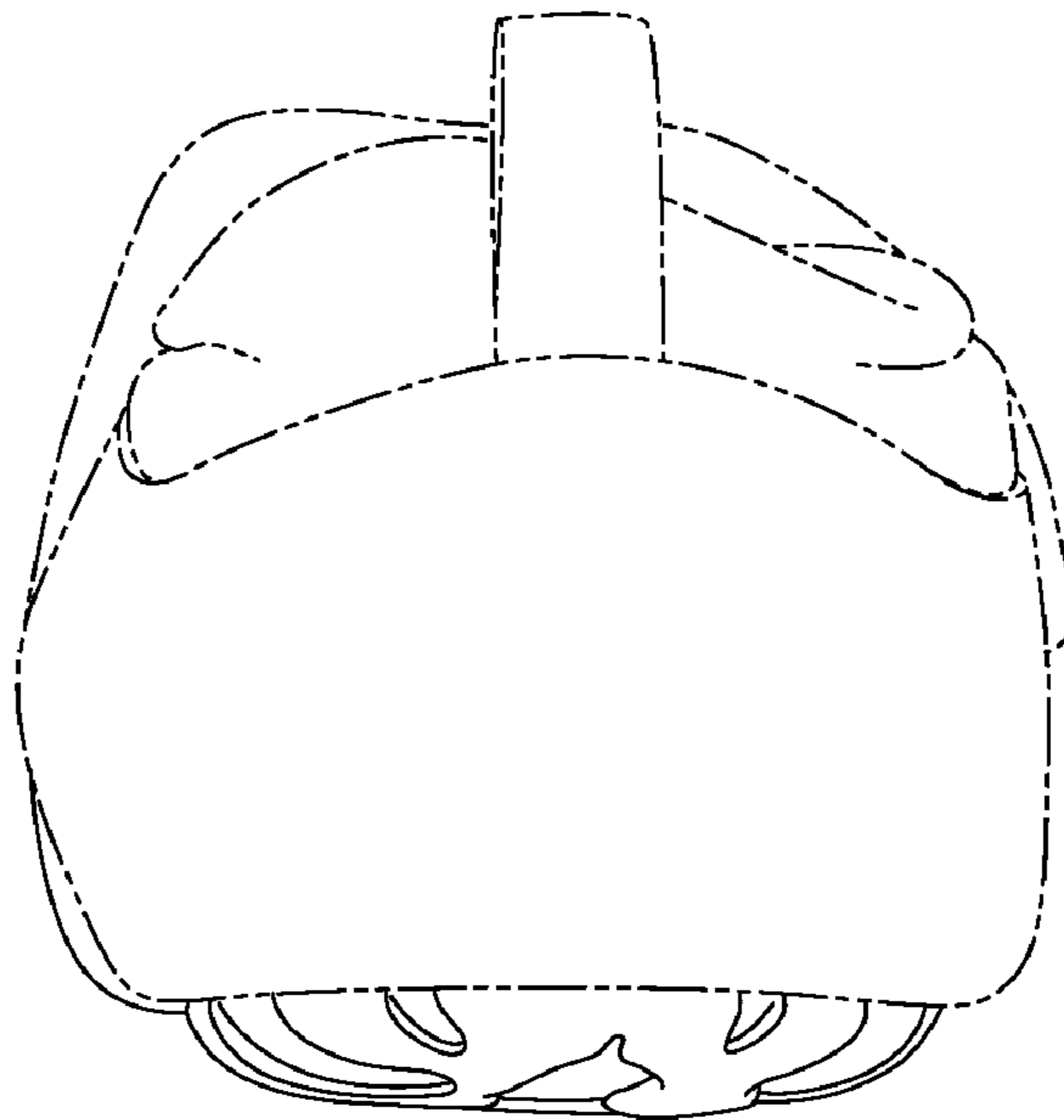
