**DESCRIPTION**

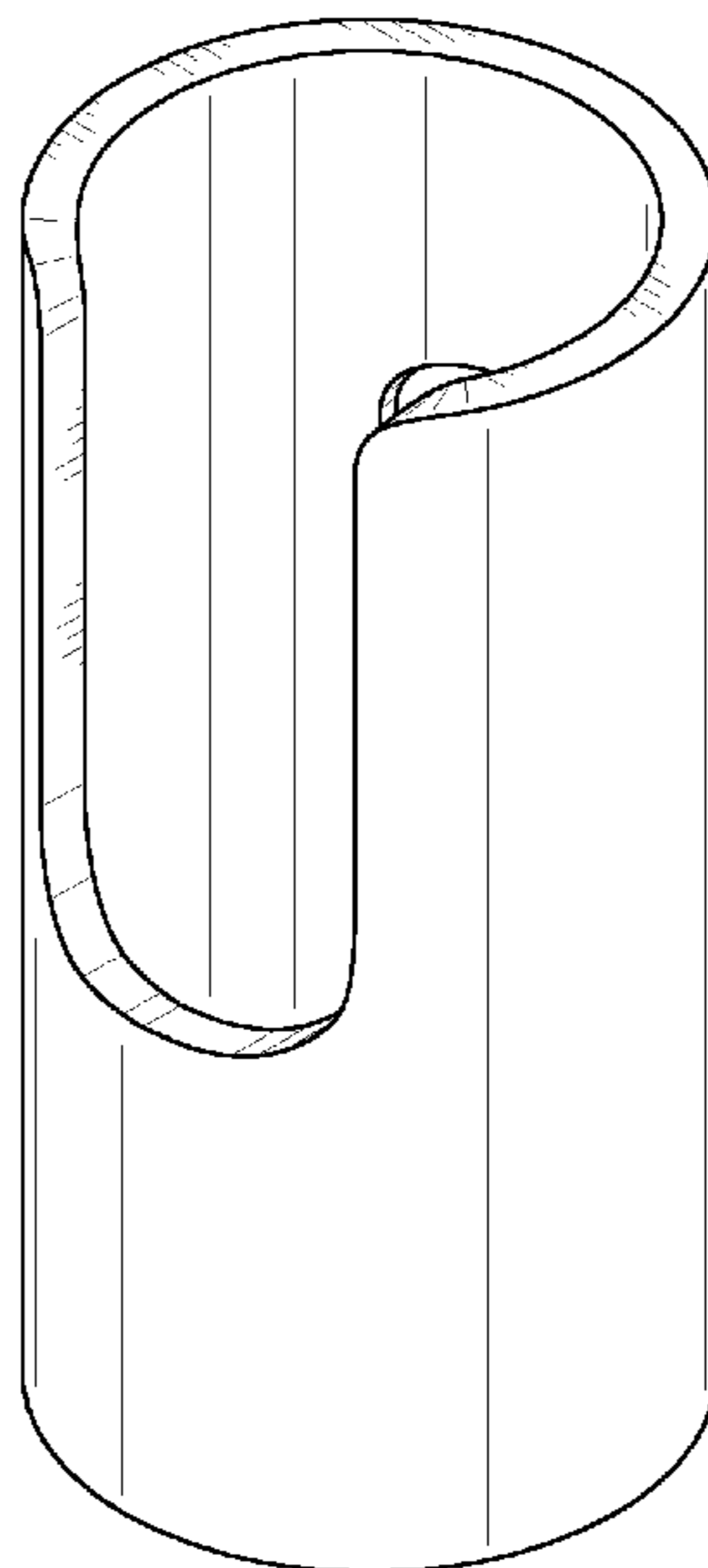
FIGS. 1 and 2 are front and rear perspective views;

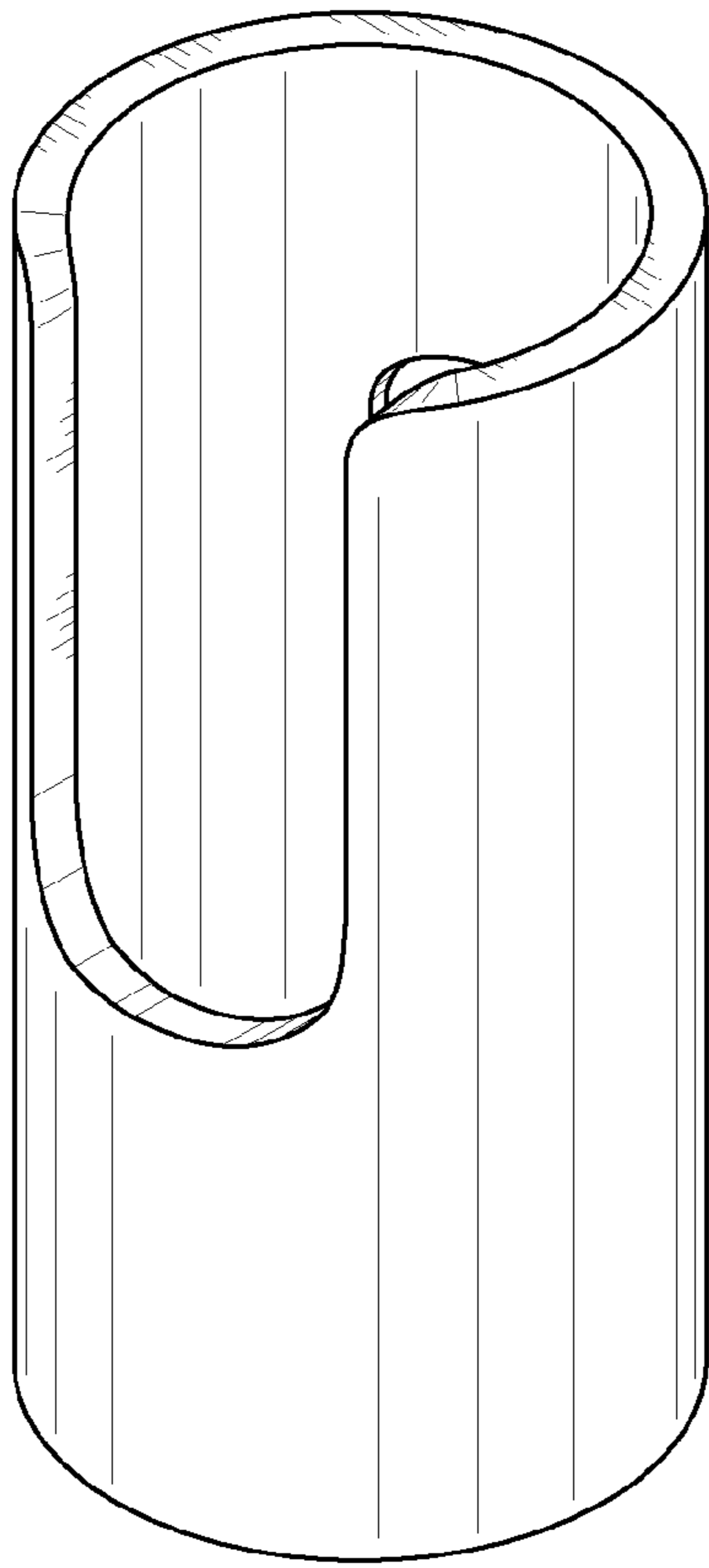

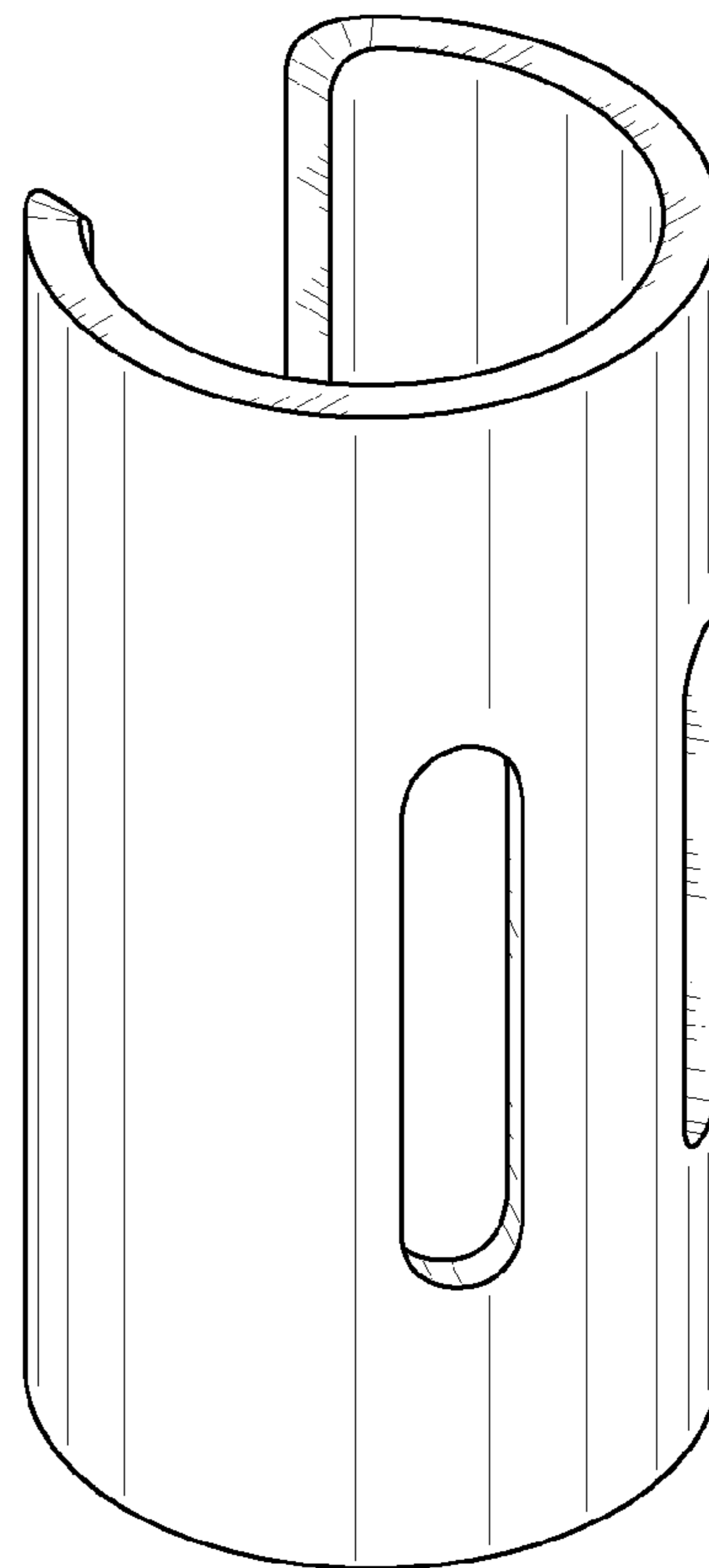

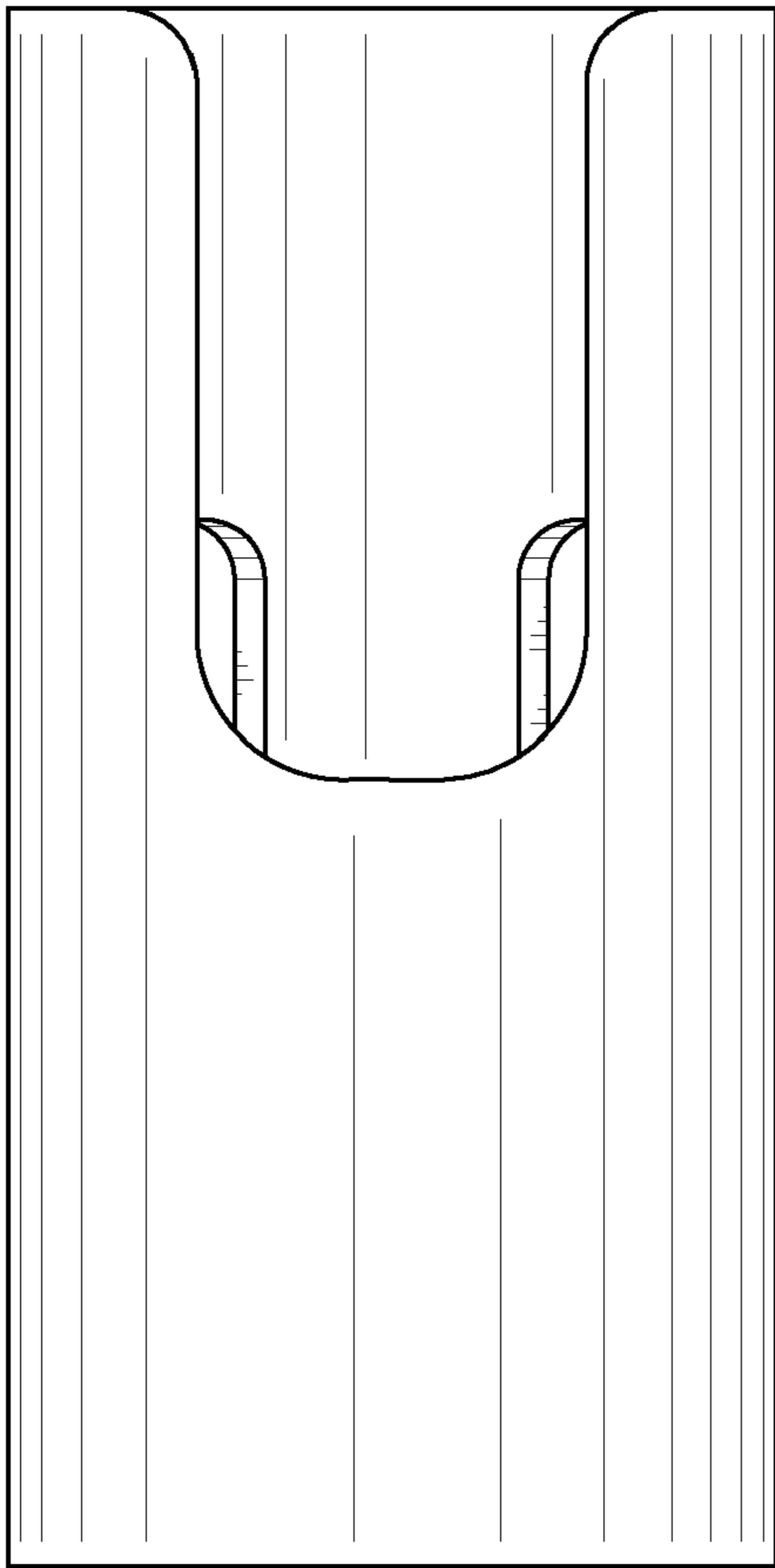

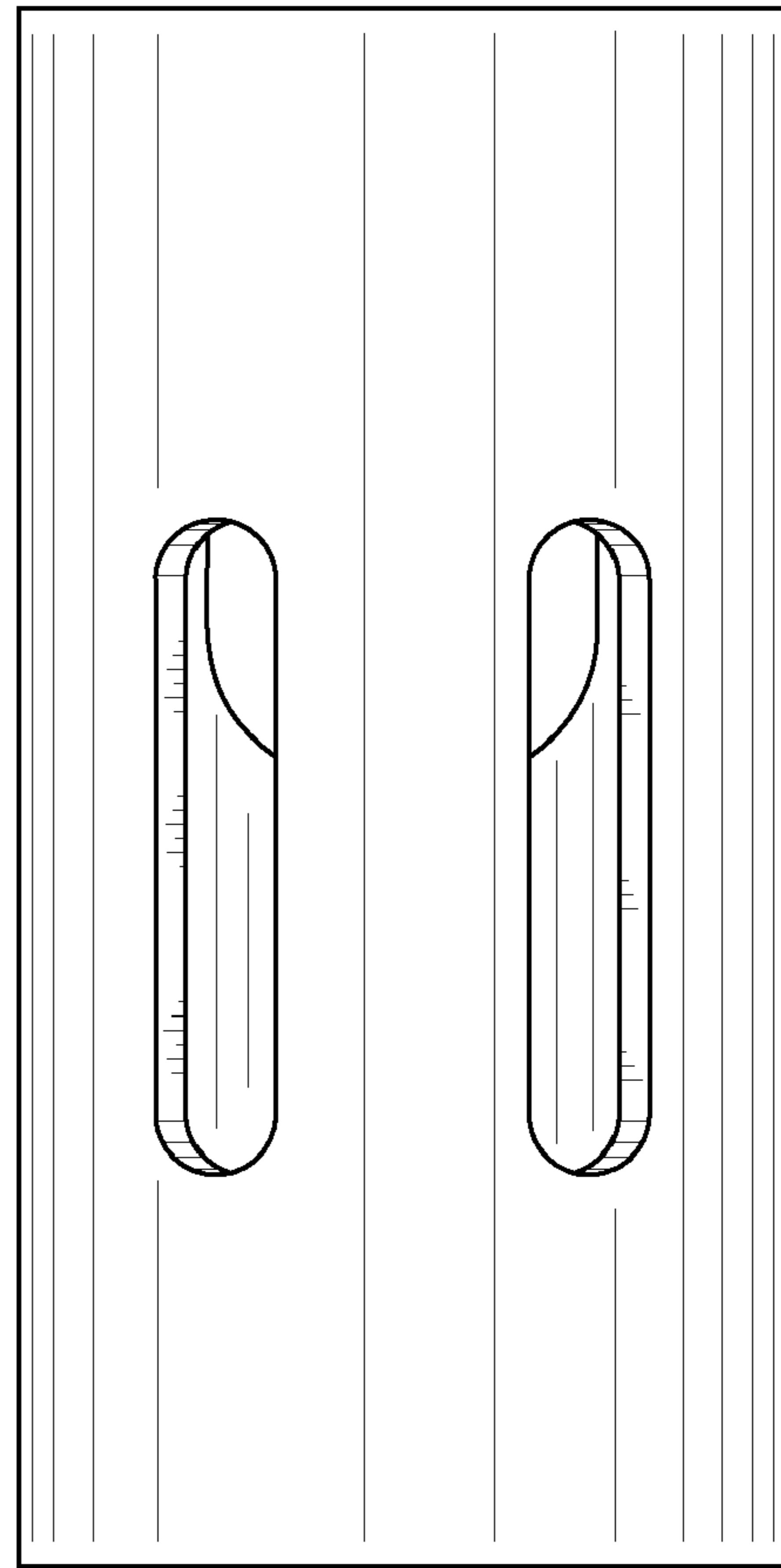

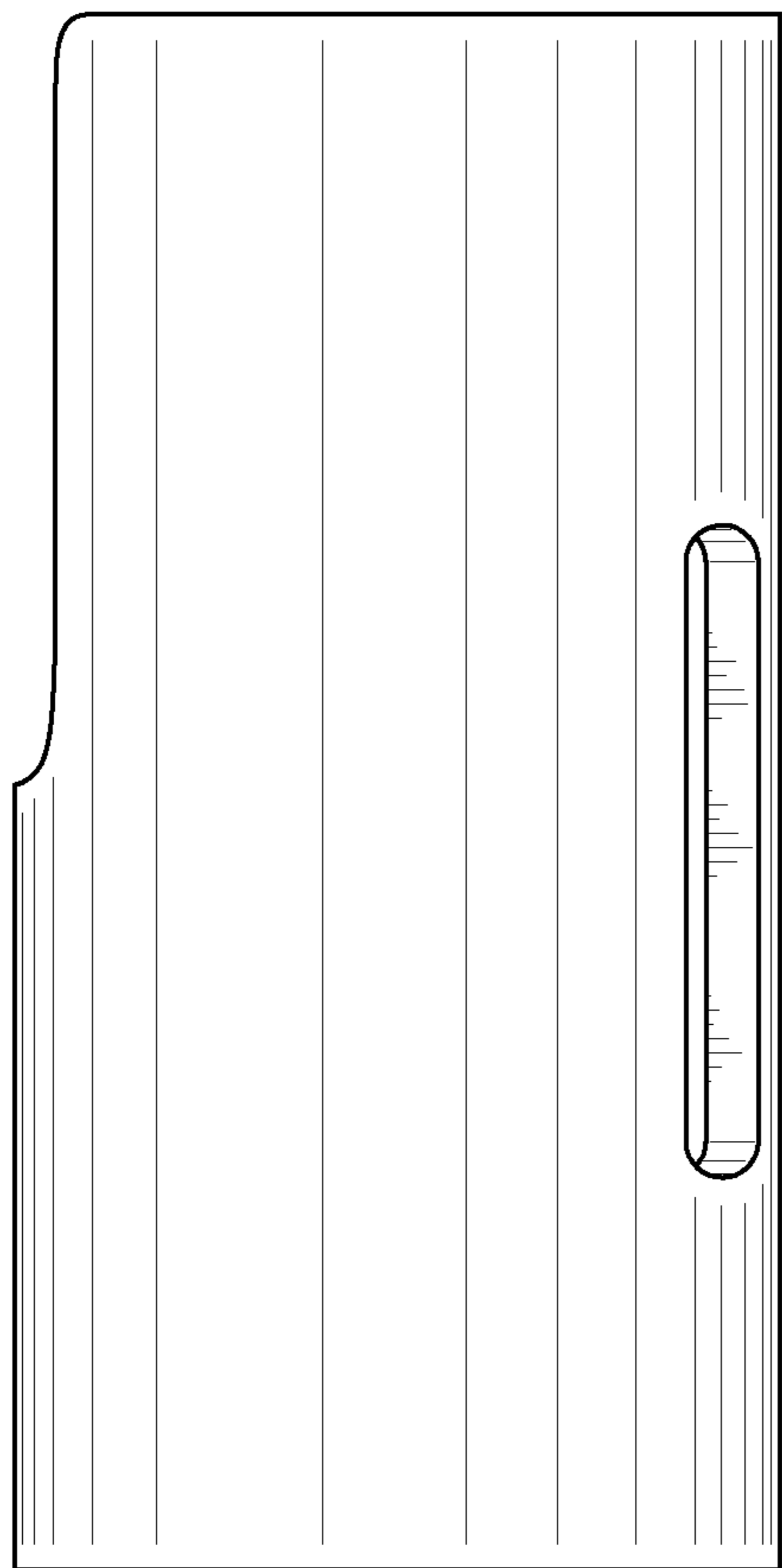

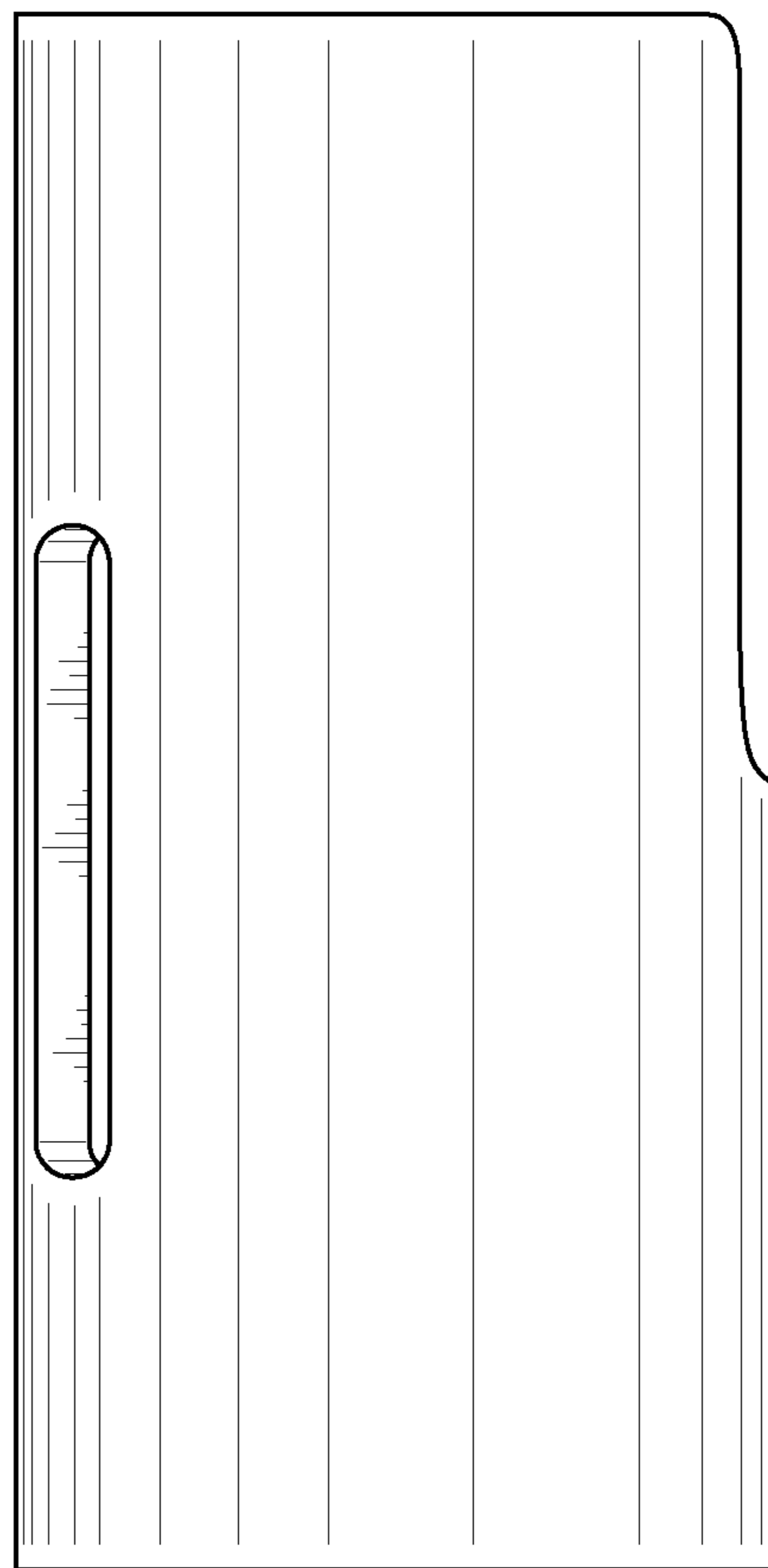

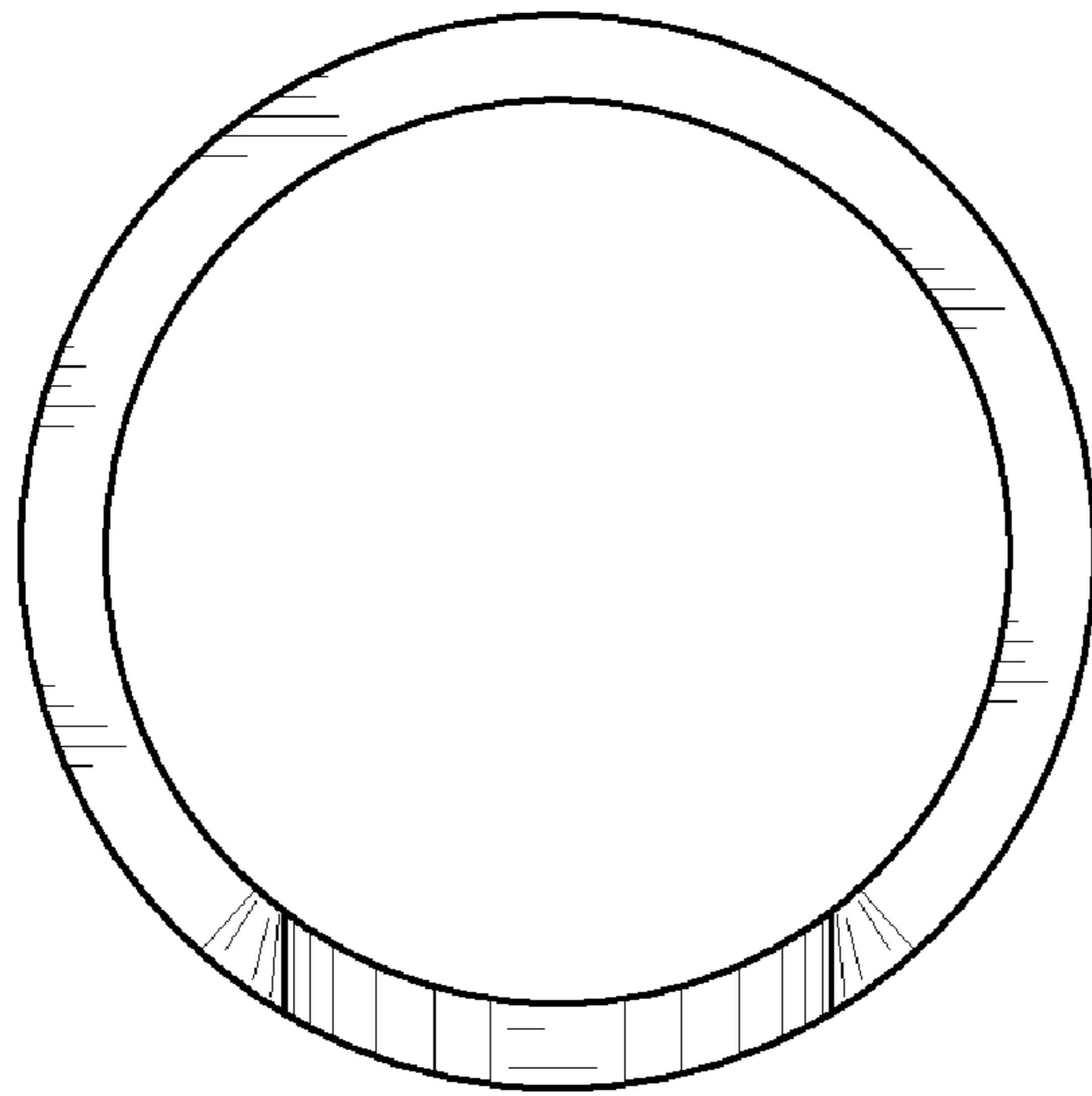

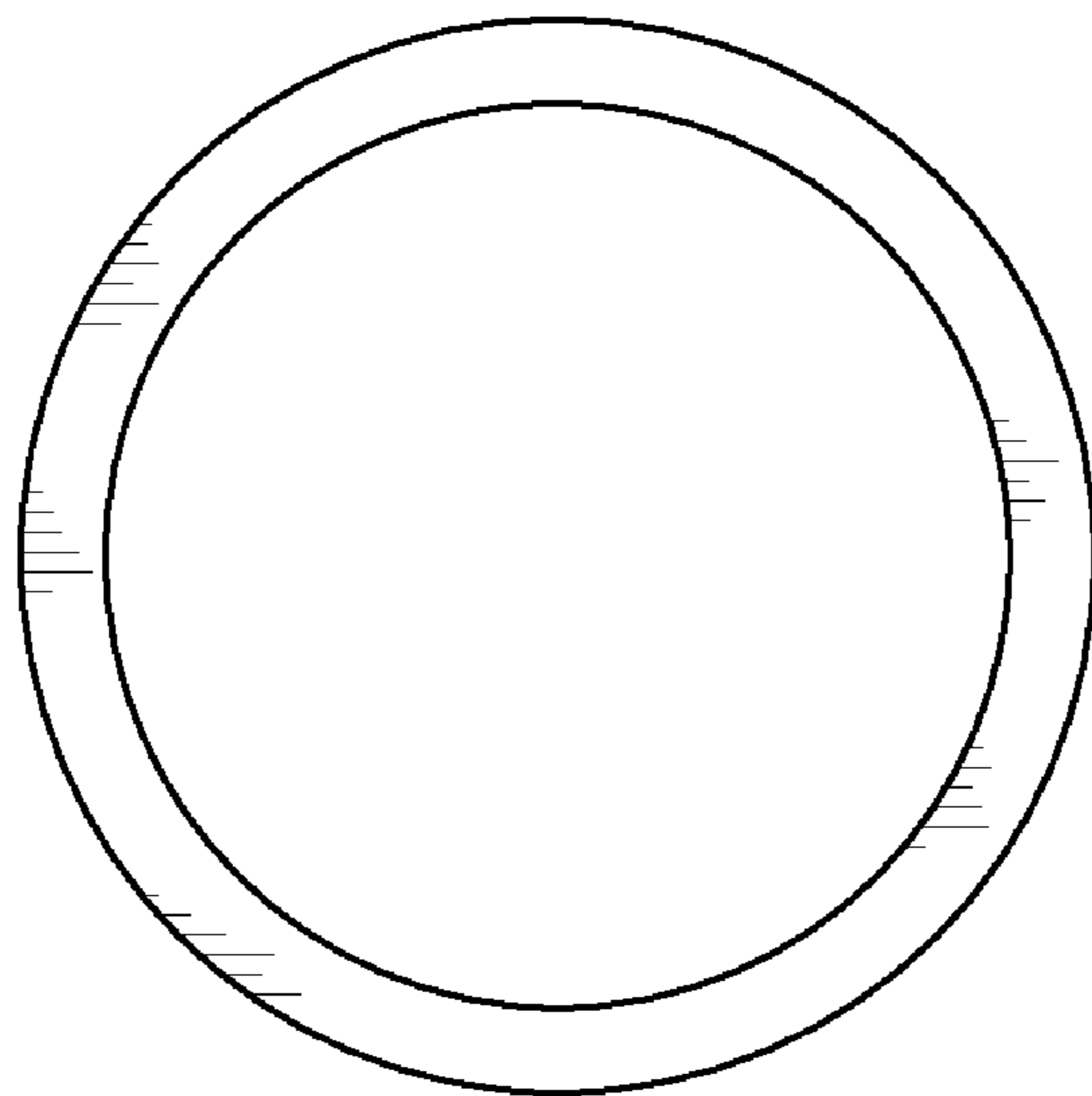
