DESCRIPTION

FIG. 1 is a top perspective view of the design for a food zester of the invention;

FIG. 2 is a top plan view of the food zester of FIG. 1;

FIG. 3 is a bottom plan view of the food zester of FIG. 1;

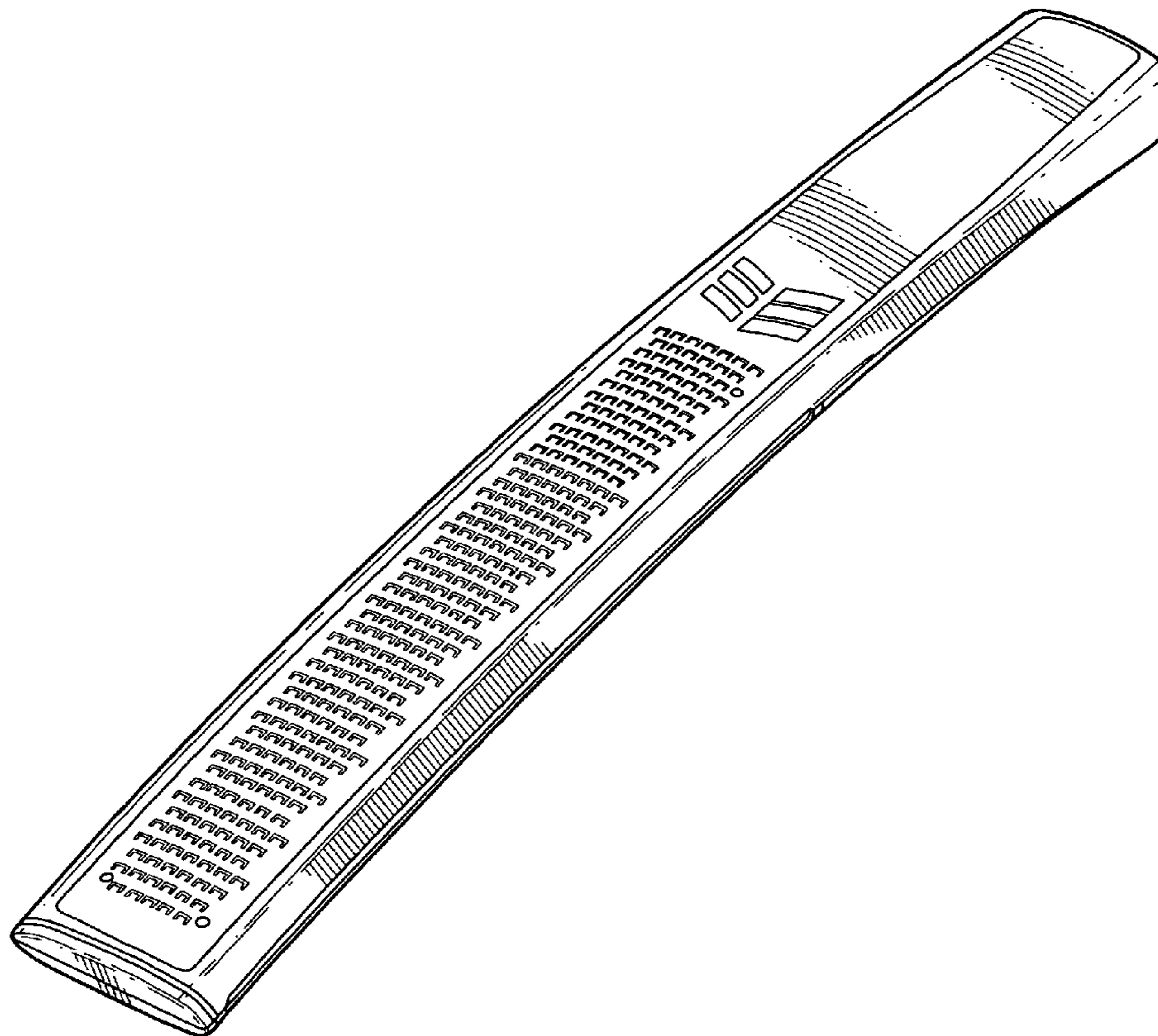
FIG. 4 is a right side elevational view, viewing FIG. 2, of the food zester of FIG. 1;

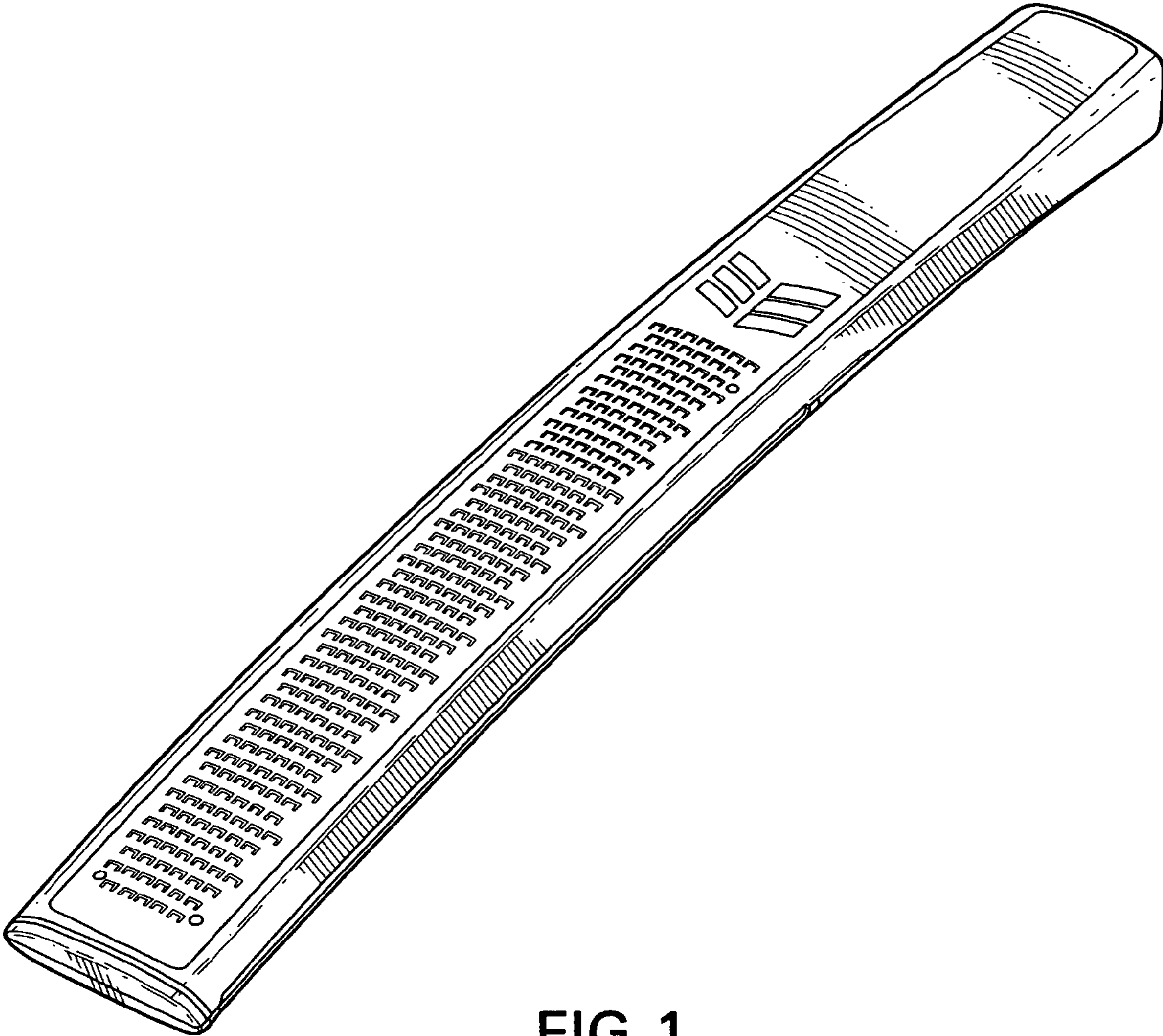

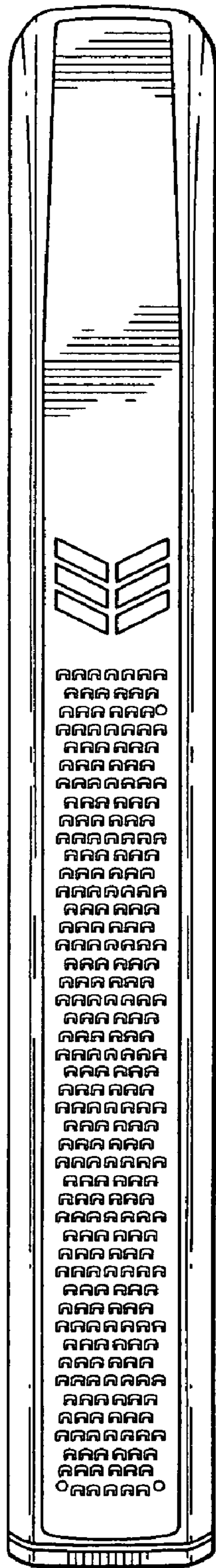

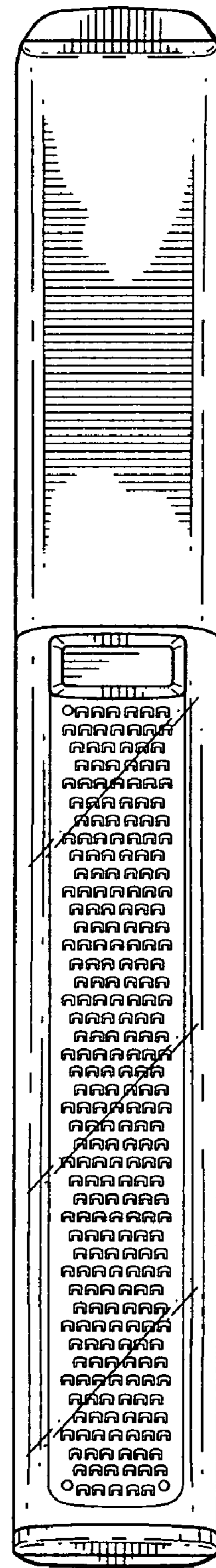

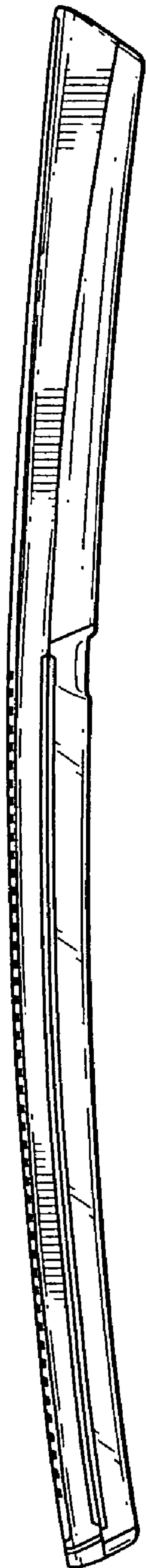

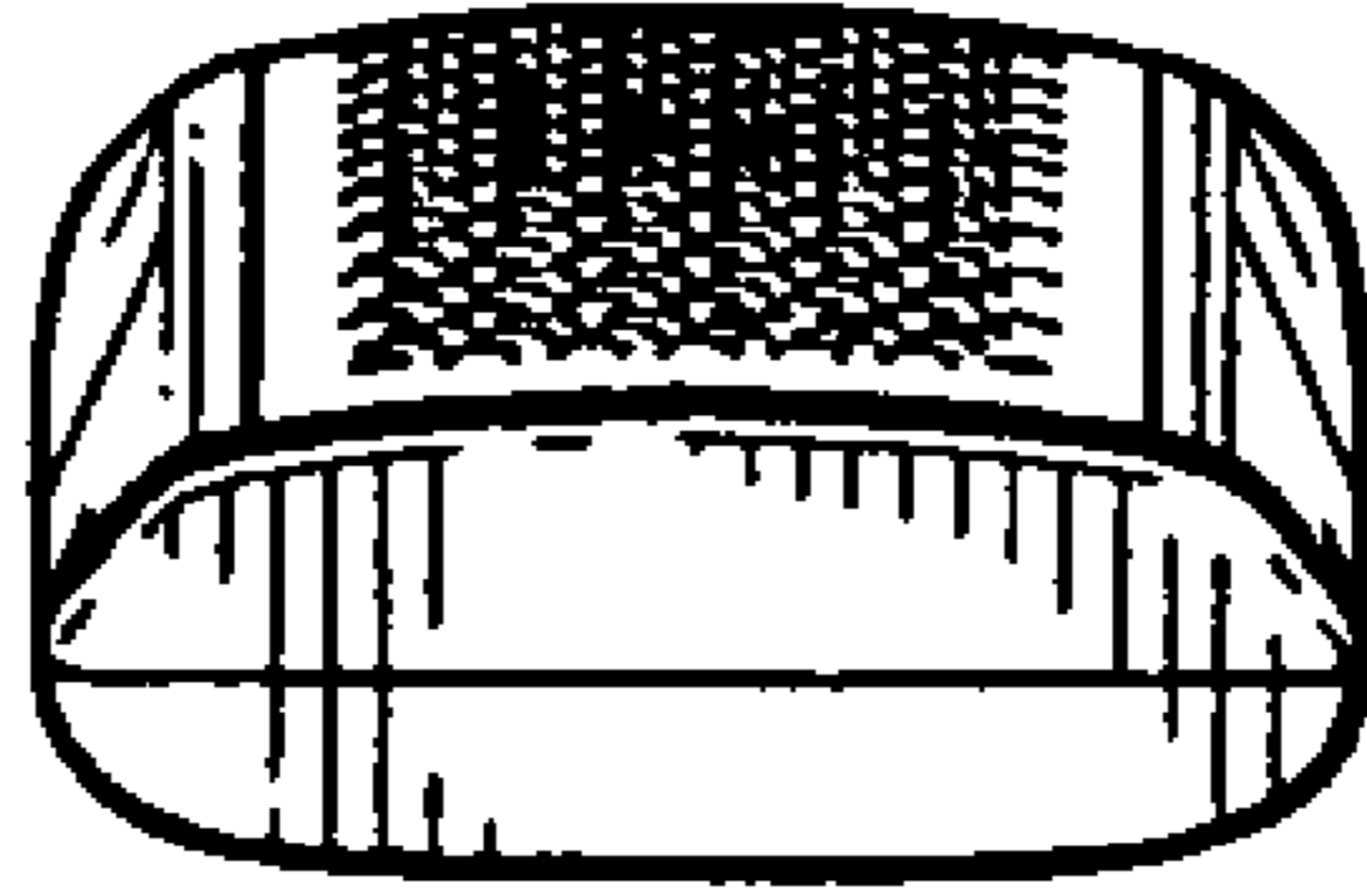

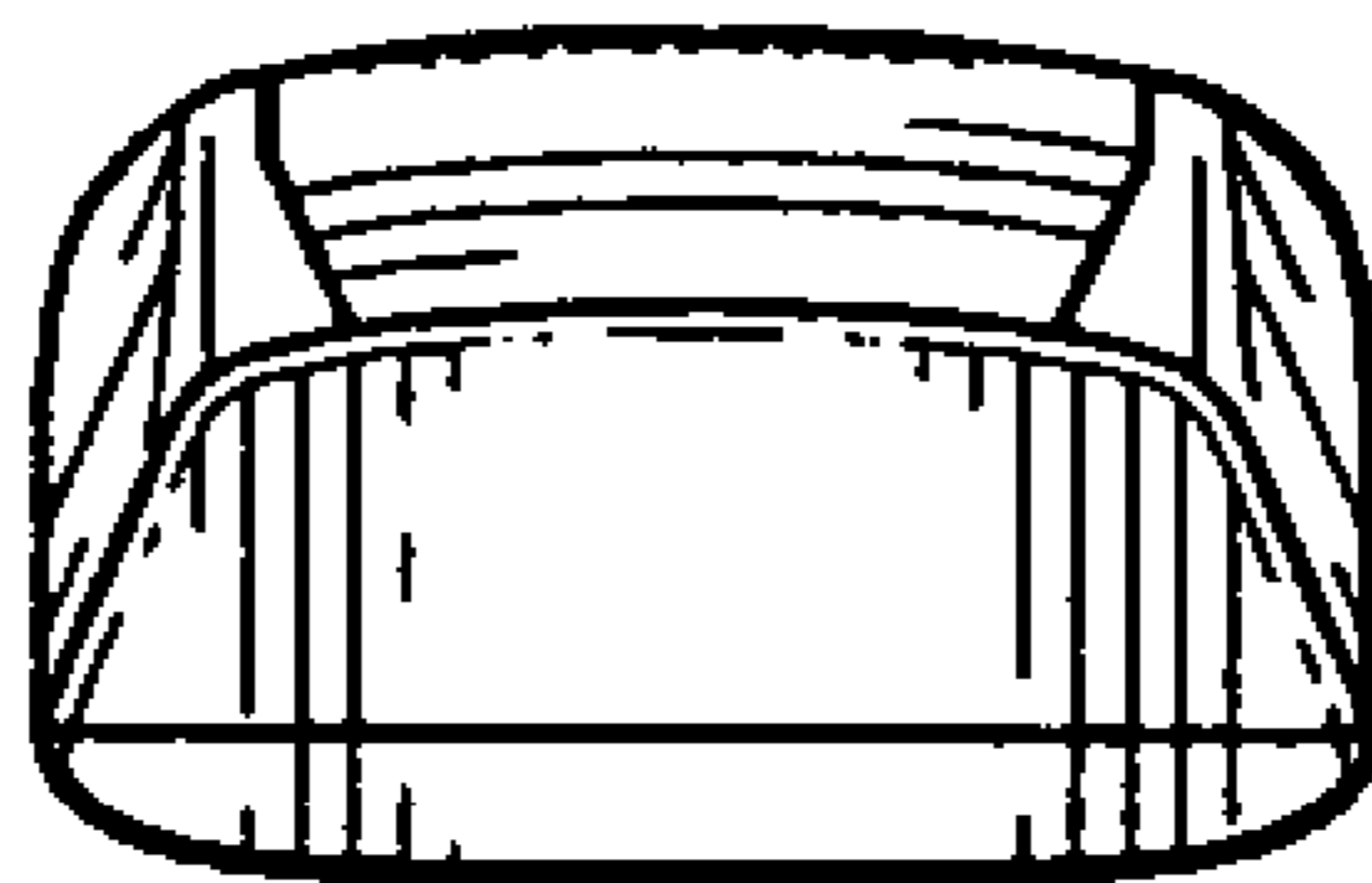
