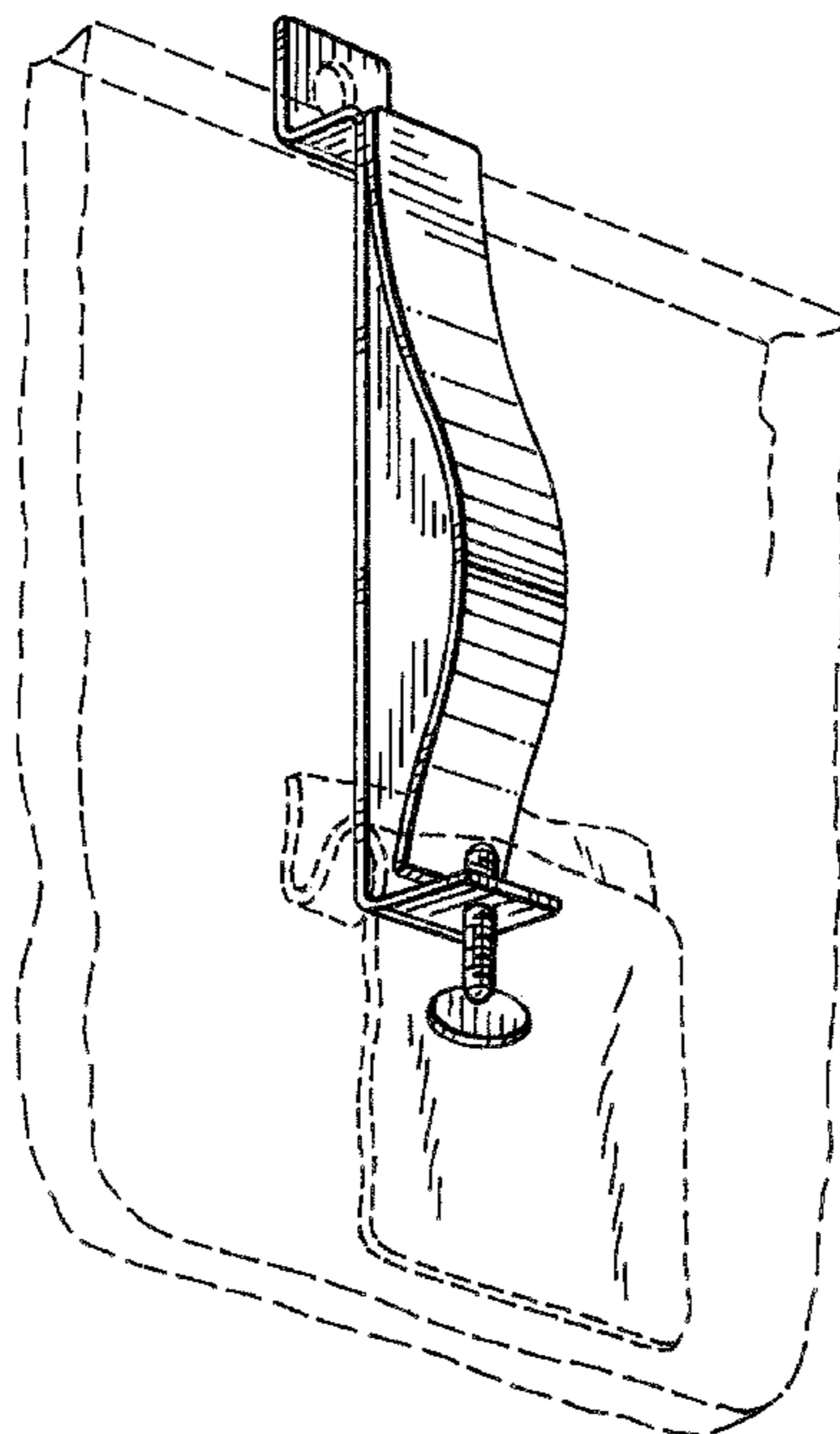
FIG. 1 is a front, left side and bottom perspective view show-

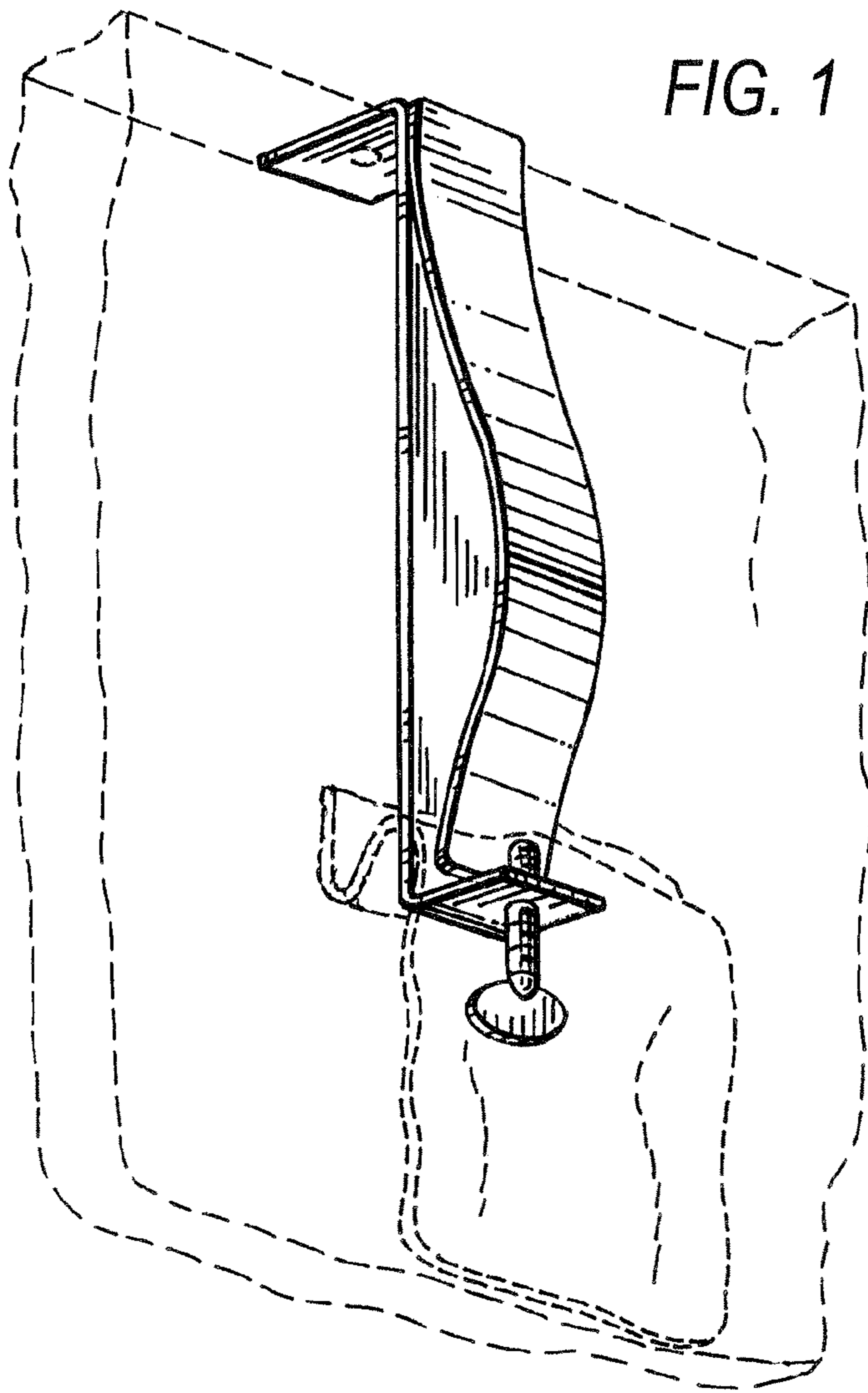

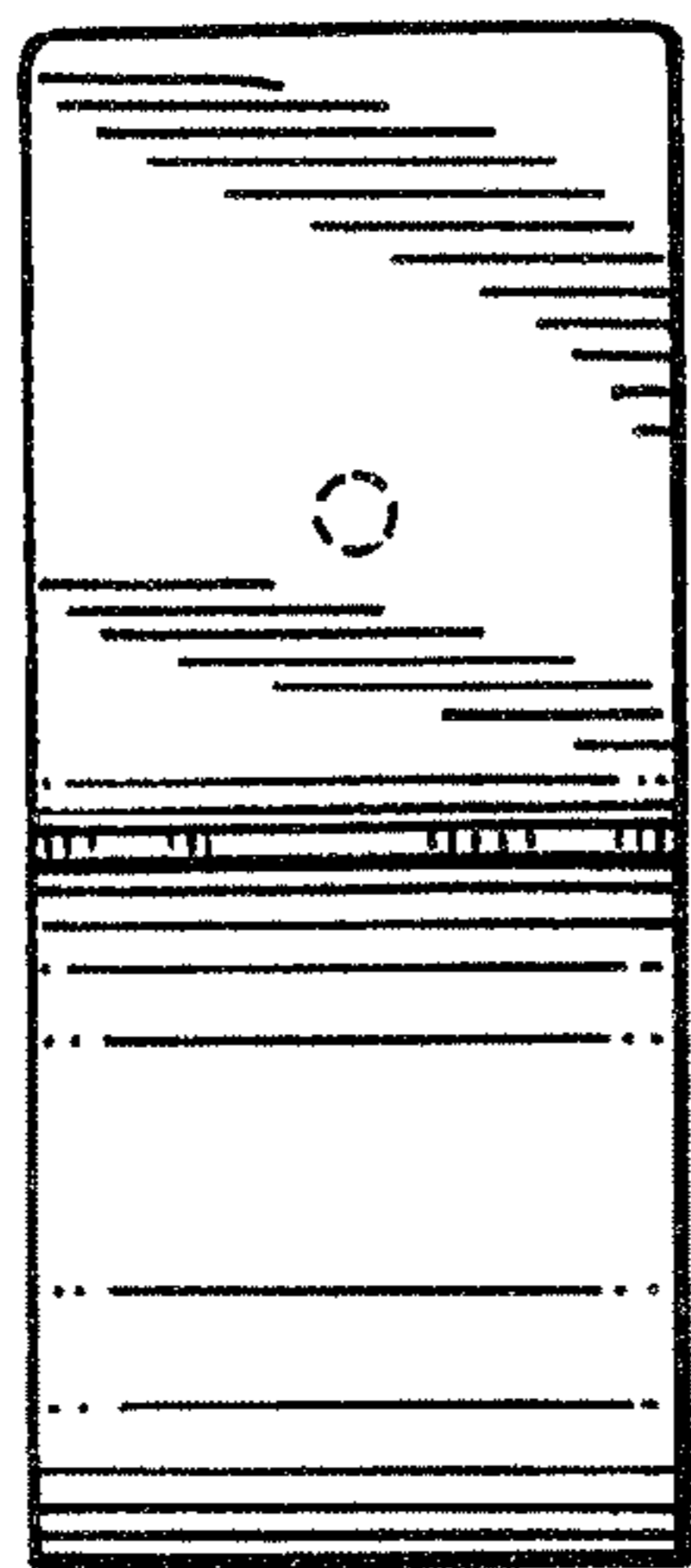

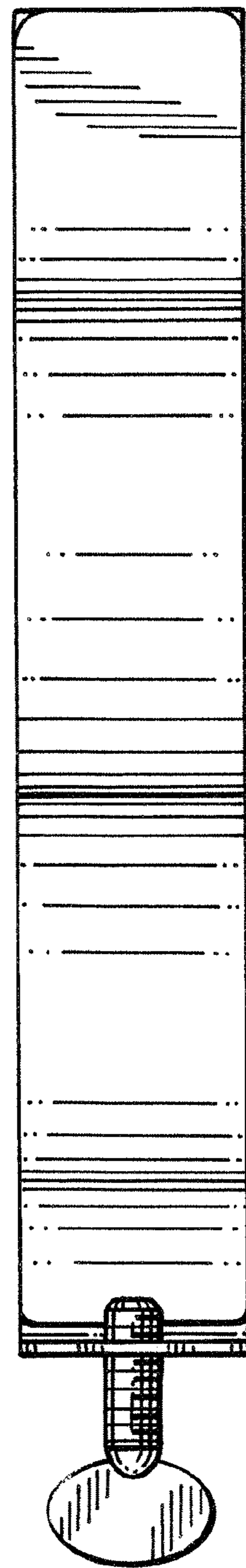

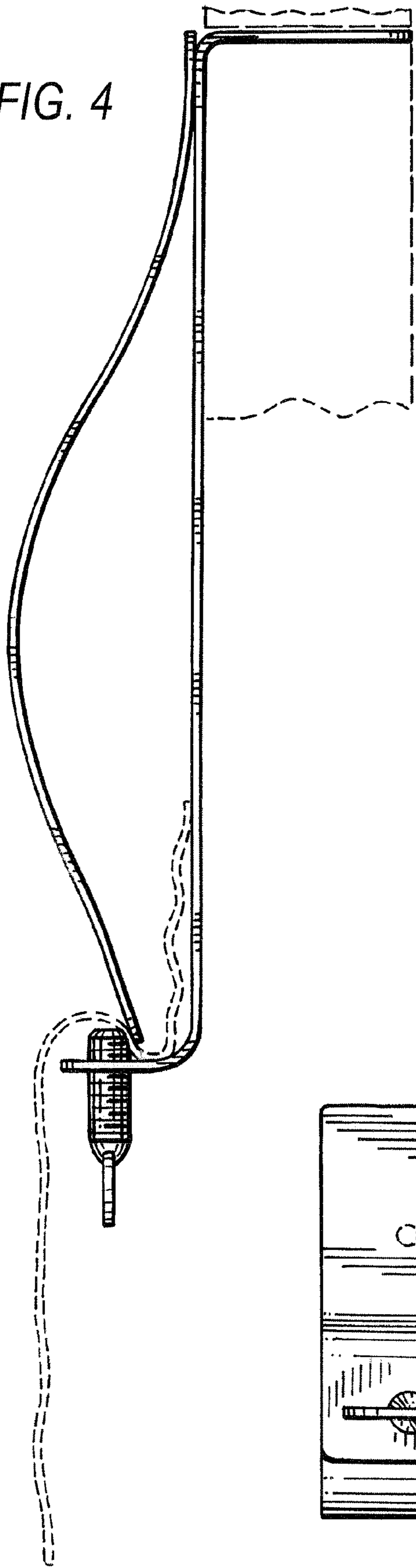

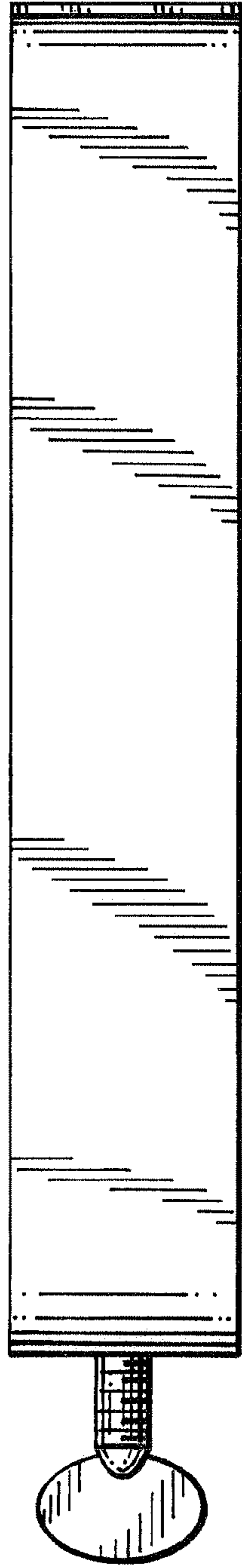
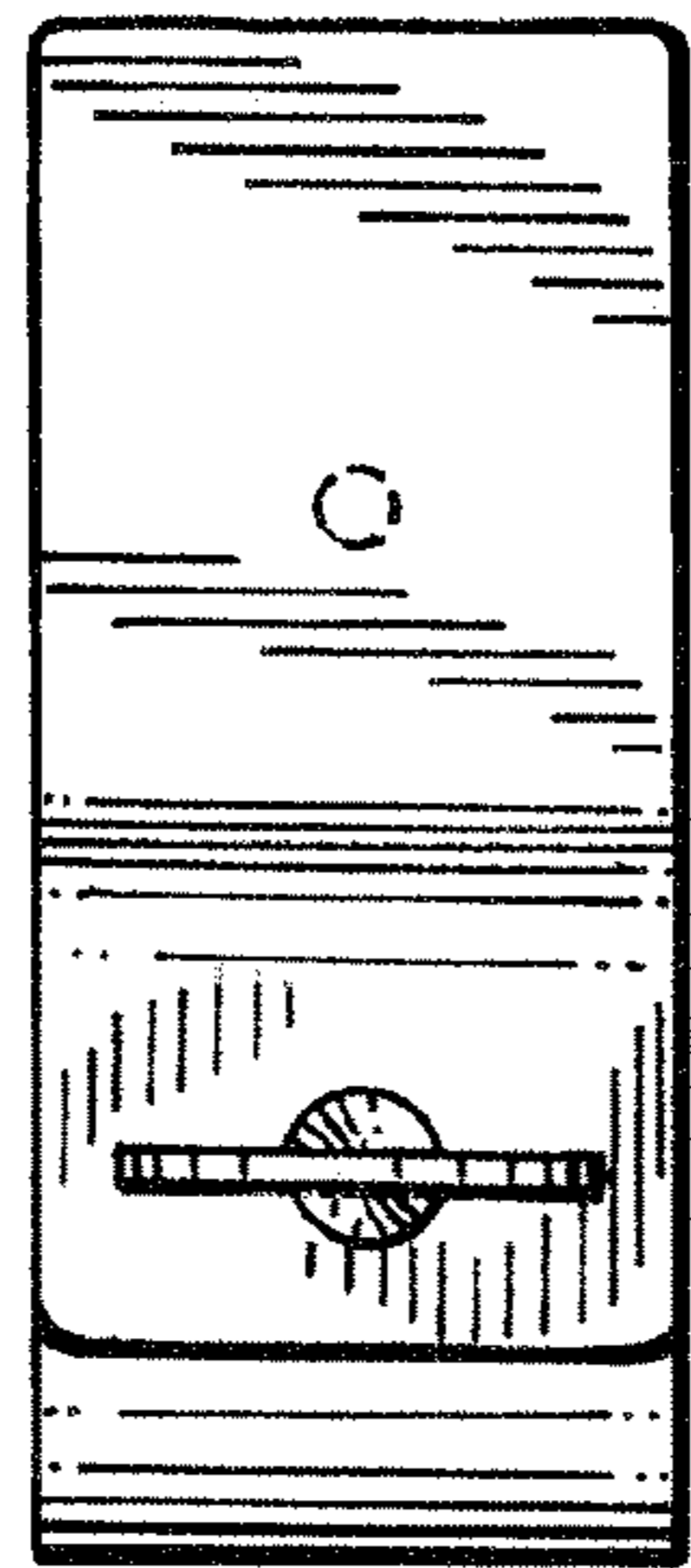

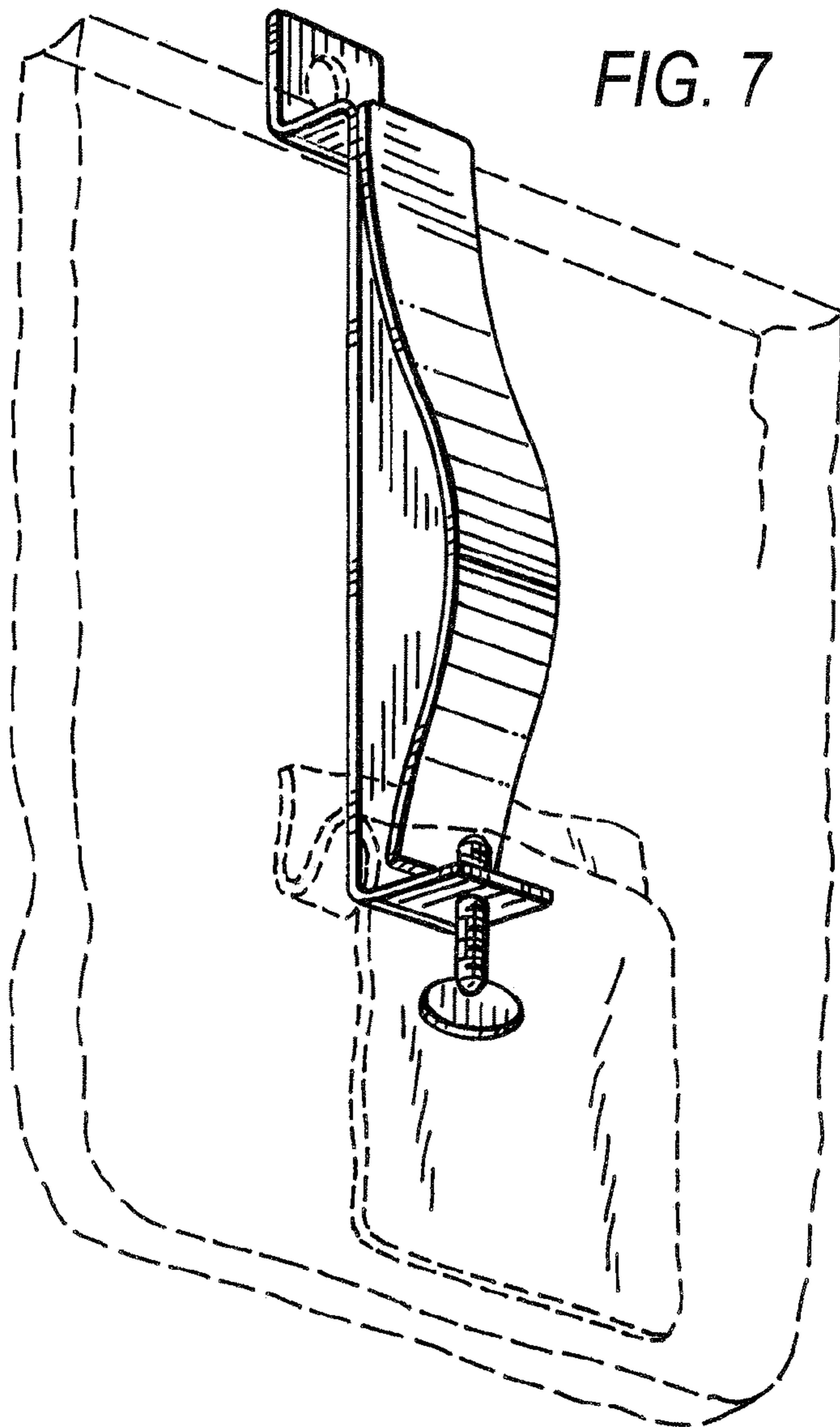
