The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a bottle showing my new design, with a stopper top shown in phantom for environmental purposes and forming no part of the claimed design.

FIG. 2 is a front elevation view thereof, all other sides being mirror images thereof;

FIG. 3 is a top plan view thereof;

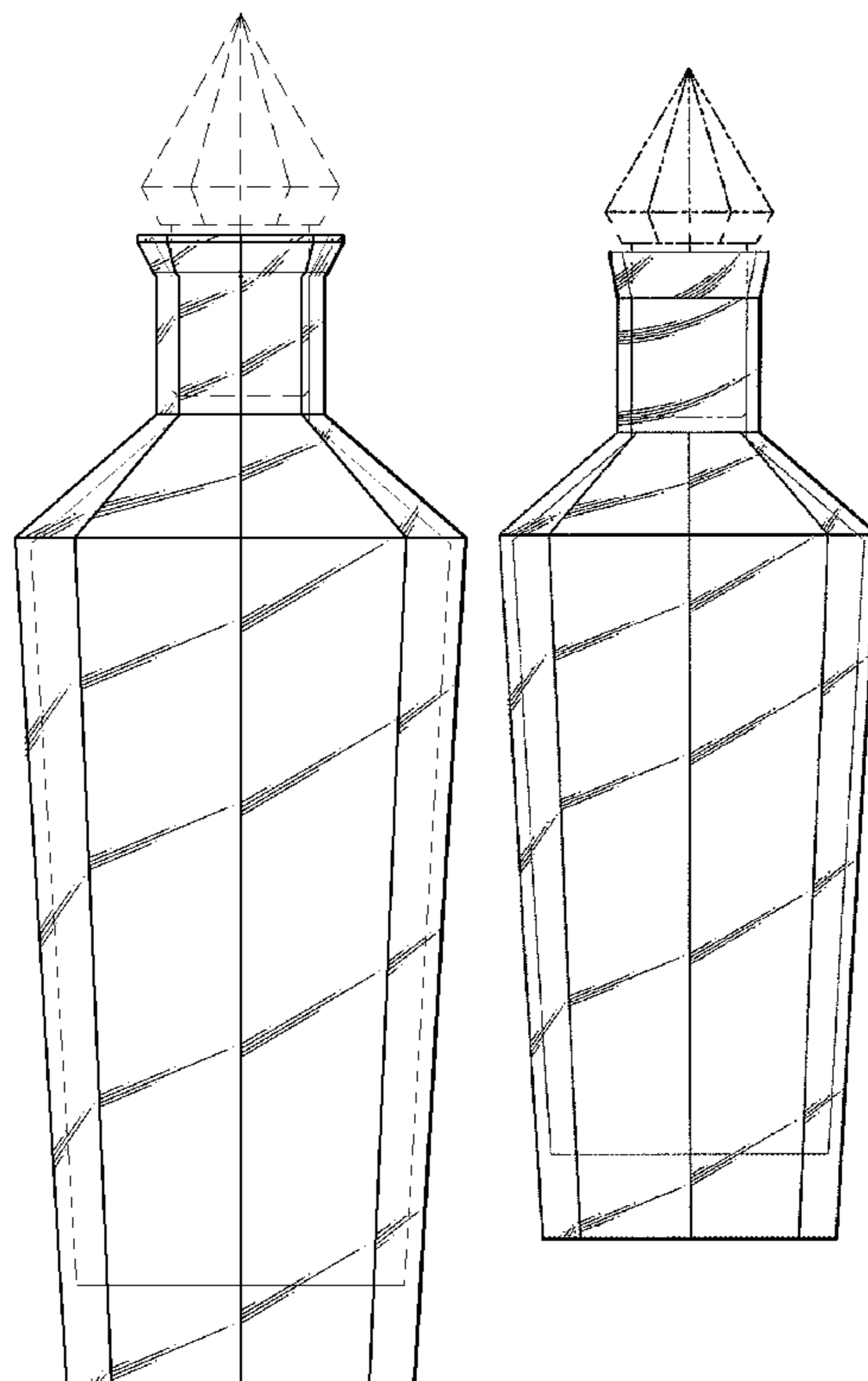
FIG. 4 is a bottom plan view thereof;

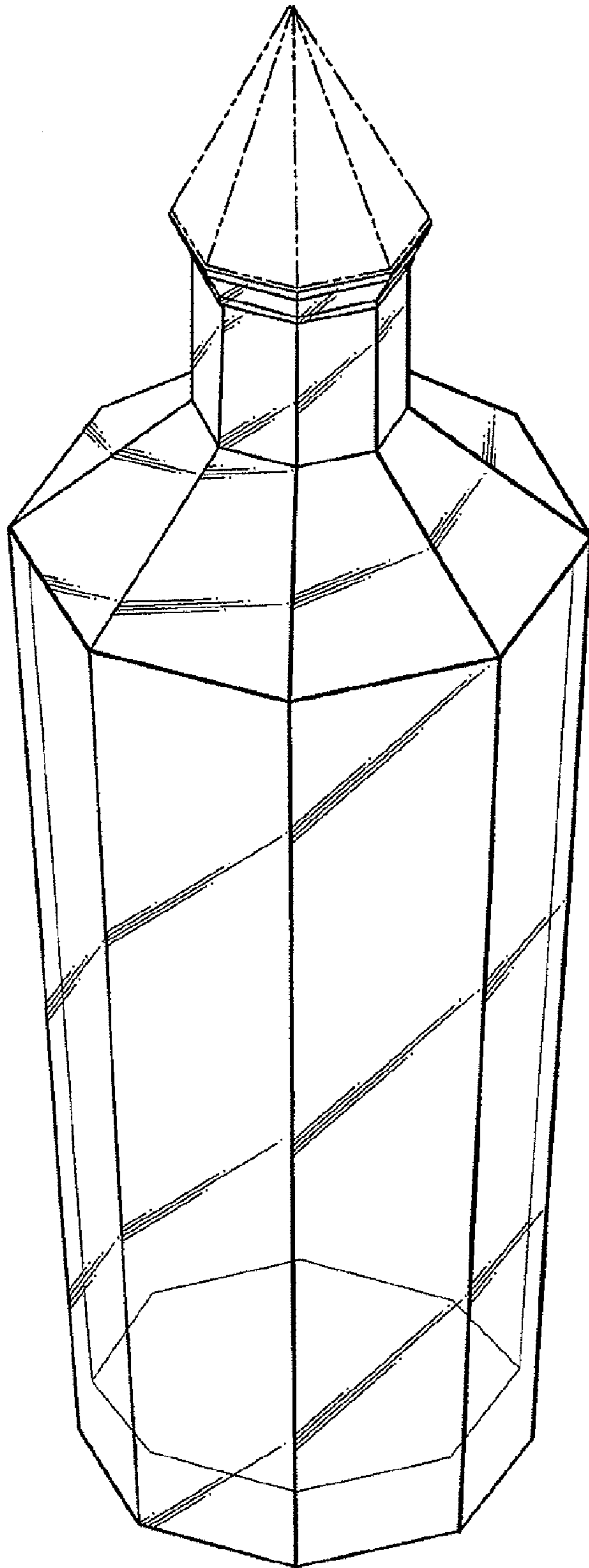

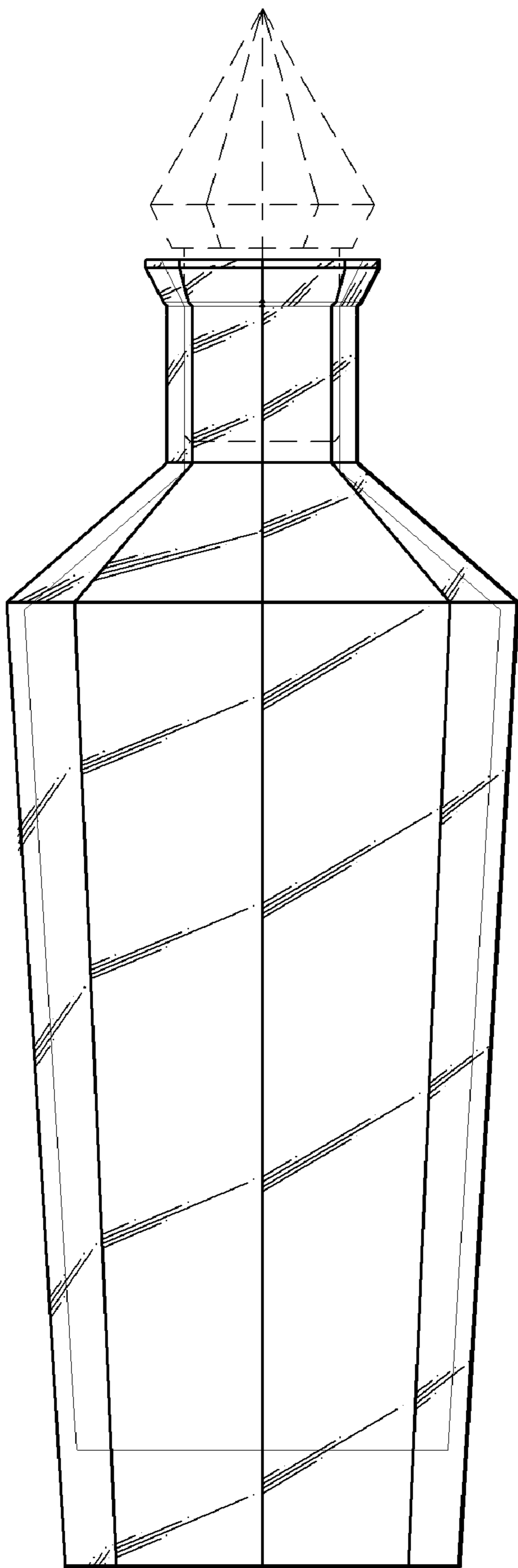

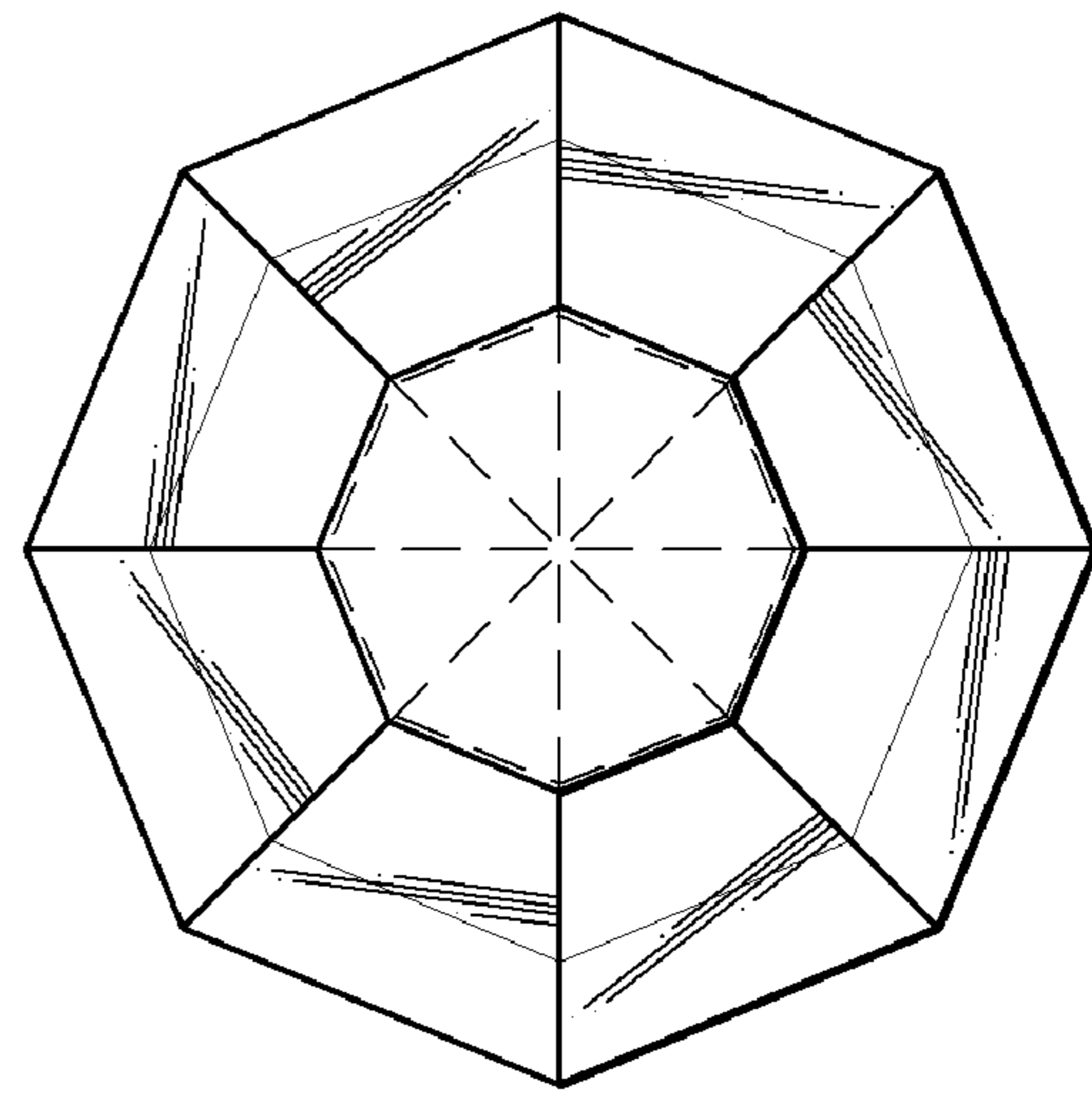

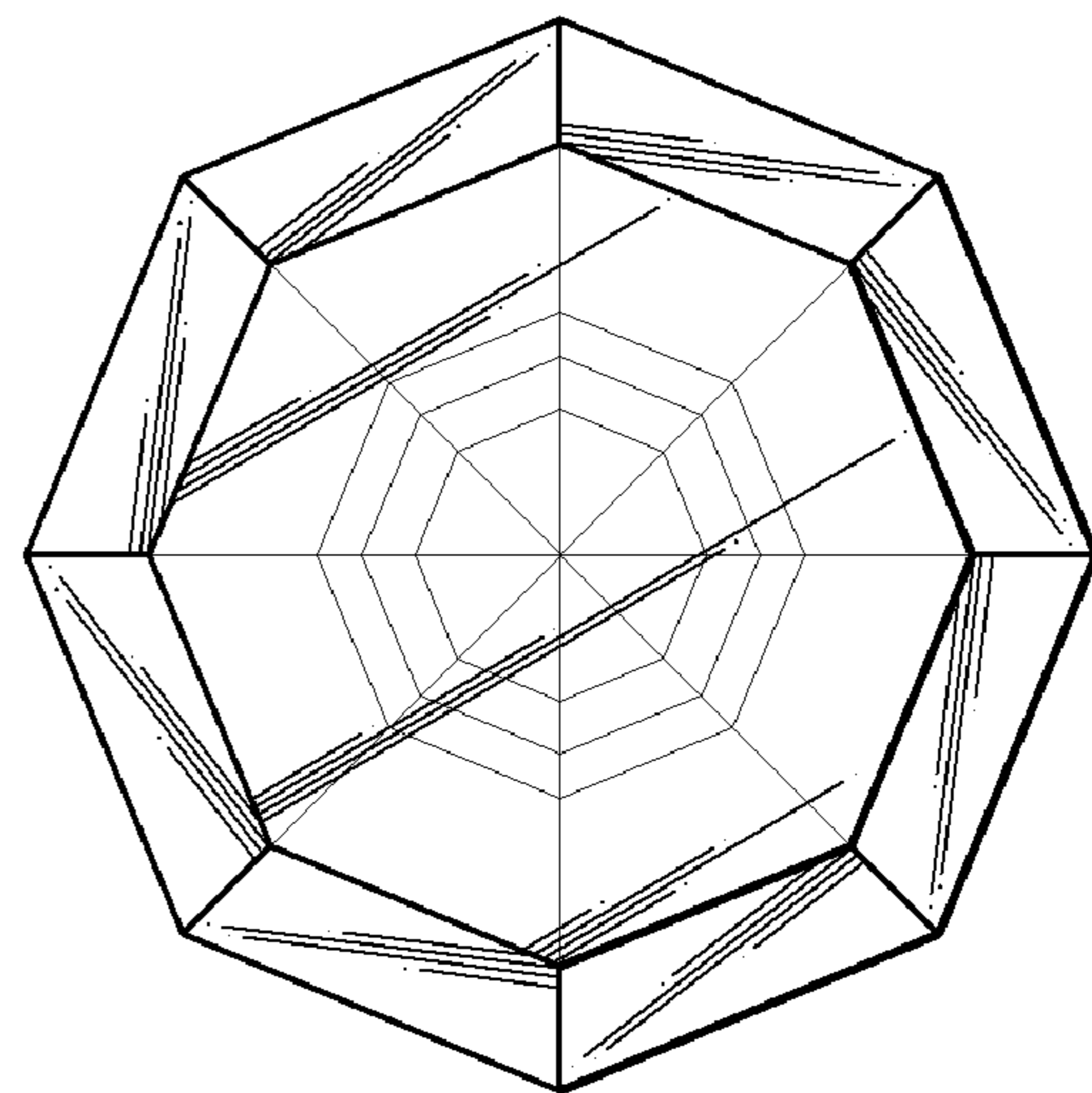

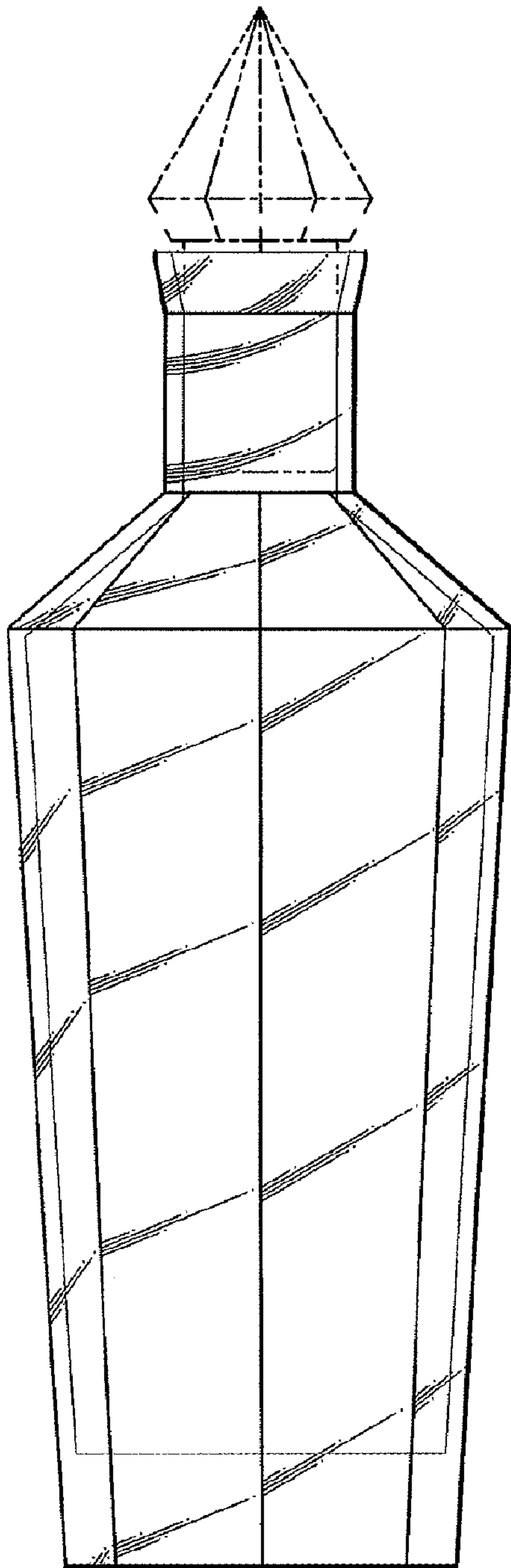

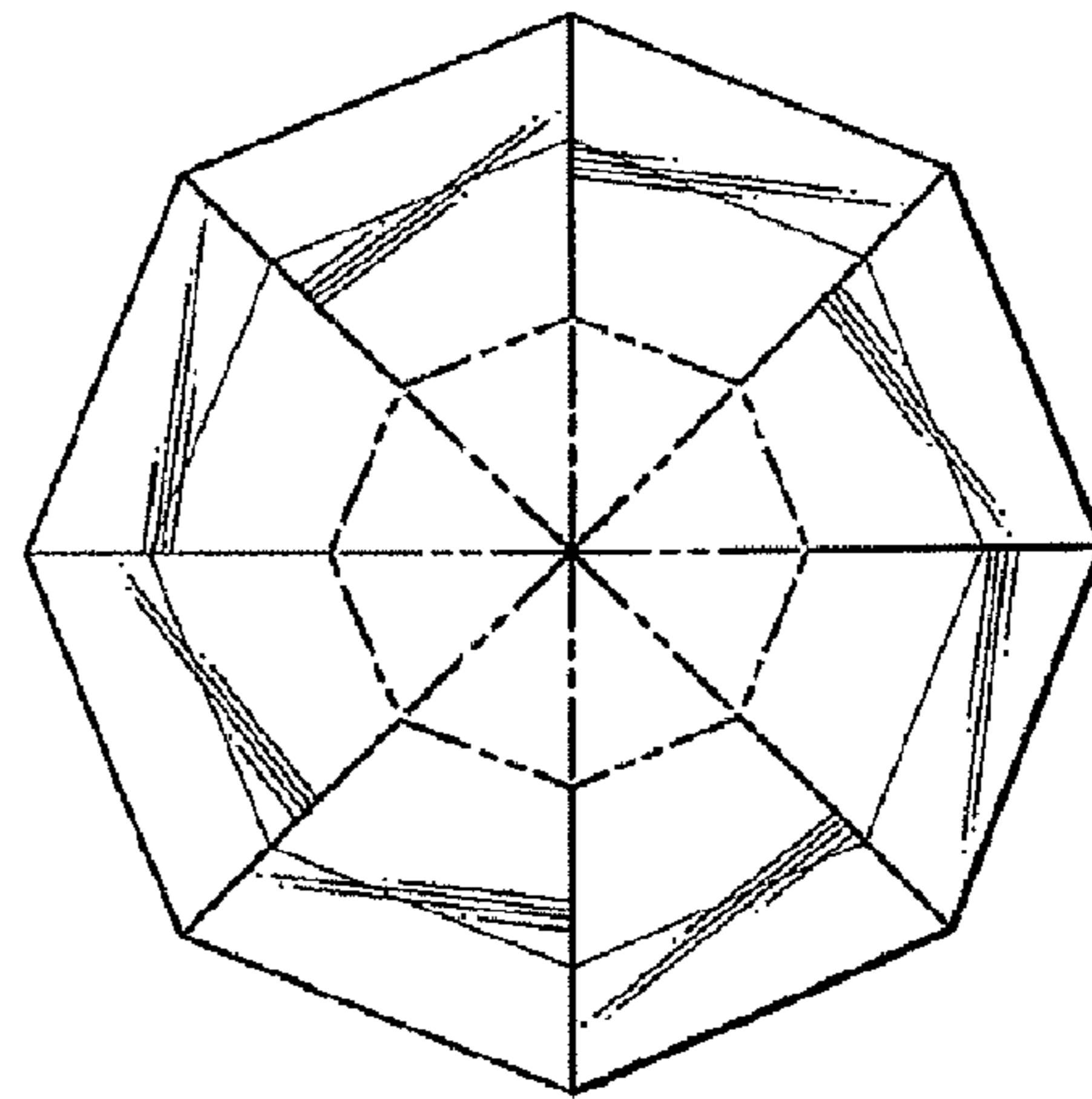

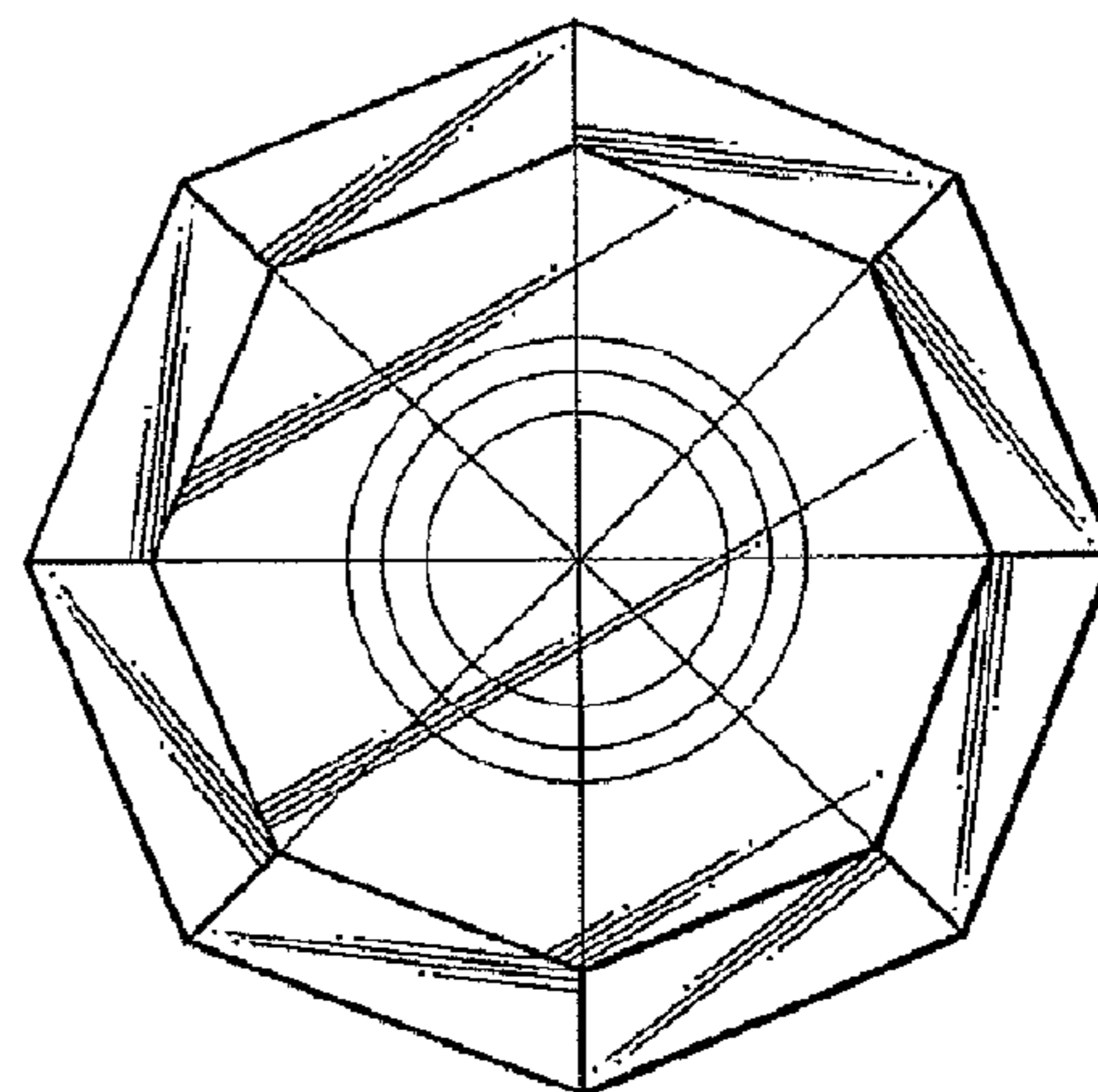
