(57) **CLAIM**

The ornamental design for a clip earring, as shown and described.

DESCRIPTION

FIG. 1 is a front right perspective view of a clip earring illustrating the new design;

FIG. 2 is a front view of the clip earring illustrated in FIG. 1;

FIG. 3 is a rear perspective view of the clip earring illustrated in FIG. 1;

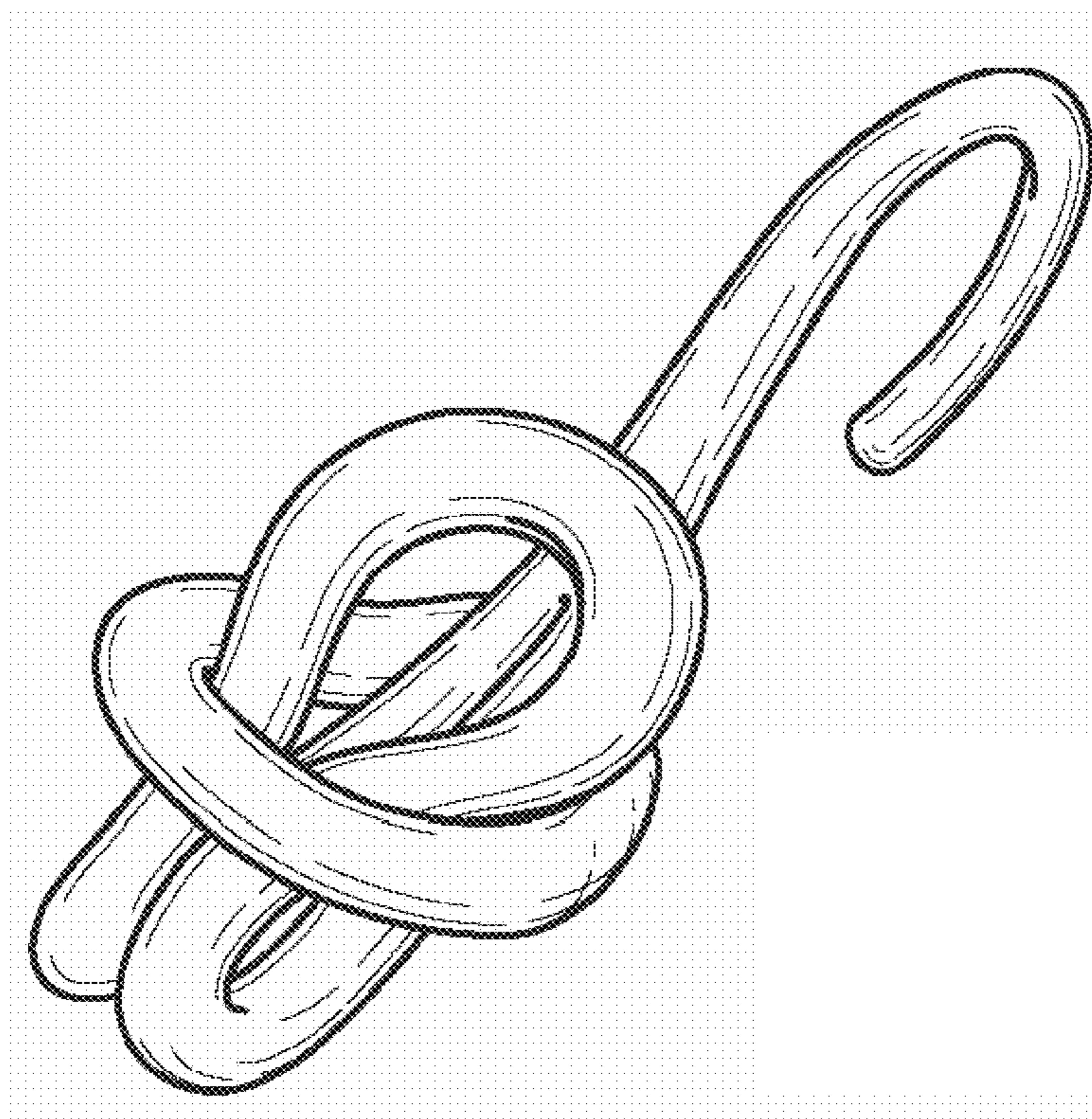
FIG. 4 is a right side perspective view of the clip earring illustrated in FIG. 1 (the left side perspective view is a mirror image of FIG. 4);

FIG. 5 is a bottom view of the clip earring shown in FIG. 1;

FIG. 6 is a right side elevational view of the clip earring illustrated in FIG. 1 (the left side elevational view is a mirror image of FIG. 6); and,

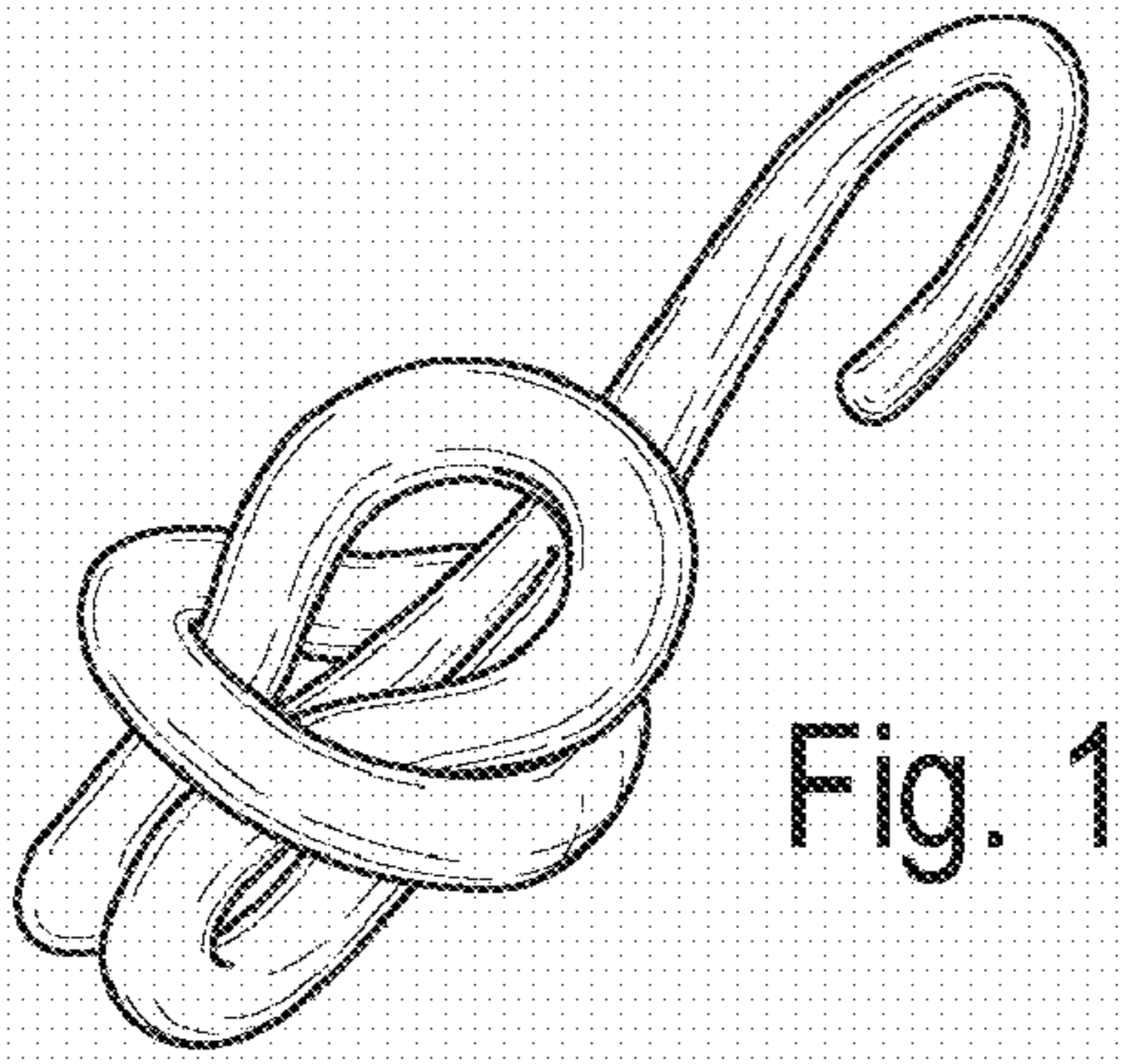

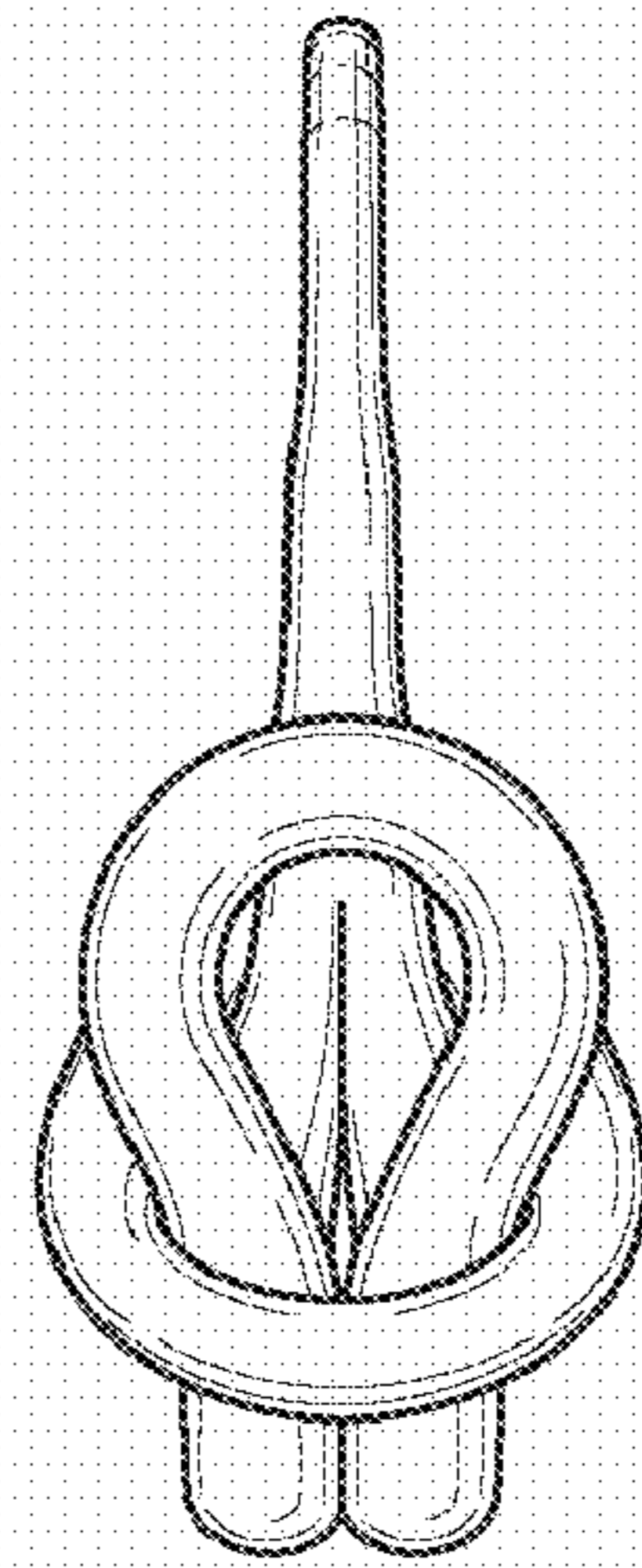

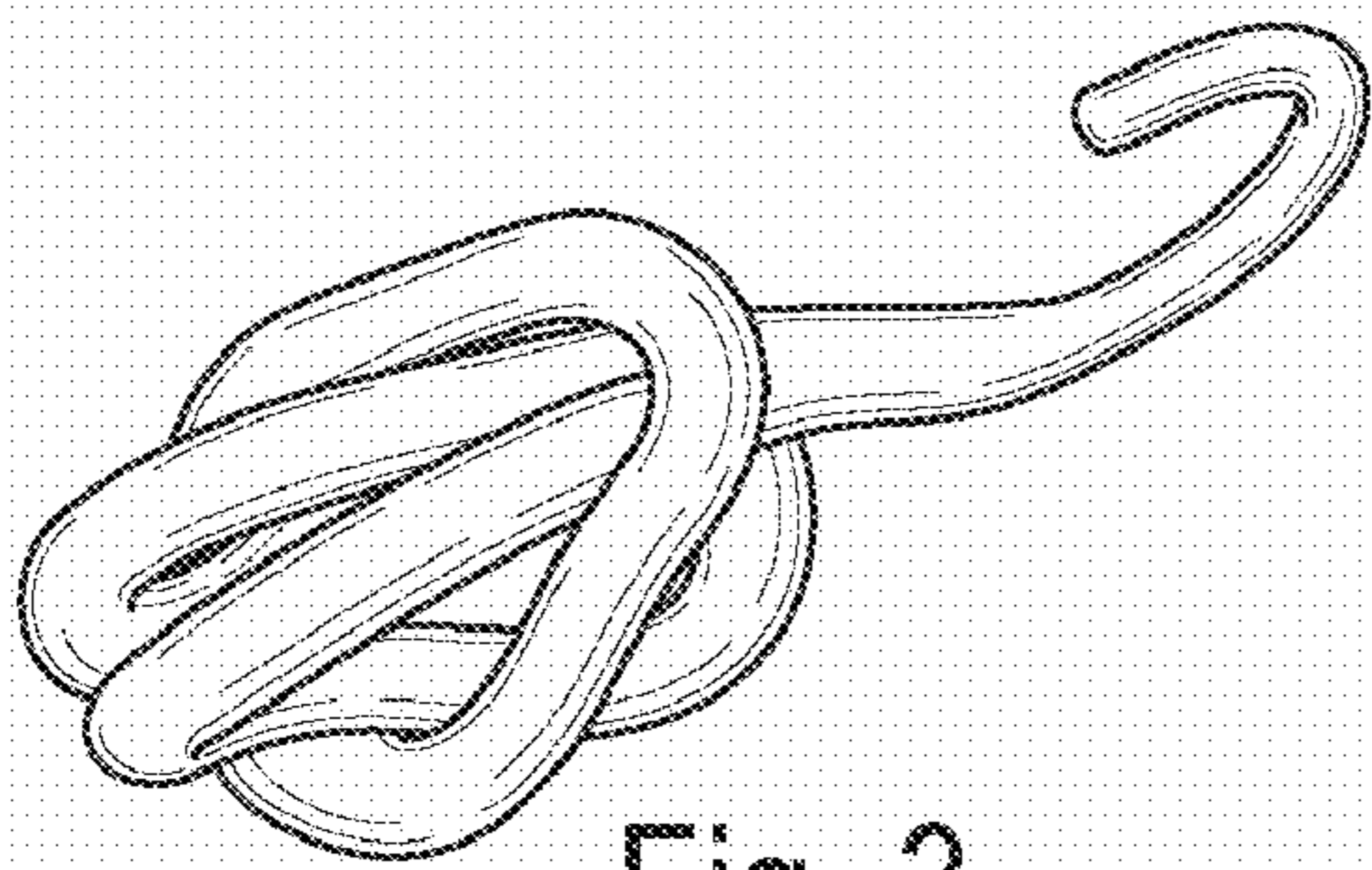

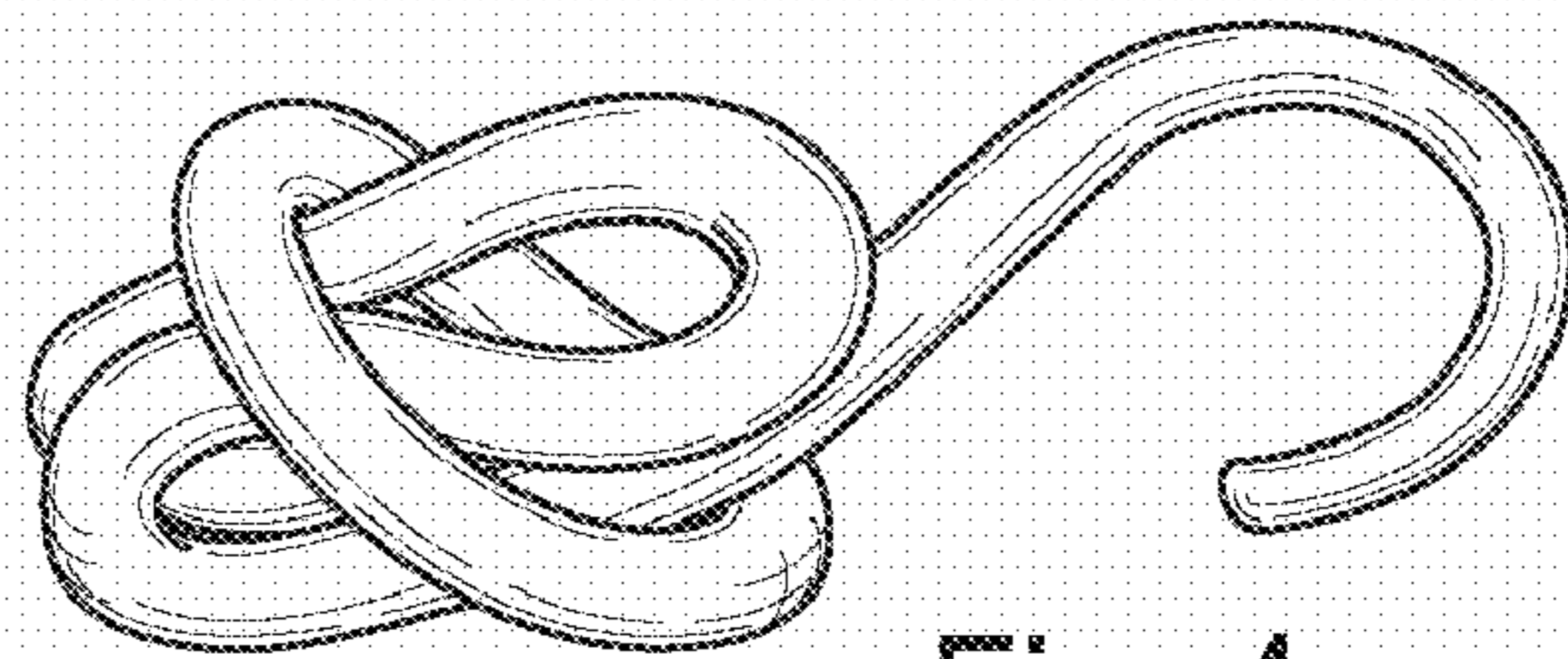

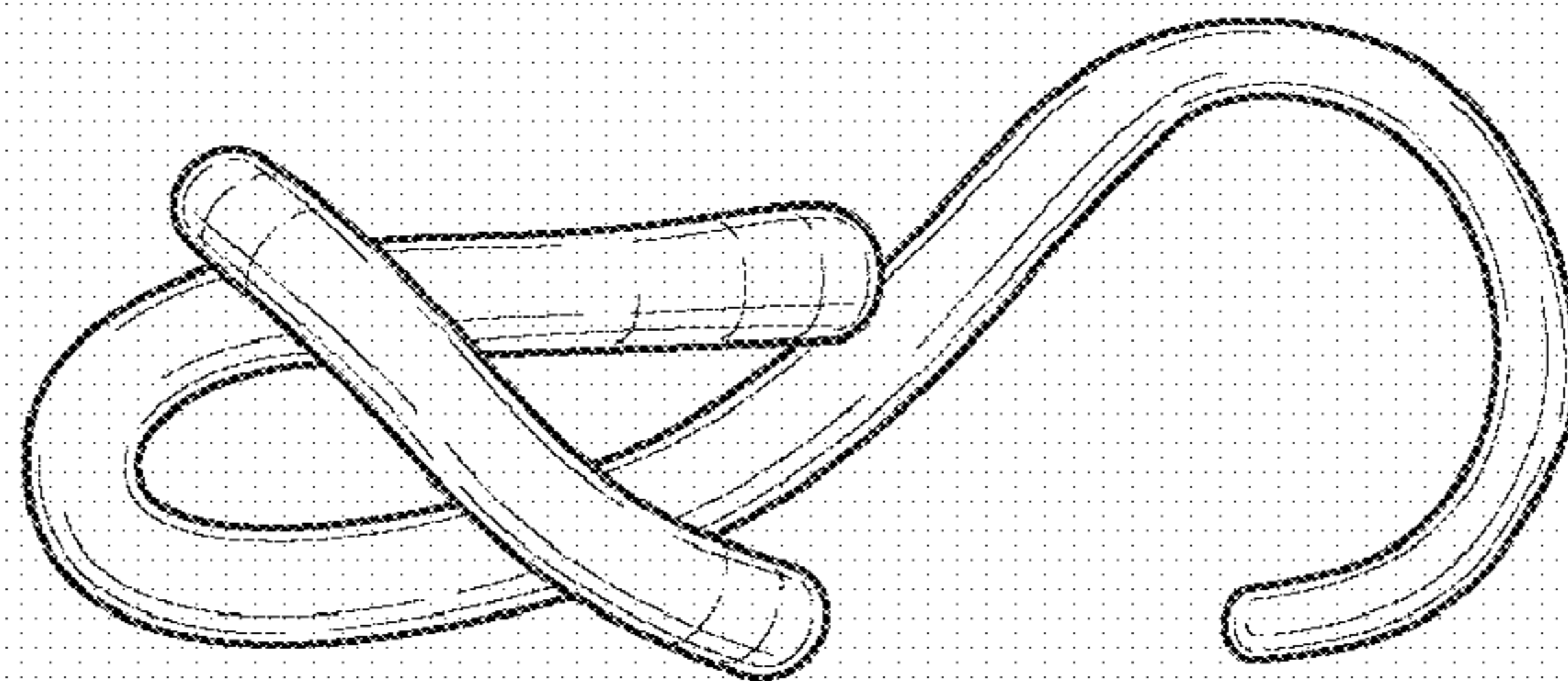

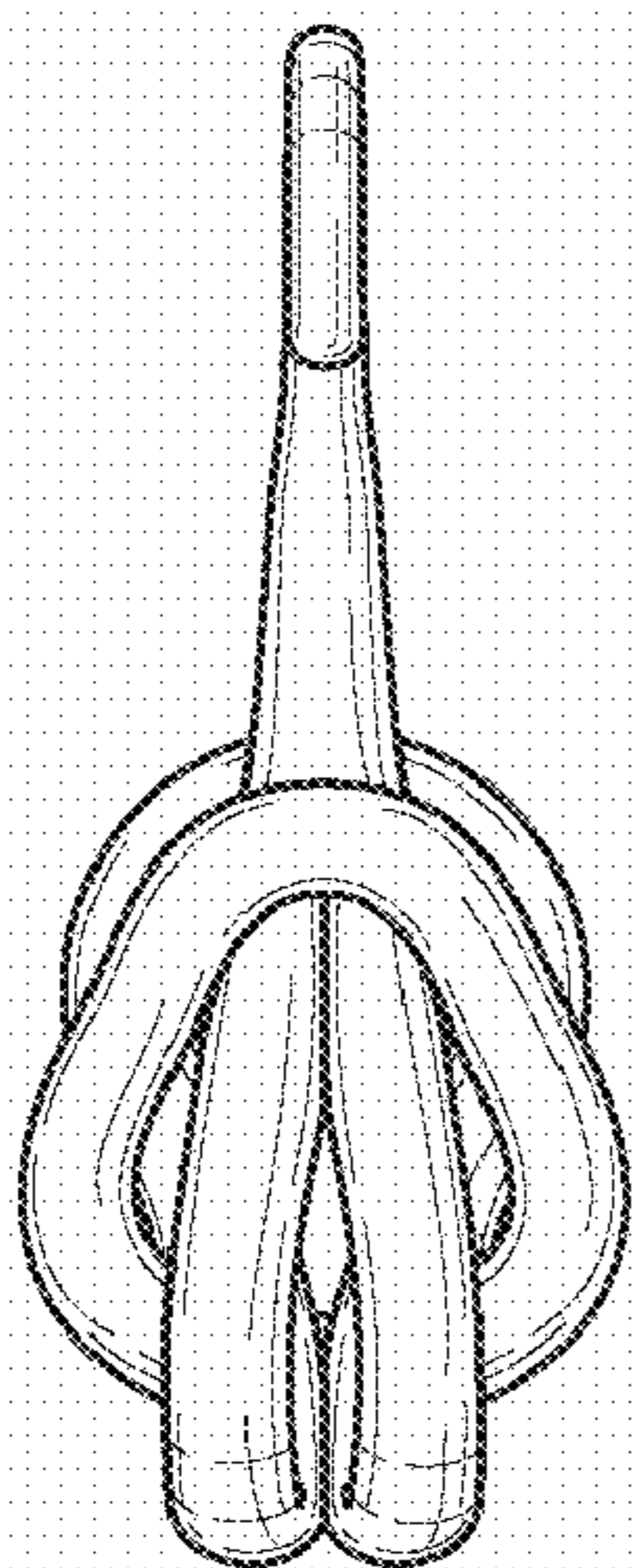

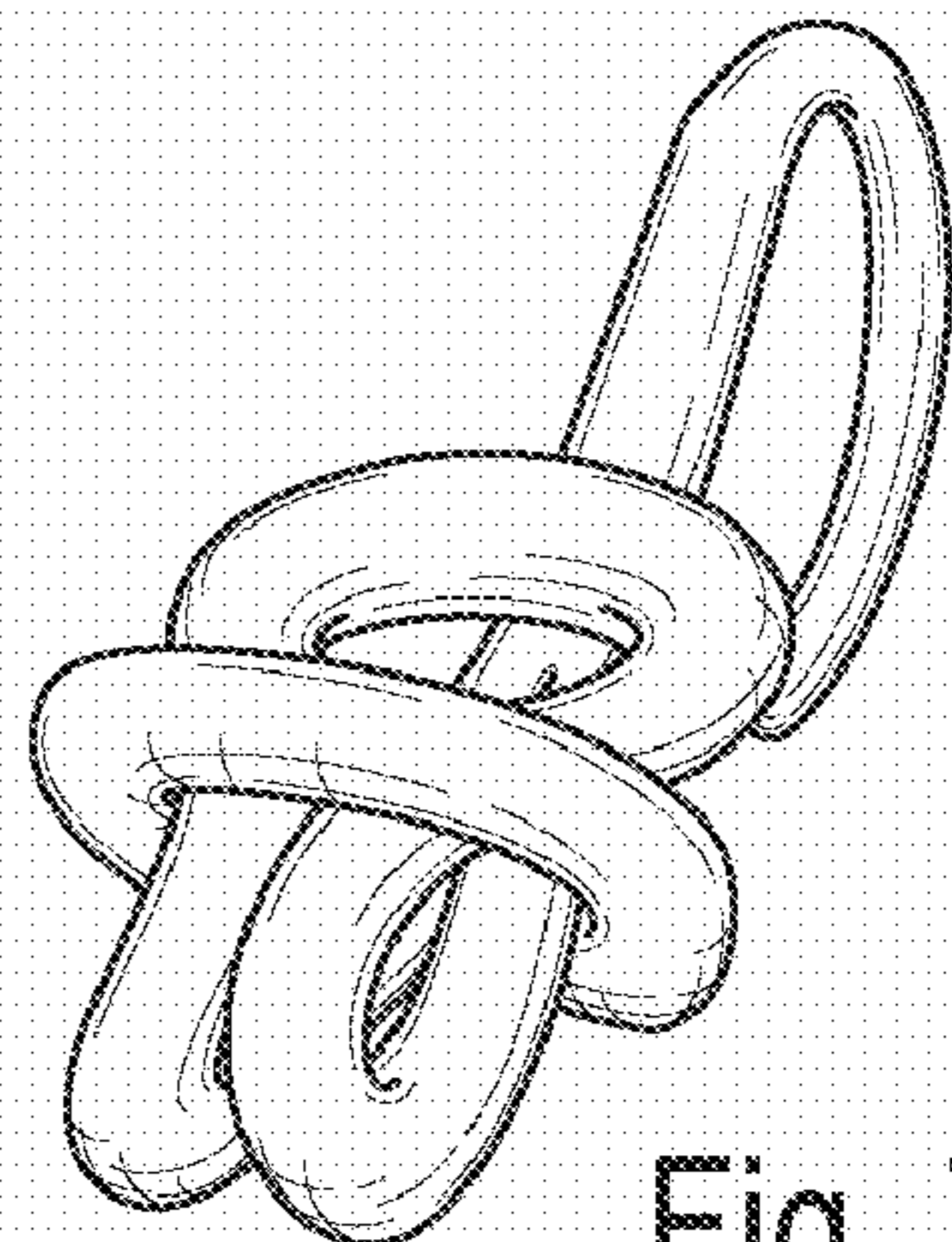
