FIG. 4 is a left side orthogonal view thereof;

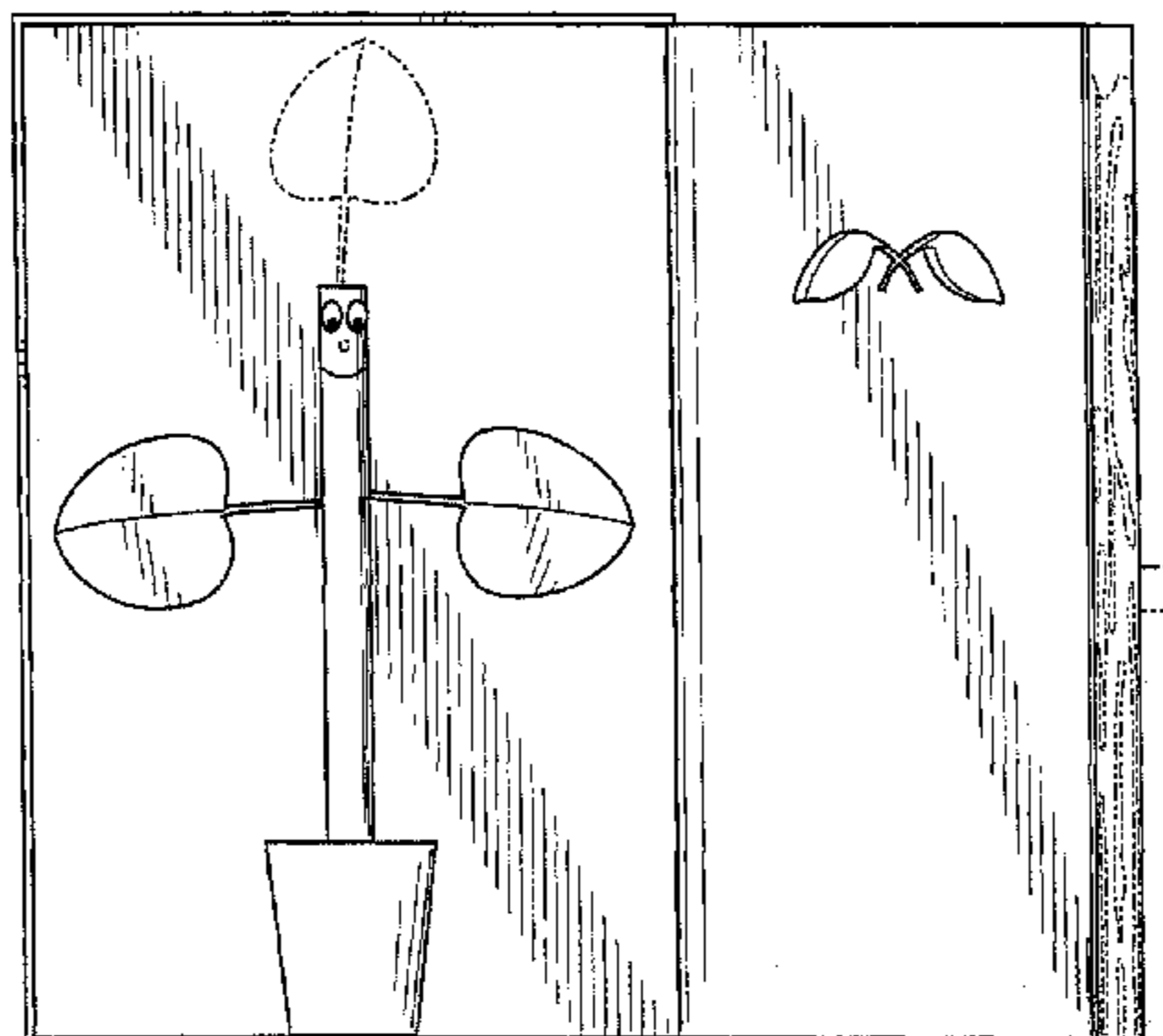
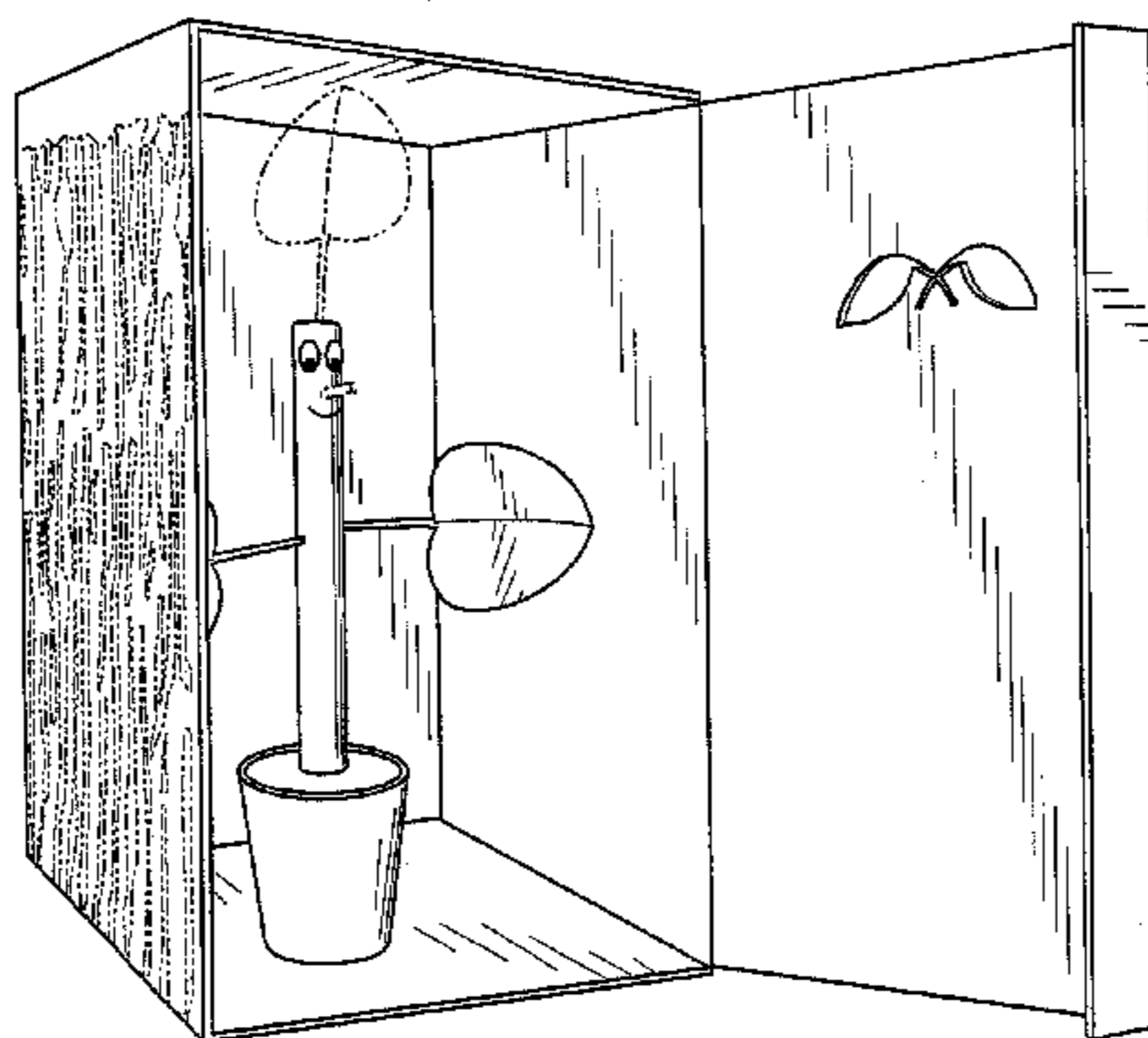
FIG. 5 is a right side orthogonal view thereof;

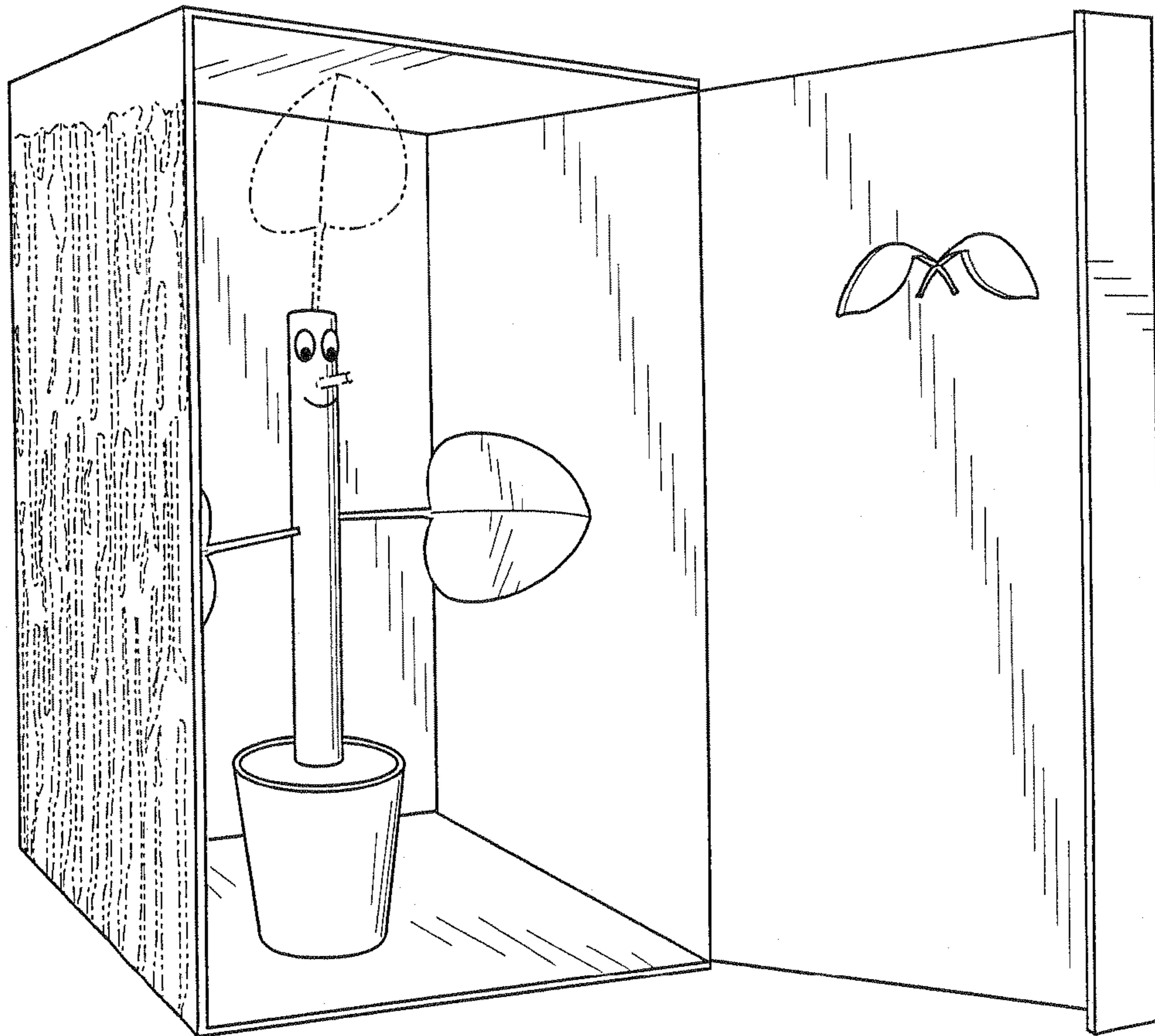
FIG. 6 is a top orthogonal view thereof; and,

FIG. 7 is a bottom orthogonal view thereof.

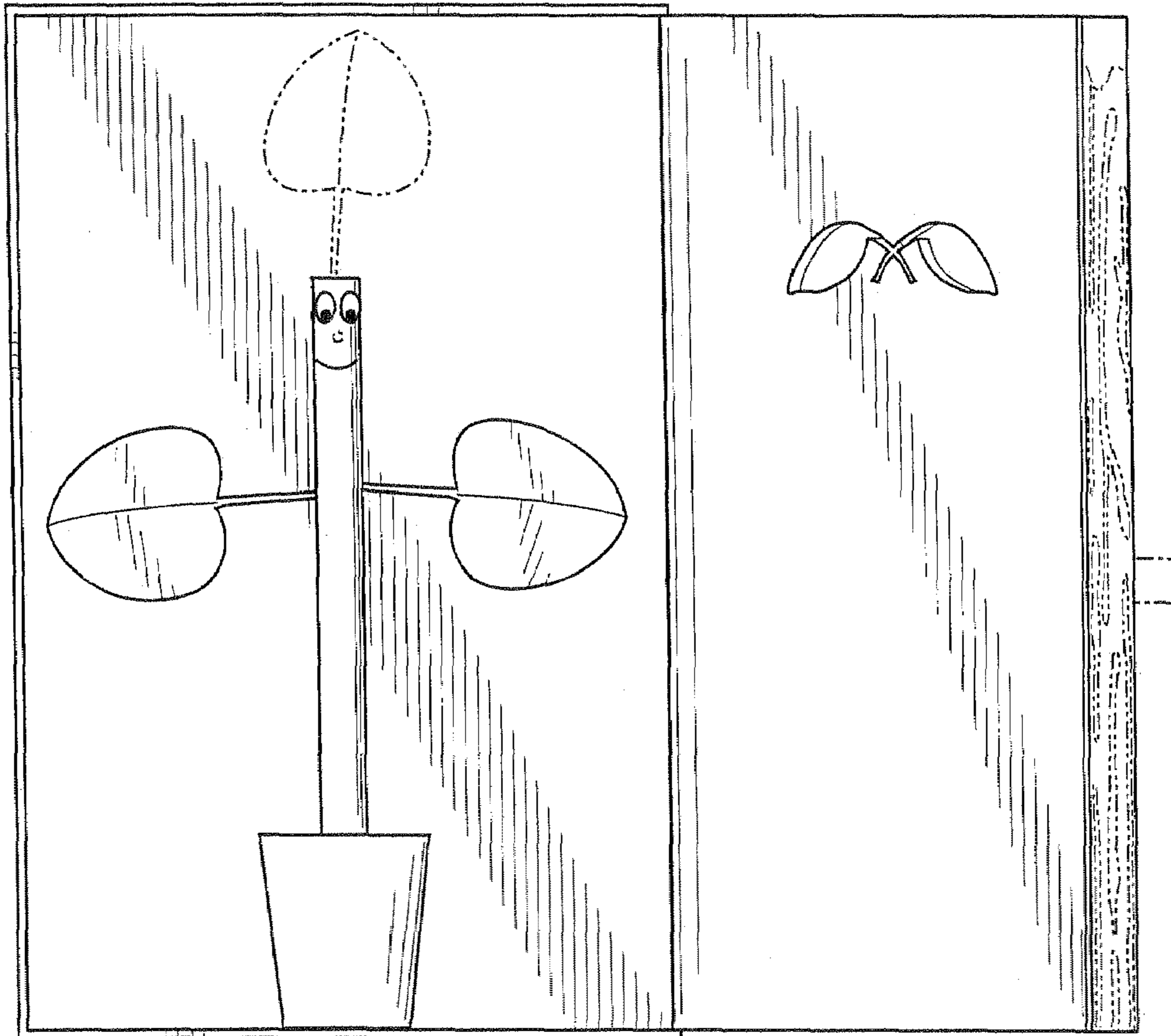

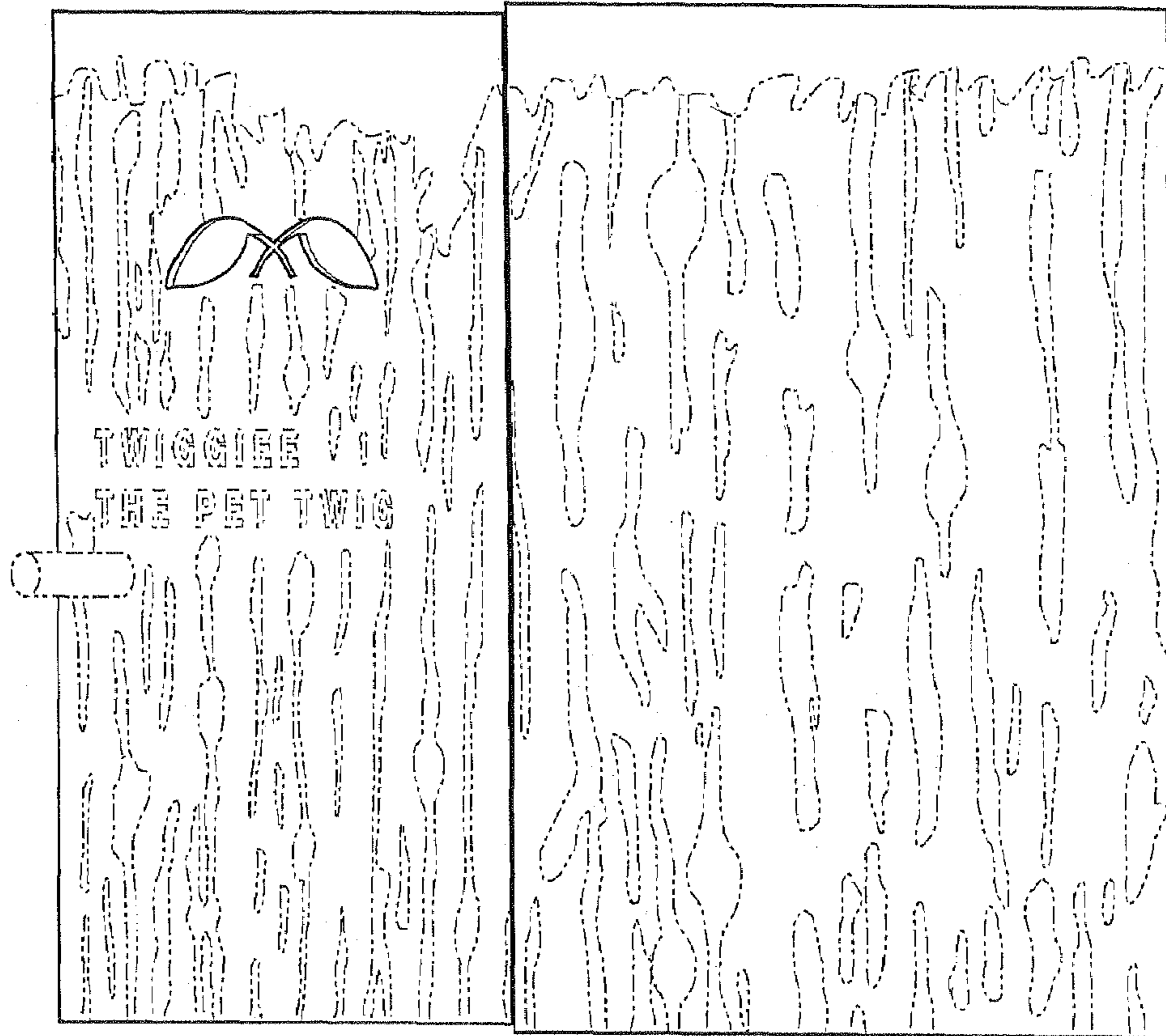

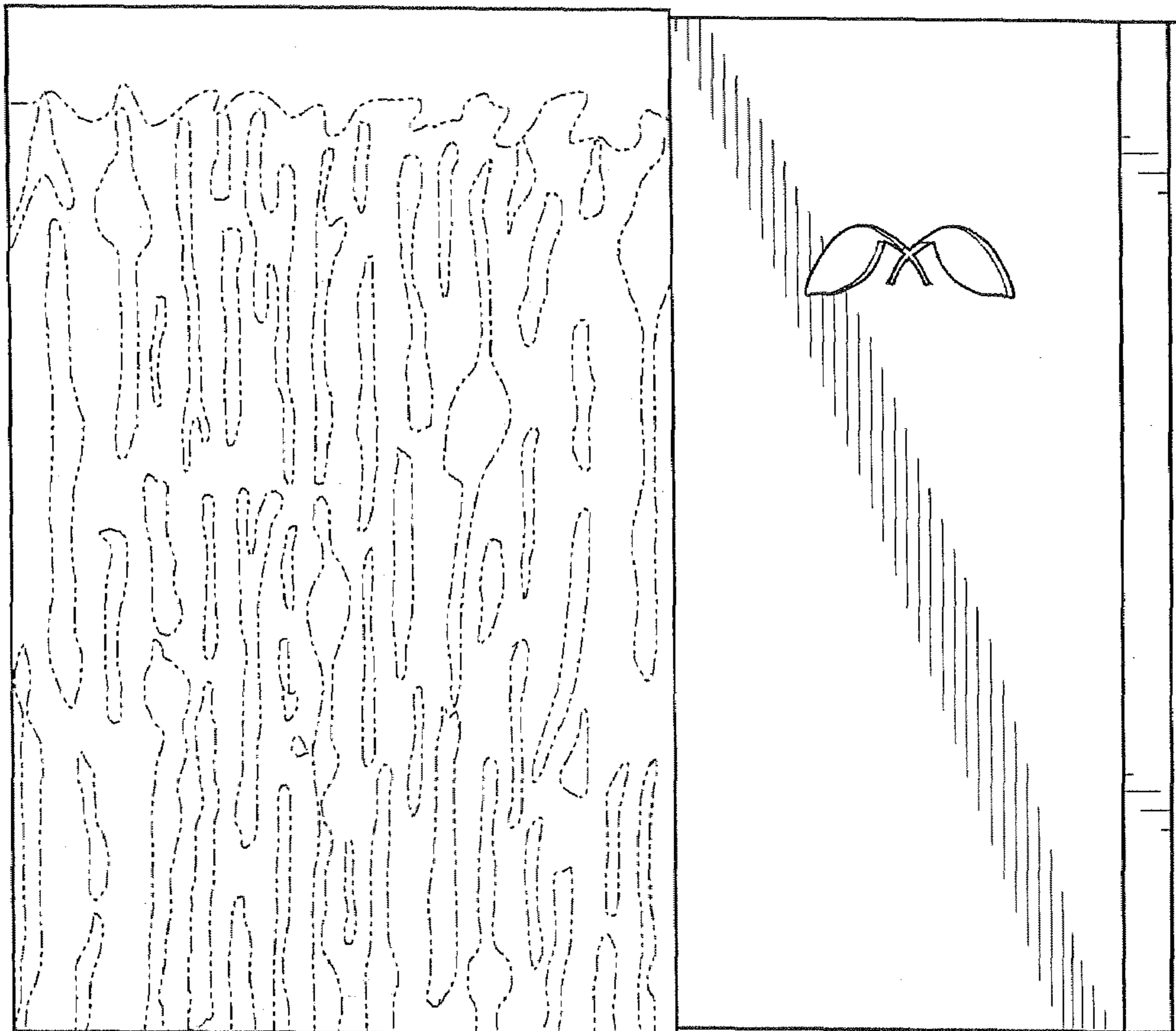

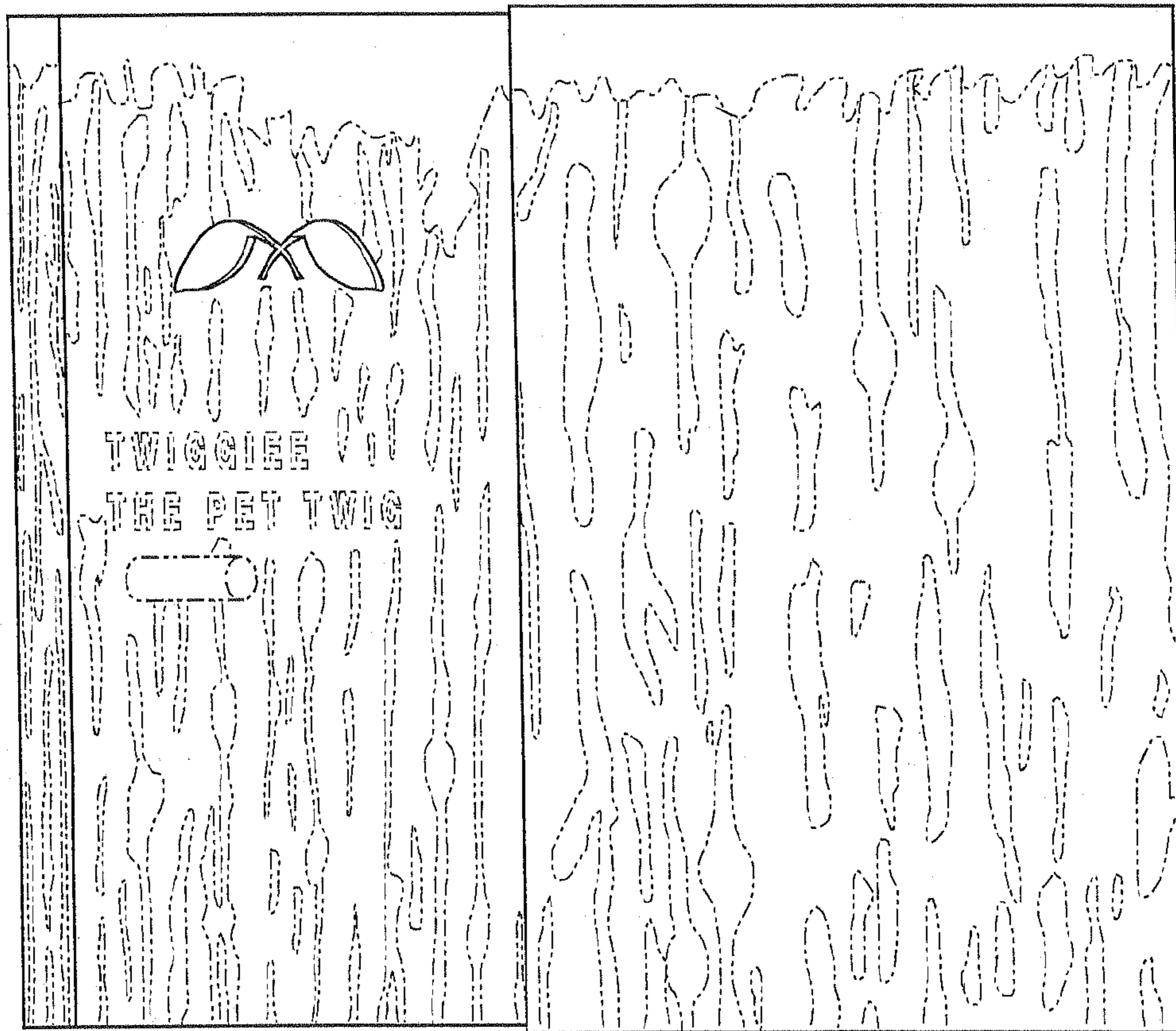

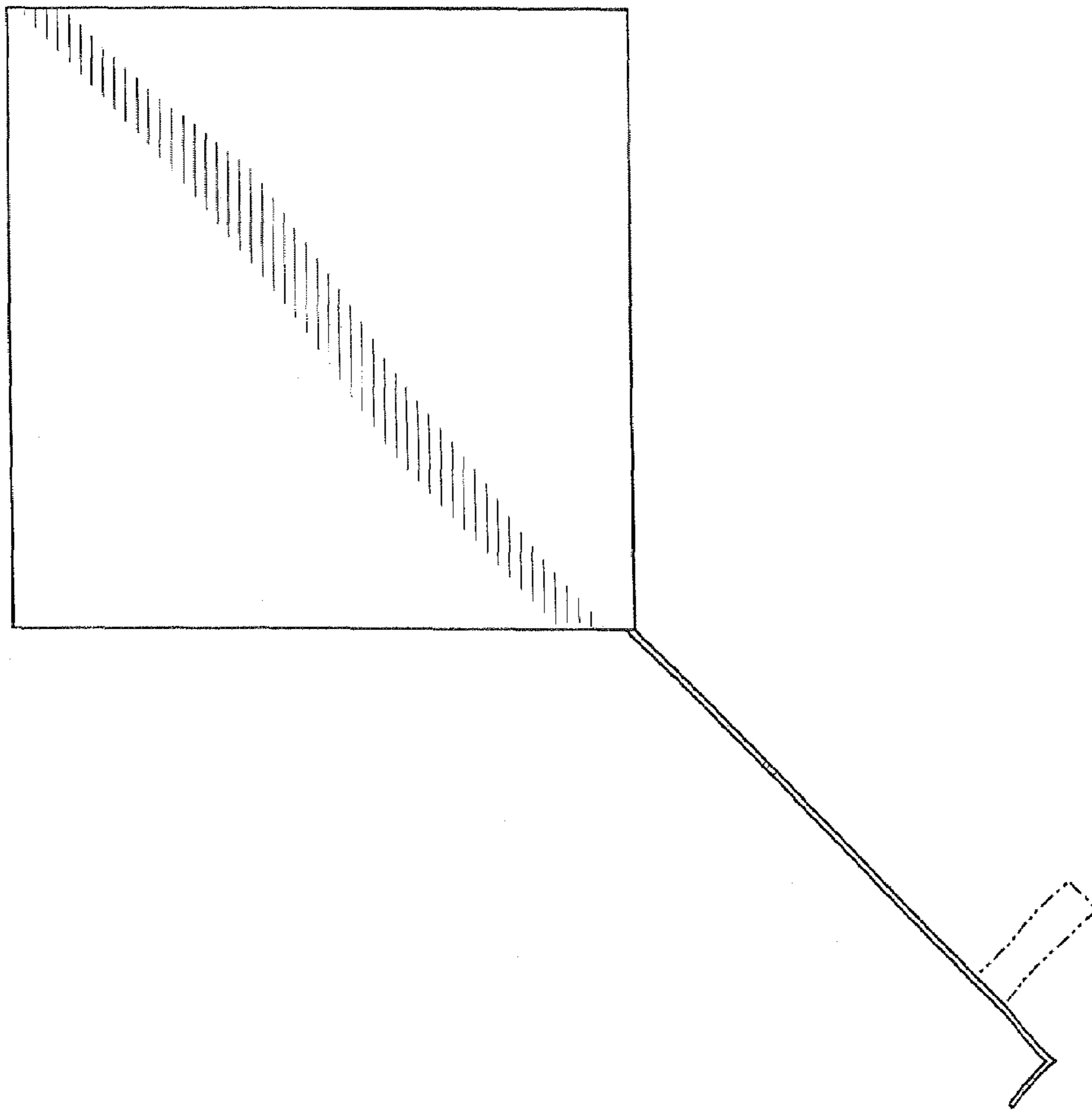




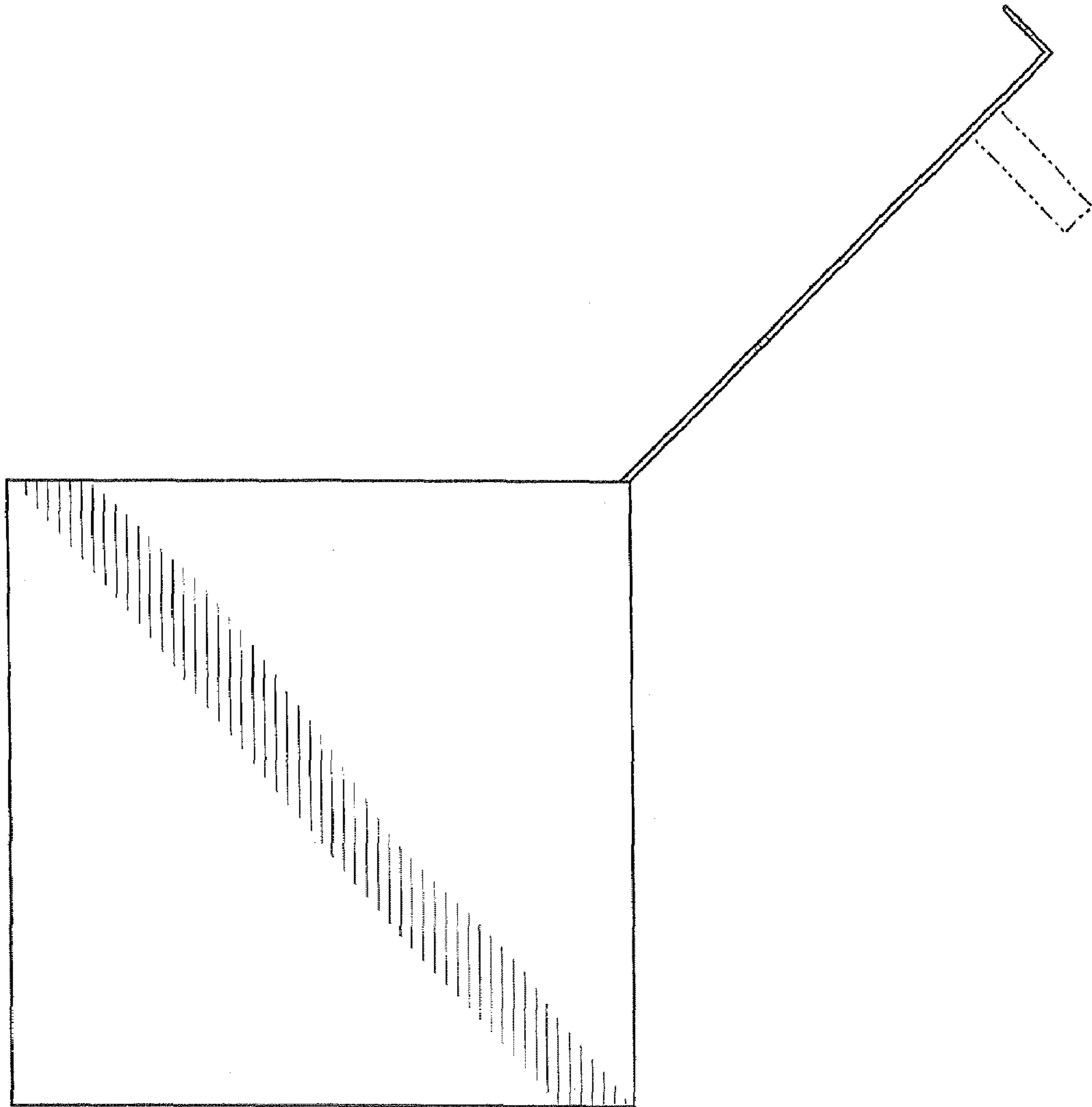
