The ornamental design for a boiler control housing cover, as shown and described.

**DESCRIPTION**

FIG. 1 illustrates a front, top, and right side perspective view of a boiler control housing cover according to one exemplary aspect of the present invention.

FIG. 2 illustrates a back, bottom, and left side perspective view of the boiler control housing cover of FIG. 1.

FIG. 3 illustrates a front elevation view of the boiler control housing cover of FIG. 1.

FIG. 4 illustrates a back elevation view of the boiler control housing cover of FIG. 1.

FIG. 5 illustrates a right side elevation view of the boiler control housing cover of FIG. 1.

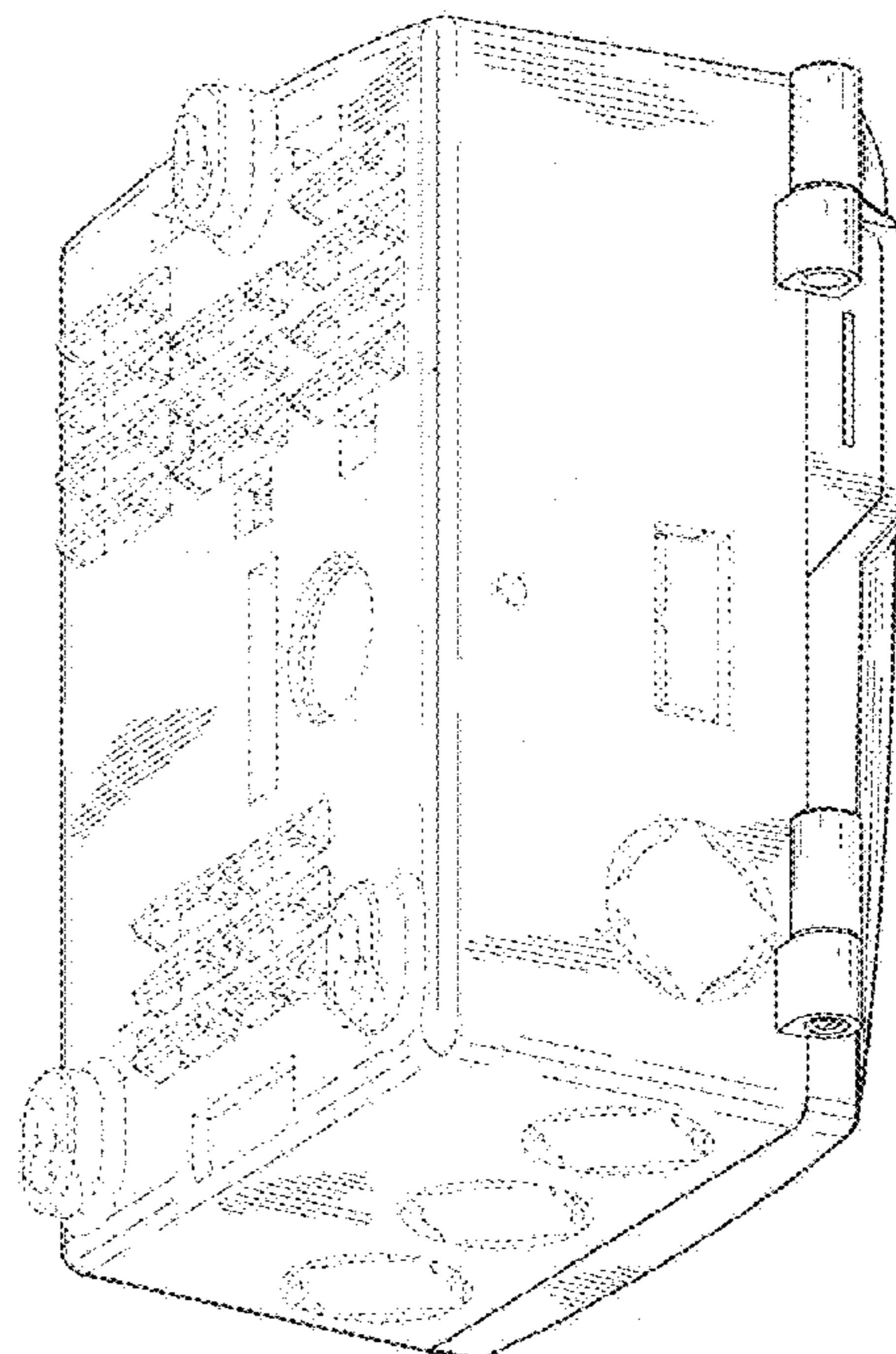
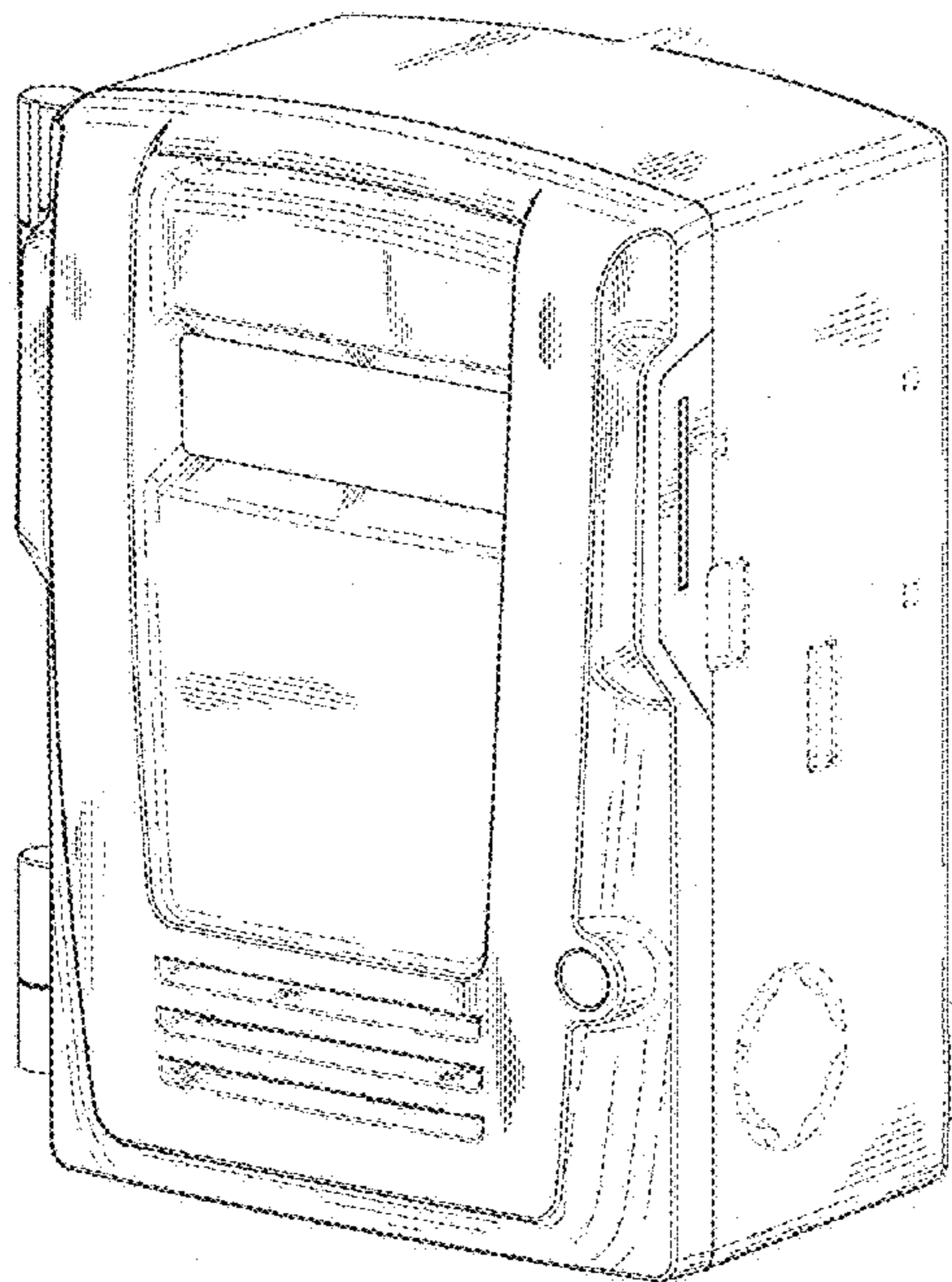
FIG. 6 illustrates a left side elevation view of the boiler control housing cover of FIG. 1.

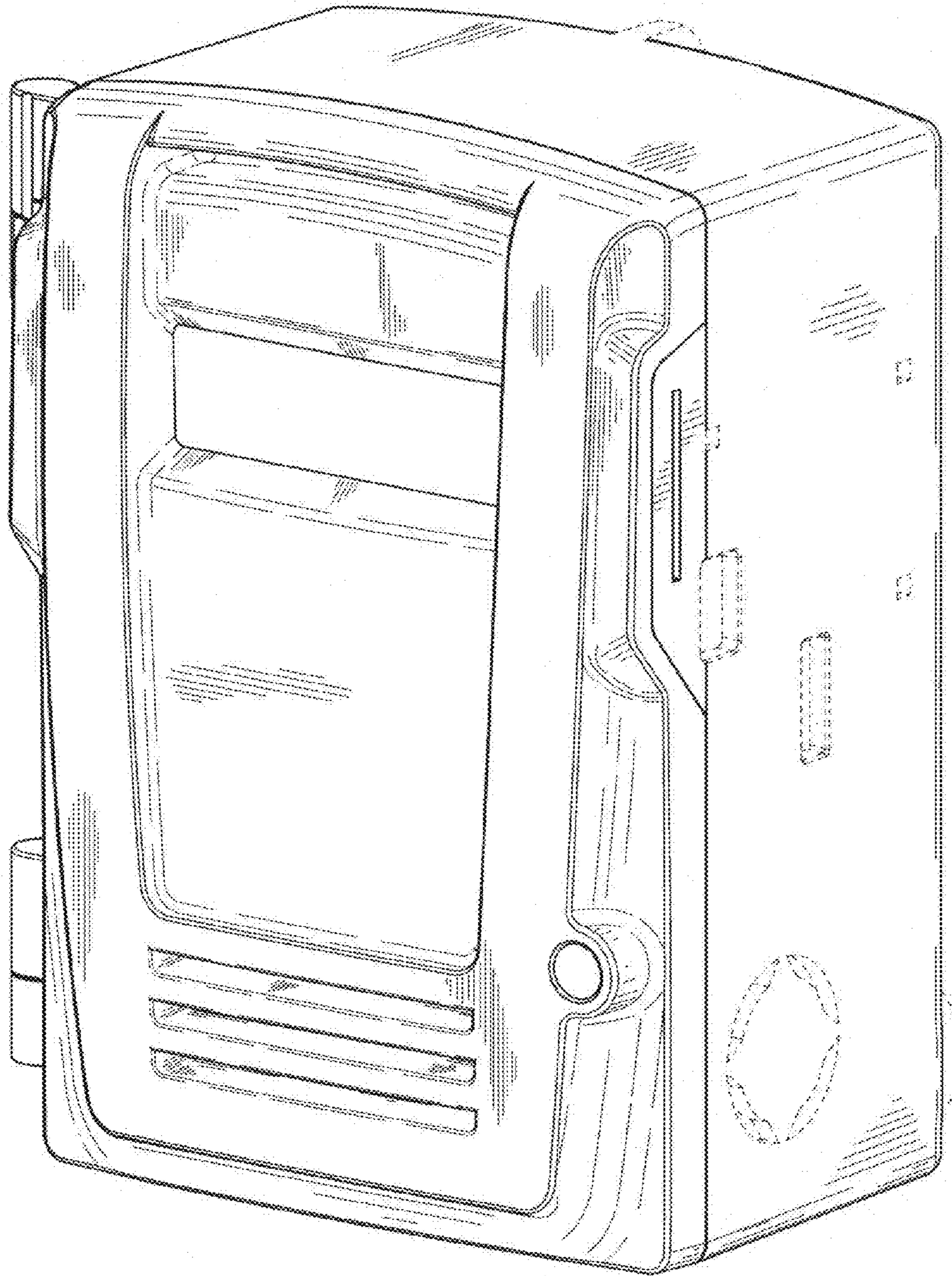

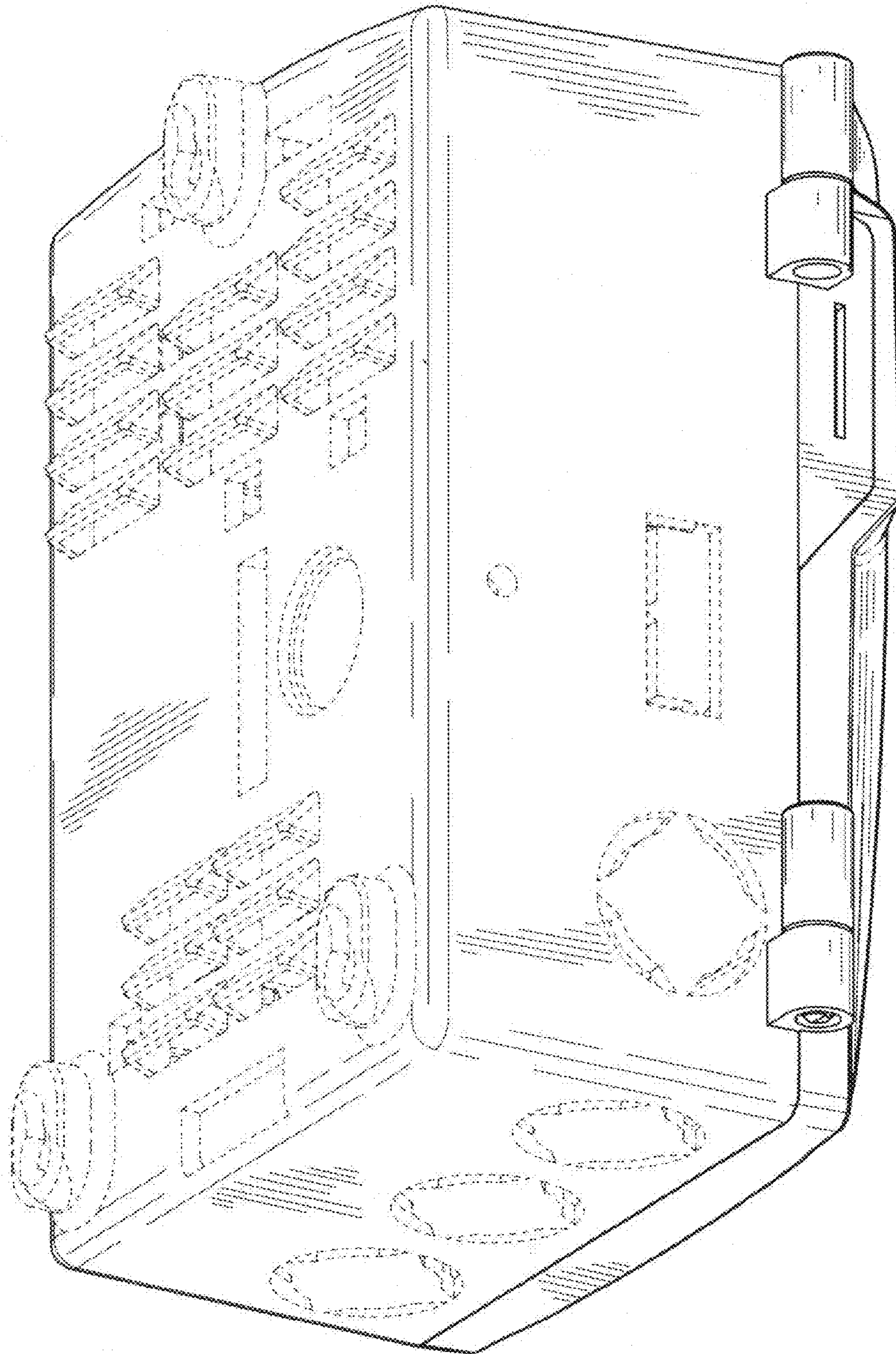

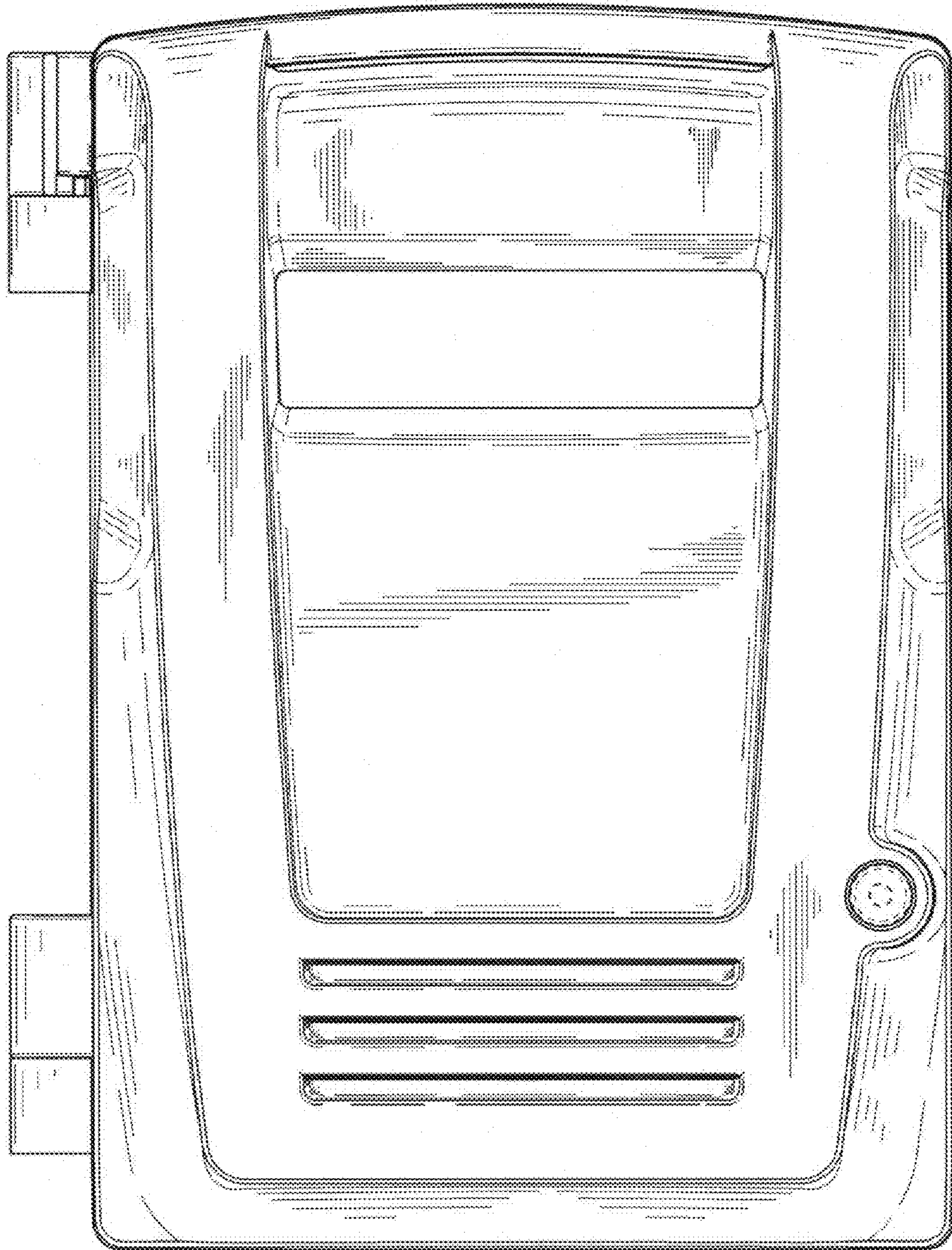

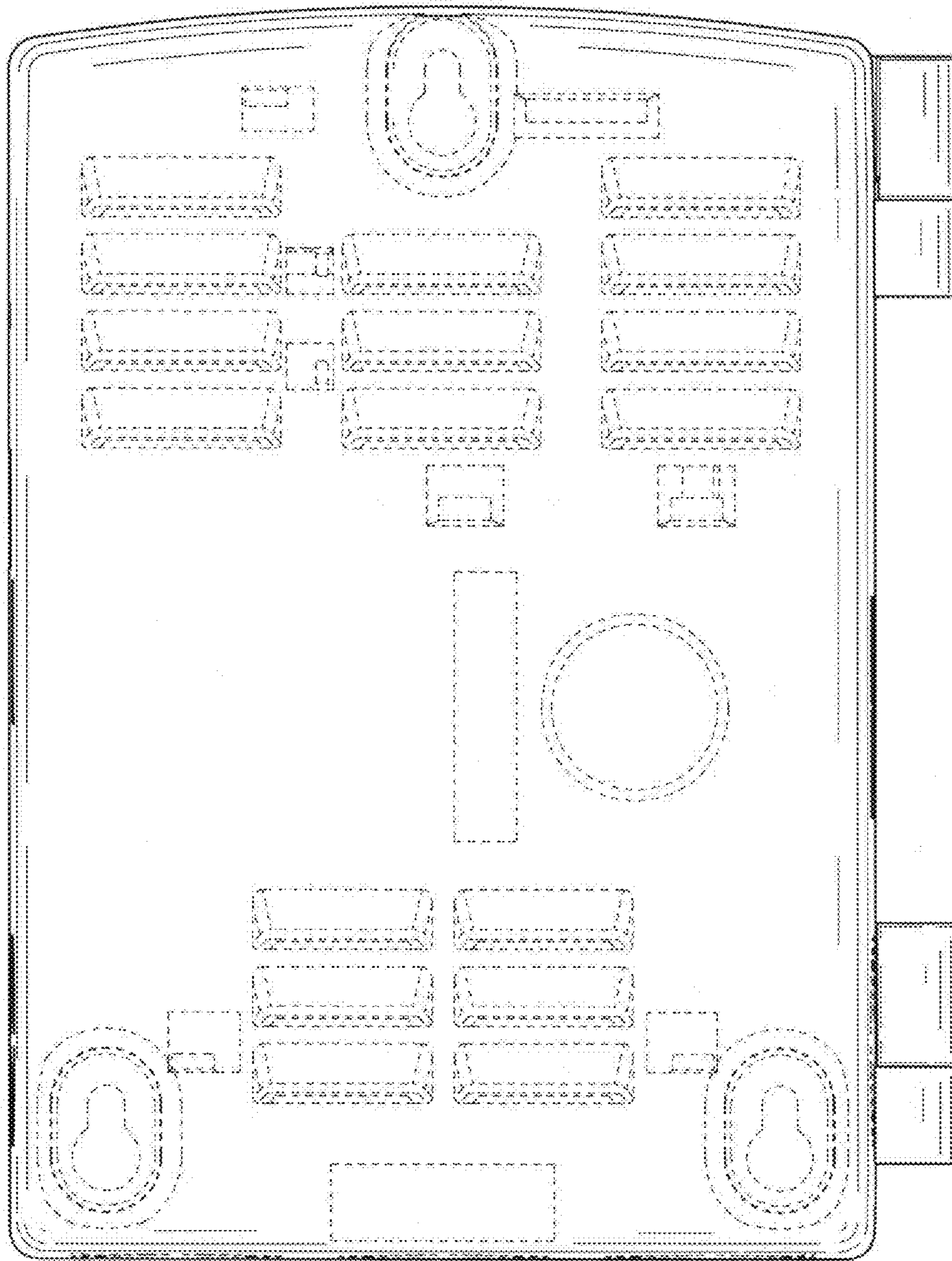

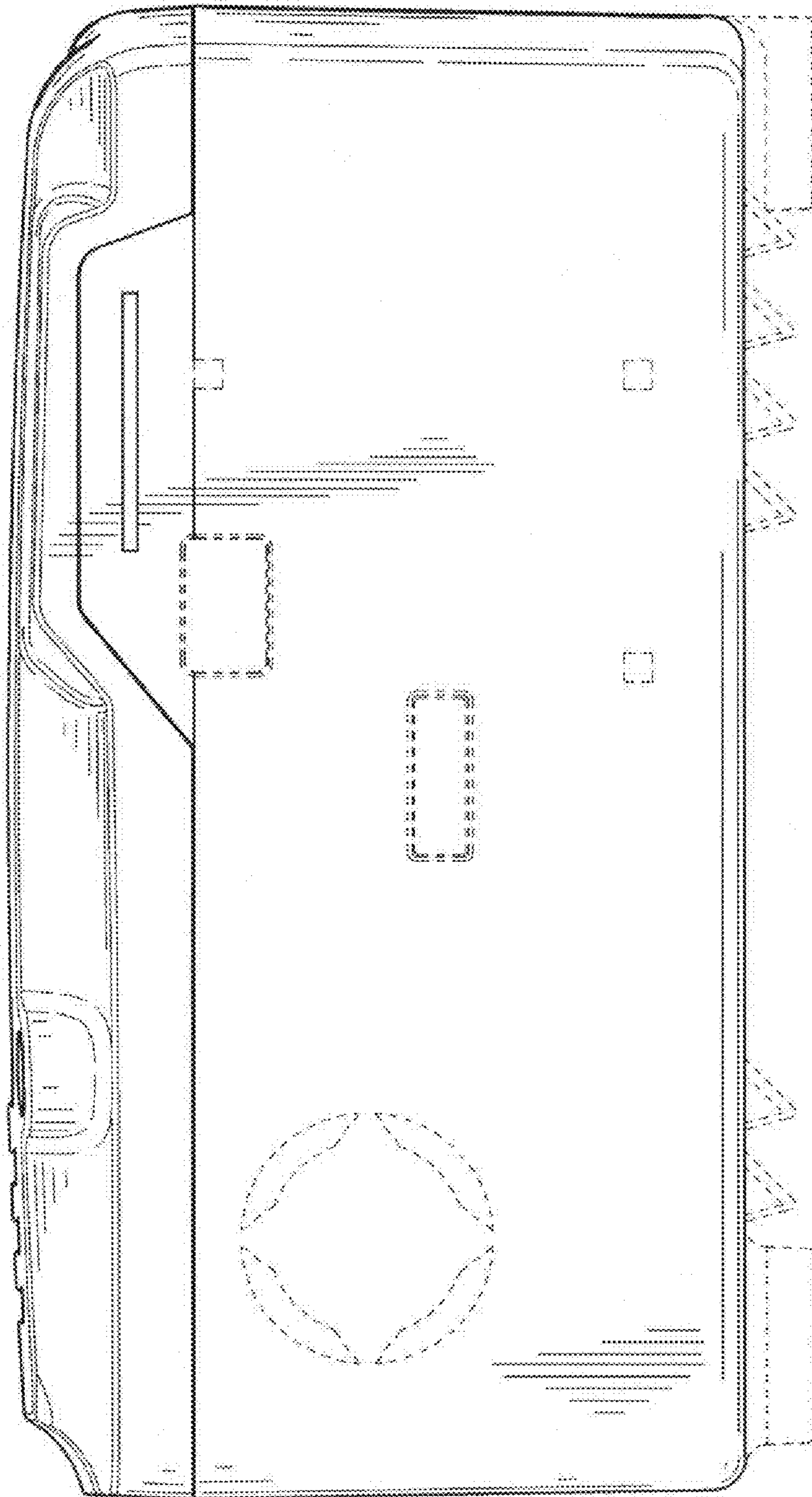

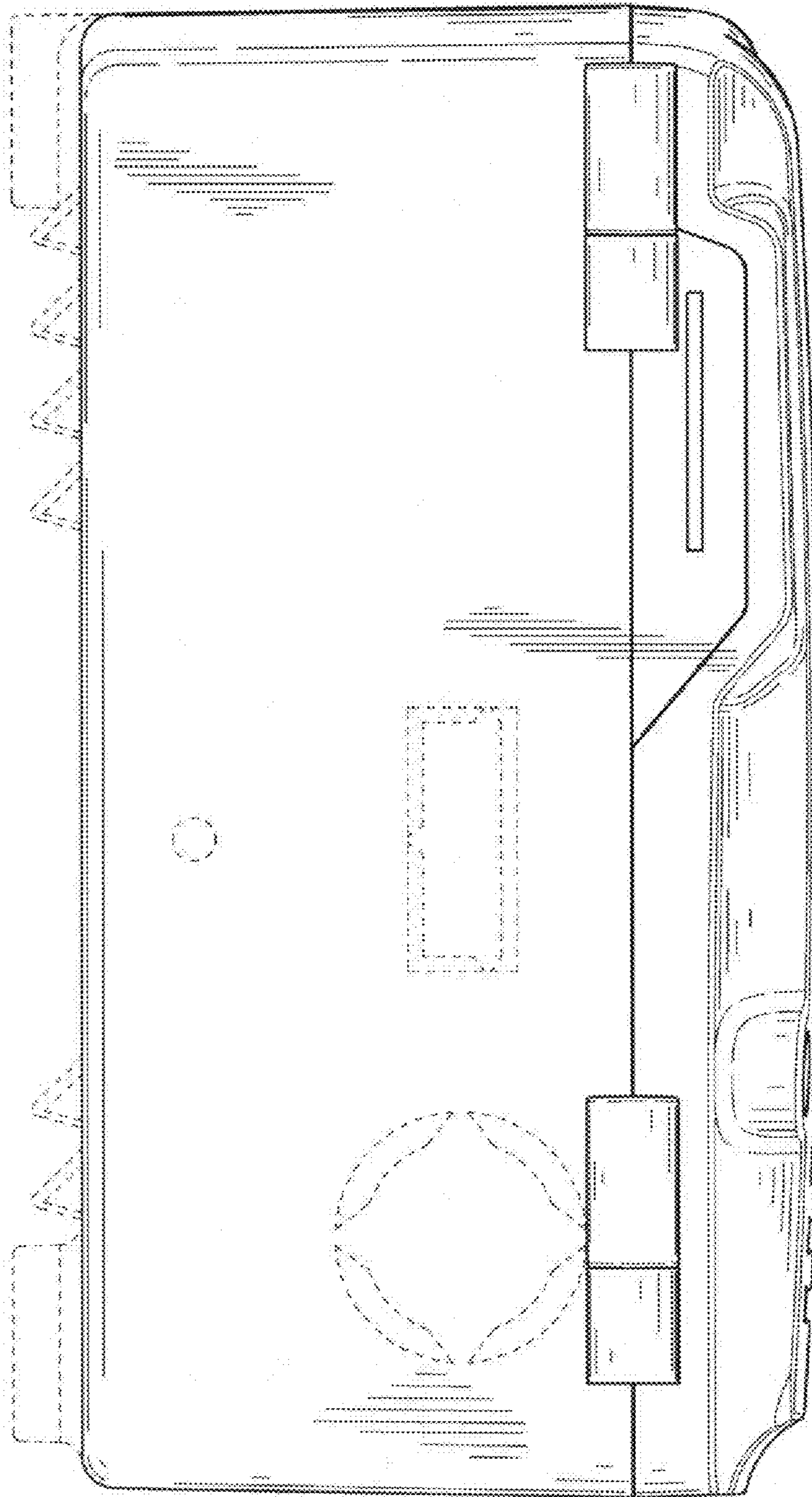

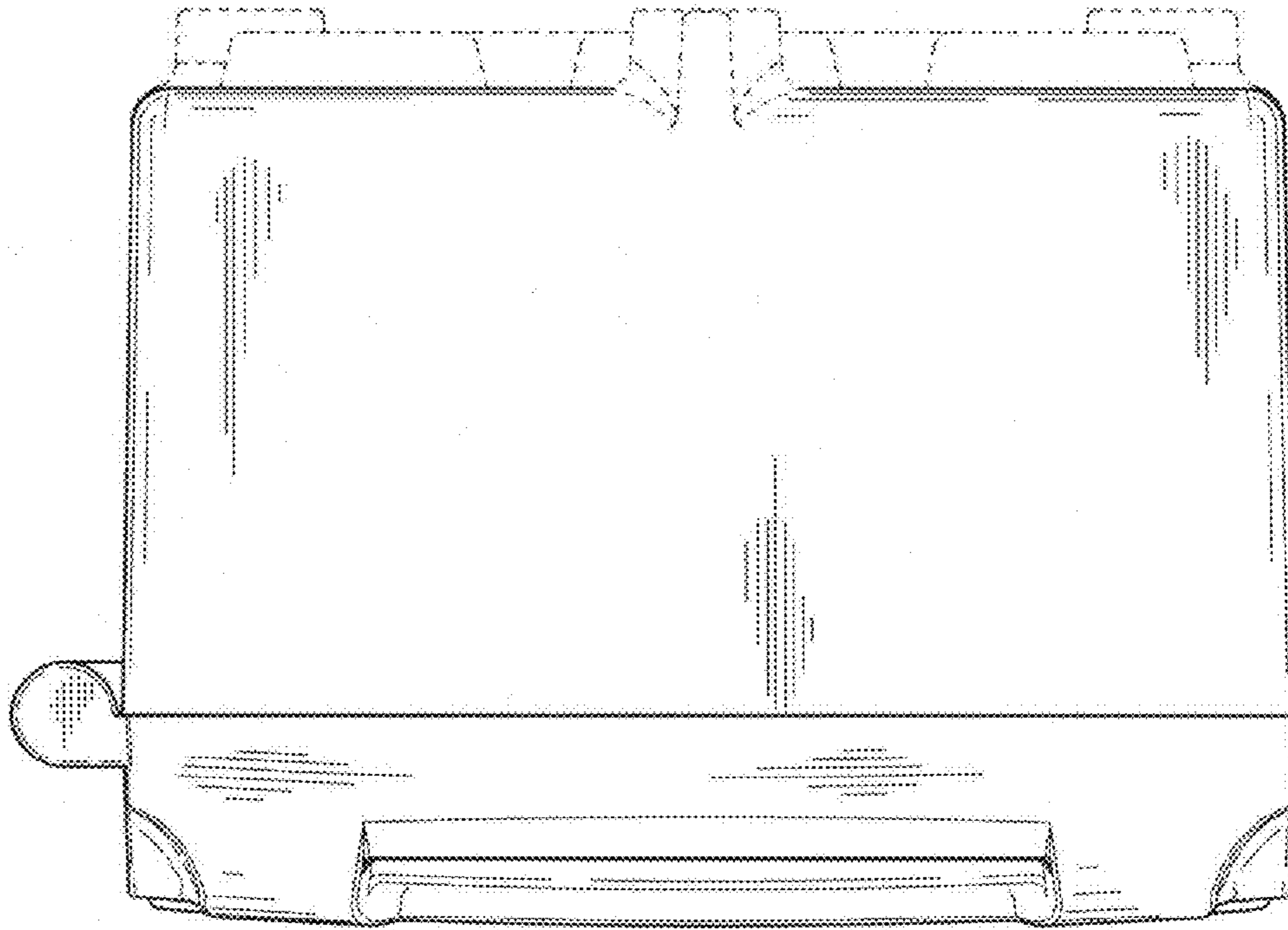

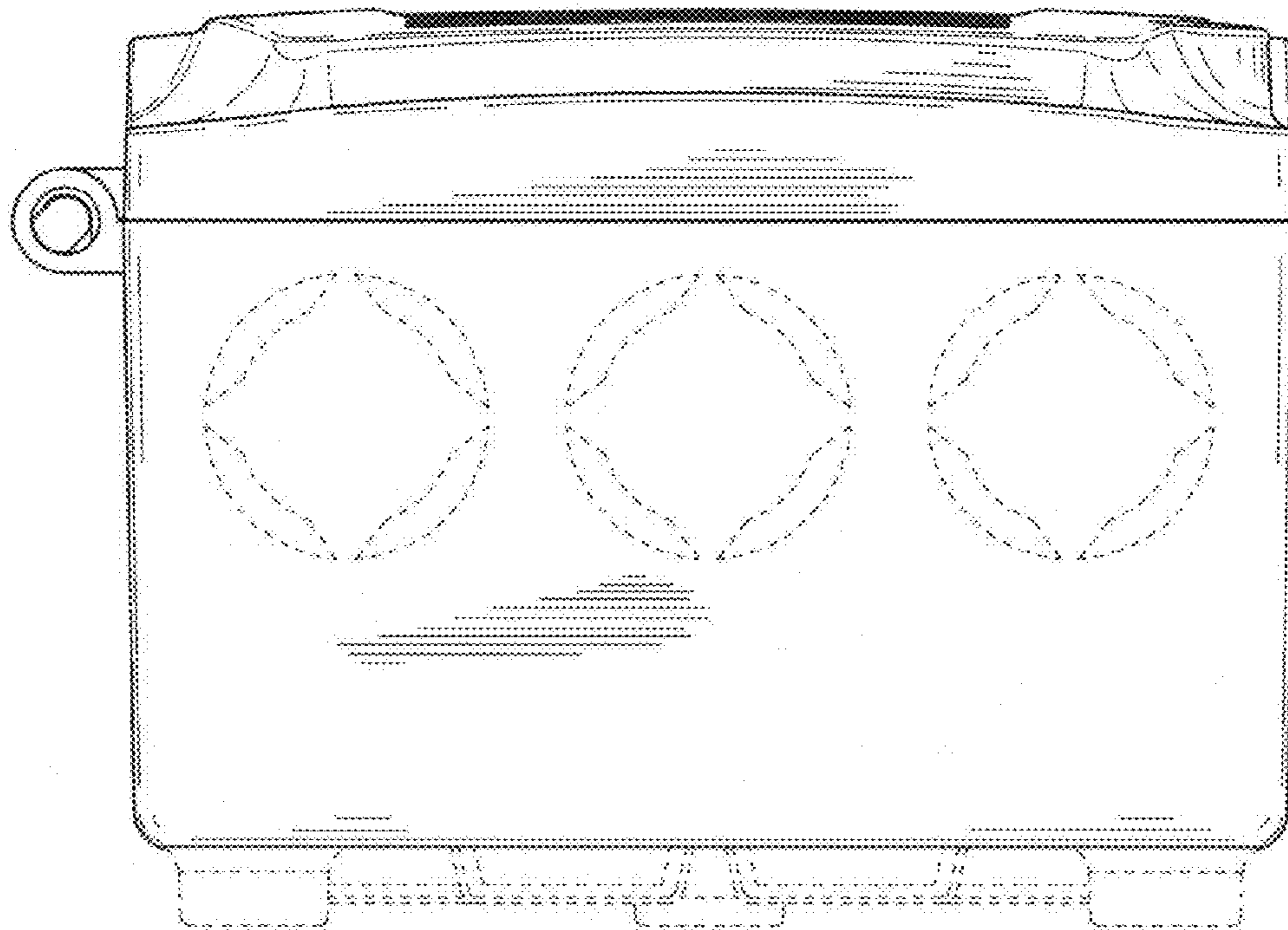
