The ornamental design for a dimmer switch, shown and described.

DESCRIPTION

FIG. 1 is a front left perspective view illustrating our new design for a dimmer switch with the broken lines showing, for illustrative purposes only, a back plate and a housing that are not part of the claimed design;

FIG. 2 is a front view thereof with the dashed lines showing the back plate;

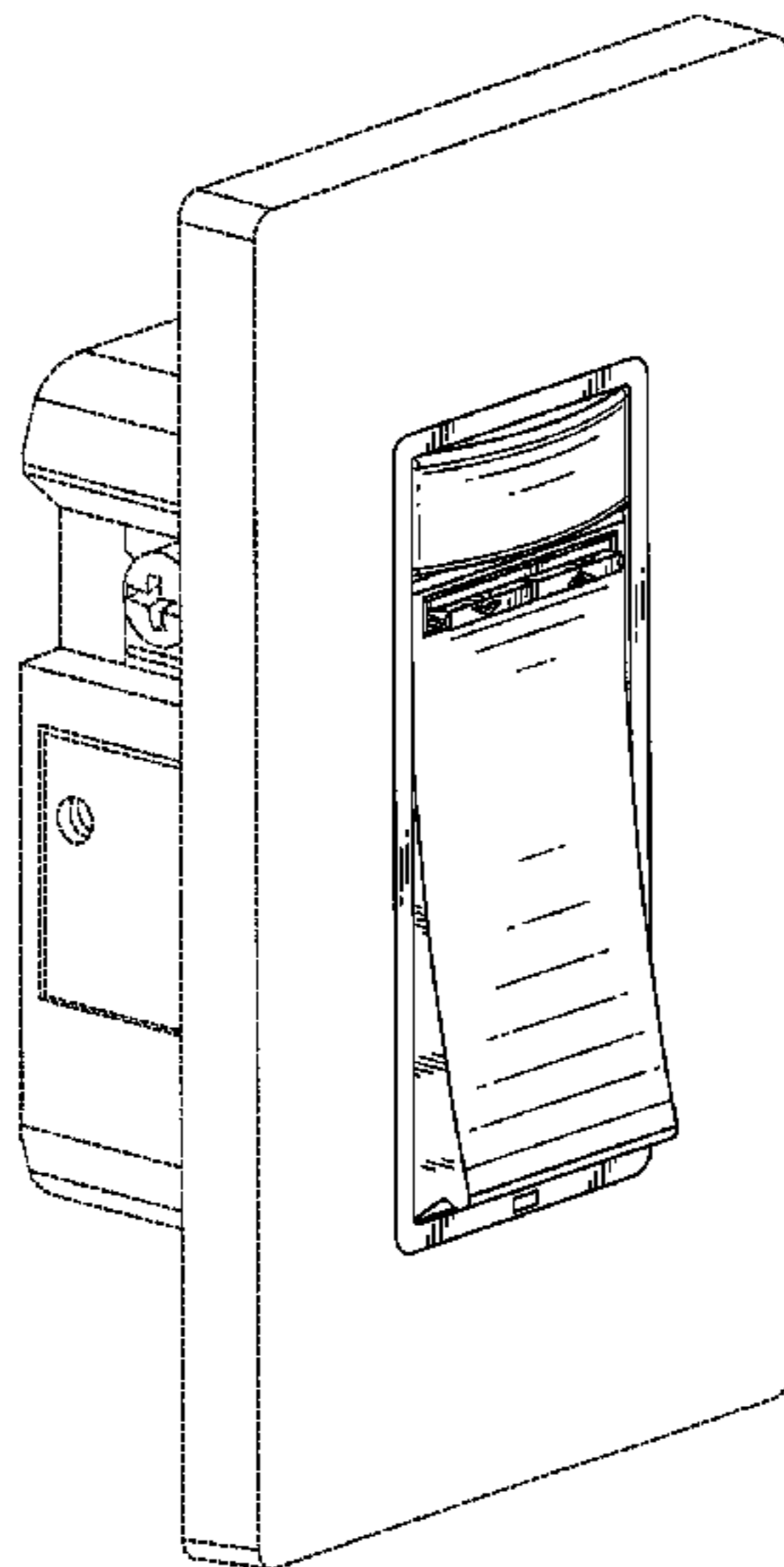
FIG. 3 is a left side view thereof with the broken lines showing the back plate and the housing;

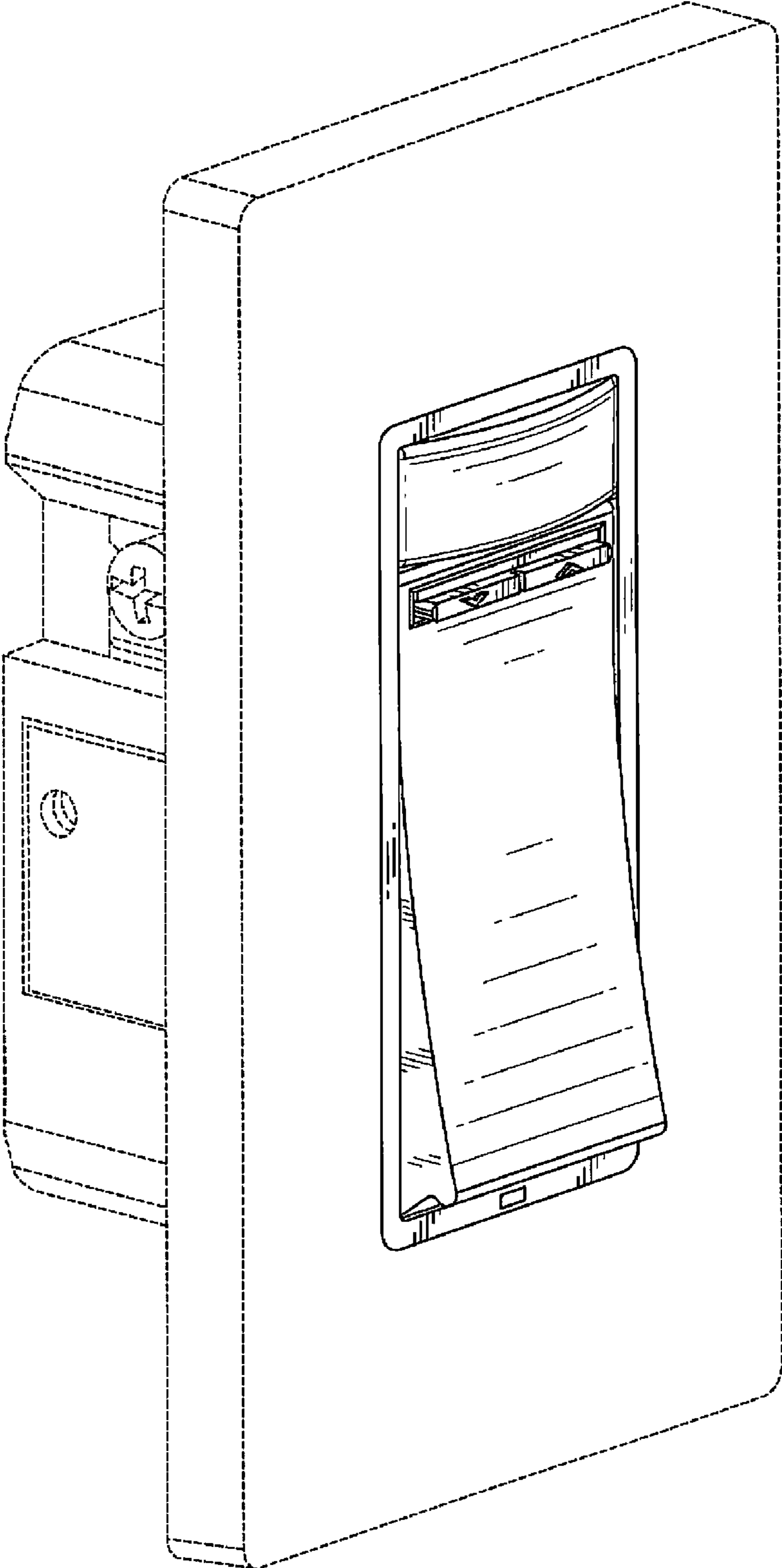

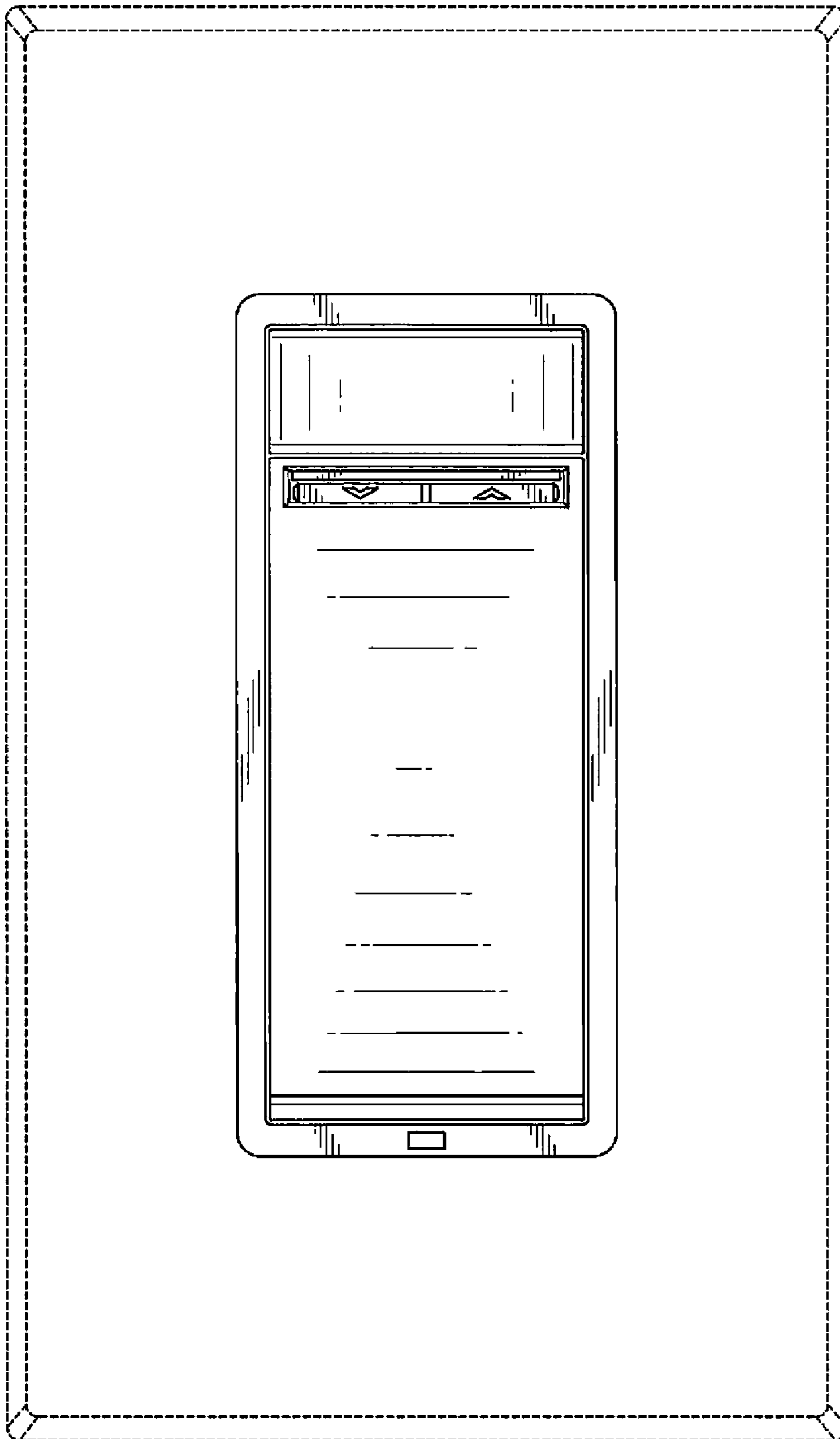

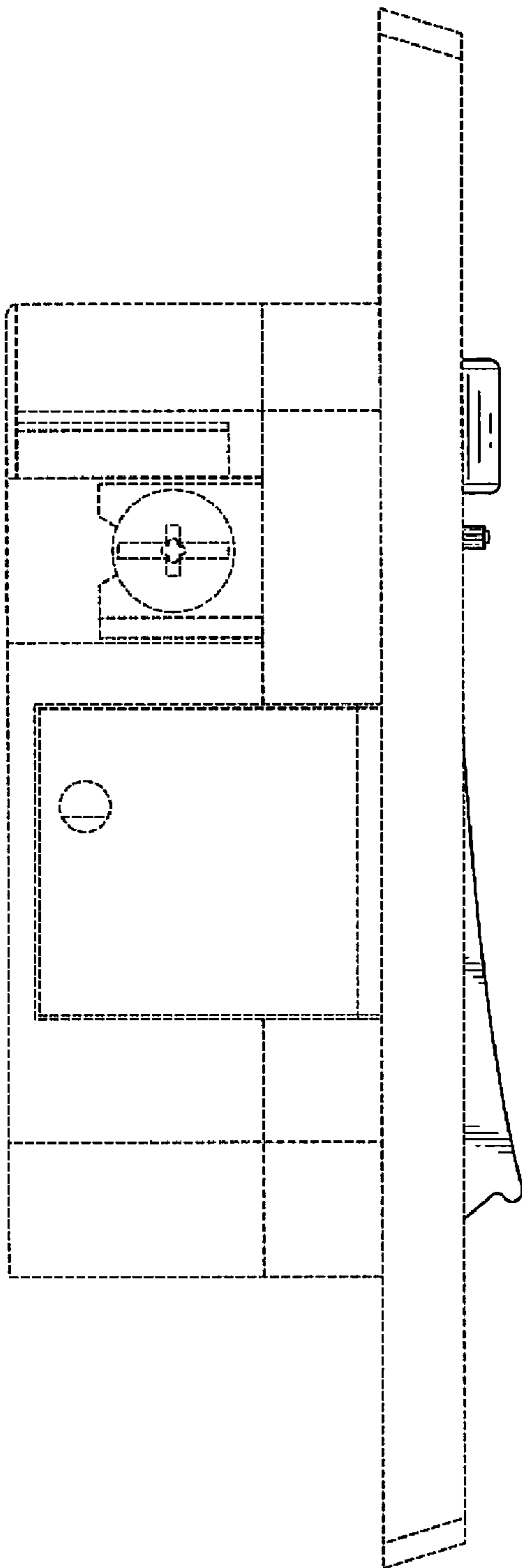

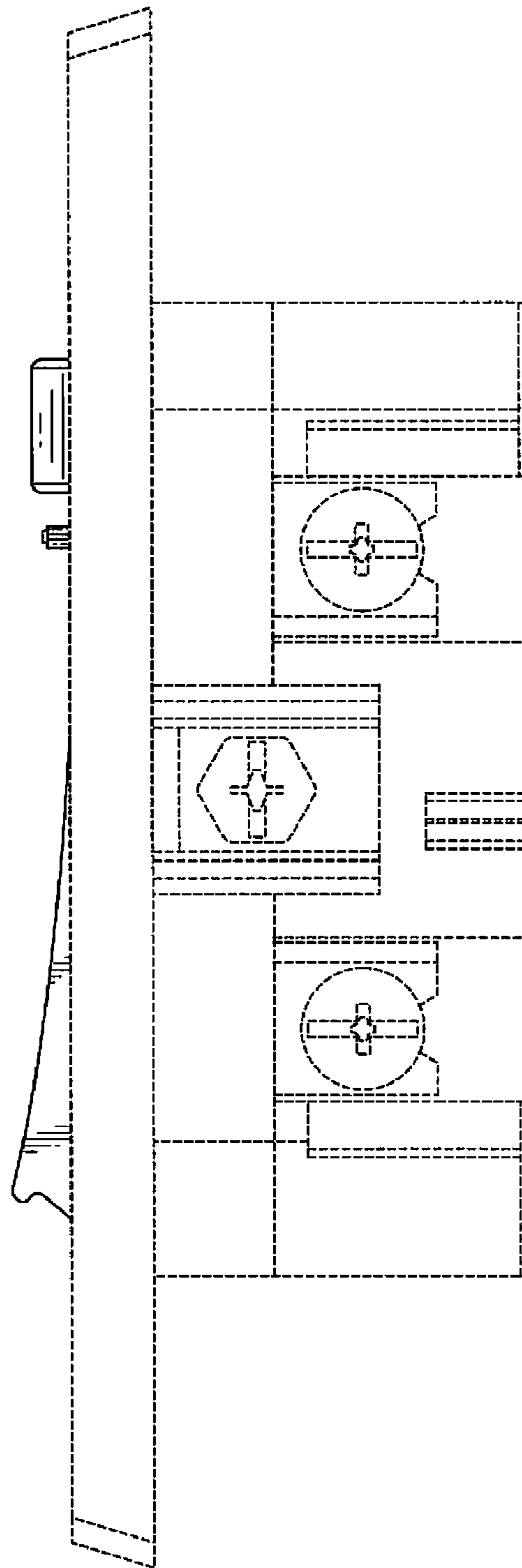

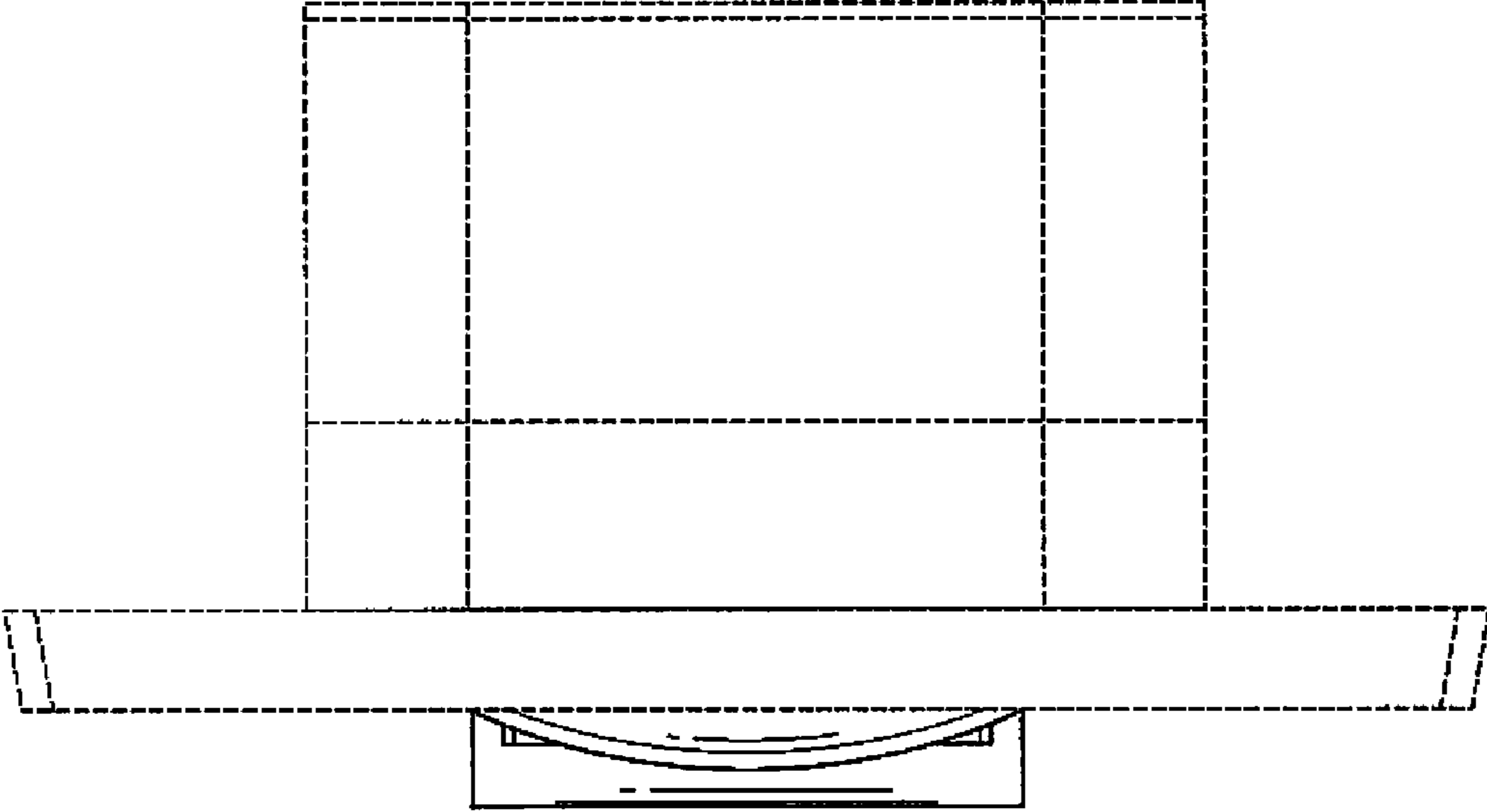

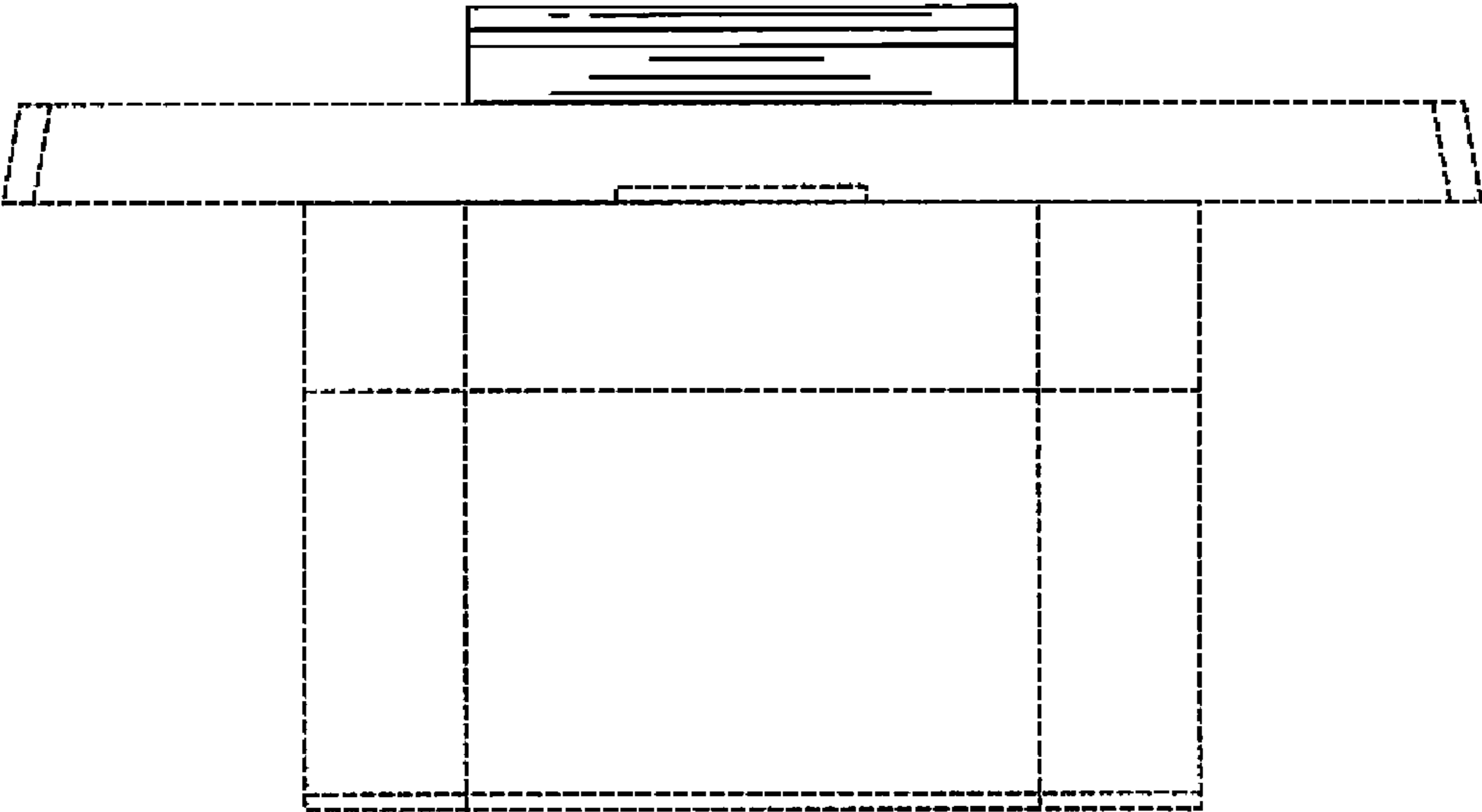
