The ornamental design for a surveillance camera, as shown and described.

DESCRIPTION

FIG. 20 is a bottom view of a surveillance camera with the housing, mount bracket and protective cover shown removed for ease of illustration thereof;

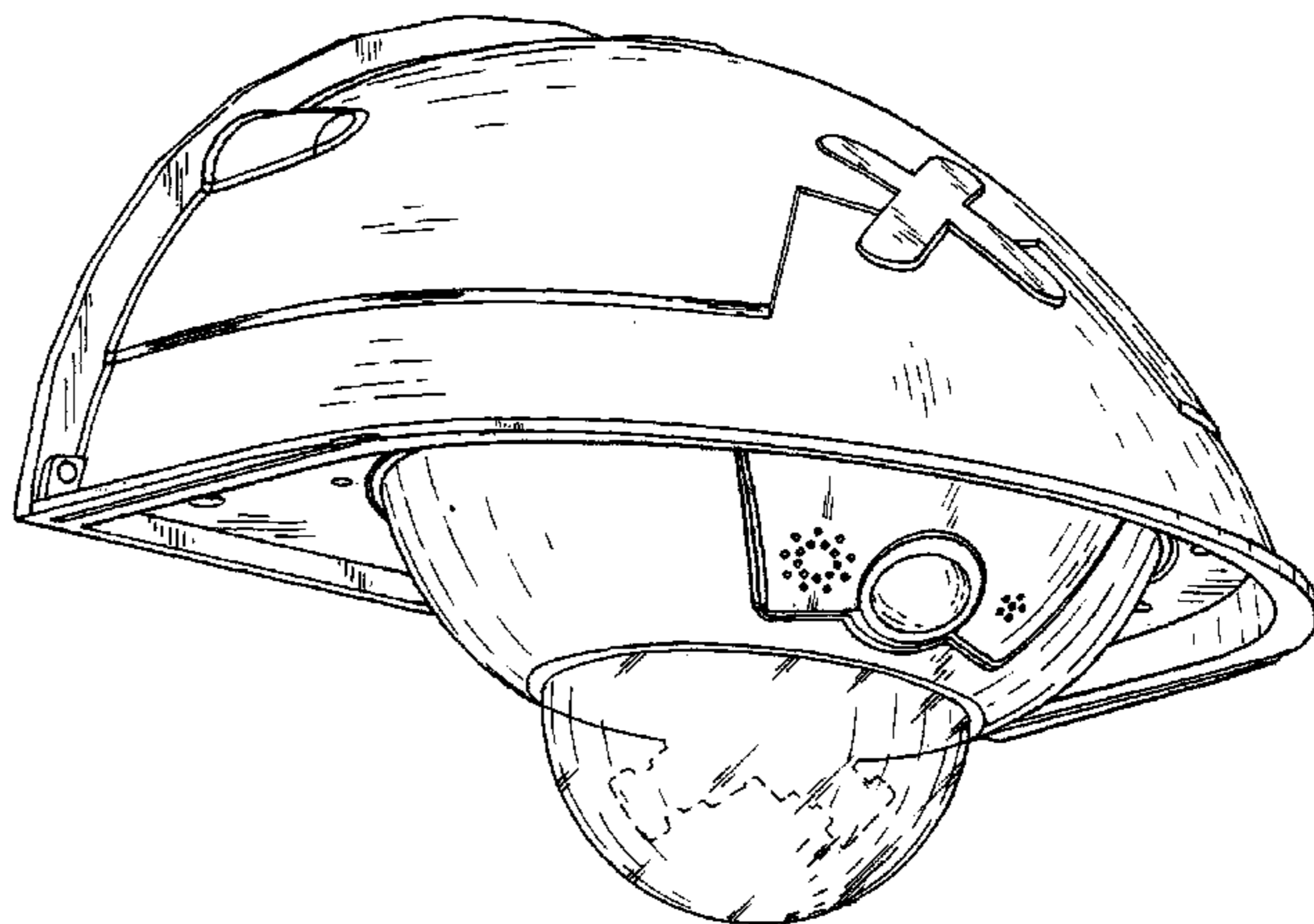
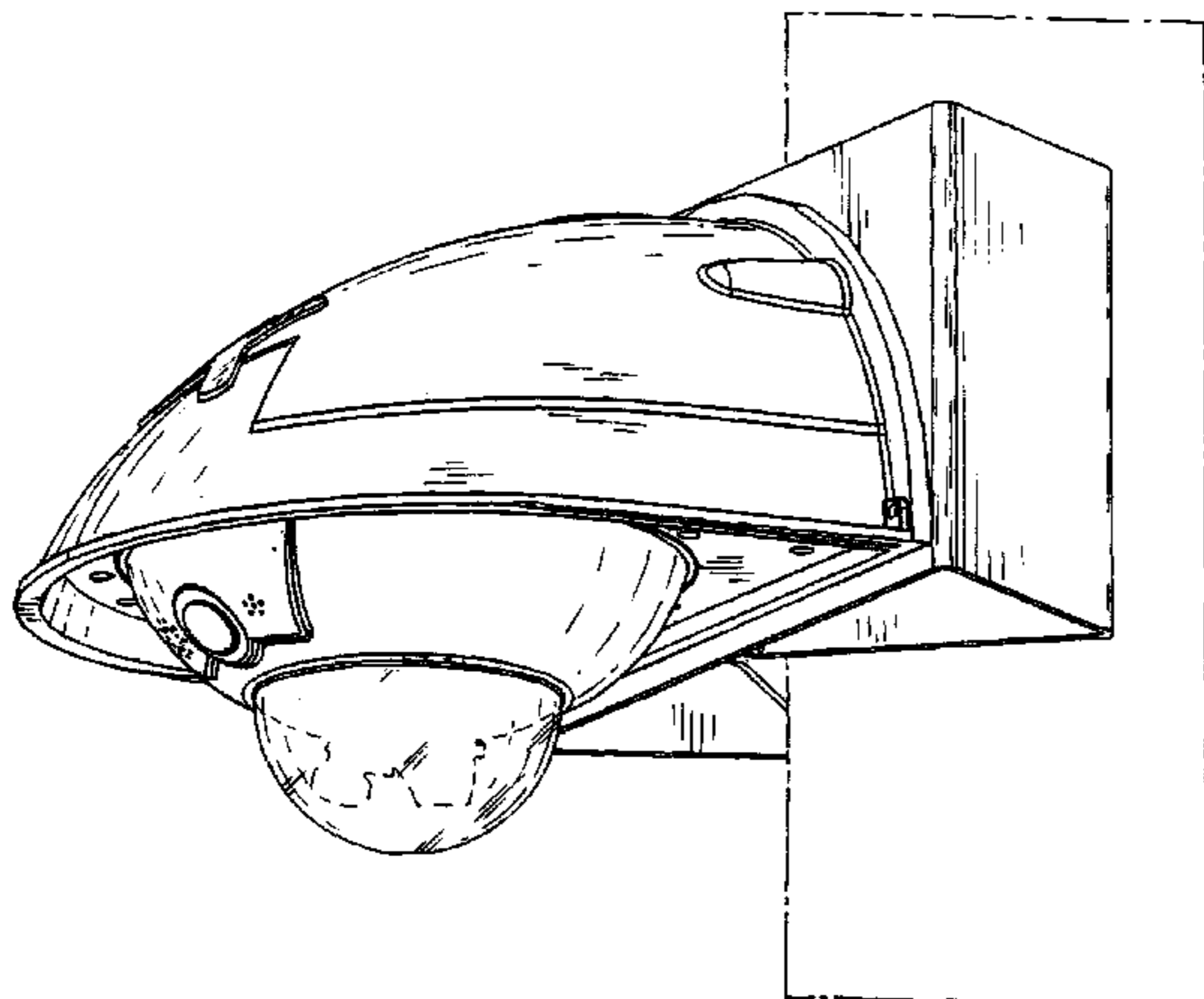


FIG. **21** is a right side view thereof;

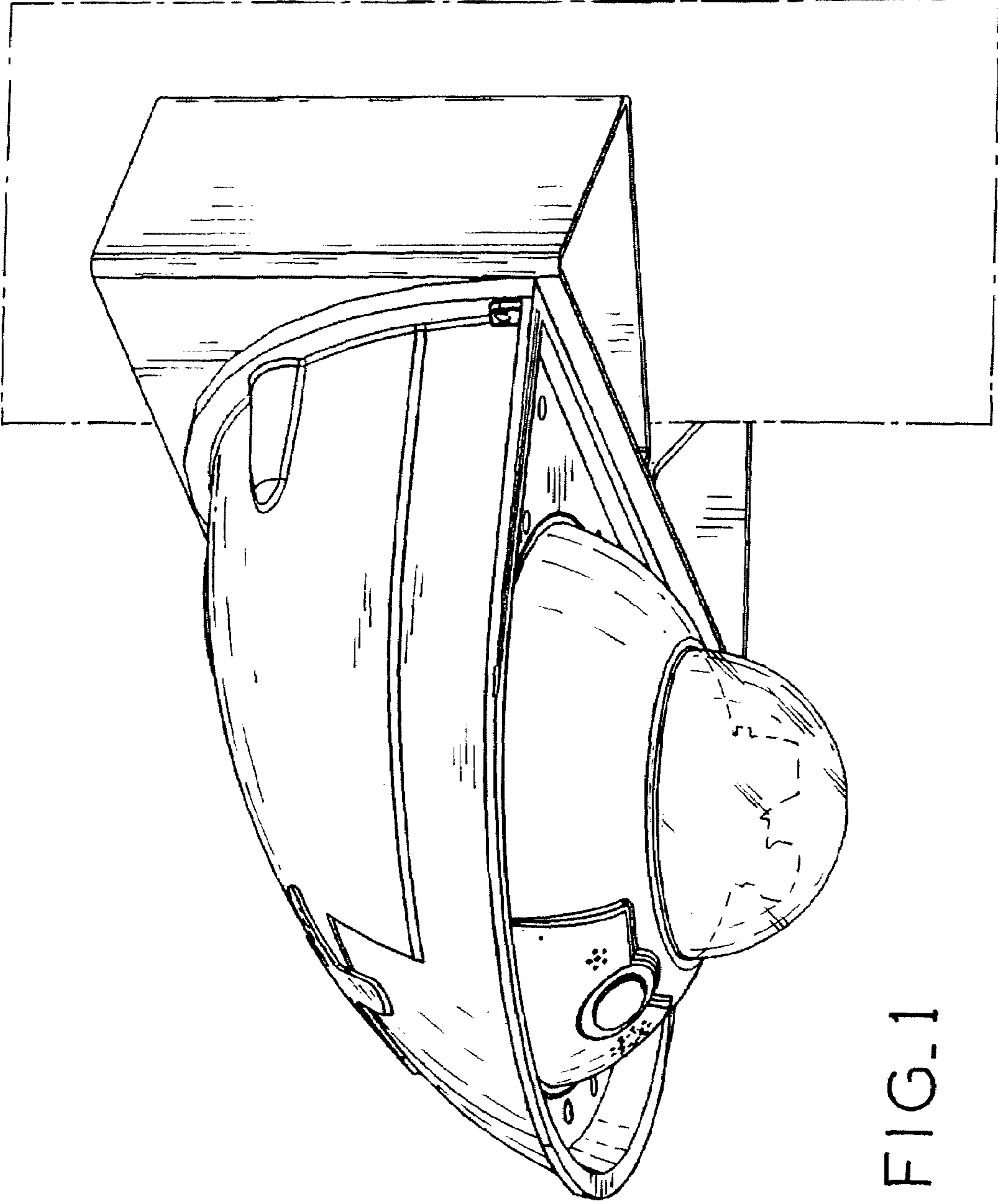

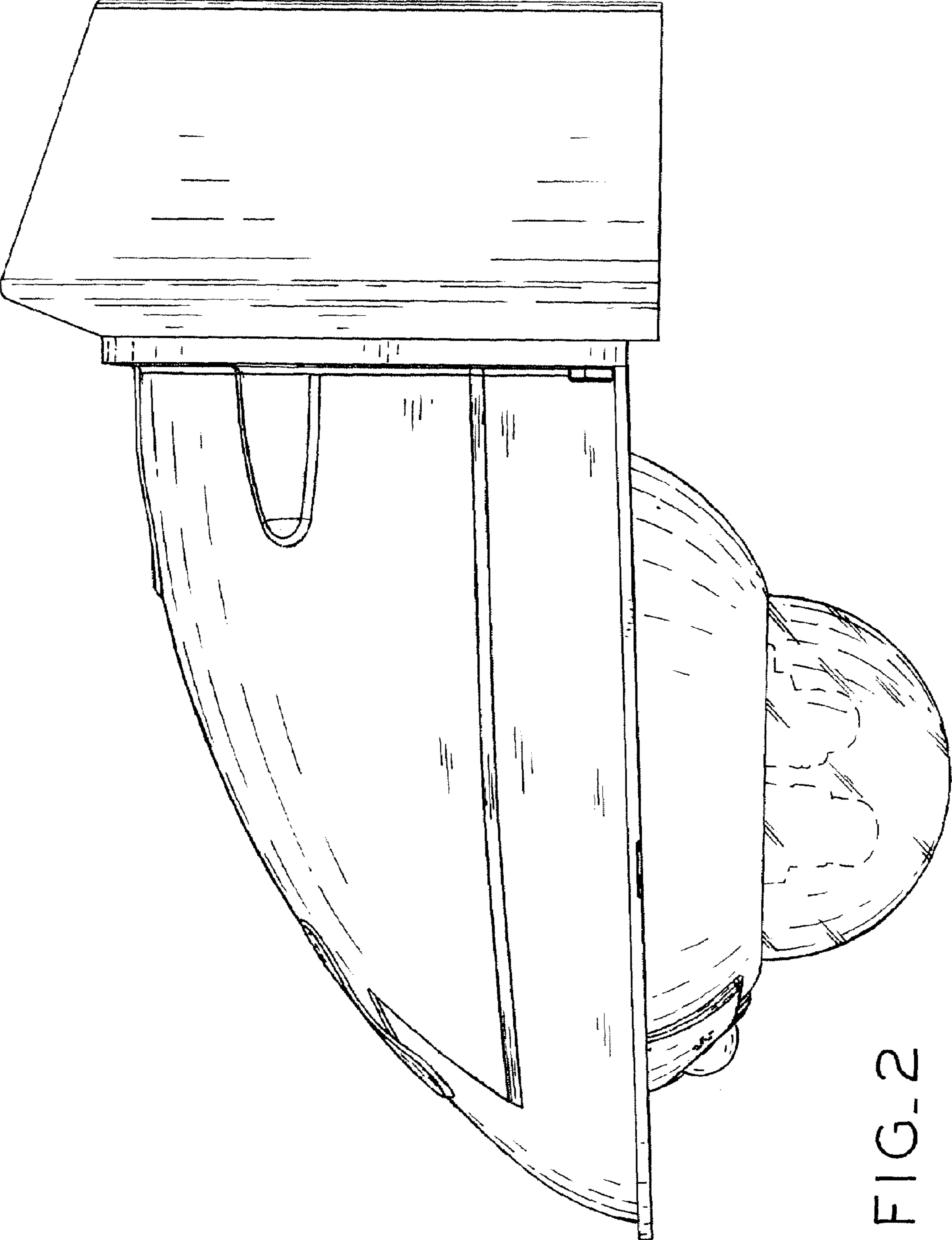

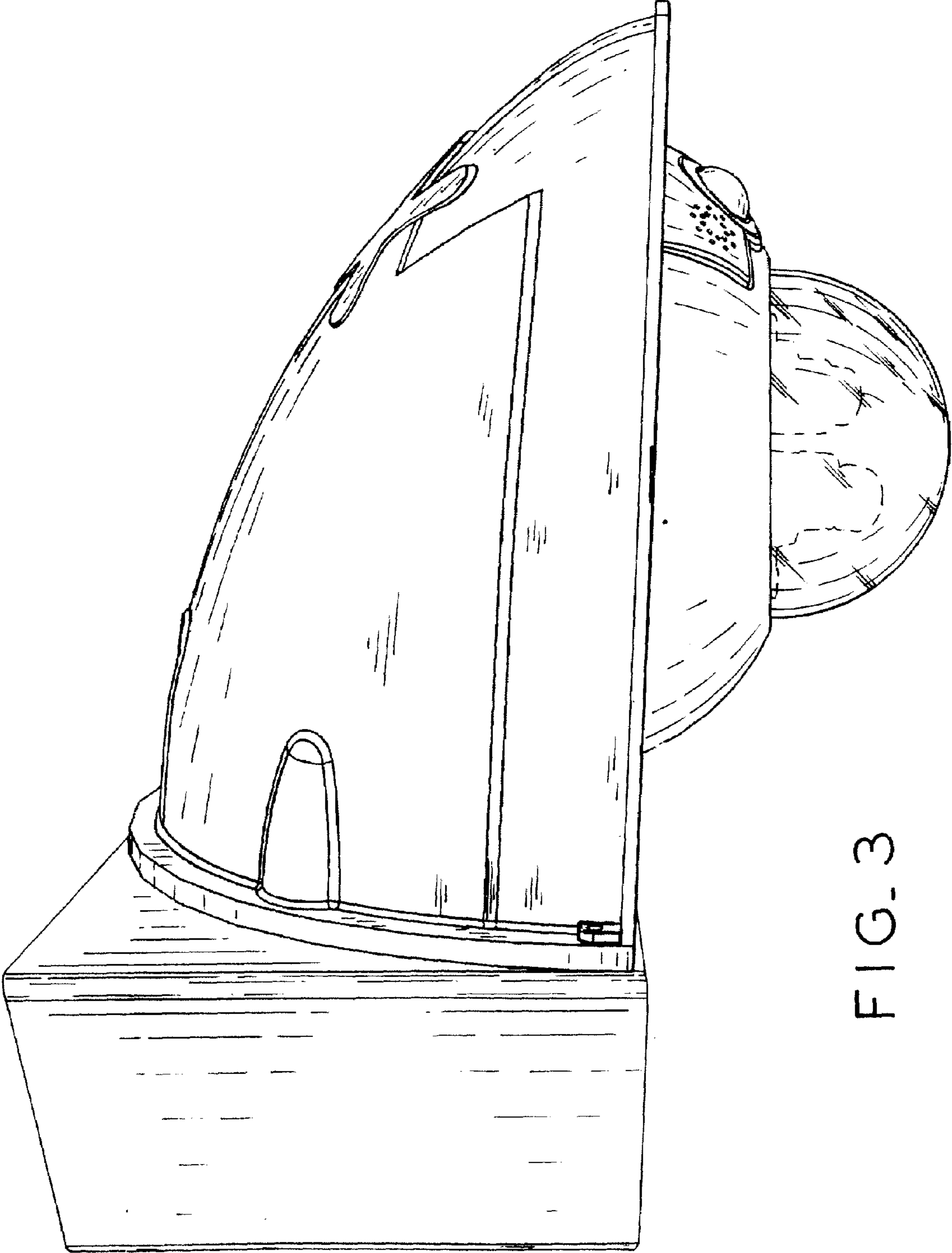

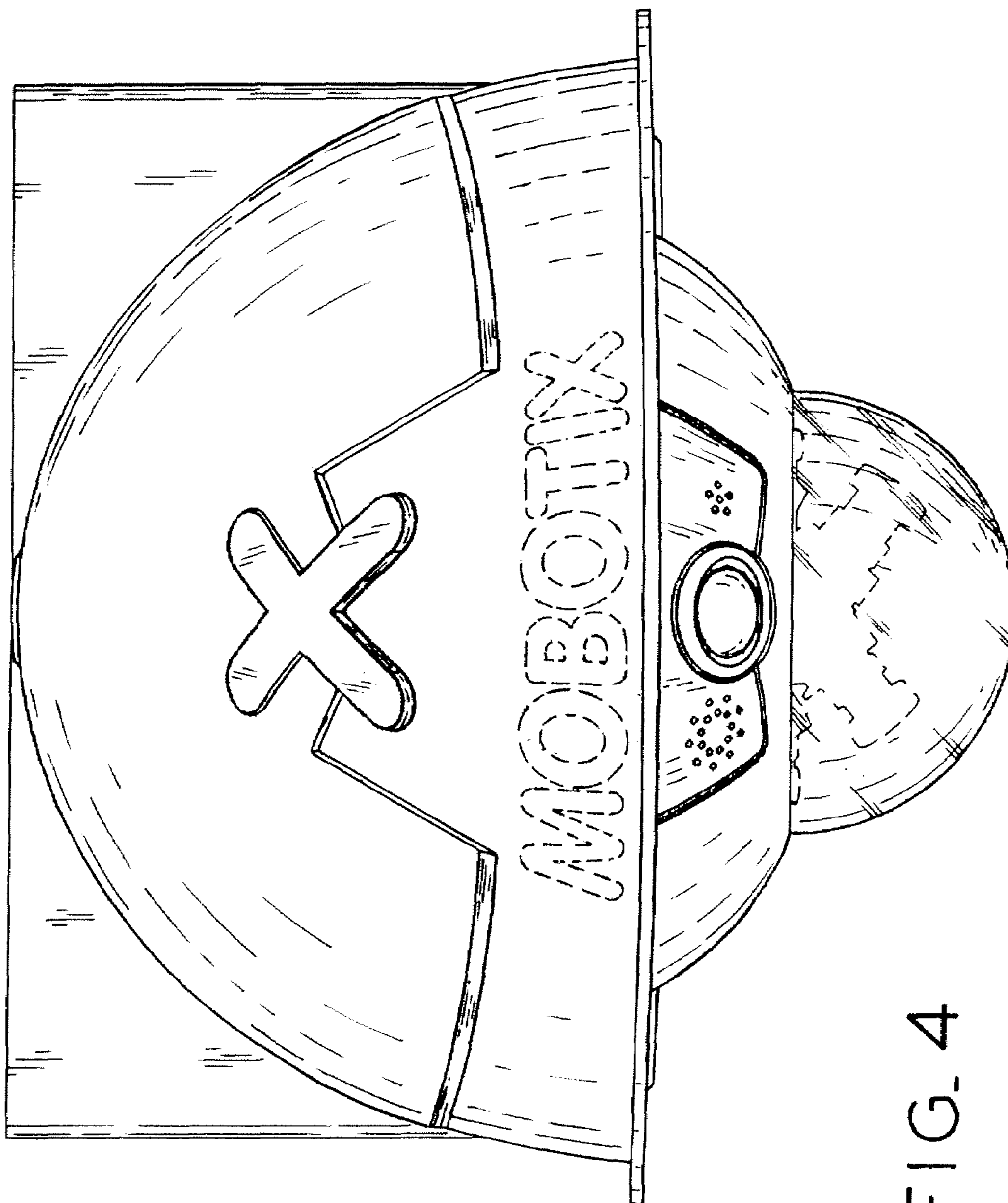

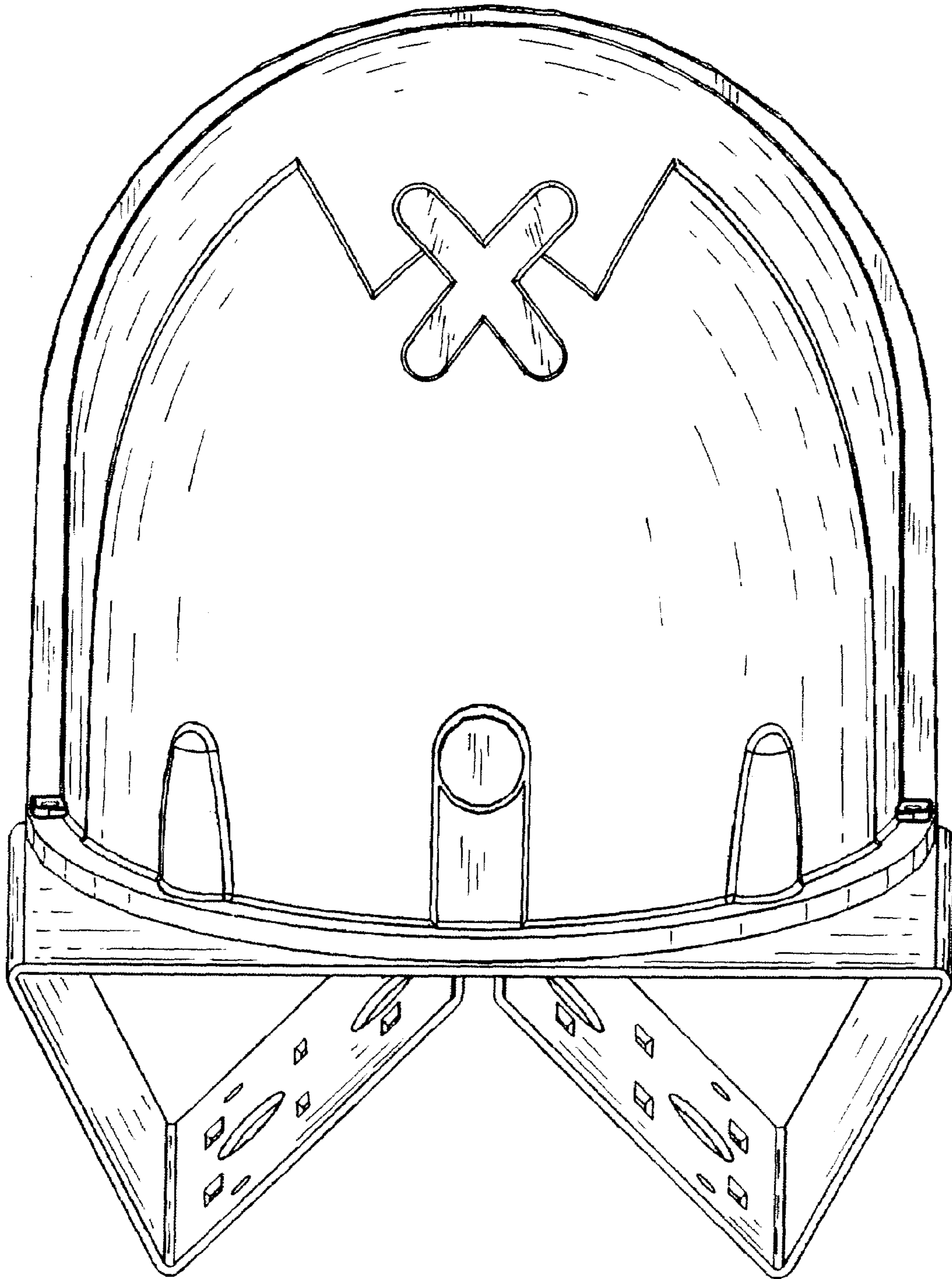

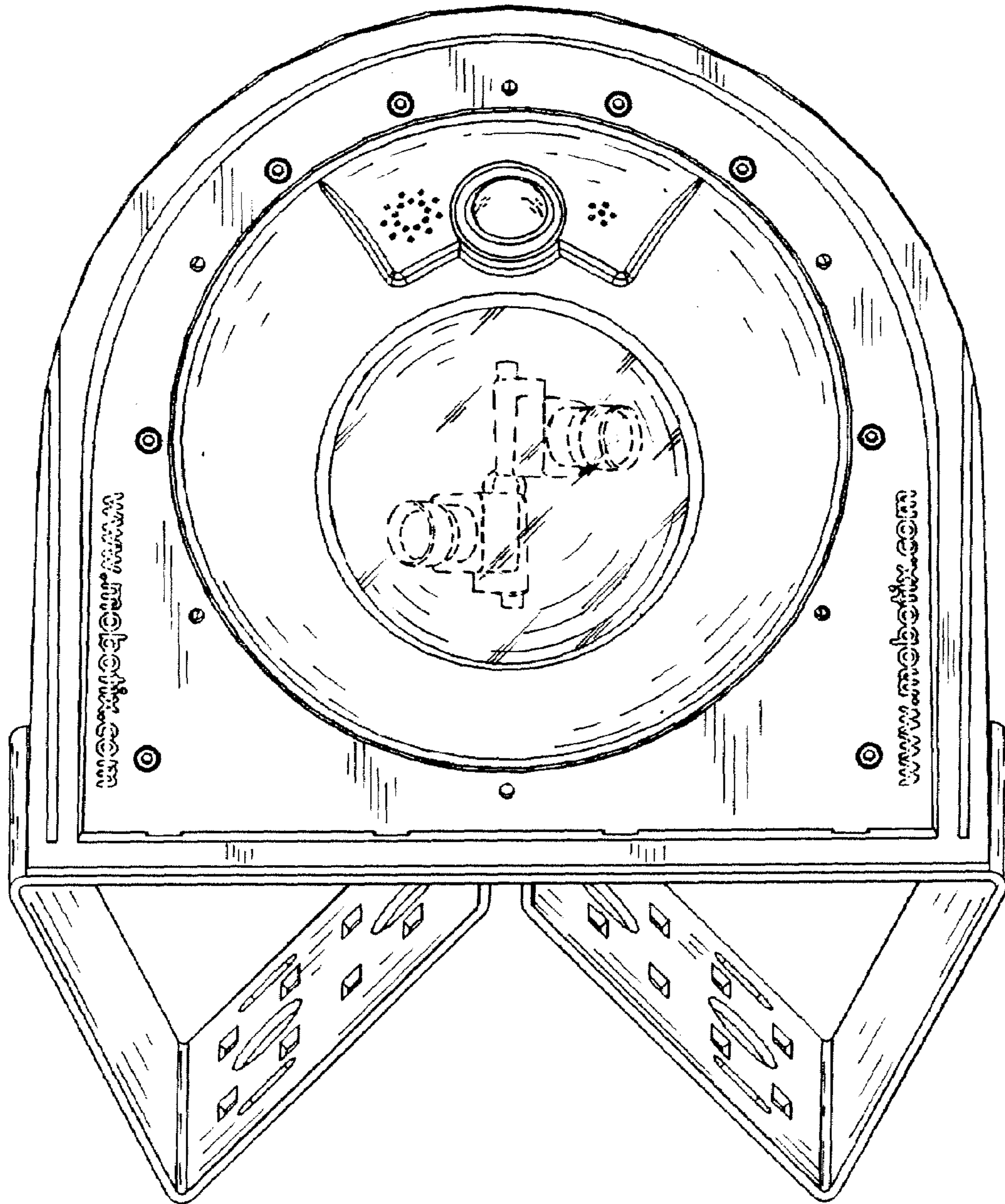

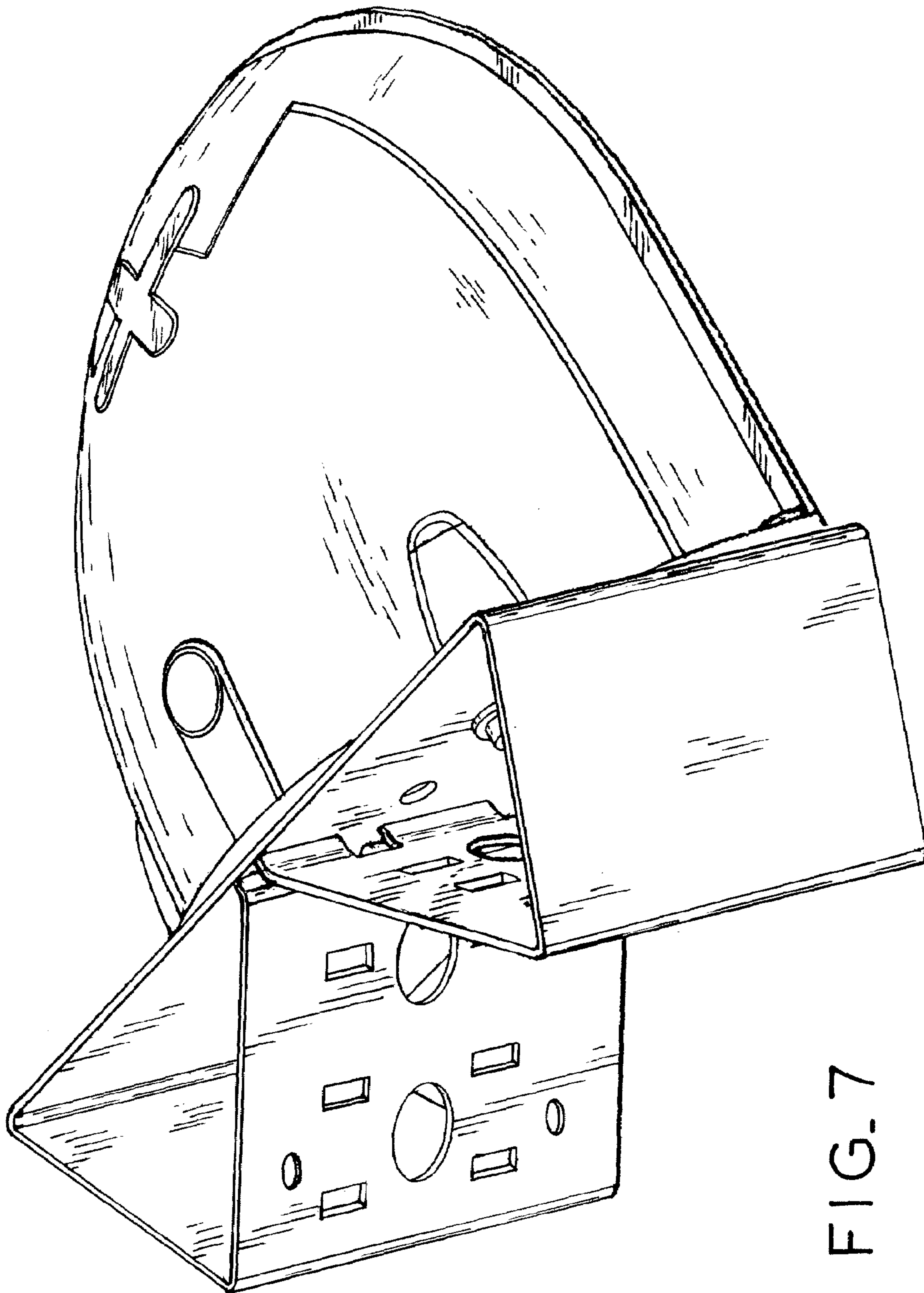

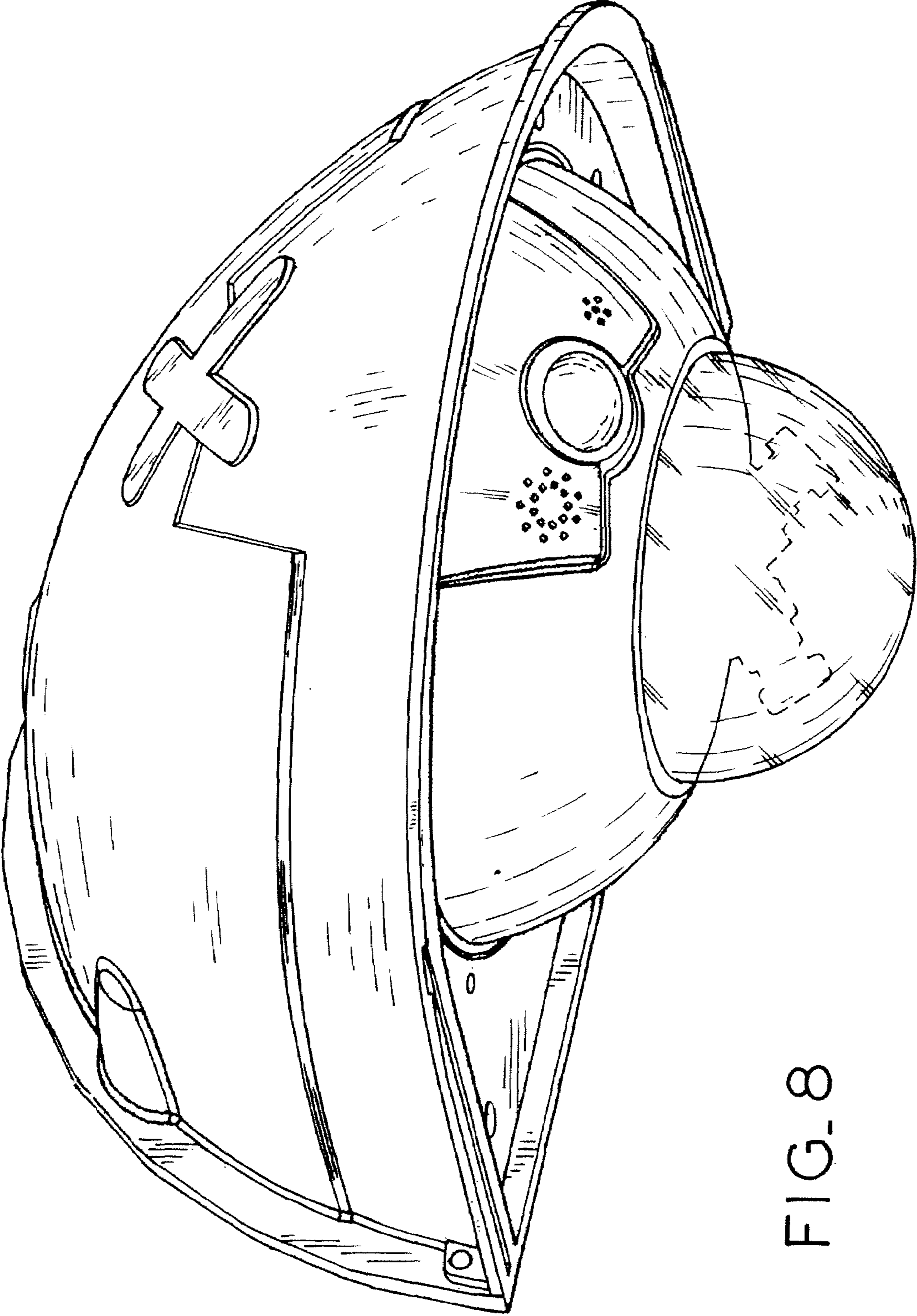

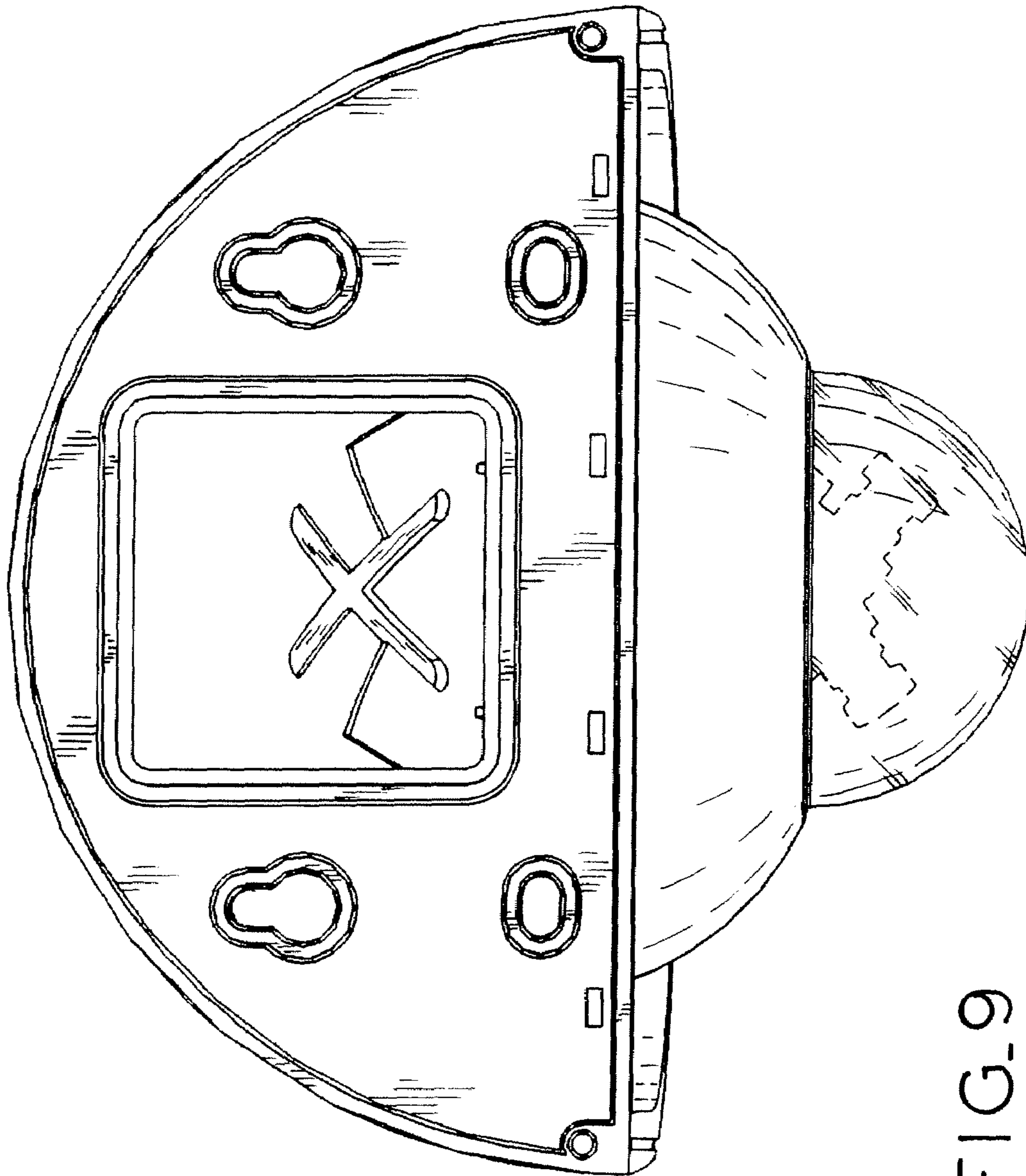

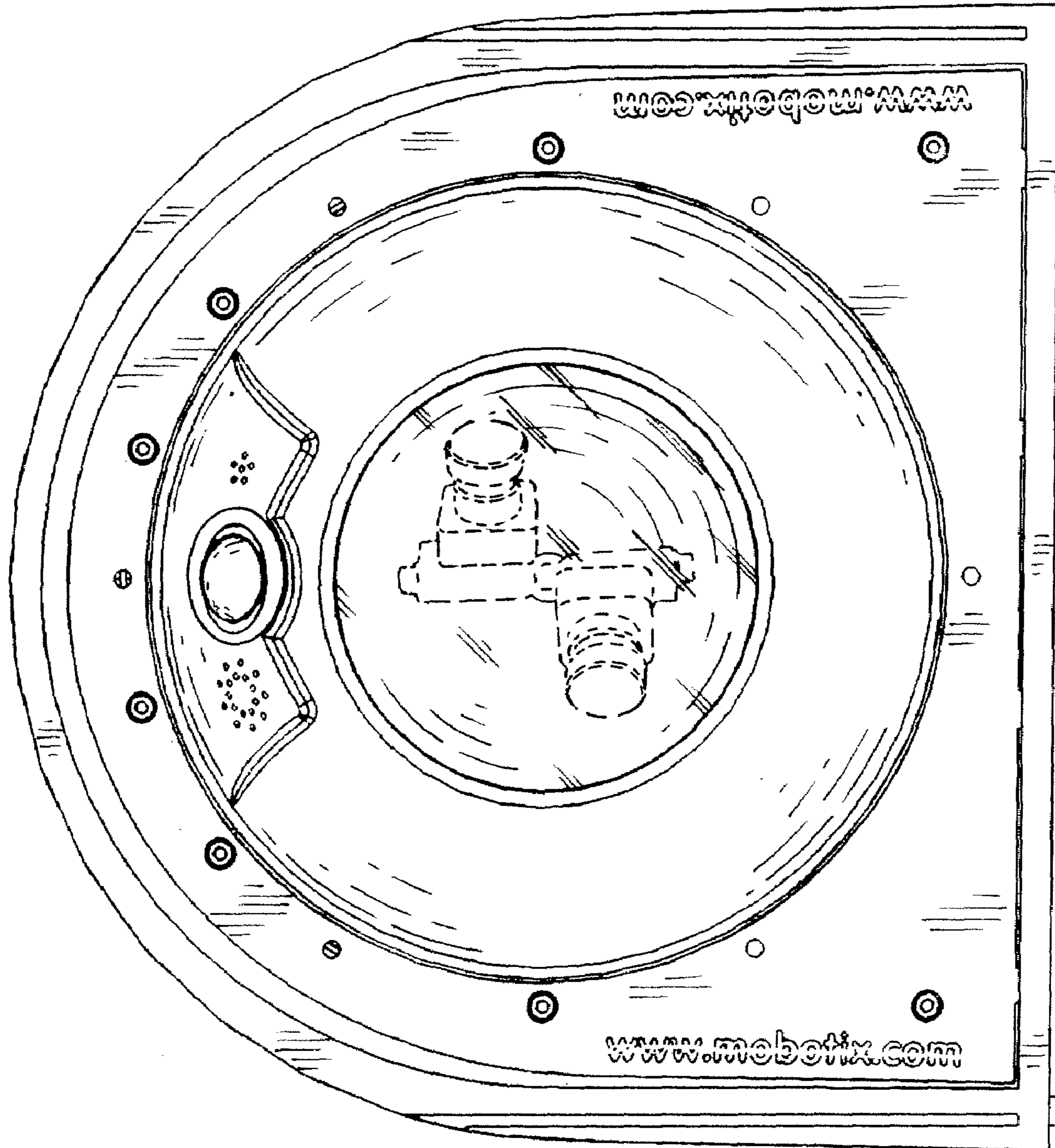

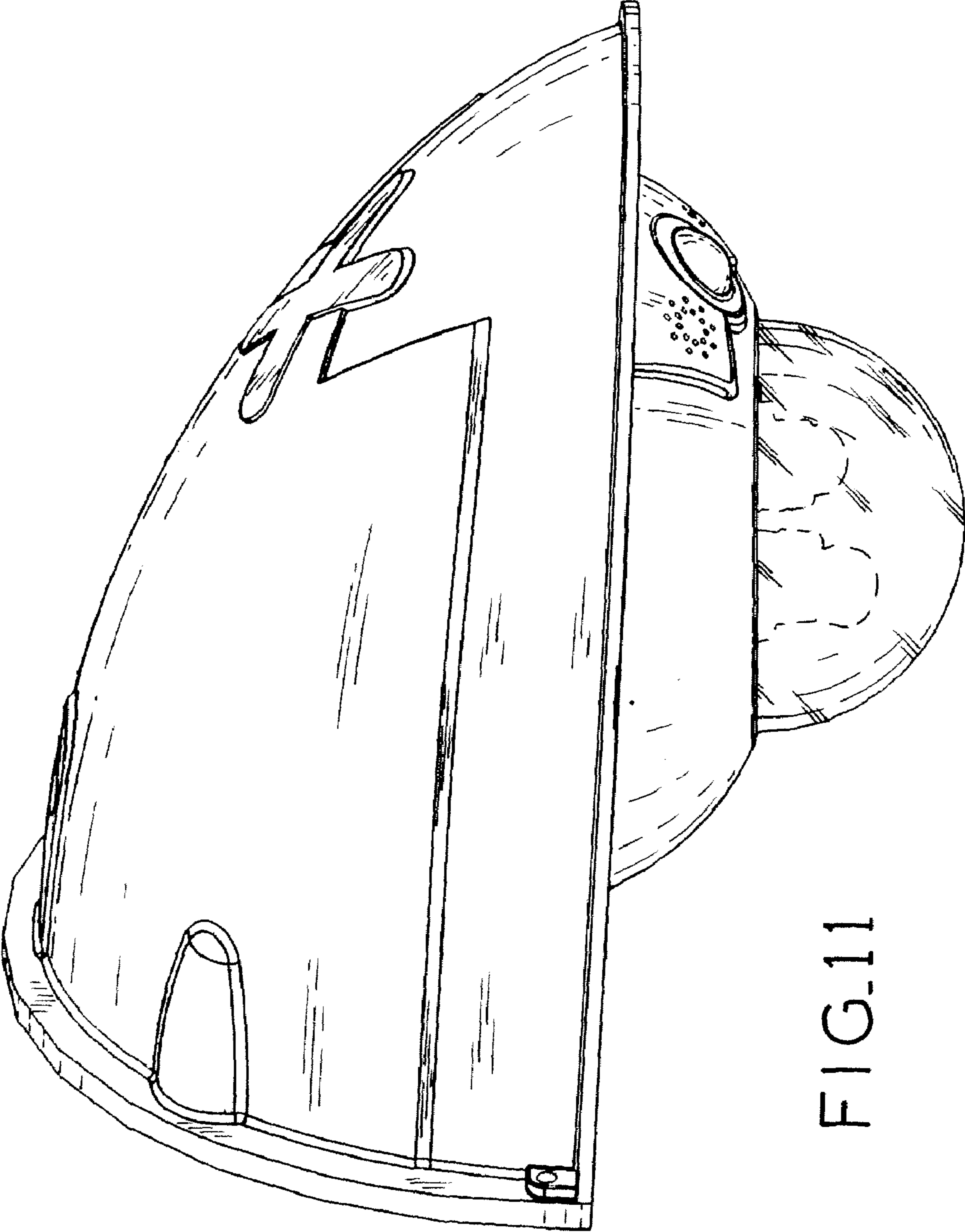

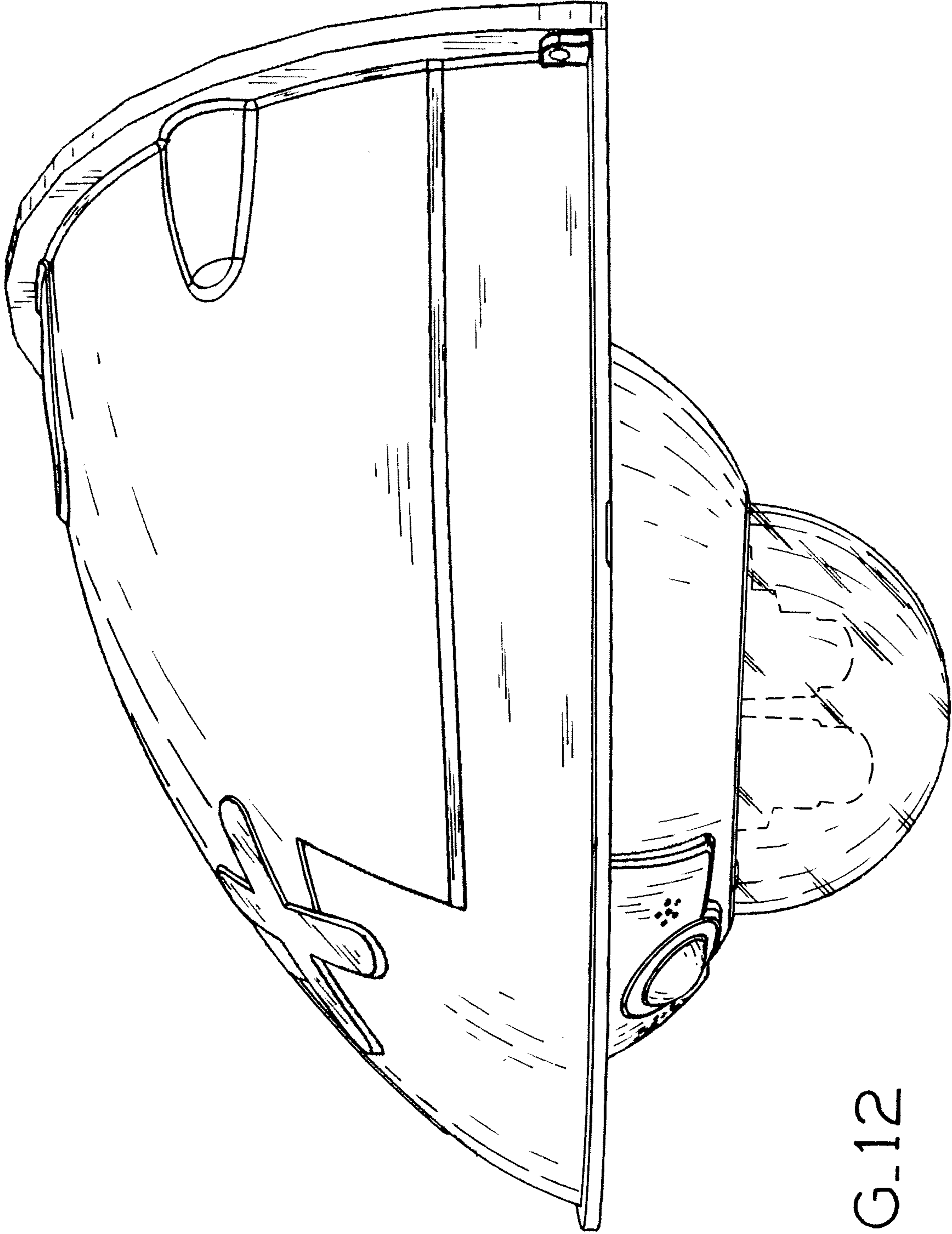

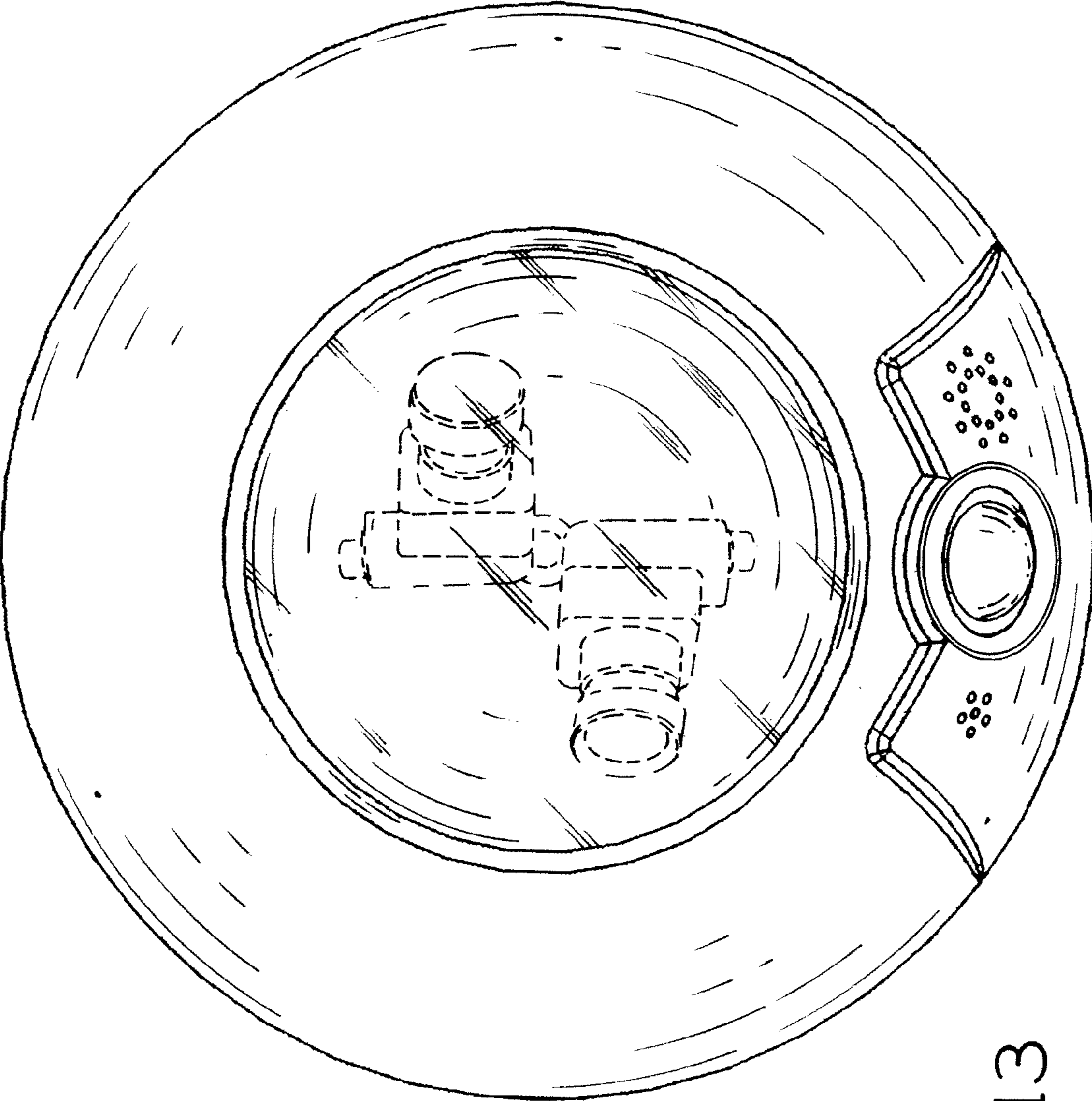

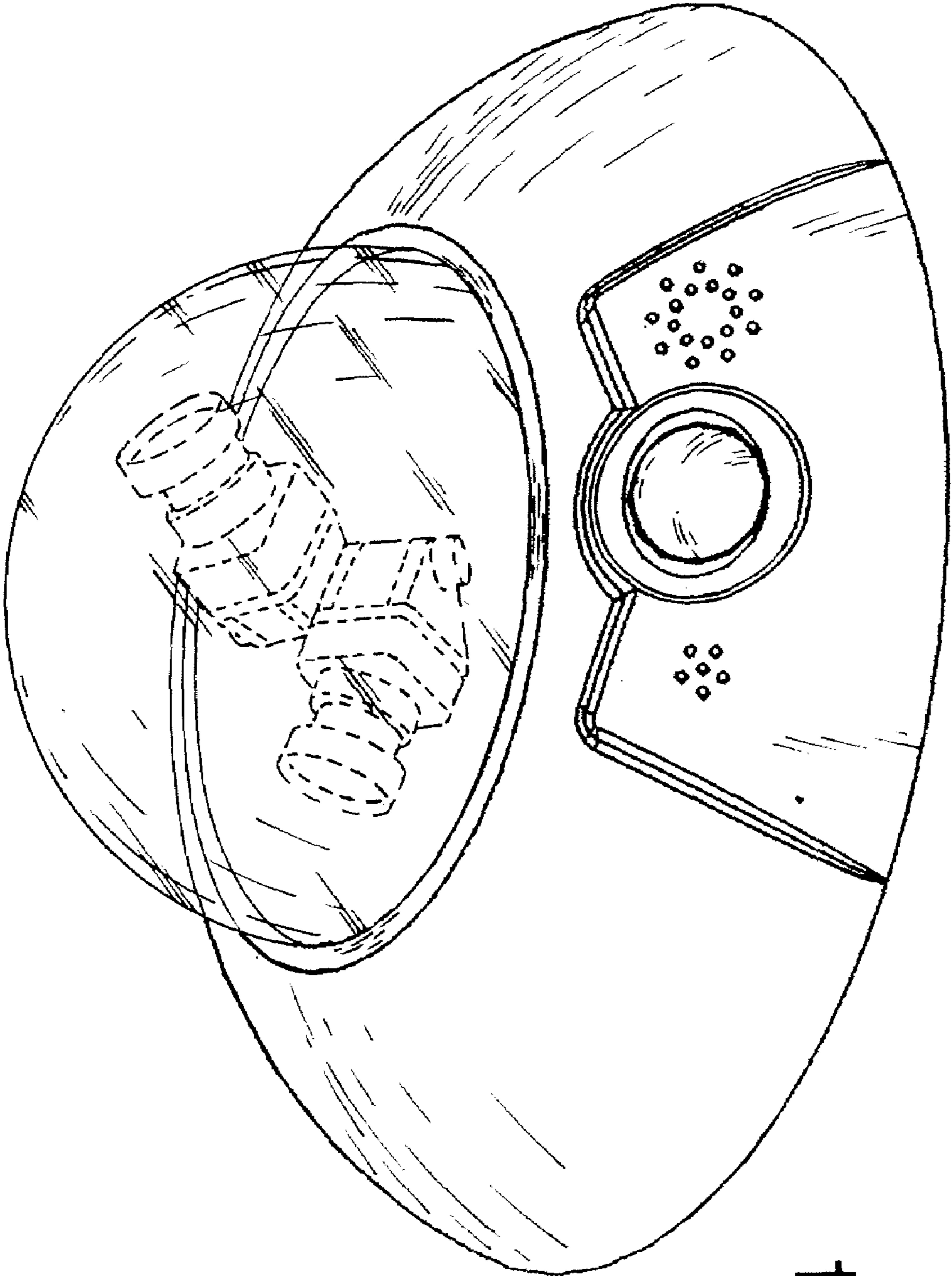

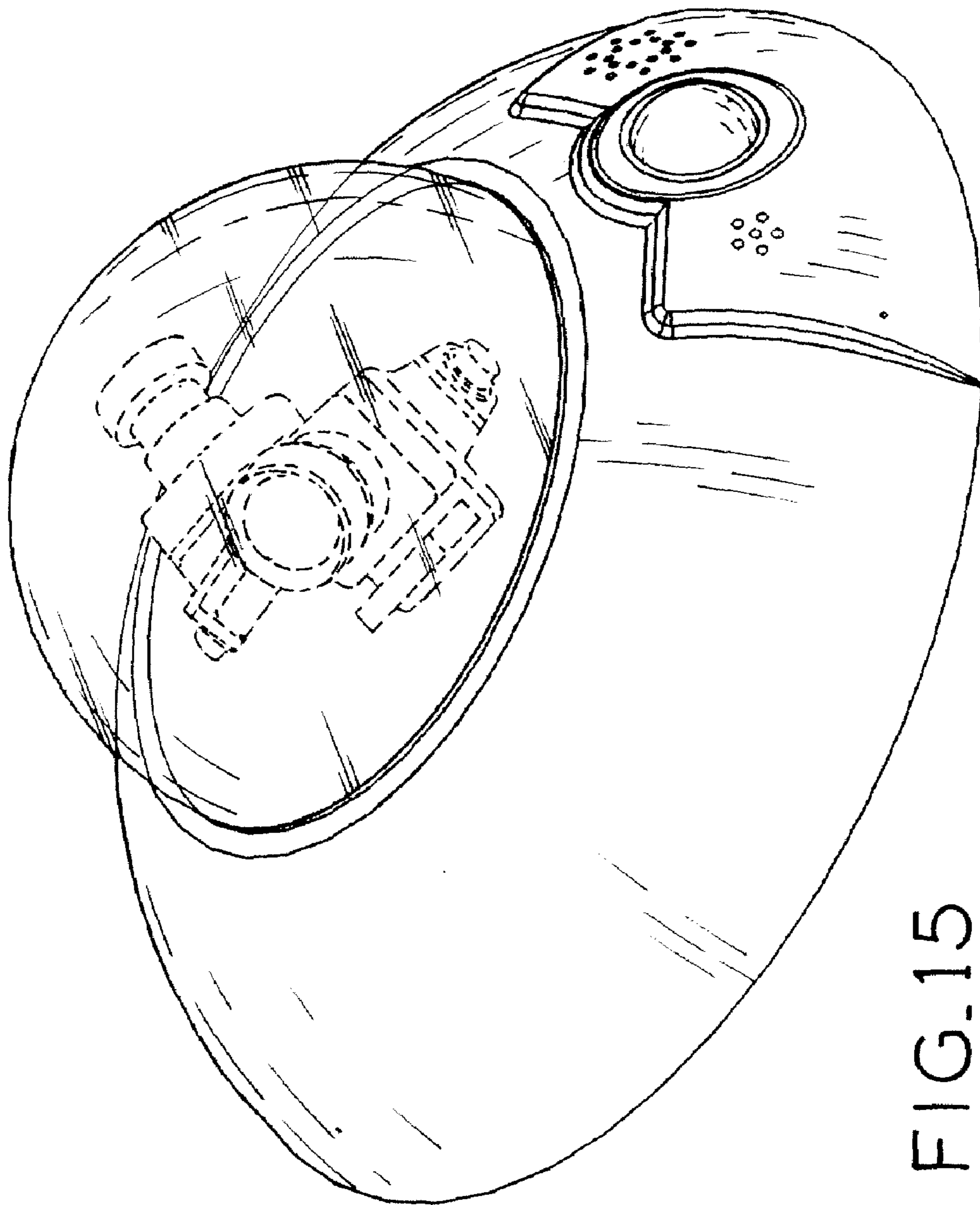

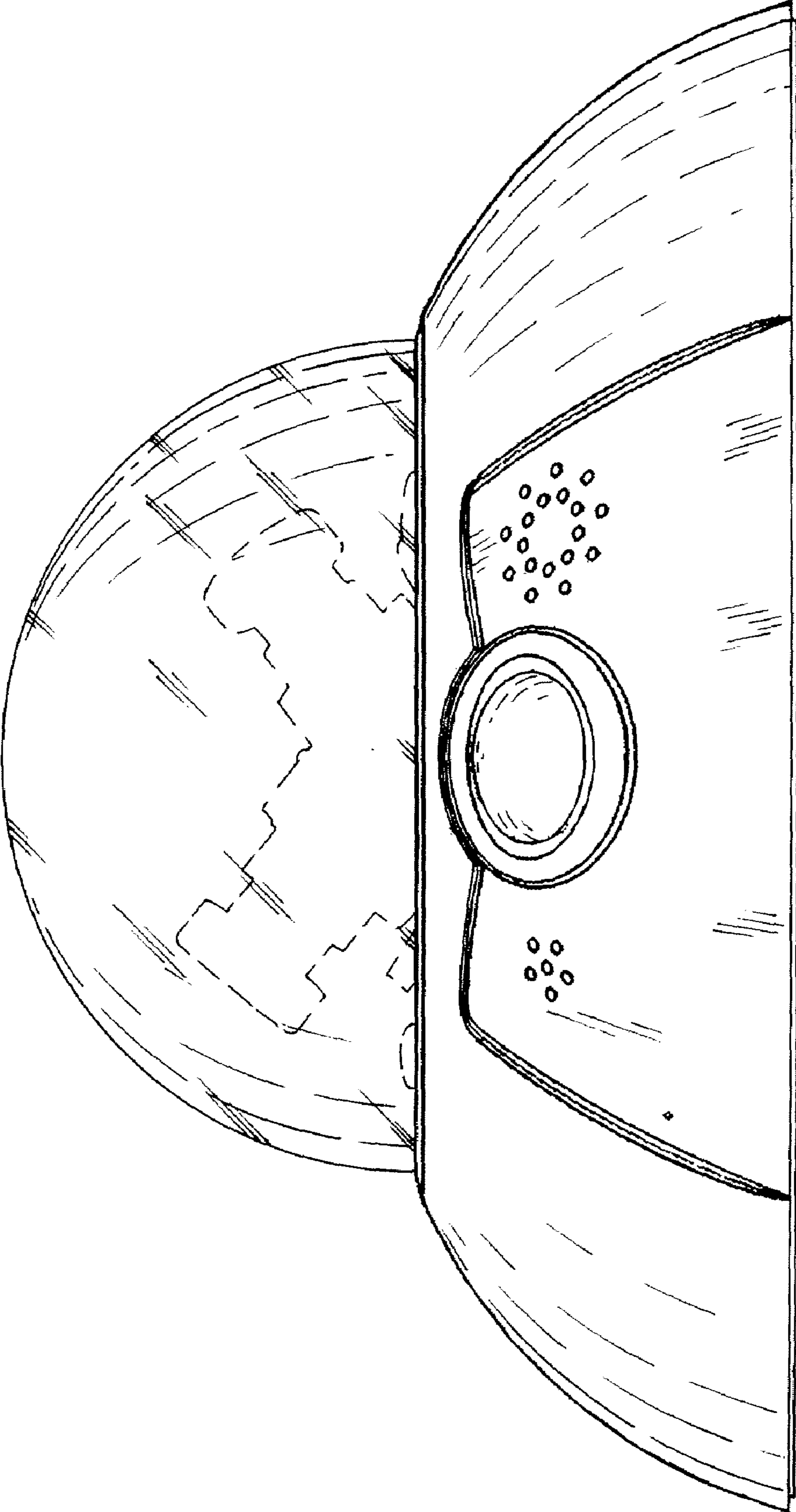

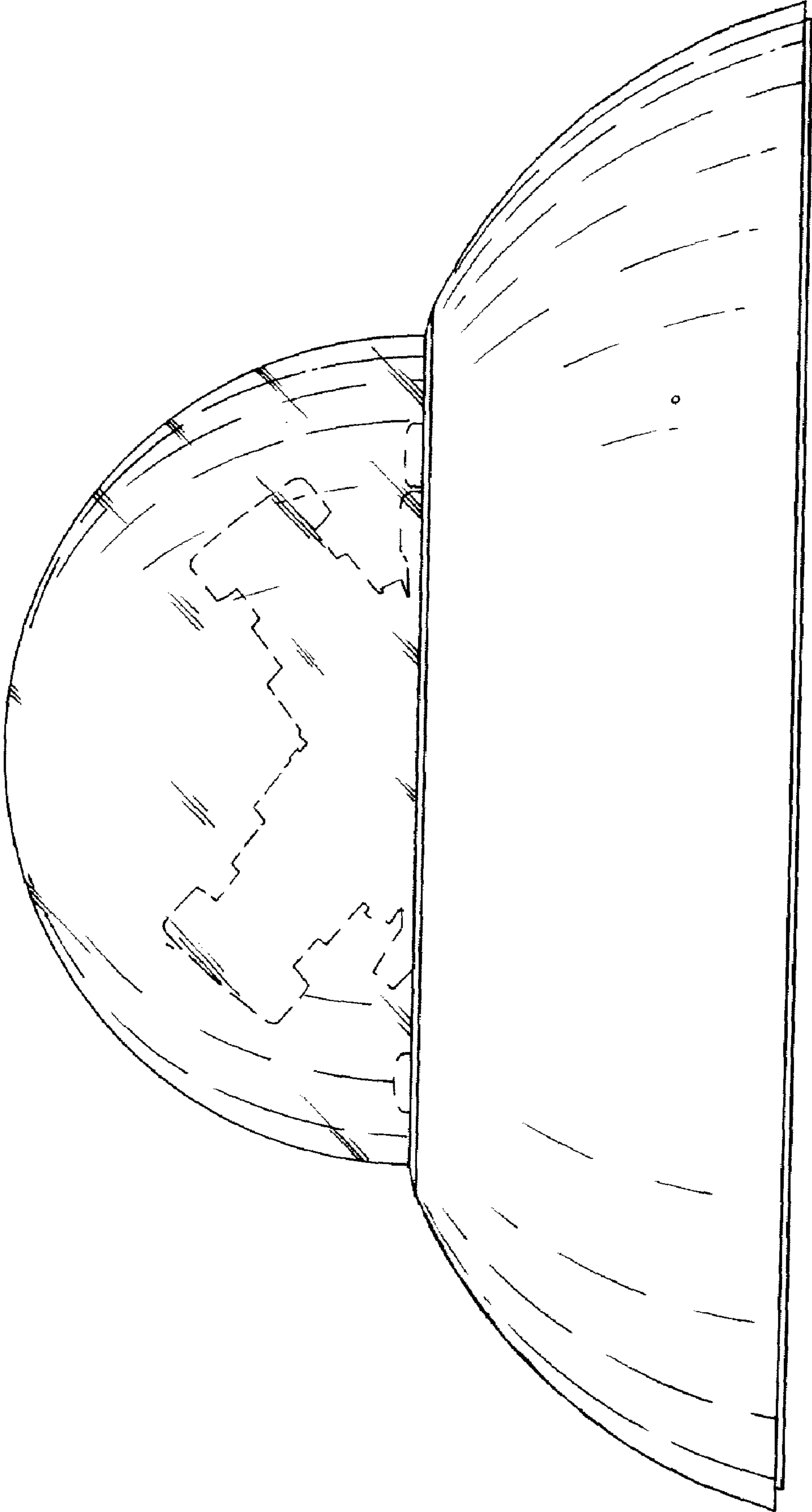

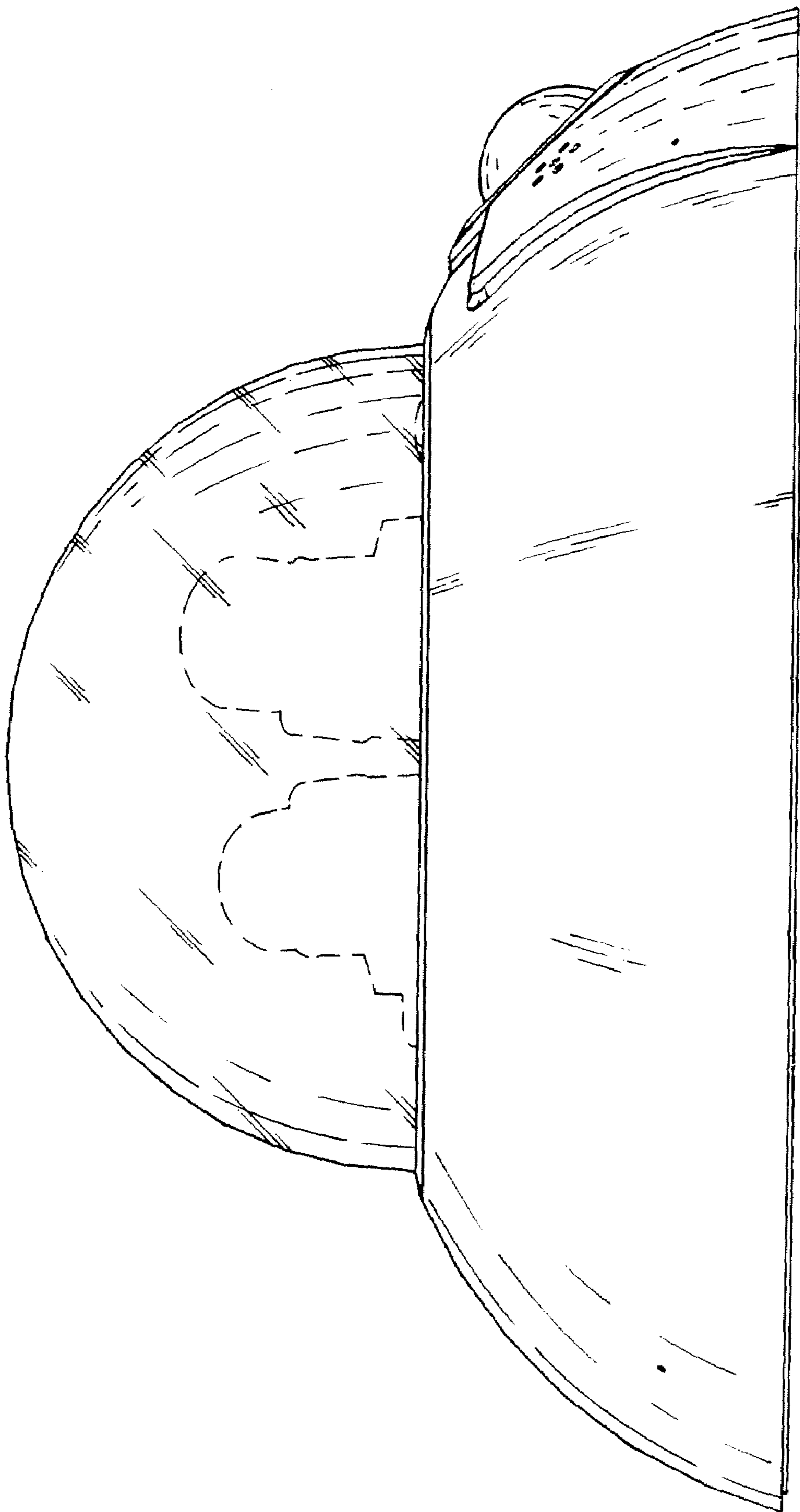

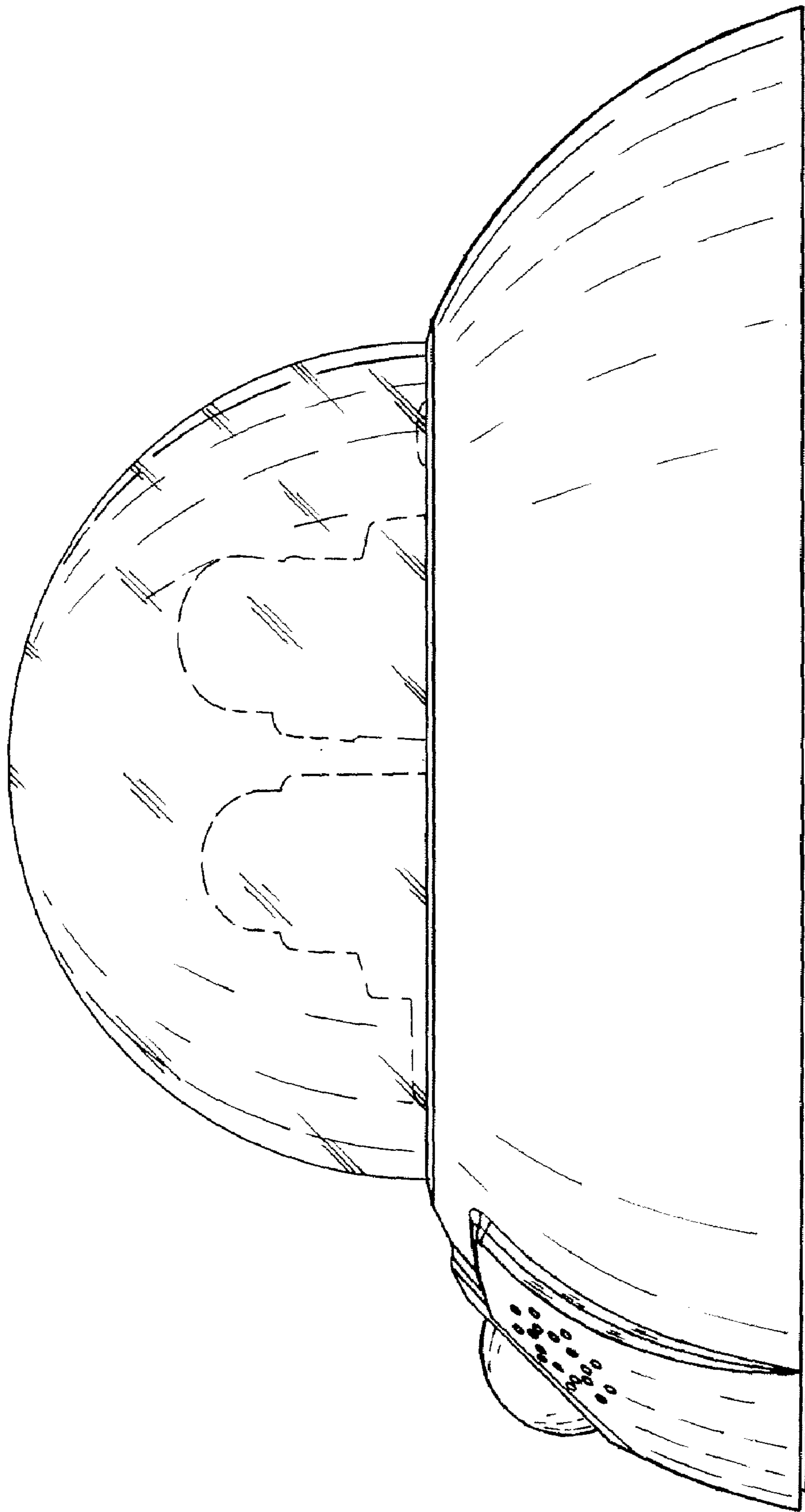

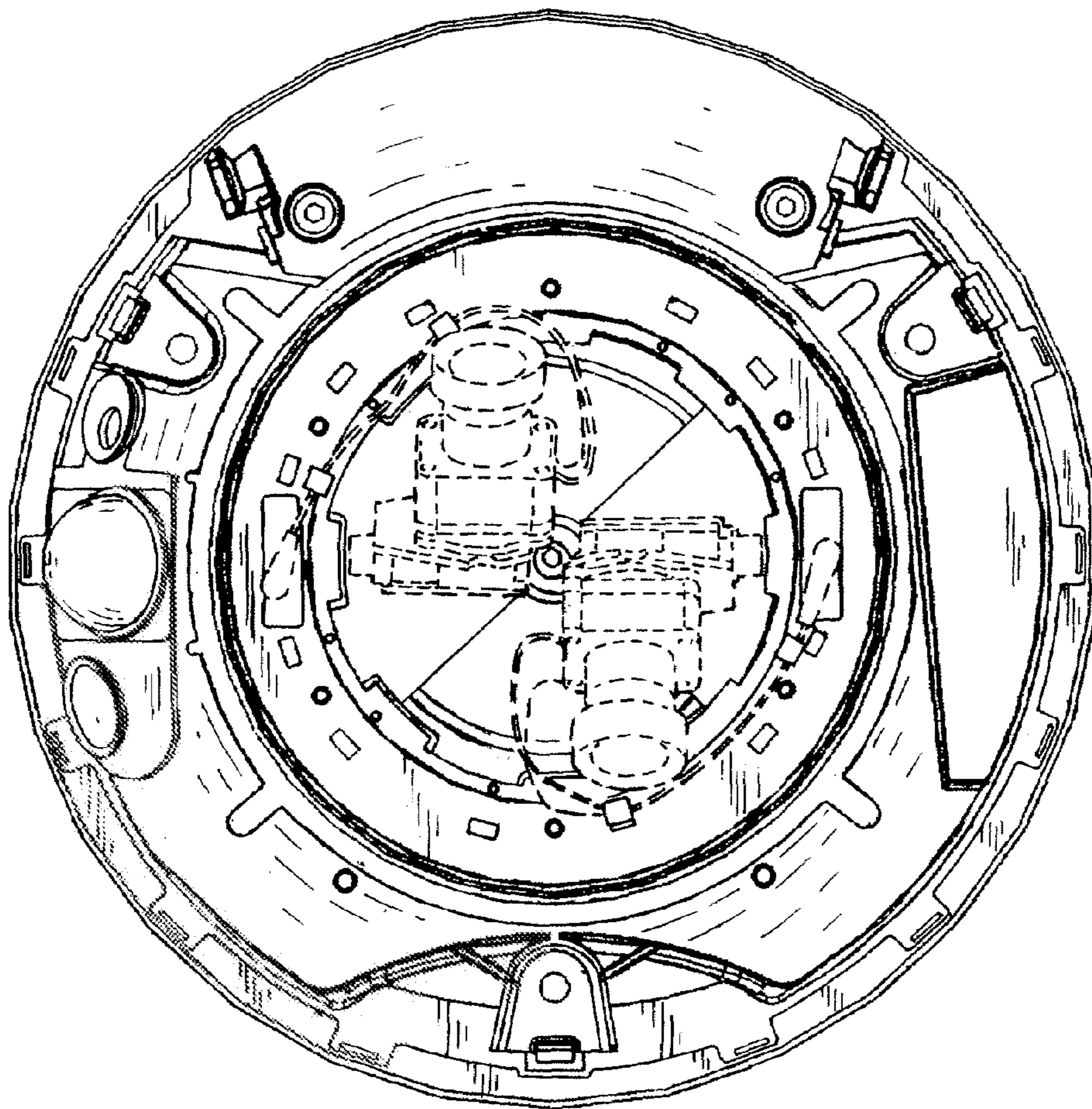

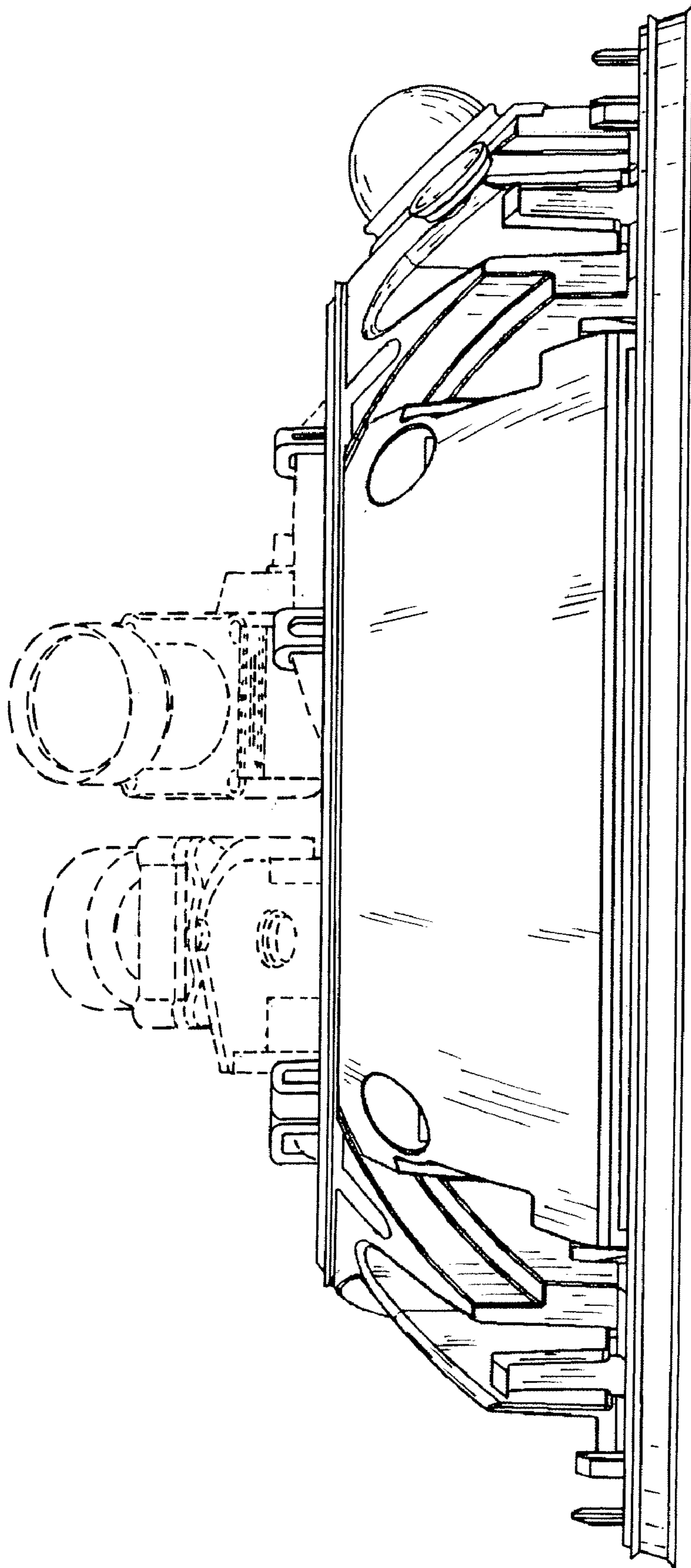

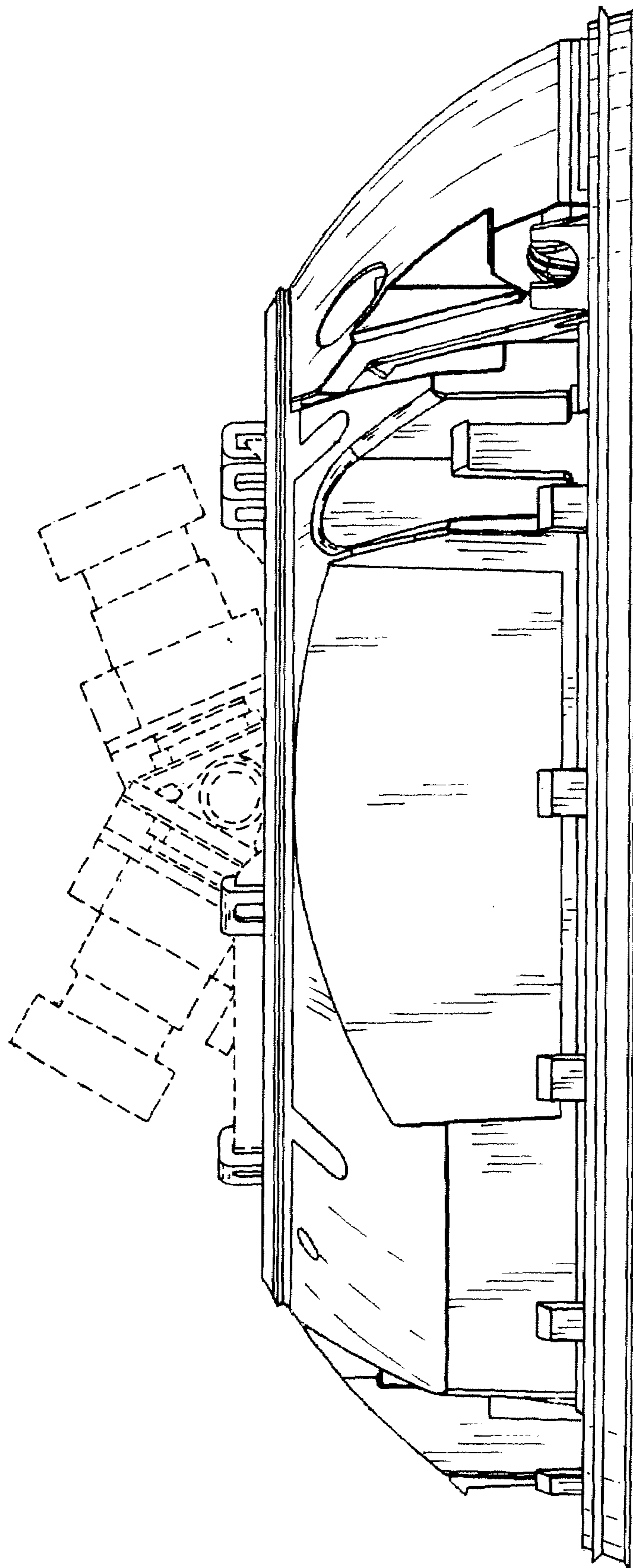

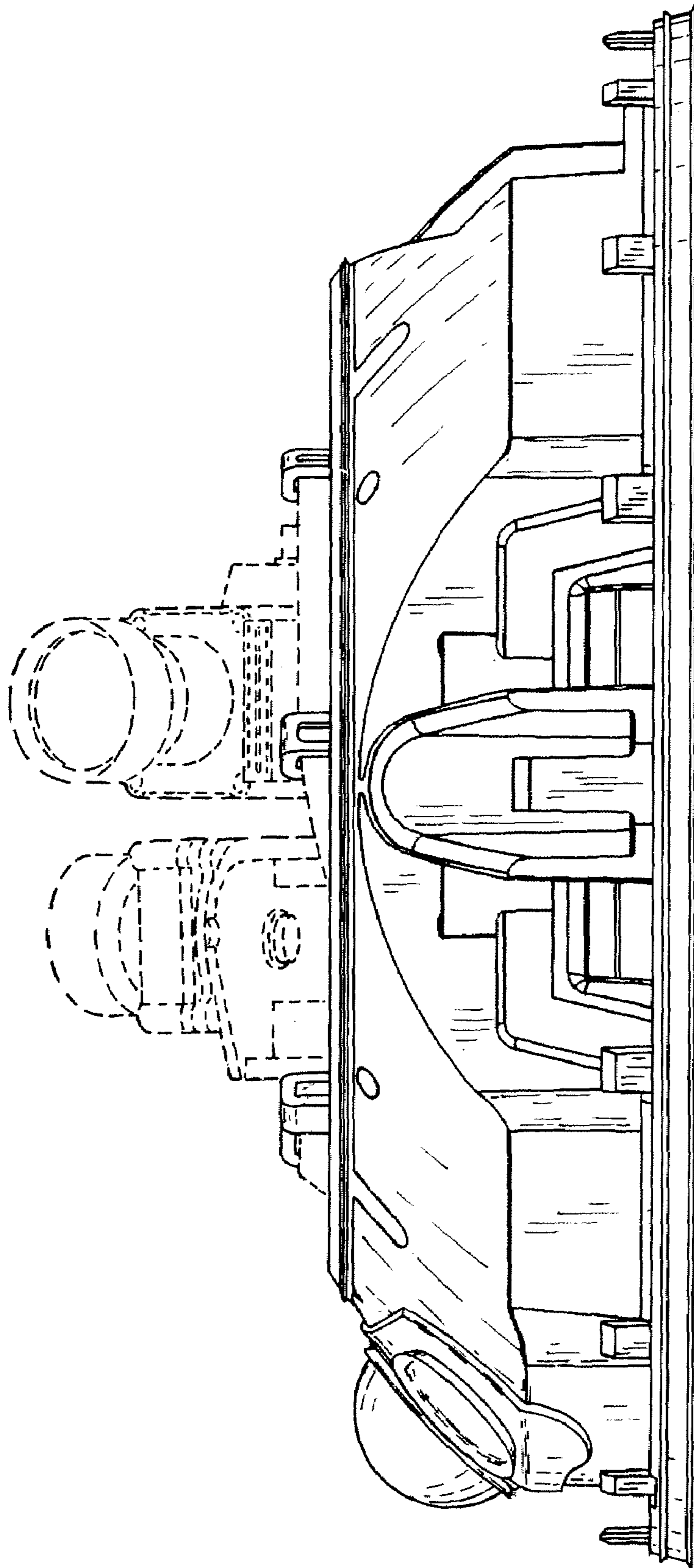

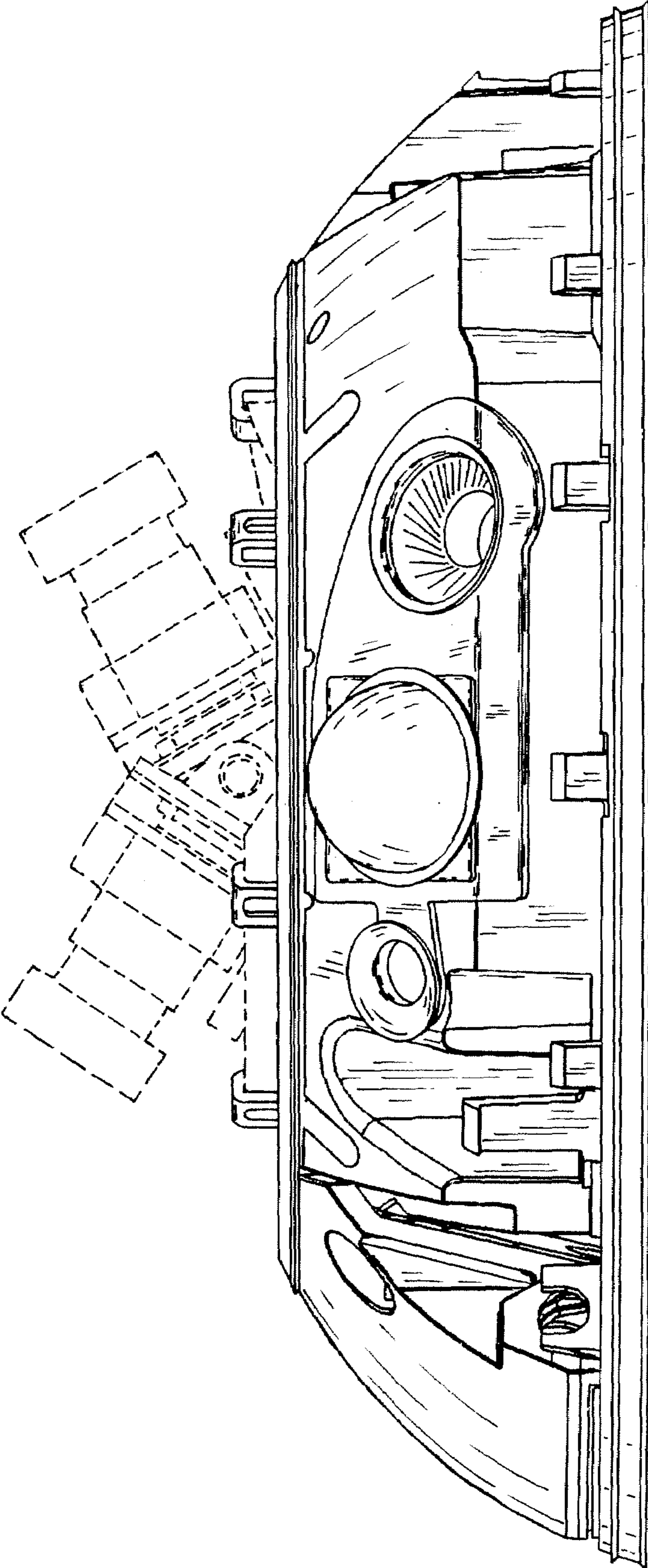

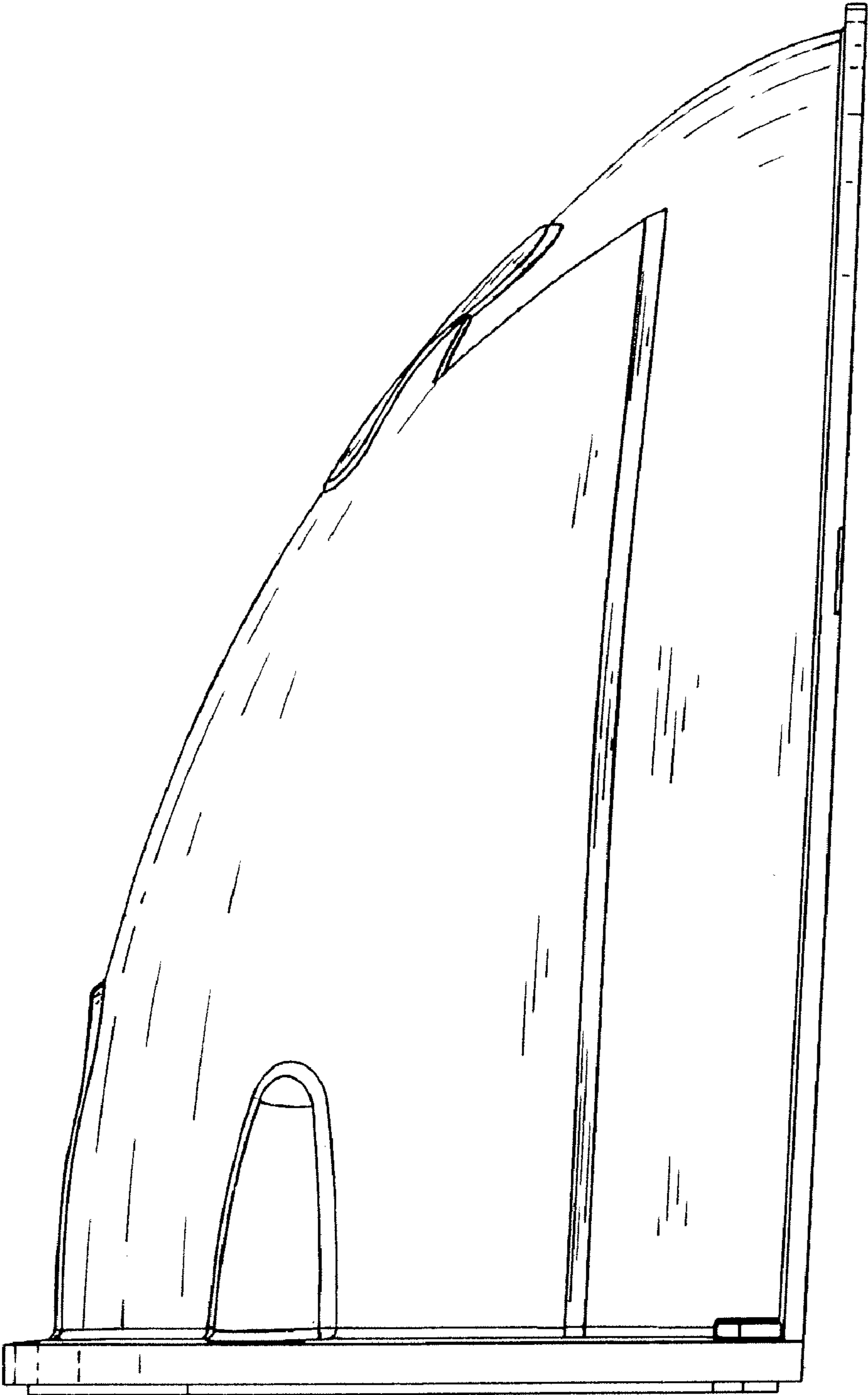

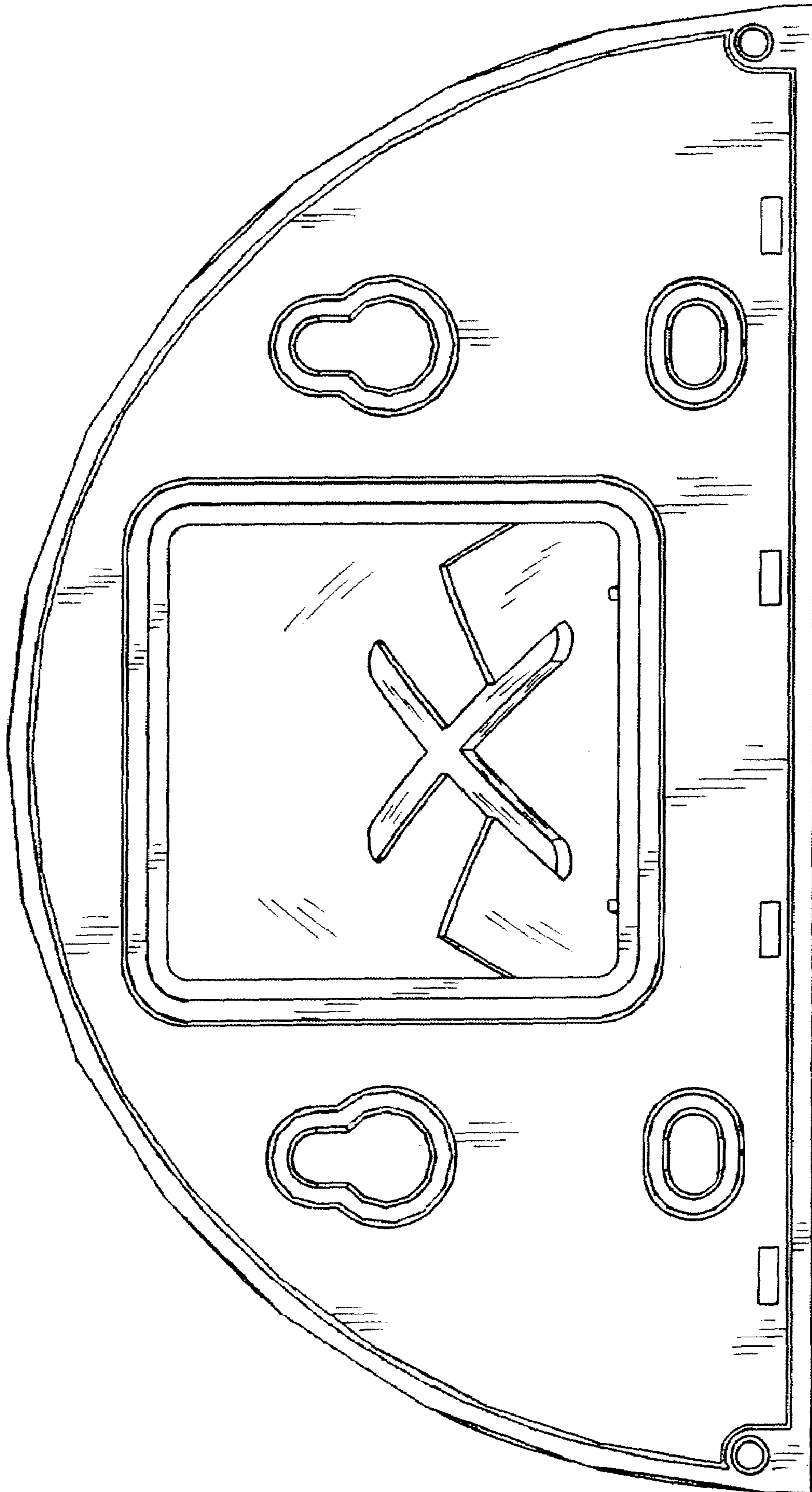

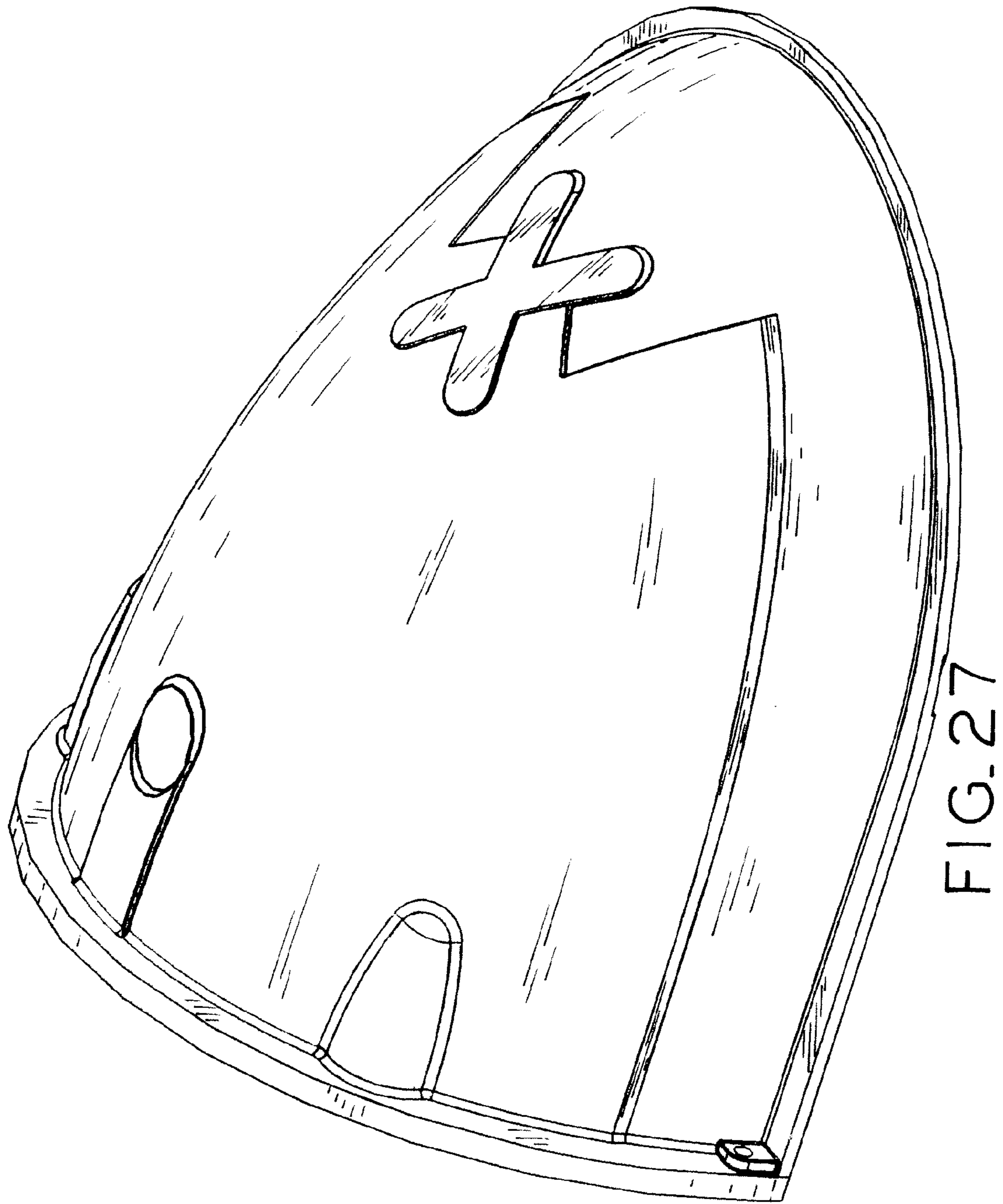

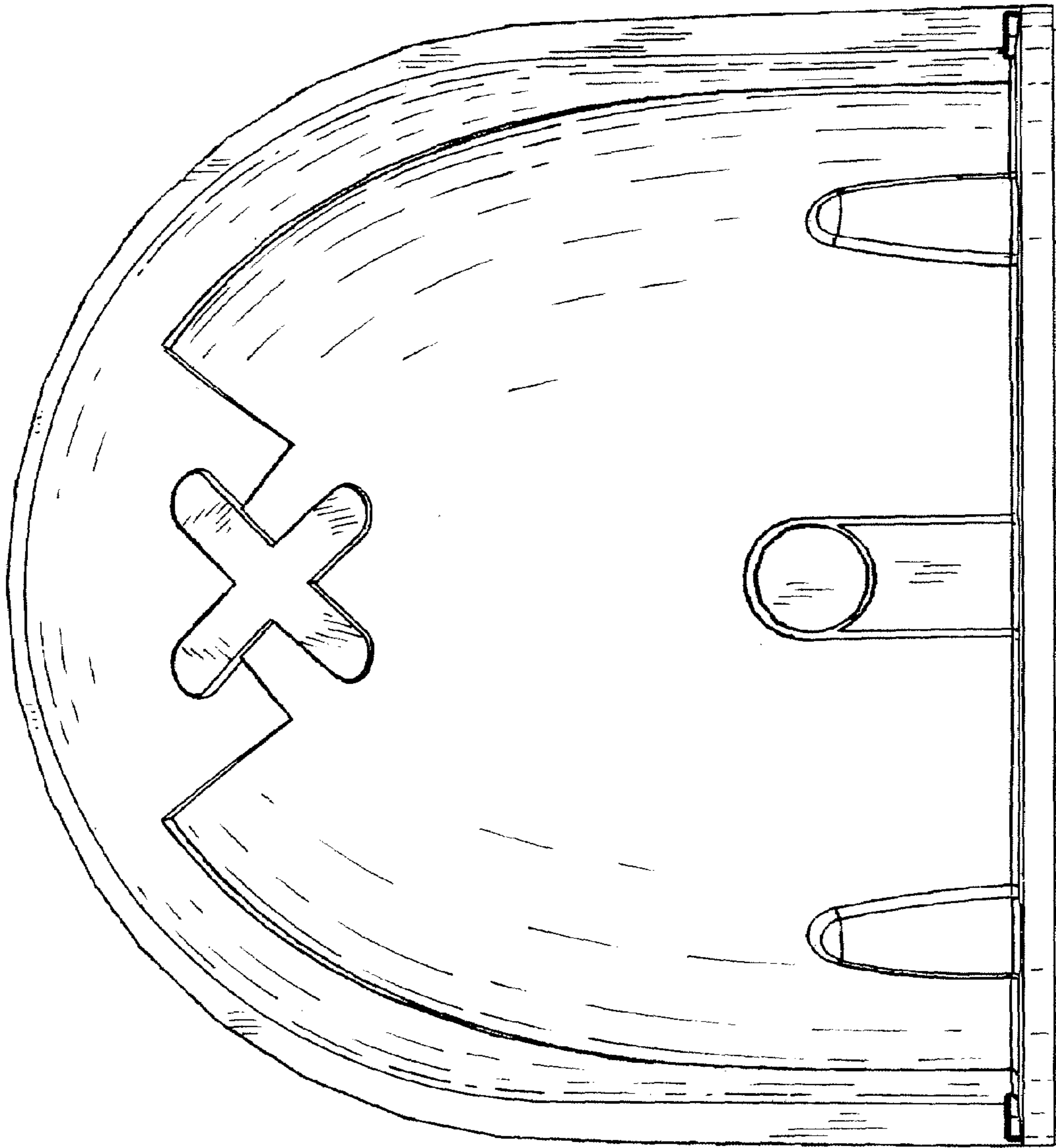

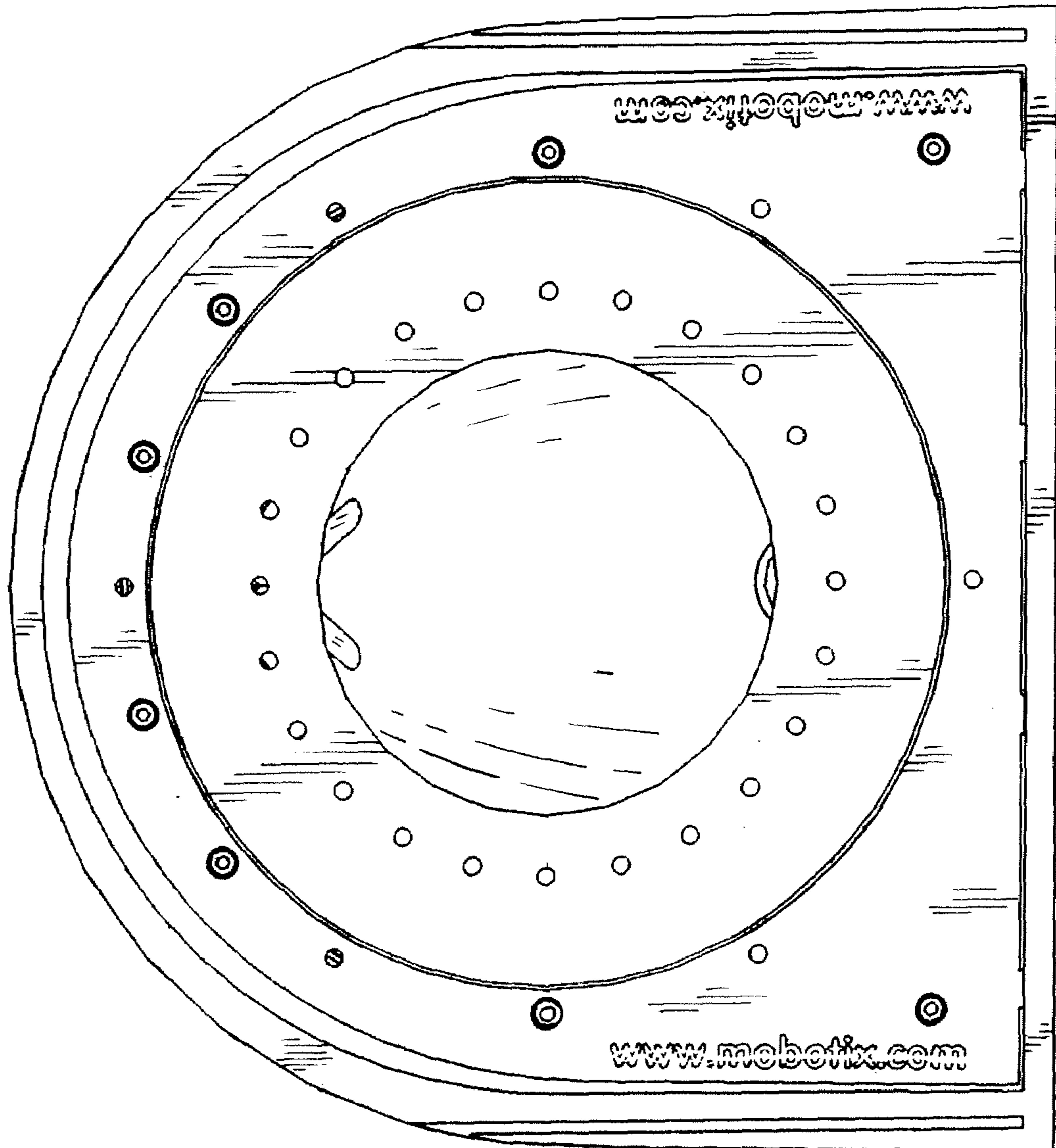

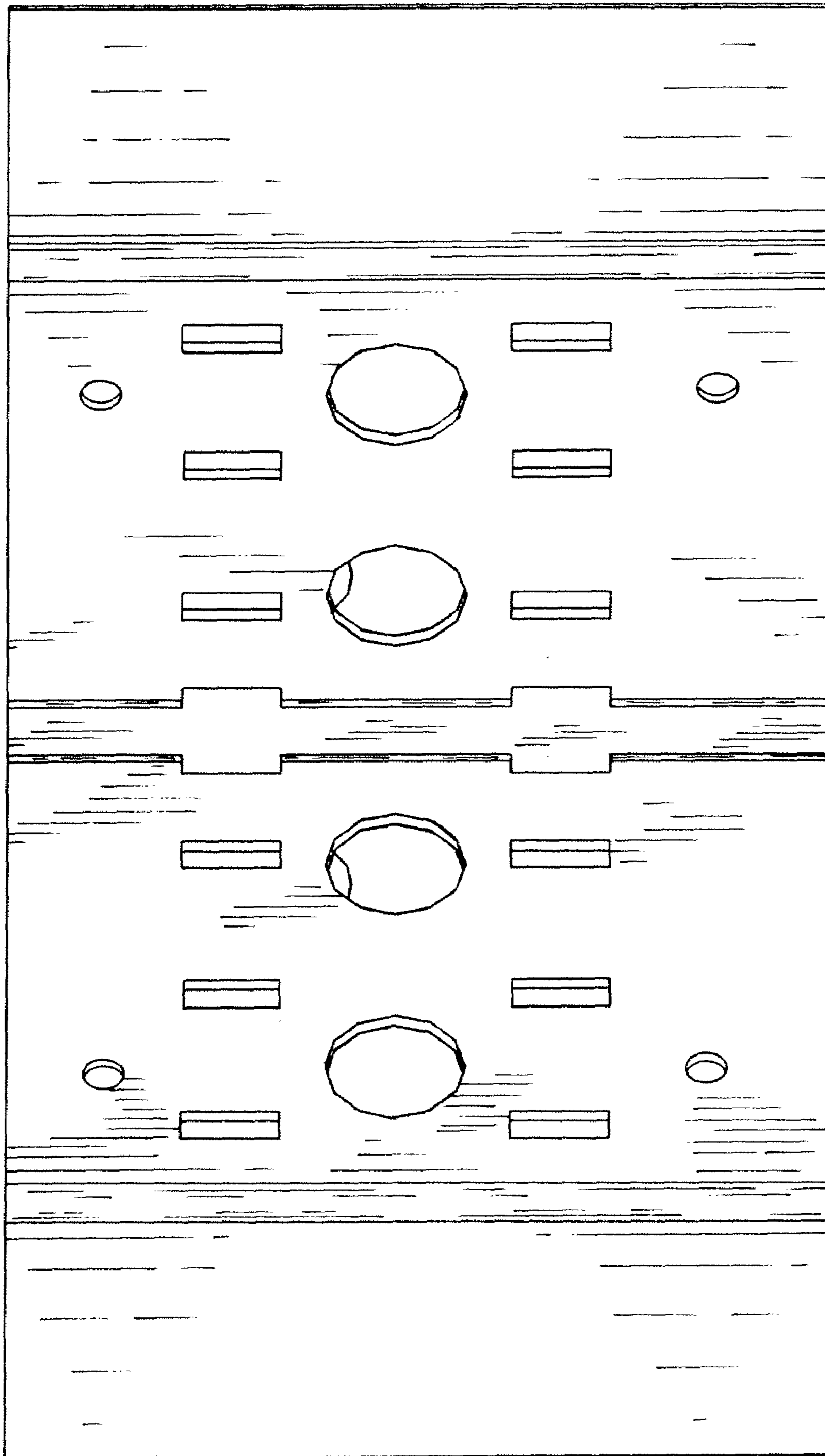

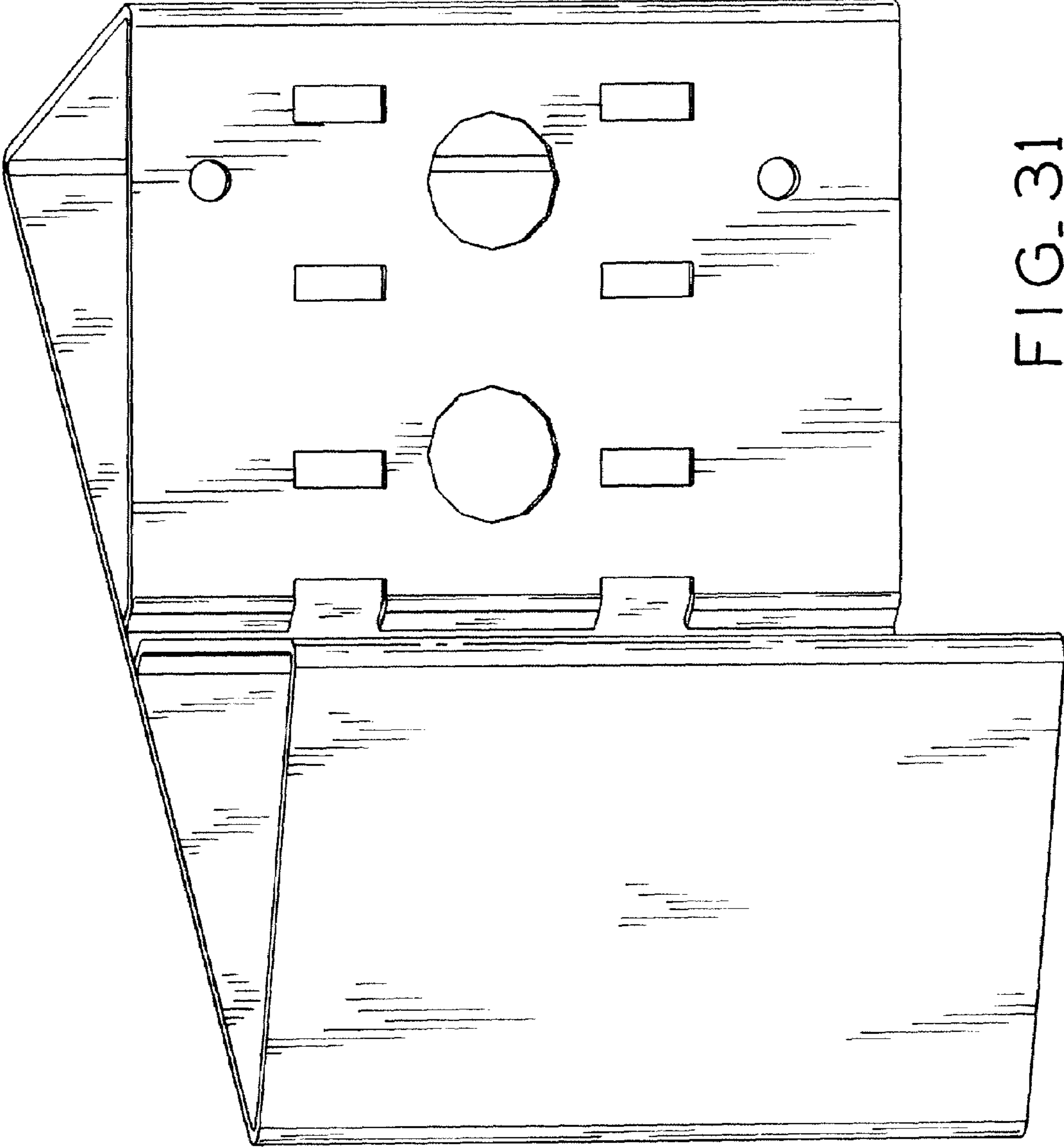

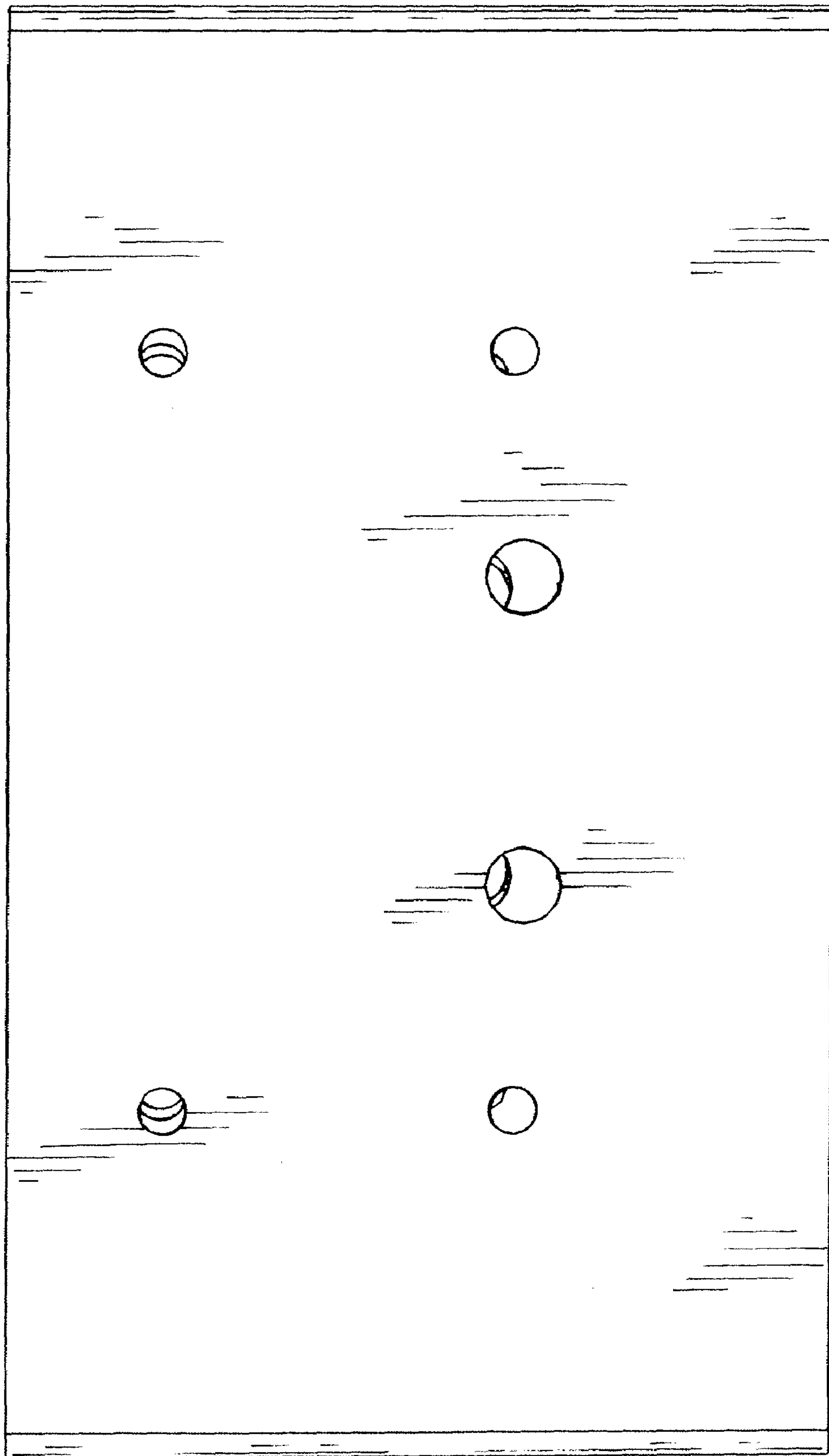

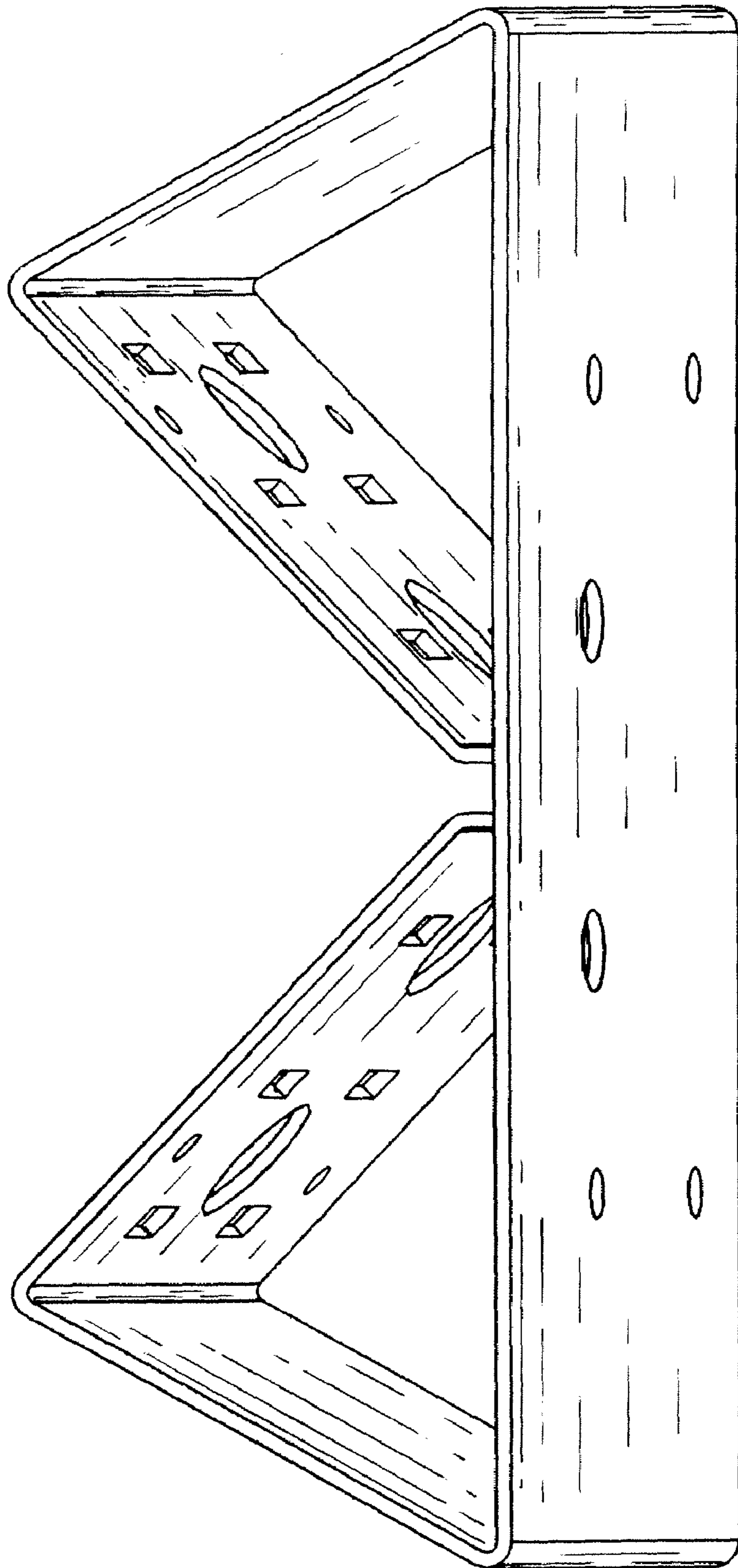
