(57) **CLAIM**

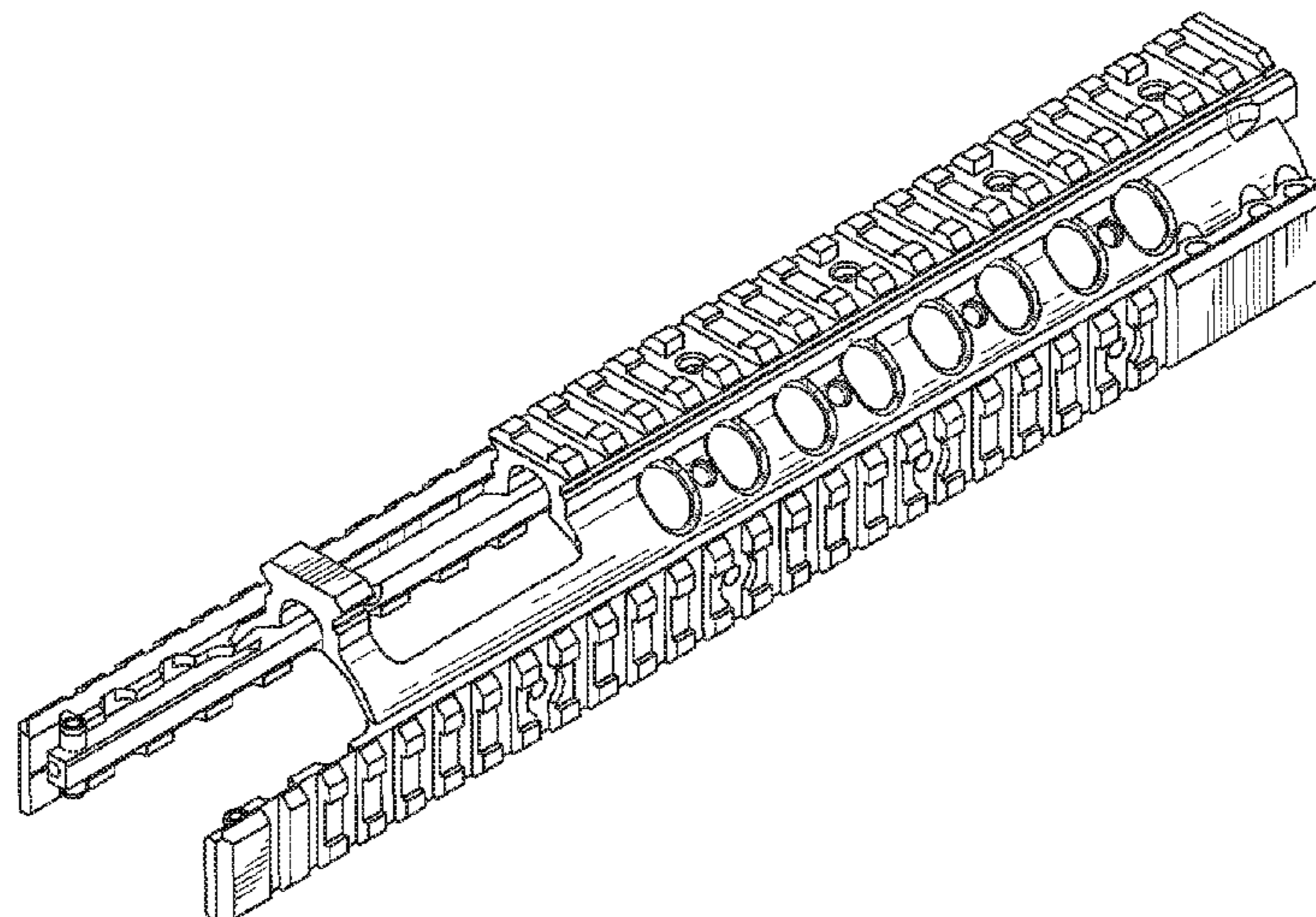
The ornamental design for a weapon handguard, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the weapon handguard in accordance with the present invention;  
FIG. 2 is a right side view thereof;  
FIG. 3 is a left side view thereof;  
FIG. 4 is a top view thereof;  
FIG. 5 is a bottom view thereof;  
FIG. 6 is a front view thereof; and,  
FIG. 7 is a rear view thereof.

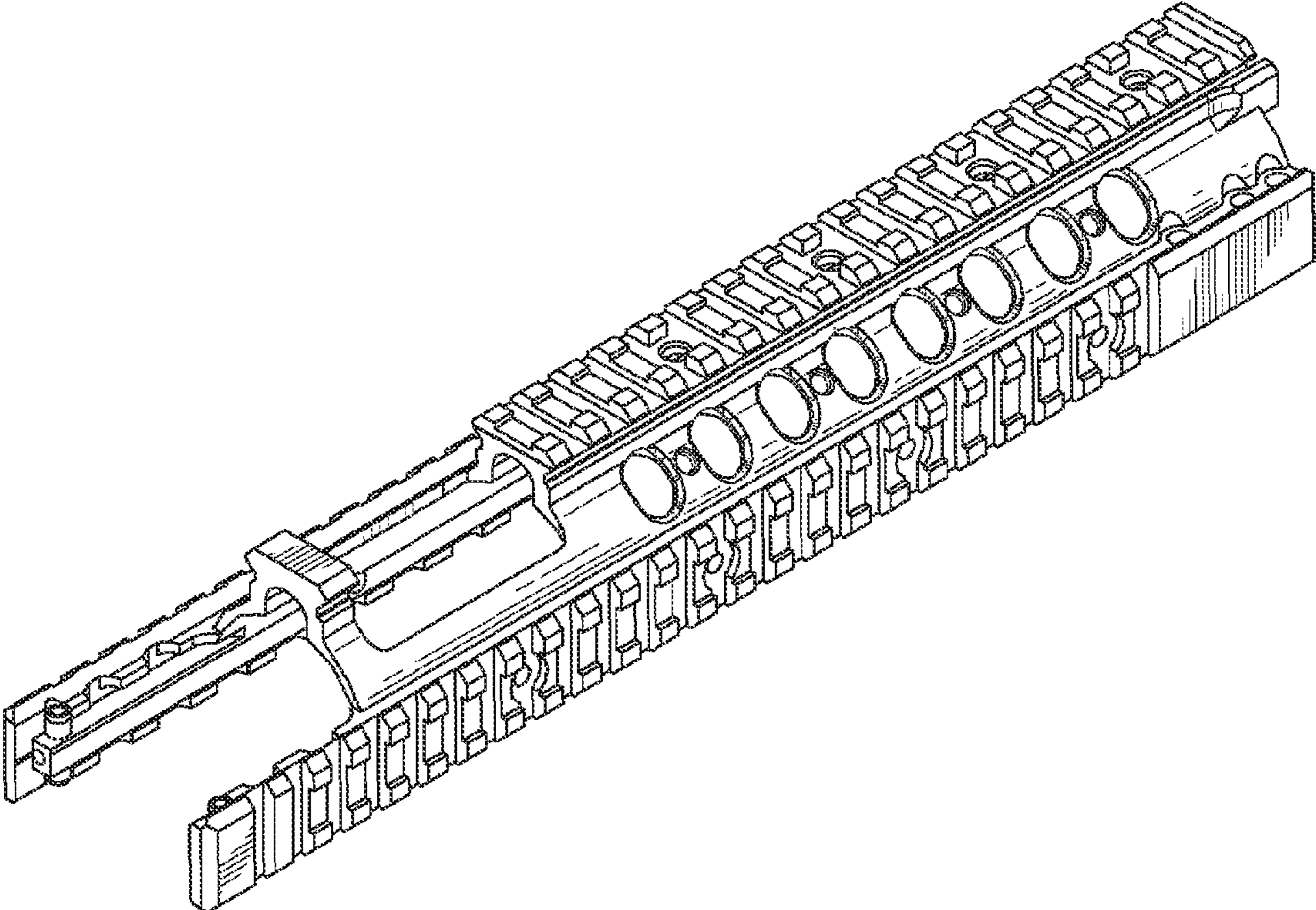

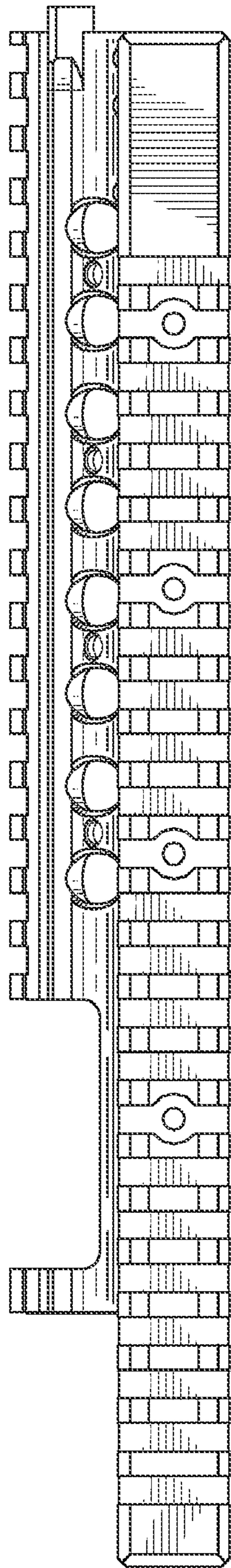

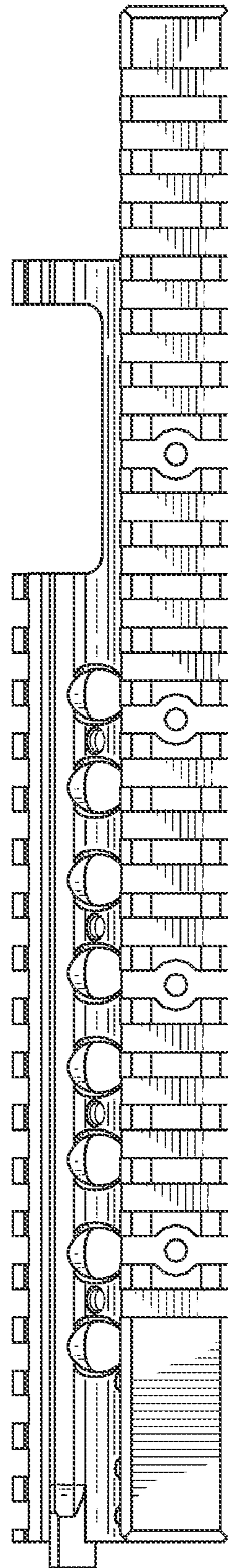

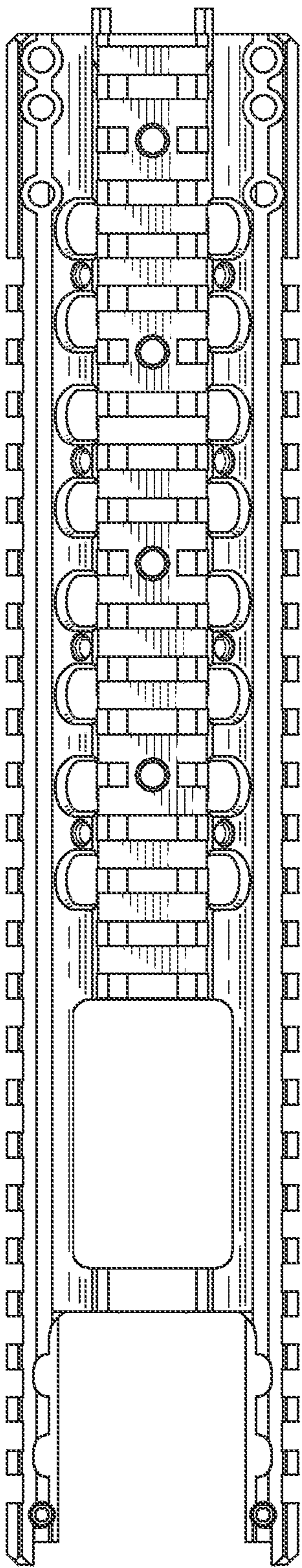

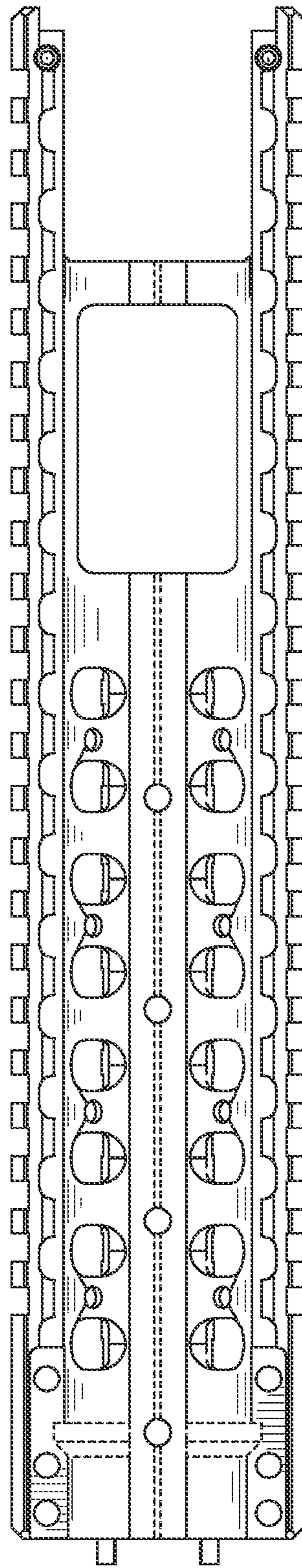
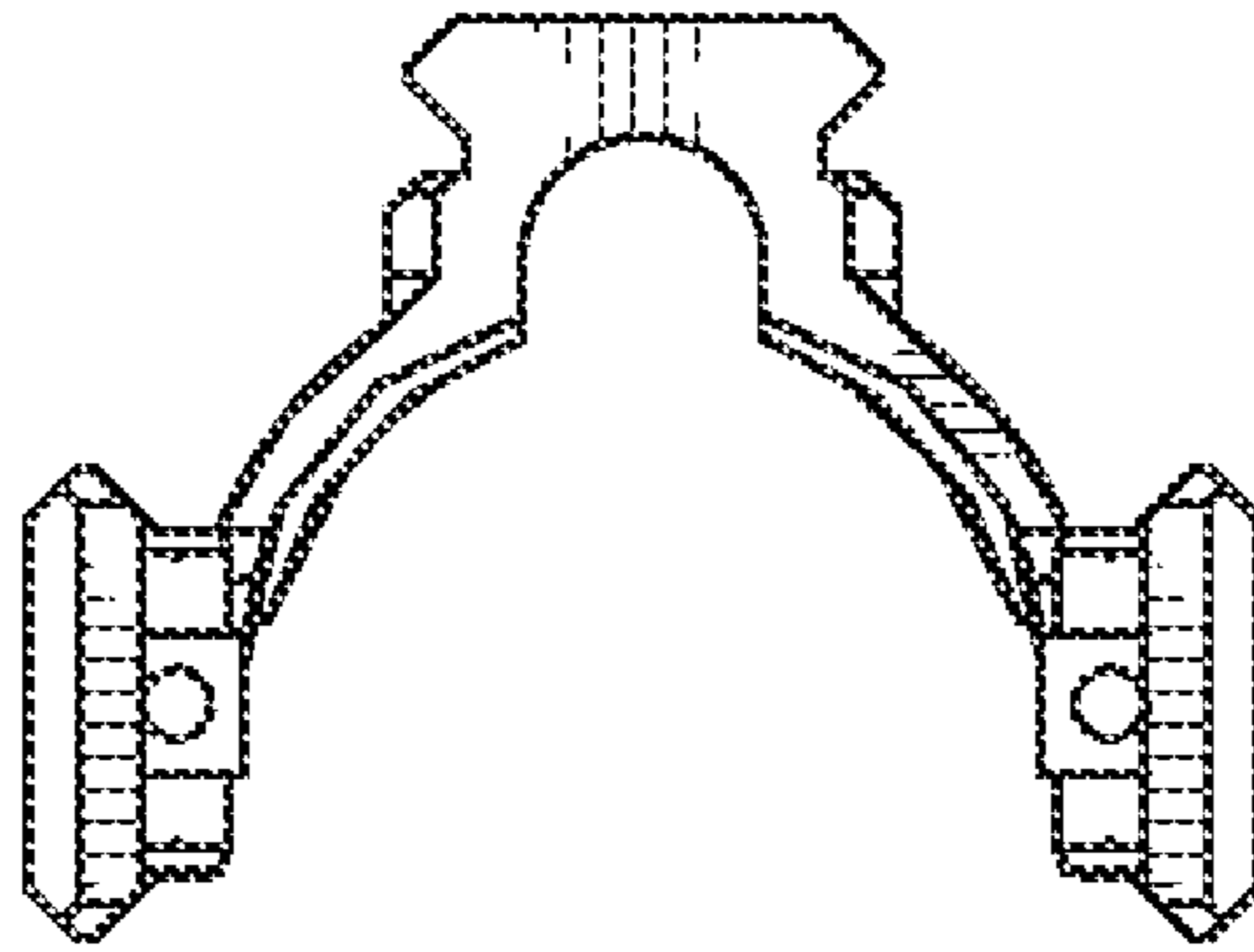
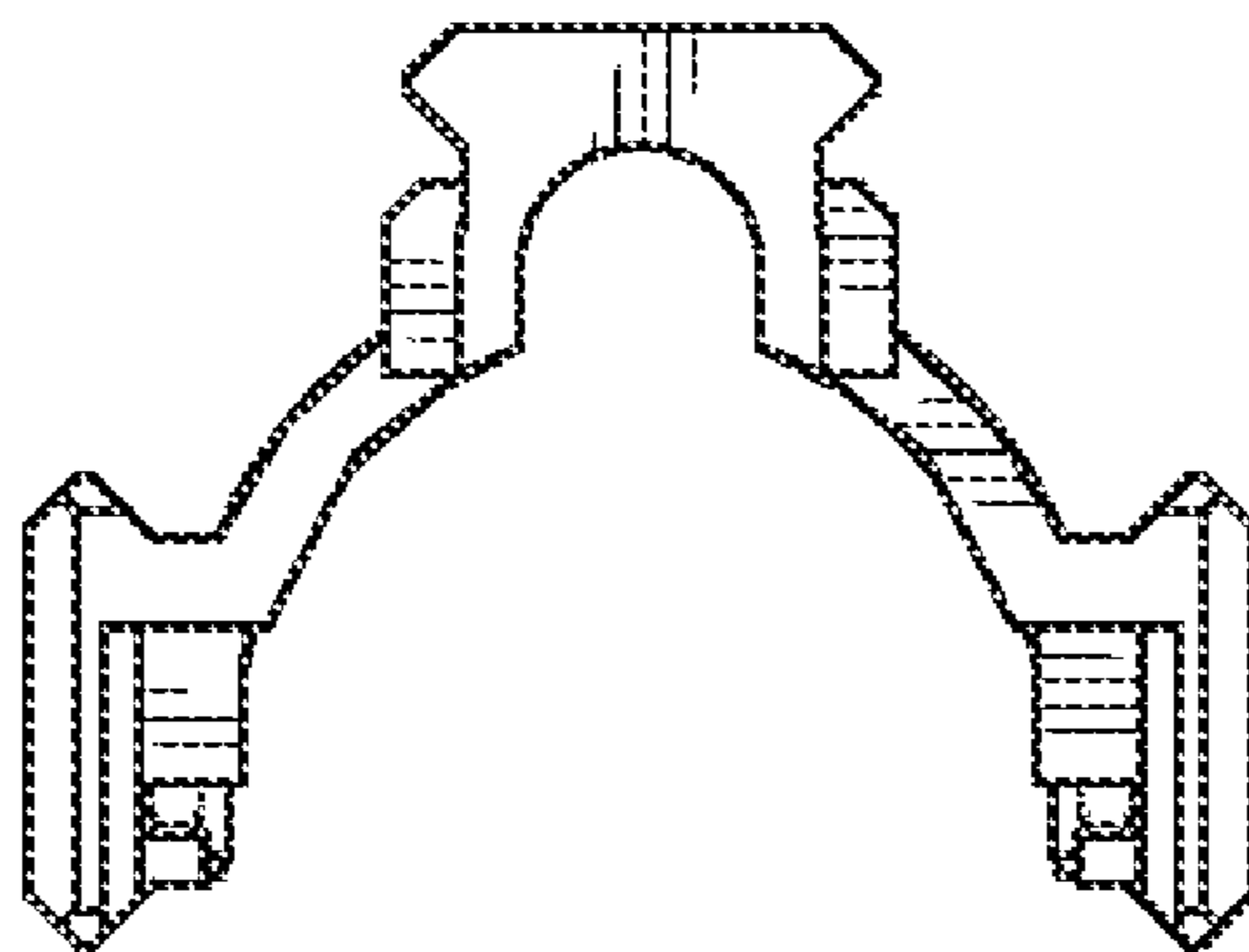
