FIG. 3 is a front view of a second version of a cigarette pack of the present design.

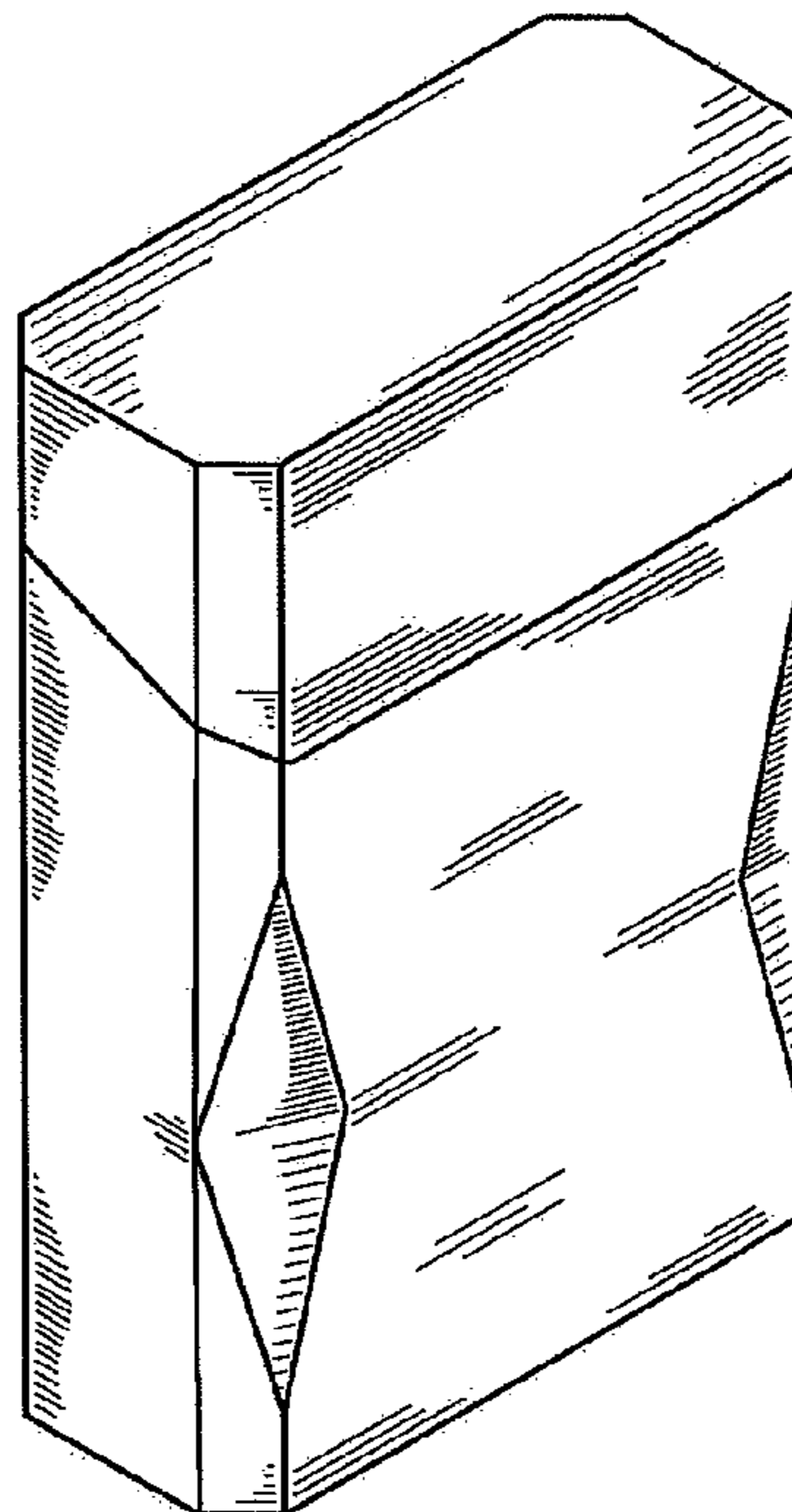
FIG. 4 is a rear view of a second version of a cigarette pack of the present design.

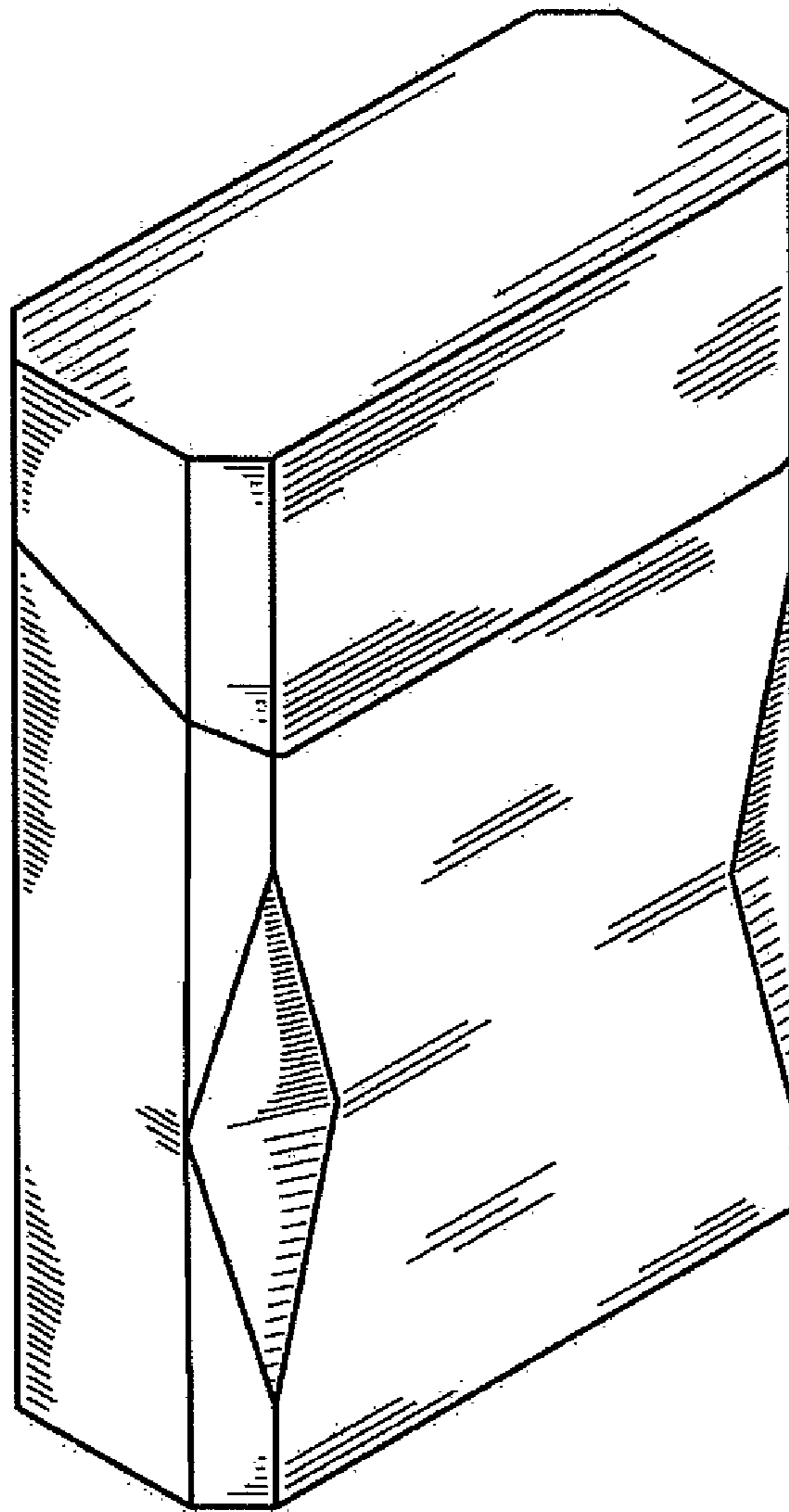

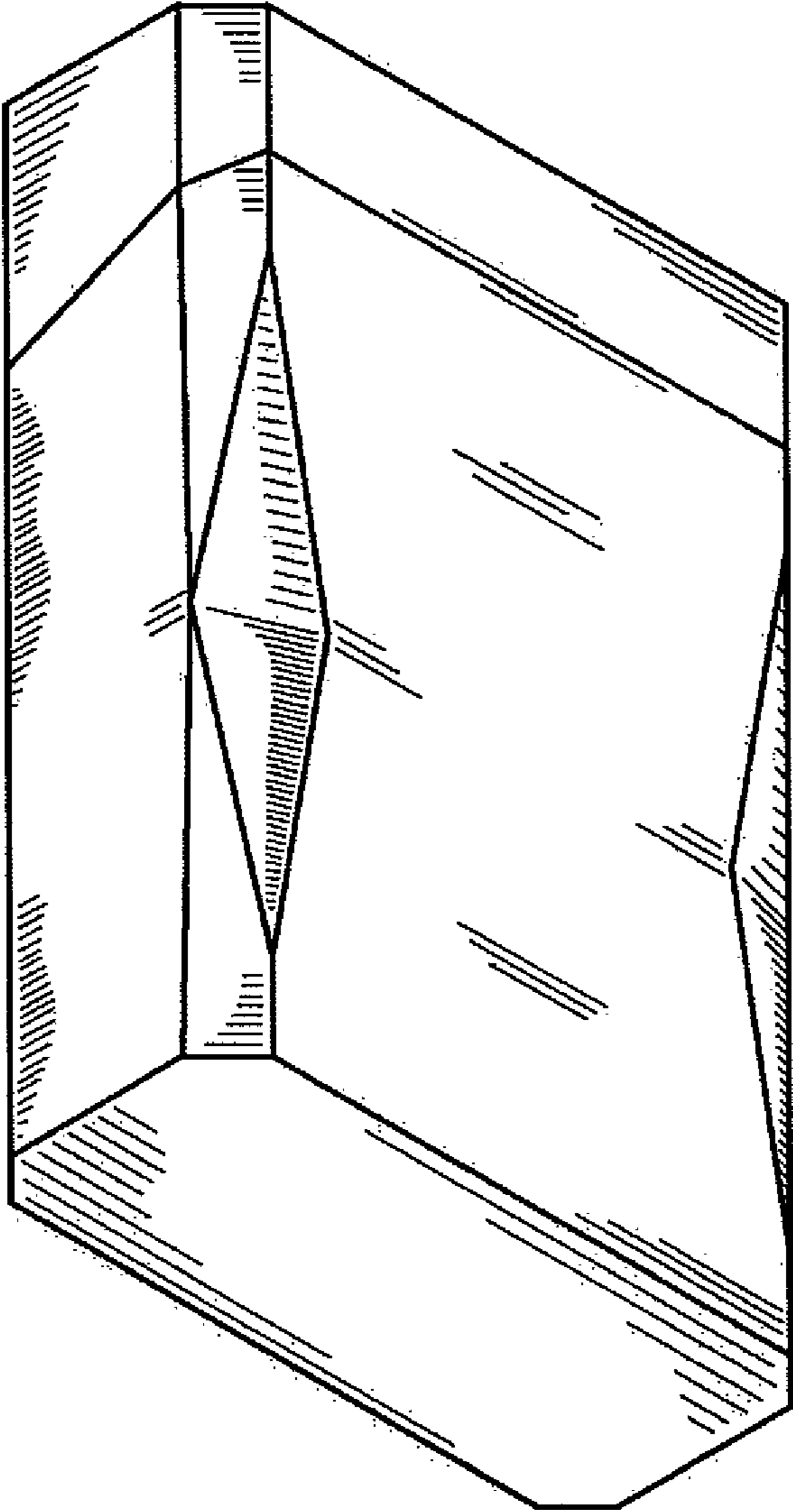

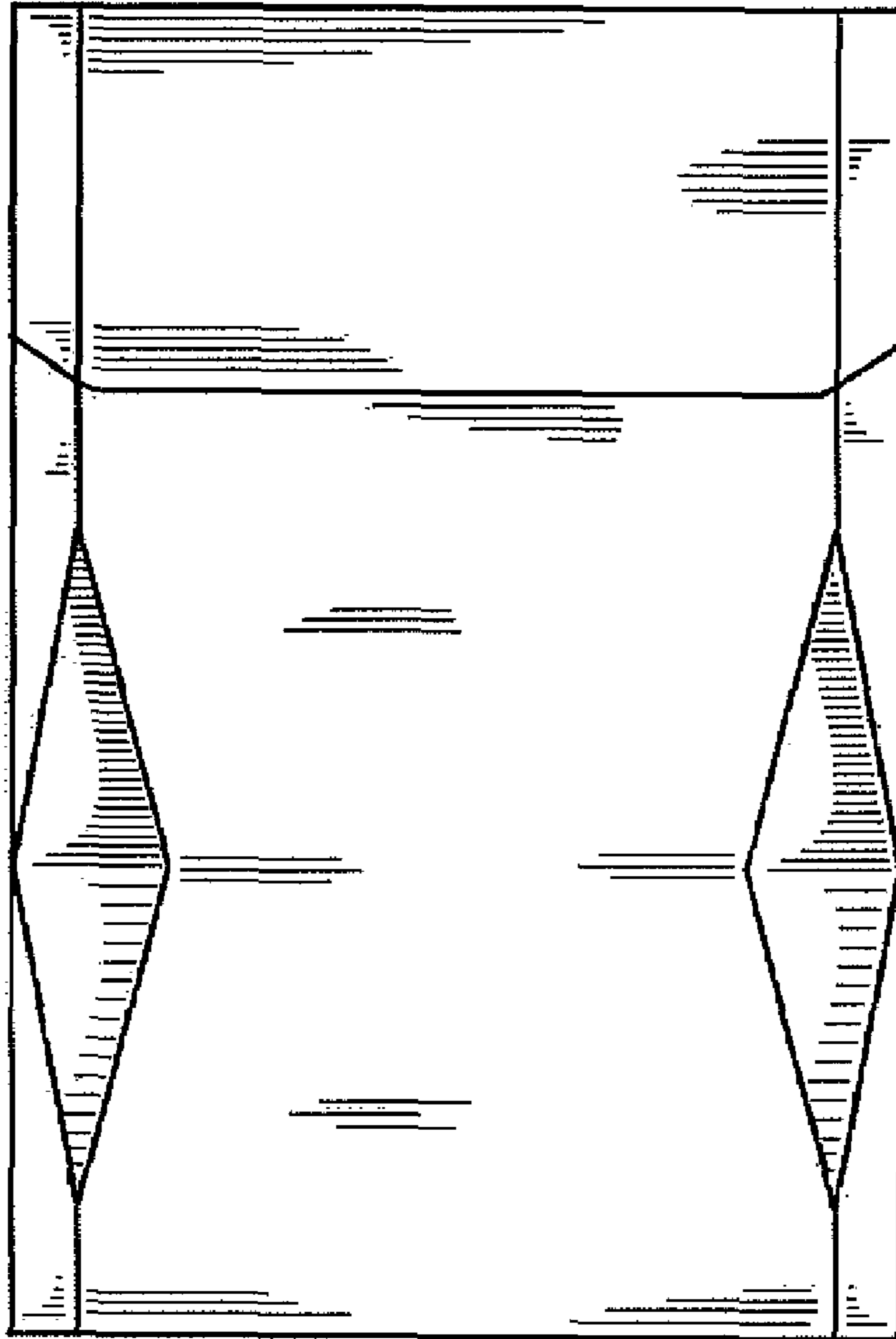

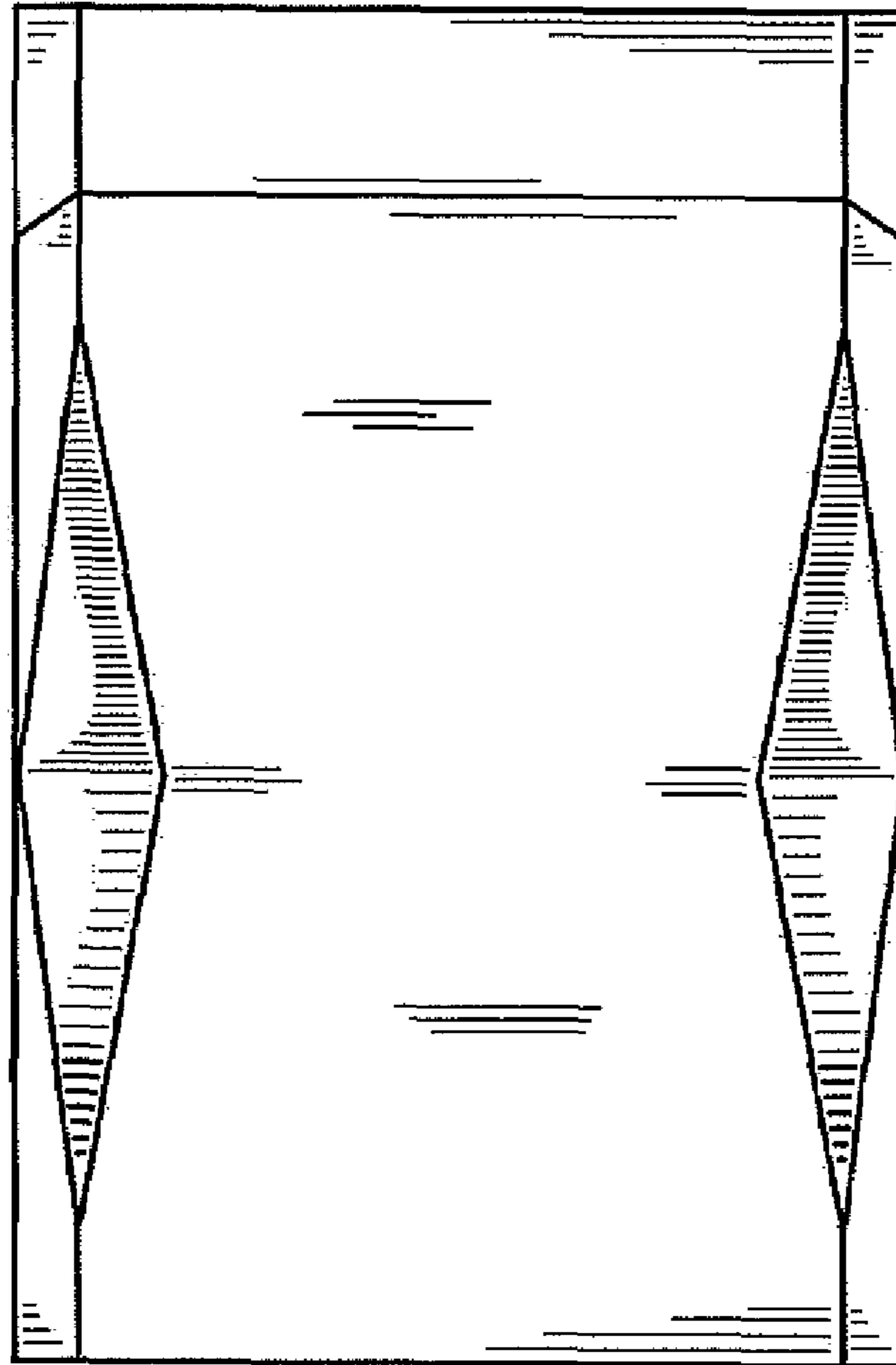

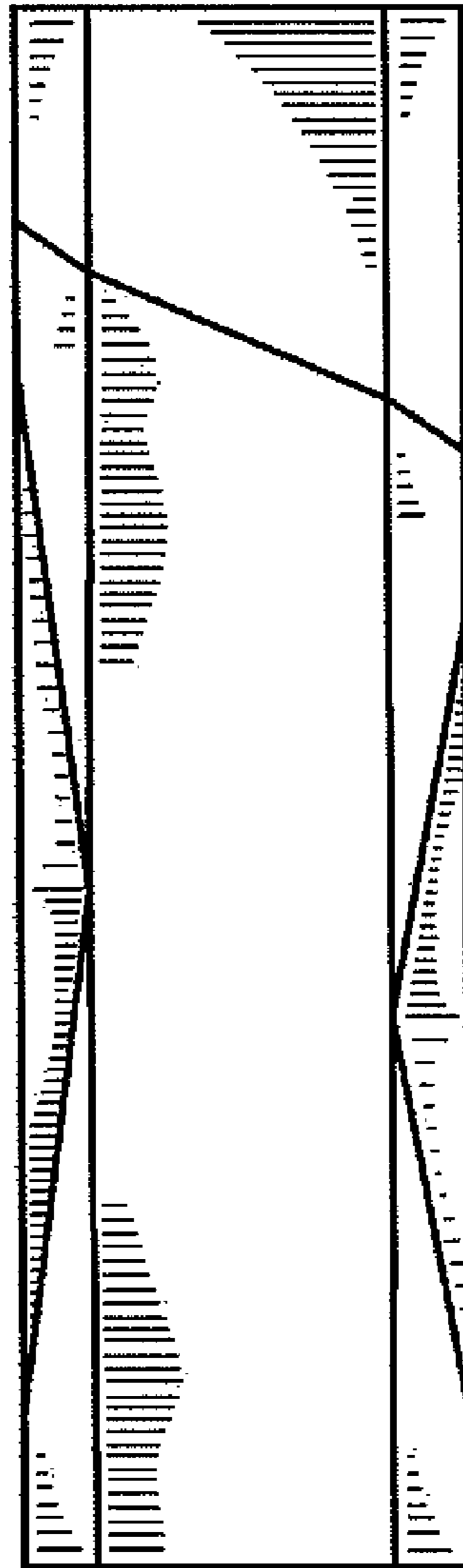

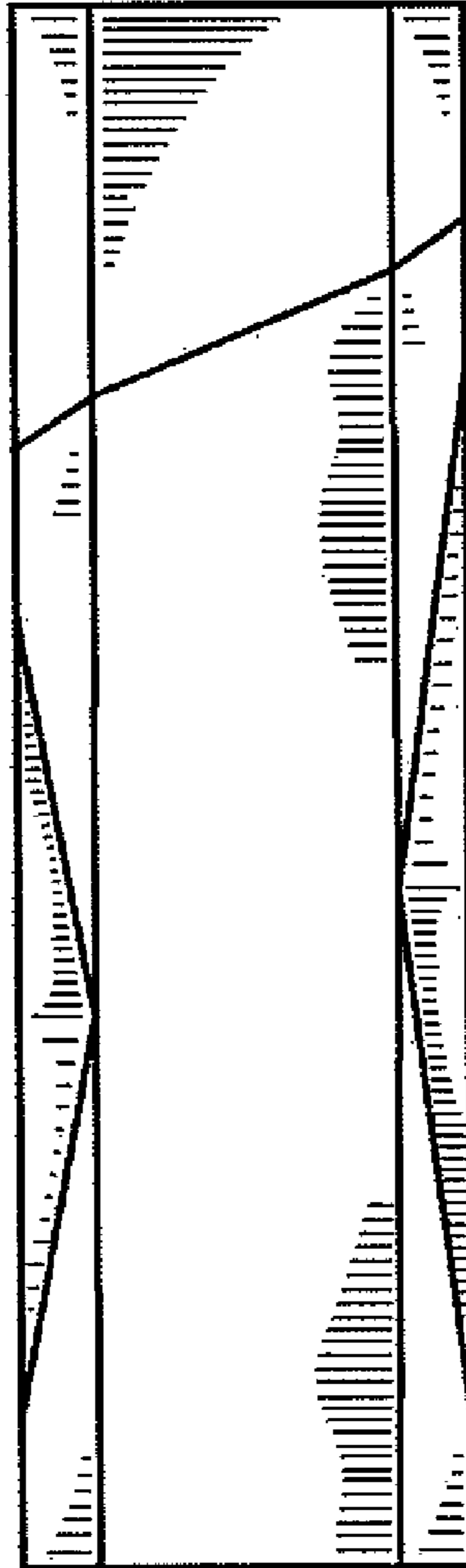

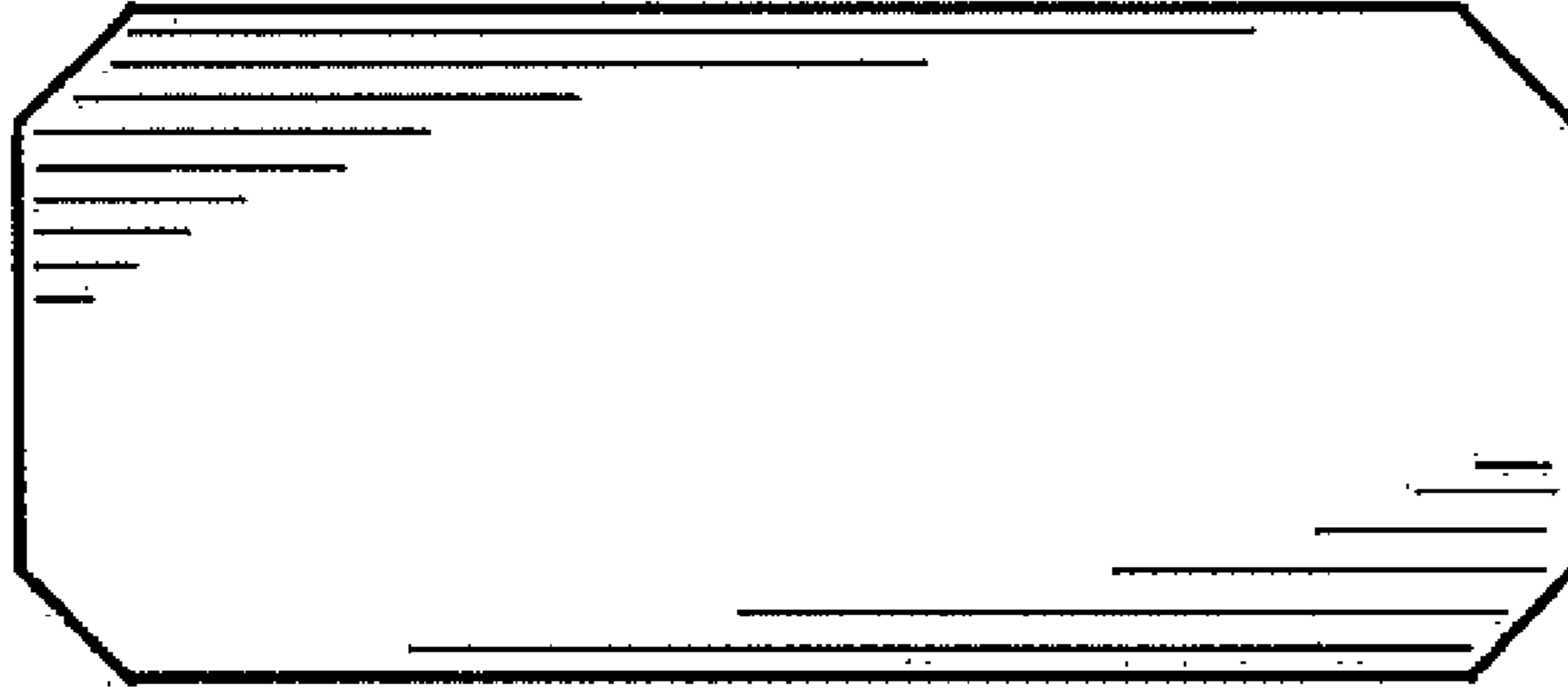
