(57) **CLAIM**

I claim the ornamental design for footwear, as shown and described.

**DESCRIPTION**

FIG. 1 Is a perspective view of an article of footwear, showing my new design; and,

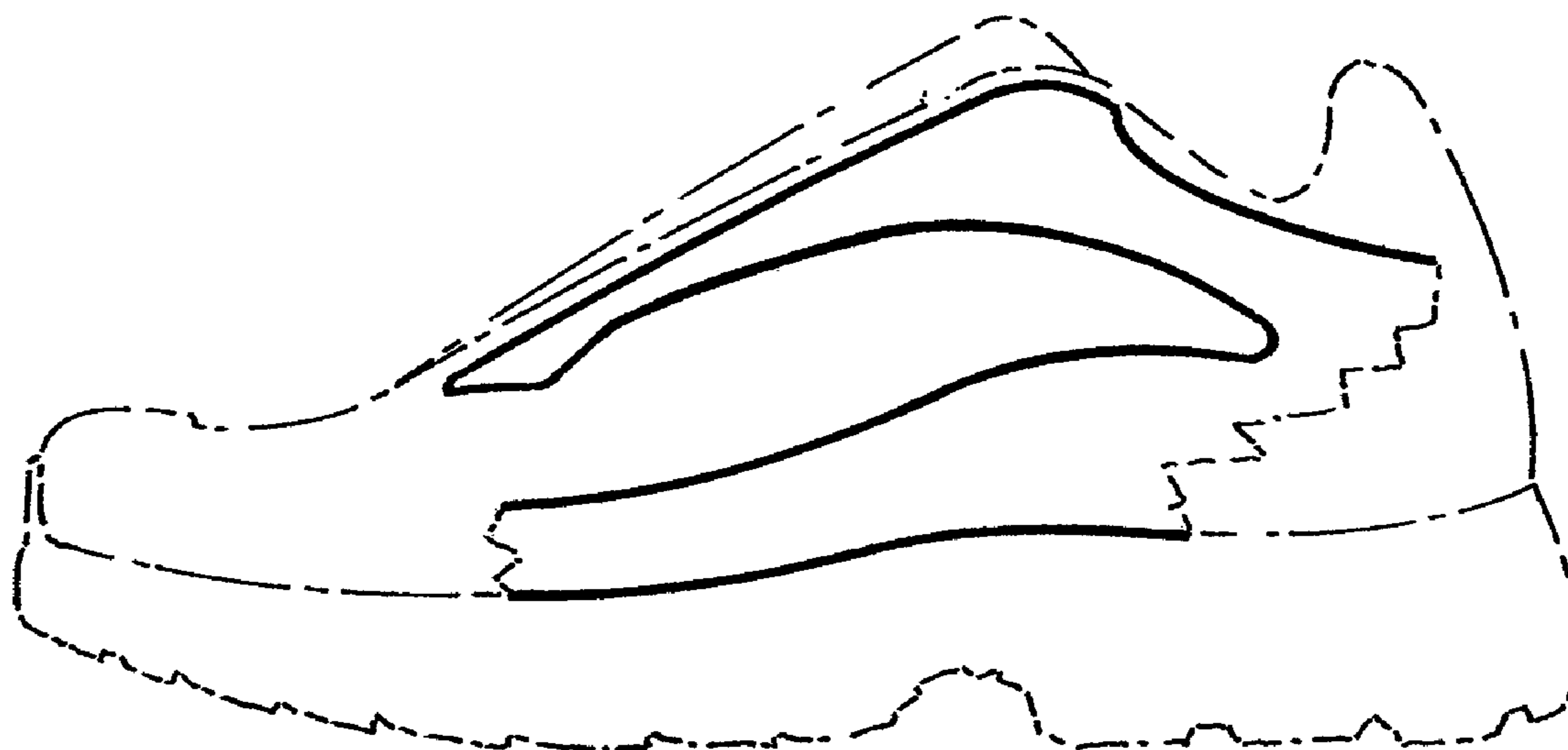

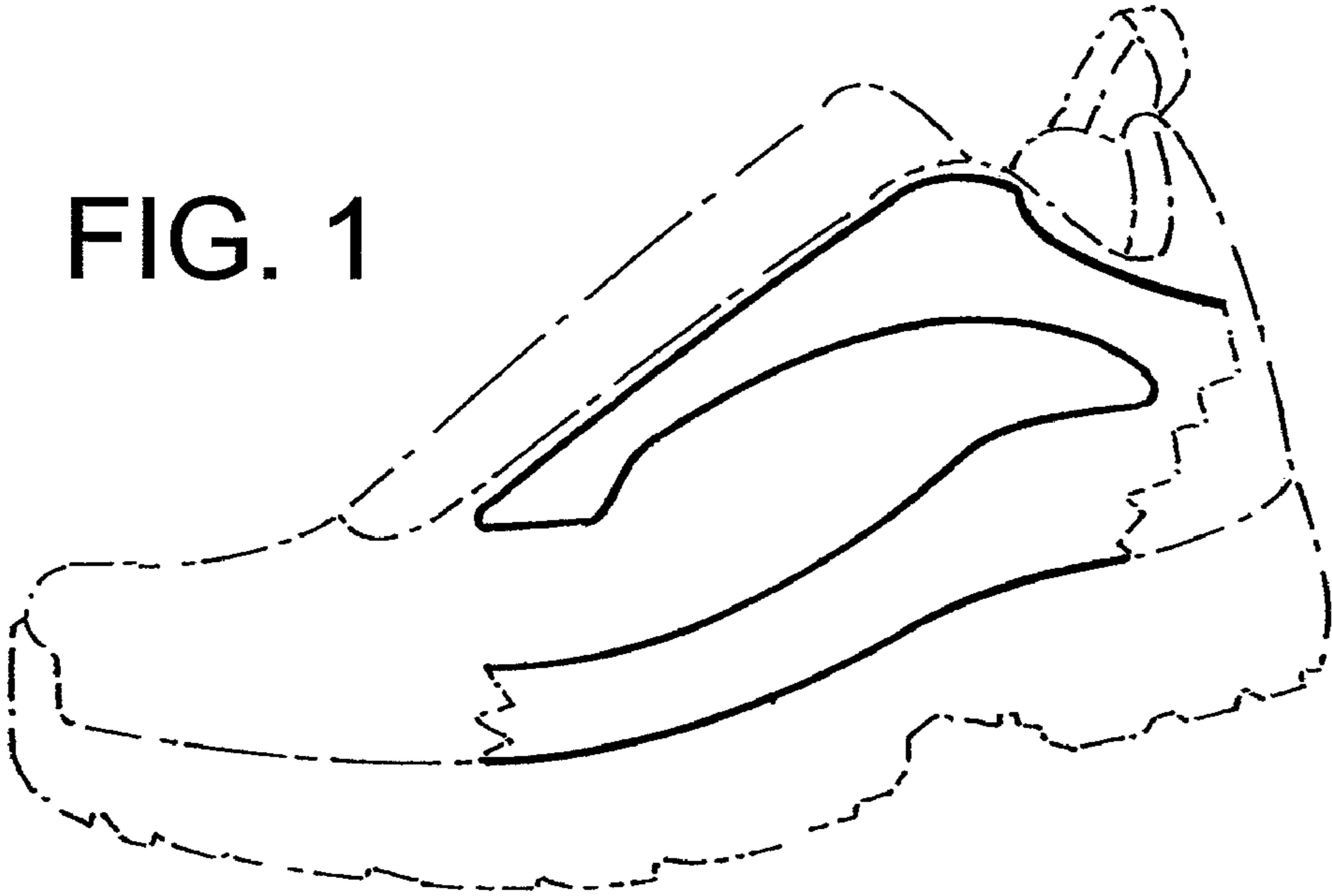
