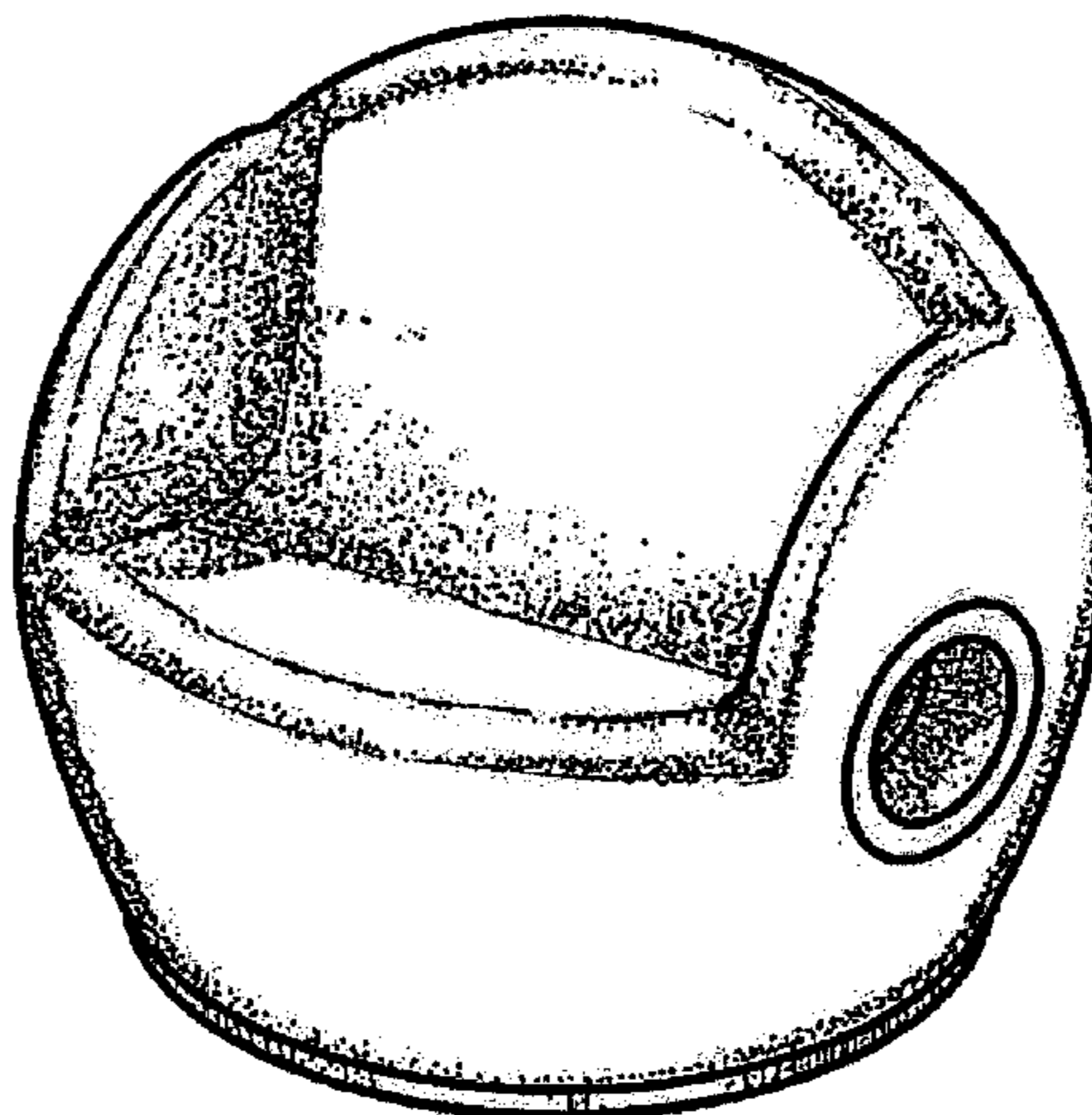
(57) **CLAIM**

able seating array, as shown and described.

**DESCRIPTION**

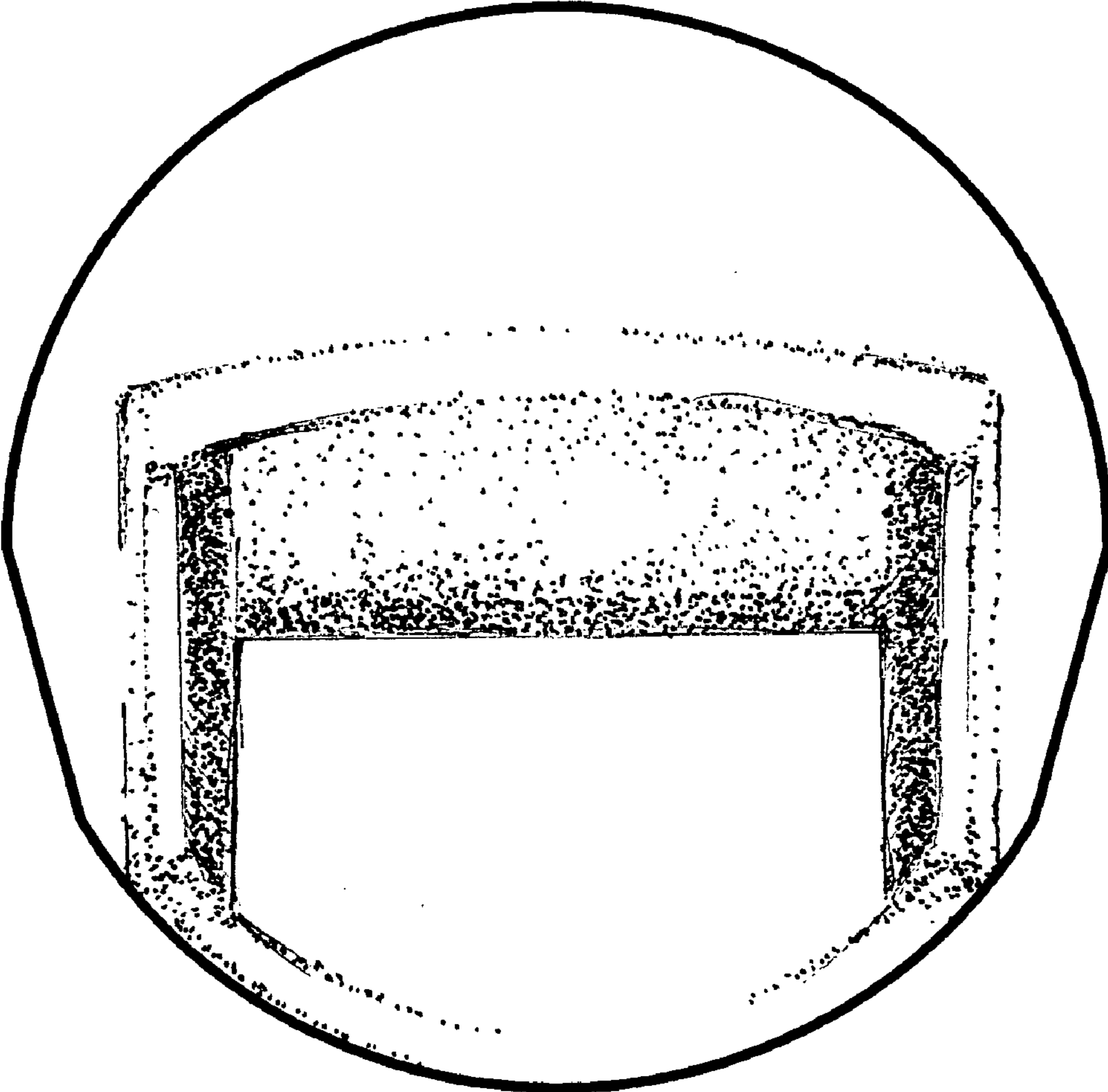

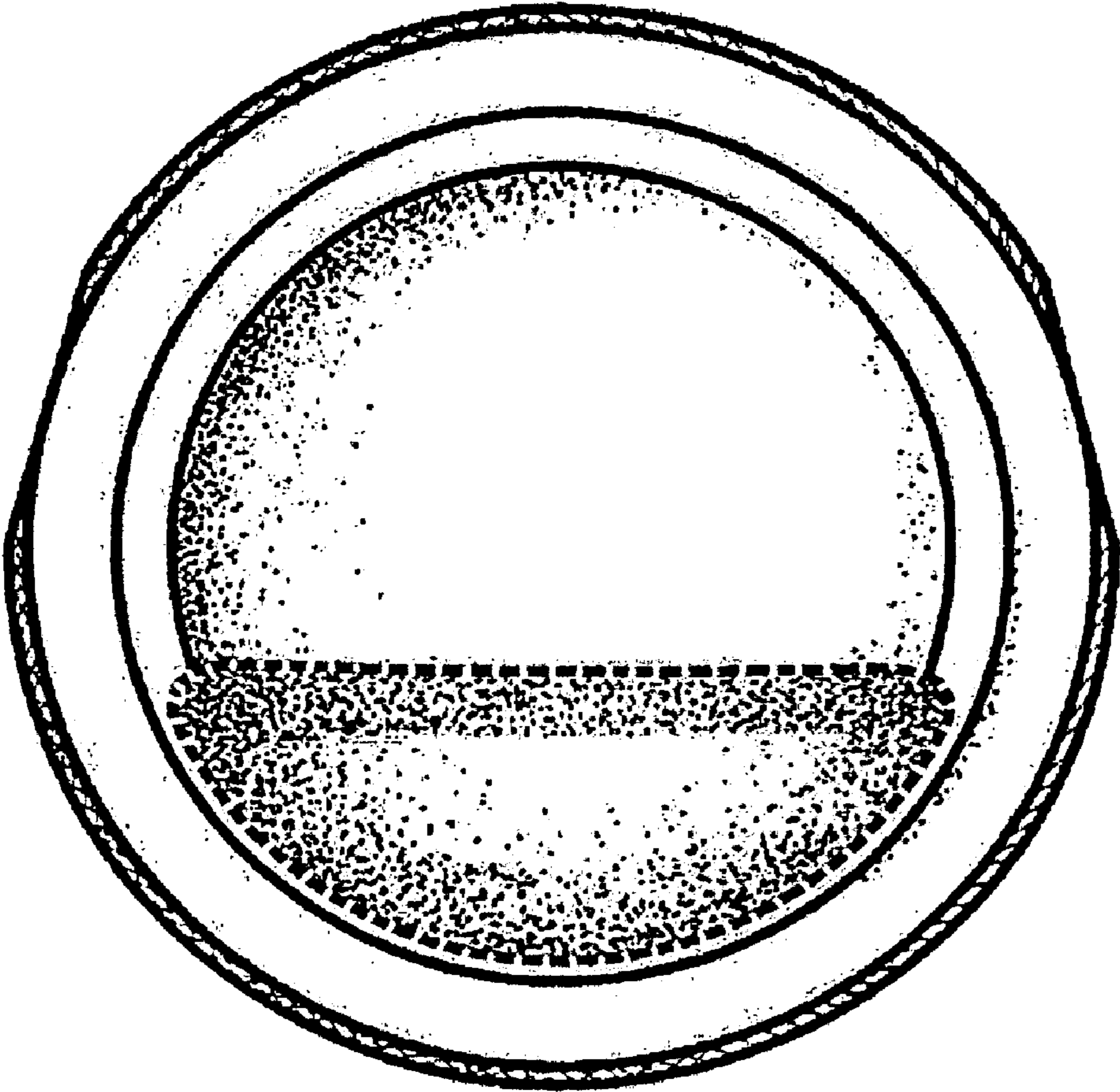

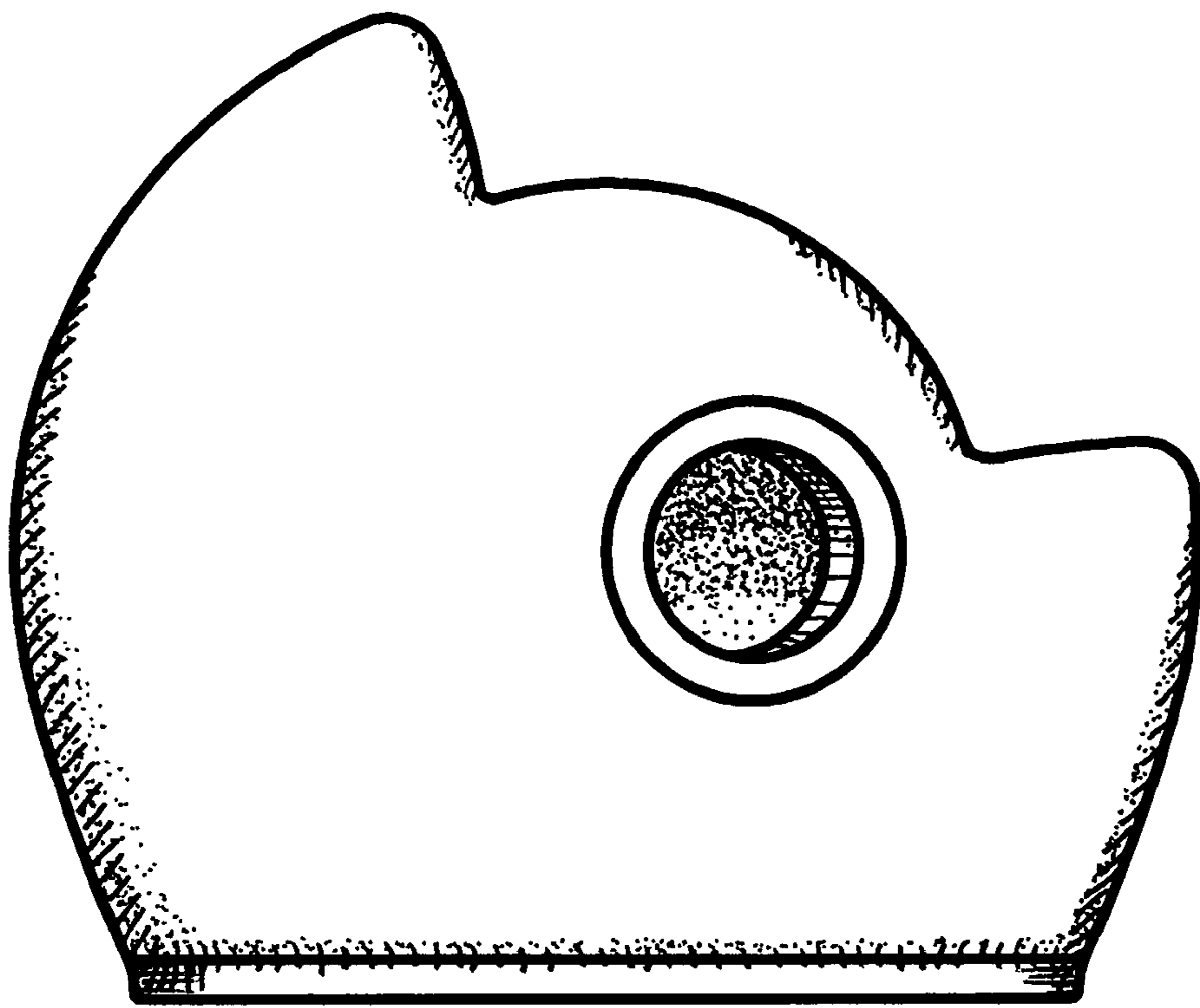

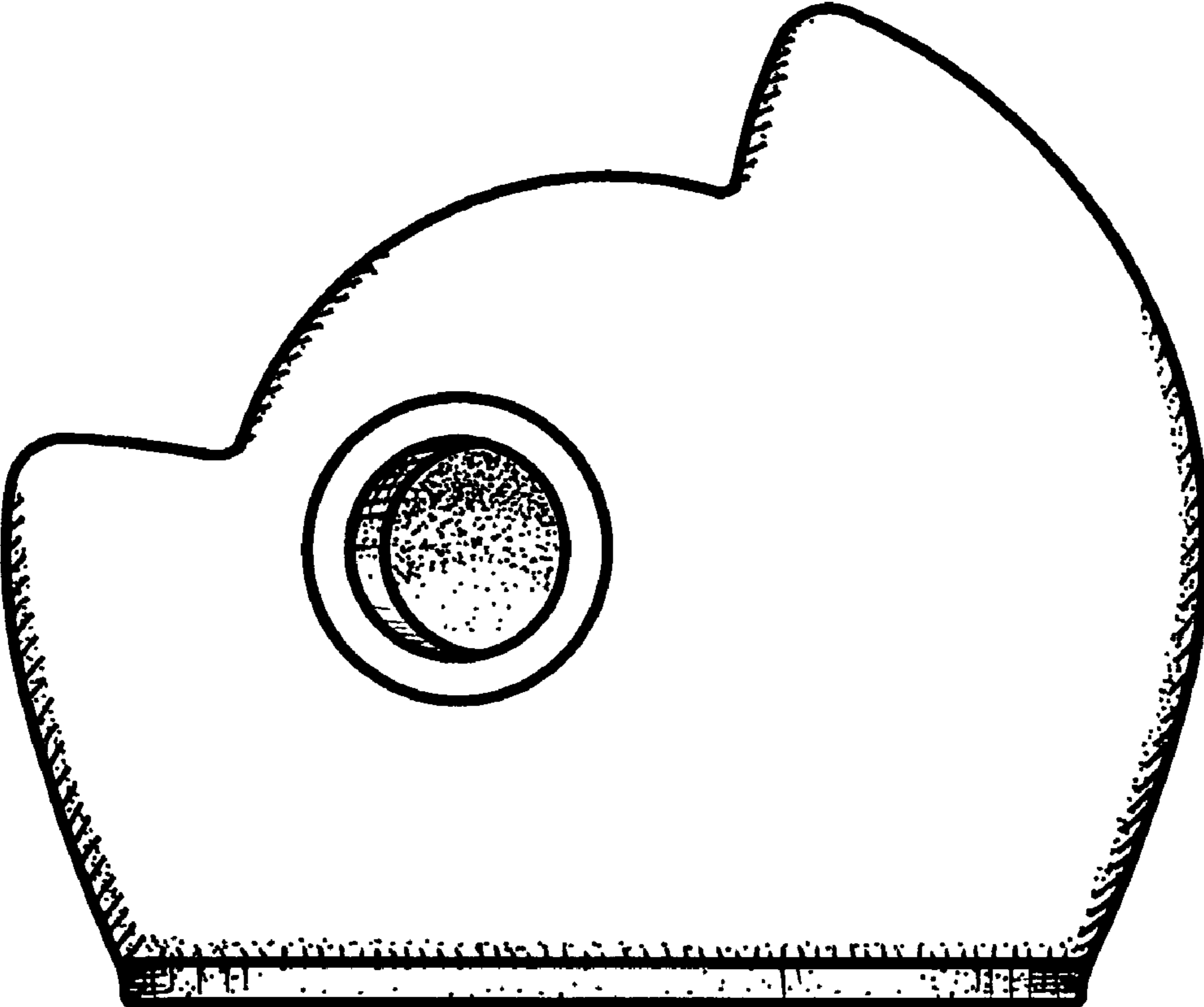

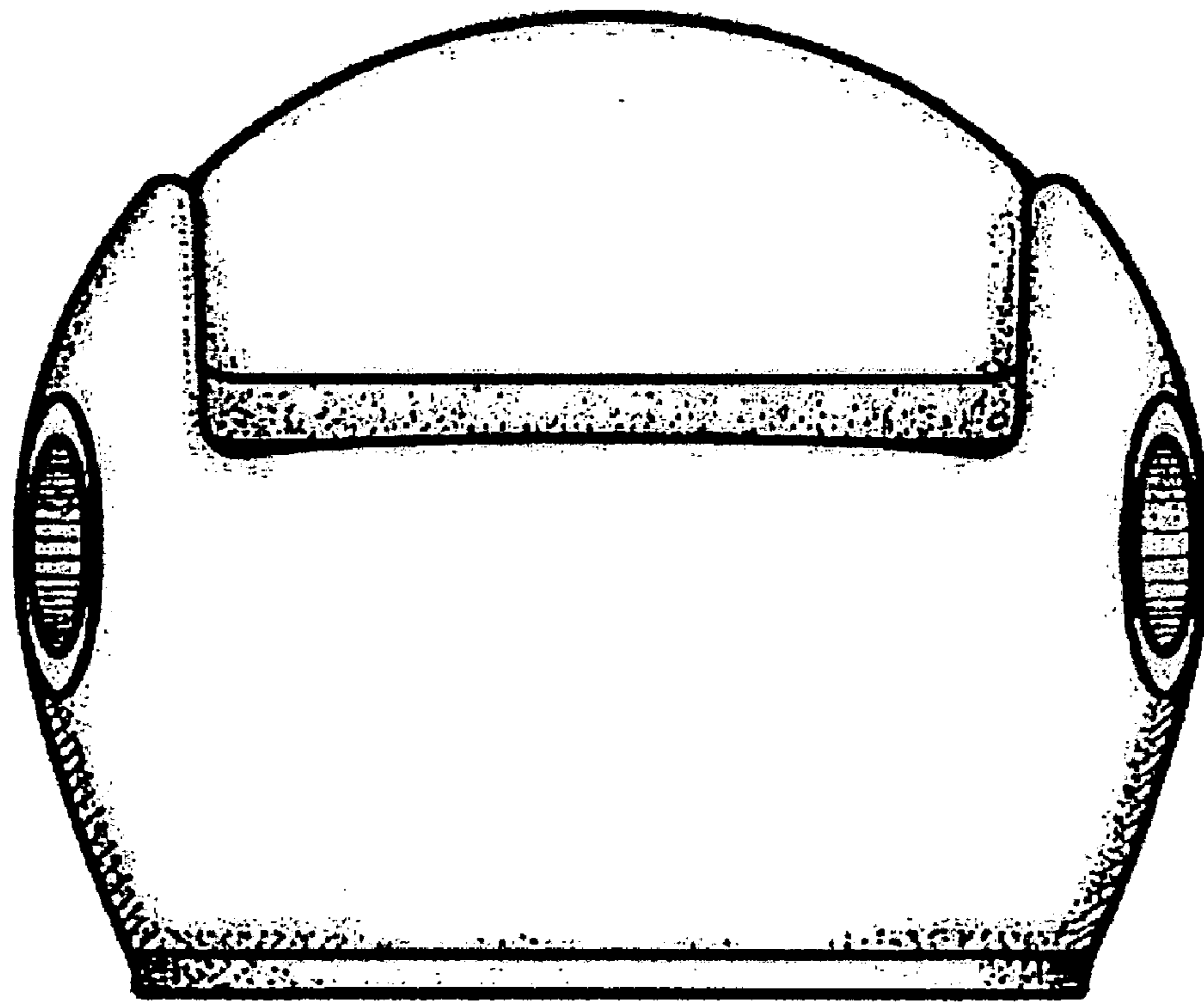

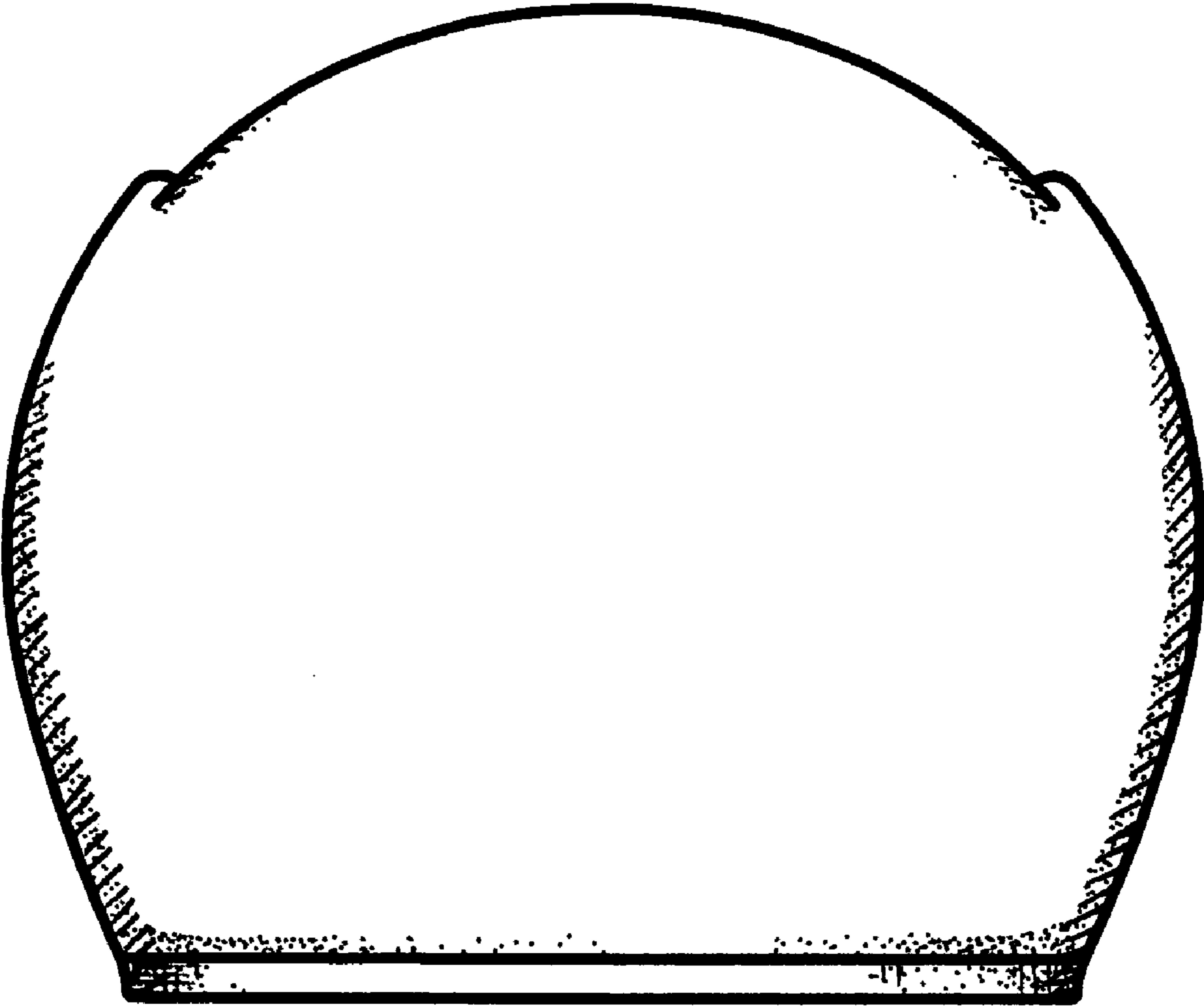

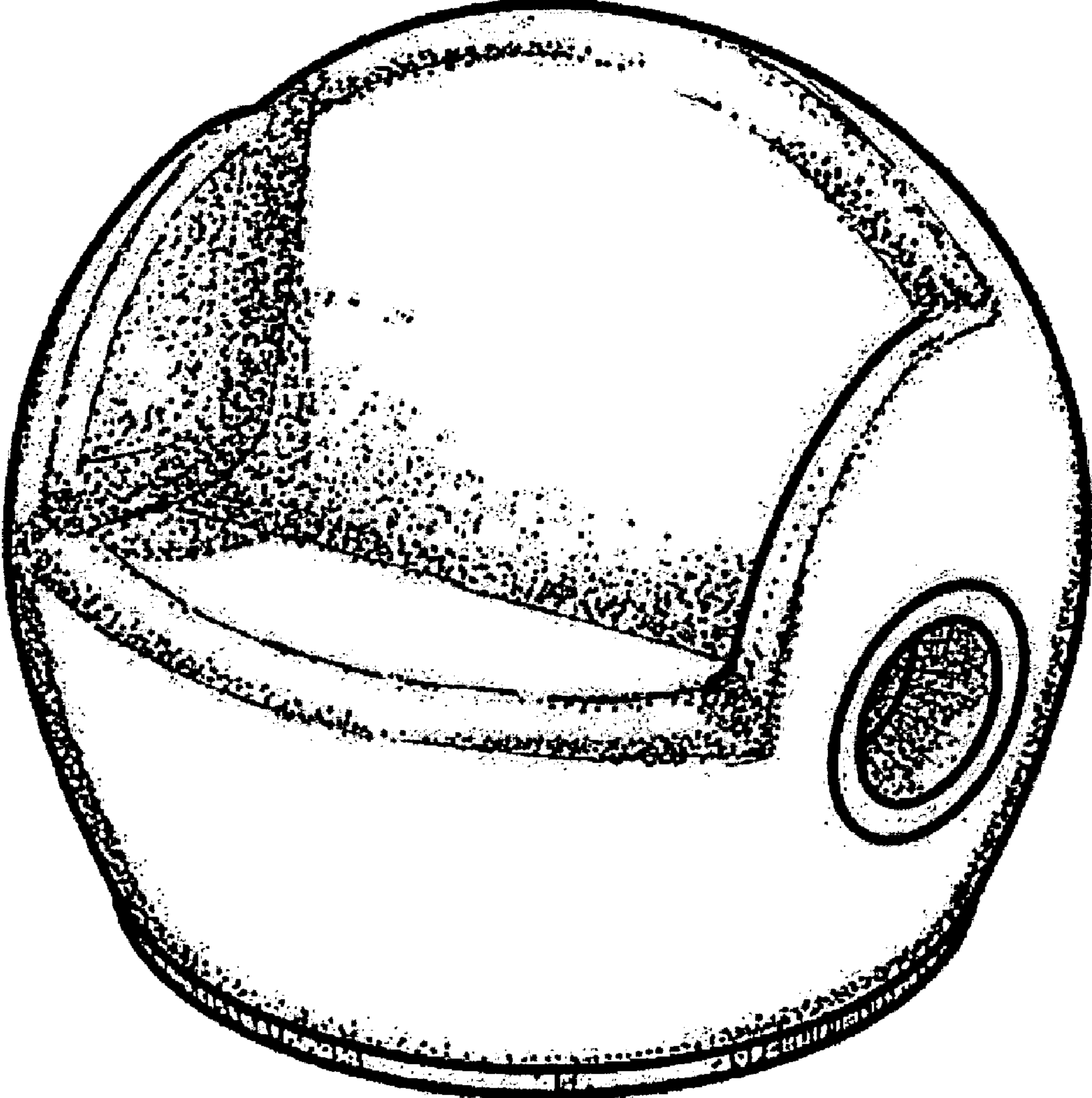

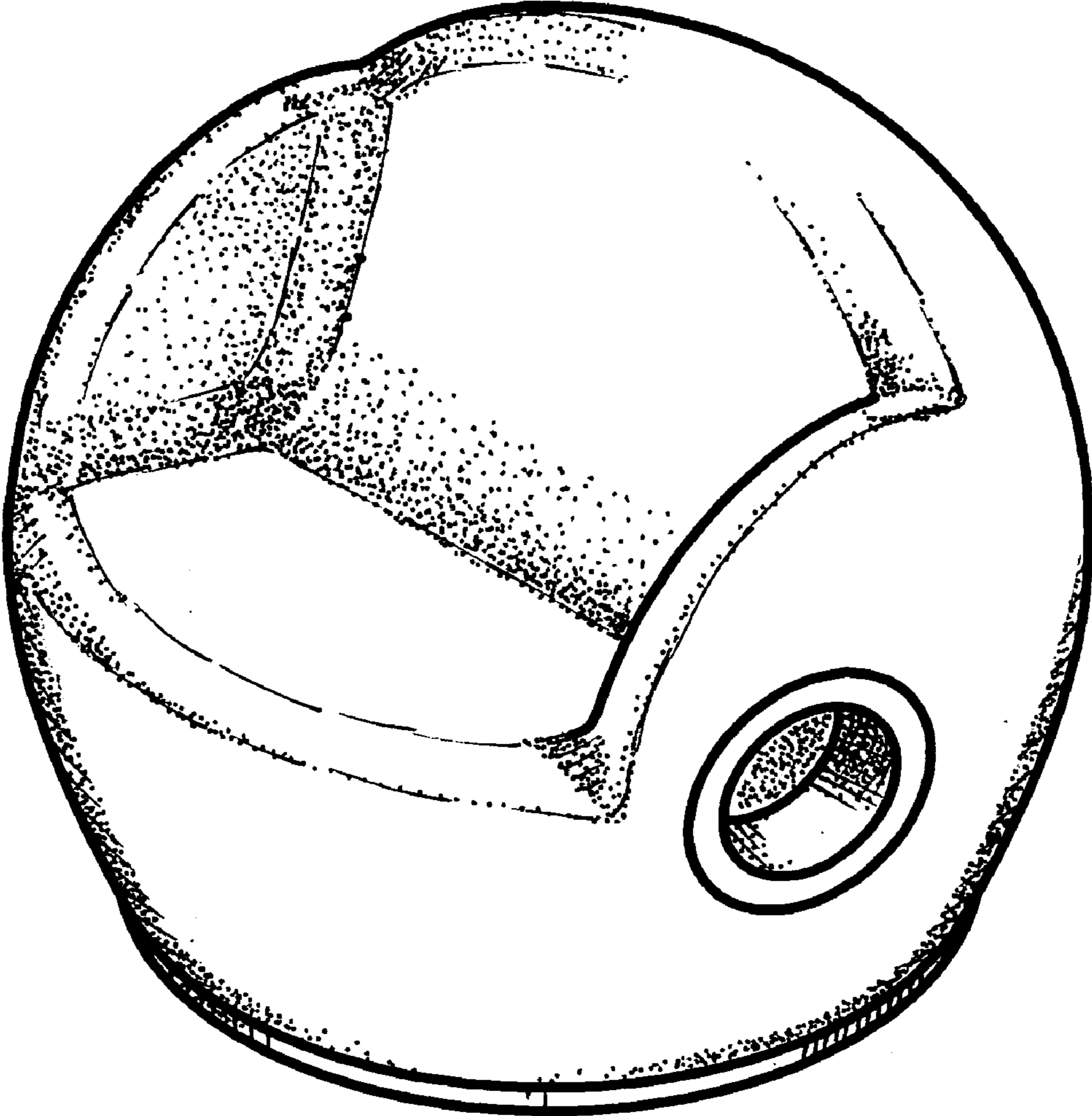

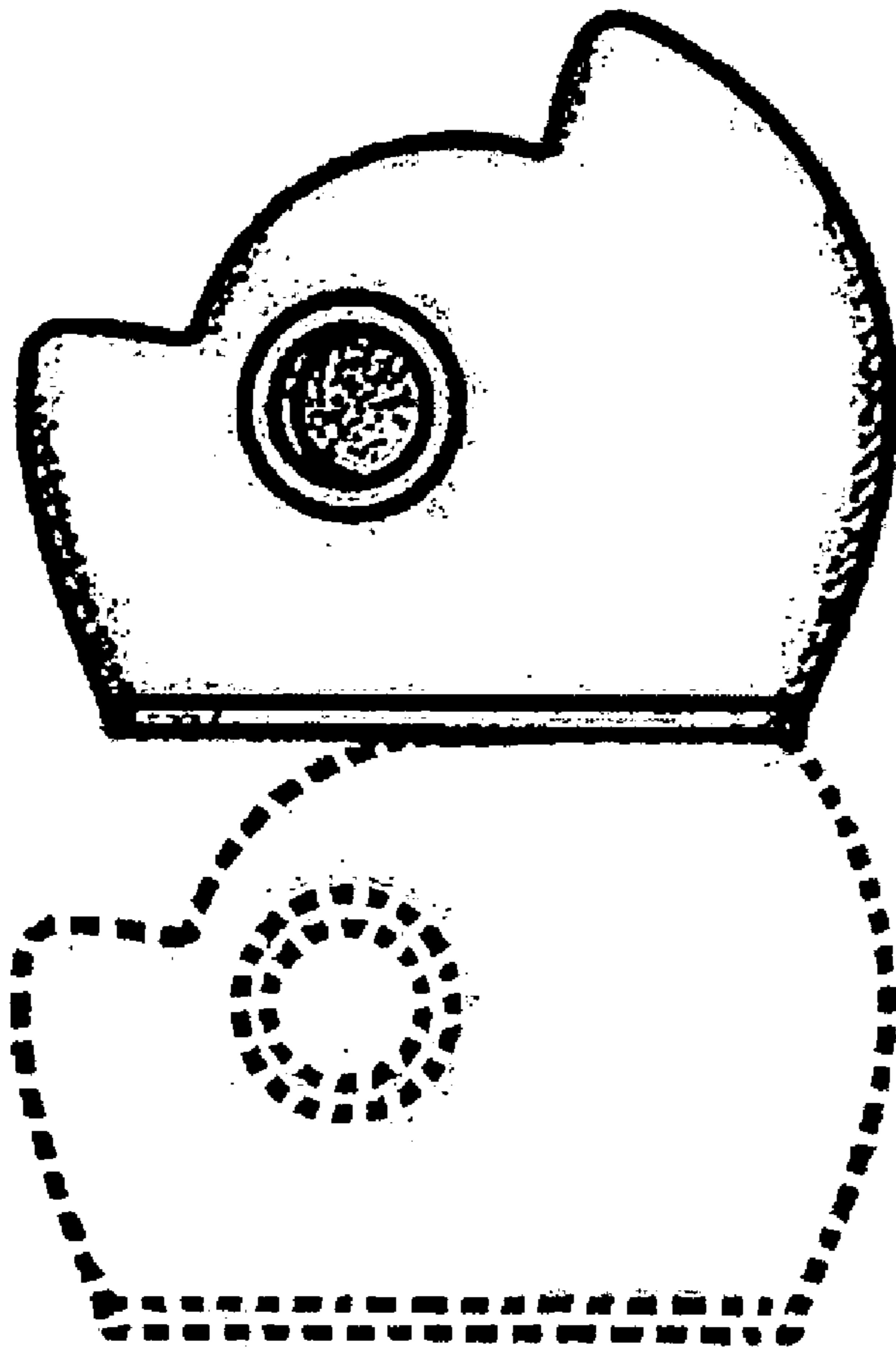

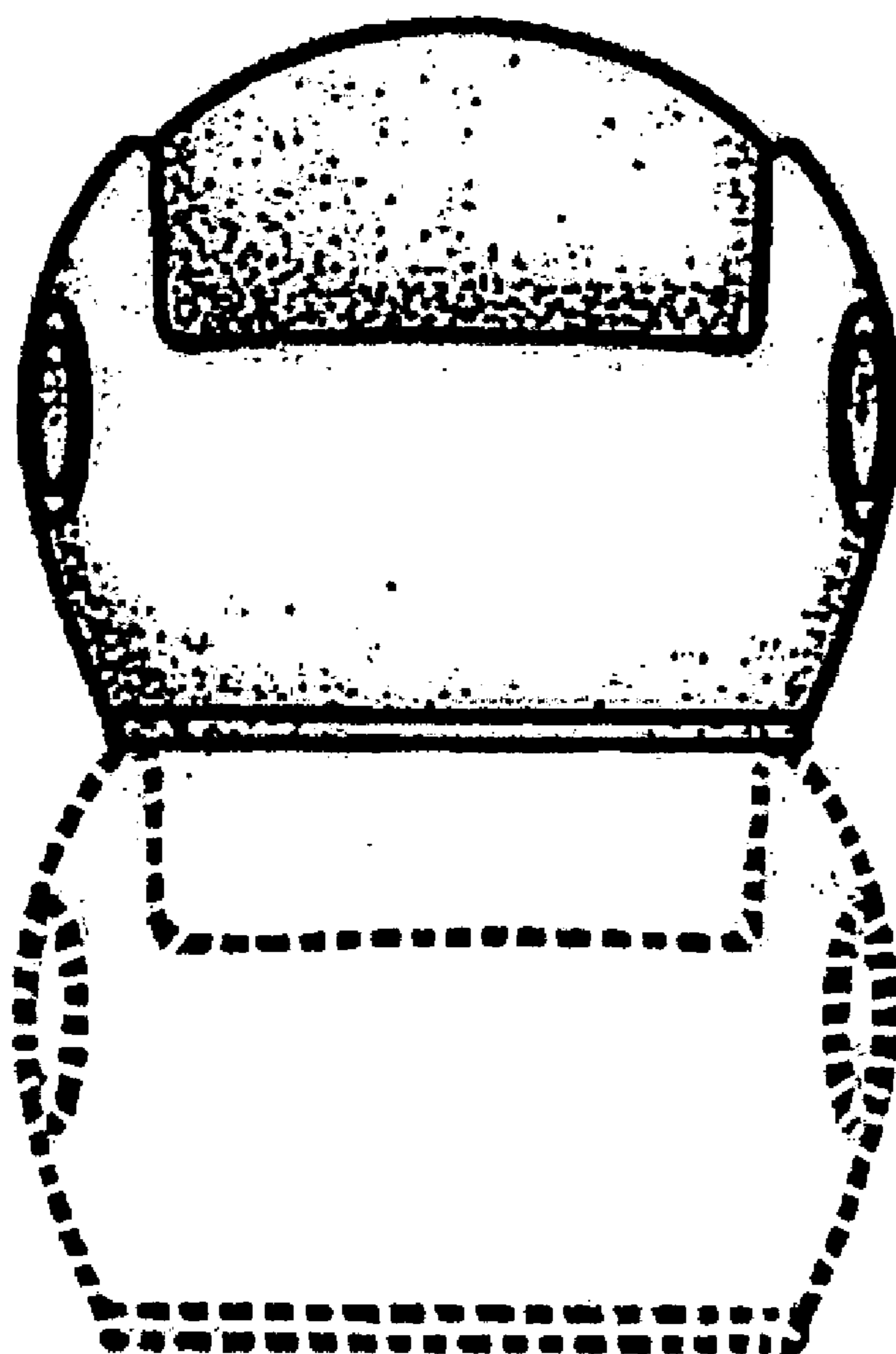

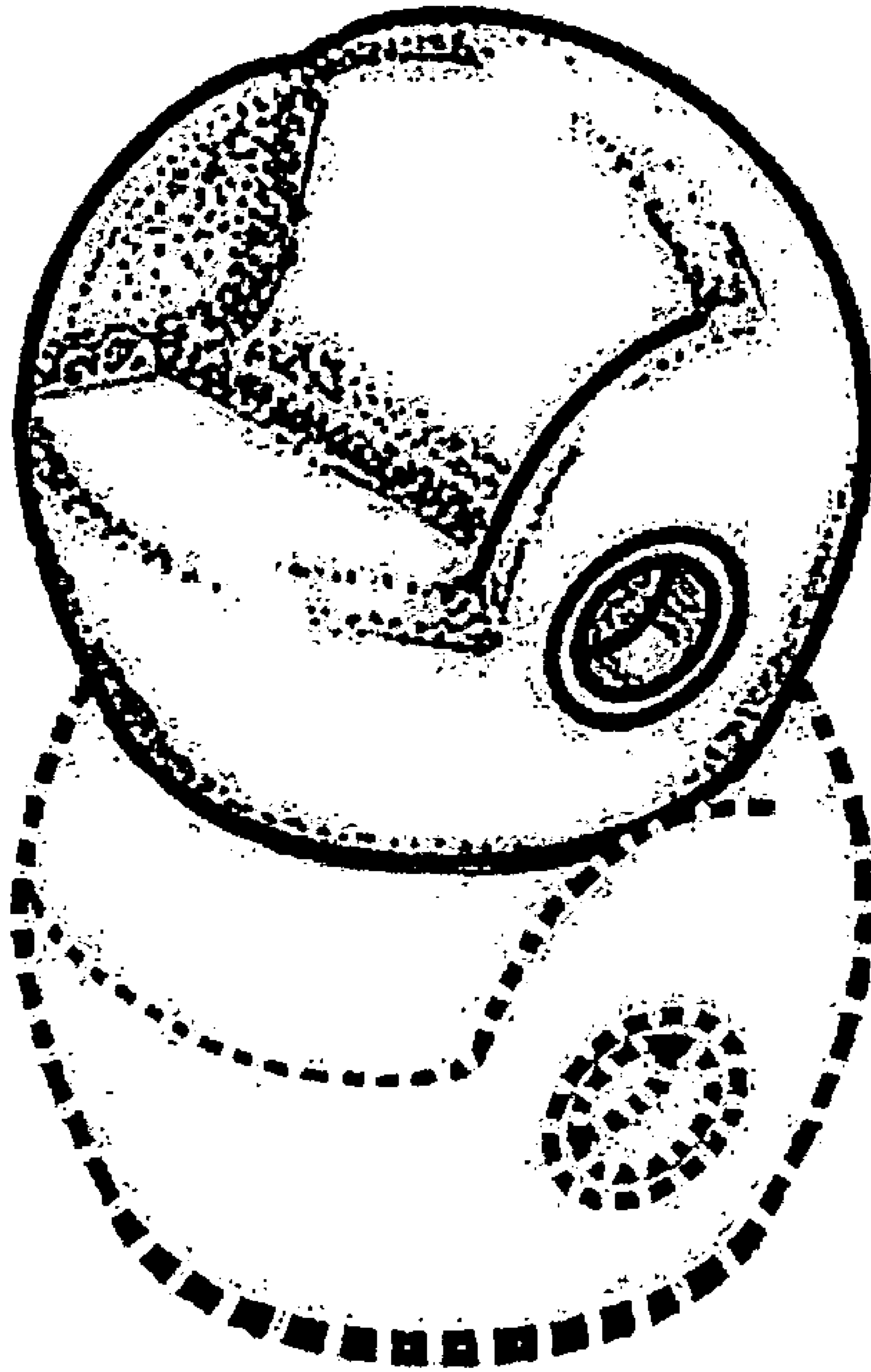

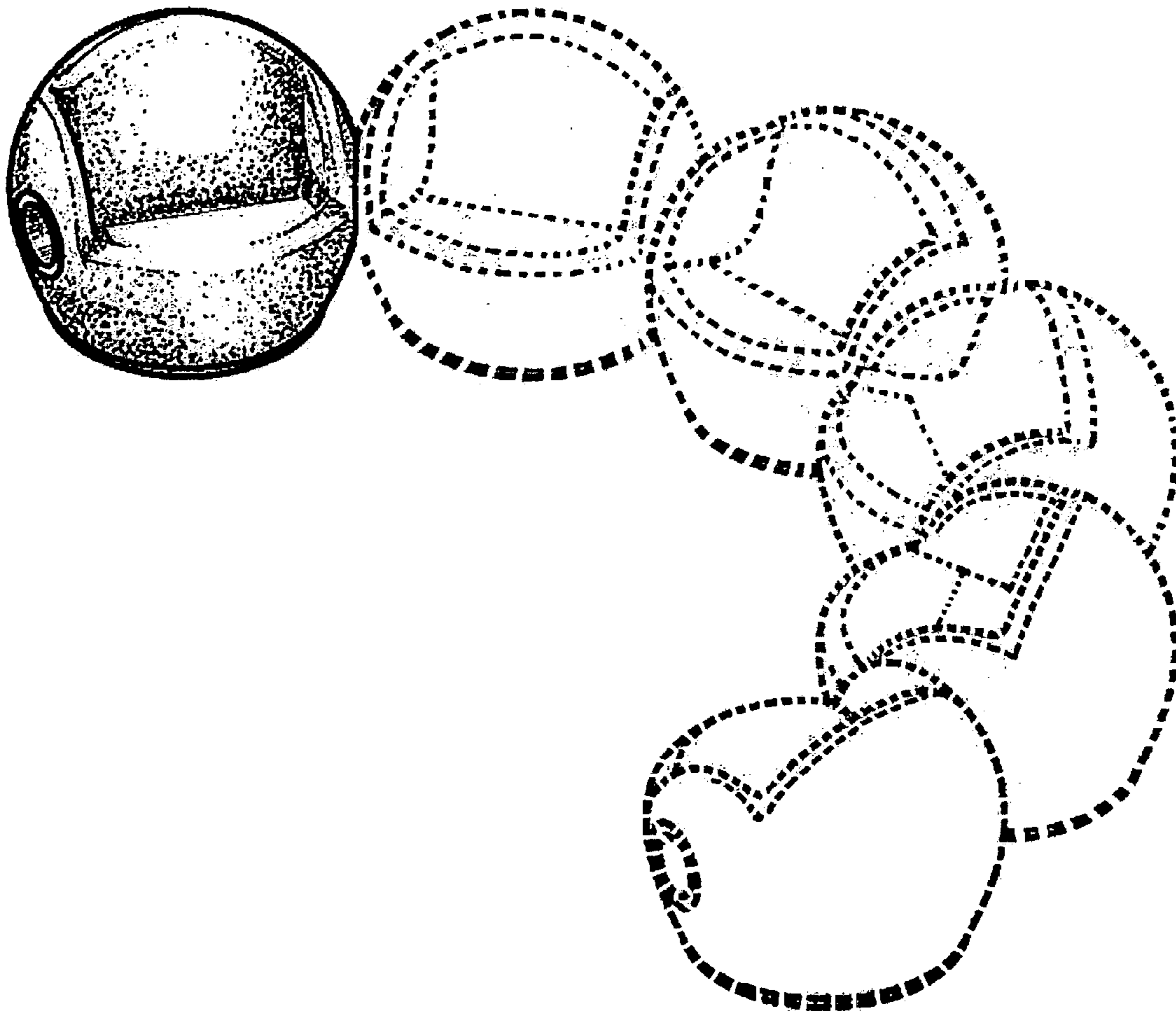

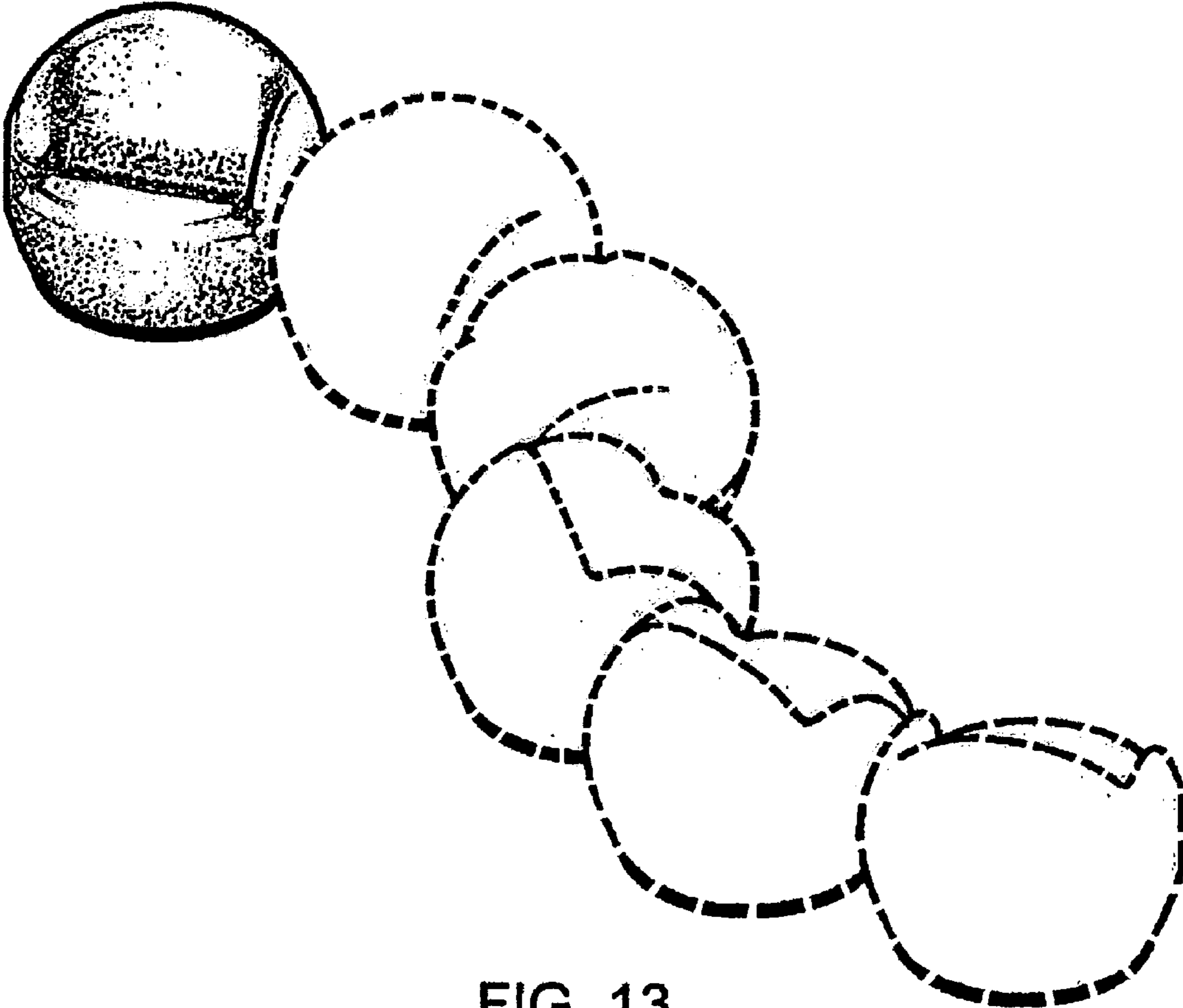

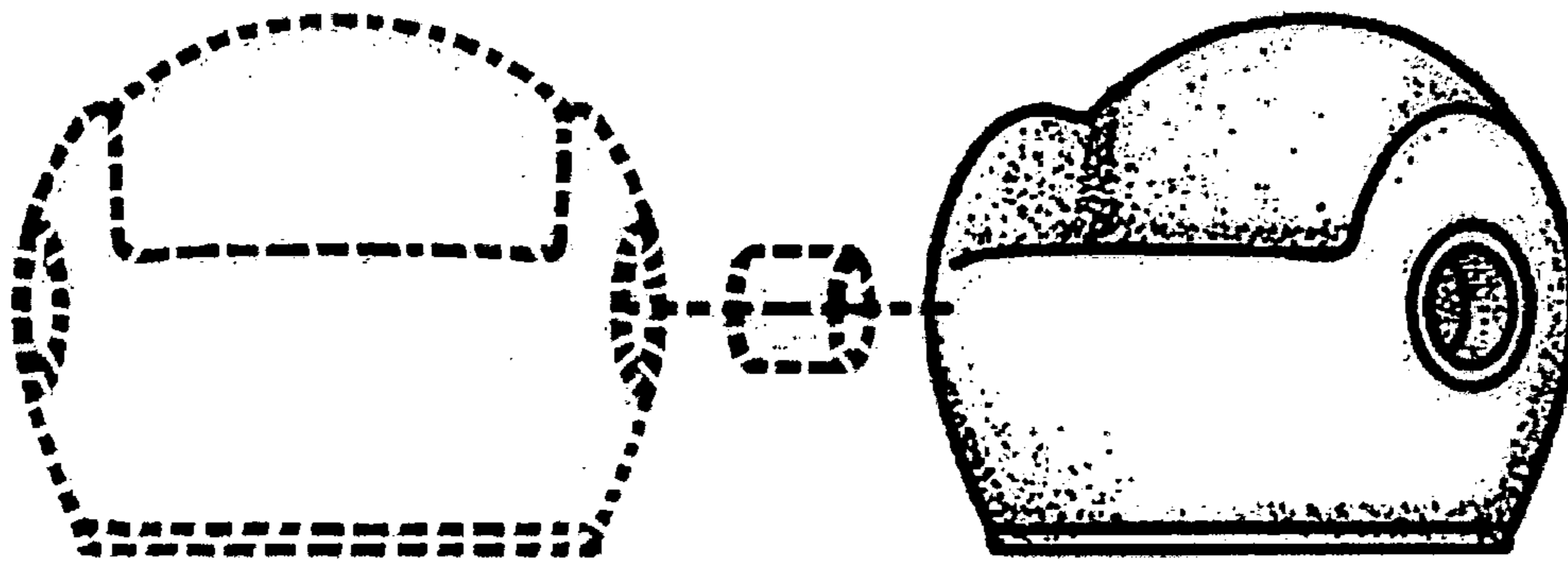
