FIG. 1 is a perspective view of a bedding accessory for article storage in accordance with an embodiment of the present invention.

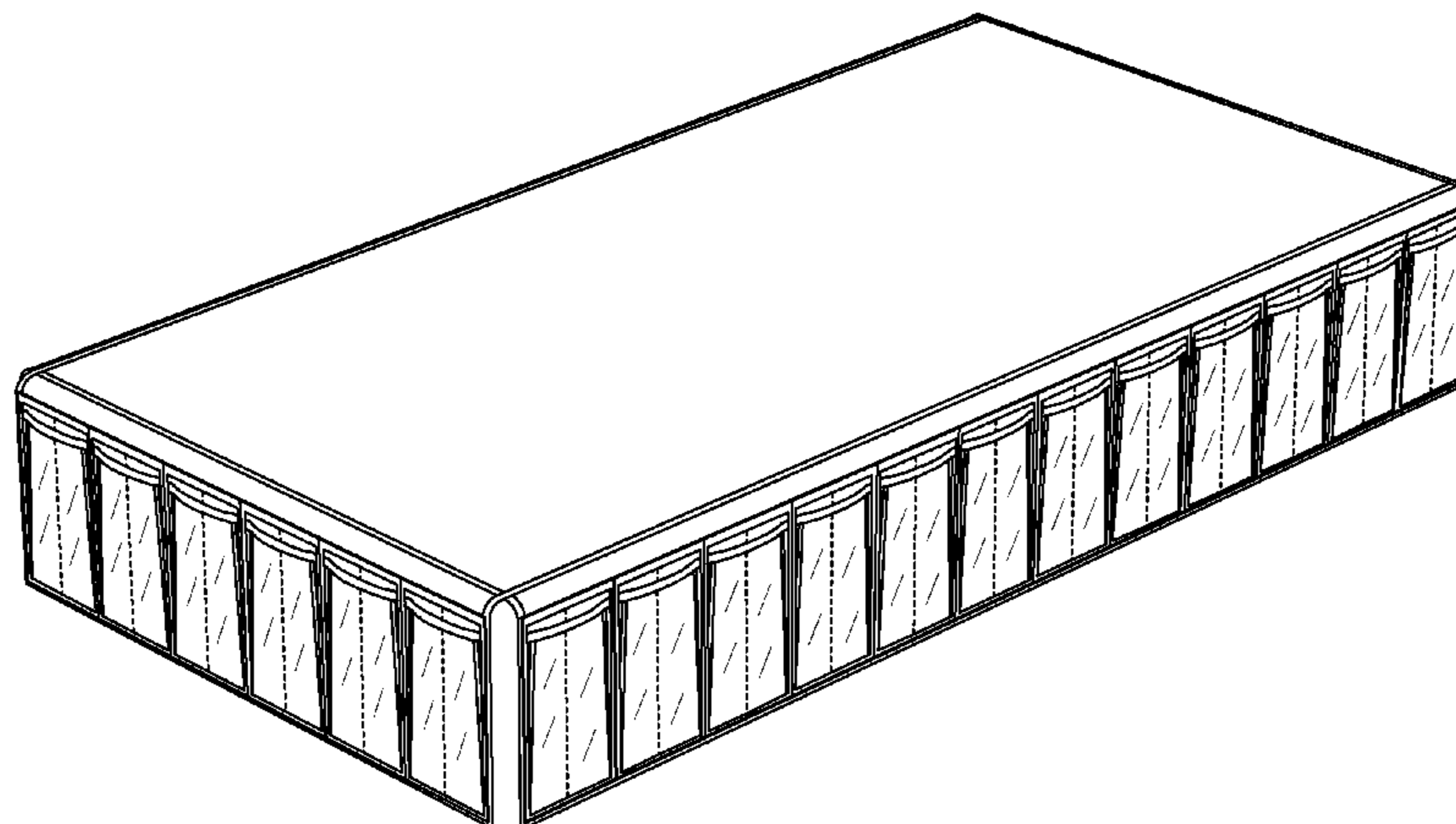
FIG. 2 is a reduced scale top view of the bedding accessory for article storage of FIG. 1.

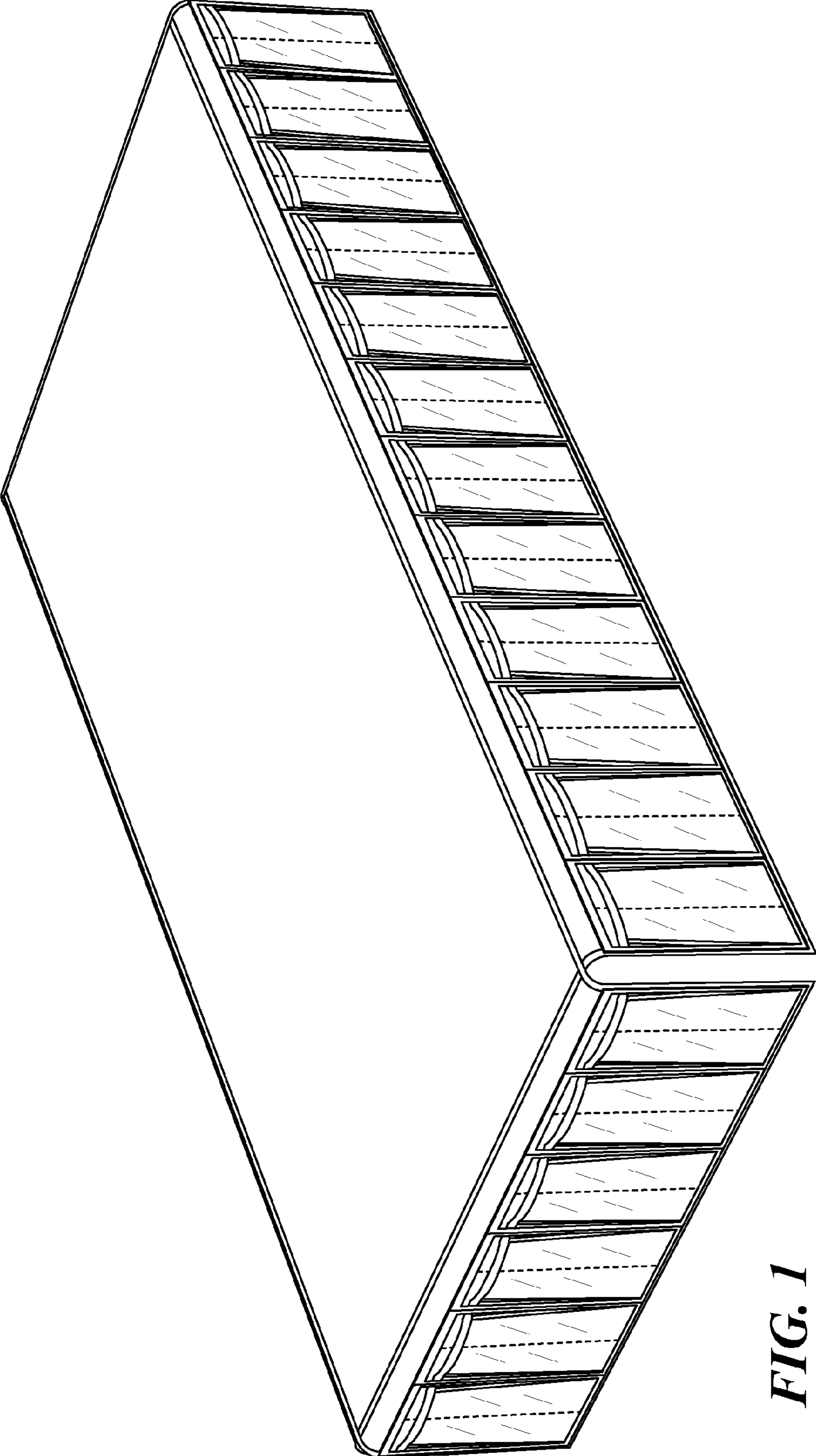
FIG. 3 is a front view of the bedding accessory for article storage of FIG. 1; and,

FIG. 4 is a right side view of the bedding accessory for article storage of FIG. 1, the left side being a mirror image thereof.

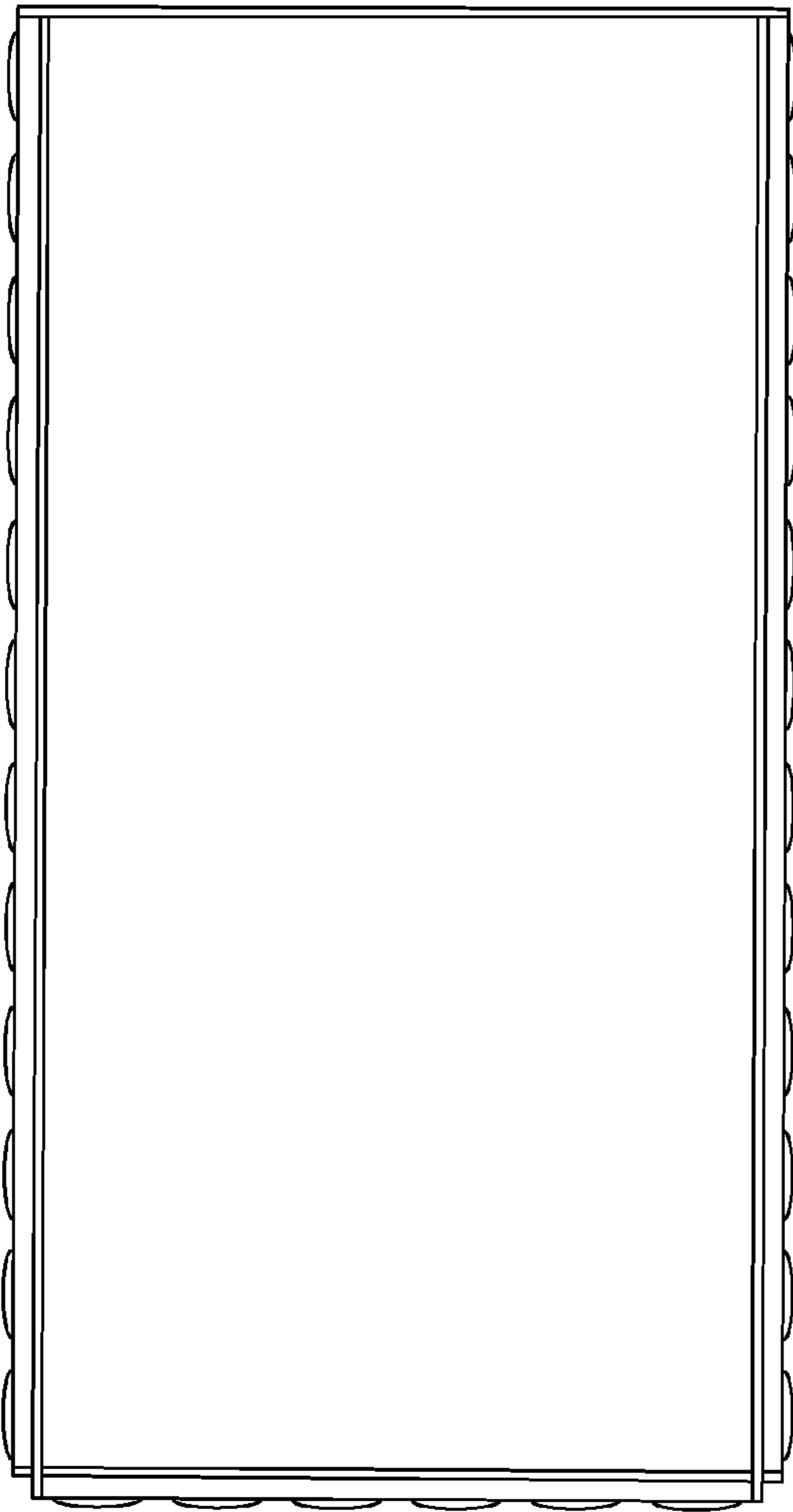

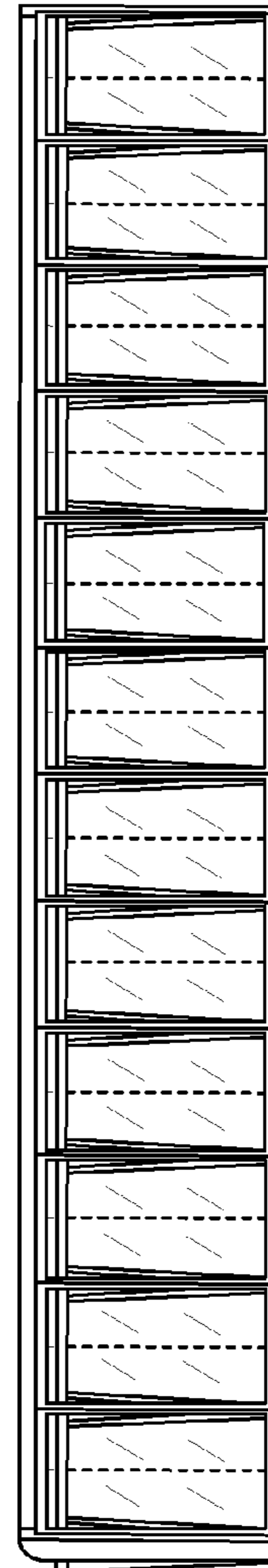




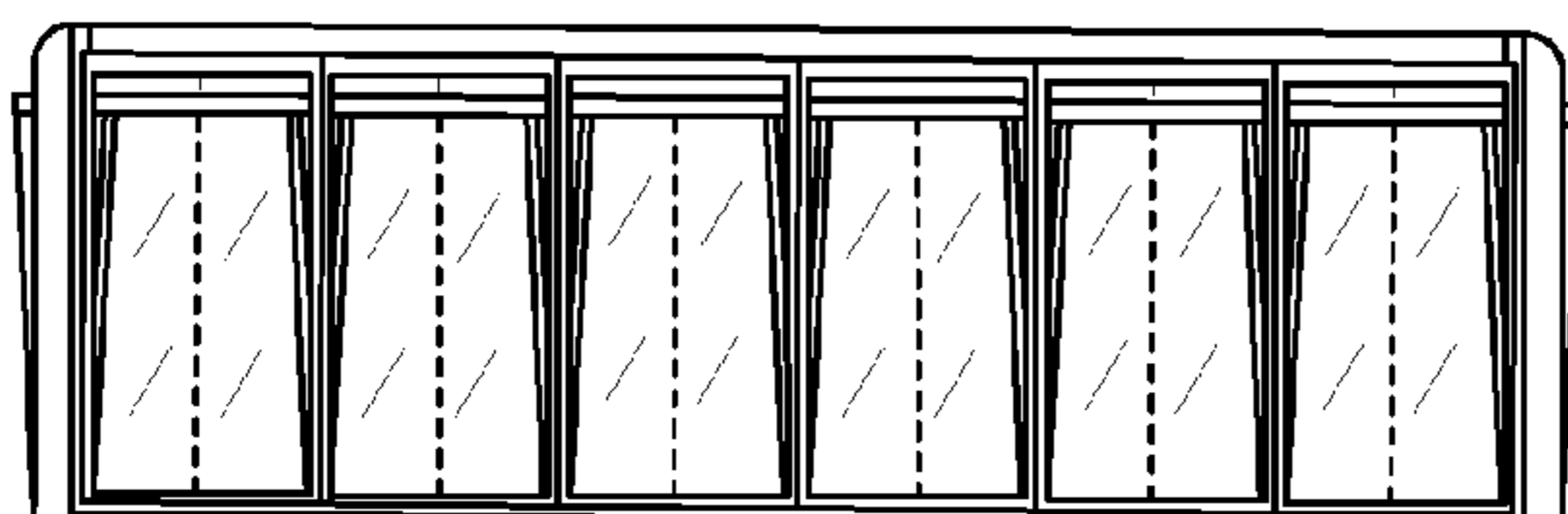
