FIG. 2 is a front view of the tanning lotion bottle.

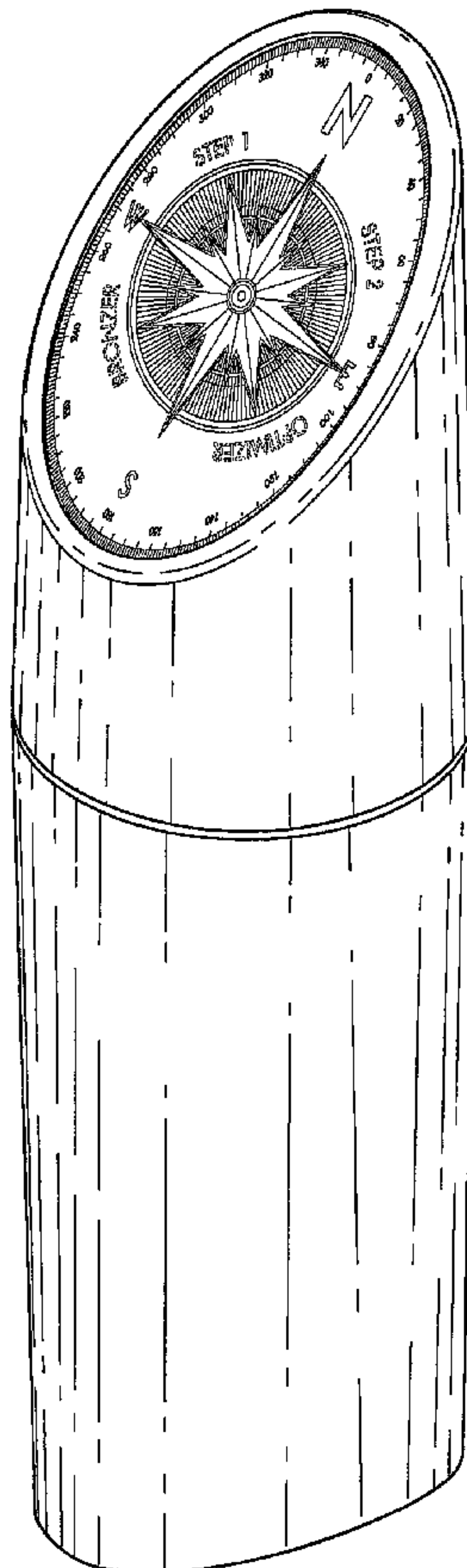
FIG. 3 is a rear view of the tanning lotion bottle.

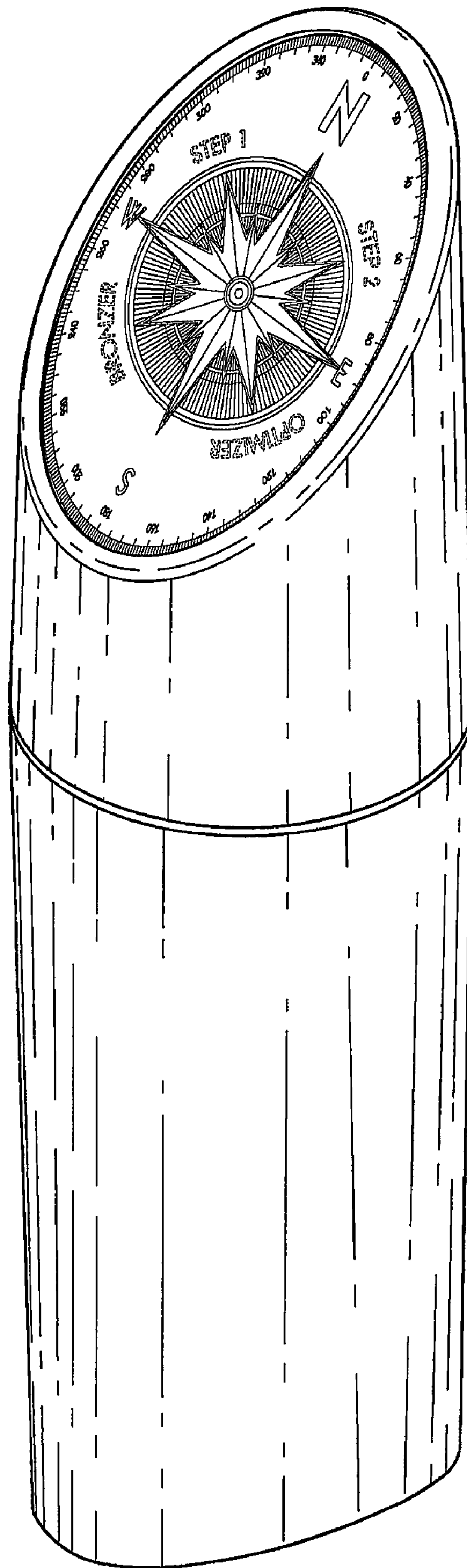

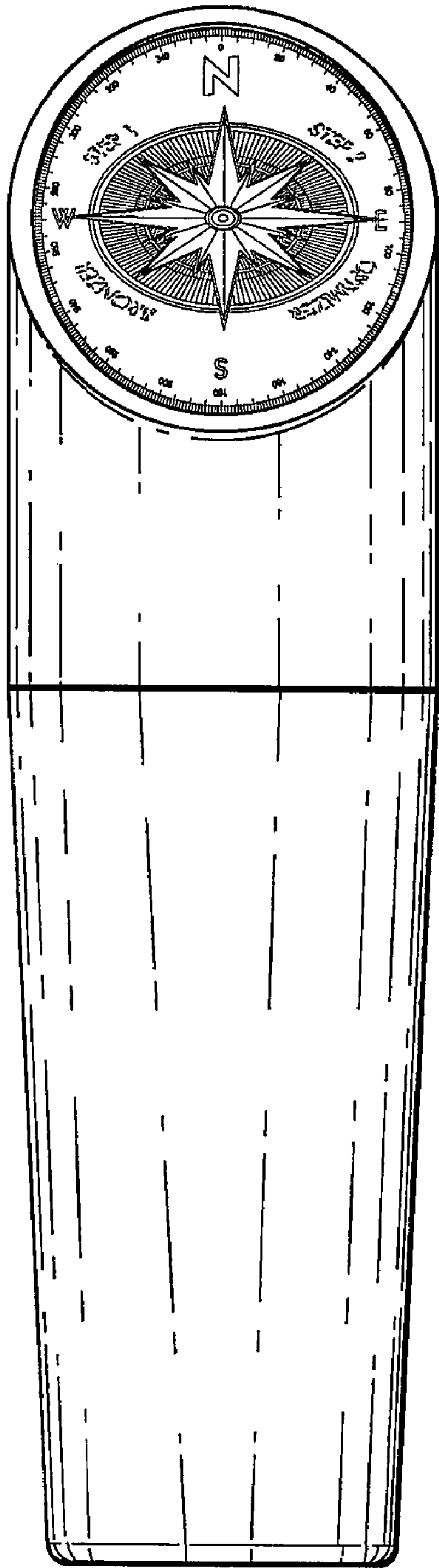

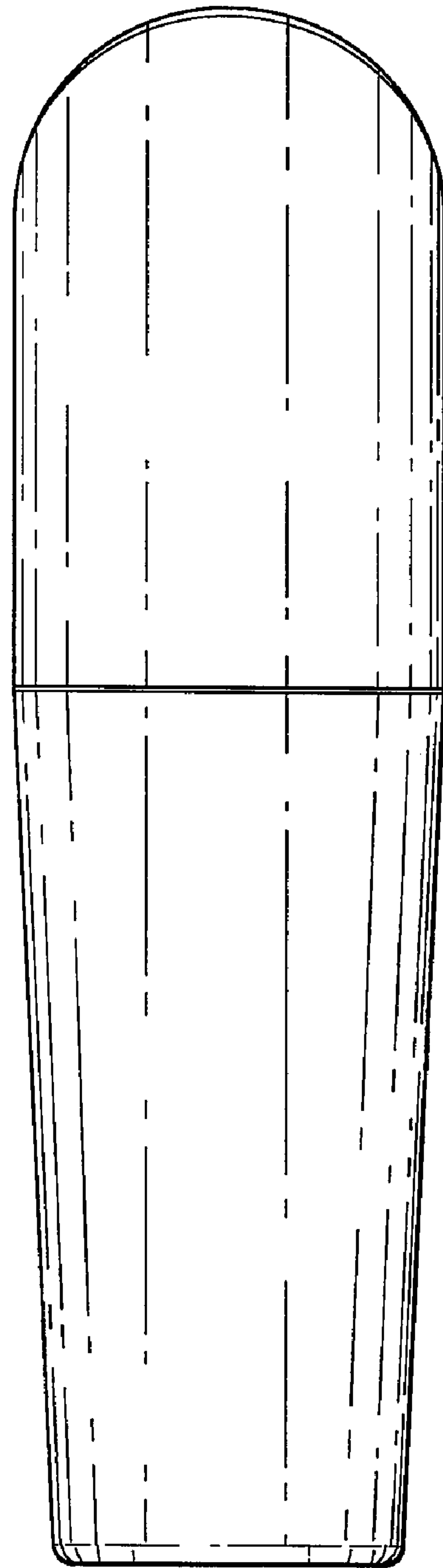

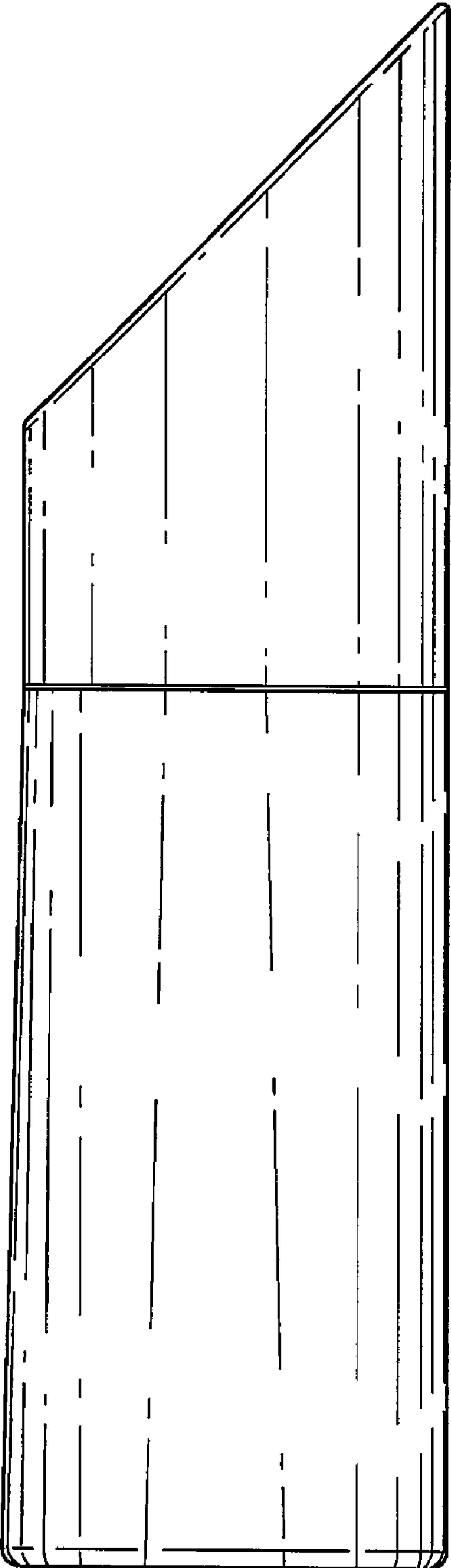

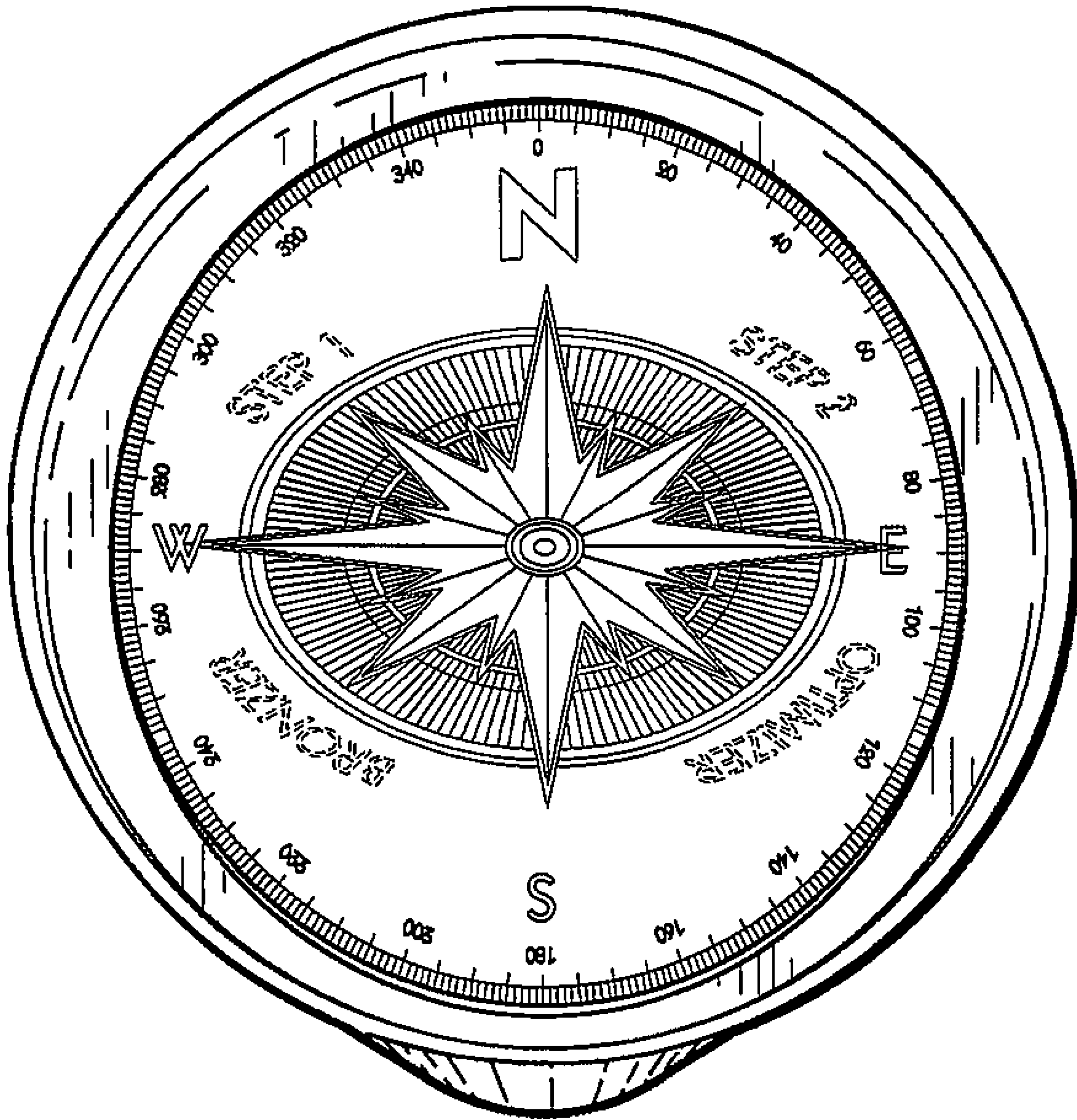
