The ornamental design for a bag with handle, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a bag with a handle.
FIG. 2 is a right side elevation view of the bag with the handle.
FIG. 3 is a left side elevation view of the bag with the handle.
FIG. 4 is a front elevation view of the bag with the handle.
FIG. 5 is a back elevation view of the bag with the handle.
FIG. 6 is a top plan view of the bag with the handle; and,
FIG. 7 is a bottom plan view of the bag with the handle.

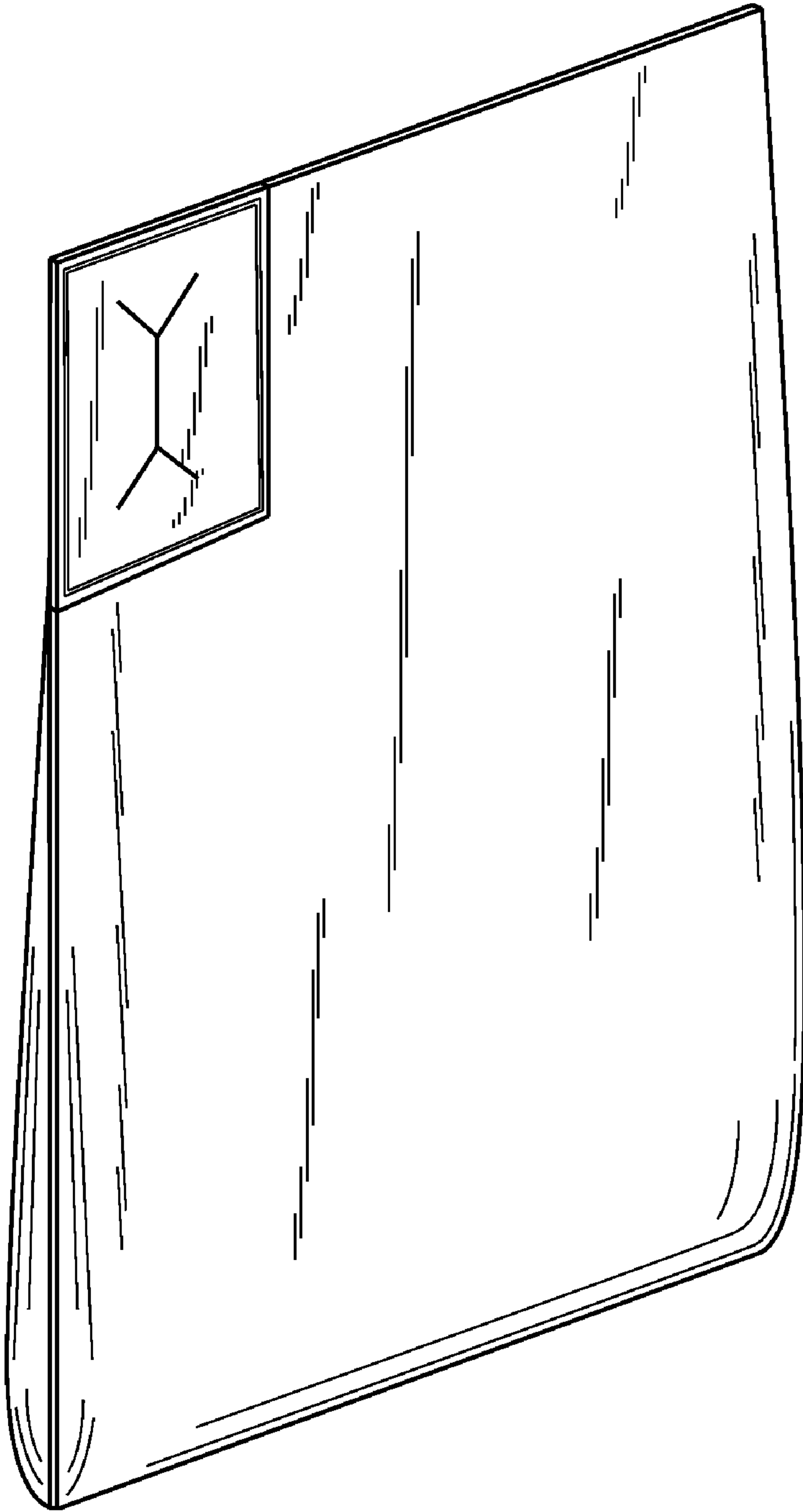

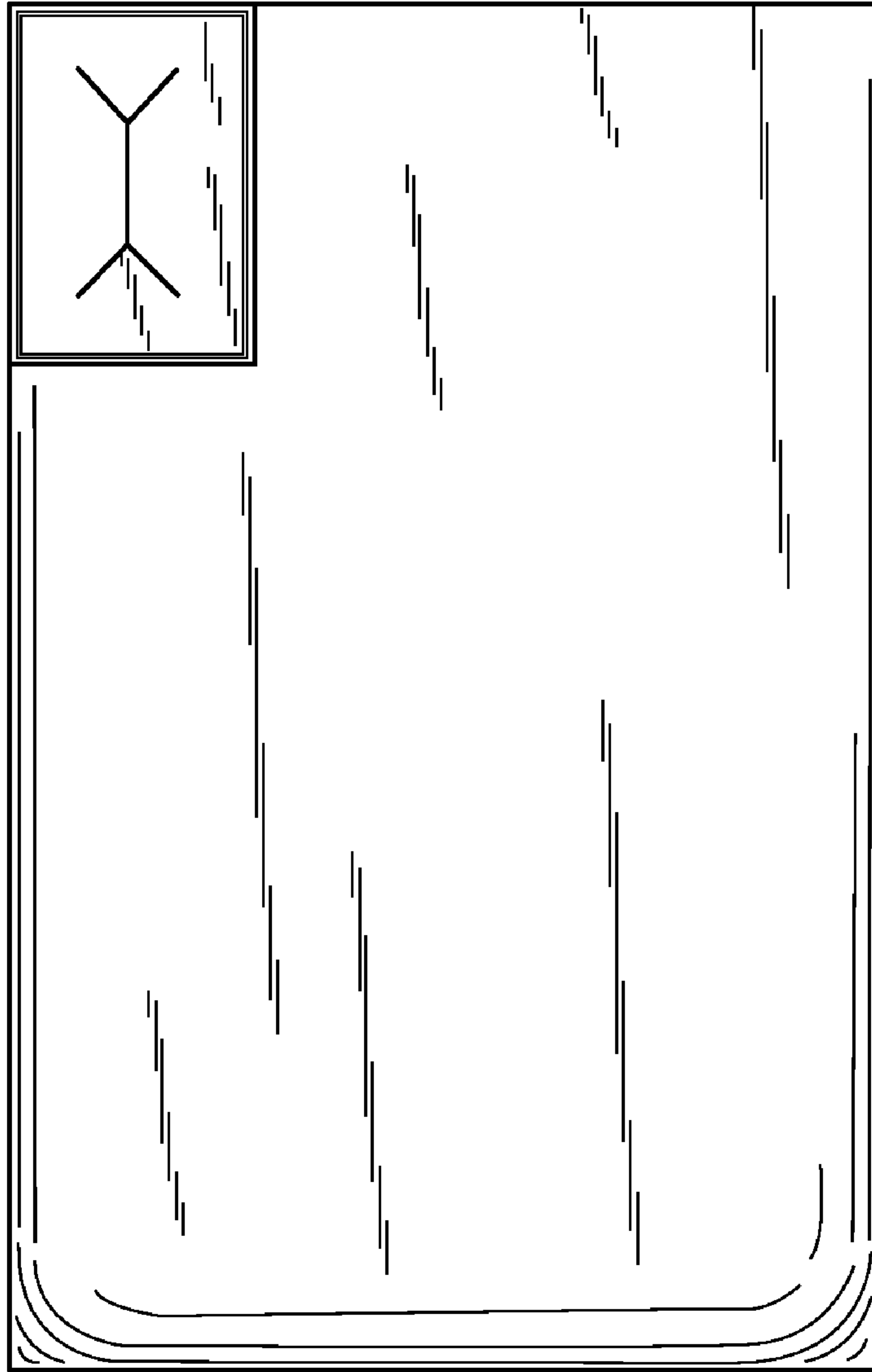

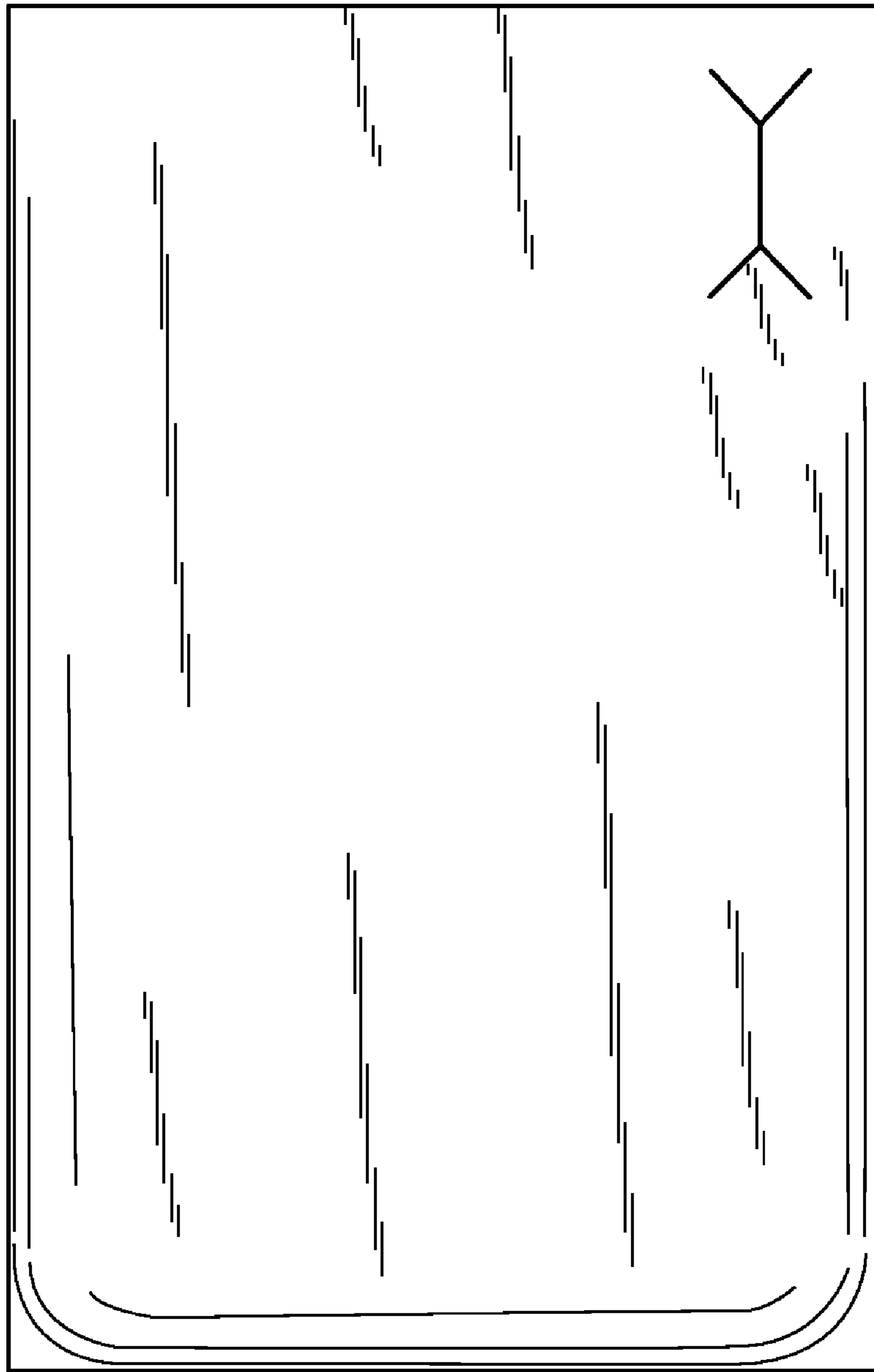

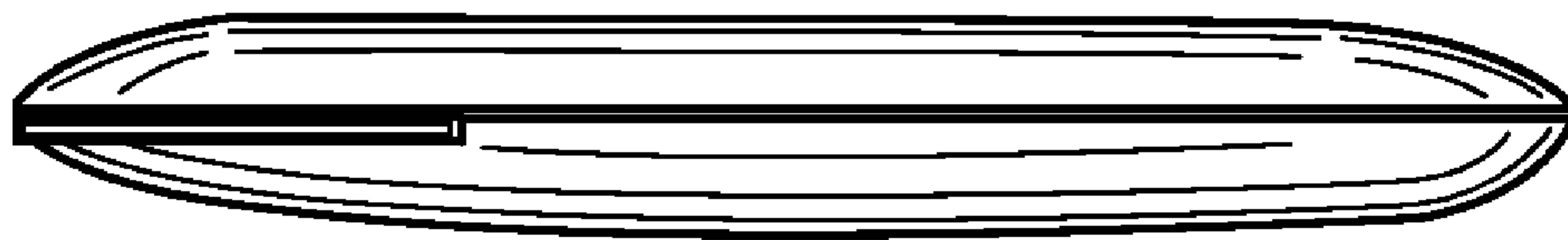

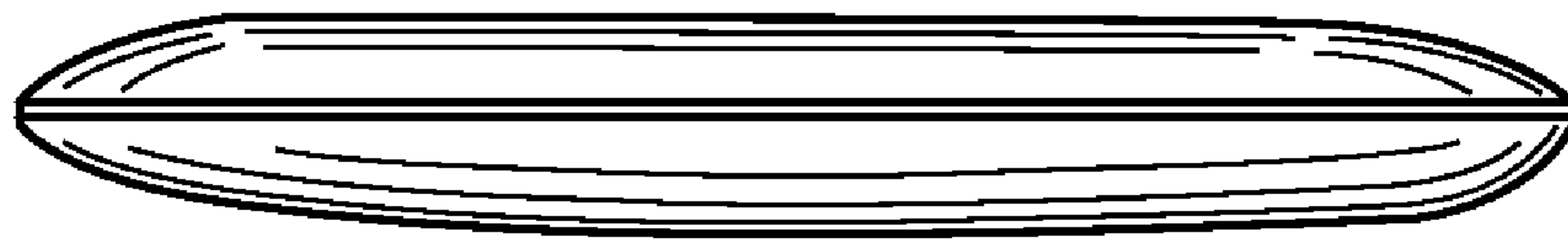
