The ornamental design for a tray with multiple separate spaces for plant pots, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a tray with multiple separate spaces for plant pots showing my new design;

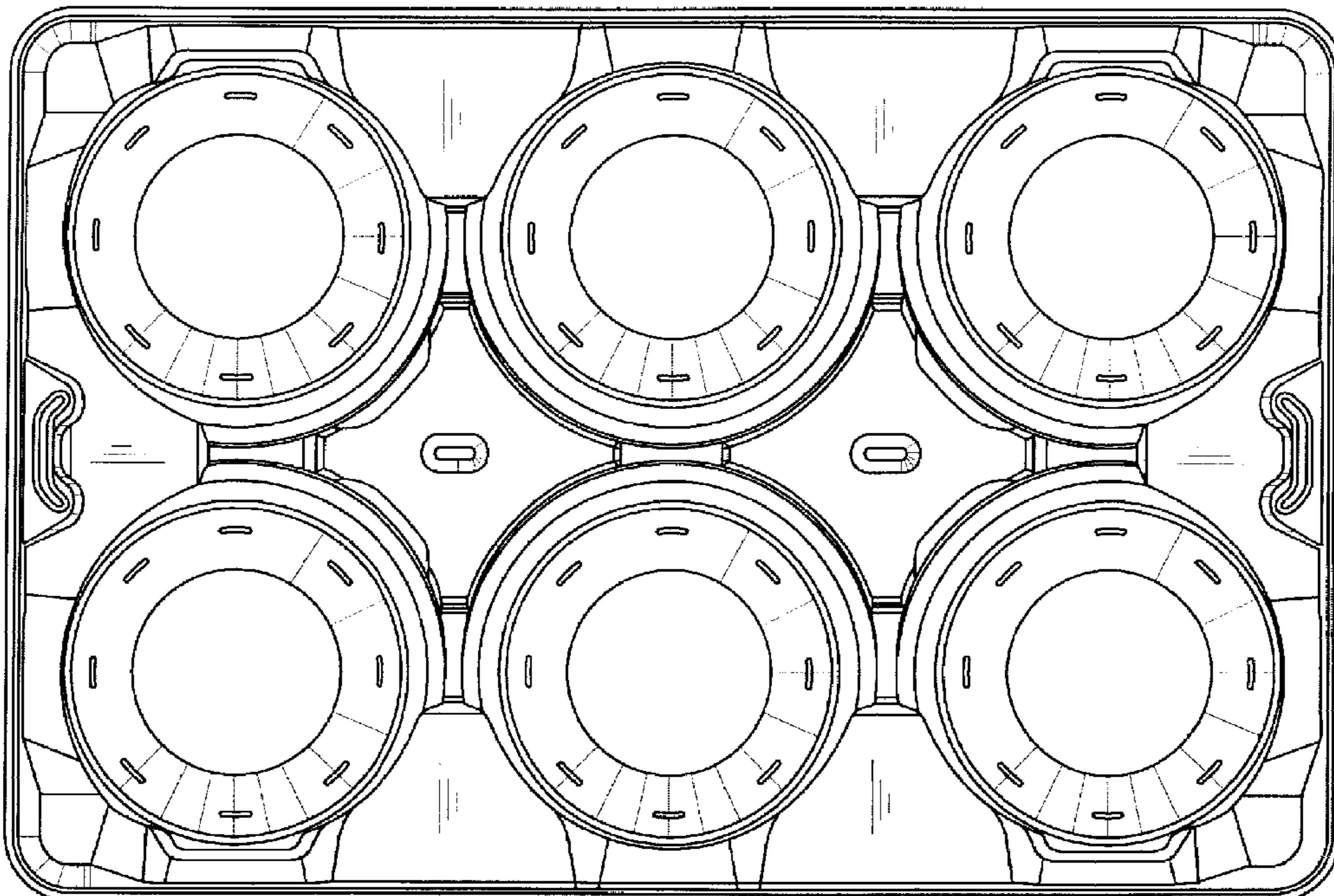
FIG. 2 is a front elevational view thereof, the rear elevational view being a mirror image thereof;

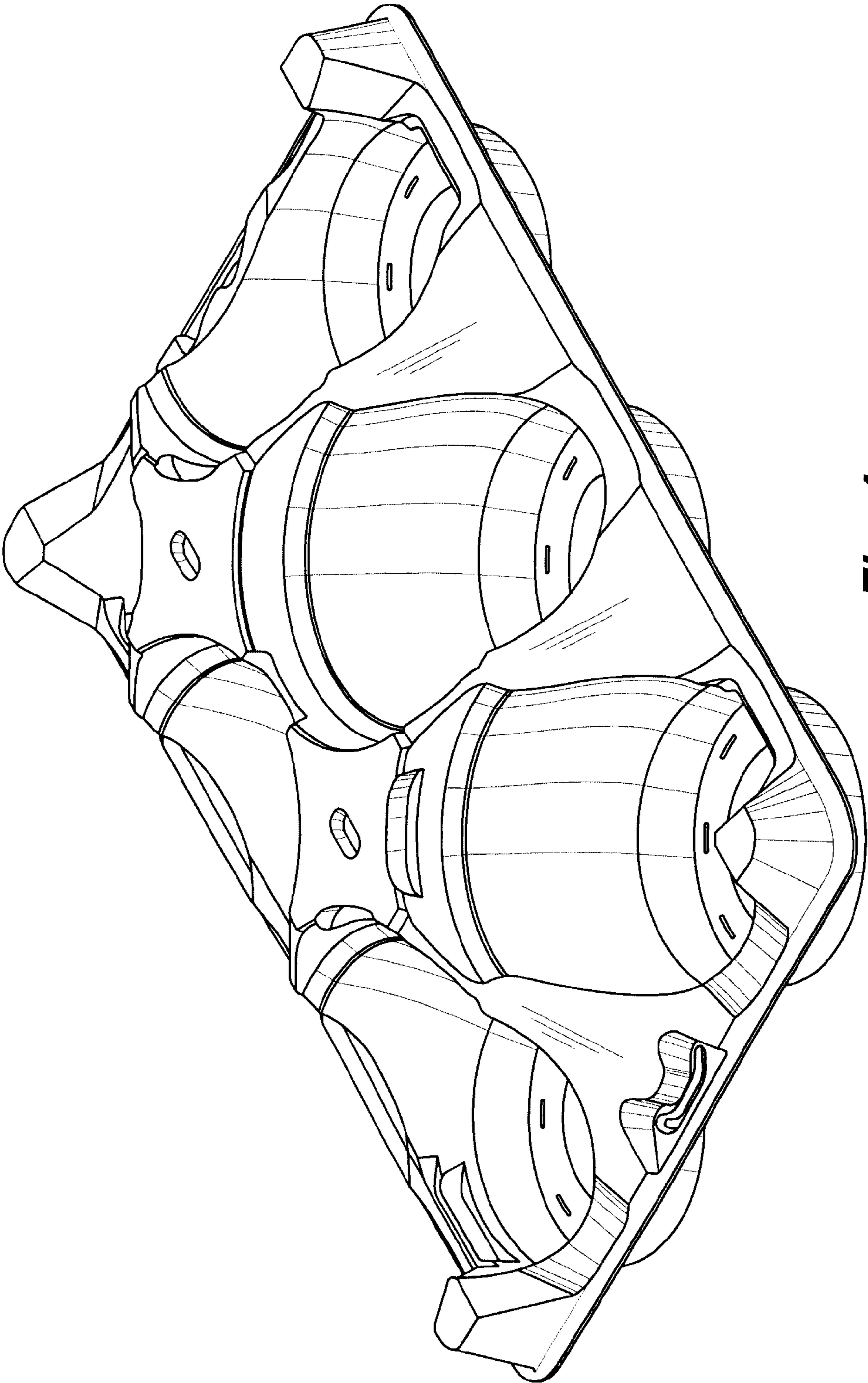
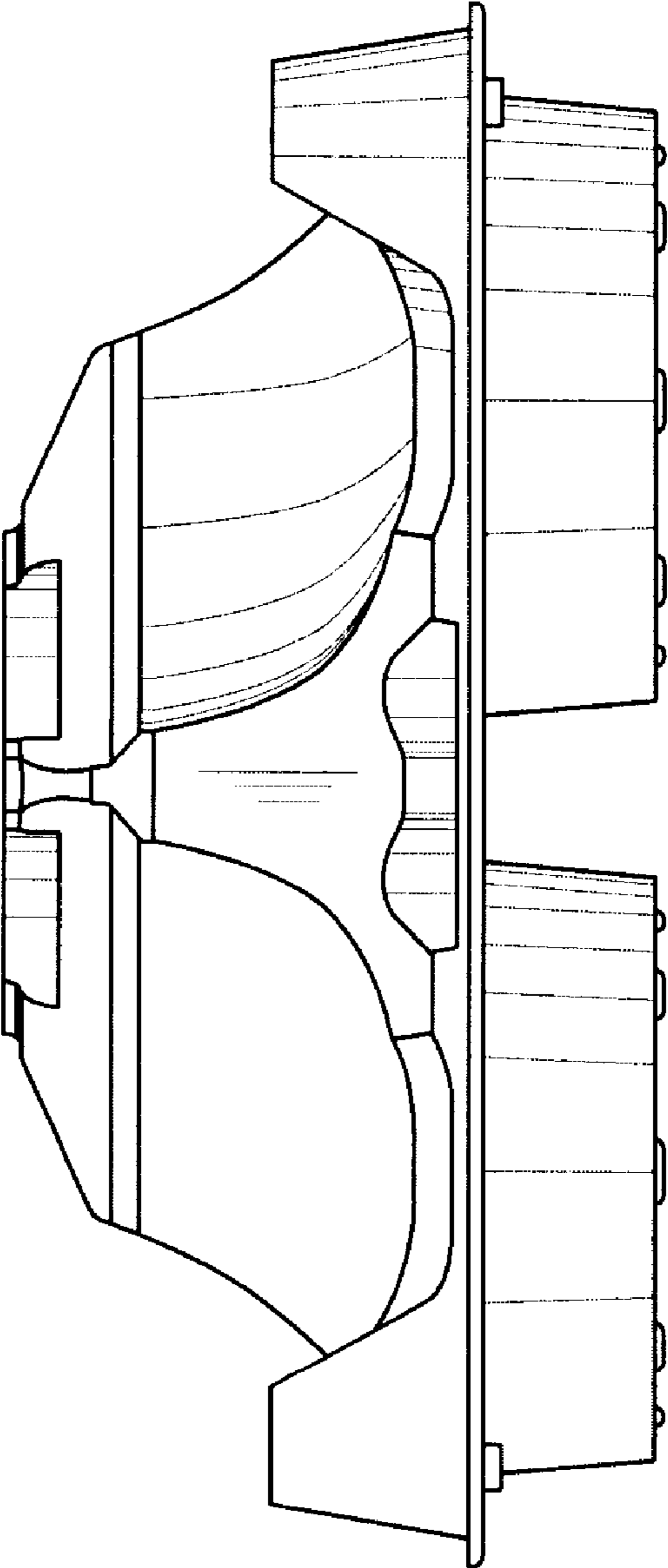
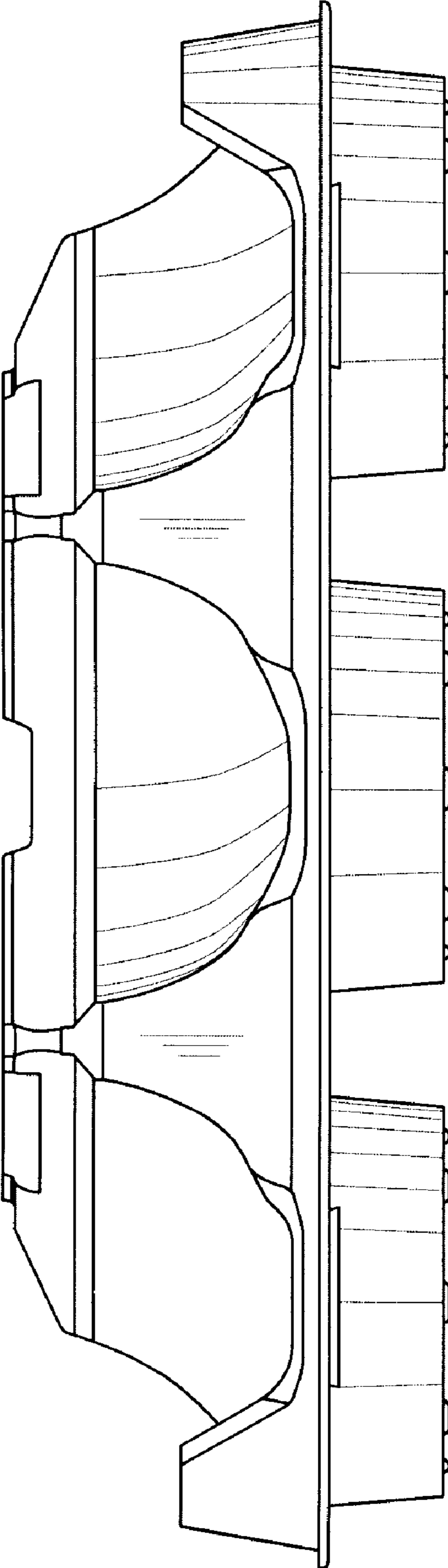


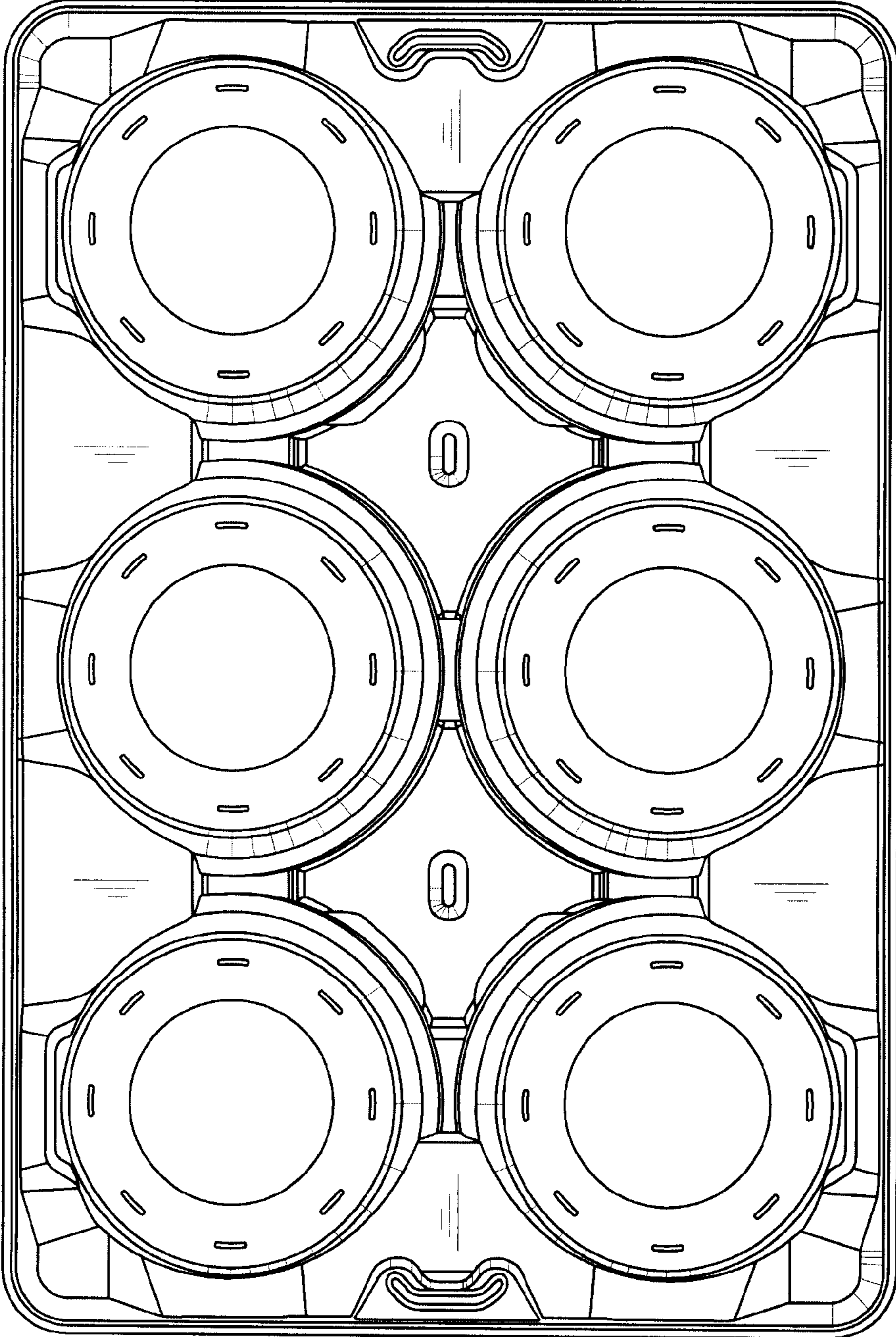

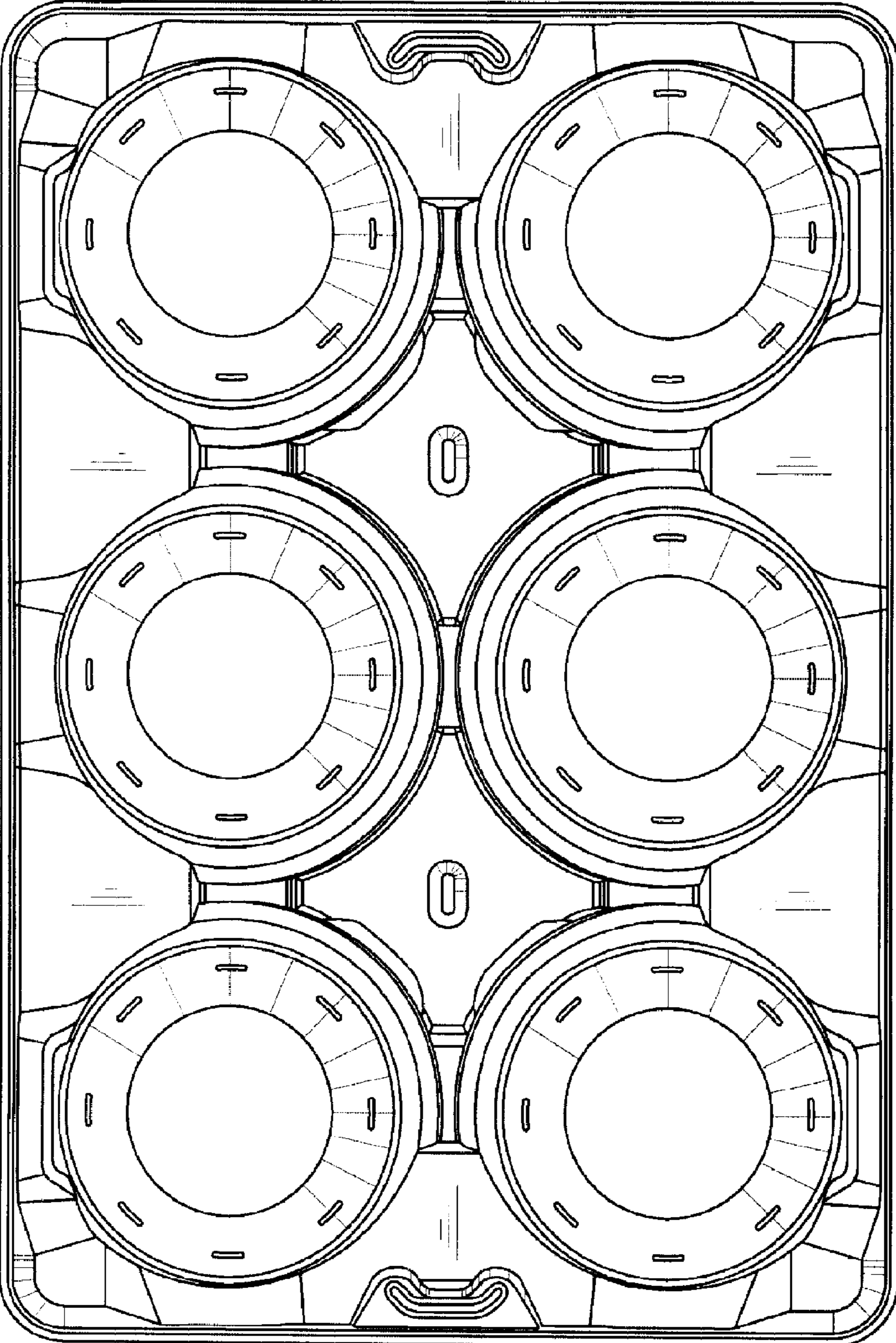
