(57) **CLAIM**

The ornamental design for a top for a boat, as shown and described.

DESCRIPTION

FIG. 1 is a left side perspective view of a top for a boat showing my new design, the top being in an operational configuration;

FIG. 2 is a right side bottom perspective view of the top for a boat shown in FIG. 1;

FIG. 3 is a front view of the top for a boat shown in FIG. 1;

FIG. 4 is a perspective view from the left rear side of the top for a boat shown in FIG. 1;

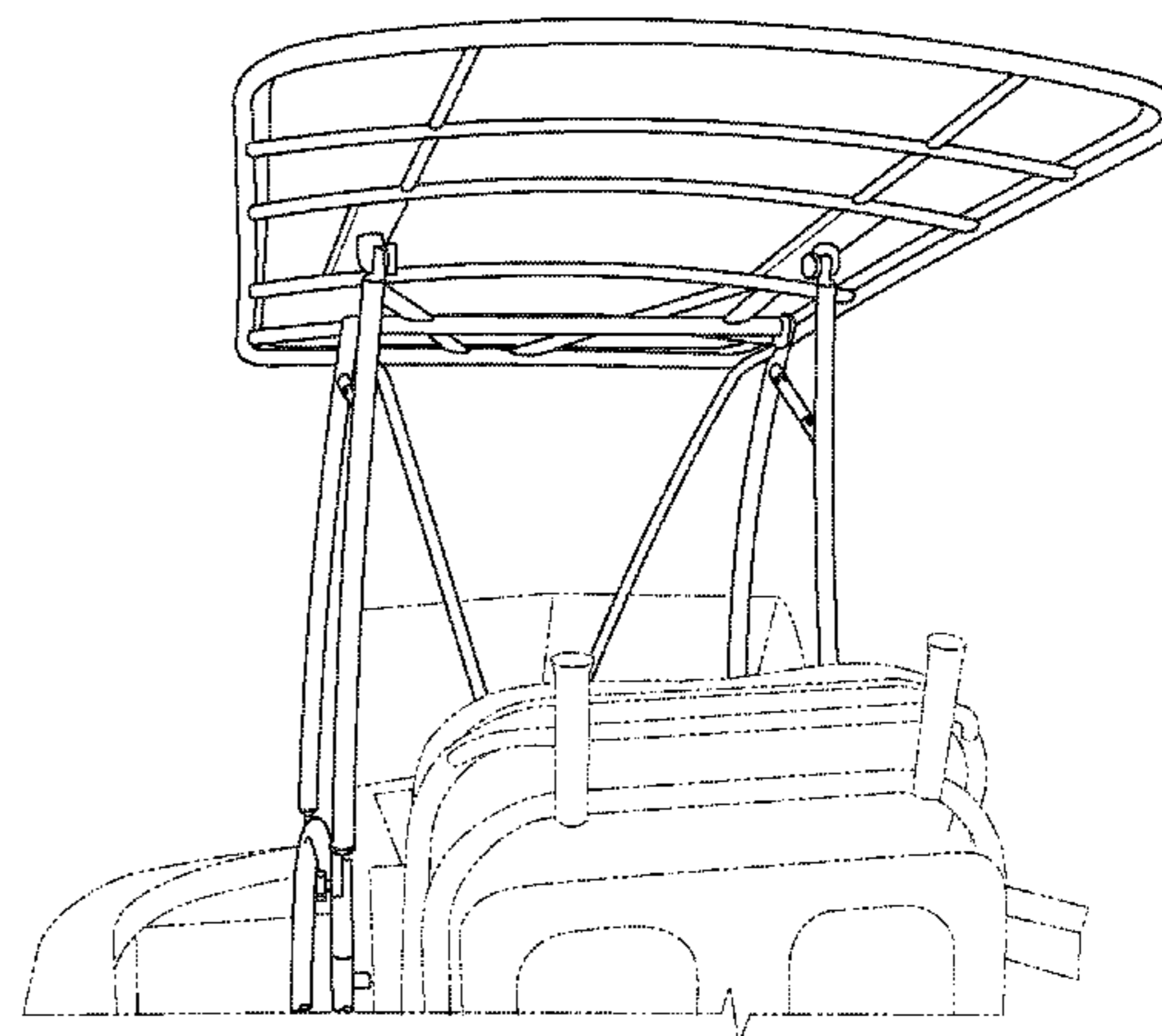
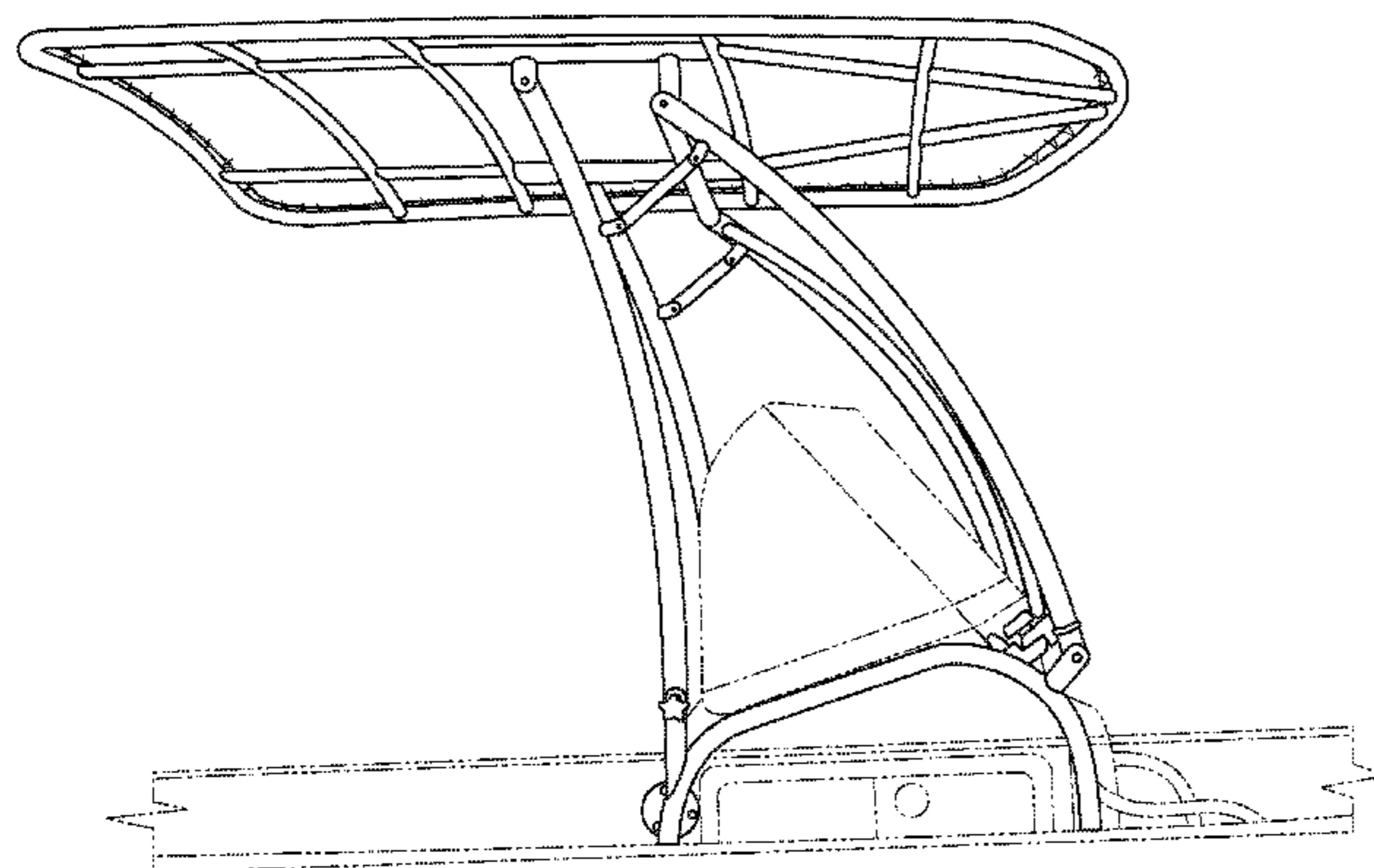
FIG. 5 is a partial right side top perspective view of the top for a boat shown in FIG. 1 in a transportable position;

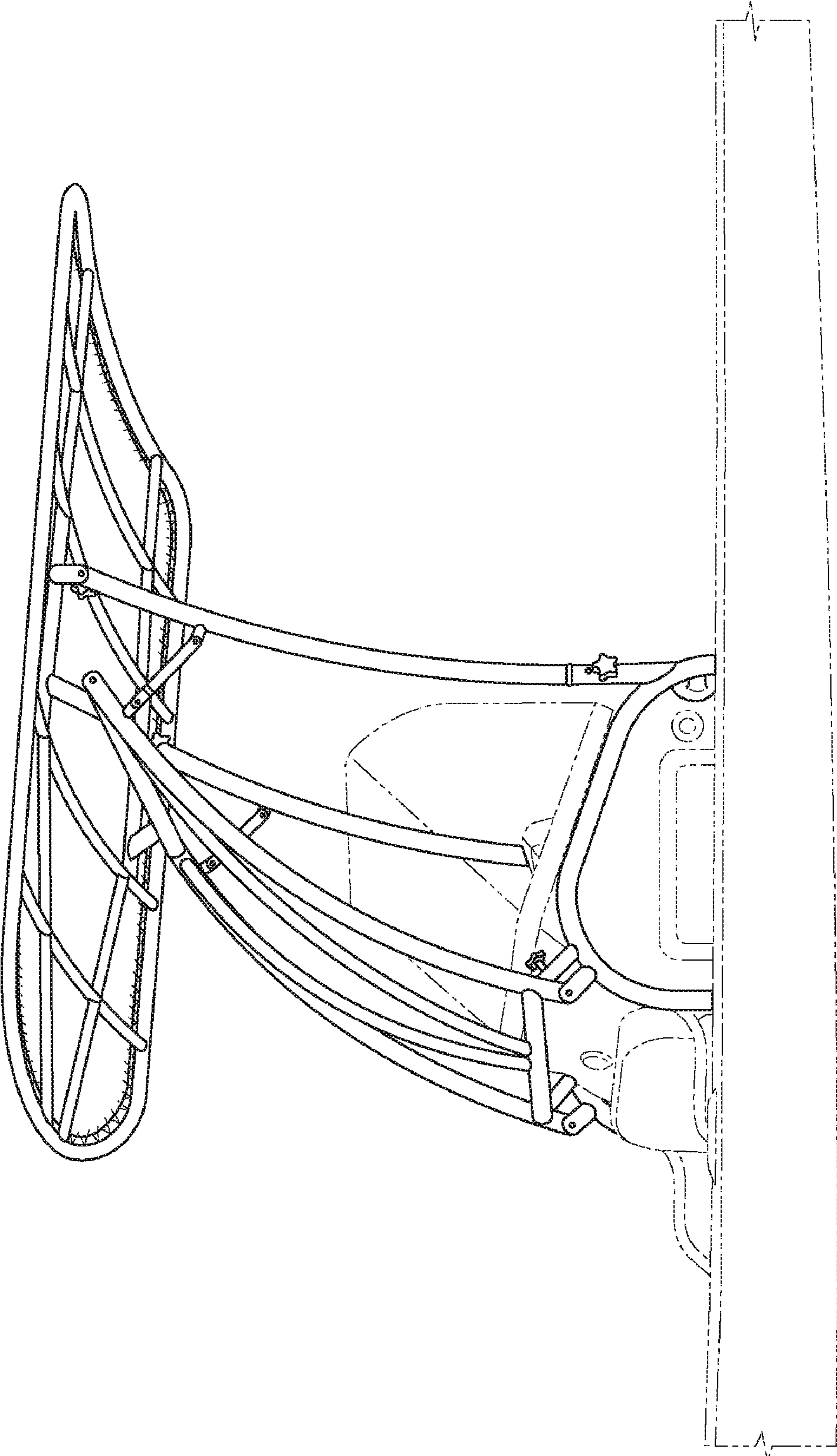

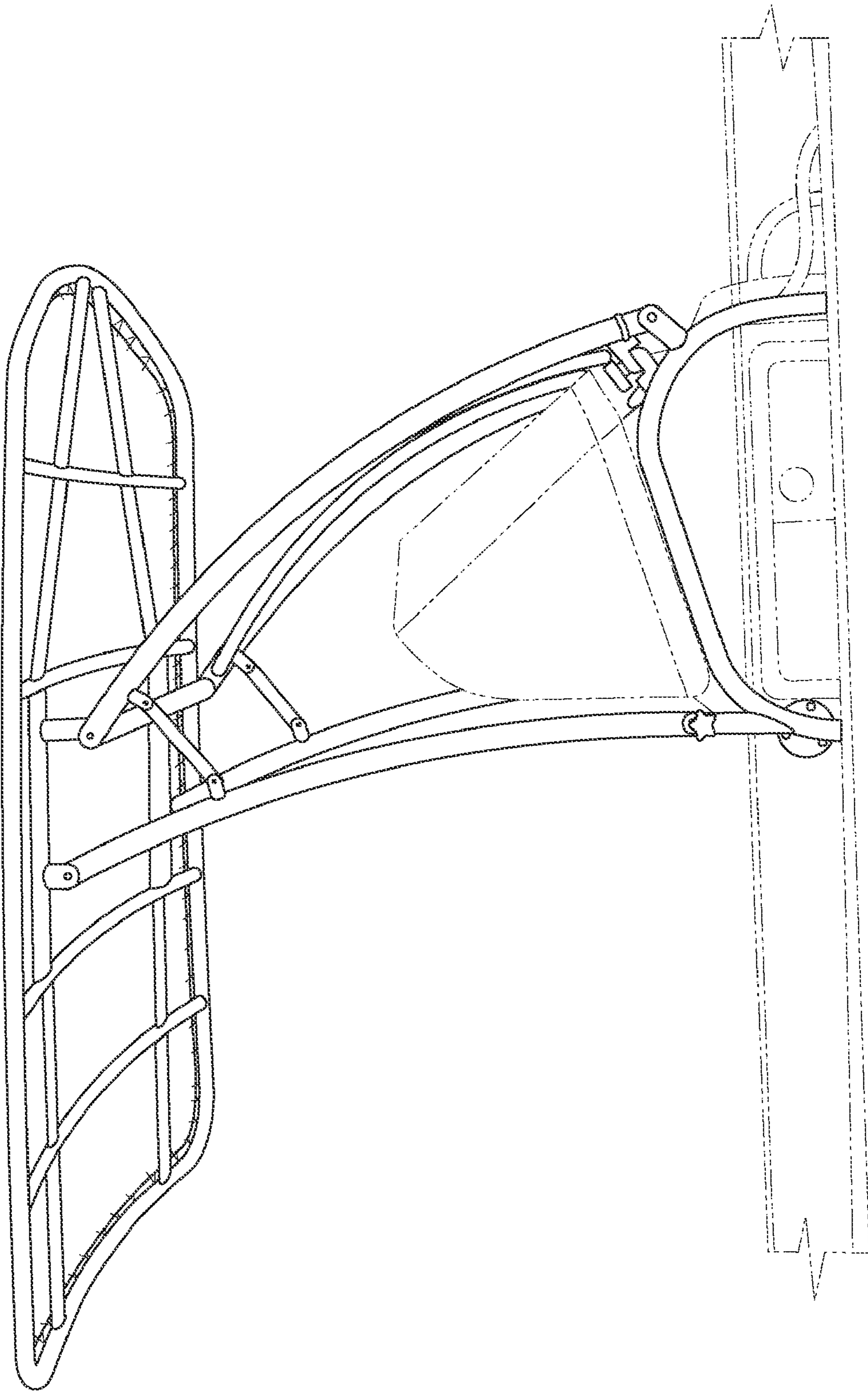

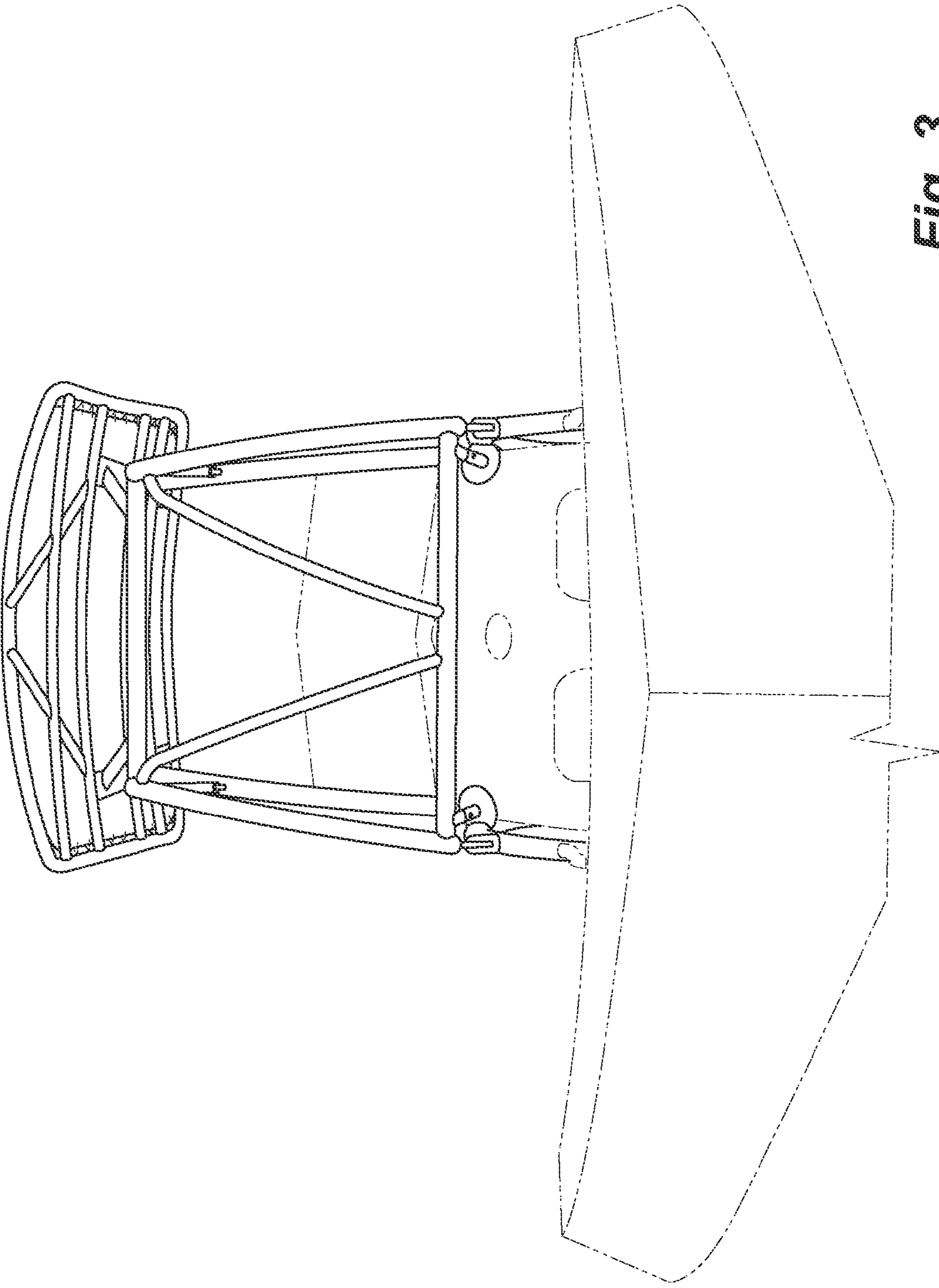

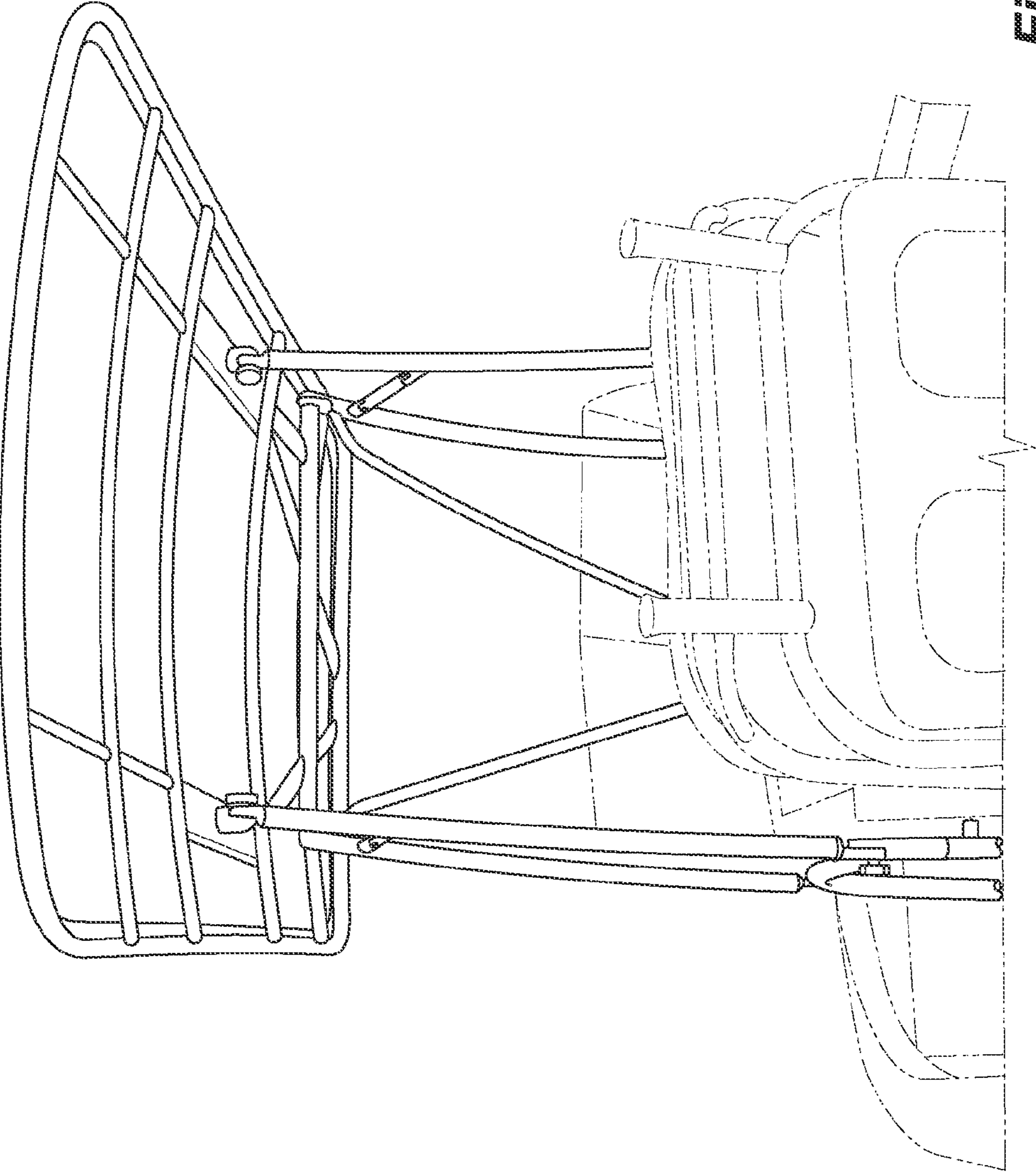

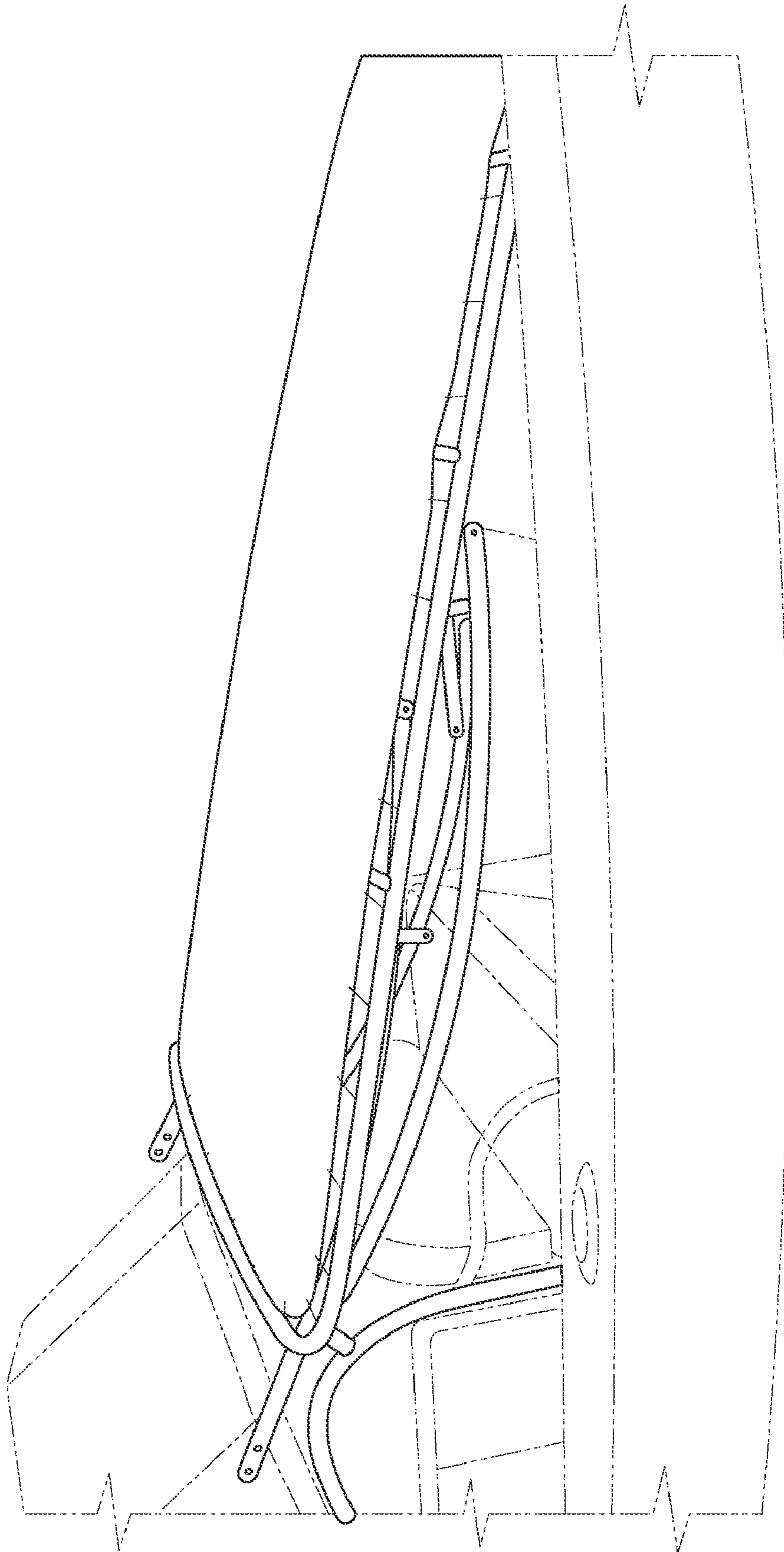

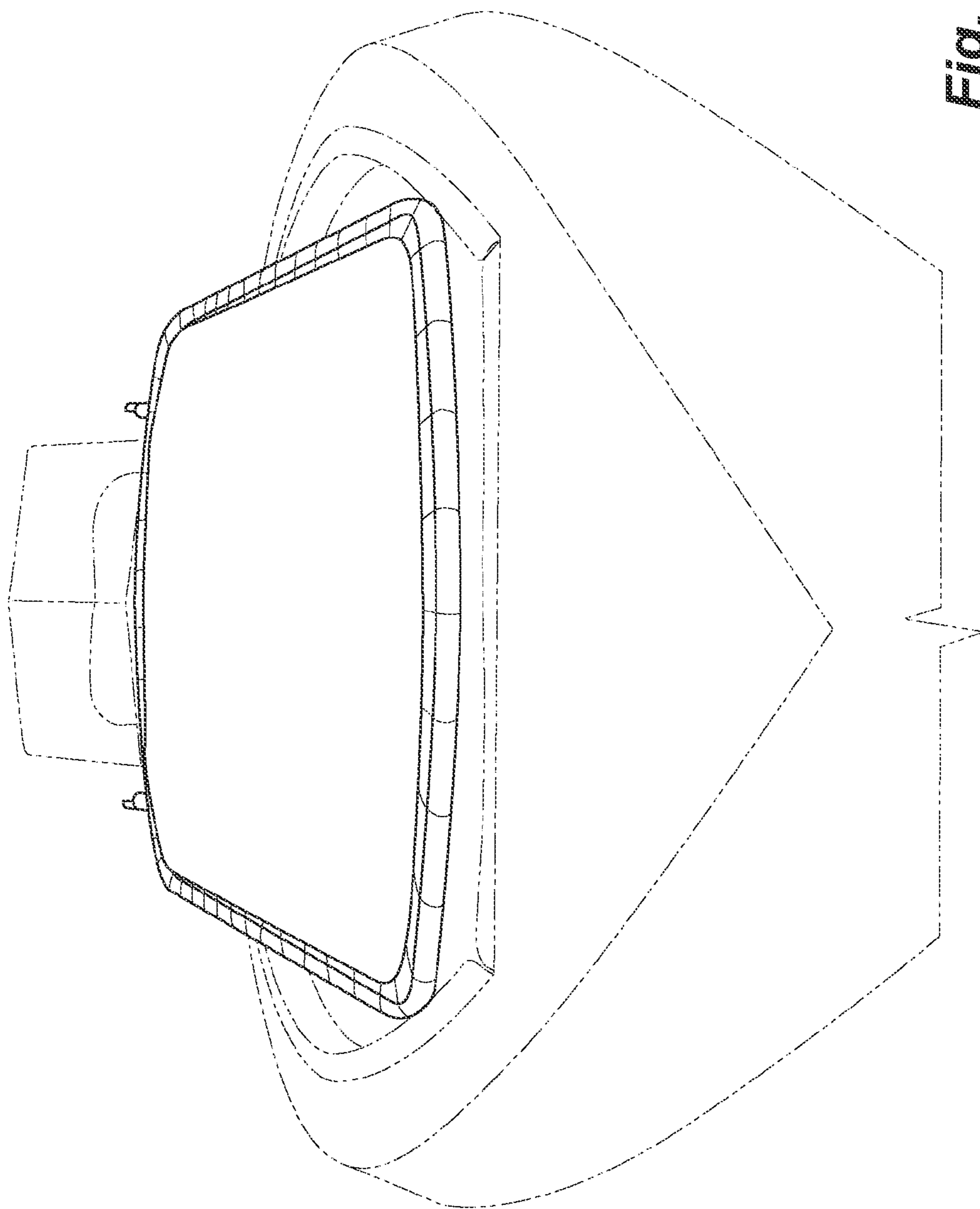

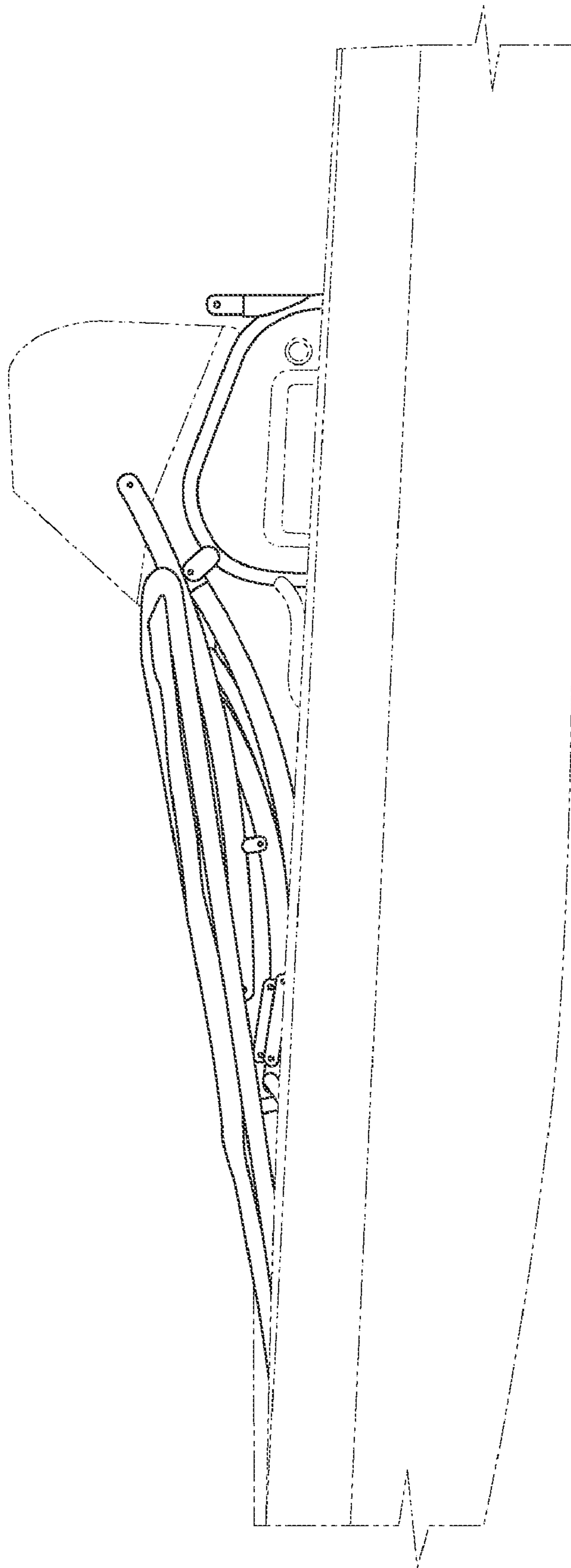
