FIG. 2 is a rear elevational view of the pneumatic tire shown in FIG. 1.

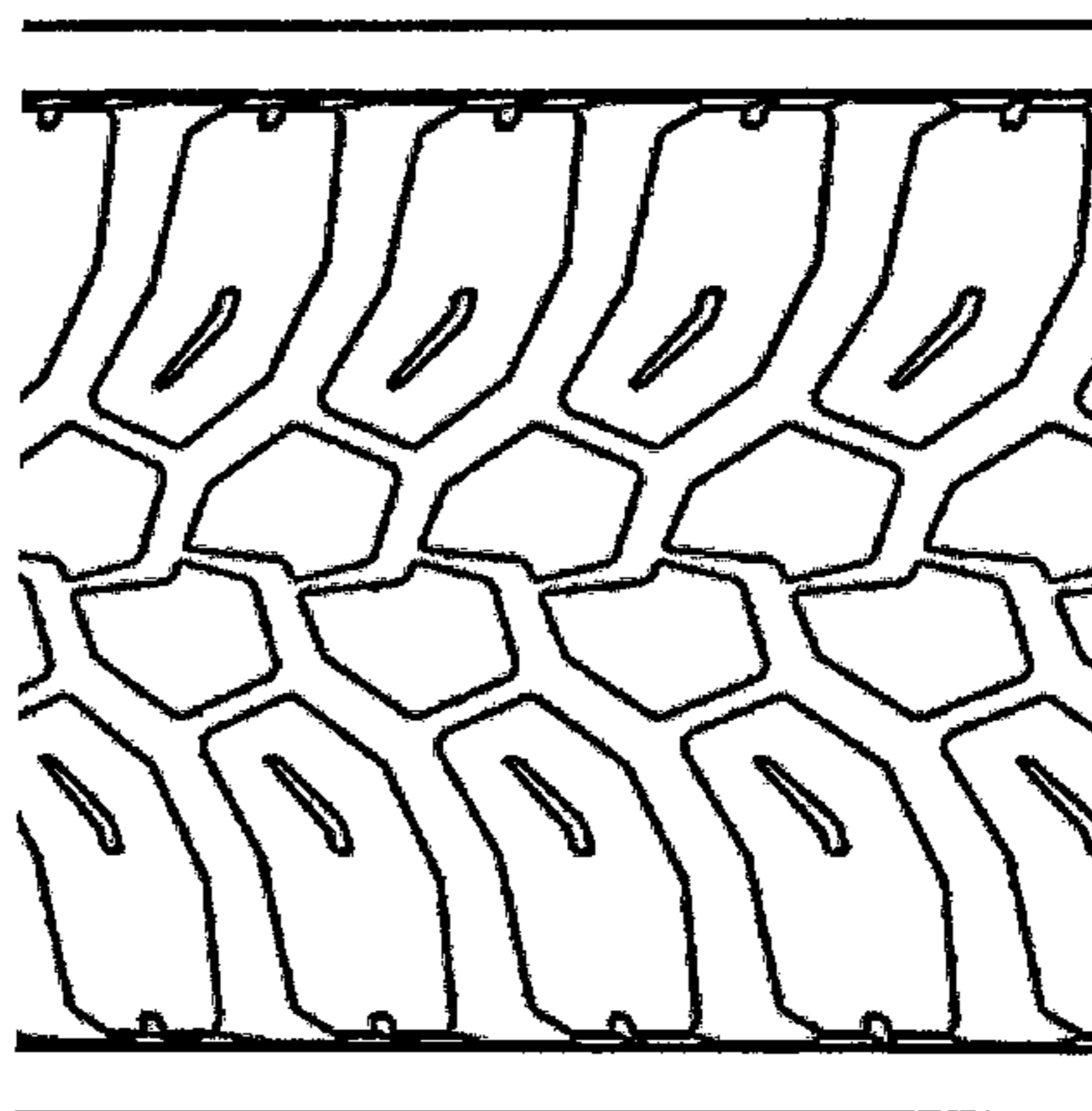
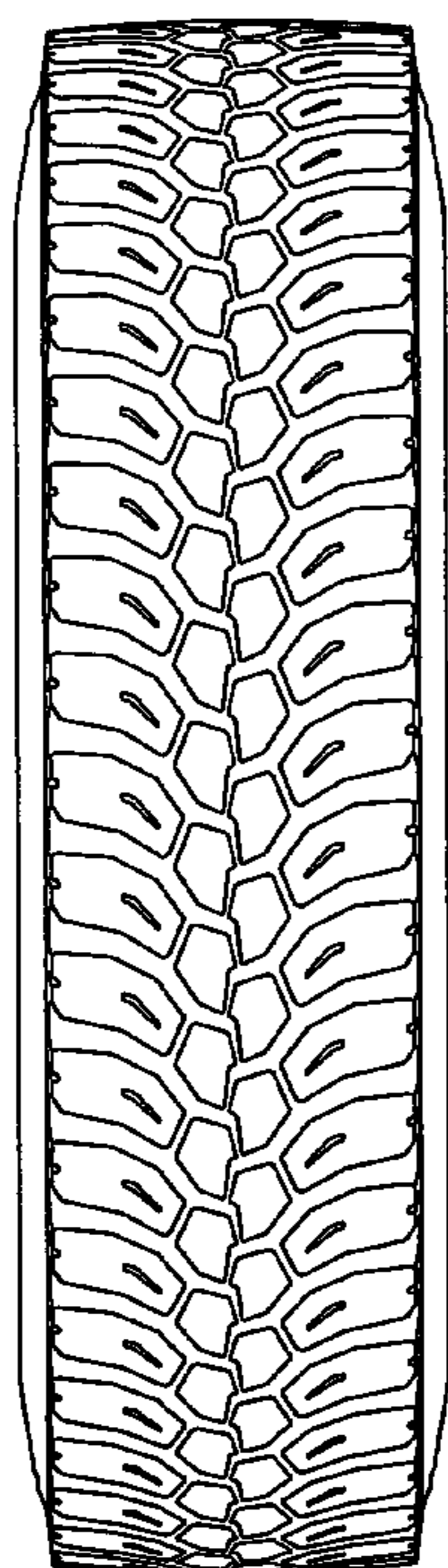
FIG. 3 is a front perspective view of the pneumatic tire shown I FIG. 1.

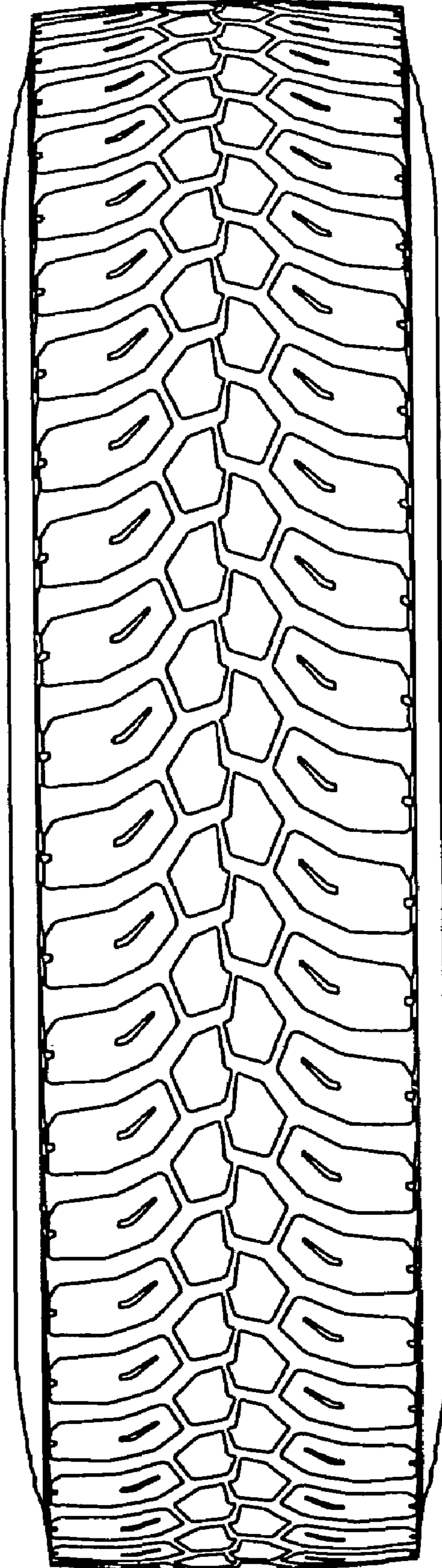
FIG. 4 is a side elevational view of one side of the pneumatic tire shown in FIG. 1.

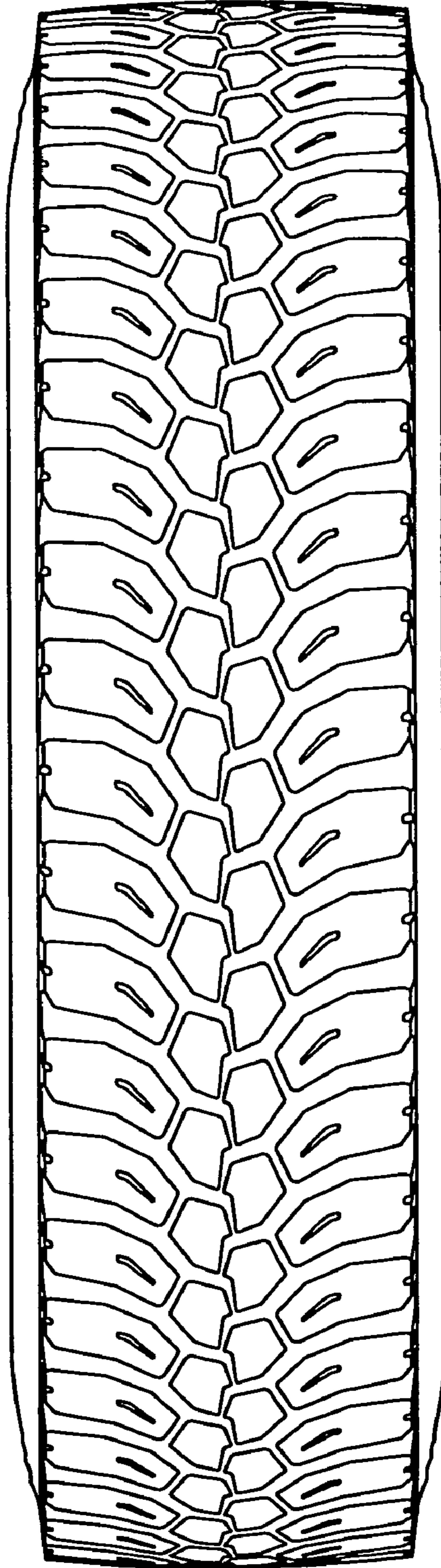

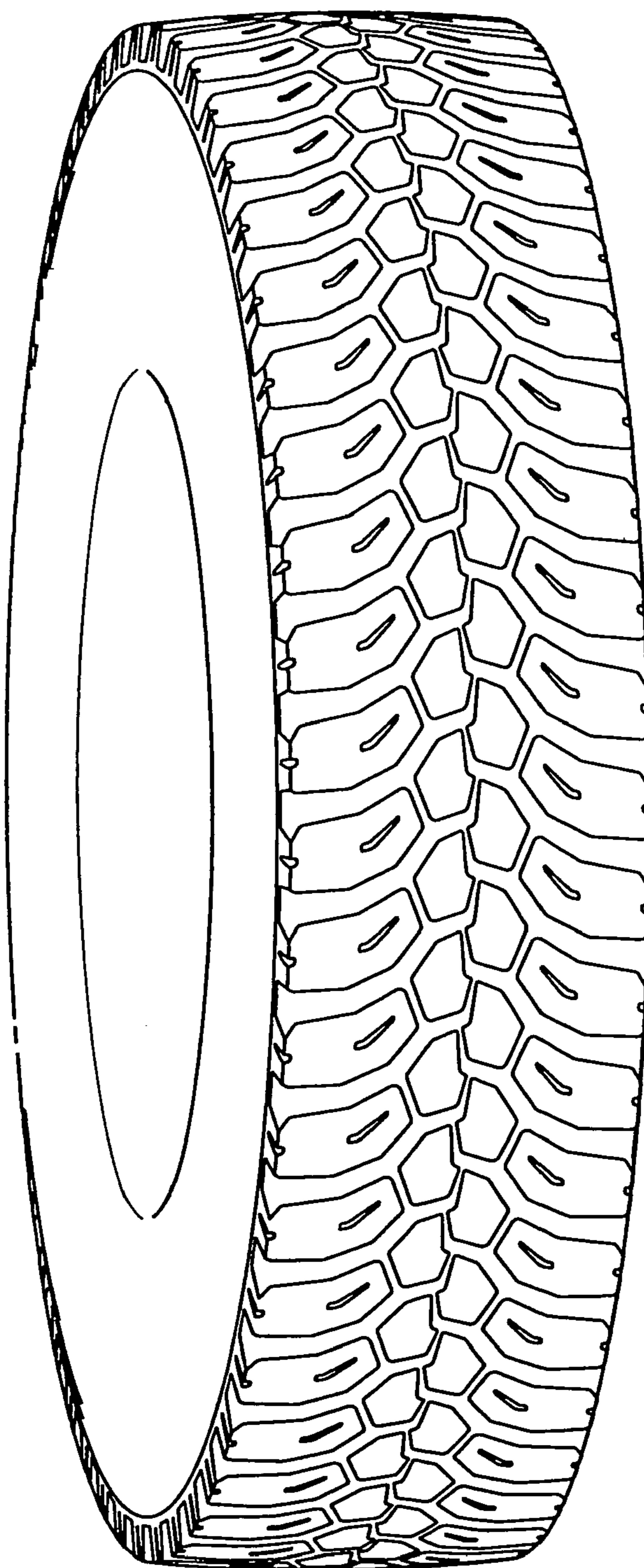

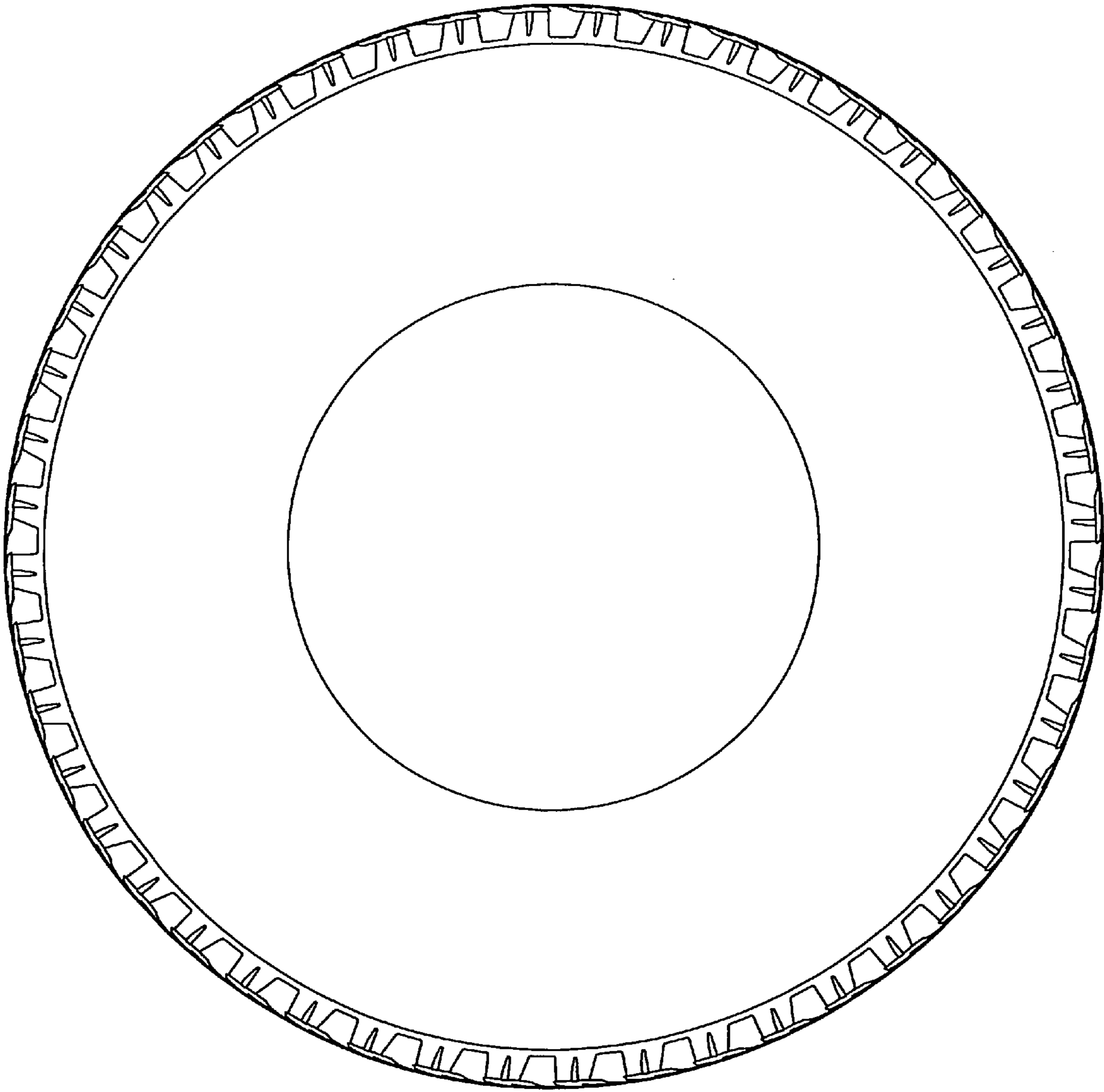

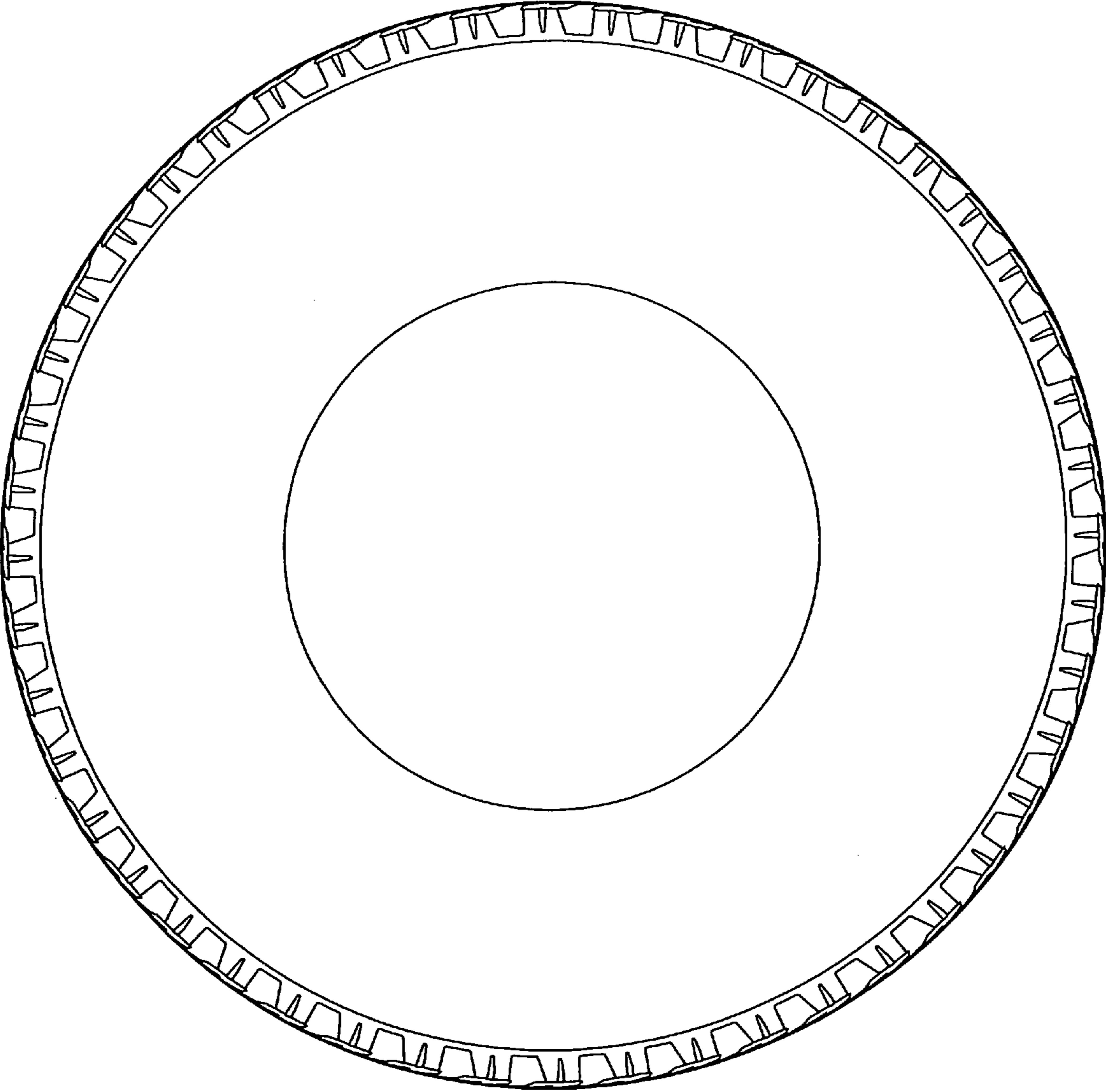

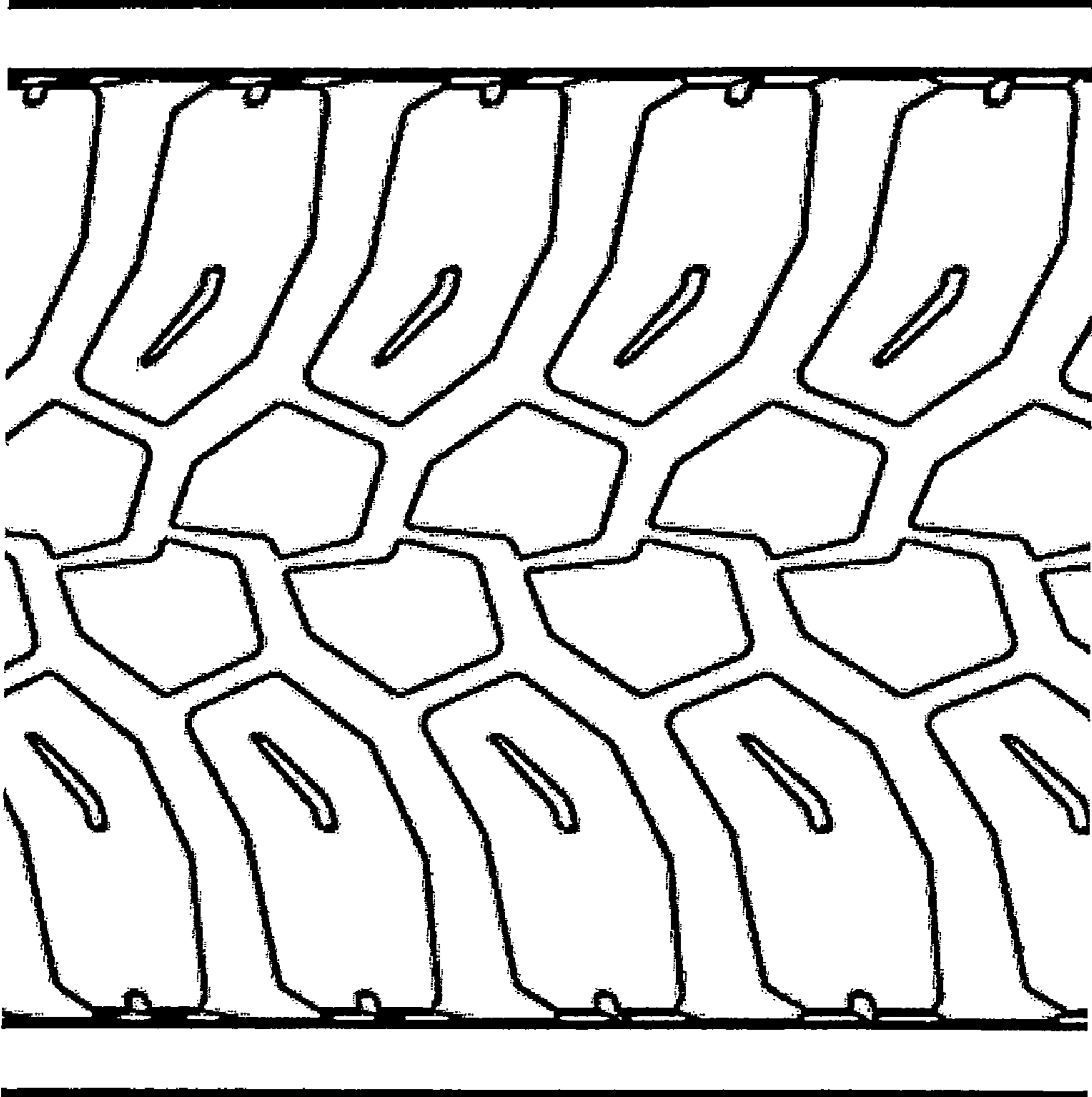
