DESCRIPTION

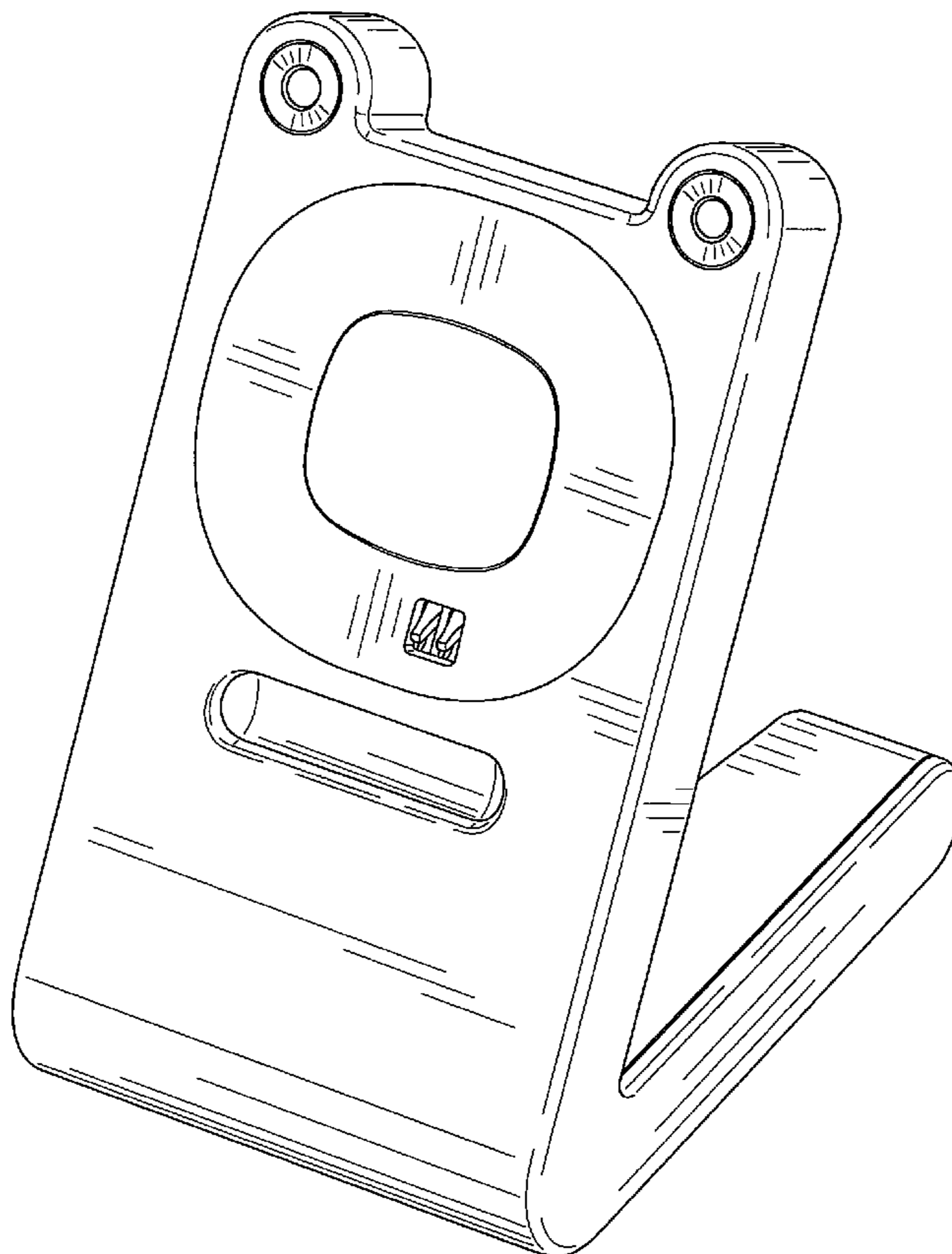
FIG. 1 is a perspective view of a docking station showing my new design;

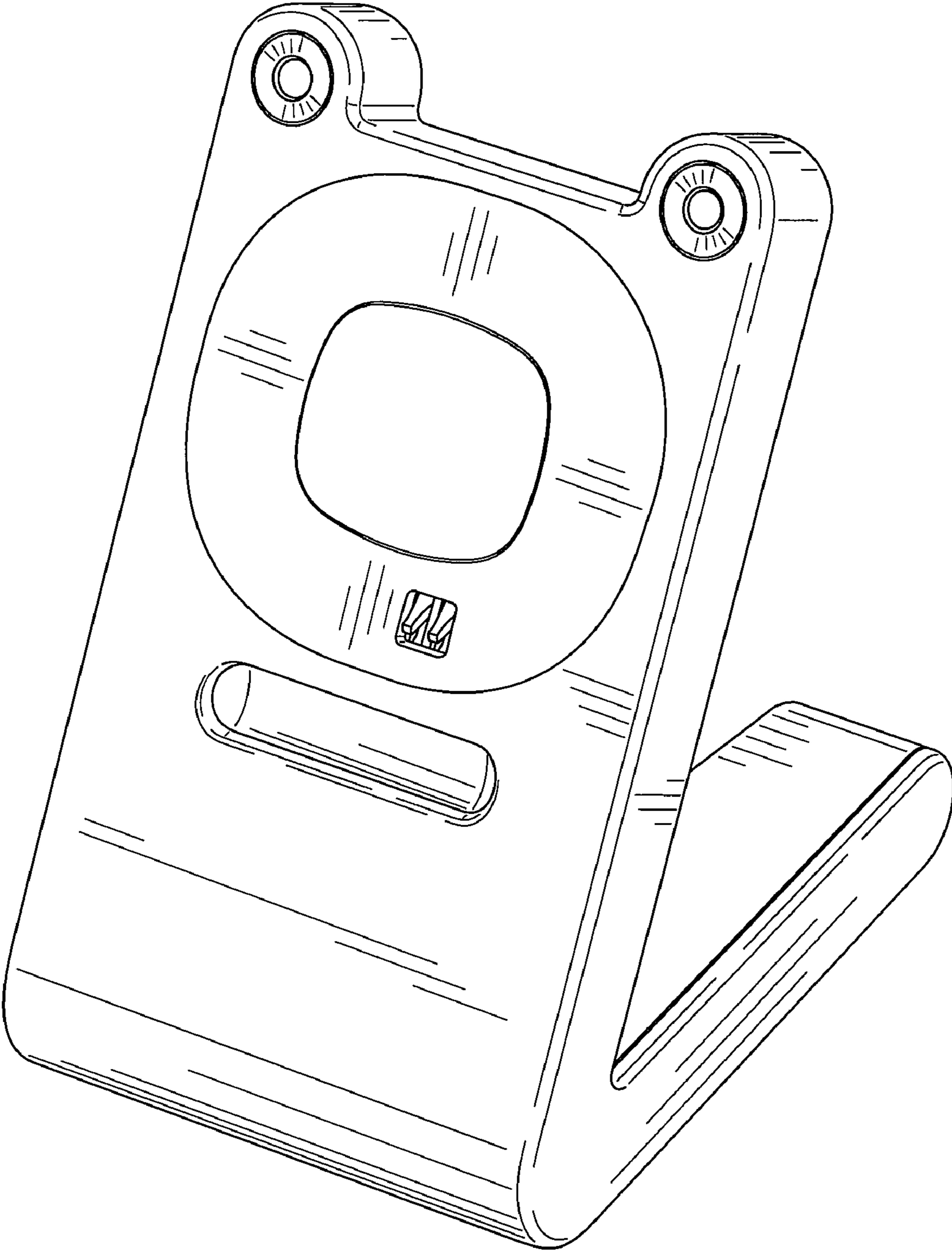

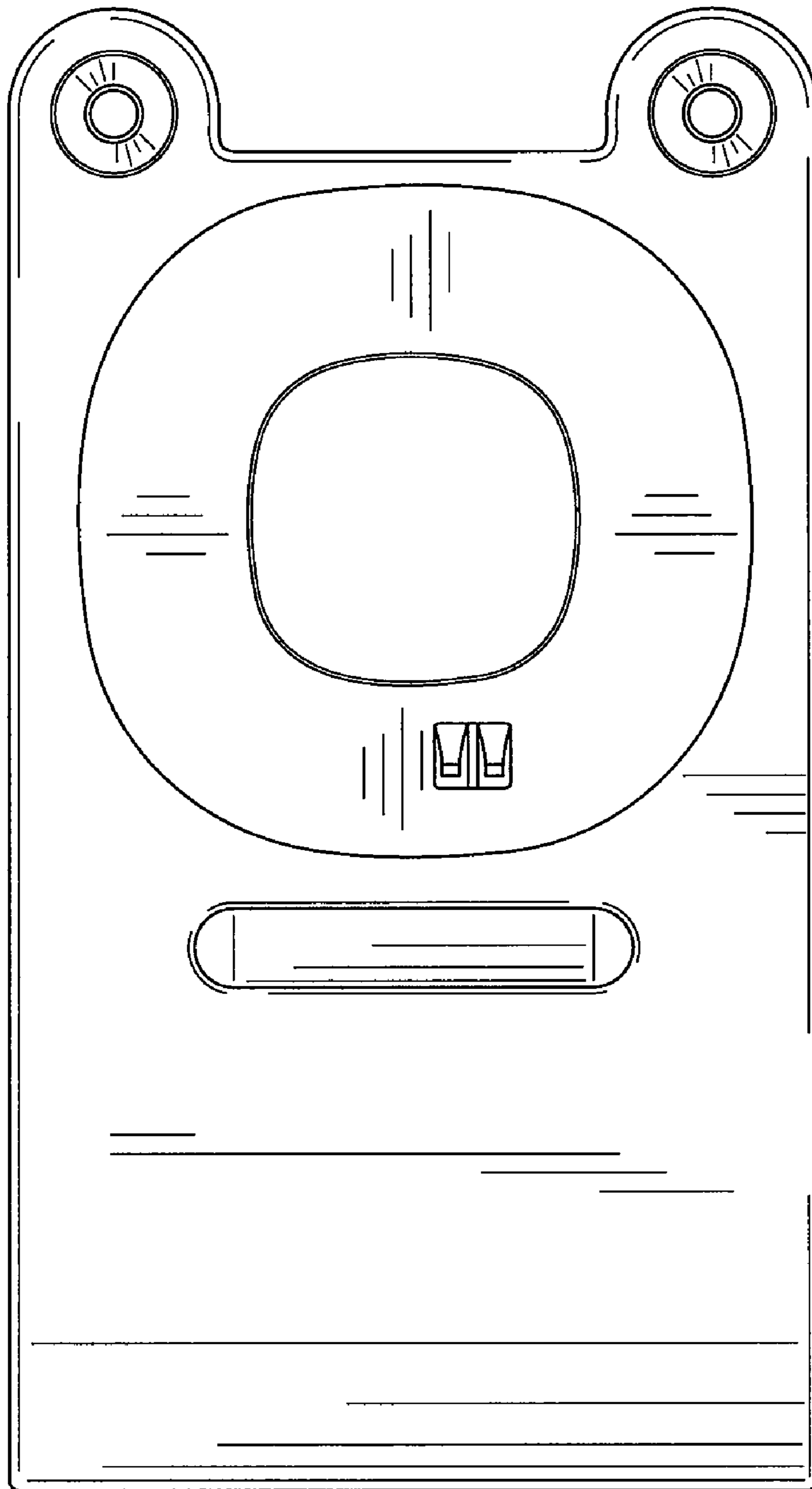

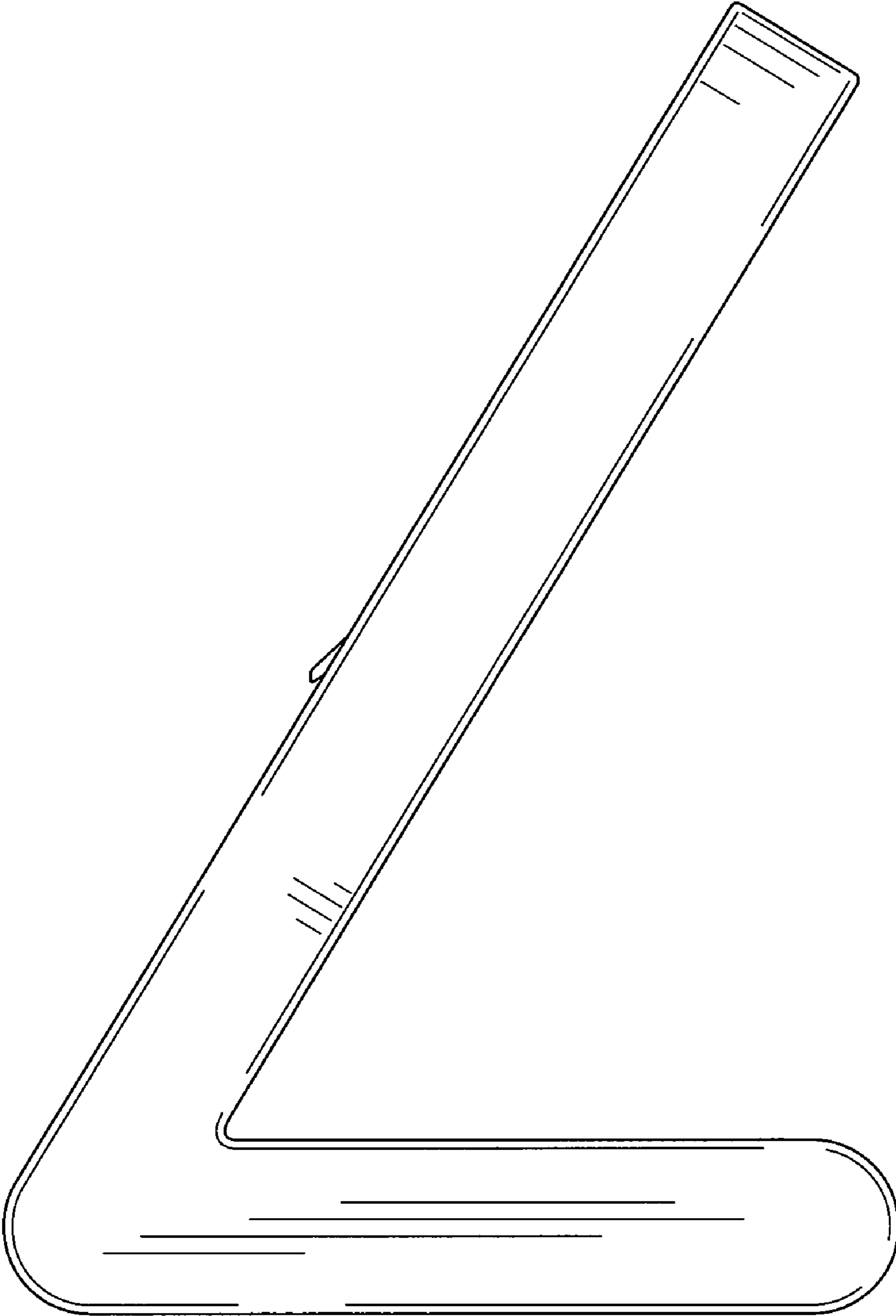

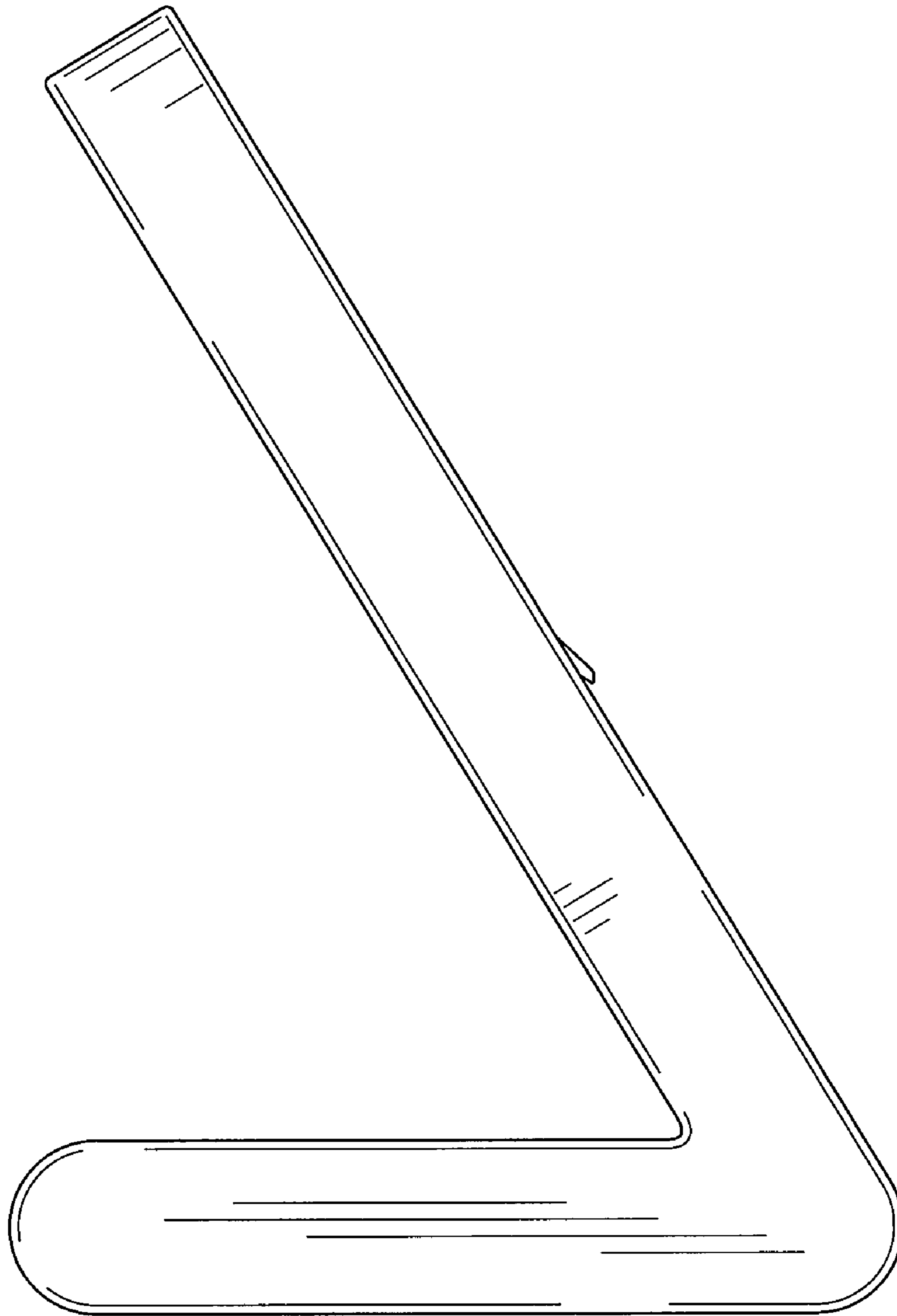
