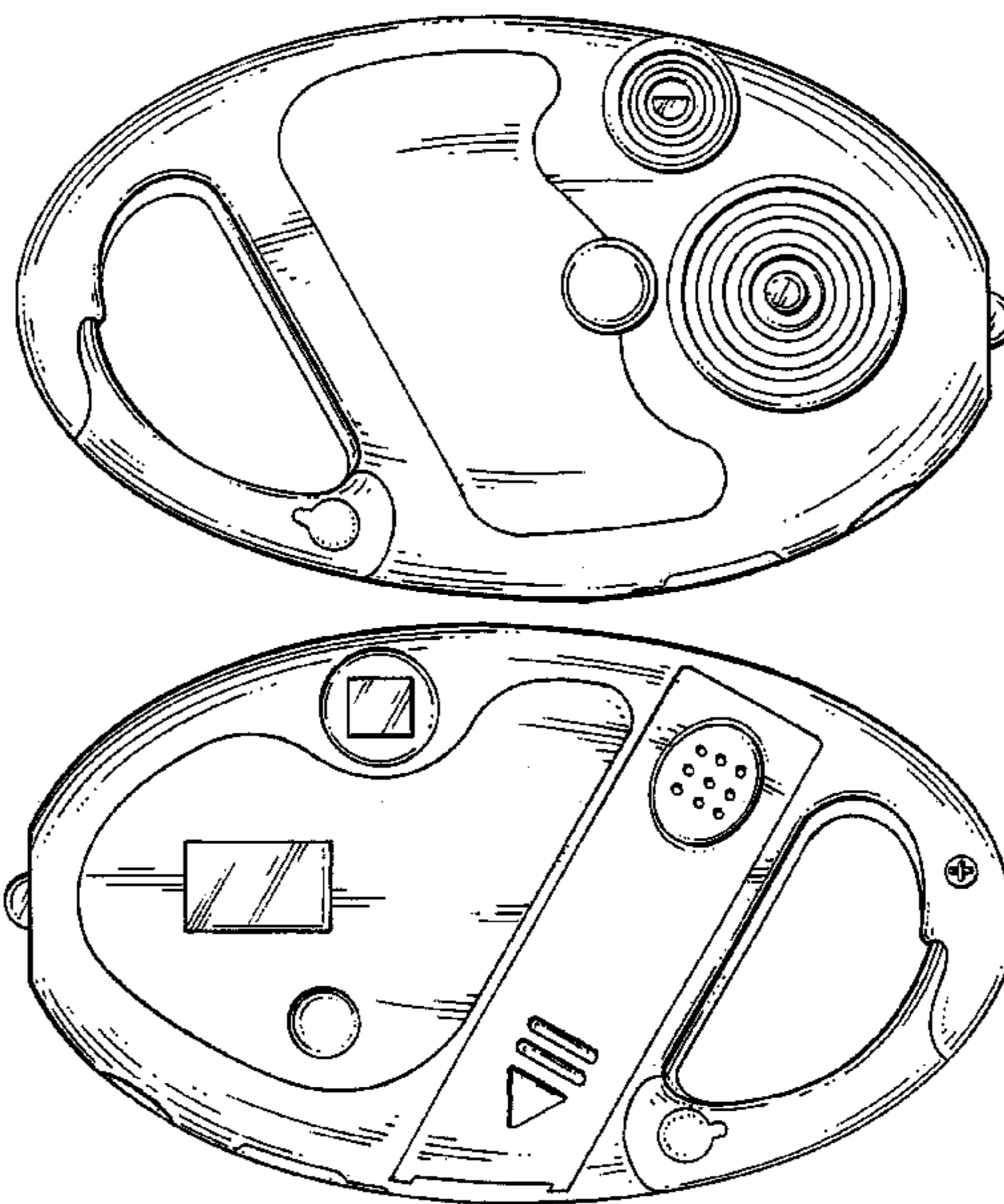

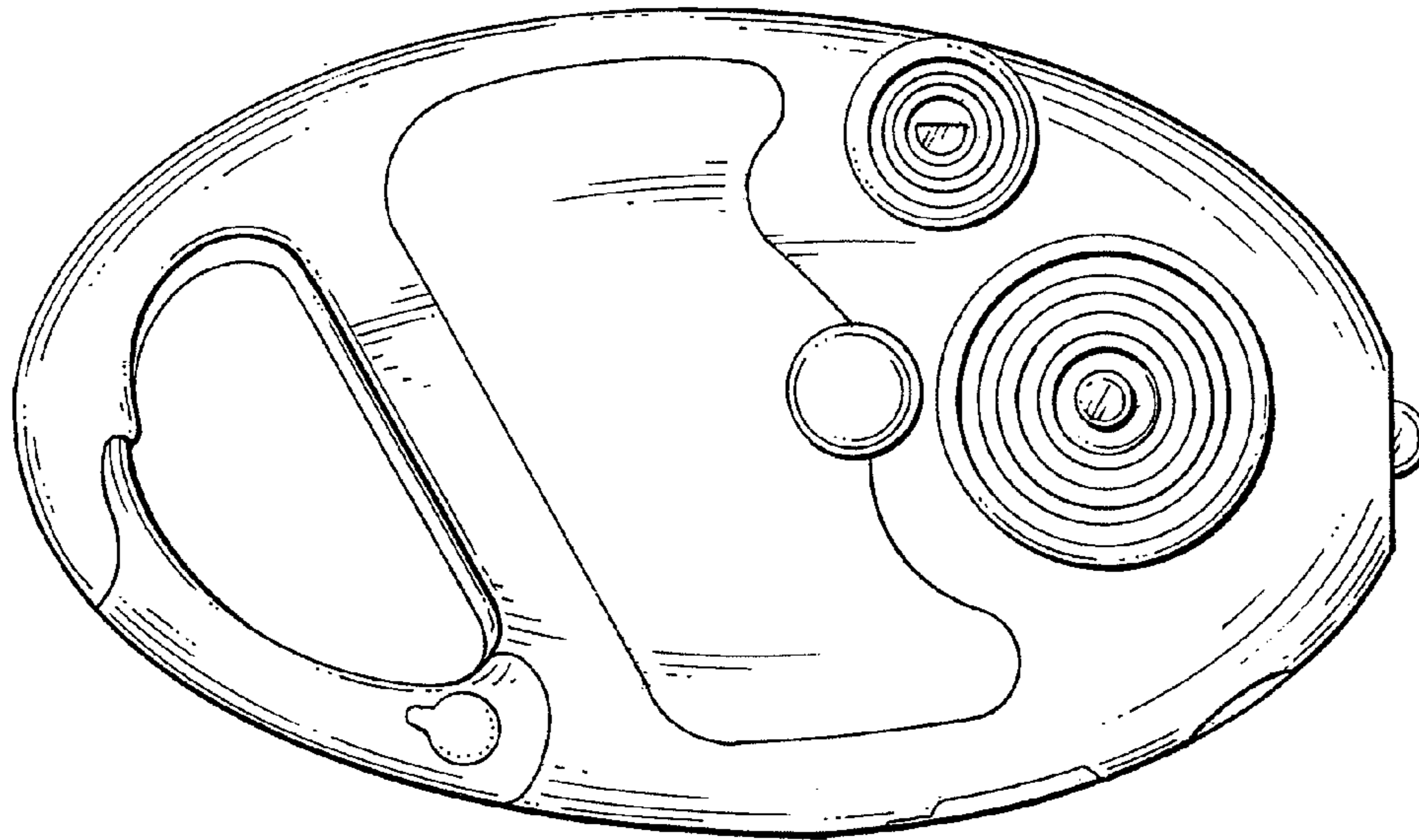
The ornamental design for a camera, as shown and described.

**DESCRIPTION**

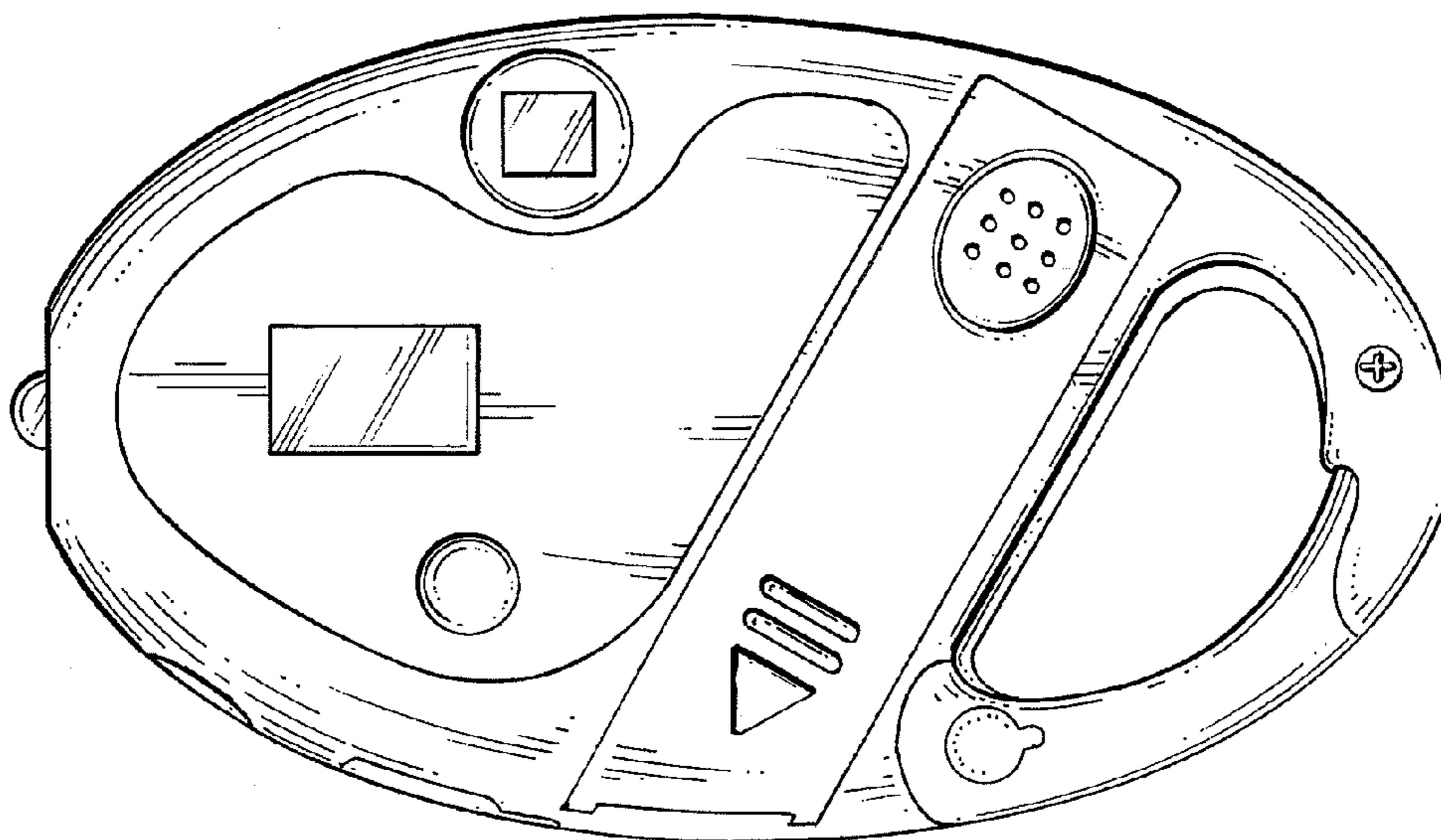
FIG. 1 is a front elevational view of a camera;

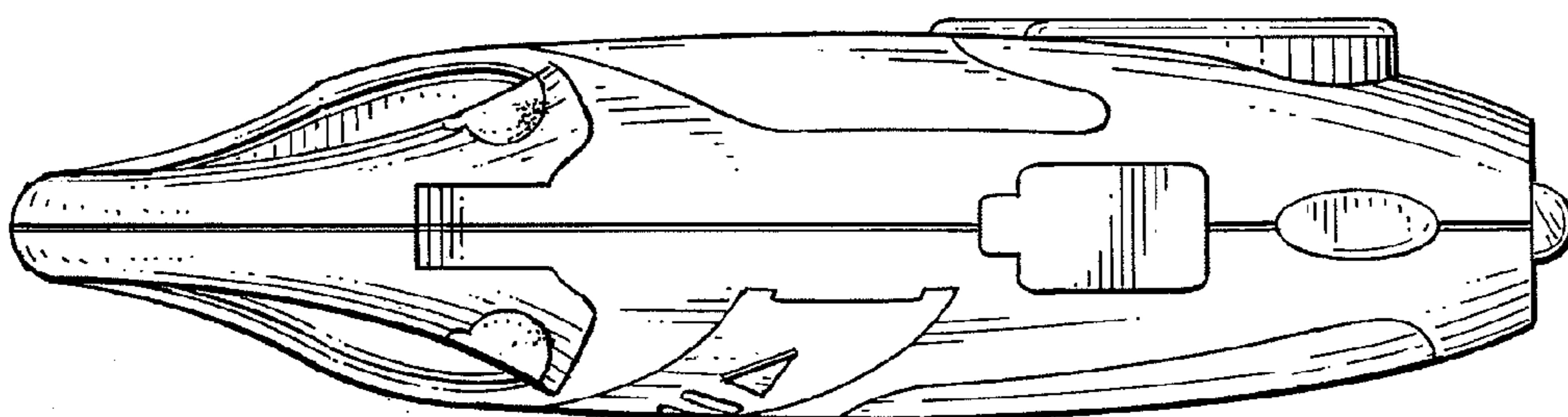




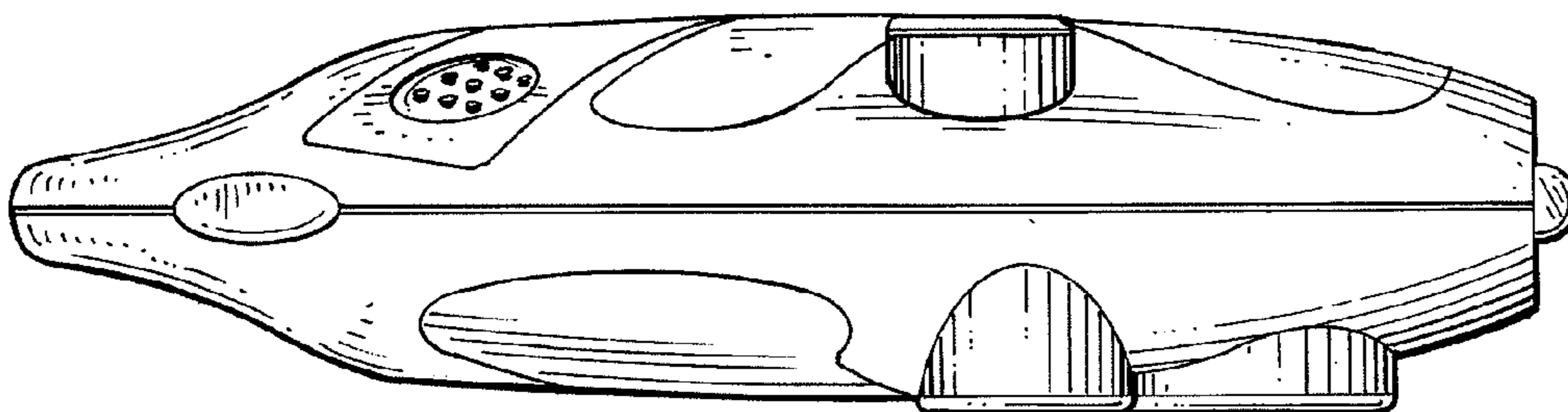

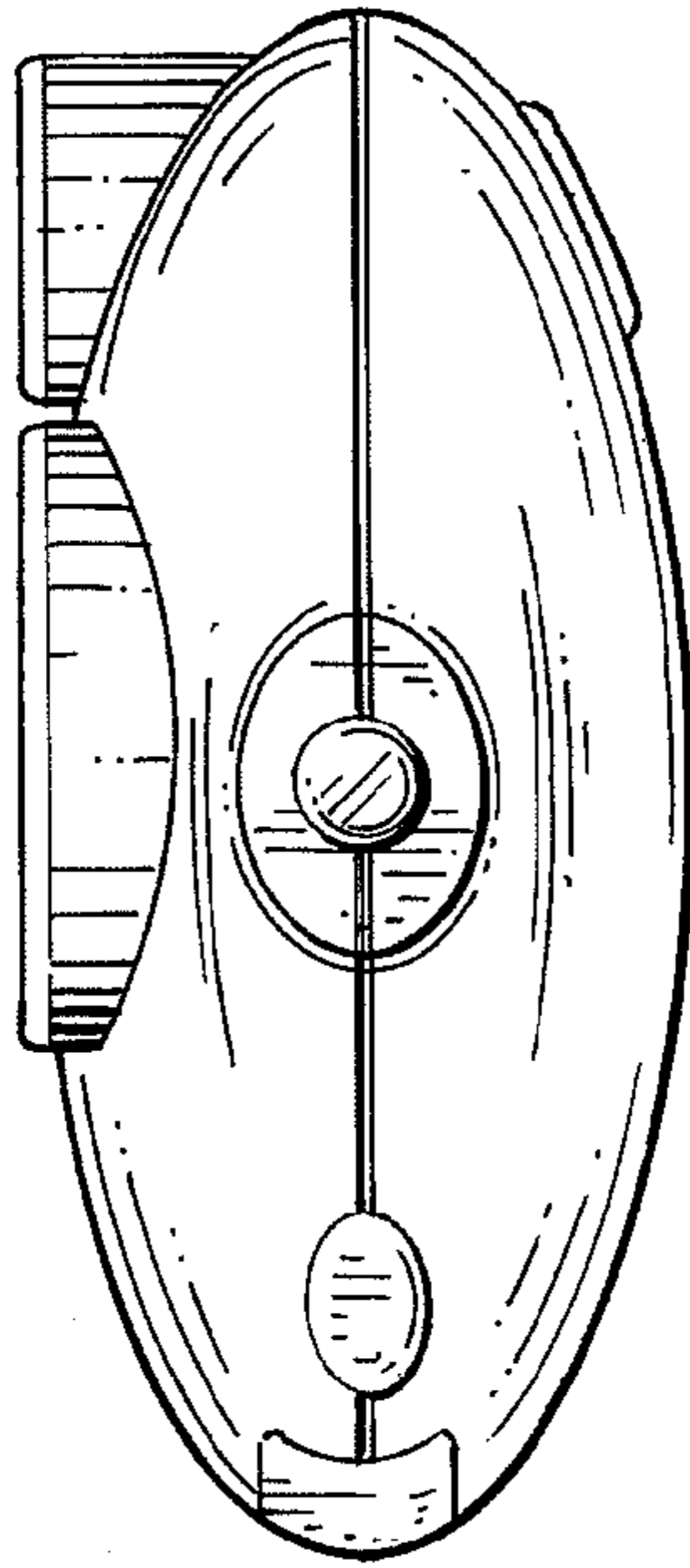

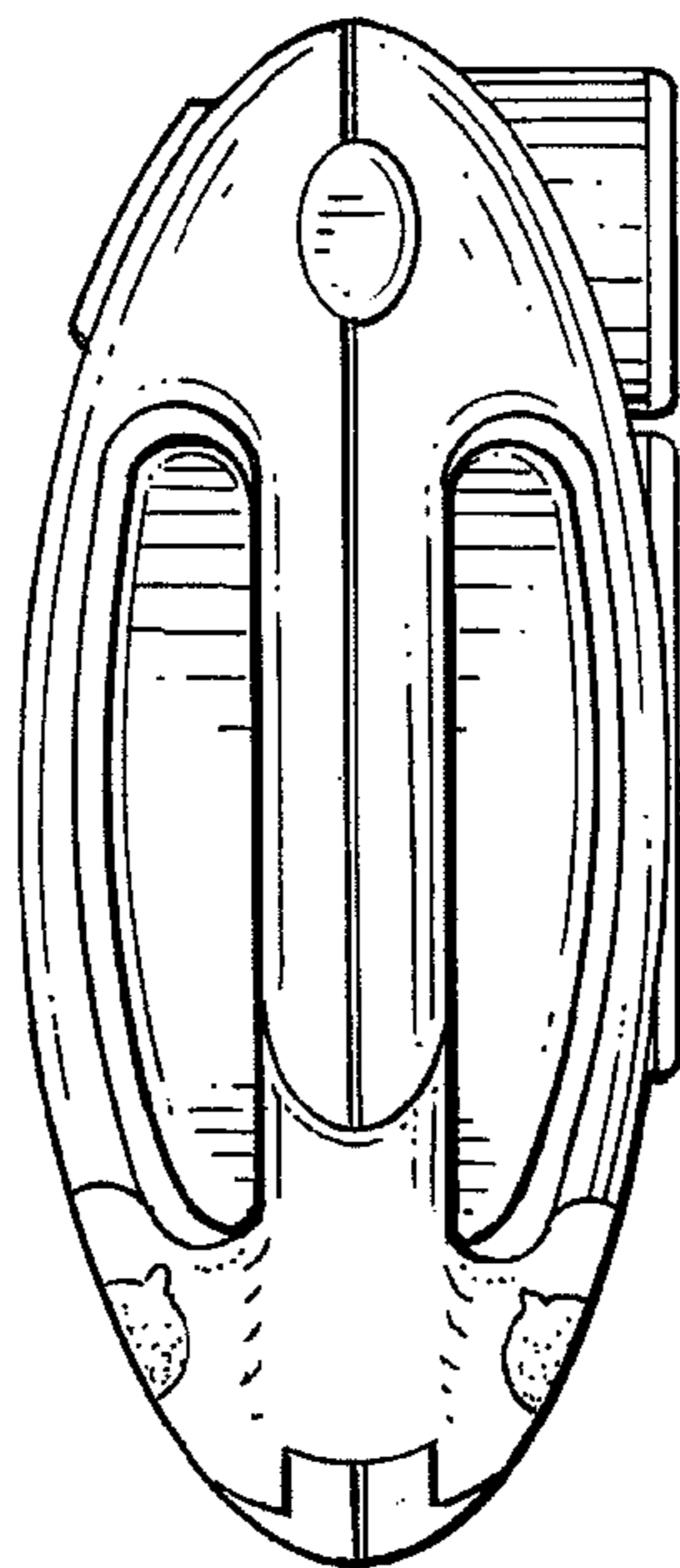
