(57) **CLAIM**

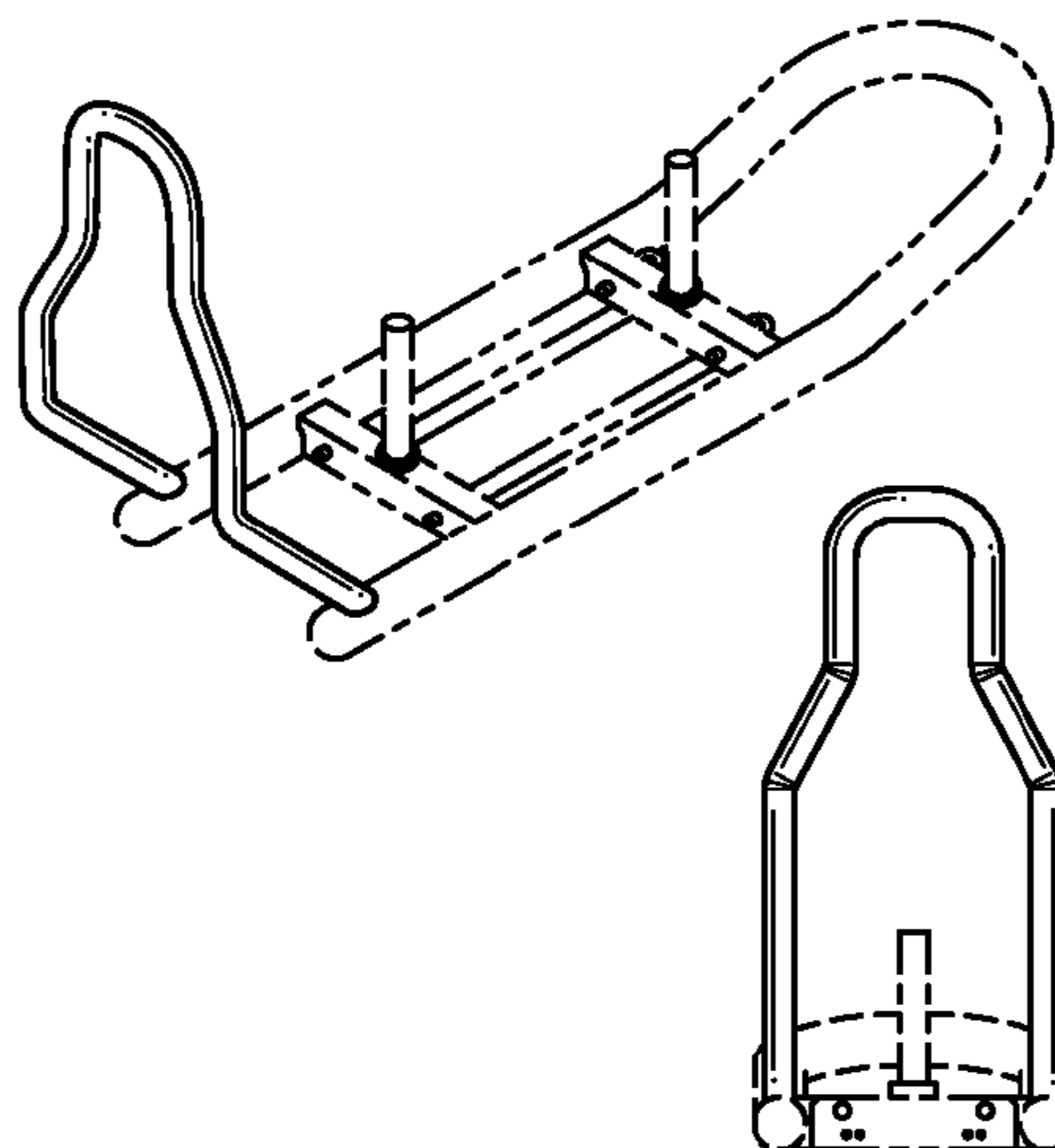
We claim the ornamental design for the drive sled, as shown and described.

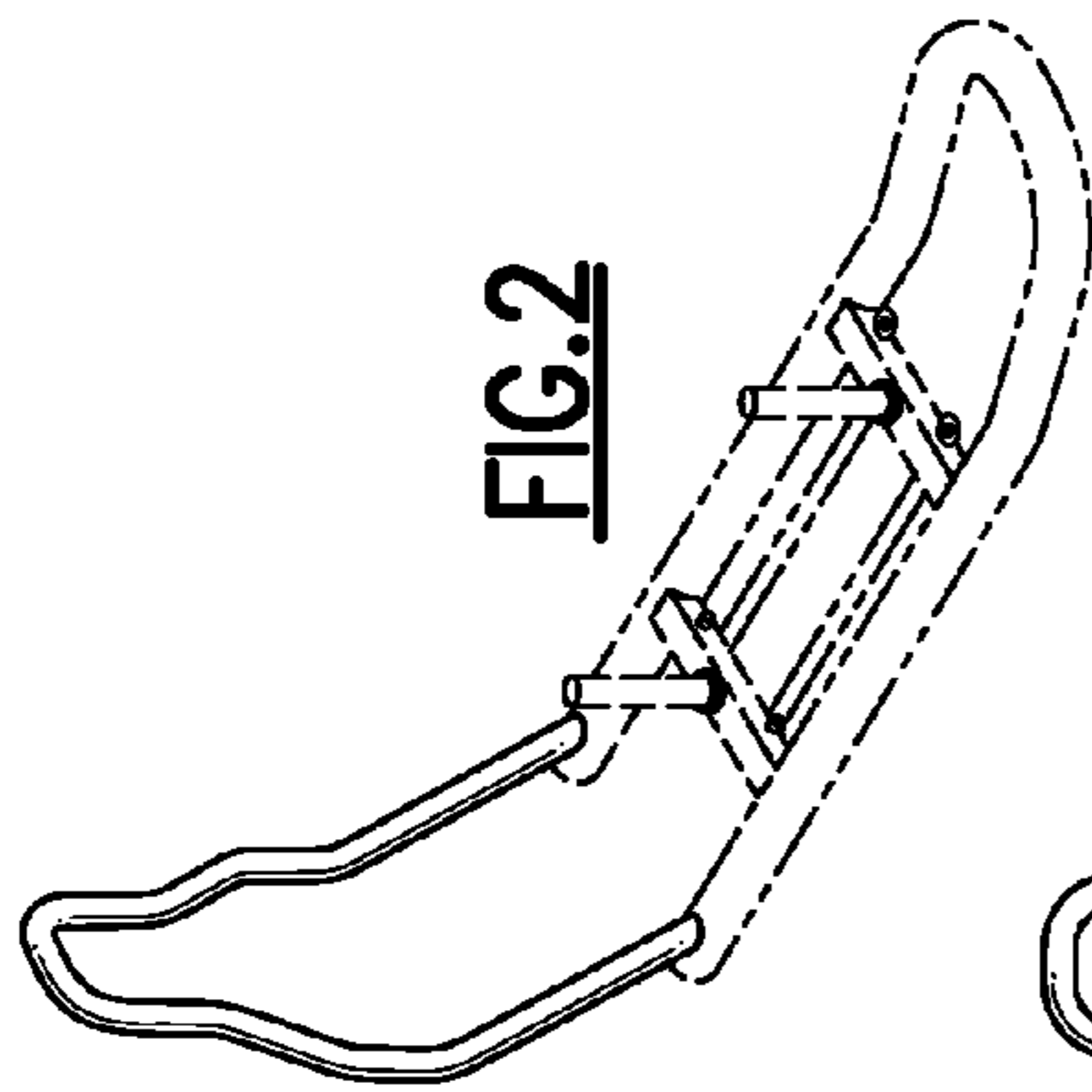
**DESCRIPTION**

- FIG. 1 is a top front right oblique view of the drive sled;
- FIG. 2 is a top rear right oblique view of the drive sled;
- FIG. 3 is a bottom front right oblique perspective view of the drive sled;
- FIG. 4 is a bottom rear right oblique perspective view of the drive sled;
- FIG. 5 is a side view of the drive sled;
- FIG. 6 is a top view of the drive sled;
- FIG. 7 is a front view of the drive sled;
- FIG. 8 is a rear view of the drive sled;
- FIG. 9 is a view of the drive sled being used in a pulling exercise; and,
- FIG. 10 is a side view of the drive sled being used in a pushing exercise.

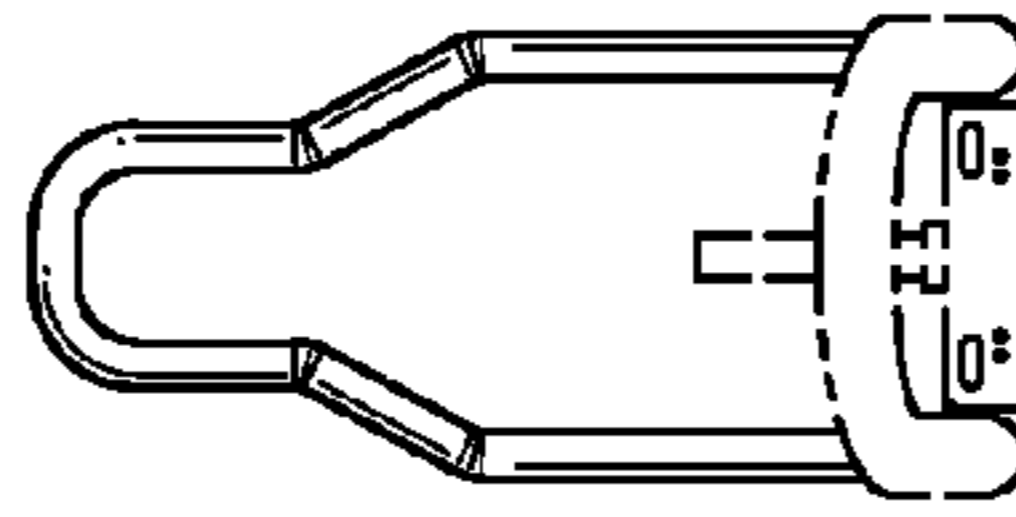
The broken lines are included for the purpose of illustrating portions of the drive sled, users and directional arrows that form no part of the claimed design.

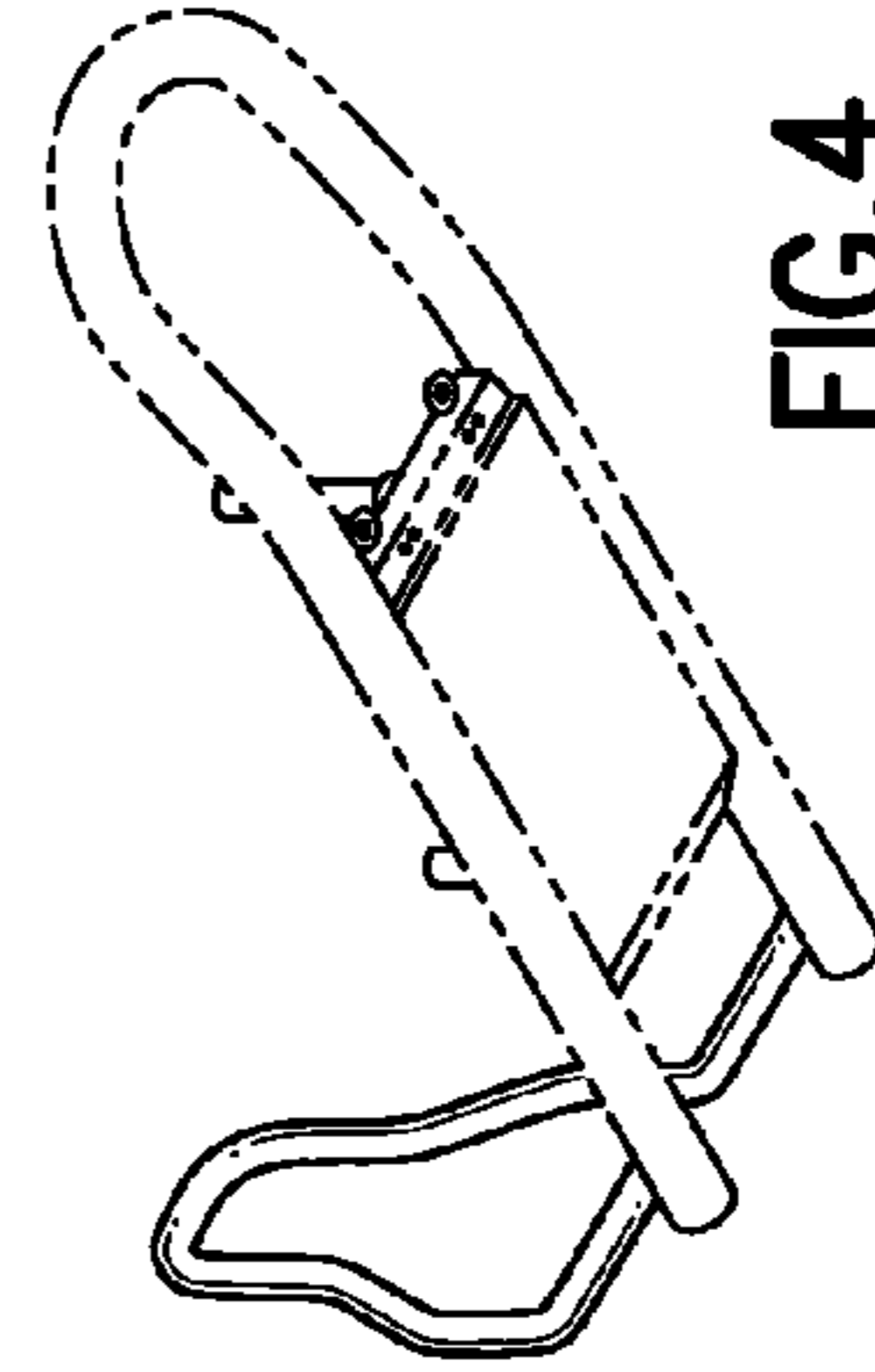




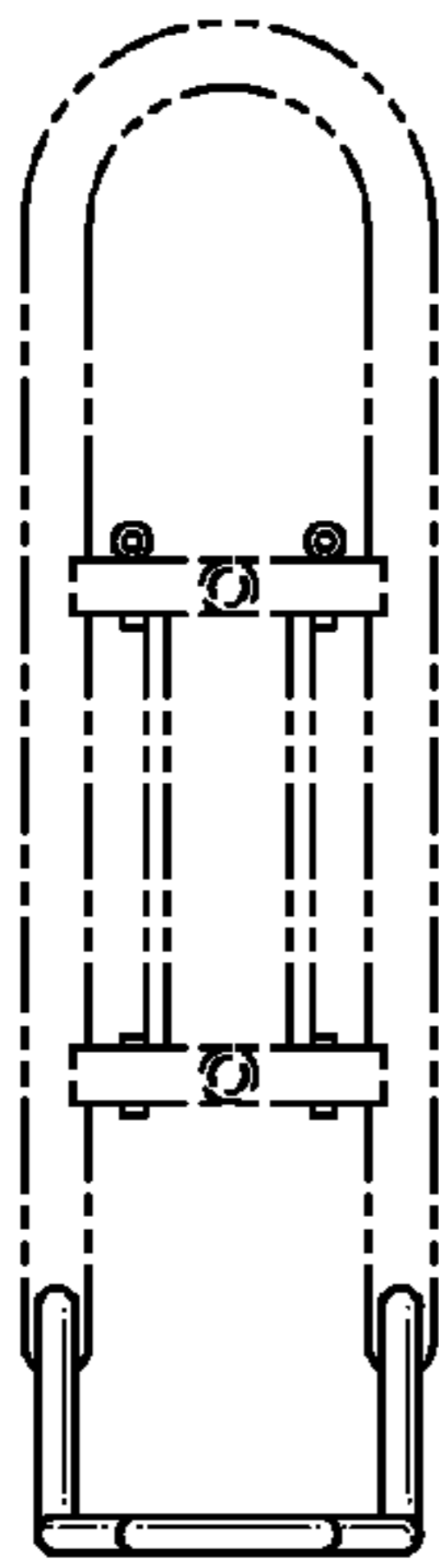

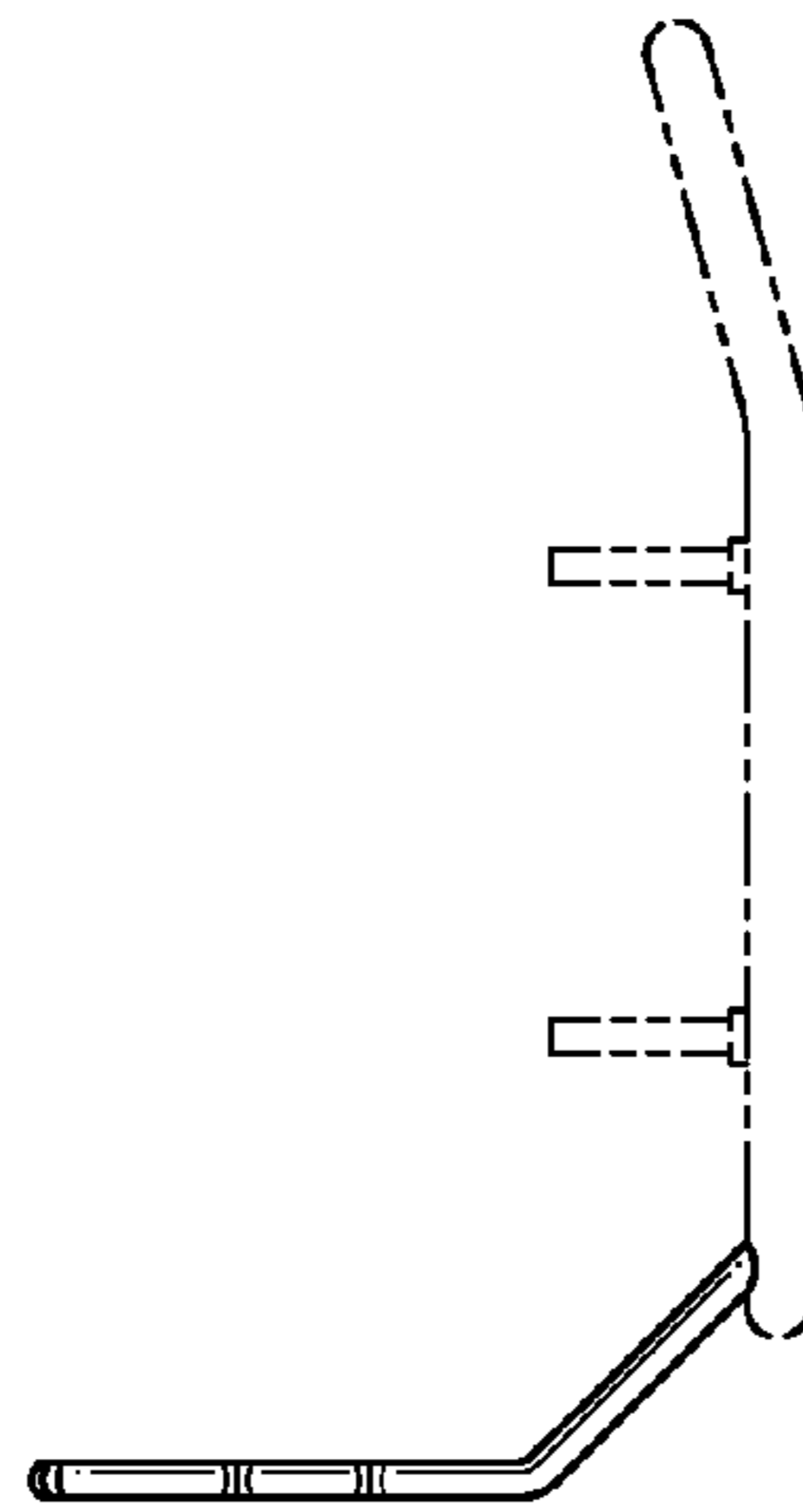

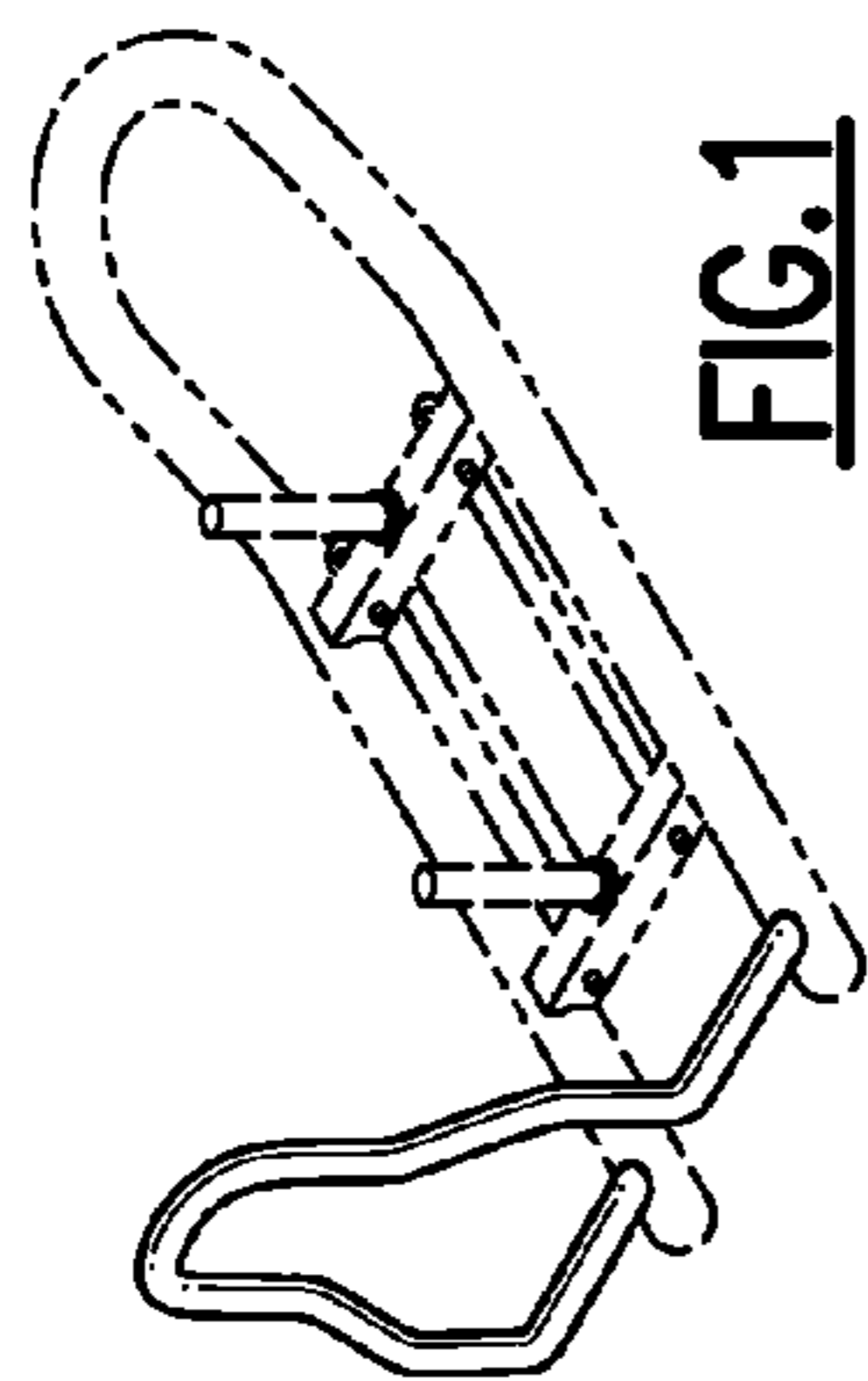

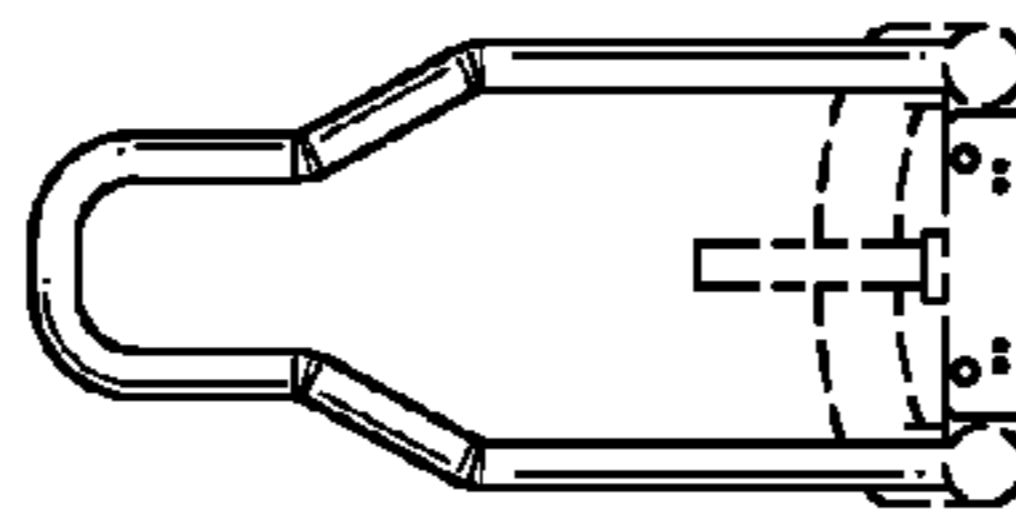

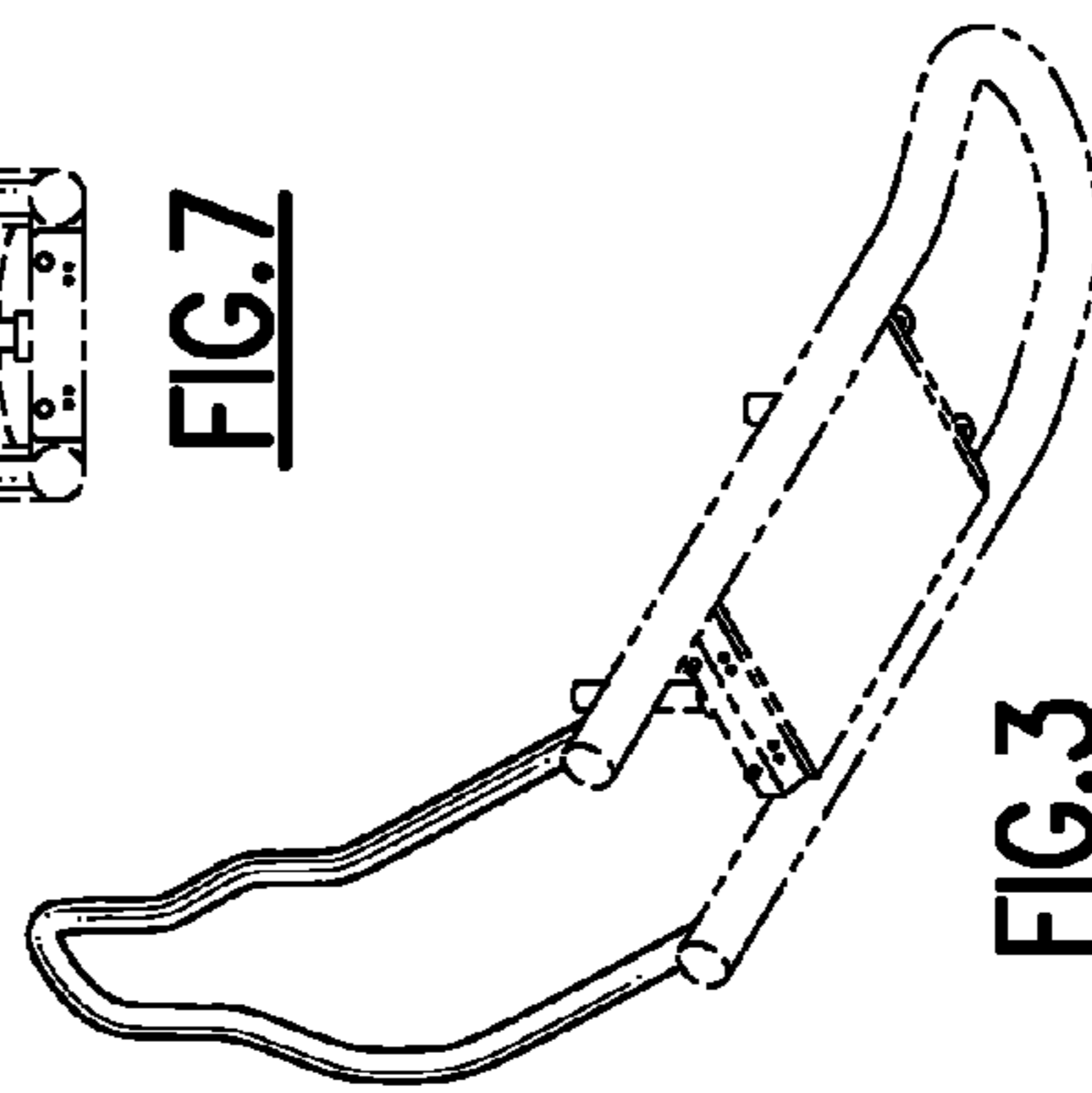

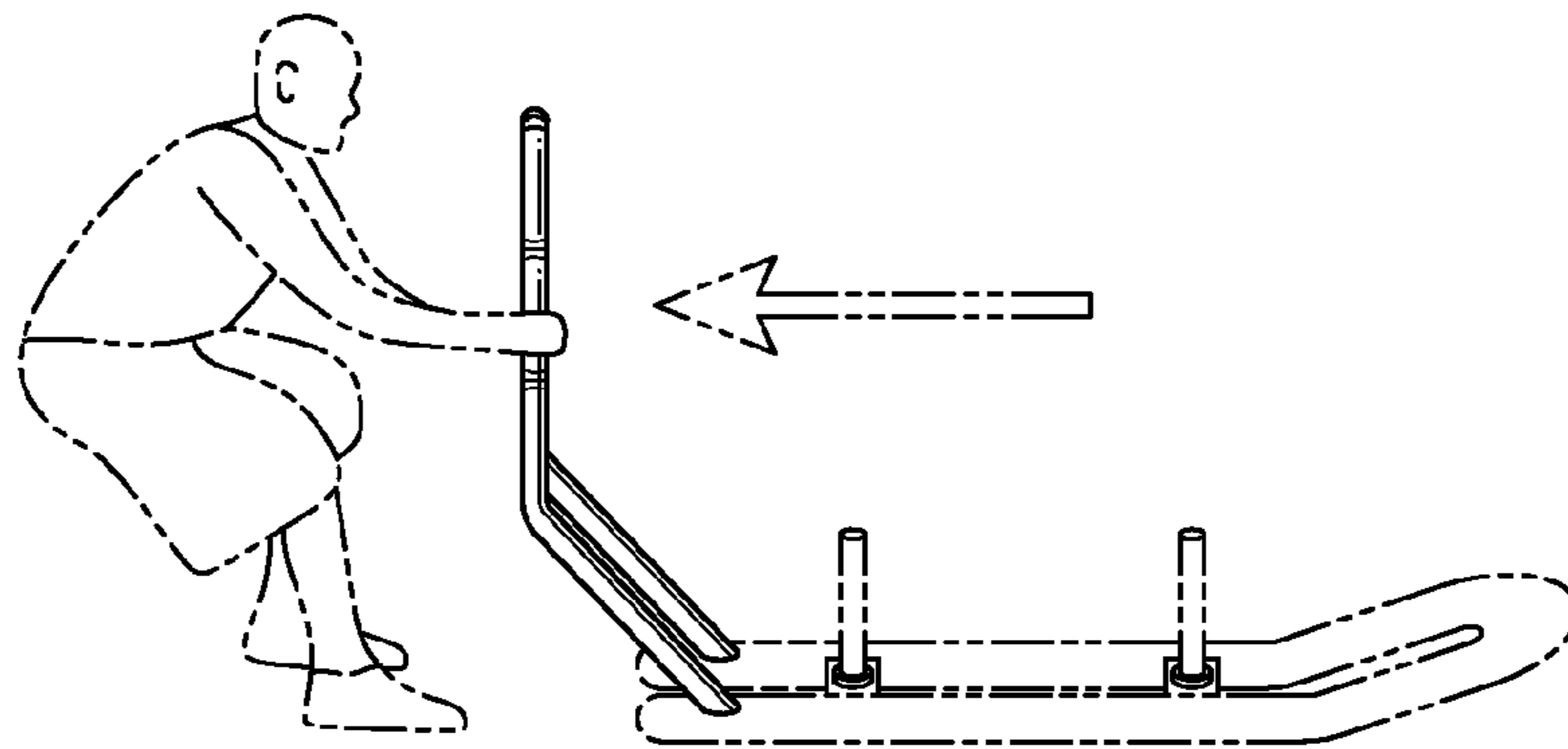

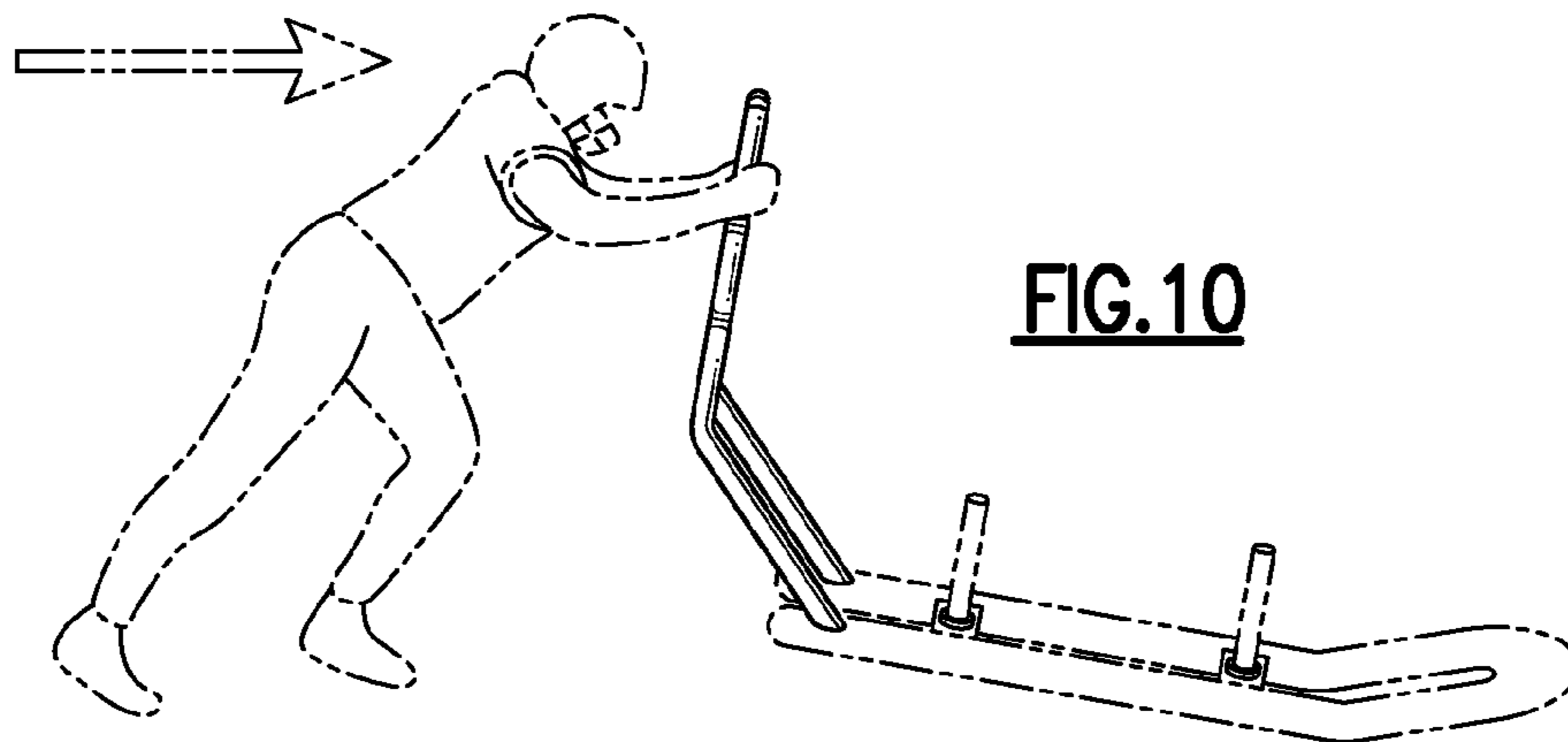
