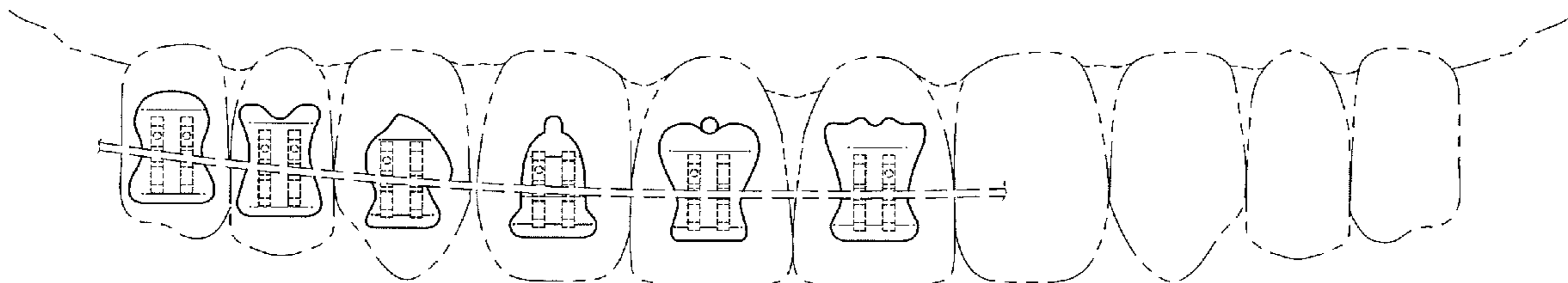


FIG. 22 is a side elevation shown from the left side thereof;

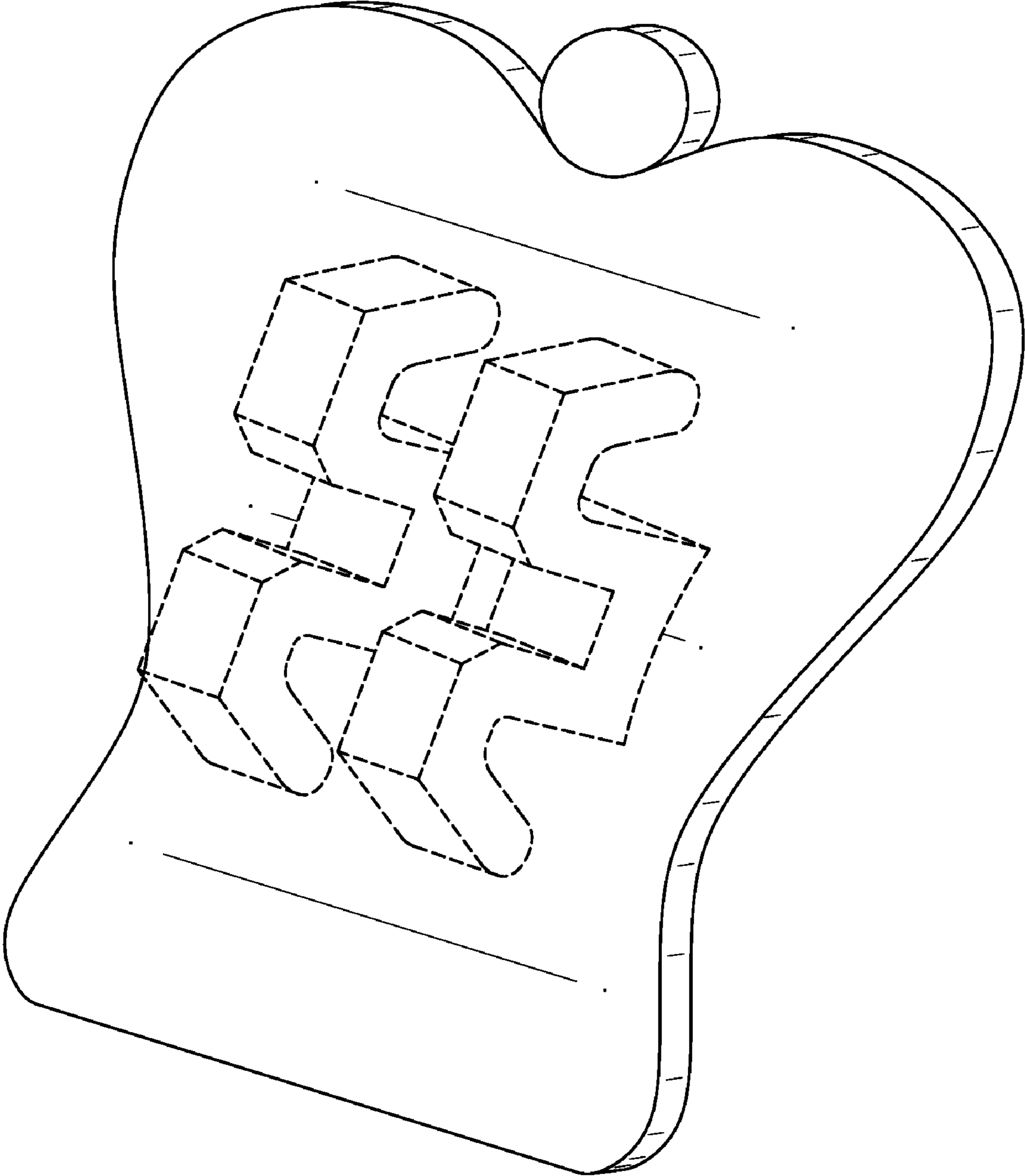

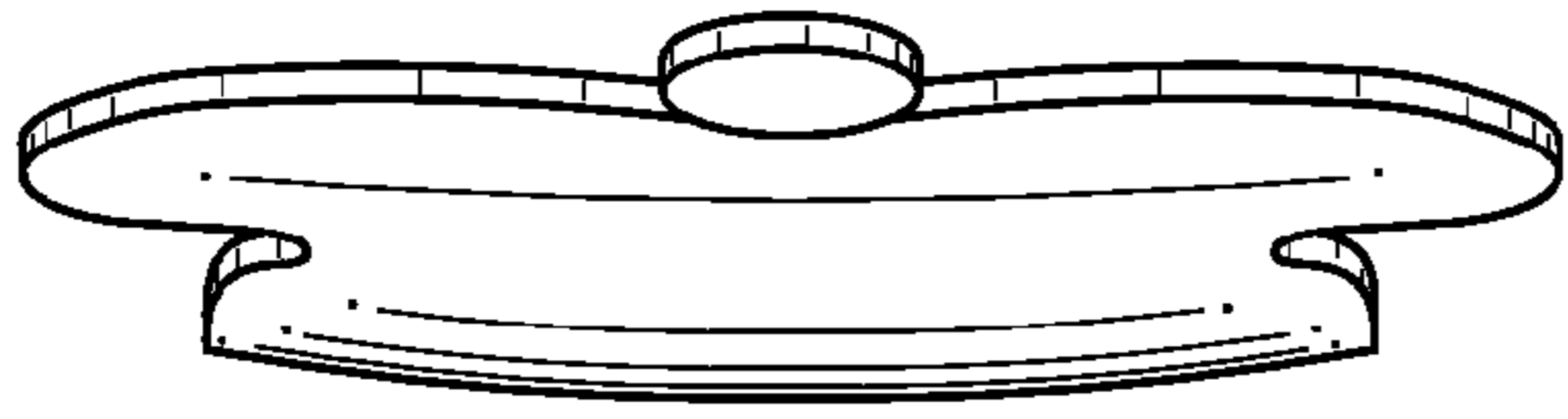

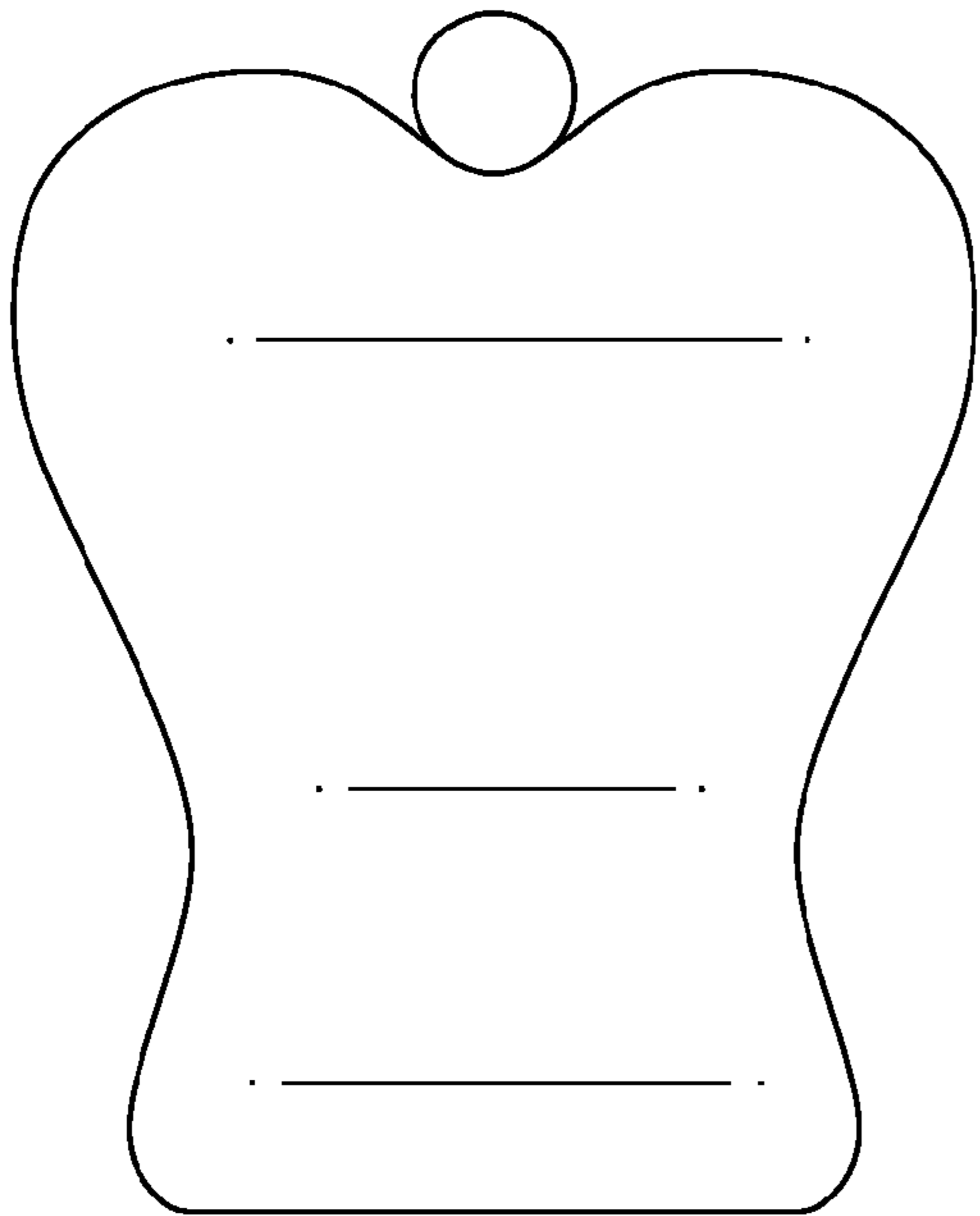

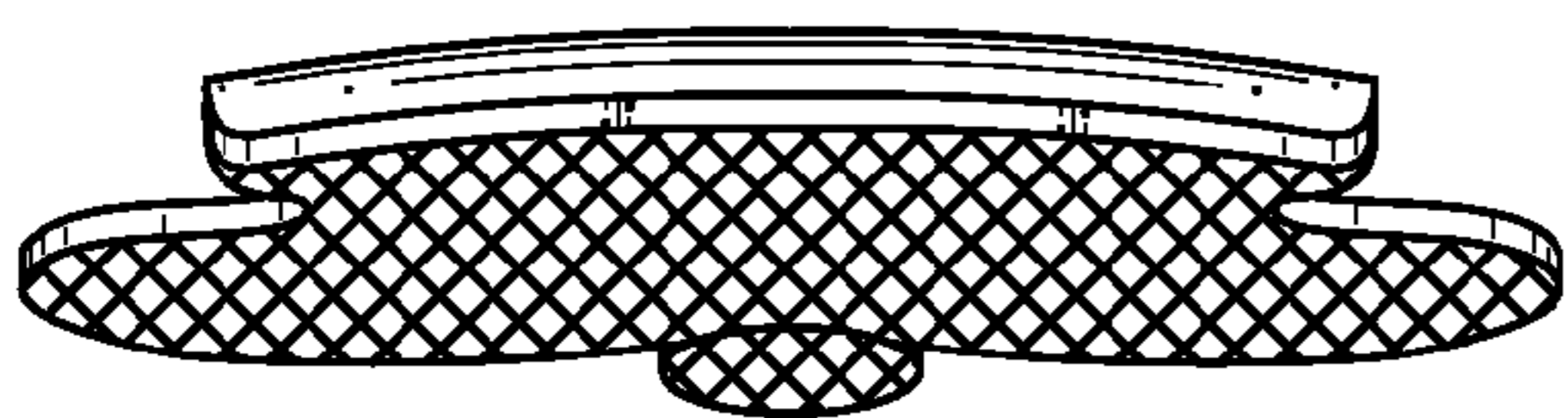

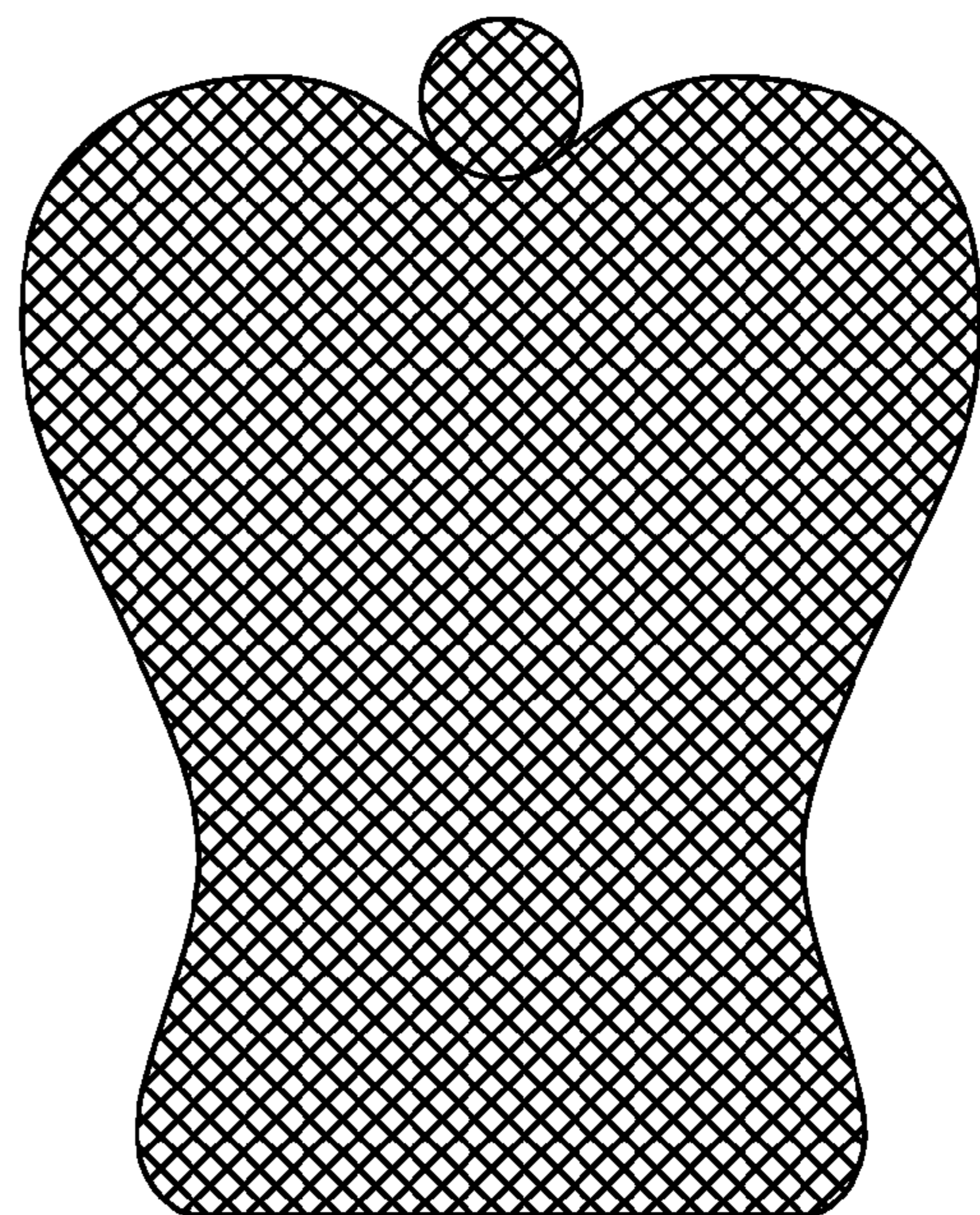

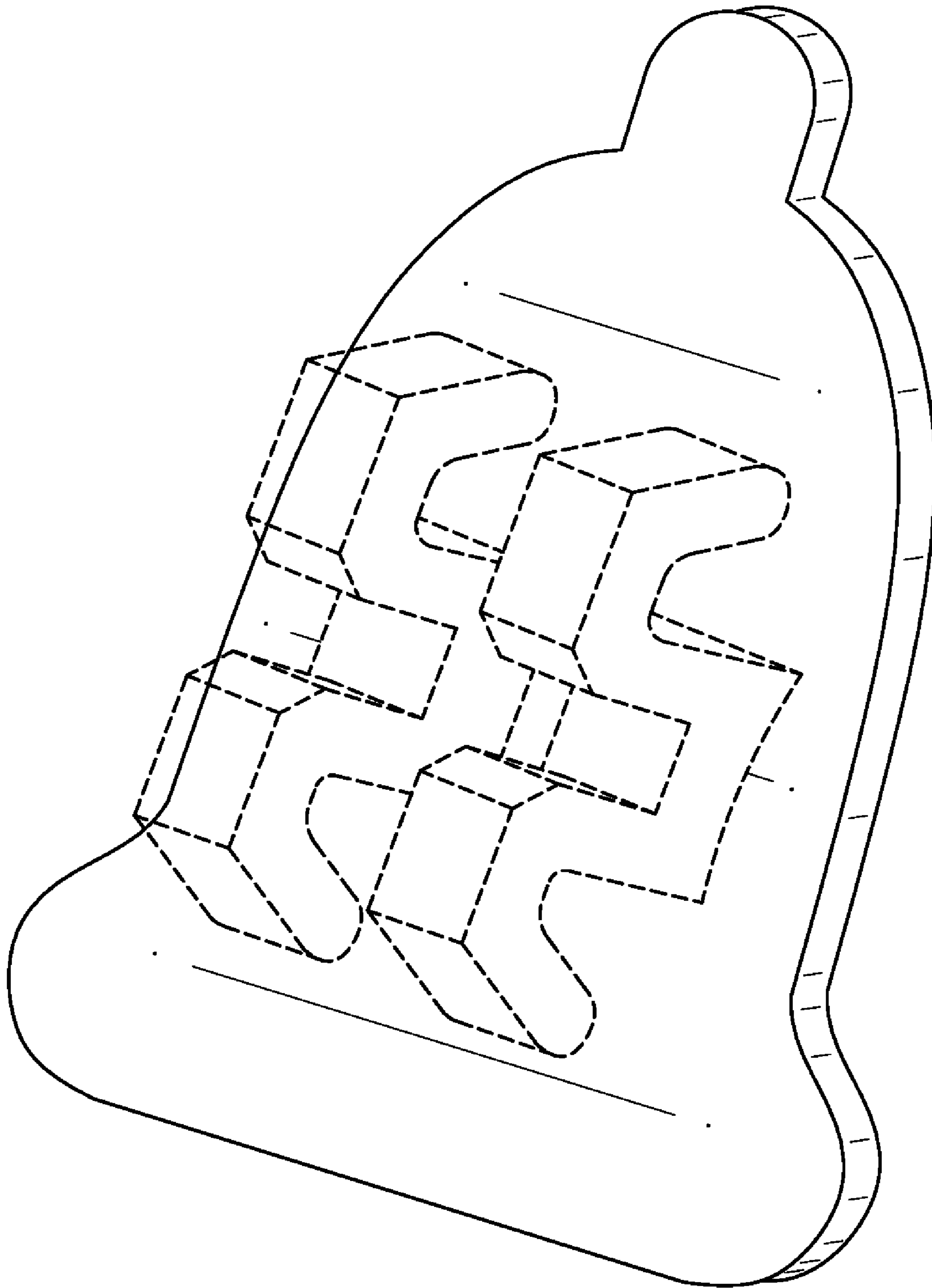

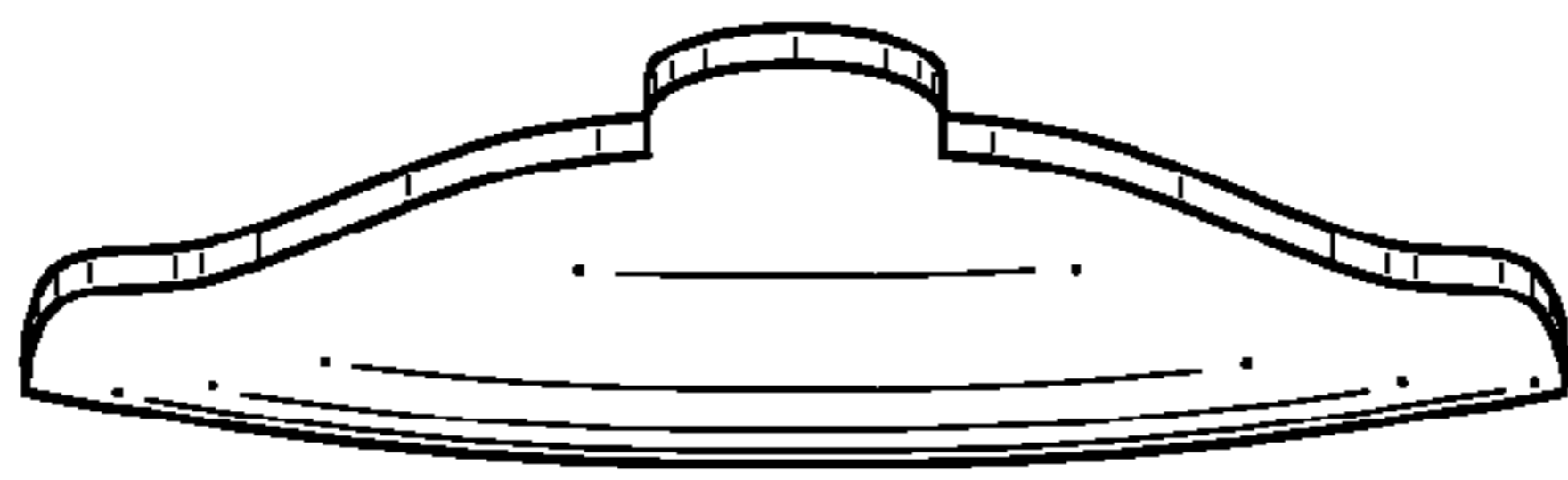

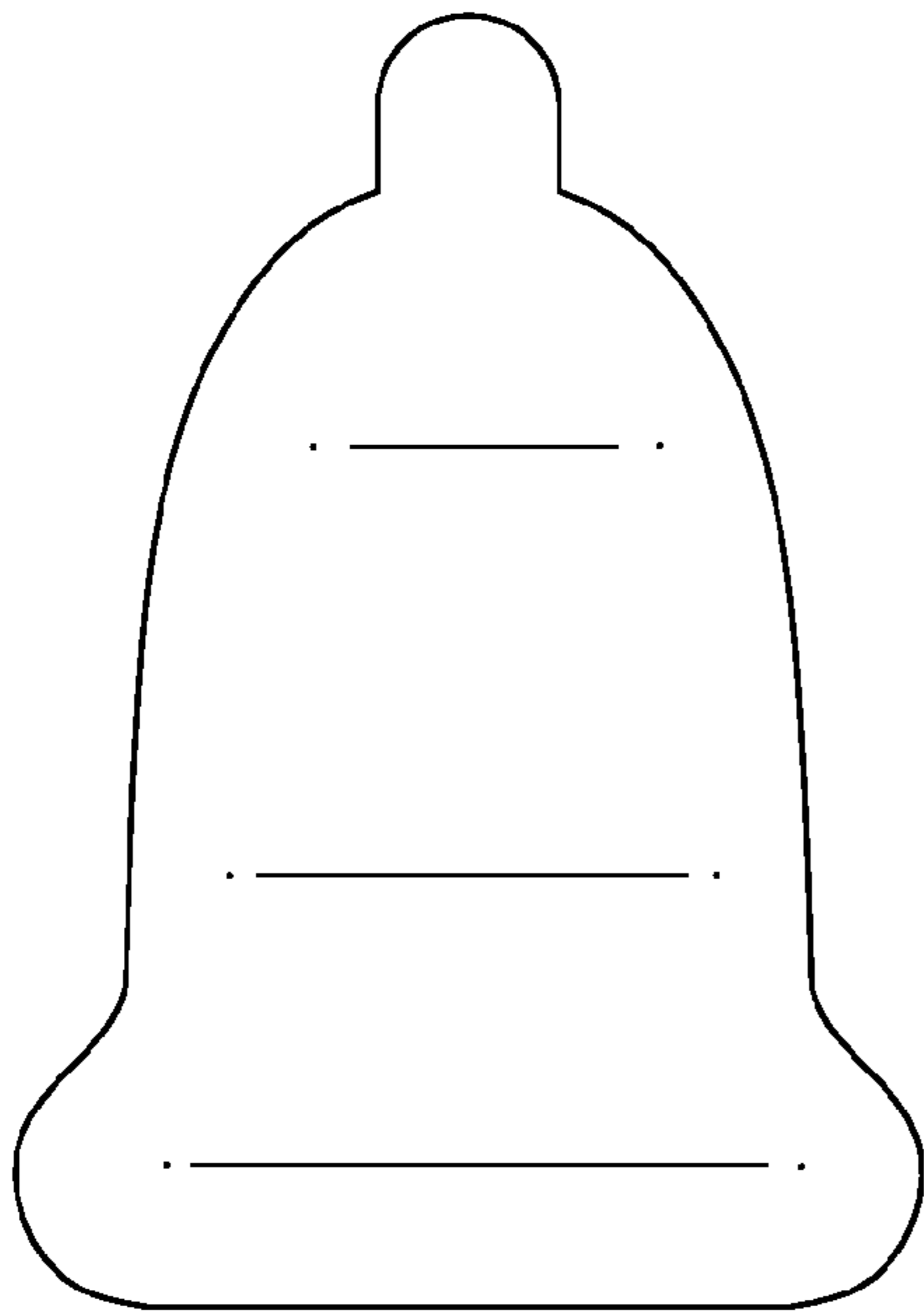

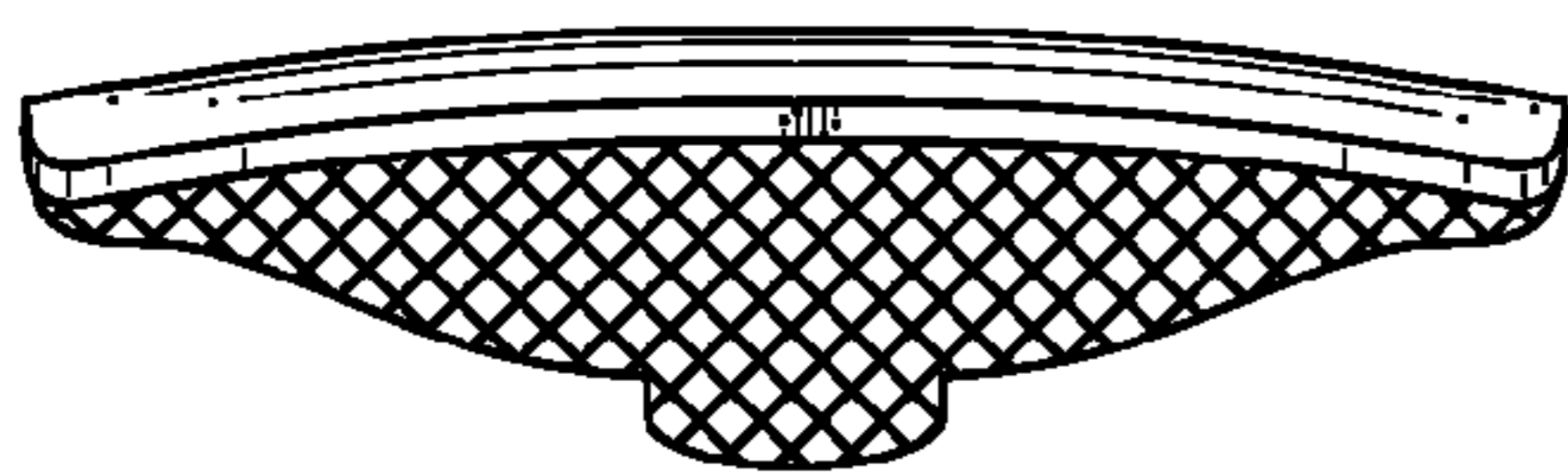

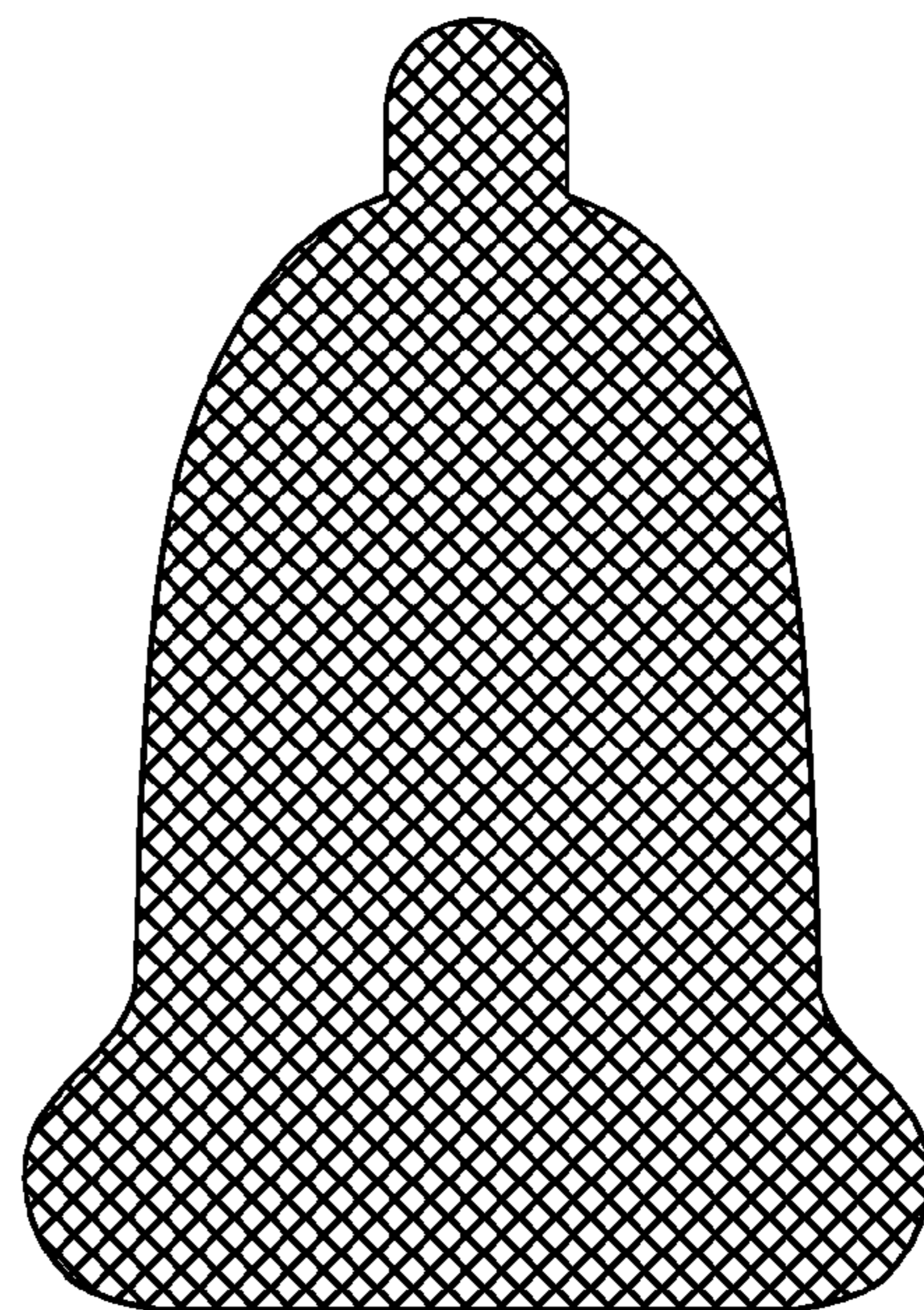

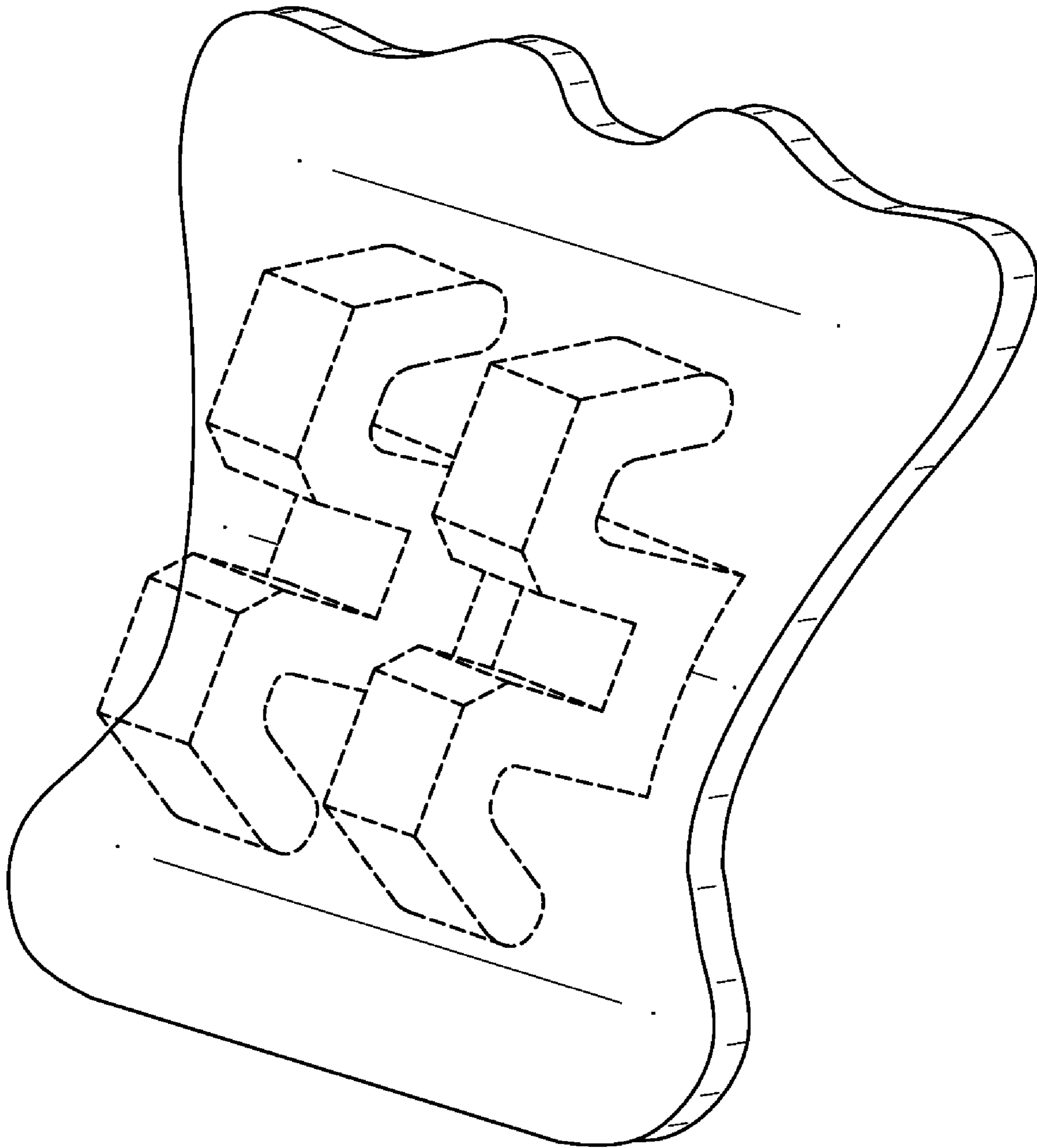

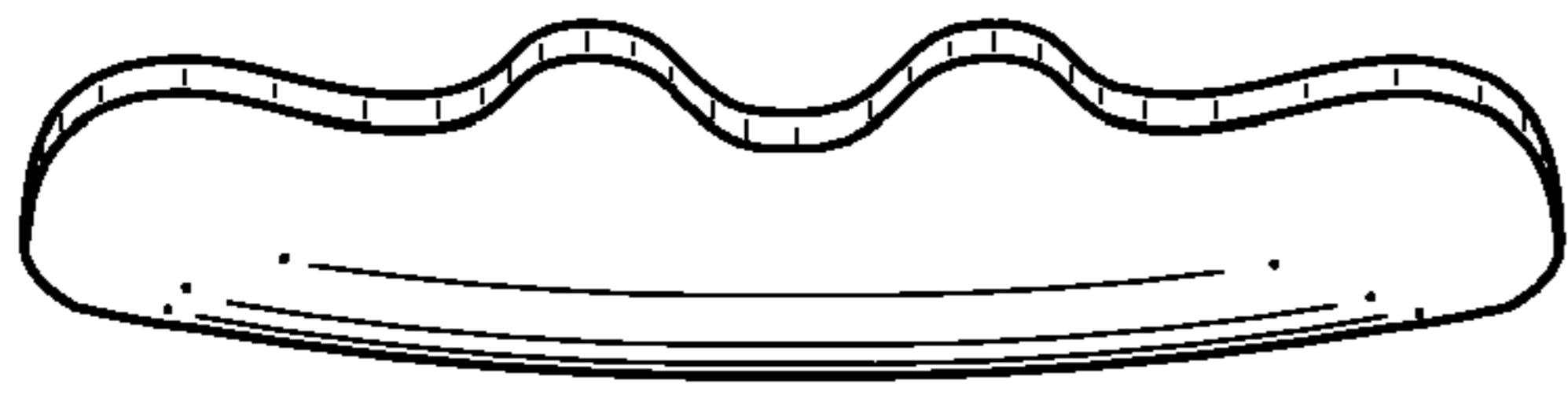

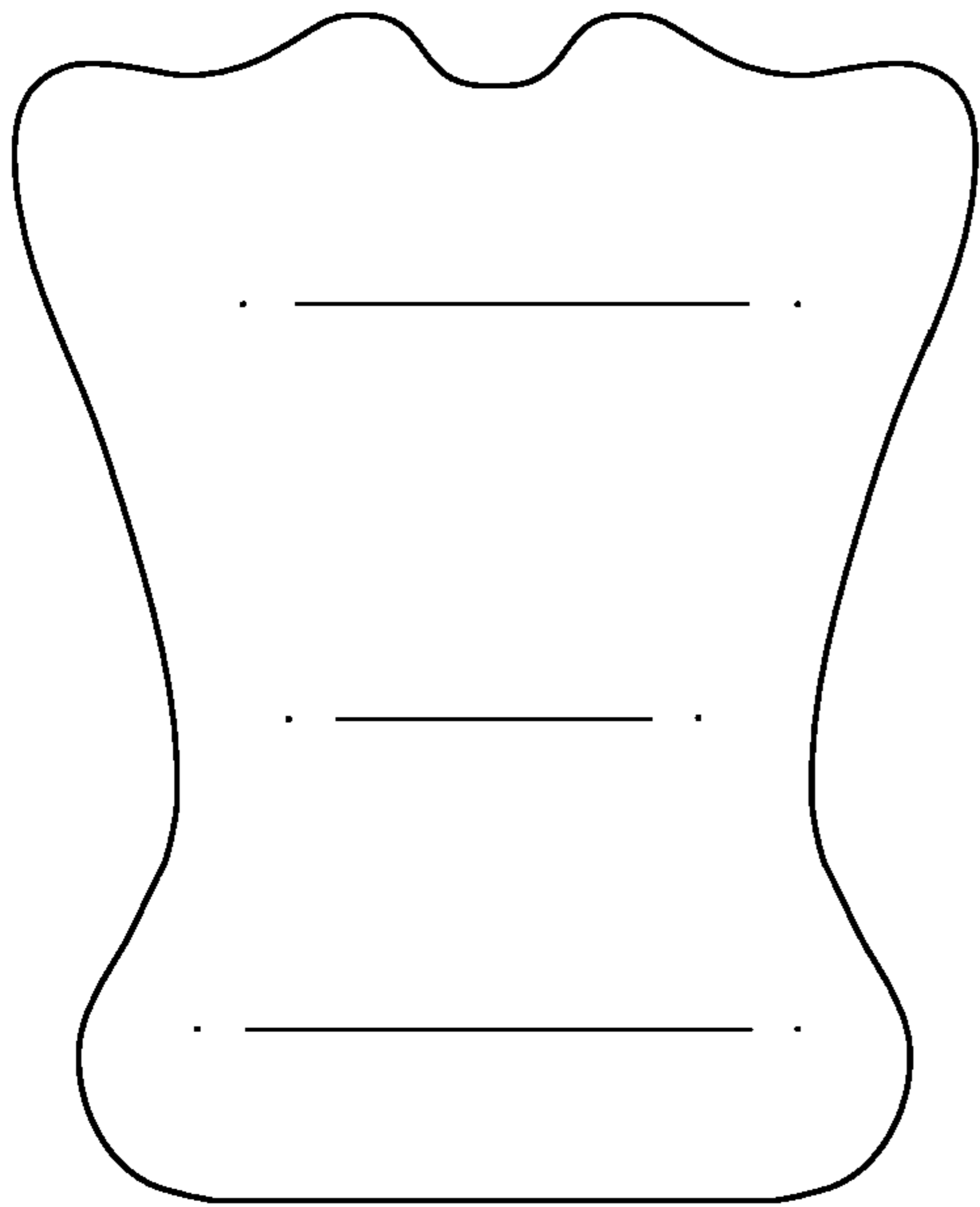

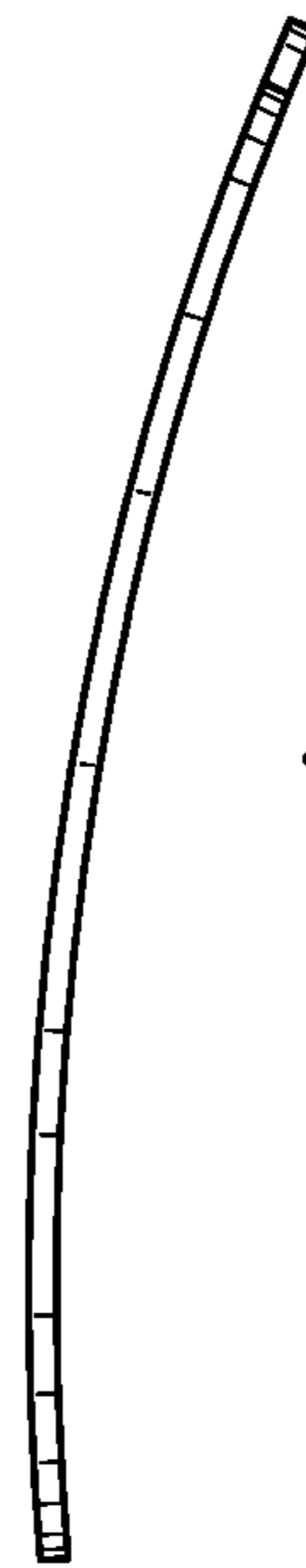

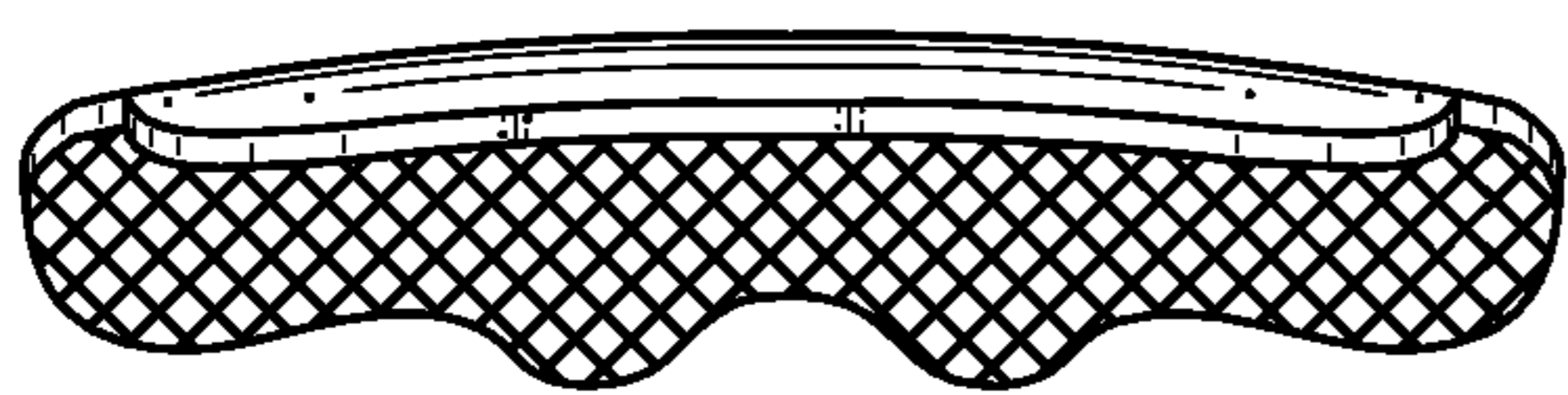

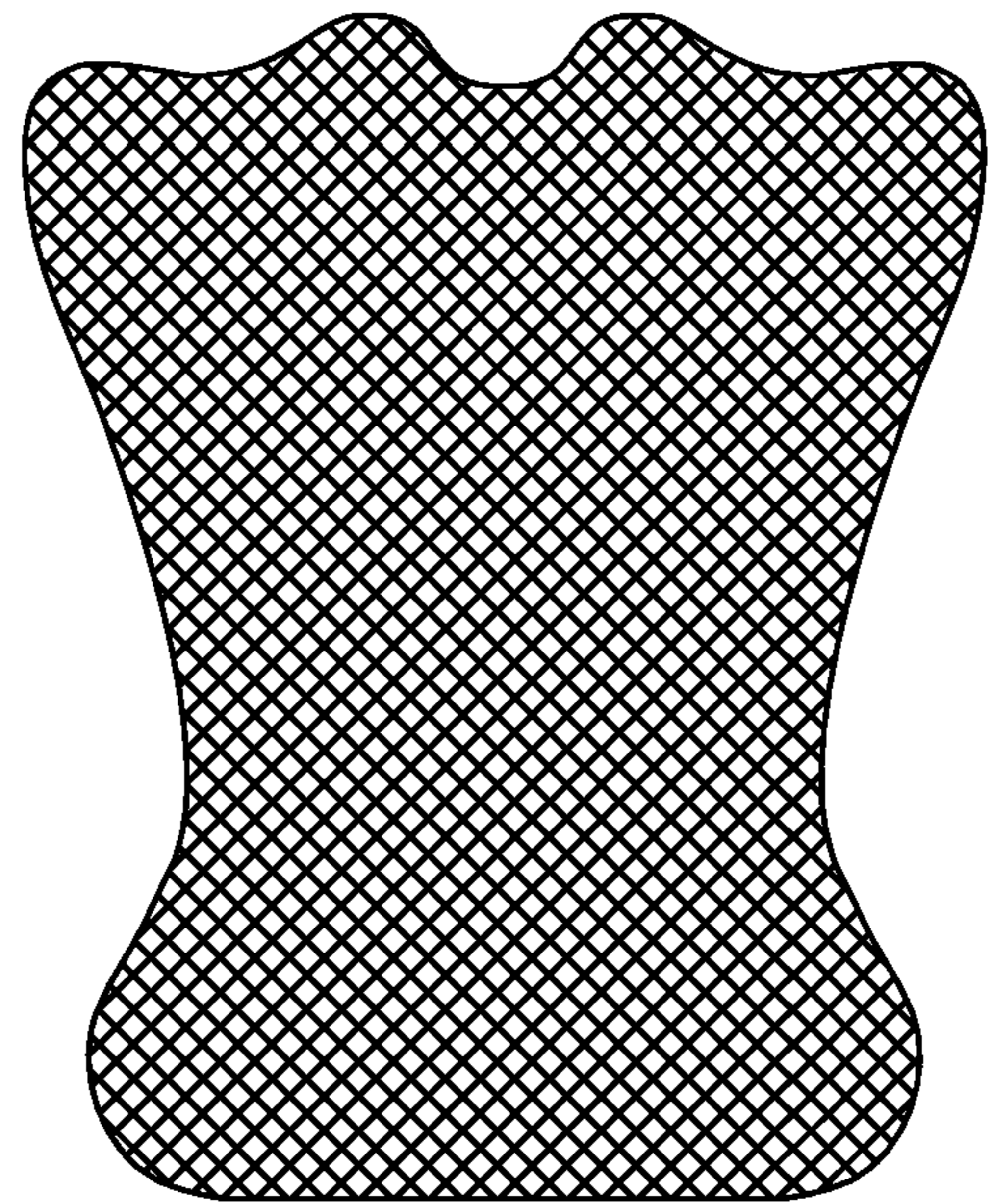

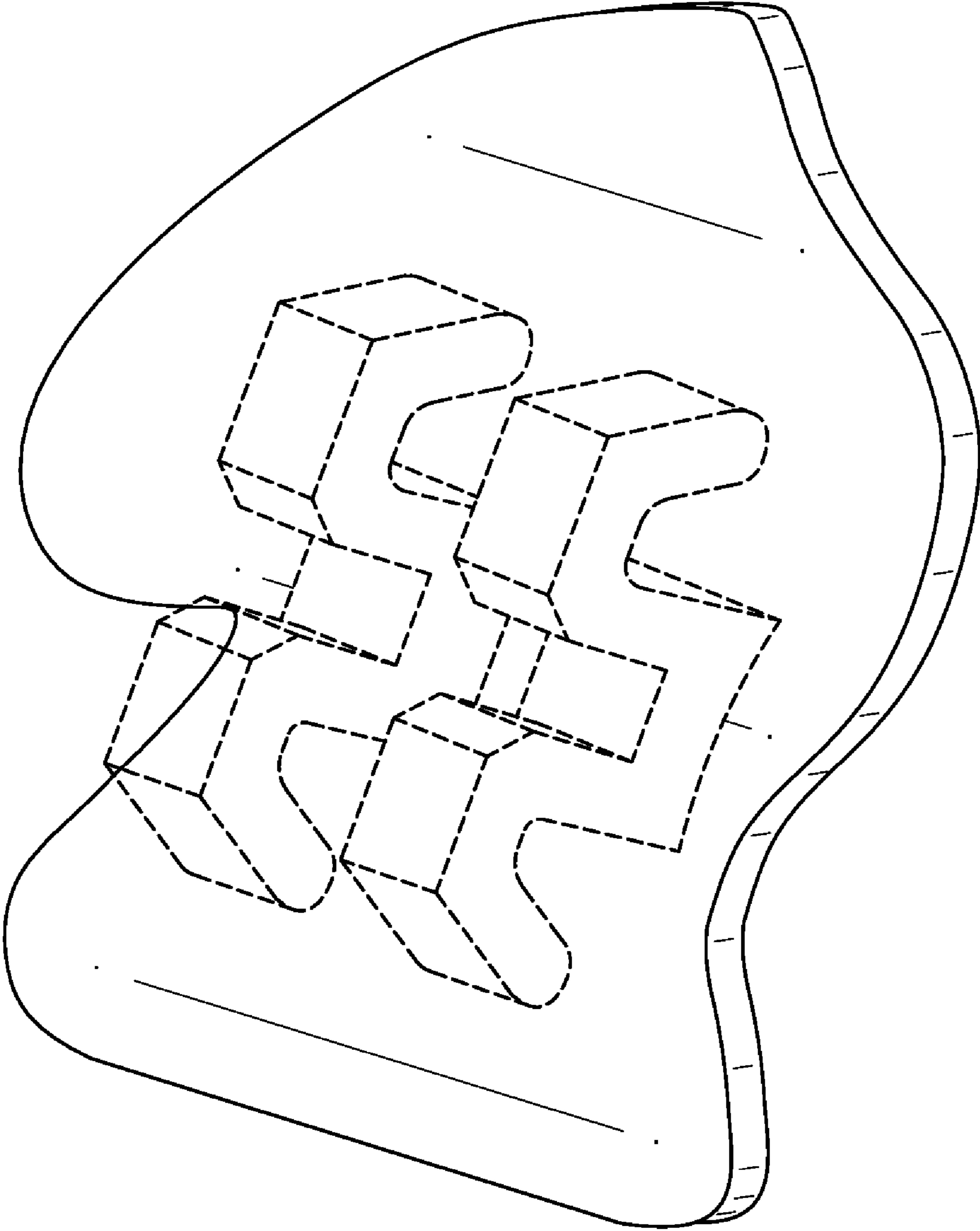

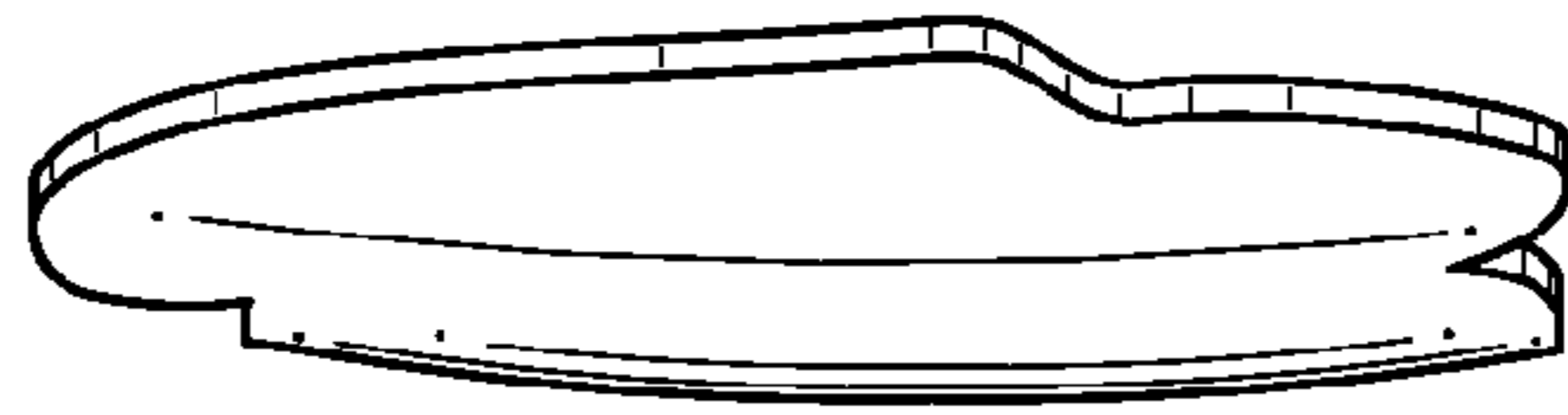

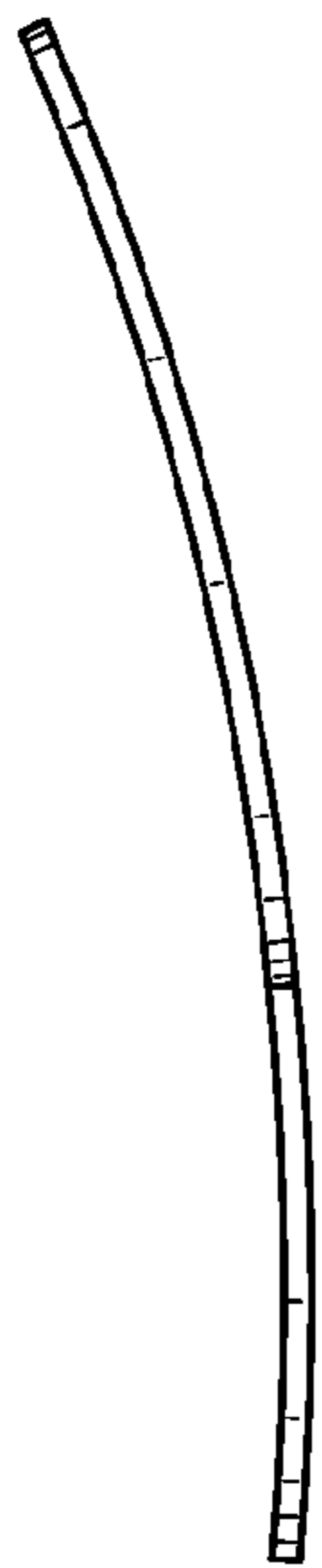

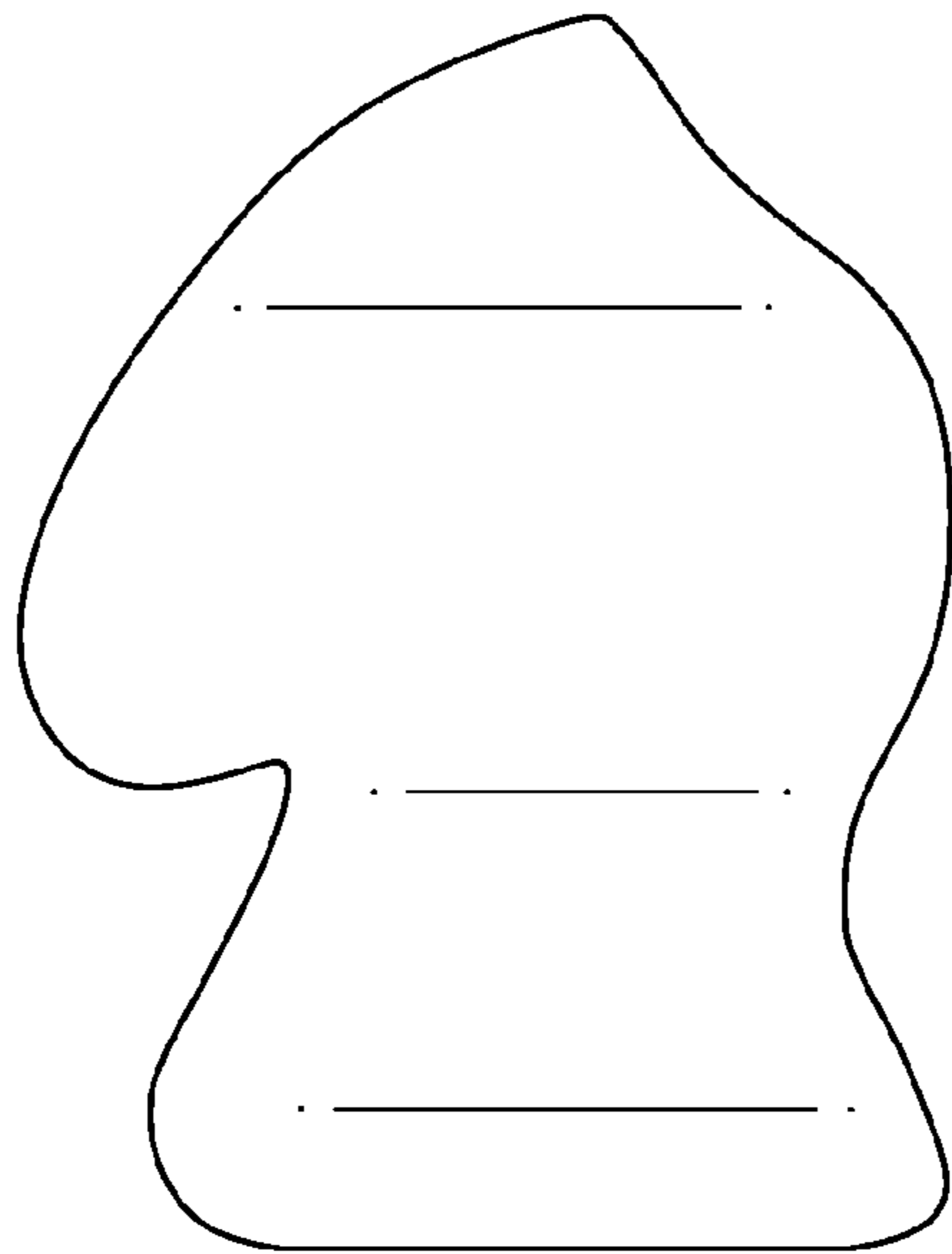

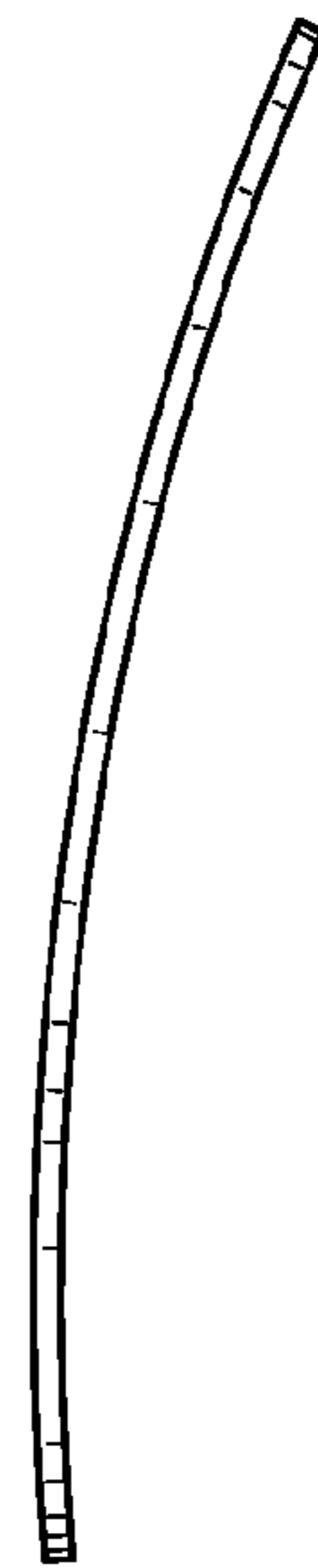

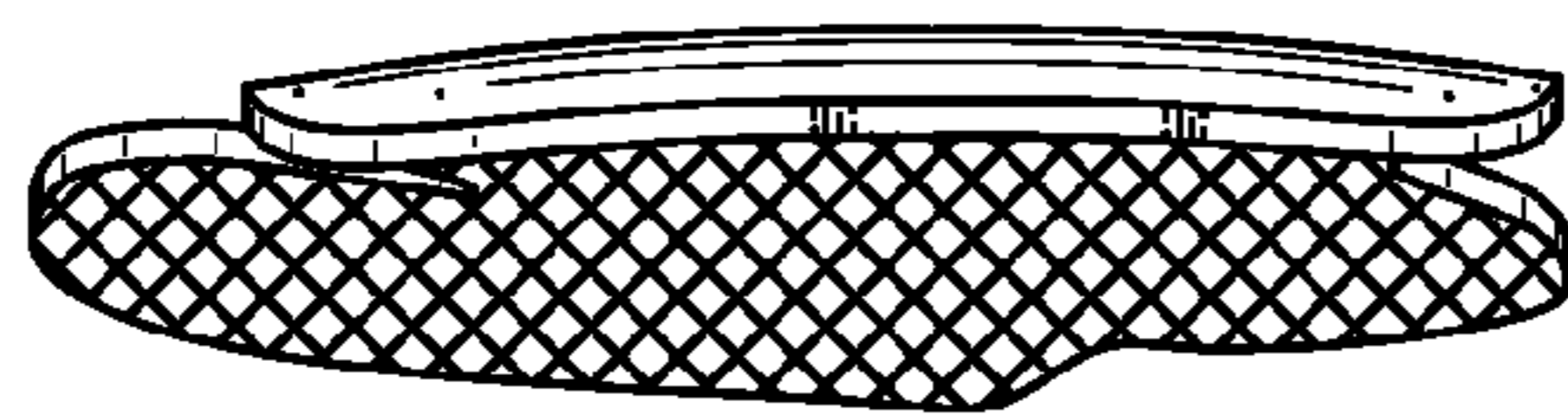

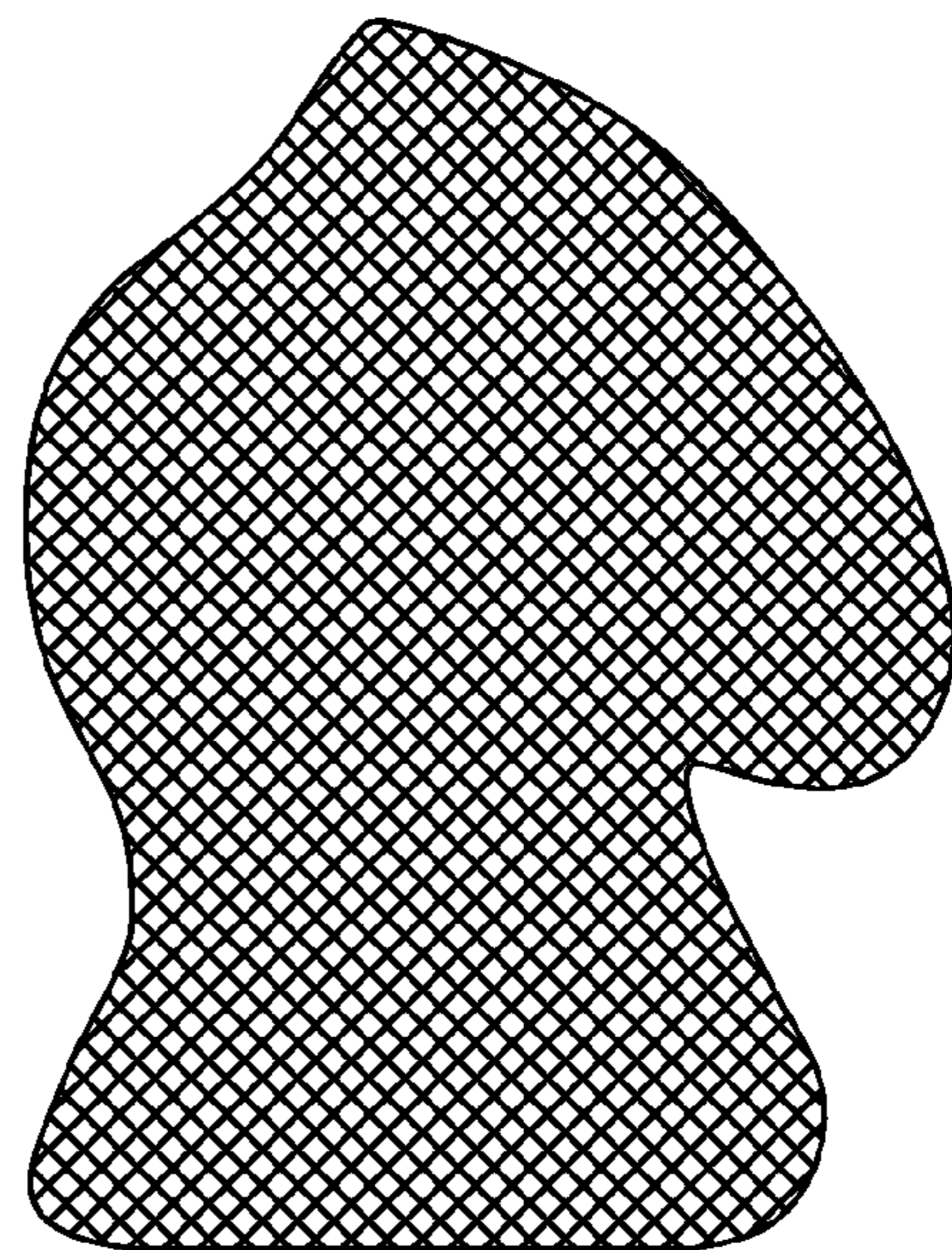

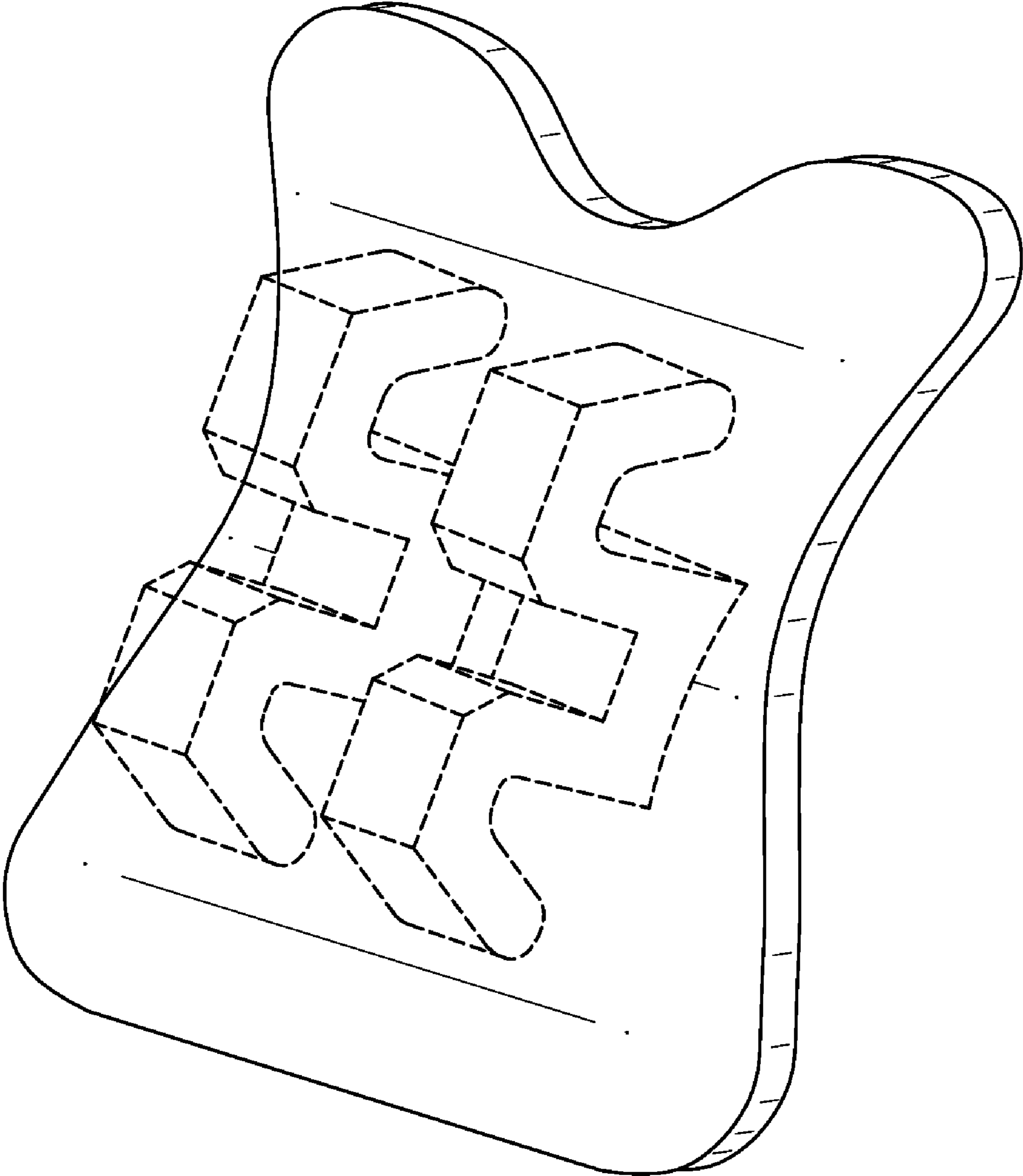

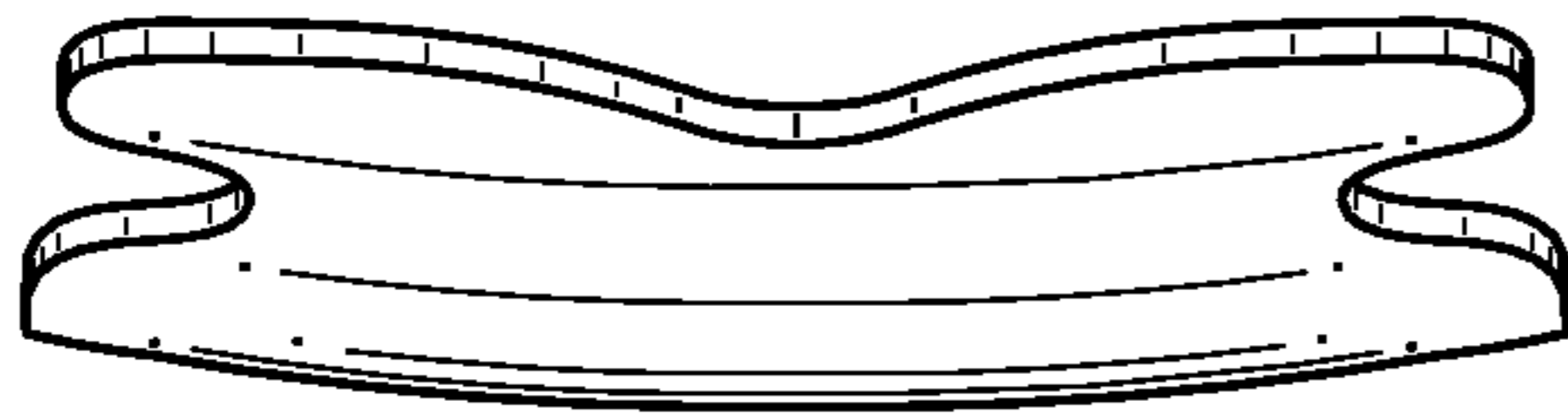

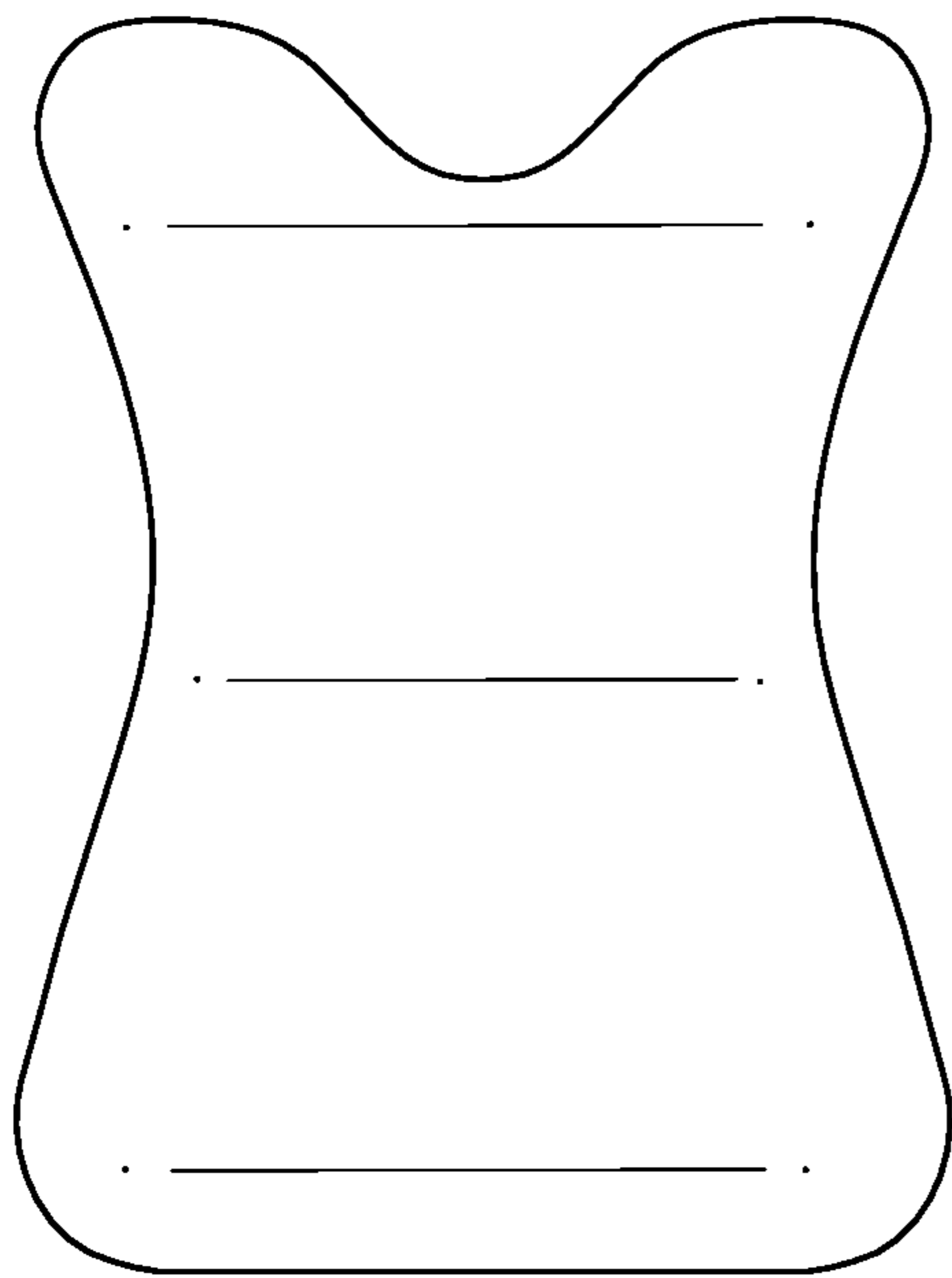

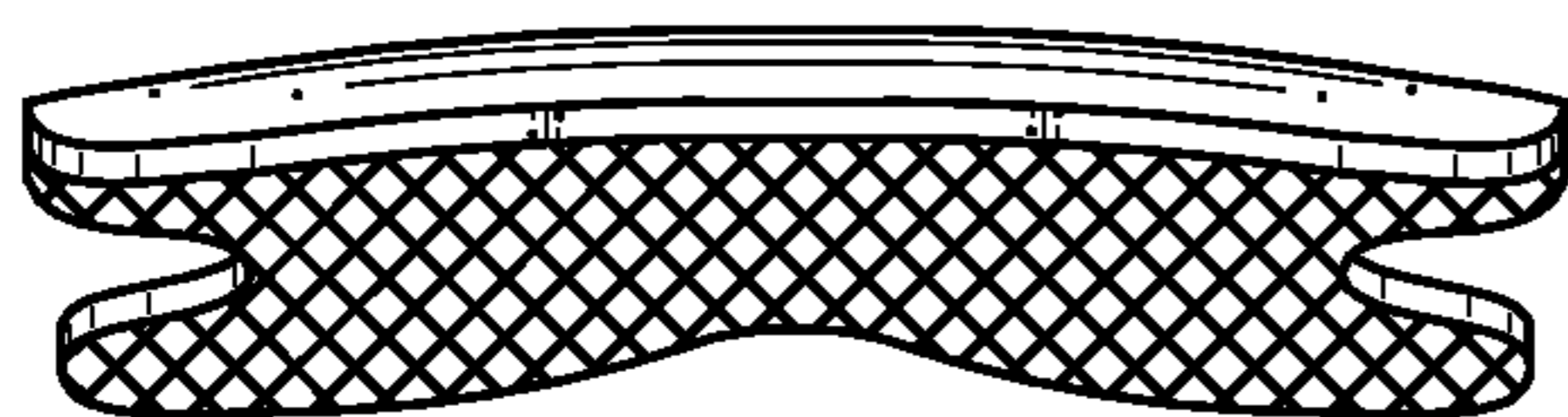

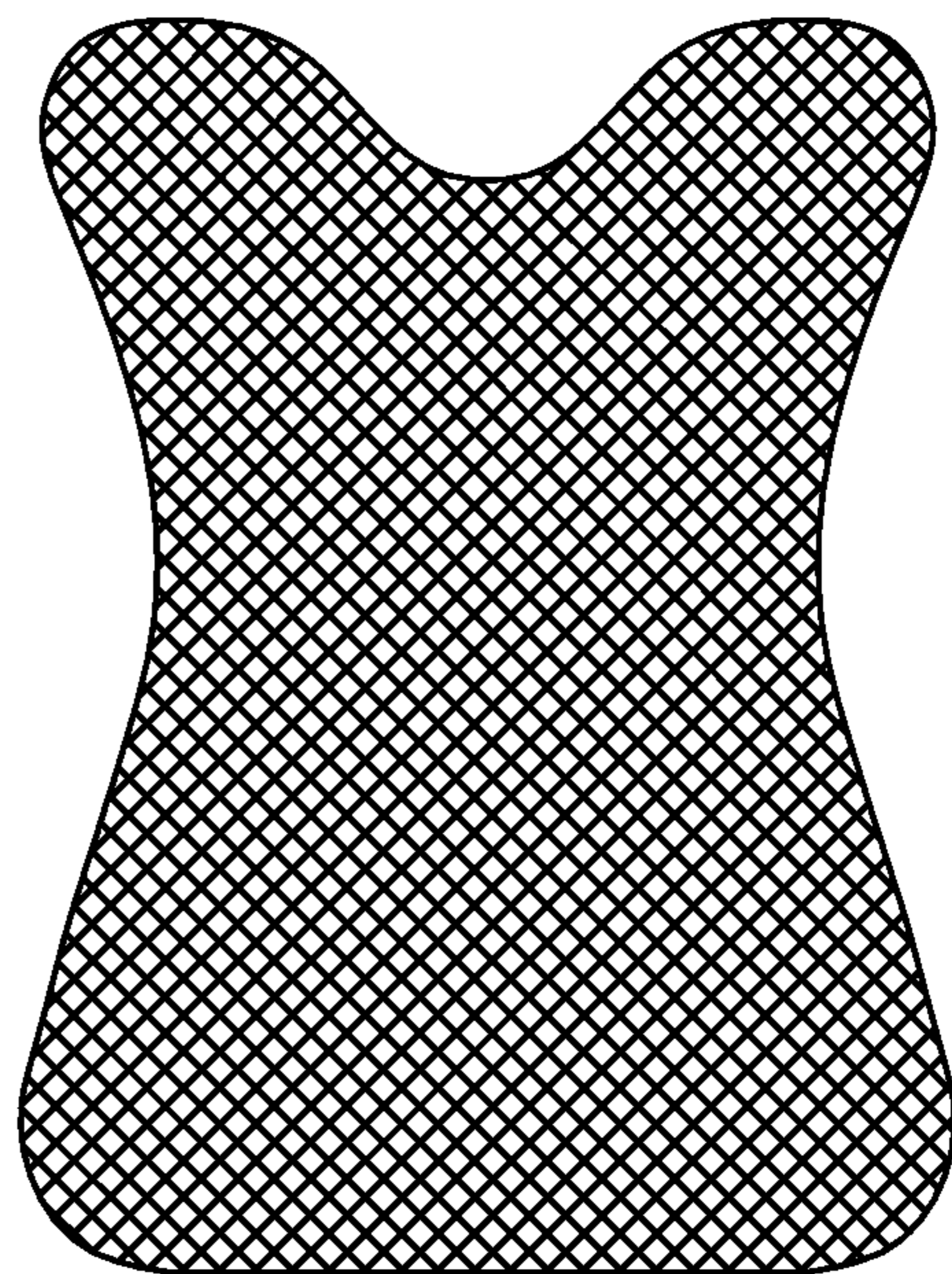

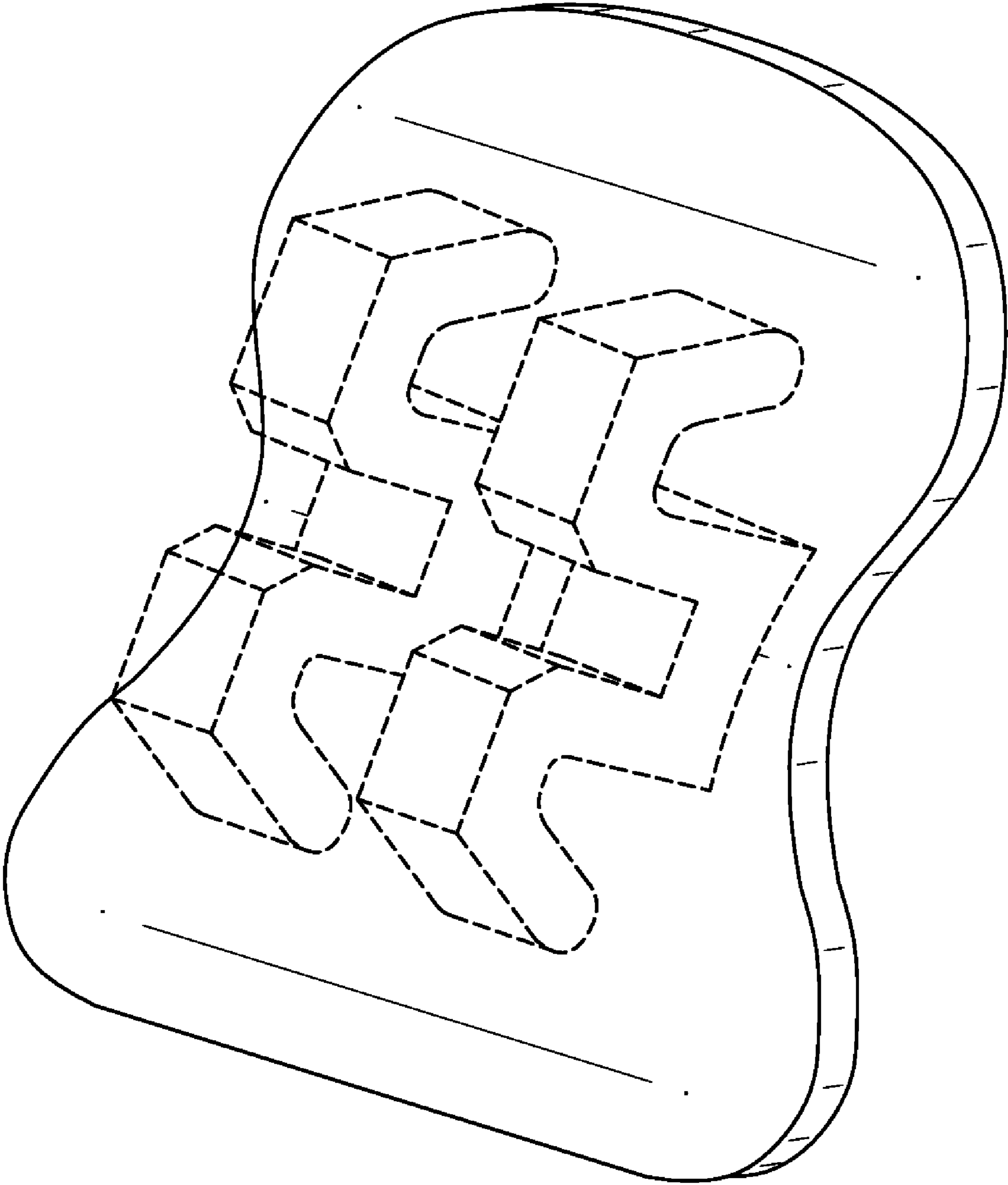

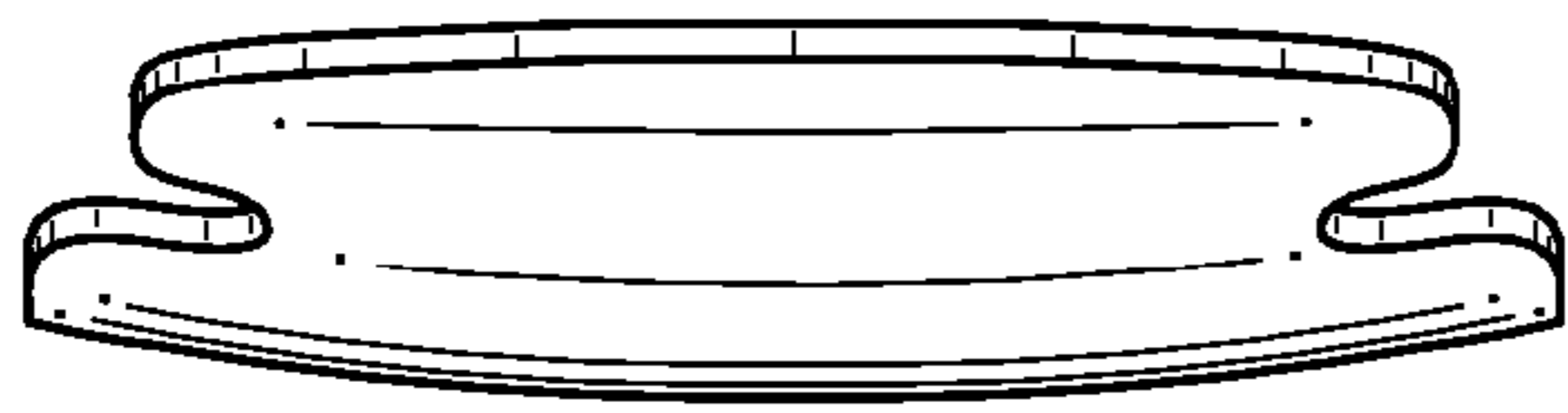

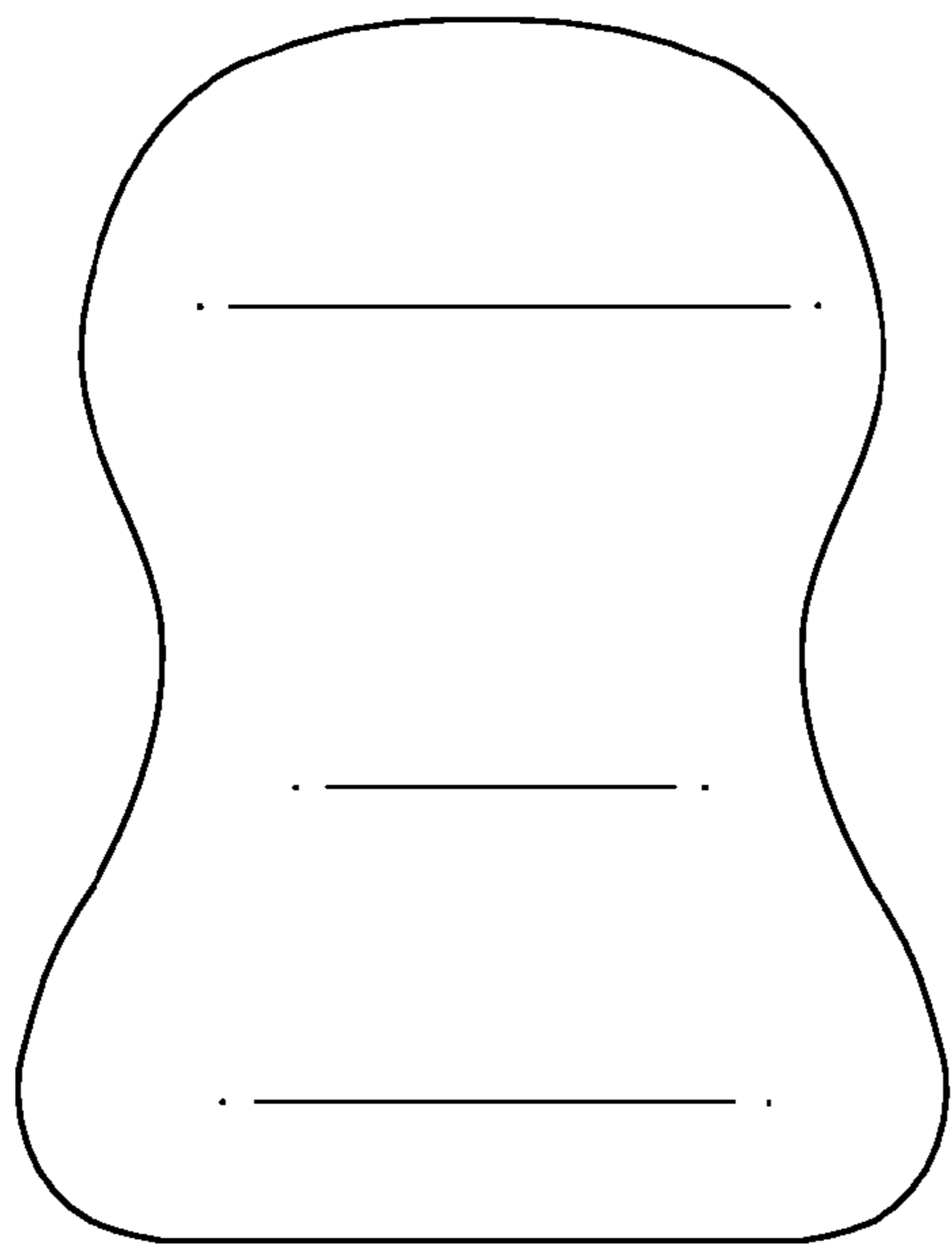

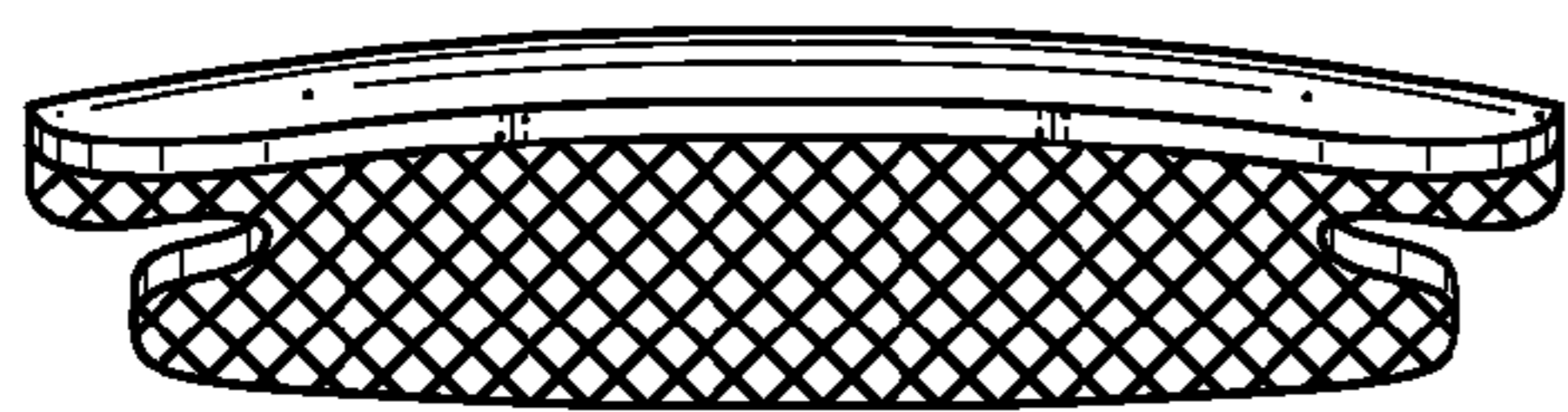

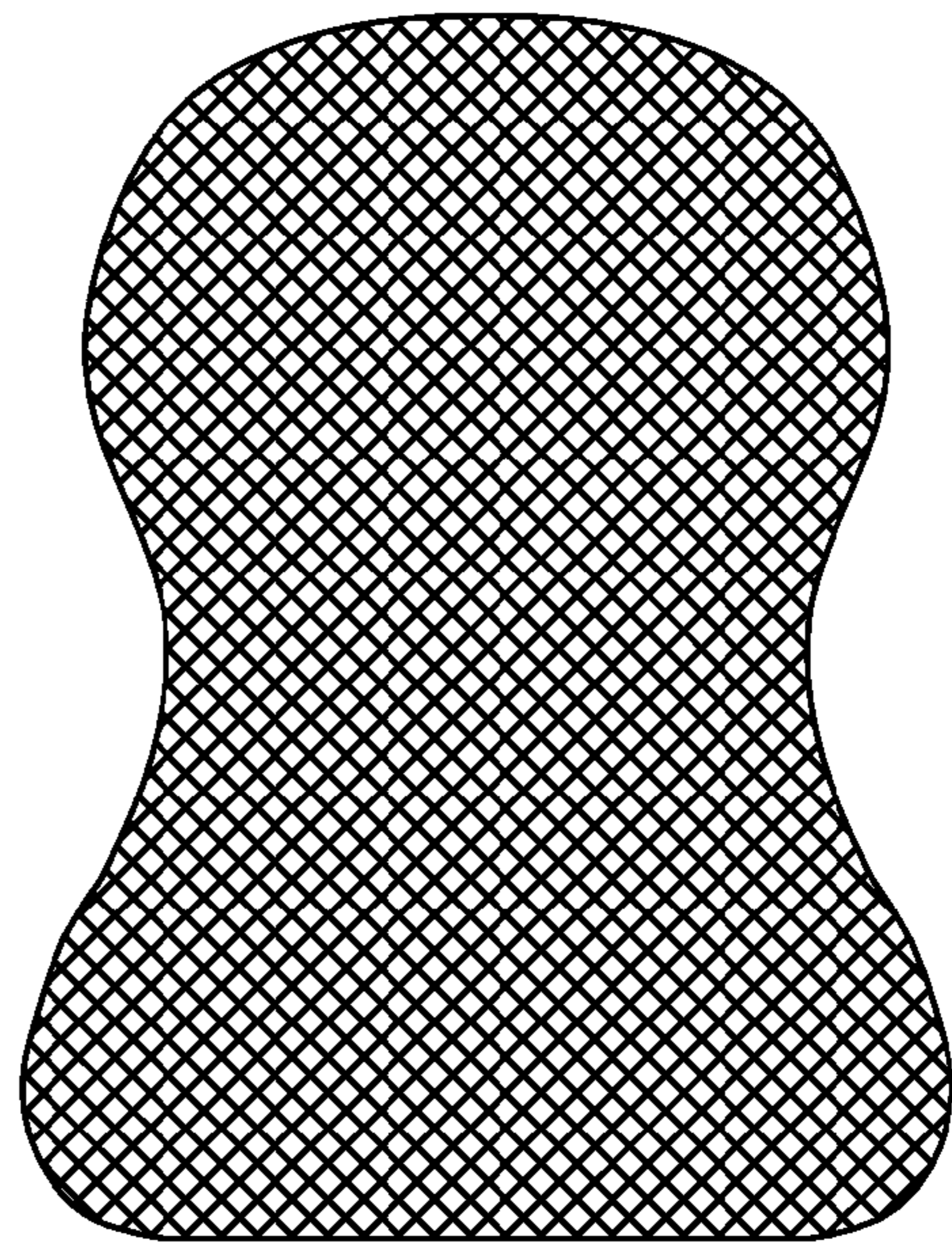

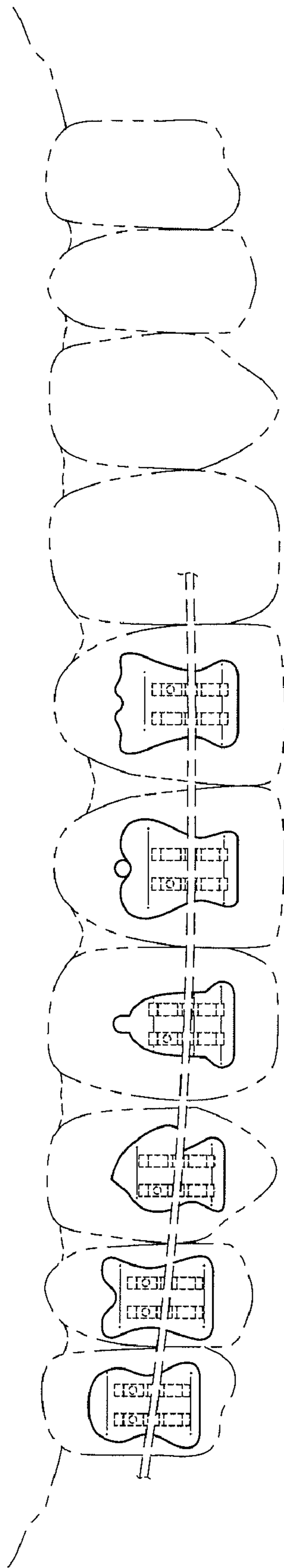
