DESCRIPTION

FIG. 3 is a top view of my design;

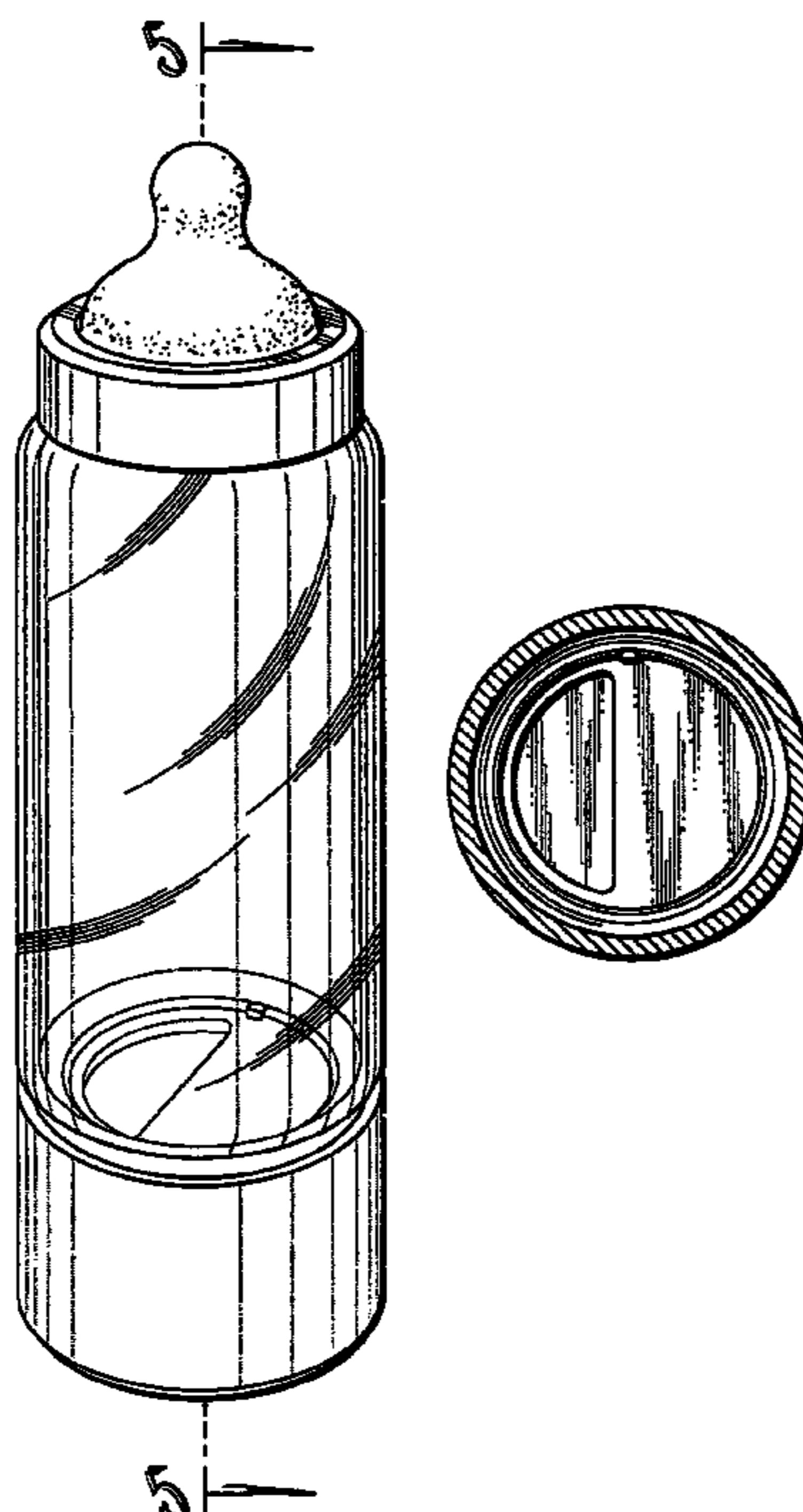
FIG. 4 is a bottom view of my design;

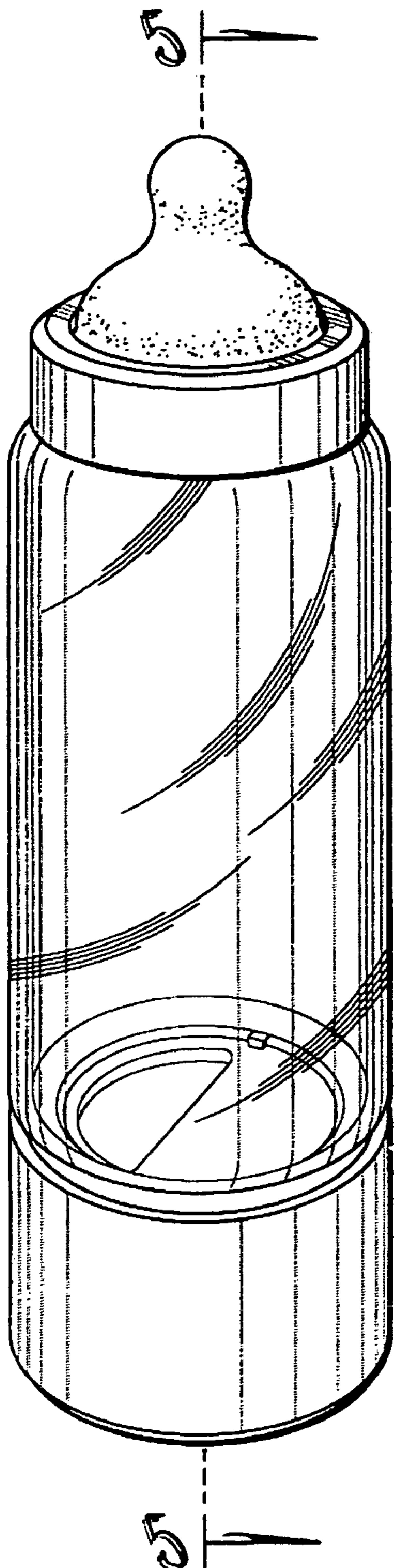

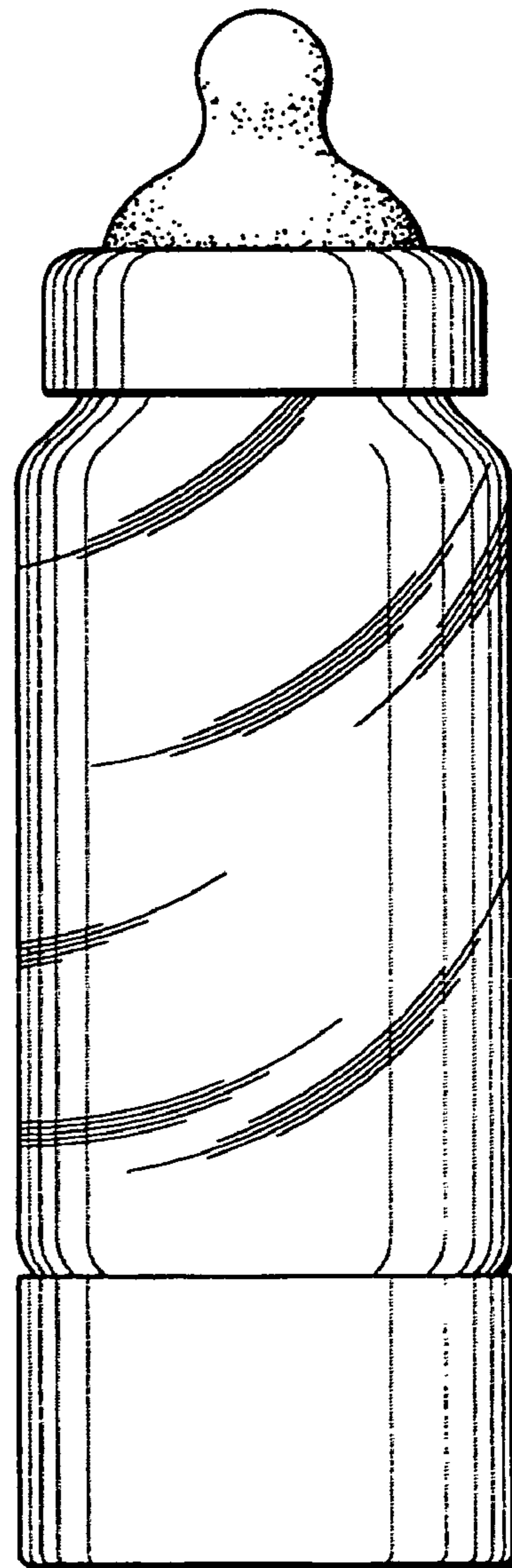

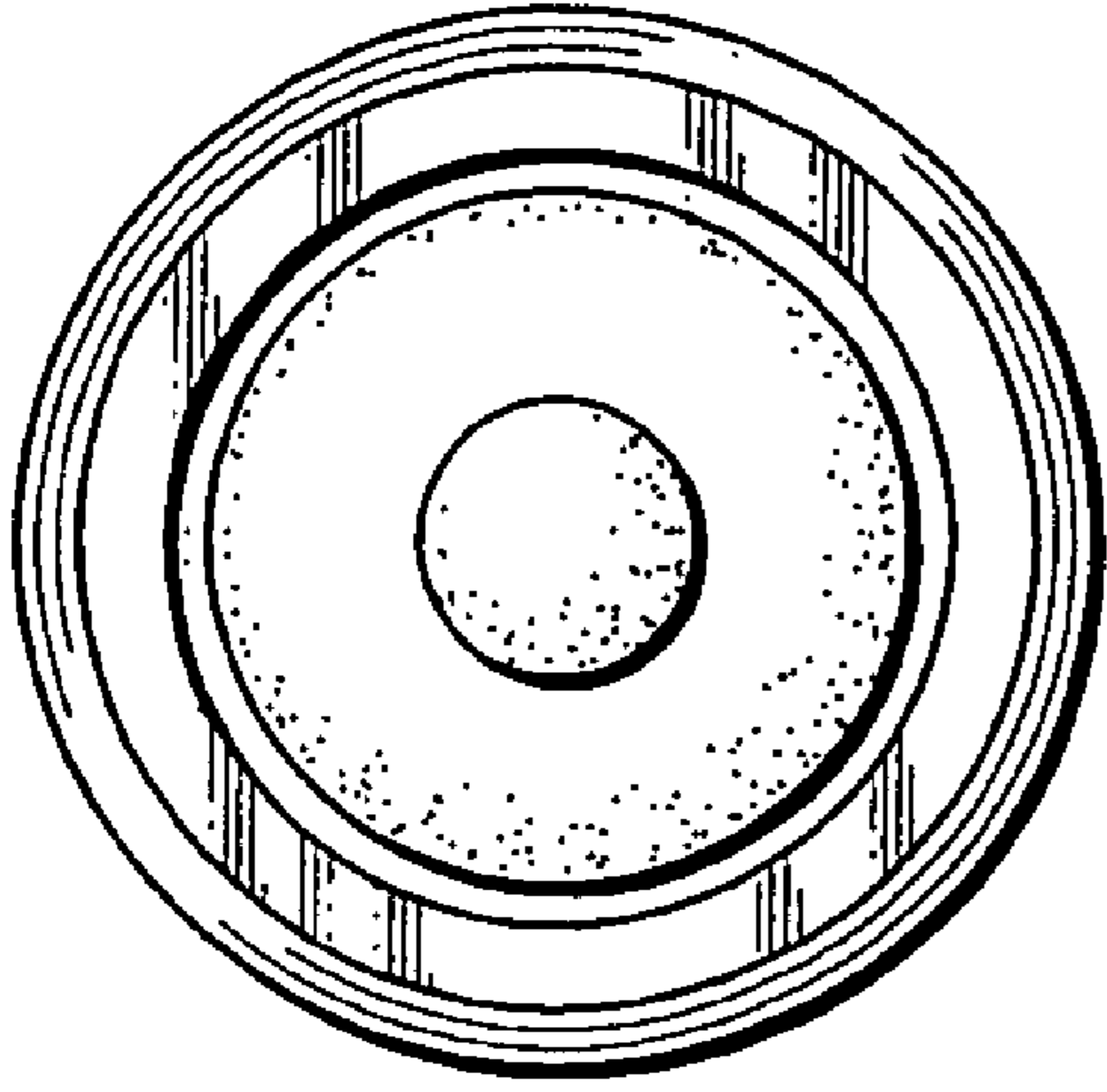

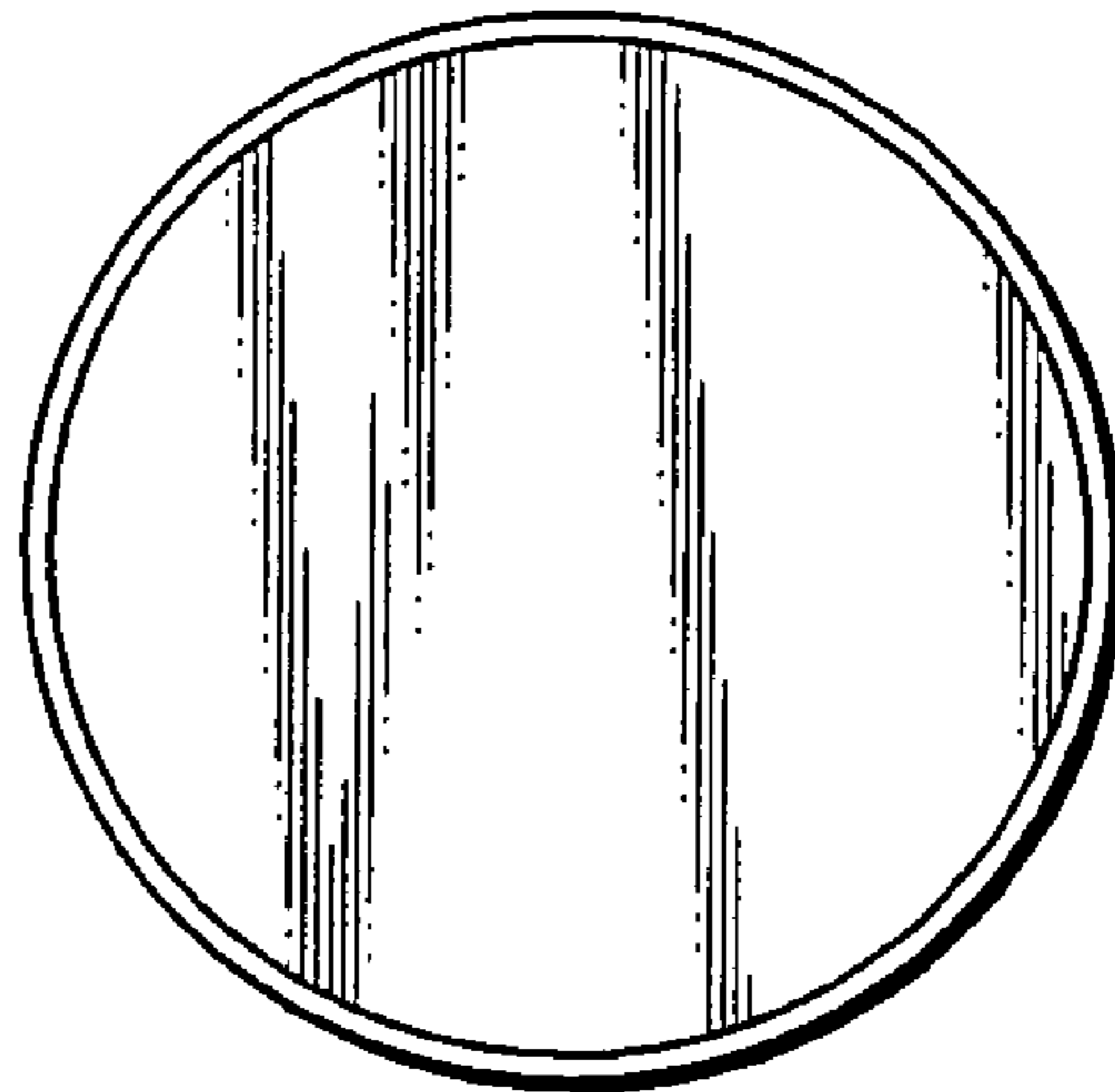

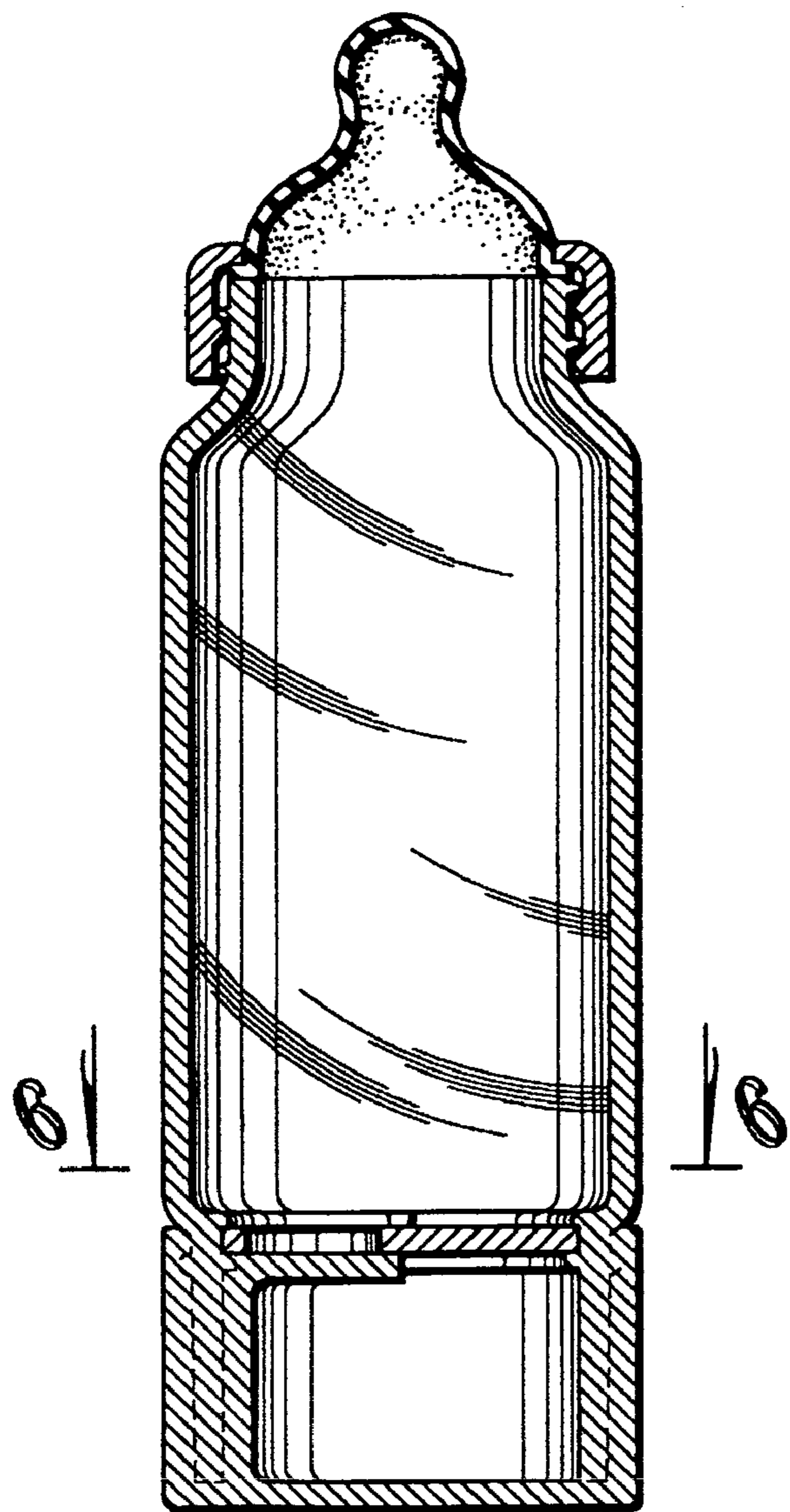

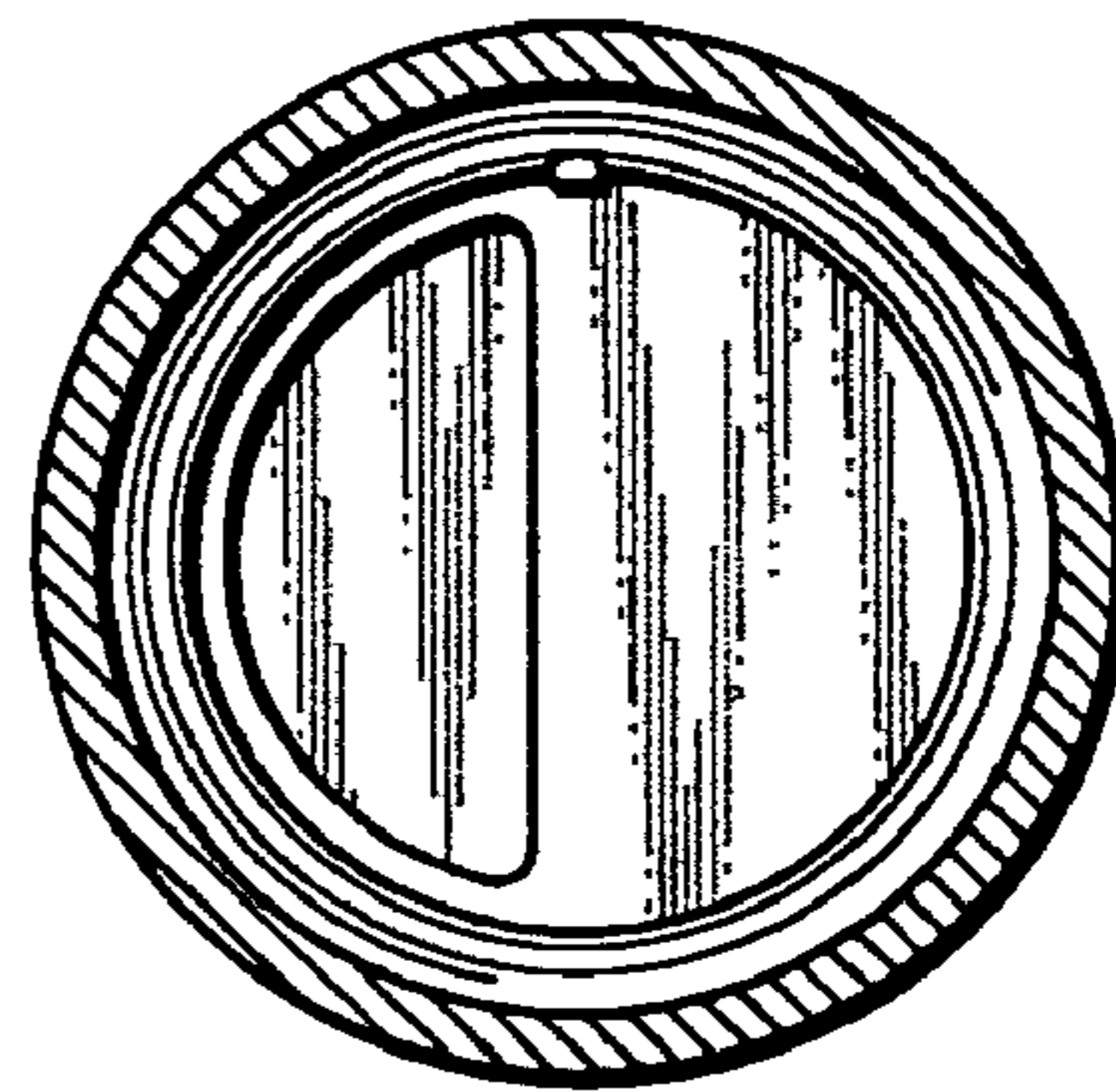
