FIG. 5 is a bottom view of the gelato container with gelato.

FIG. 6 is an opposing side view of the gelato container with gelato along the length; and,

FIG. 7 is an opposing side view of the gelato container with gelato along the width.

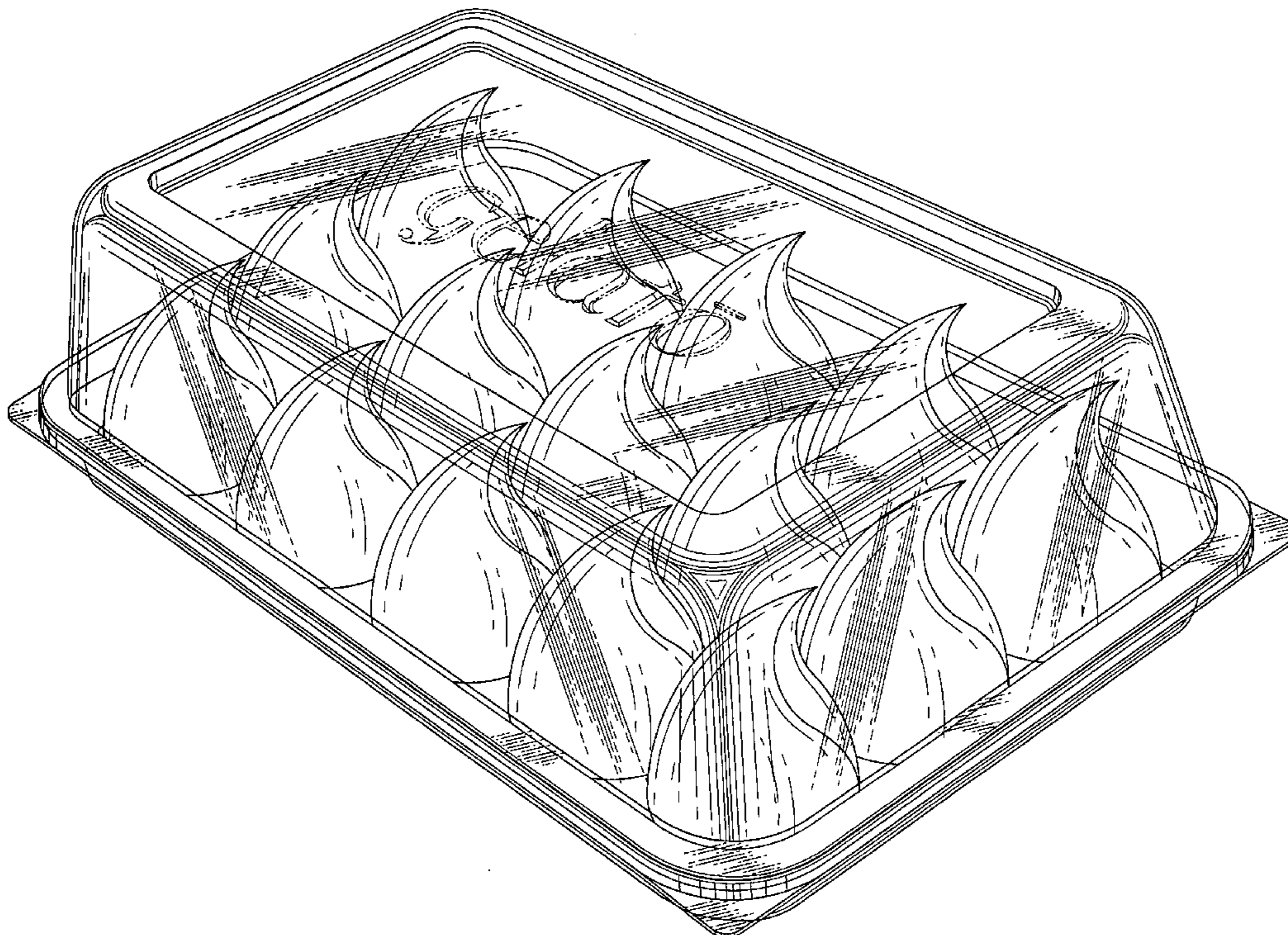

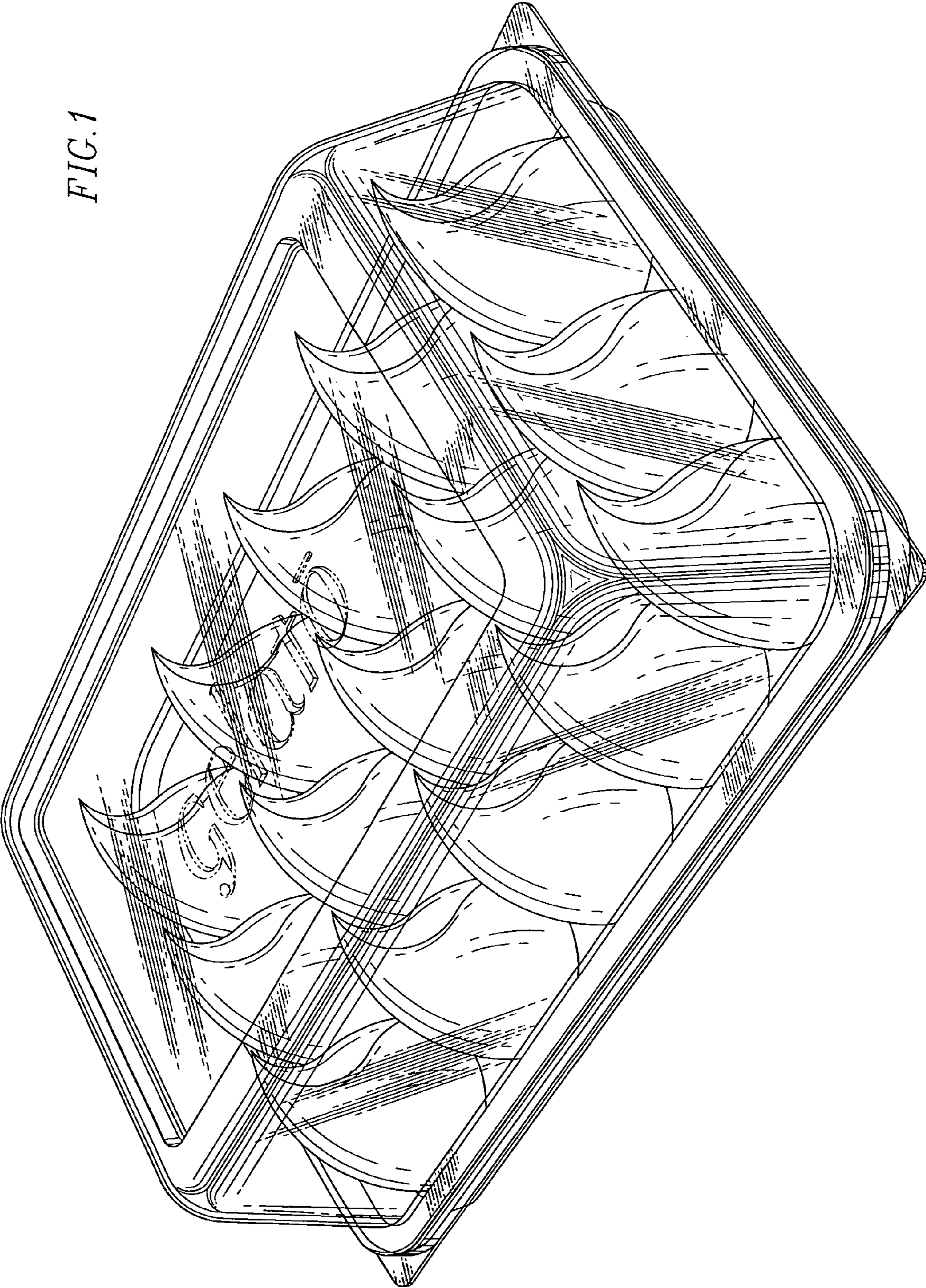

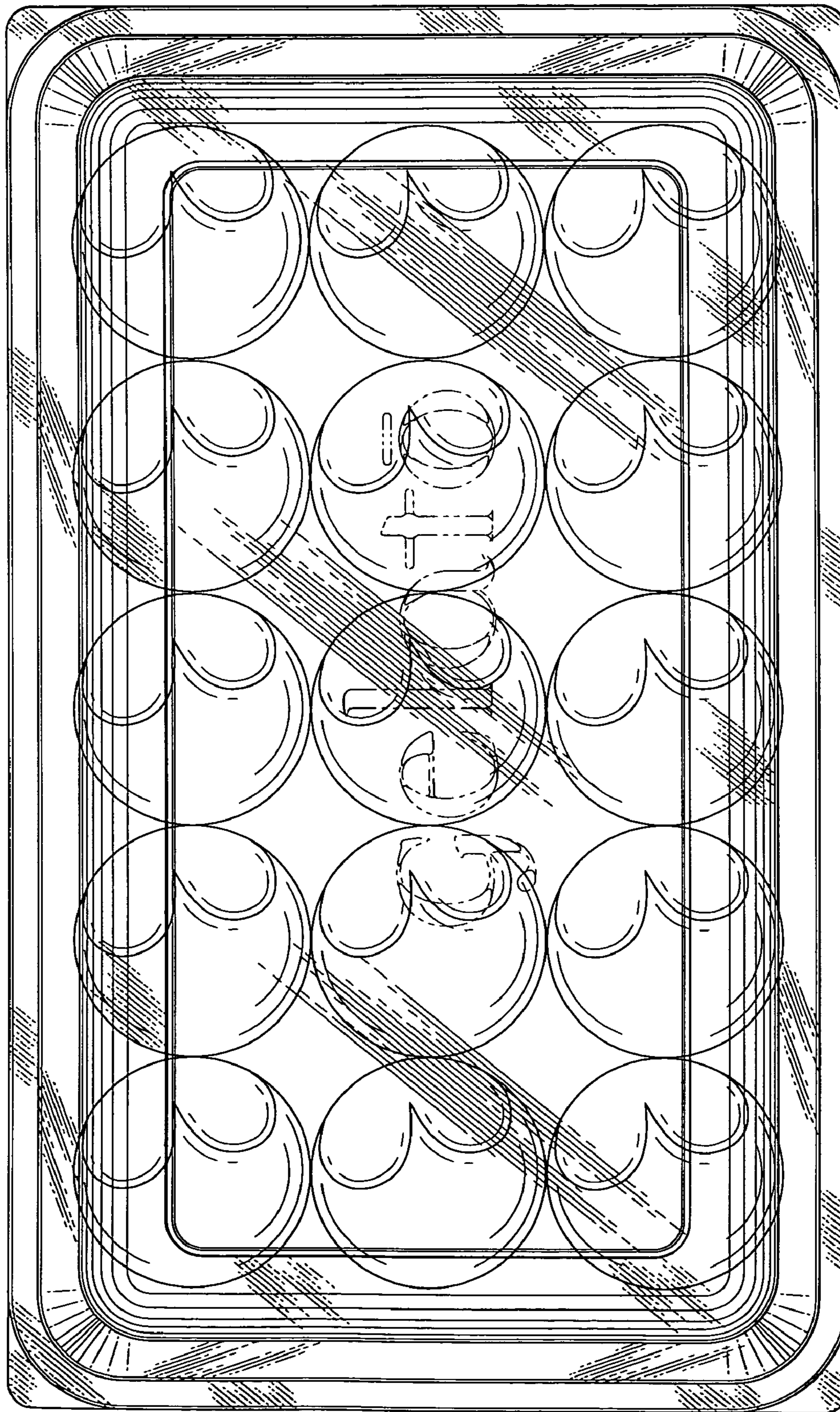

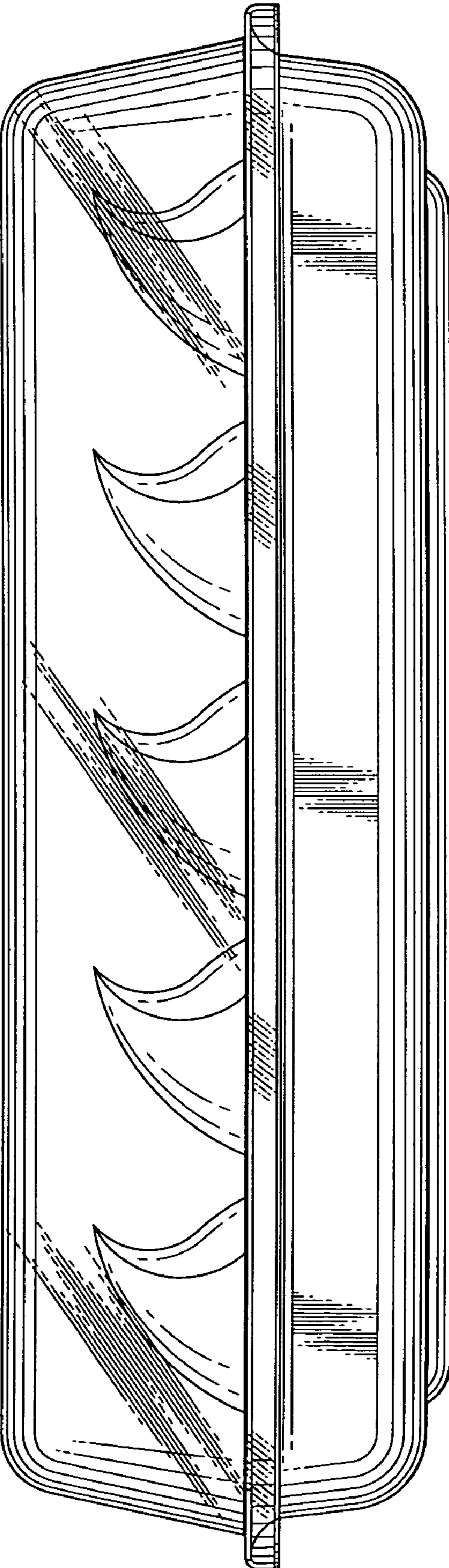

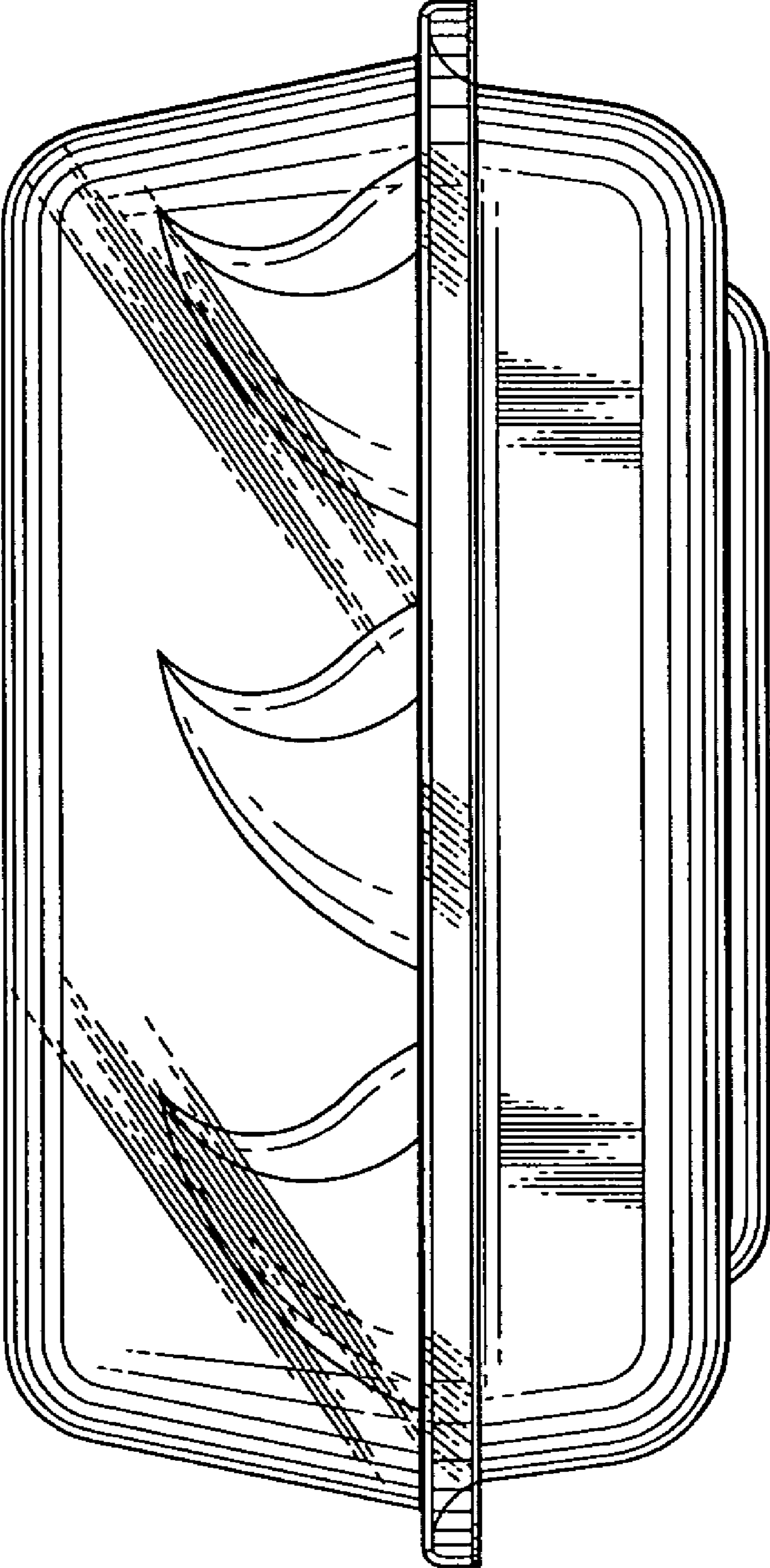

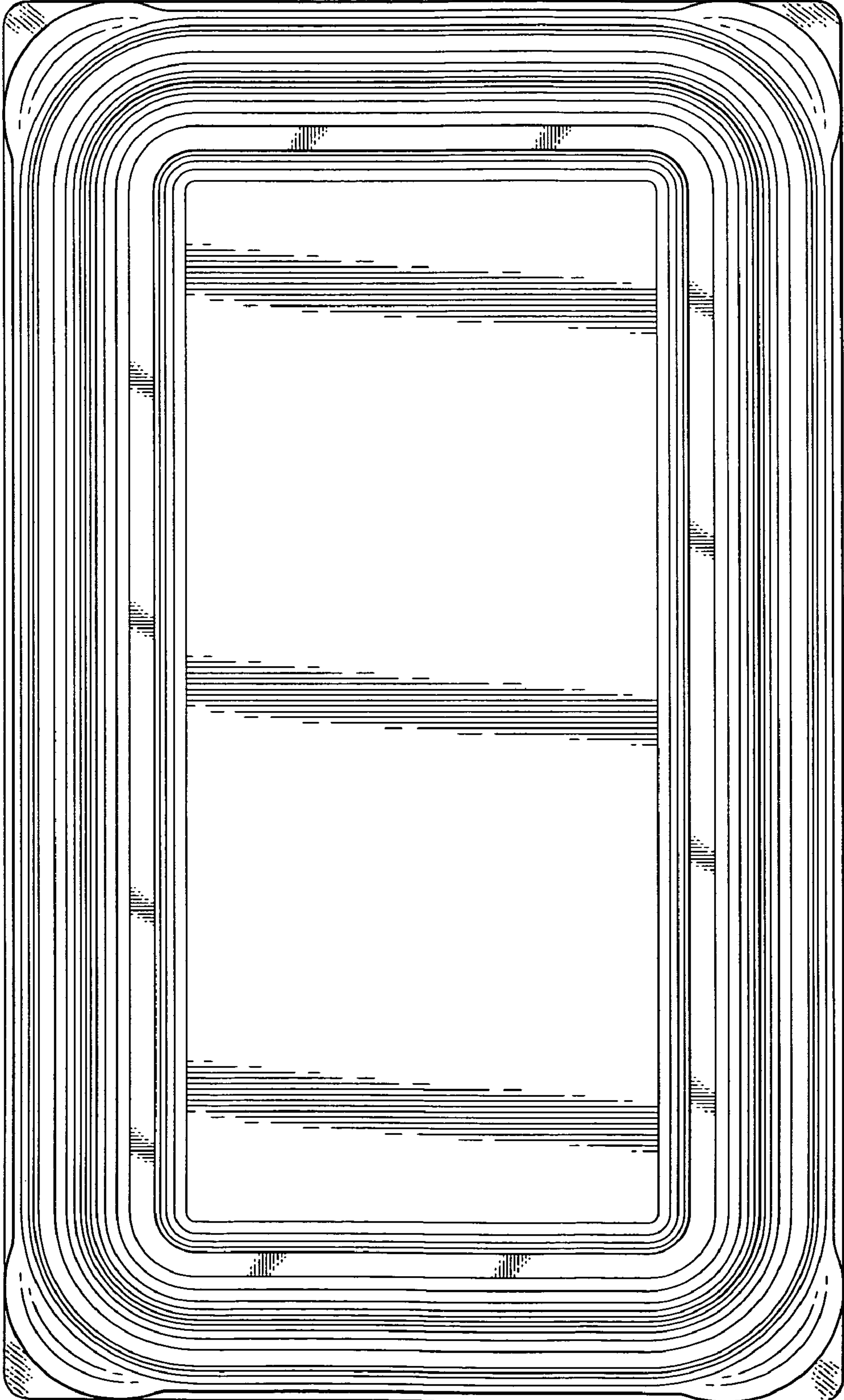

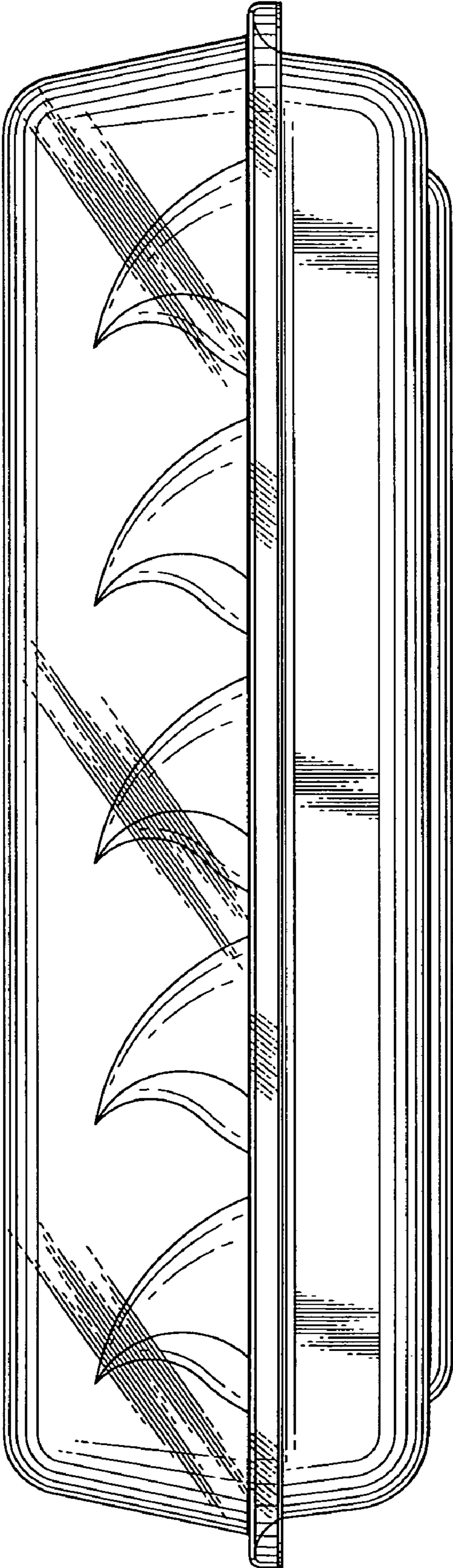
