FIG. 1 is a front perspective view of a handbag showing my new design;

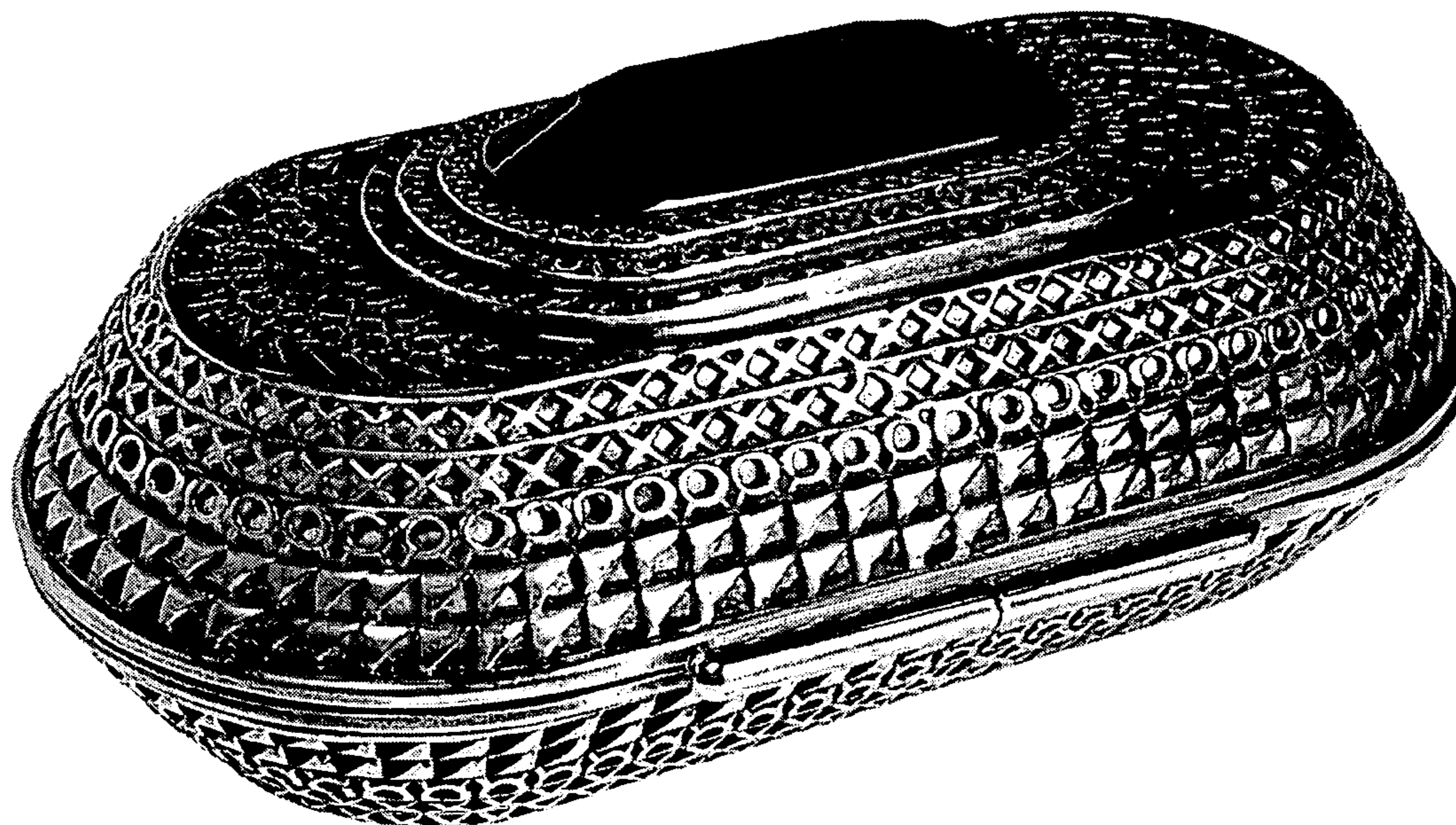
FIG. 2 is a top view of the handbag shown in FIG. 1;

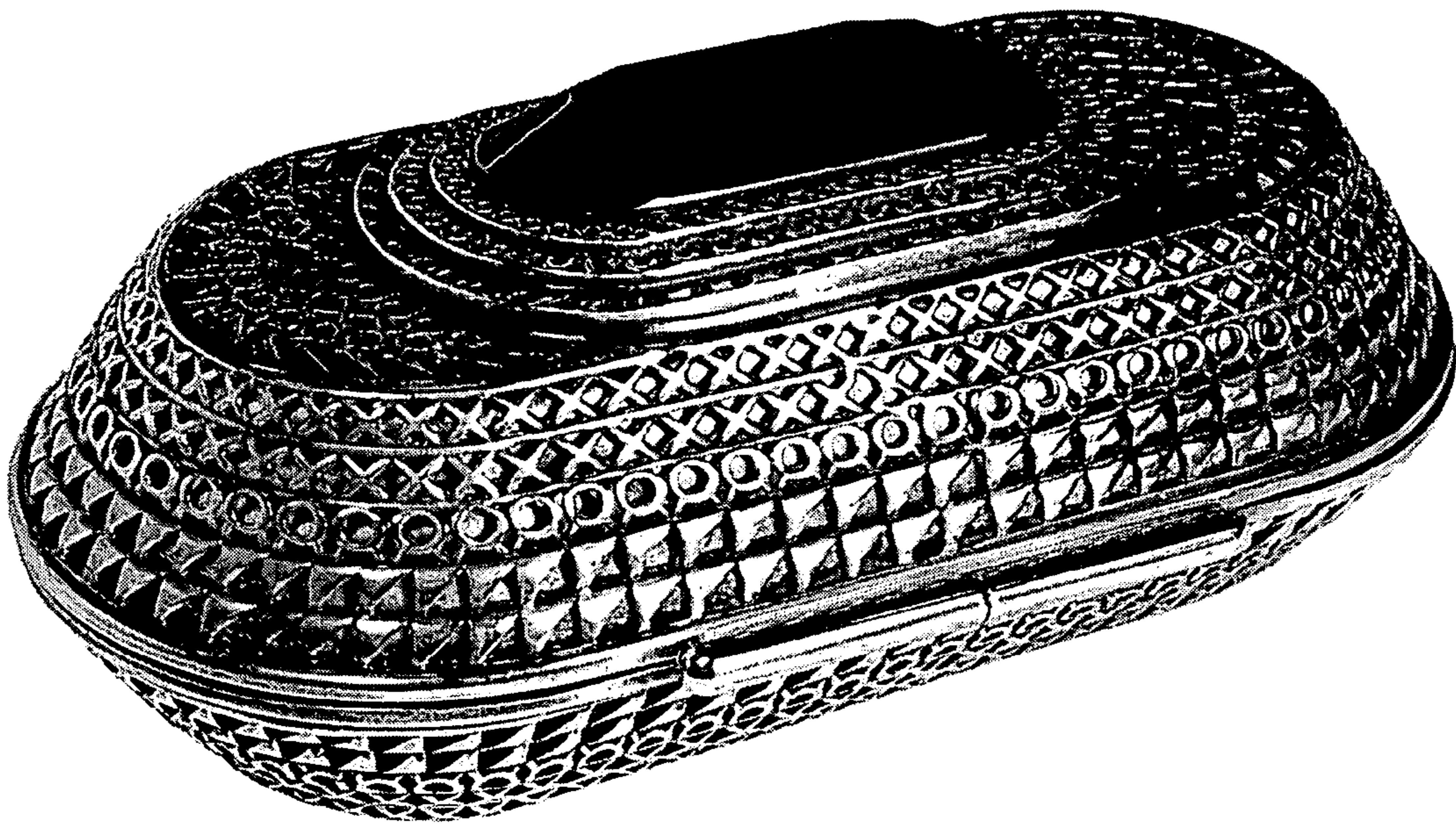

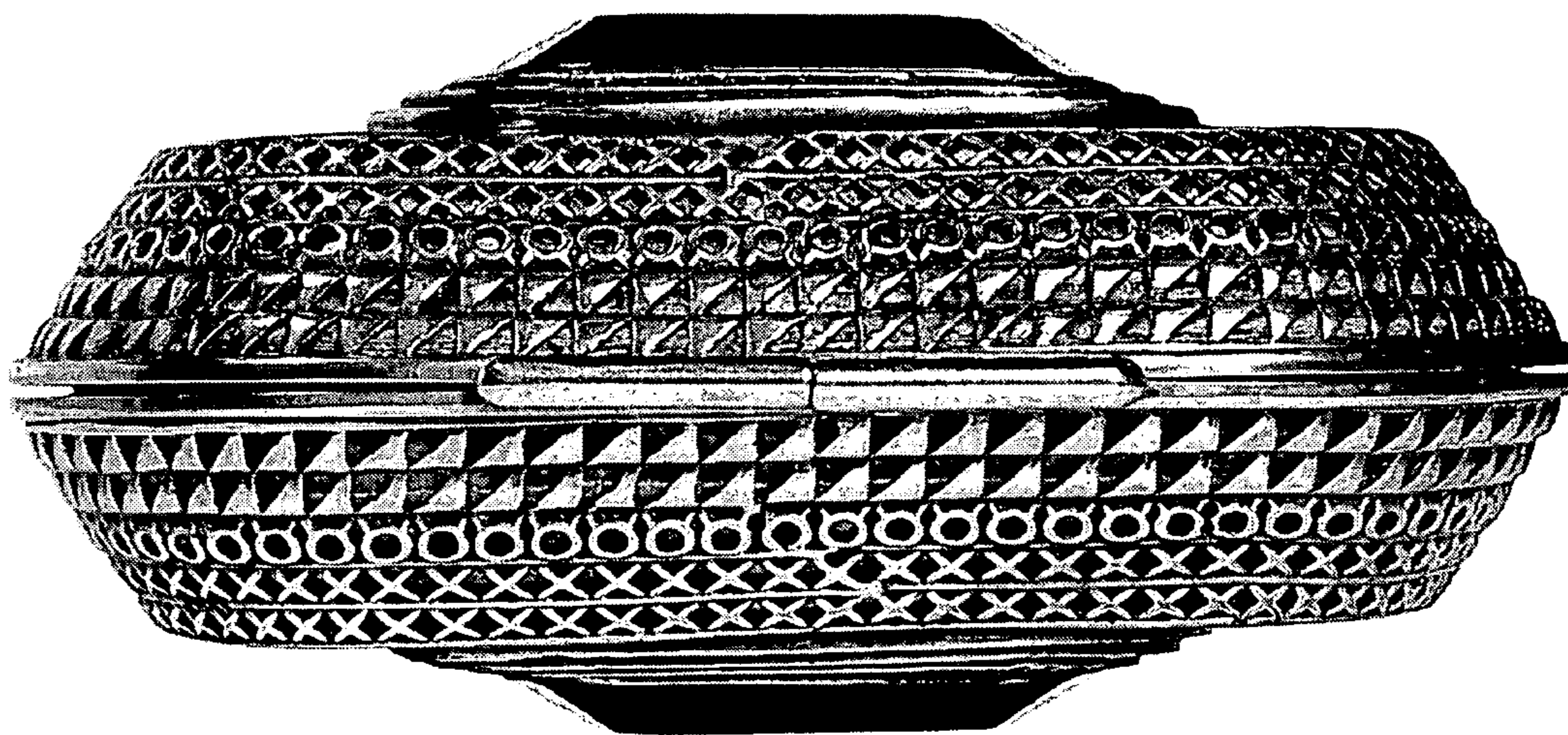

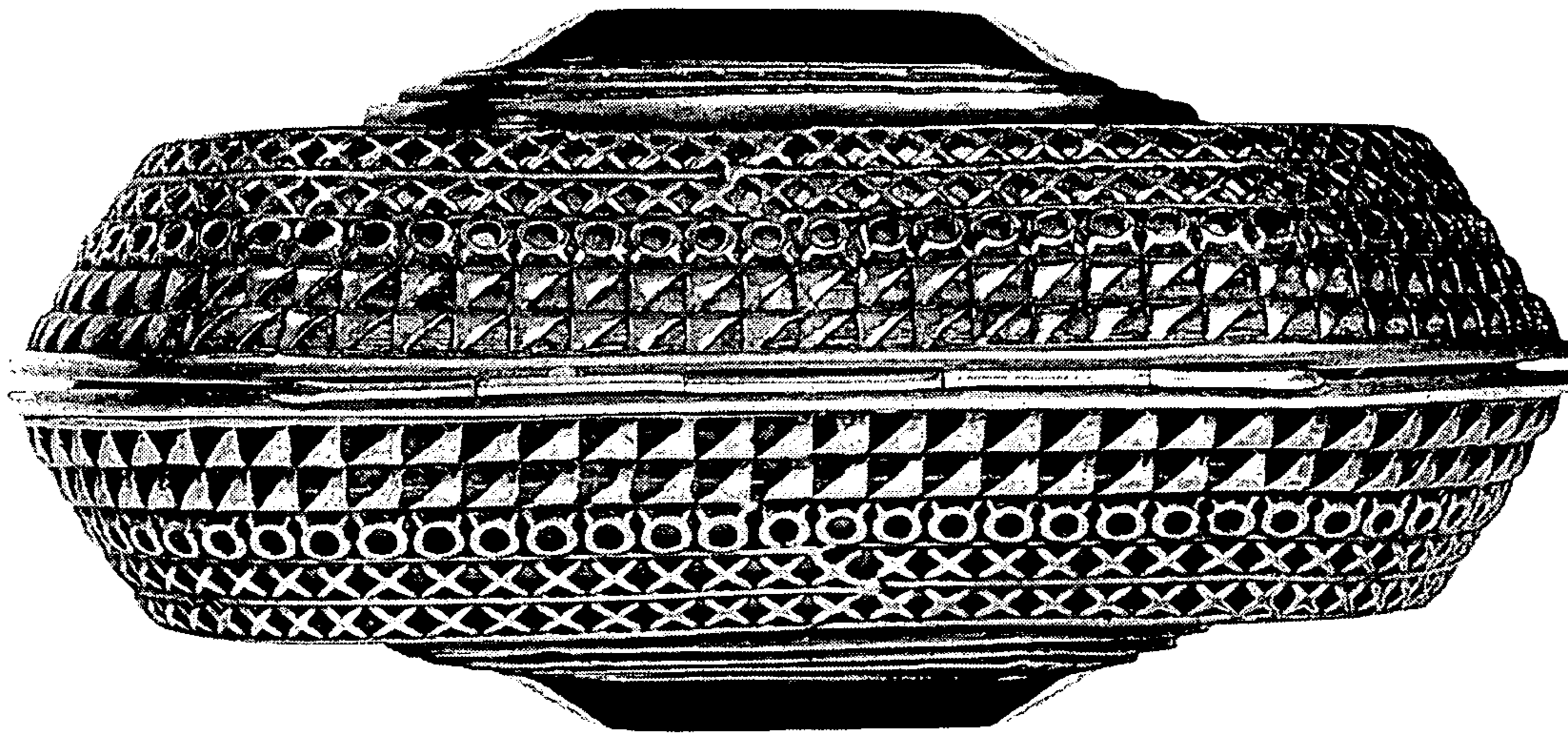

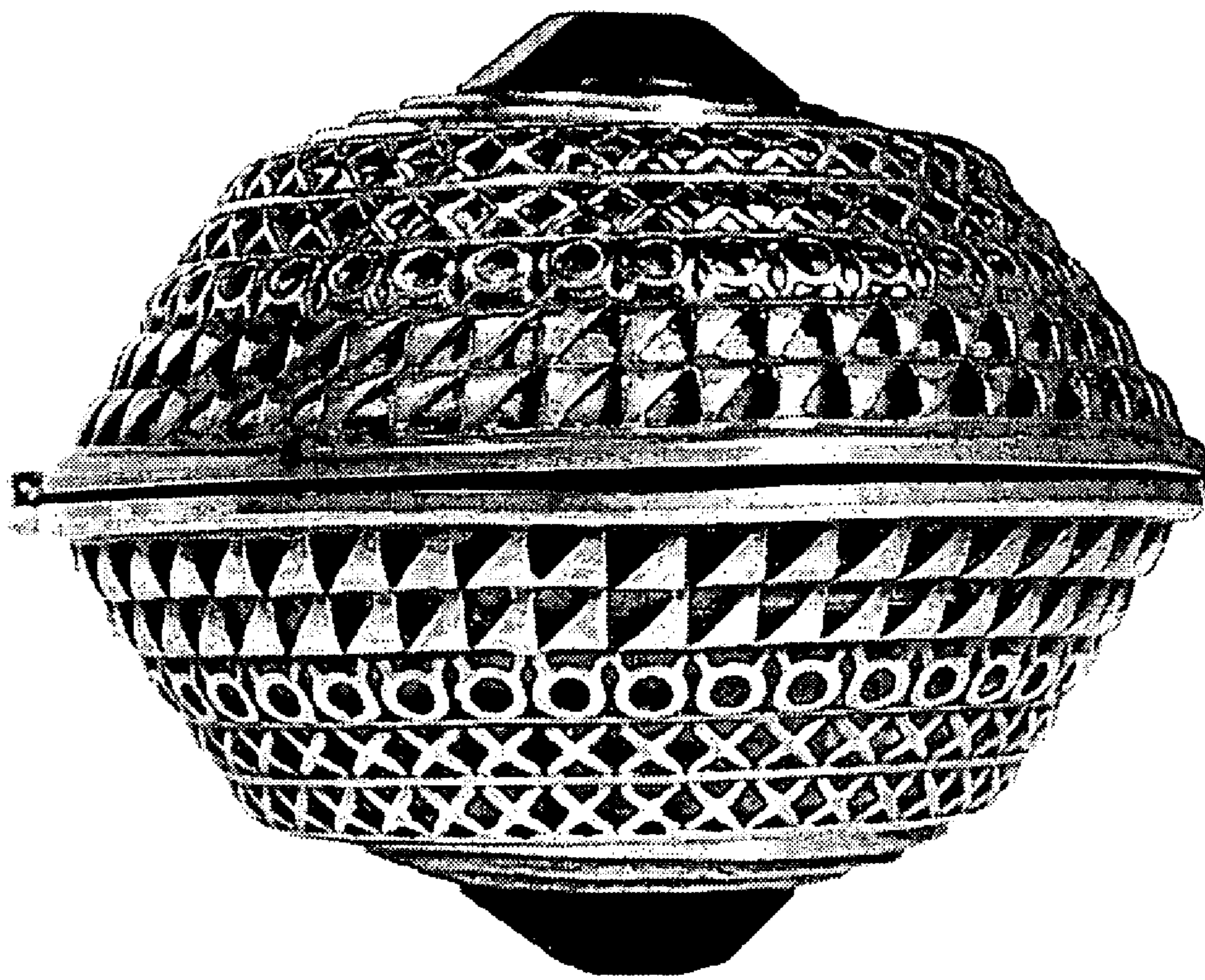

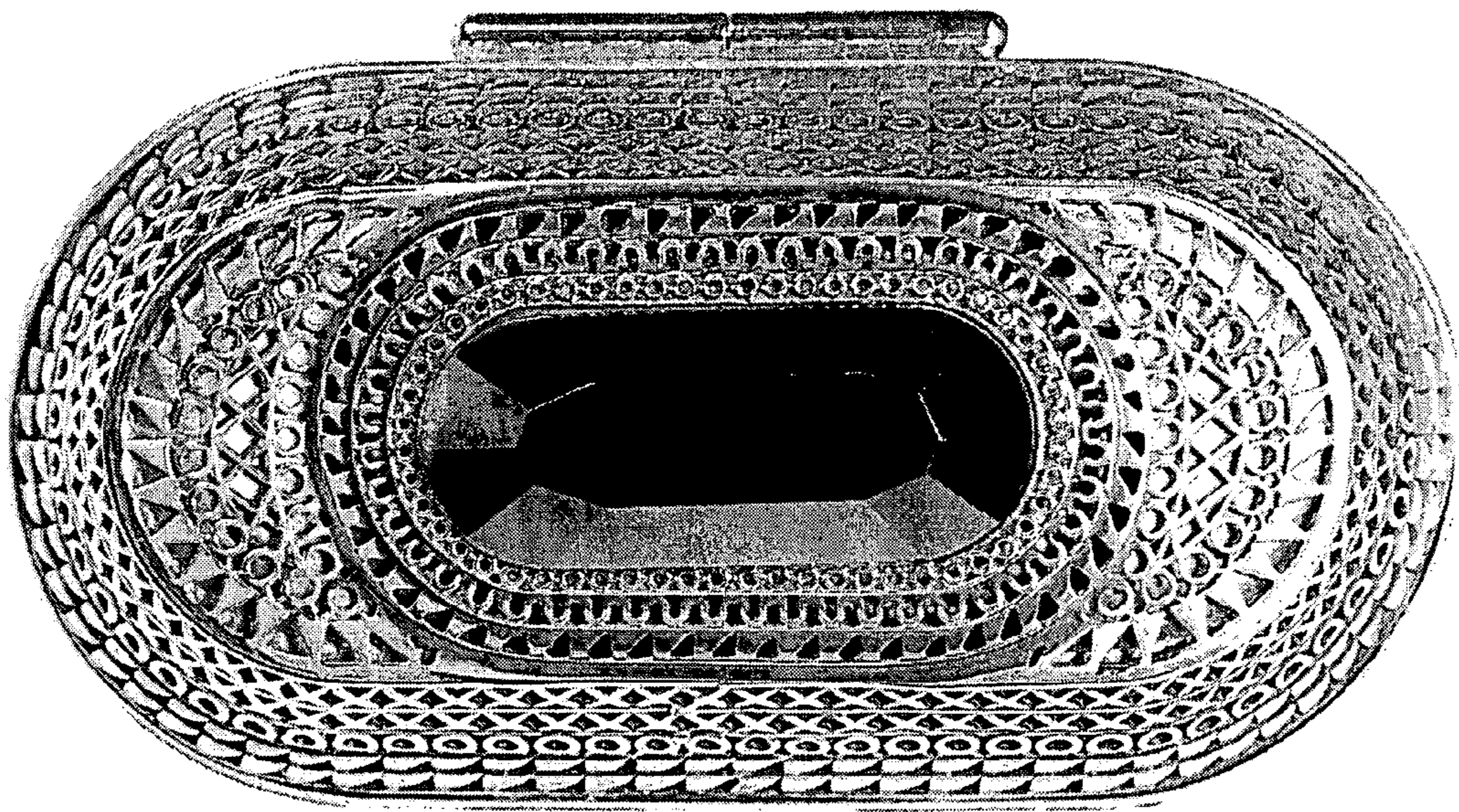
