(57) **CLAIM**

The ornamental design for a claim stake capsule with sealable and removable top and support extension, as shown and described.

DESCRIPTION

FIG. 1 is a side elevation view of the claim stake capsule with sealable and removable top and support extension with the top removed;

FIG. 2 is an opposite side elevation view thereof;

FIG. 3 is a front elevation view thereof;

FIG. 4 is a rear elevation view thereof;

FIG. 5 is a top plan view thereof showing the exterior of the top and the interior of the body;

FIG. 6 is a bottom view thereof showing the interior of the top and the bottom exterior of the body; and,

FIG. 7 is a perspective view thereof.

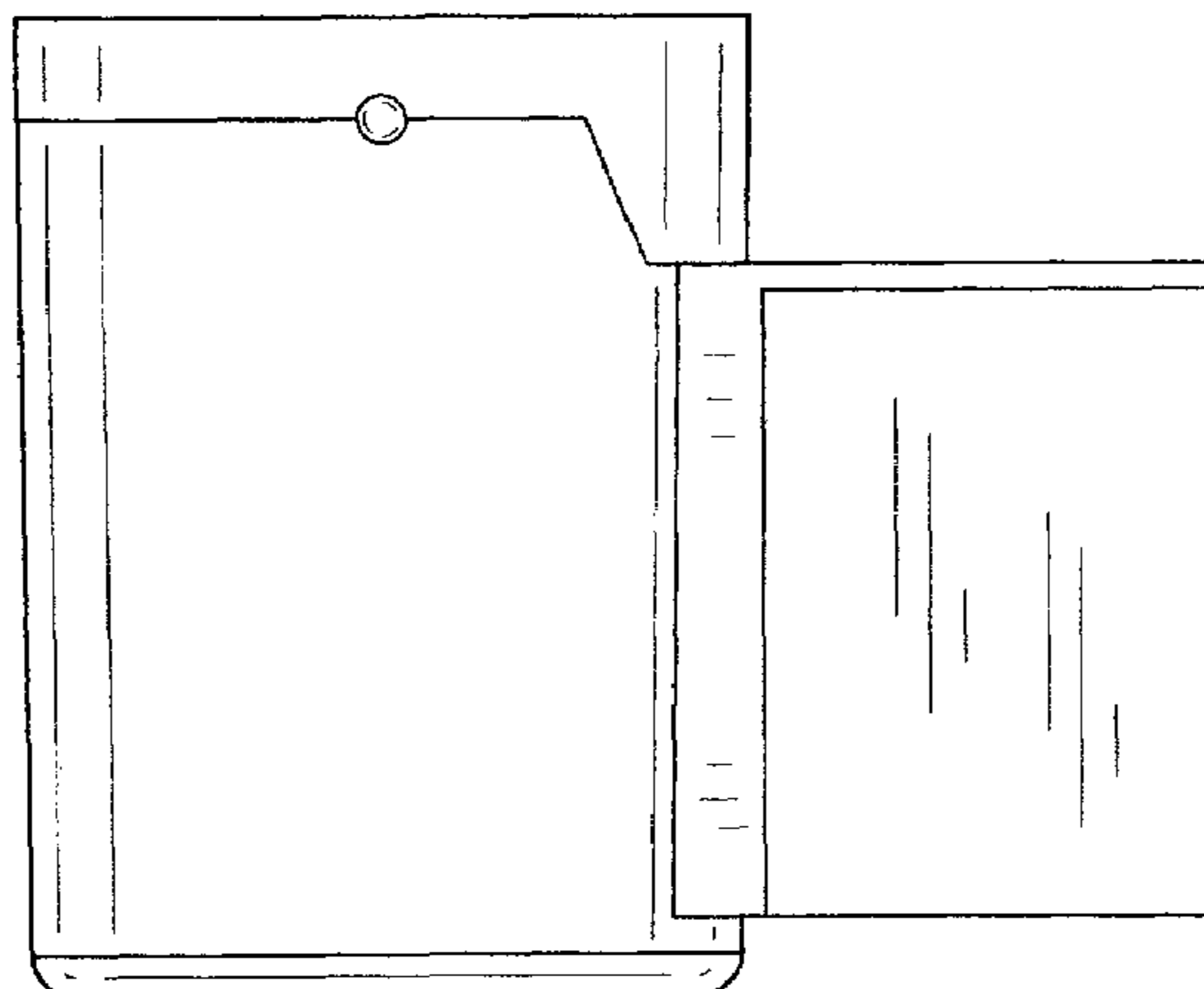
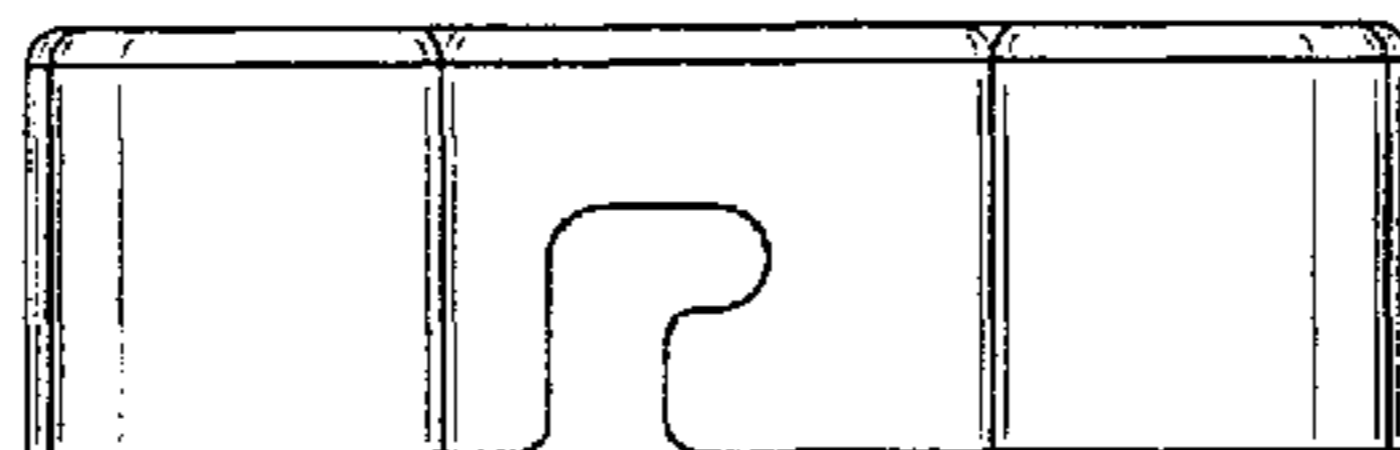

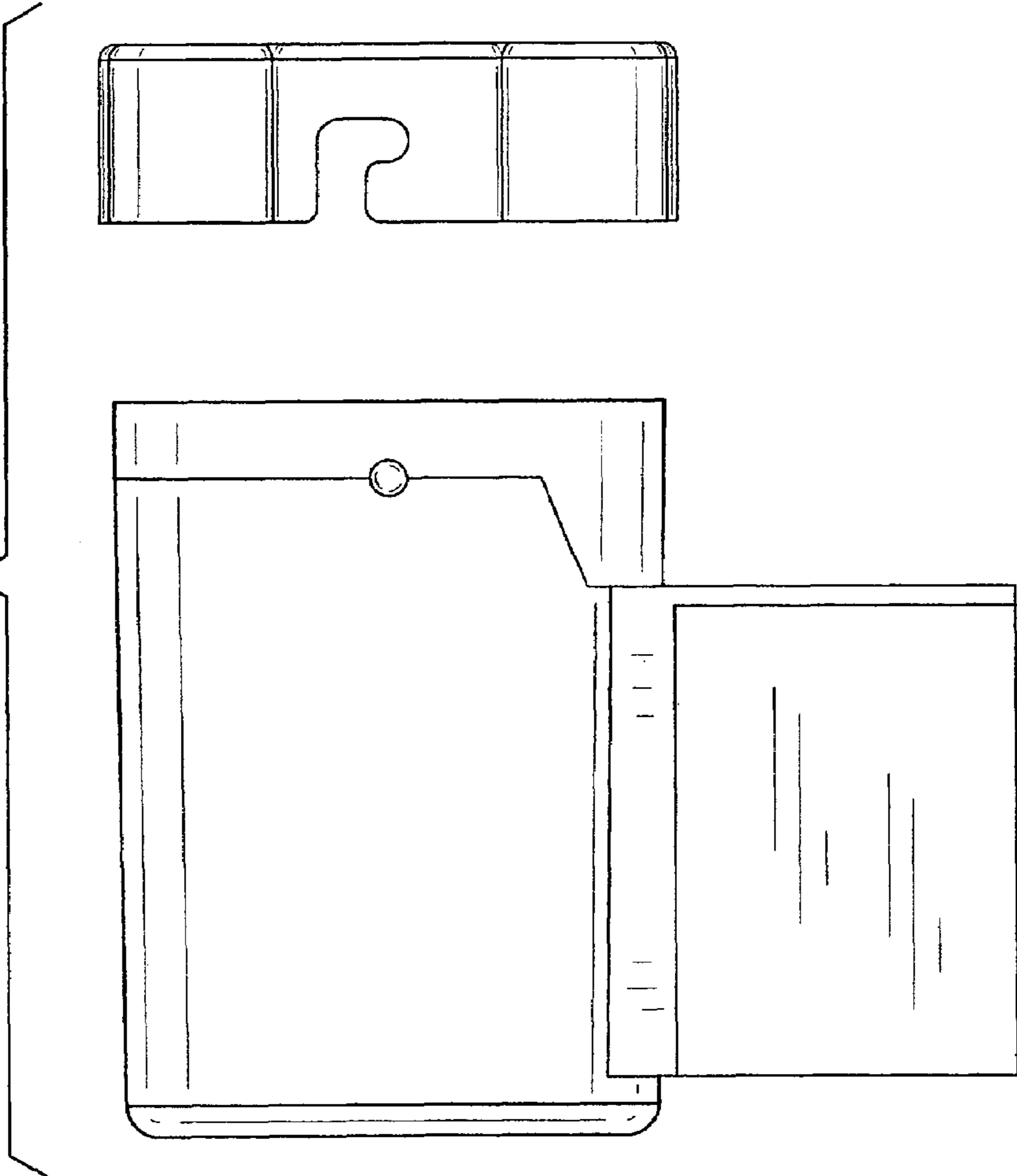
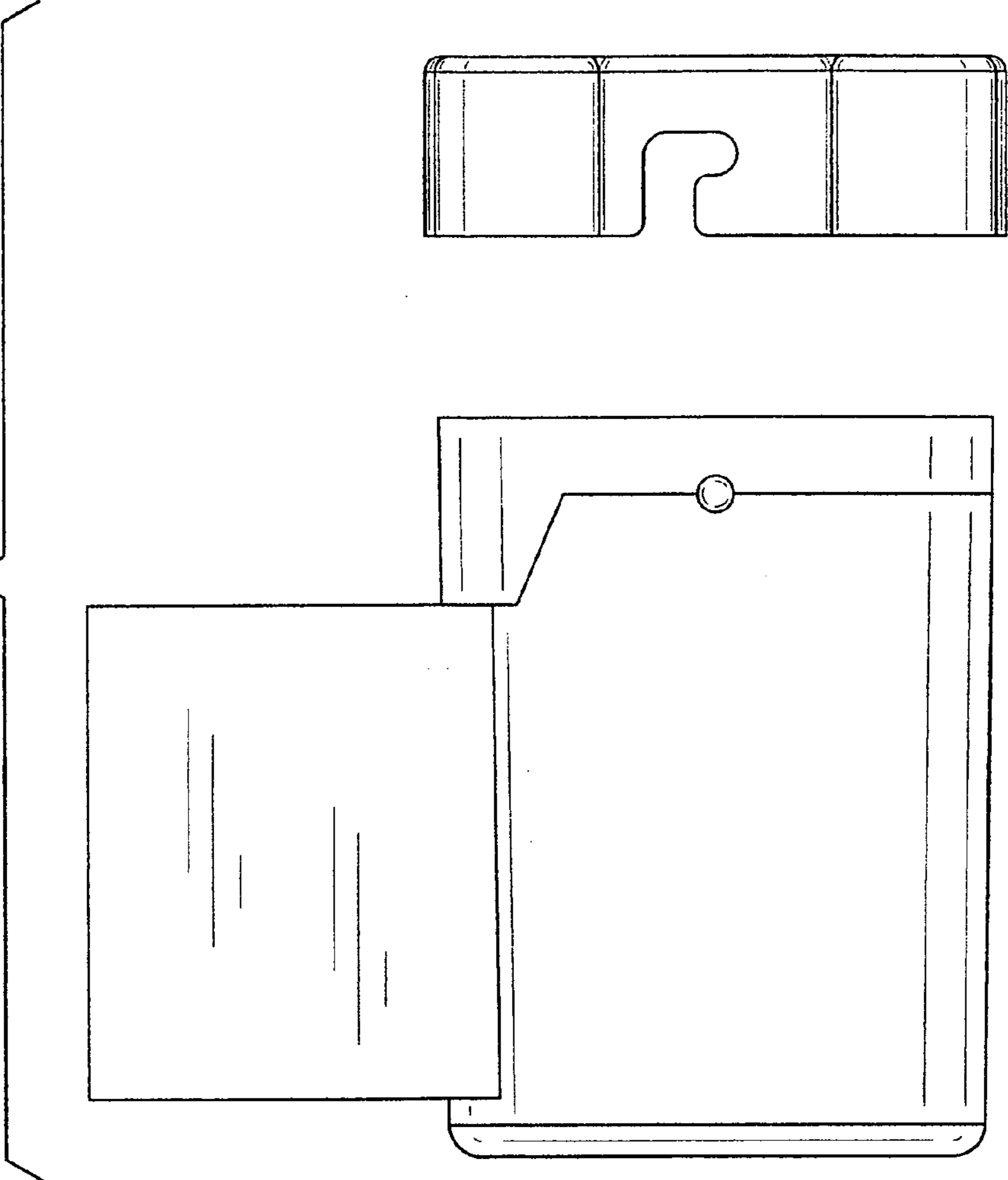

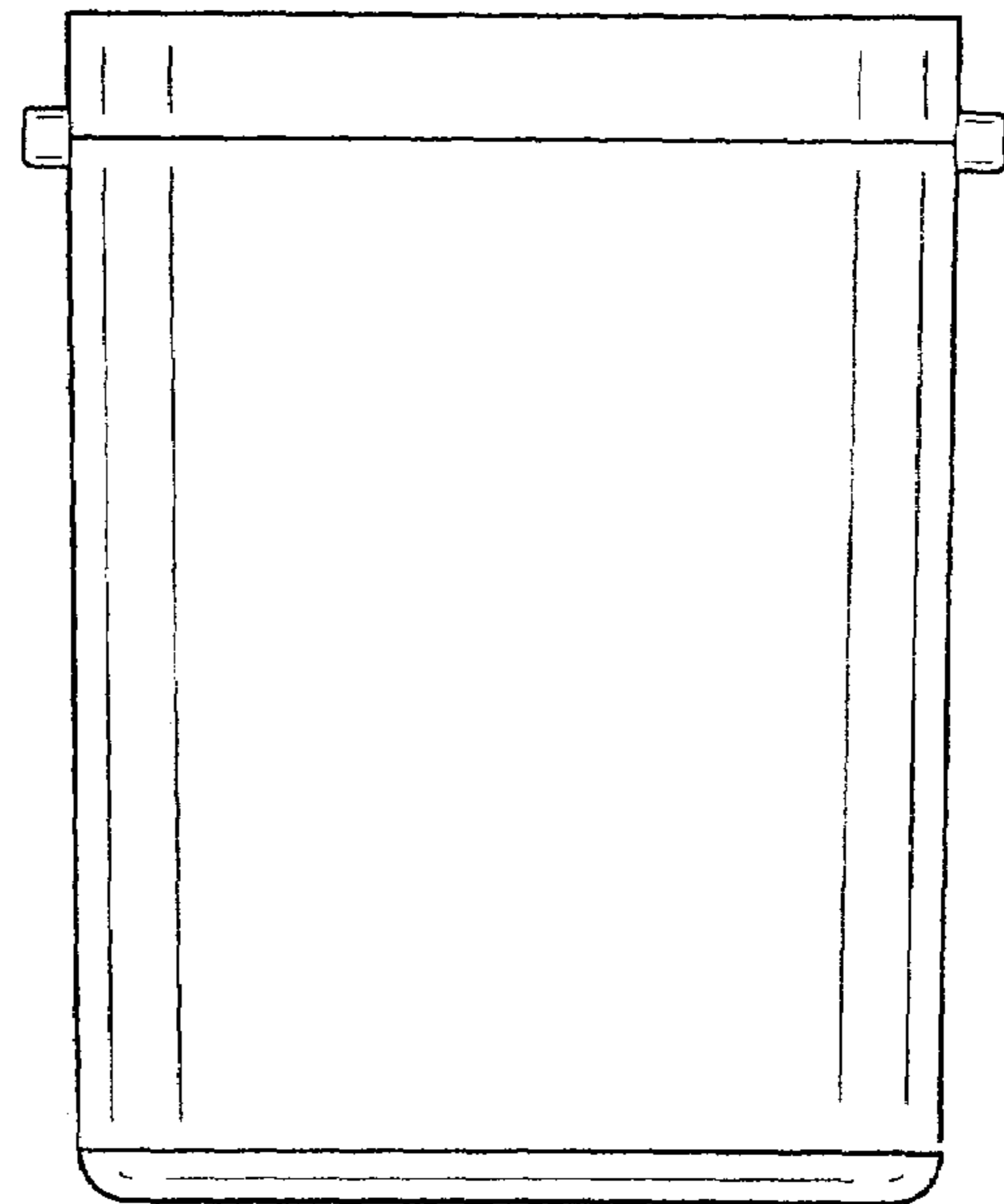
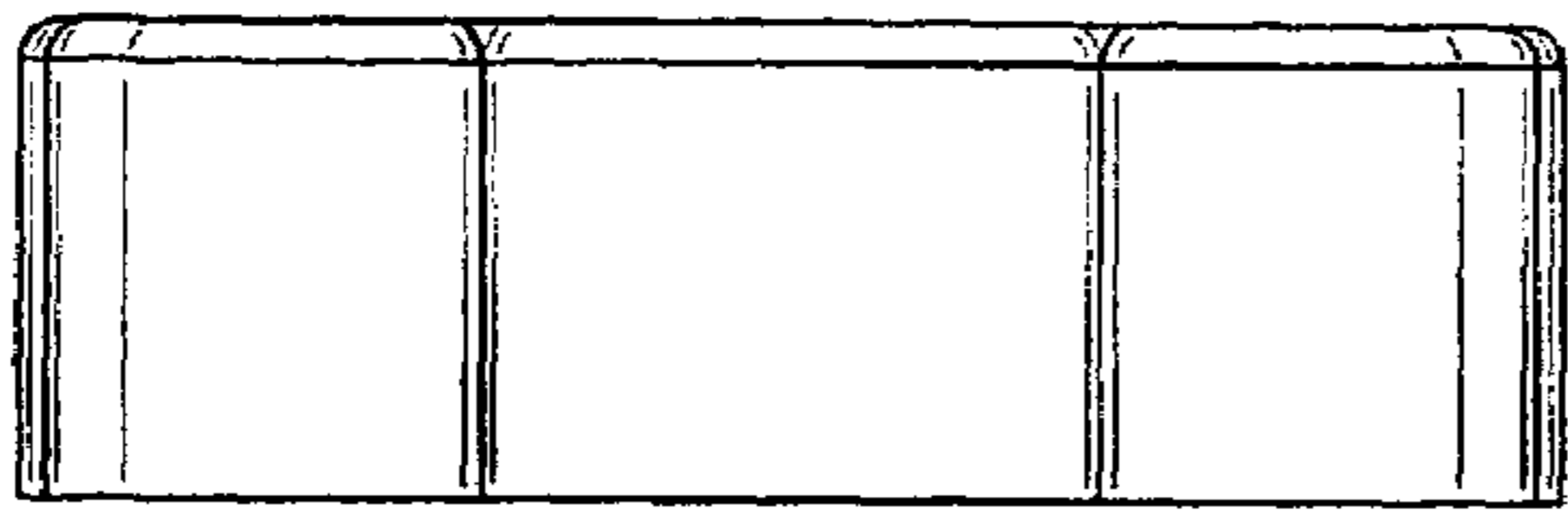

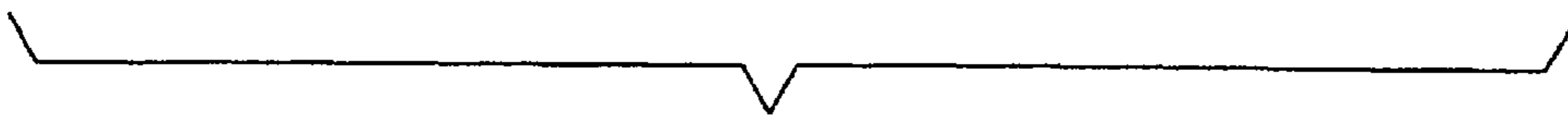
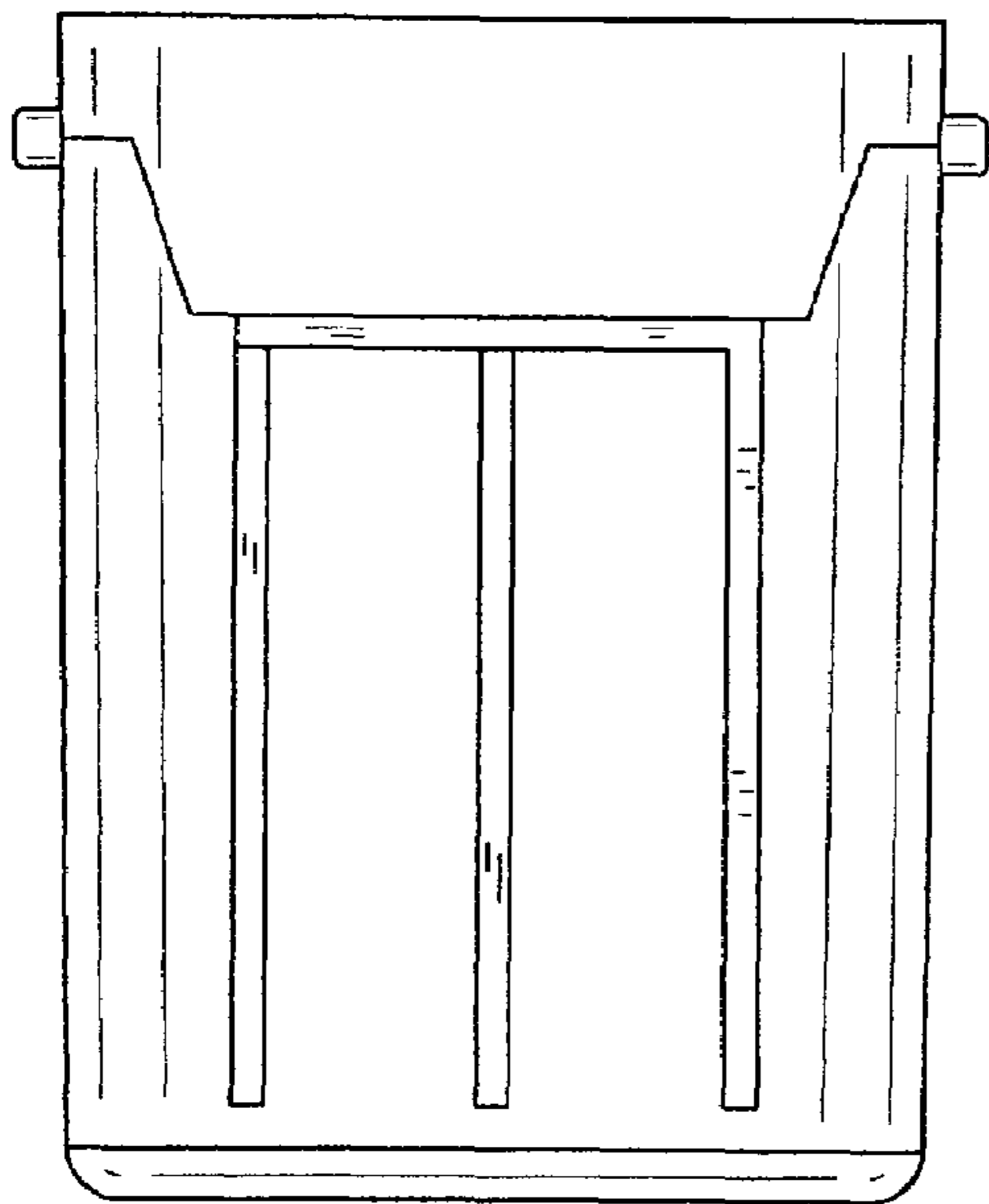
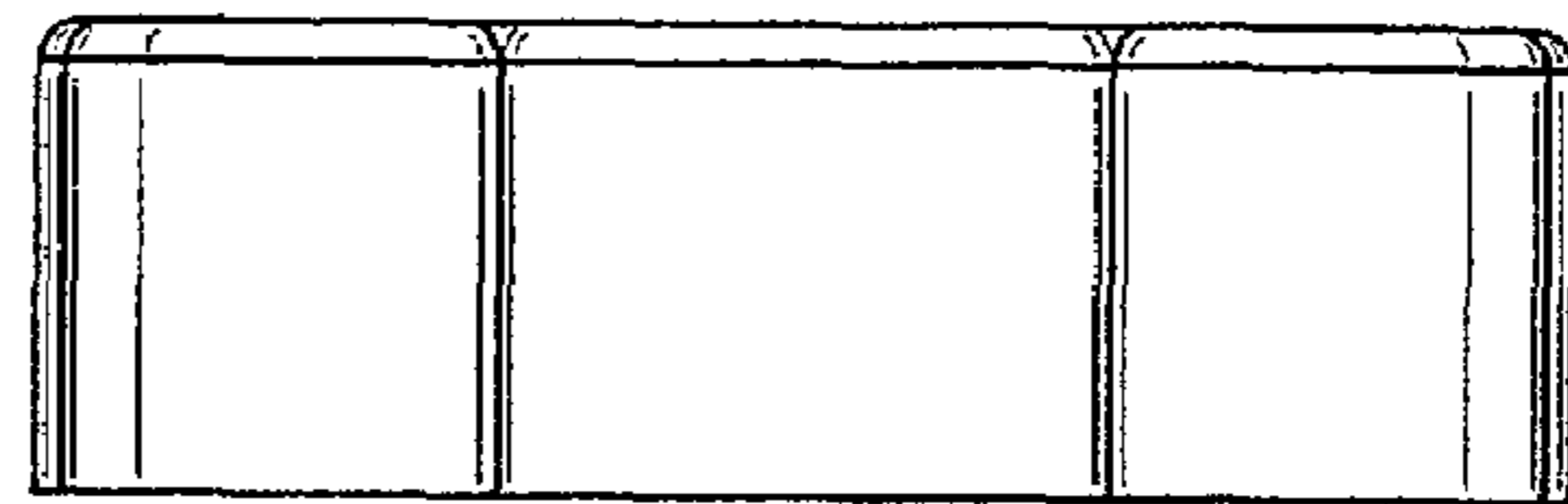
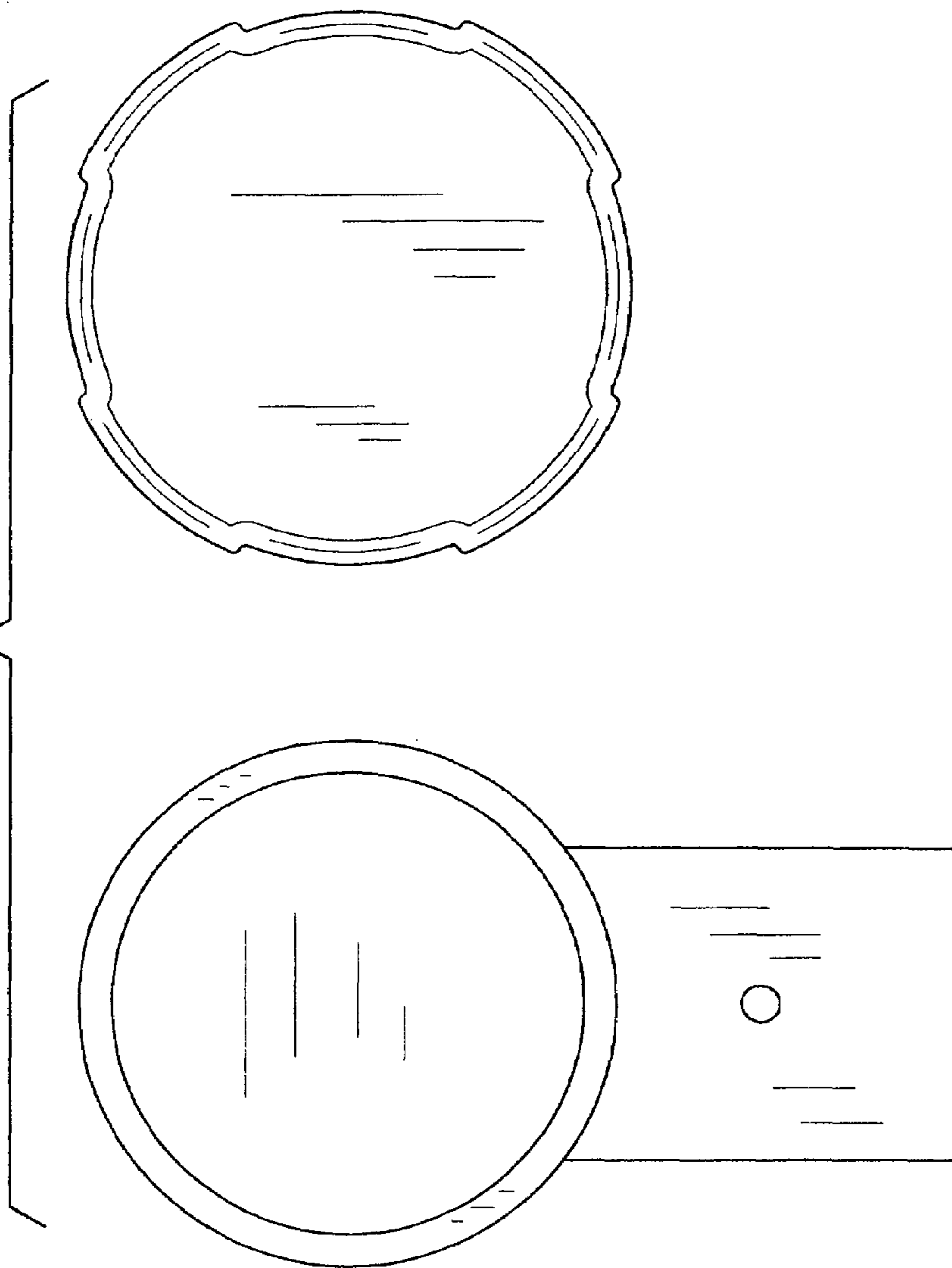

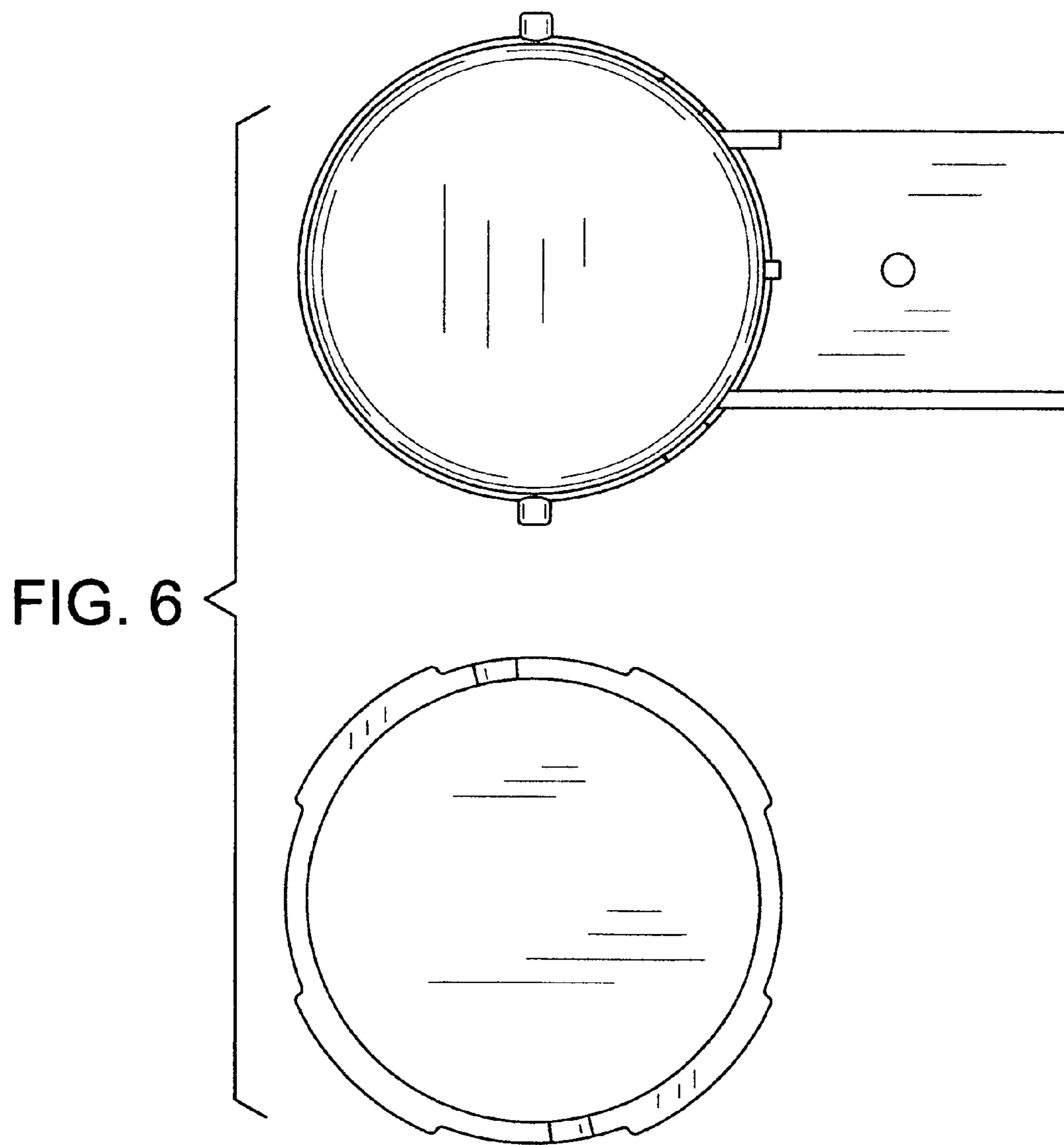
