FIG. 2 is a frontal view of the bag/pouch of FIG. 1;

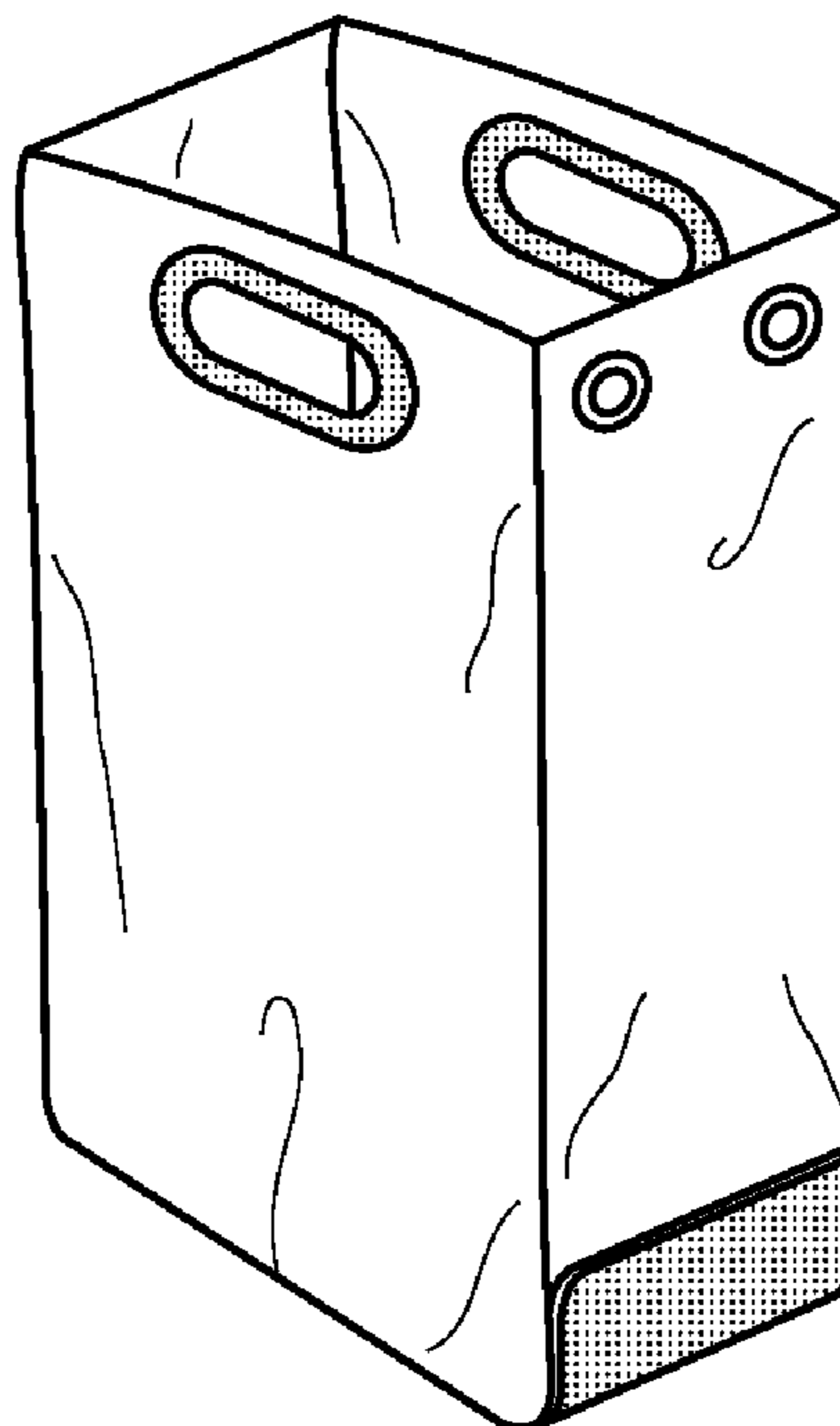
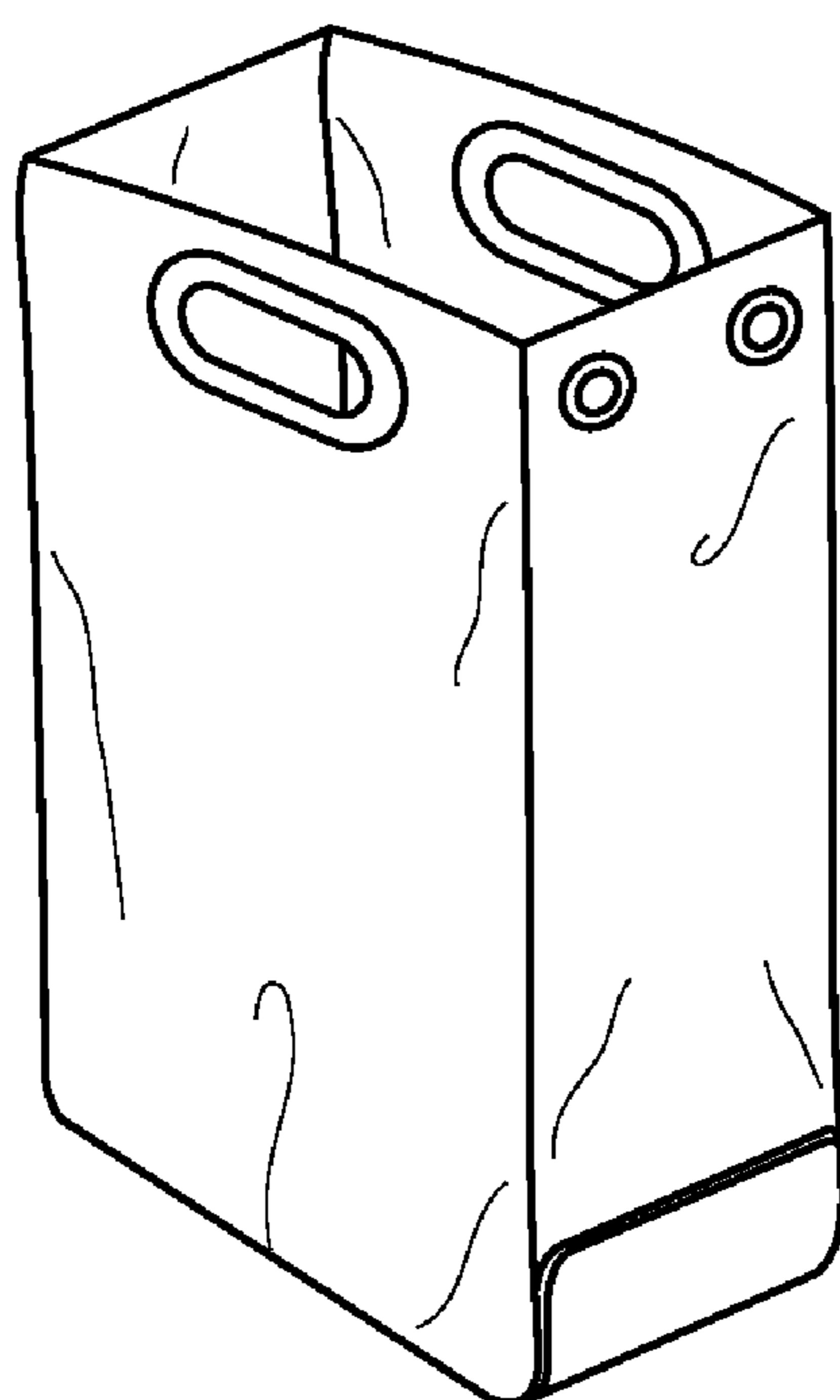
FIG. 3 is a side view of the bag/pouch of FIG. 1;

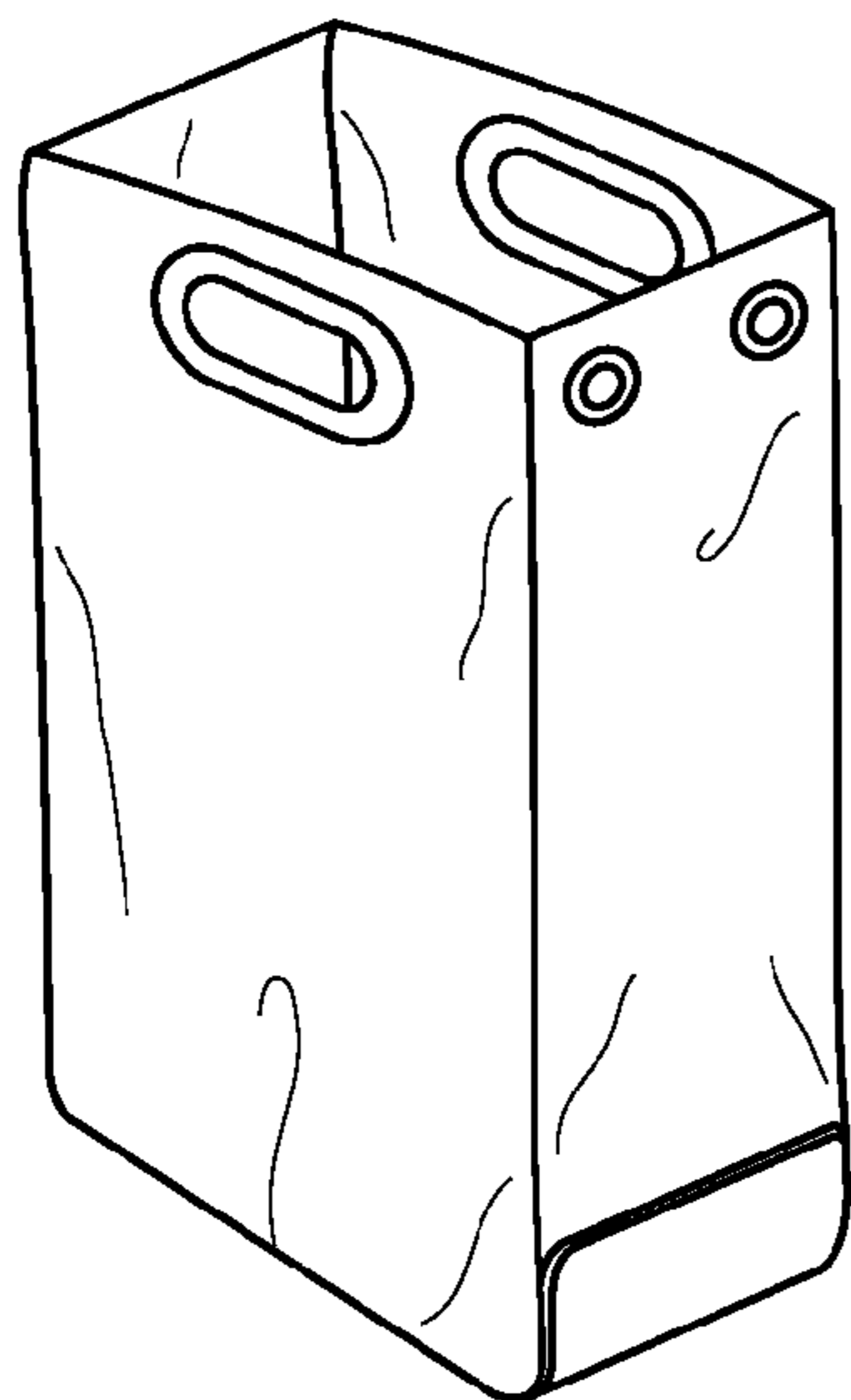

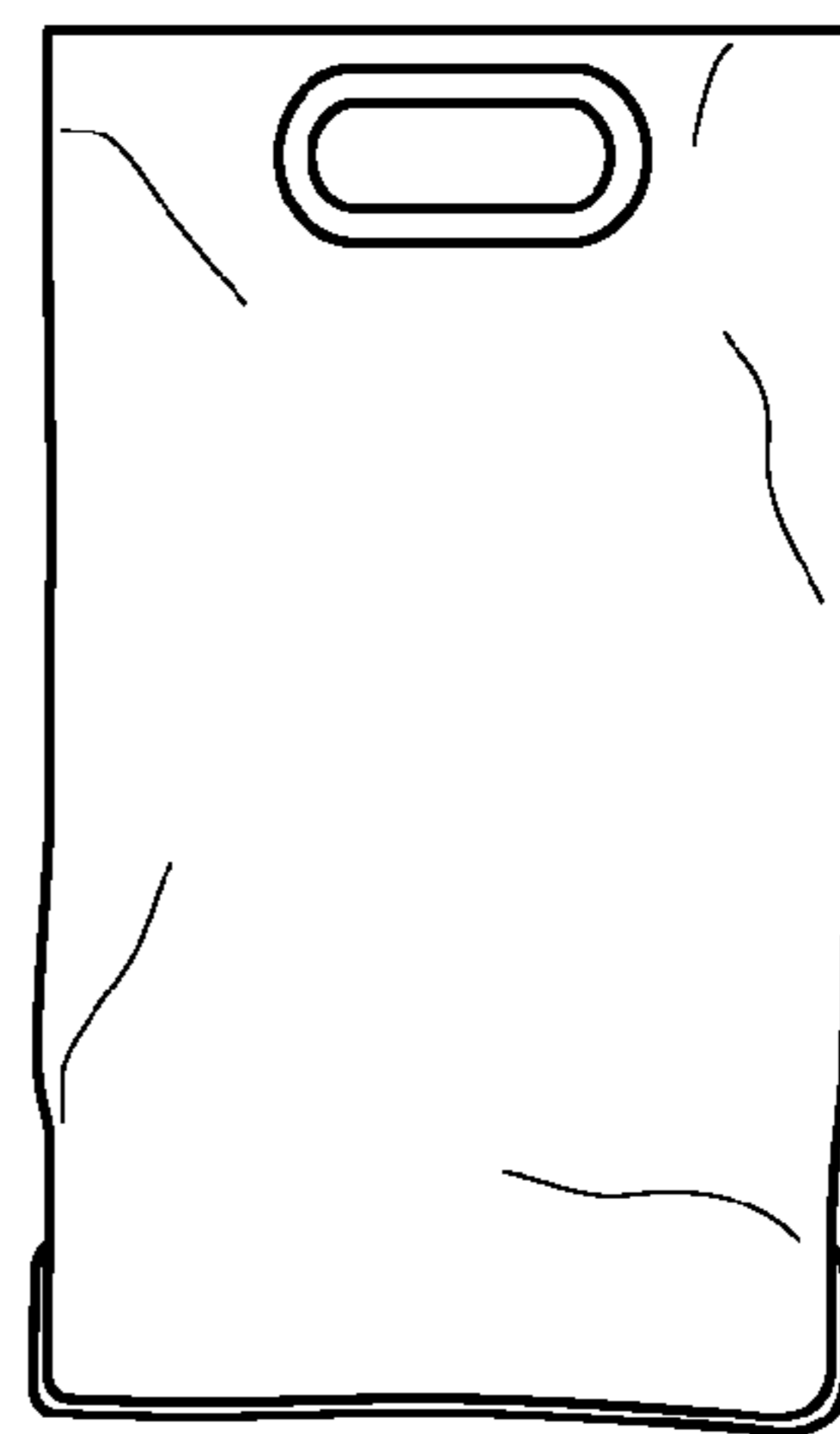

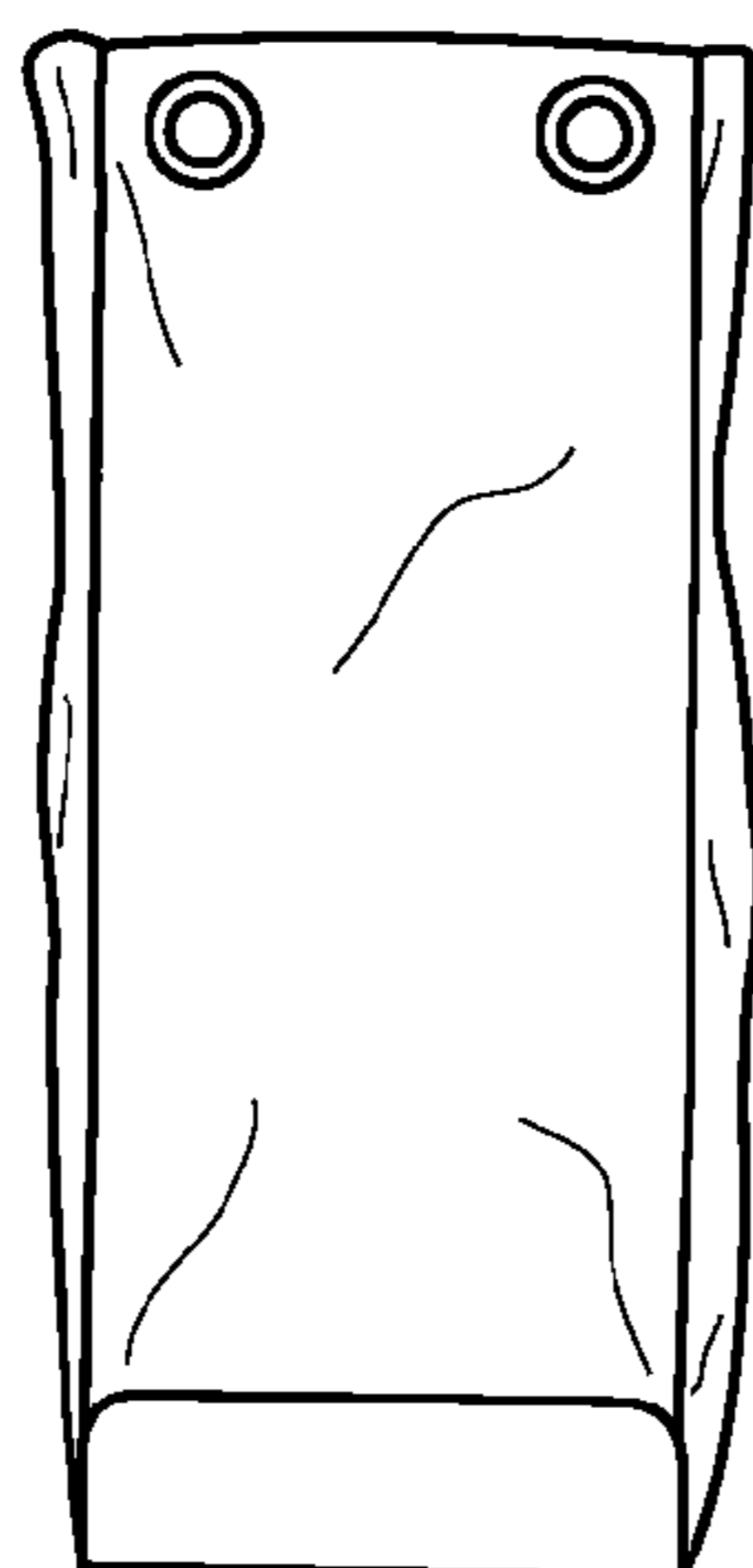

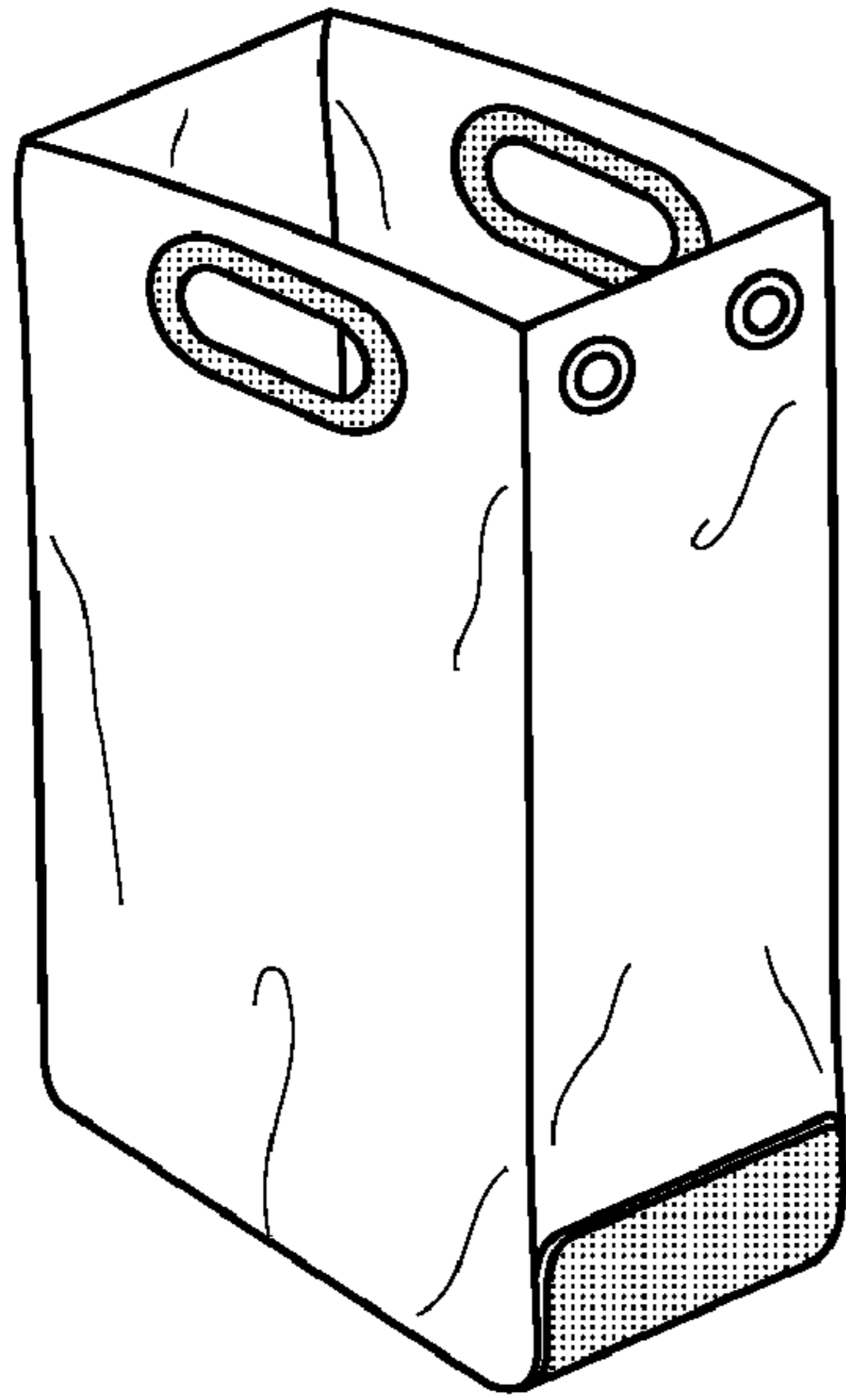

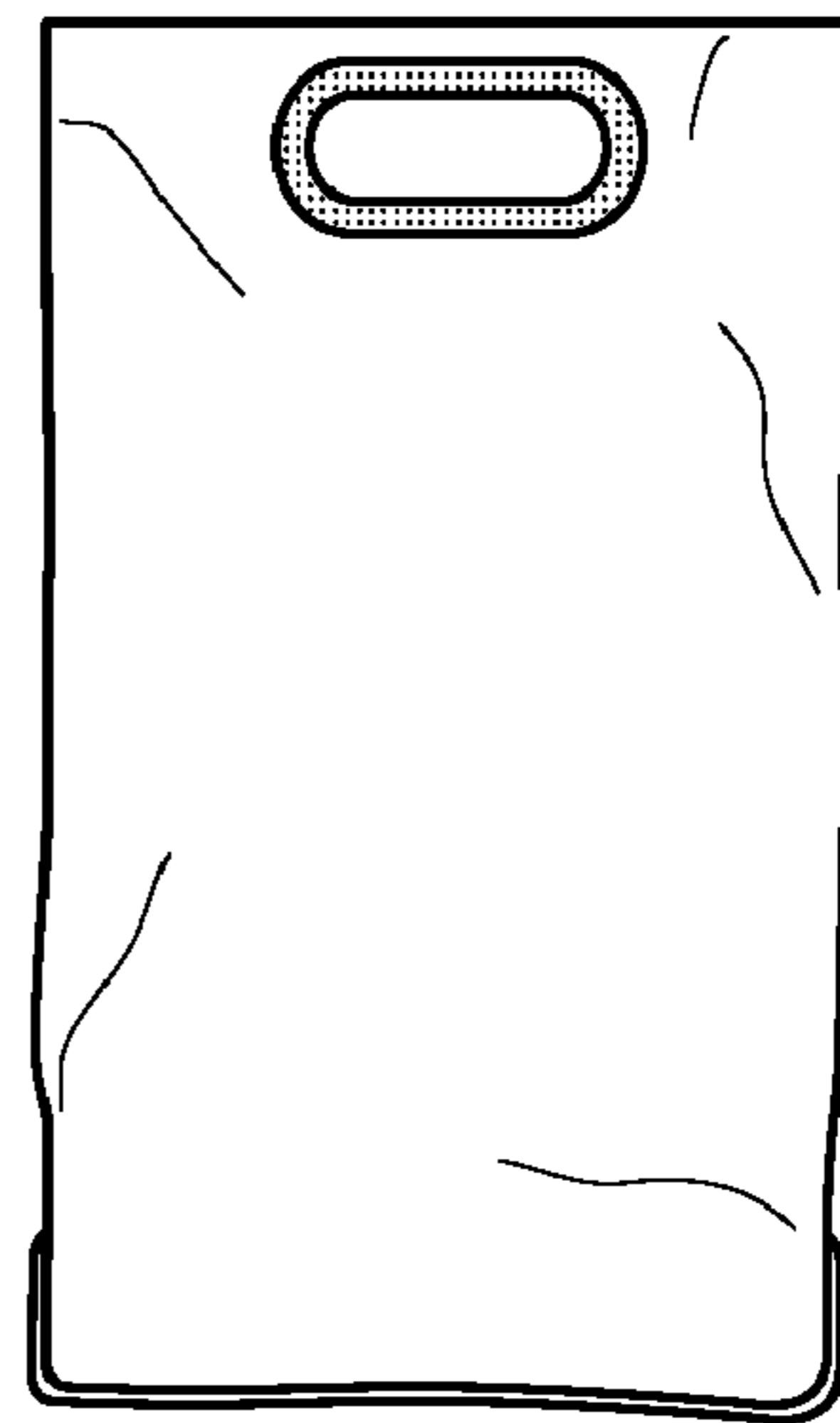

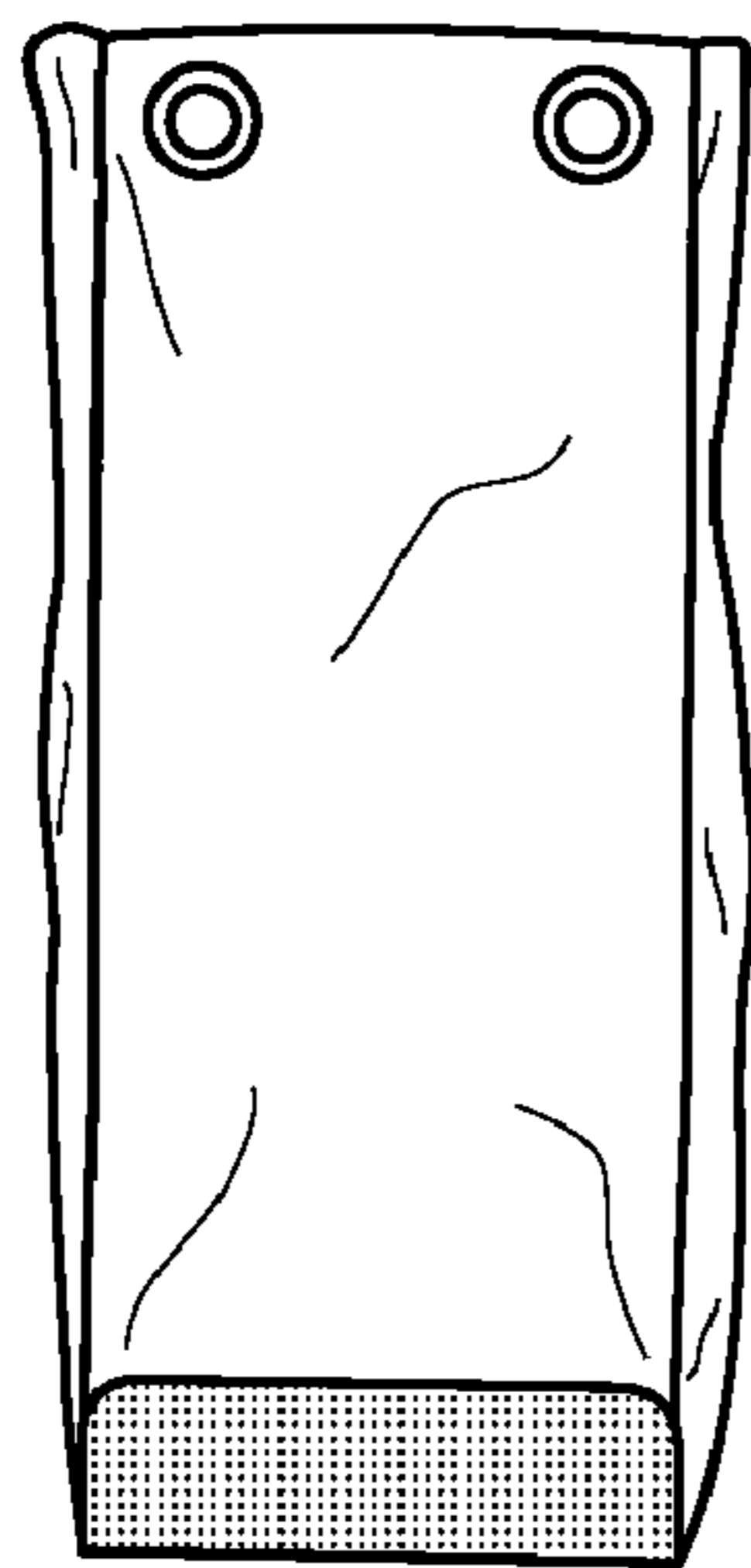
