(57) **CLAIM**

The ornamental design for a wall basket, substantially as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a basket showing my new design;

FIG. 2 is a rear elevational view thereof;

FIG. 3 is a side elevational view thereof, the opposite side view being a mirror image thereof;

FIG. 4 is a top view the broken lines form no part of the claimed design thereof;

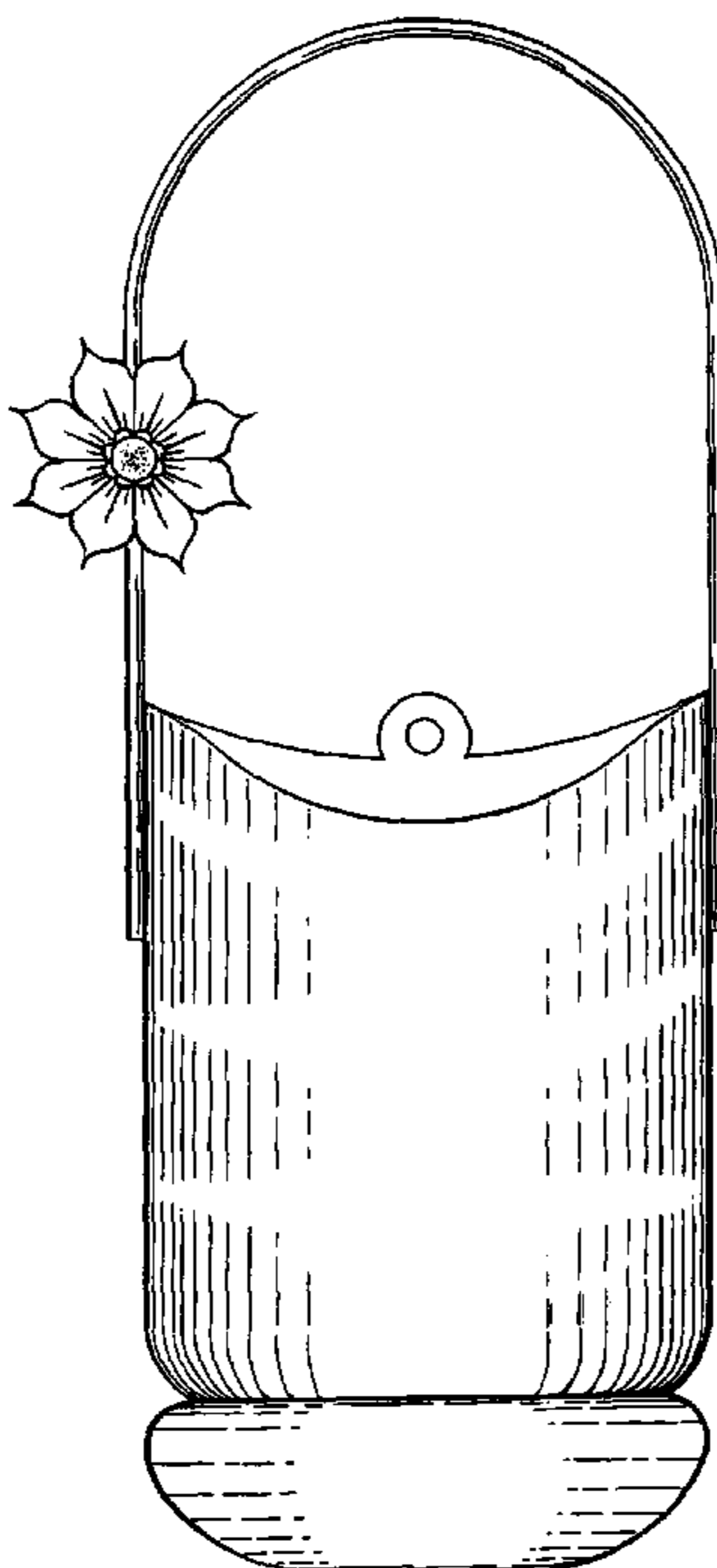
FIG. 5 is a cross sectional view taken along line 5—5 of FIG. 3, the broken lines form no part of the claimed design thereof;

FIG. 6 is a cross sectional view taken along 6—6 of FIG. 3, the broken lines form no part of the claimed design thereof; and,

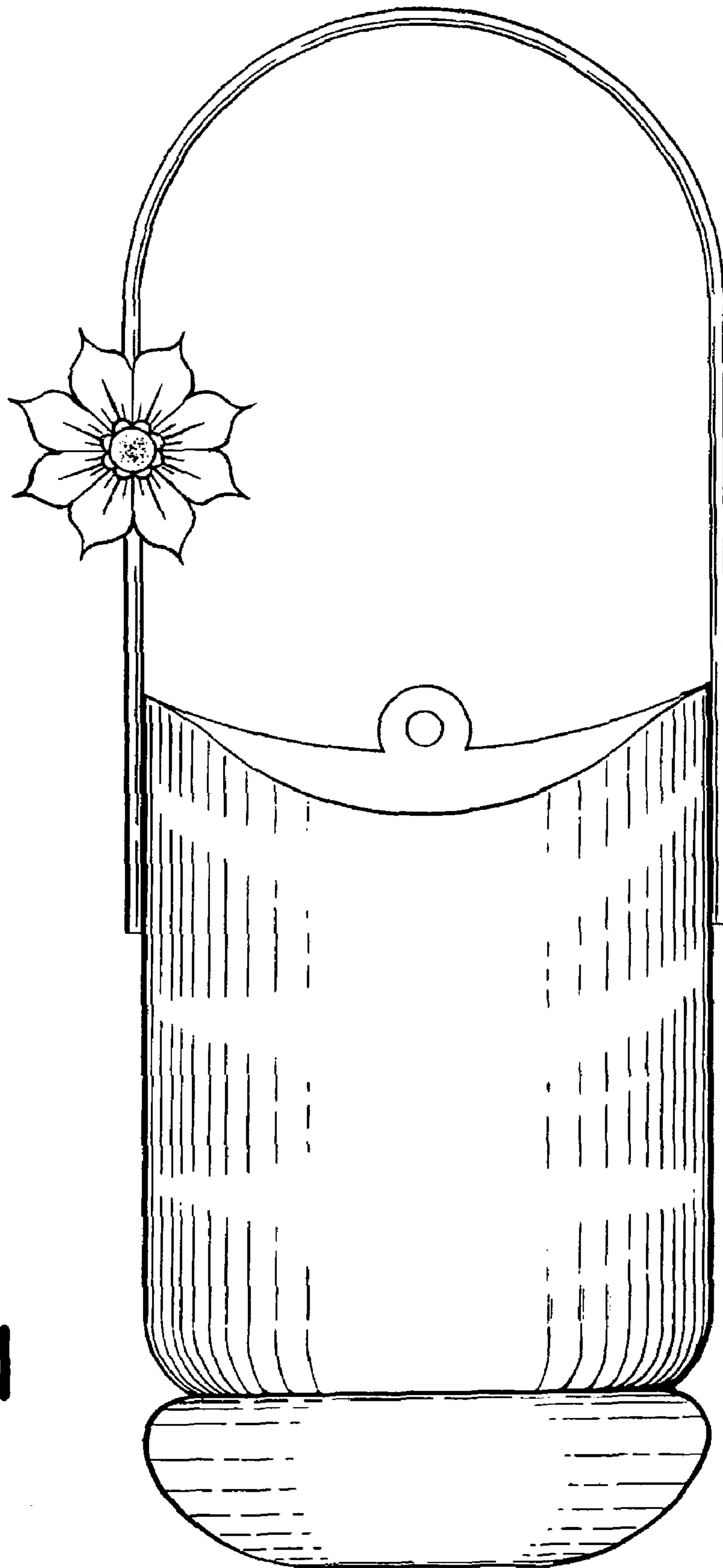

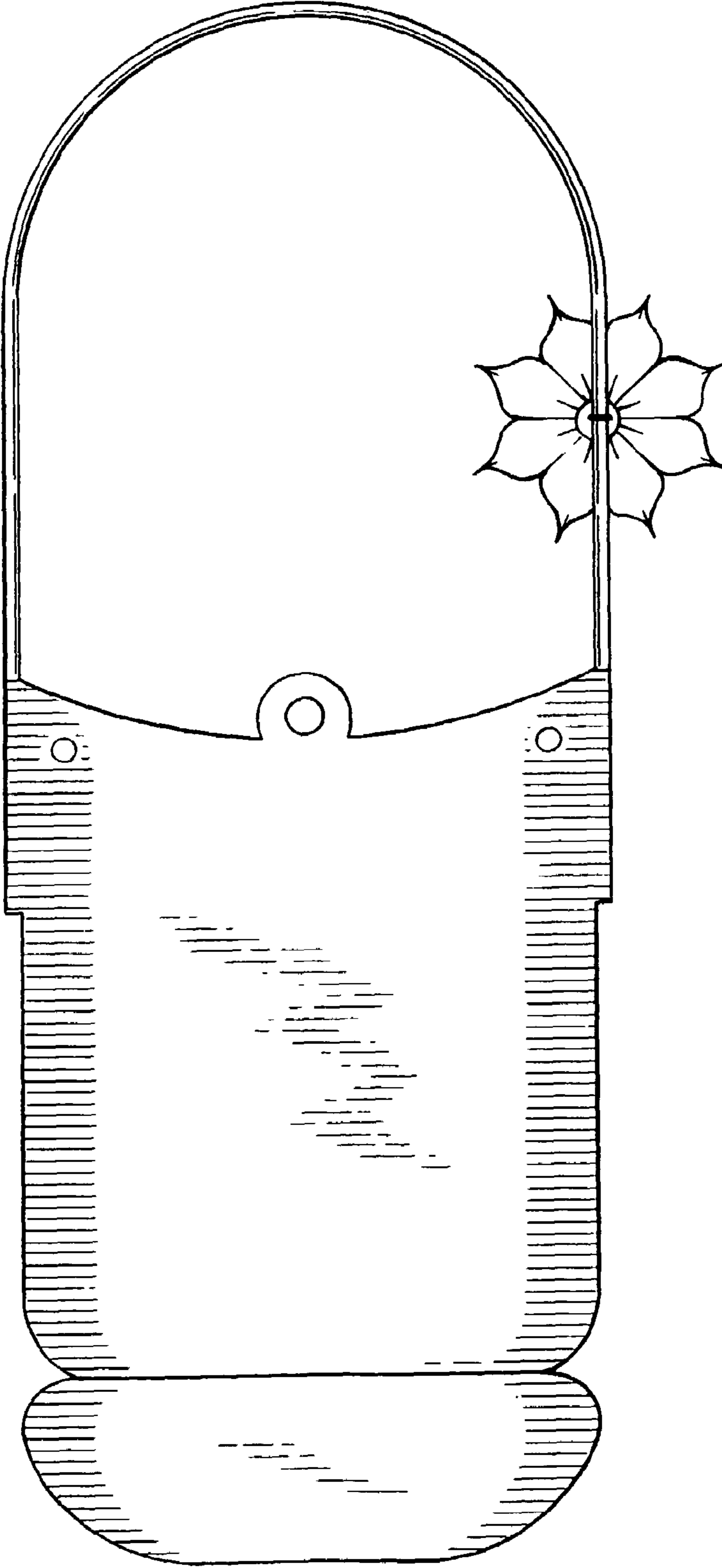

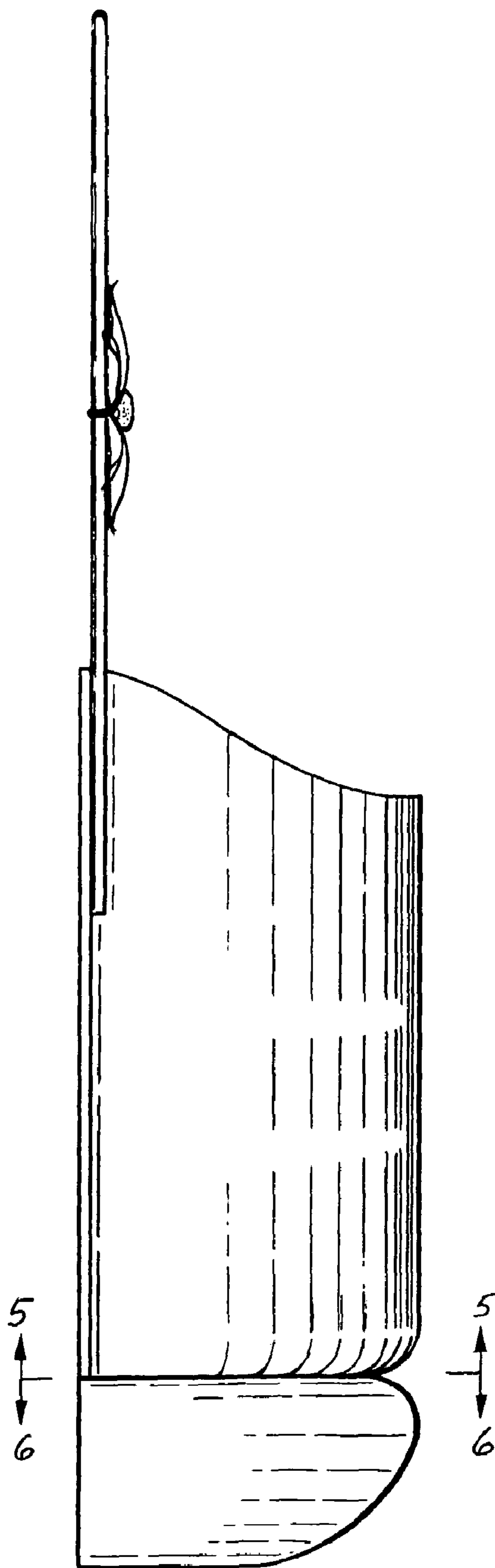

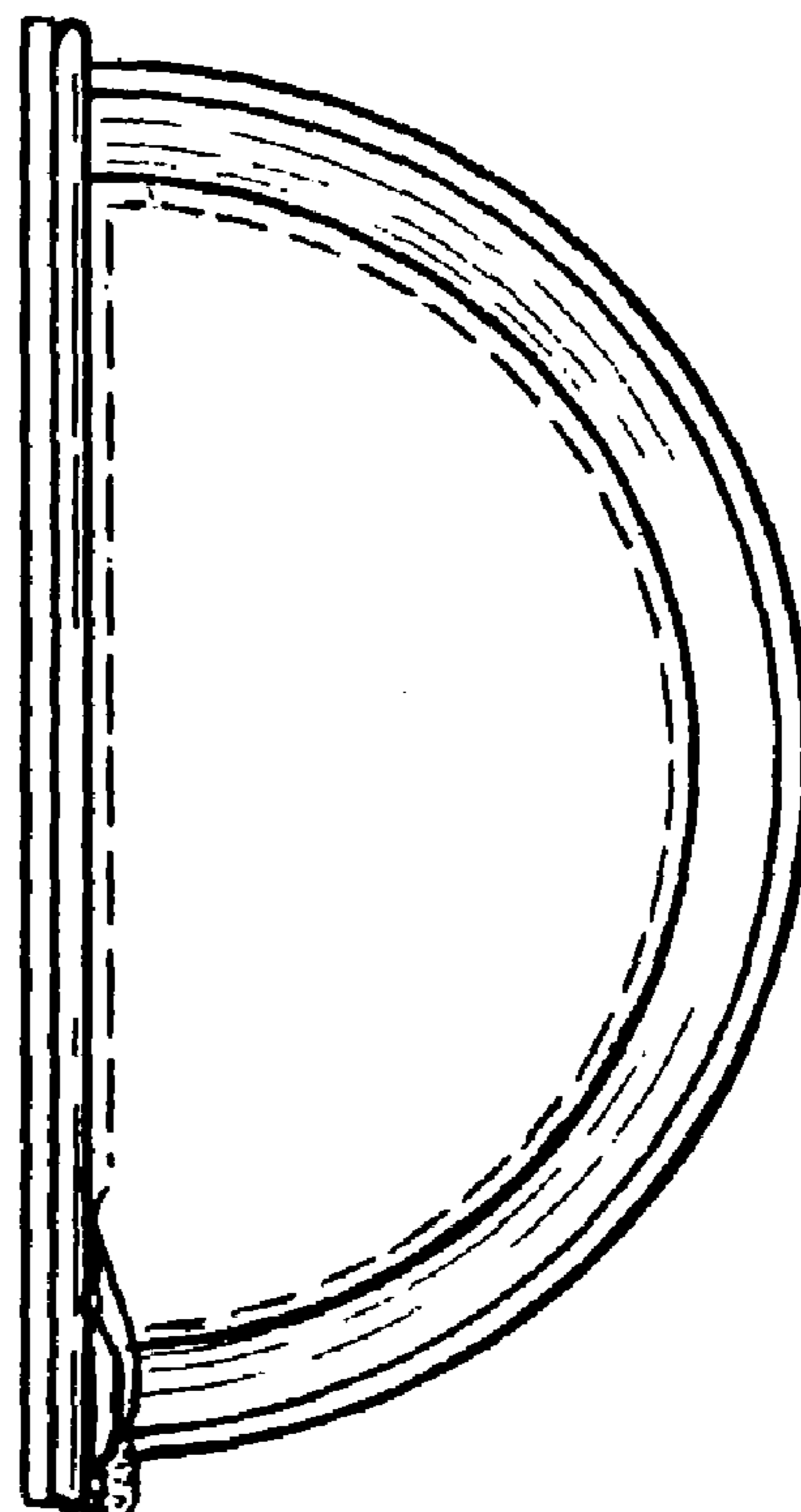
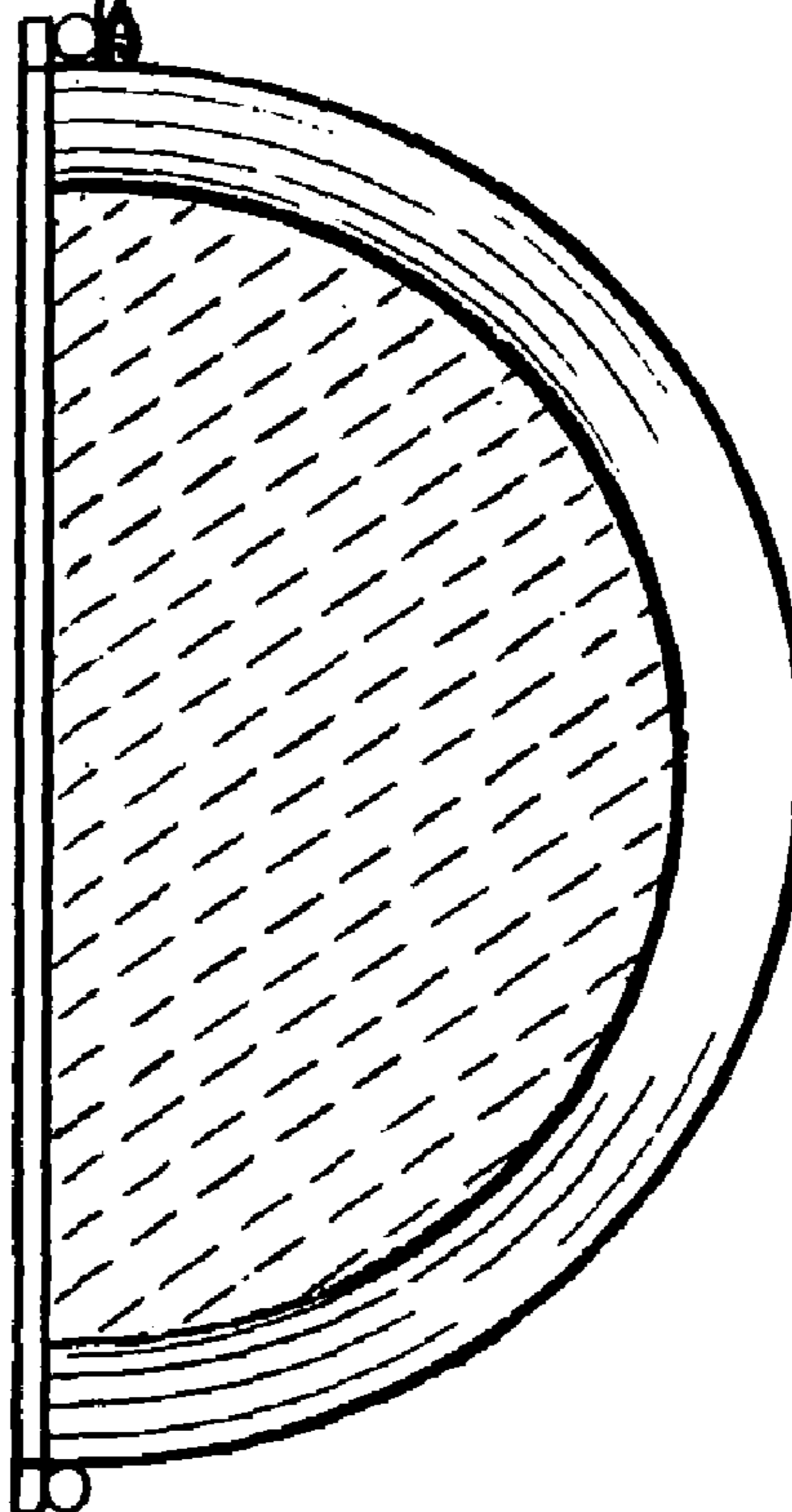

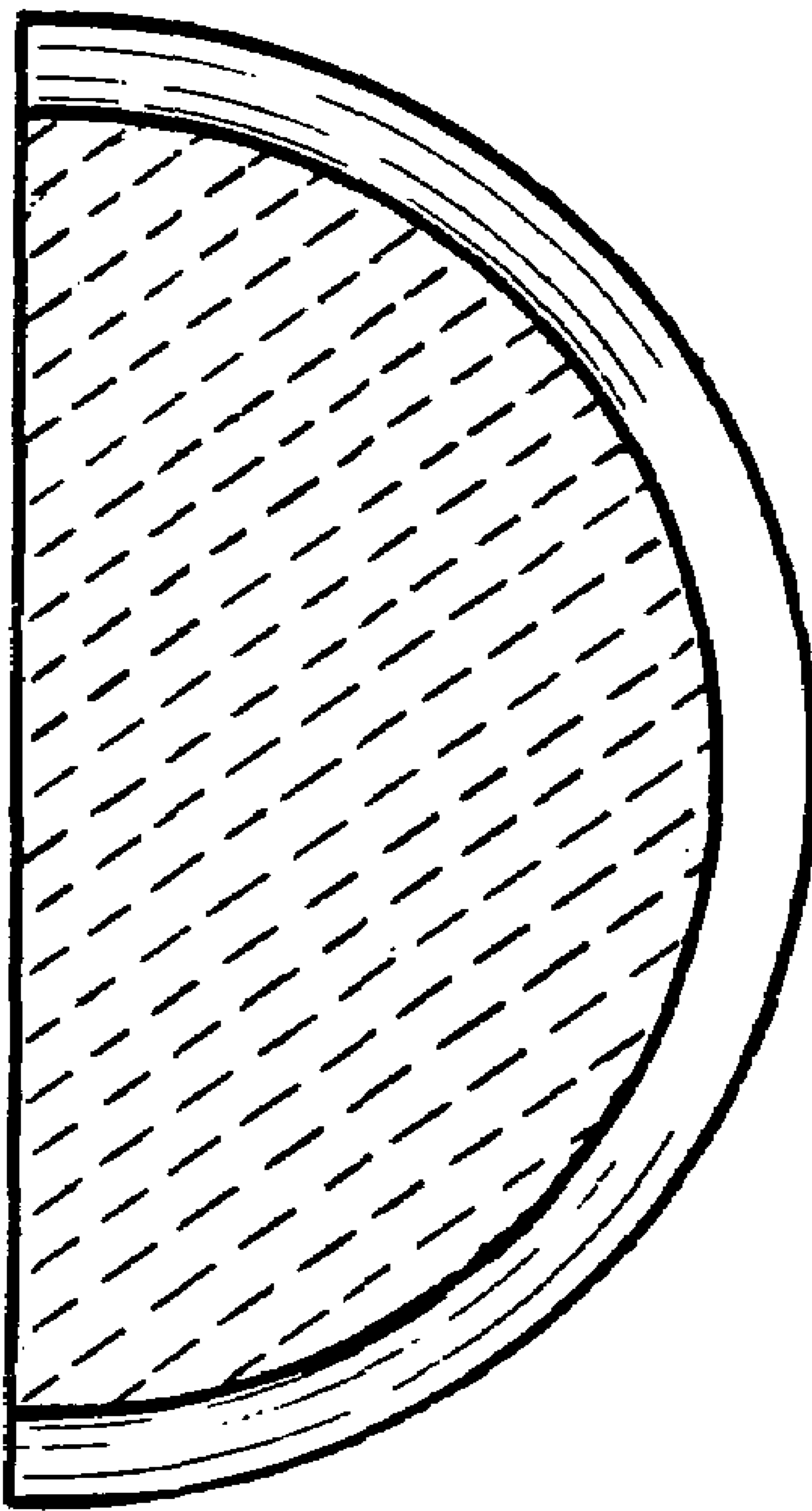

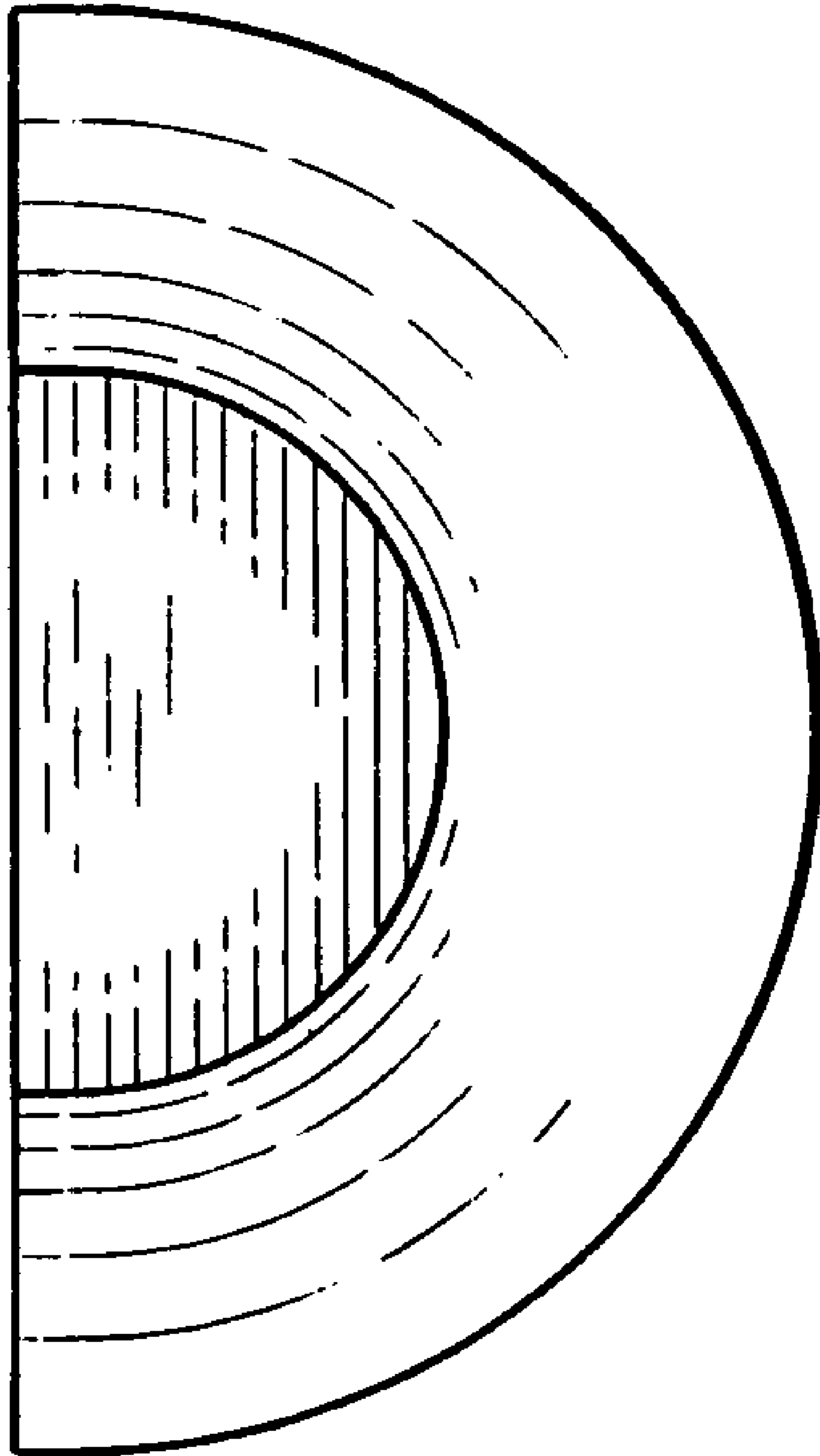
