**DESCRIPTION**

FIG. 1 is a perspective view of a utensil handle showing our new design;

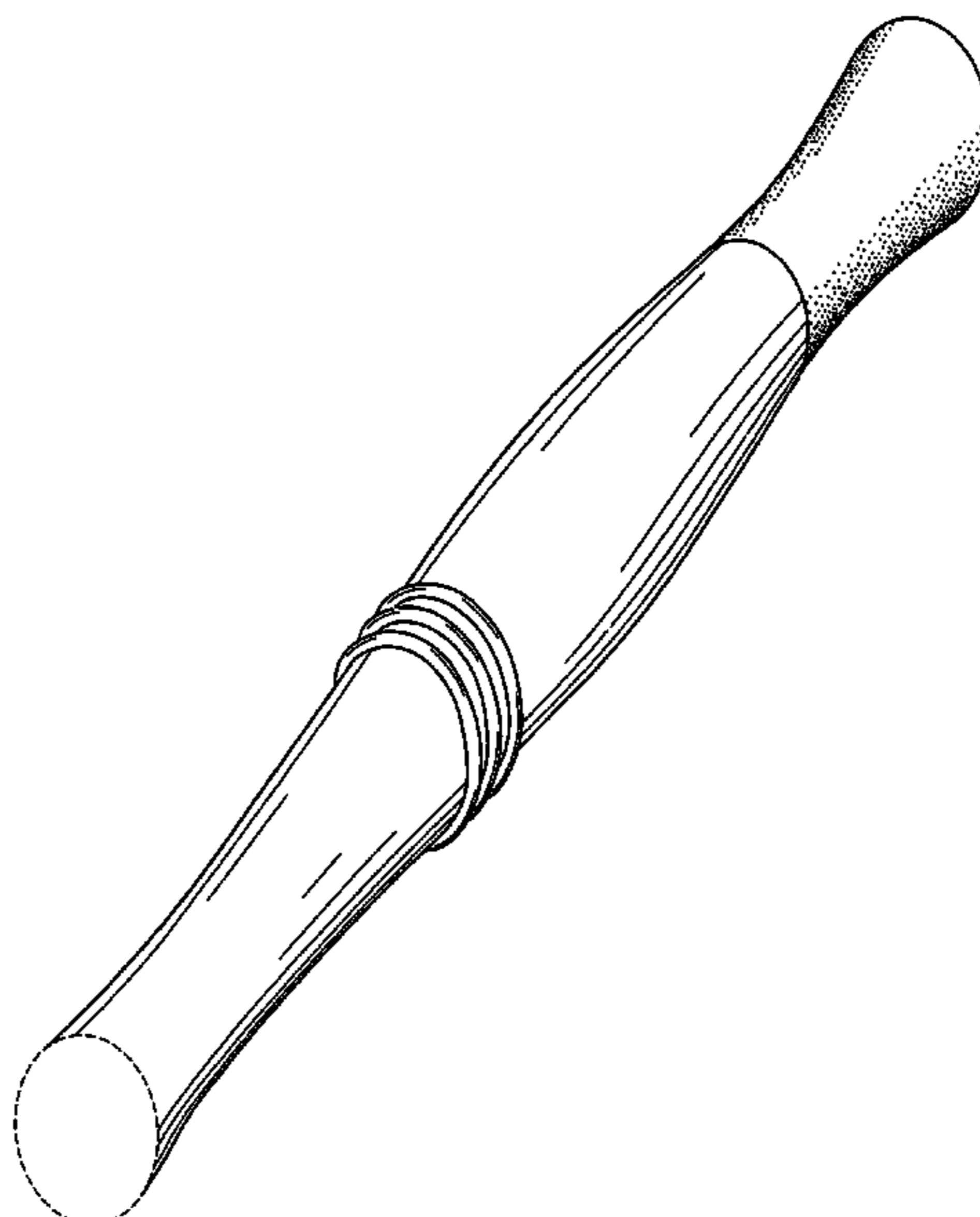
FIG. 2 is a left side, elevational view of the utensil, handle of FIG. 1, the right side being a mirror image thereof;

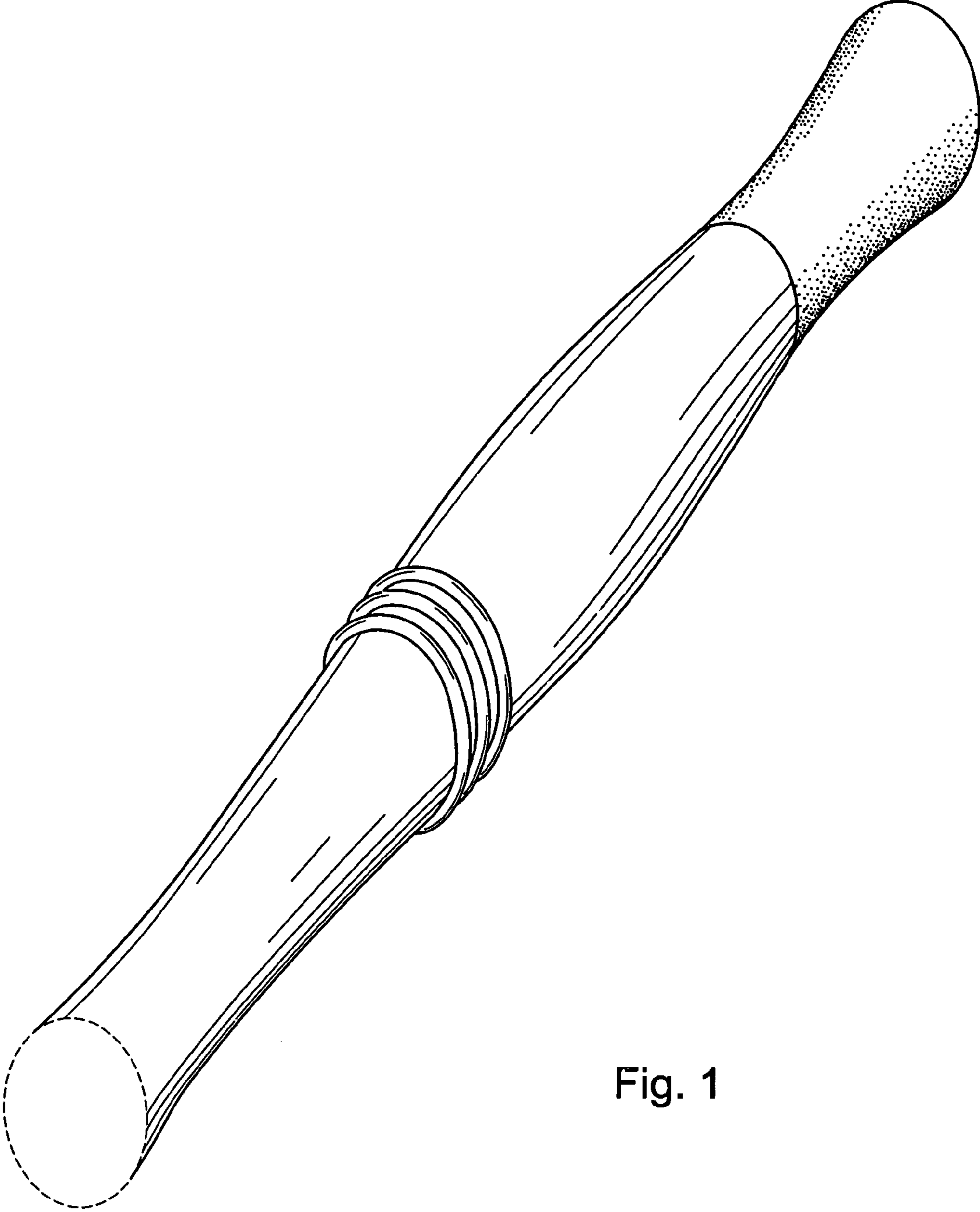

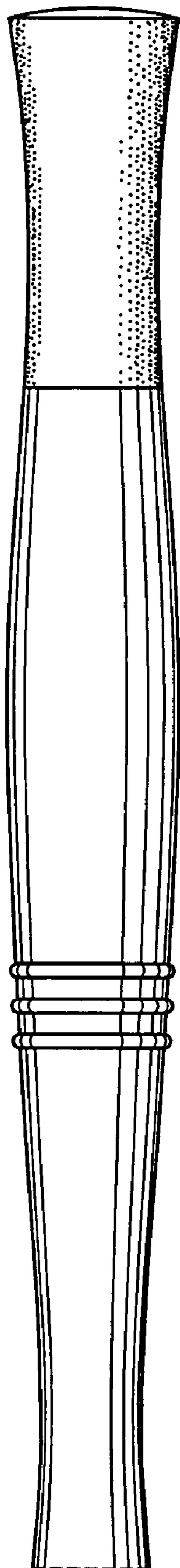

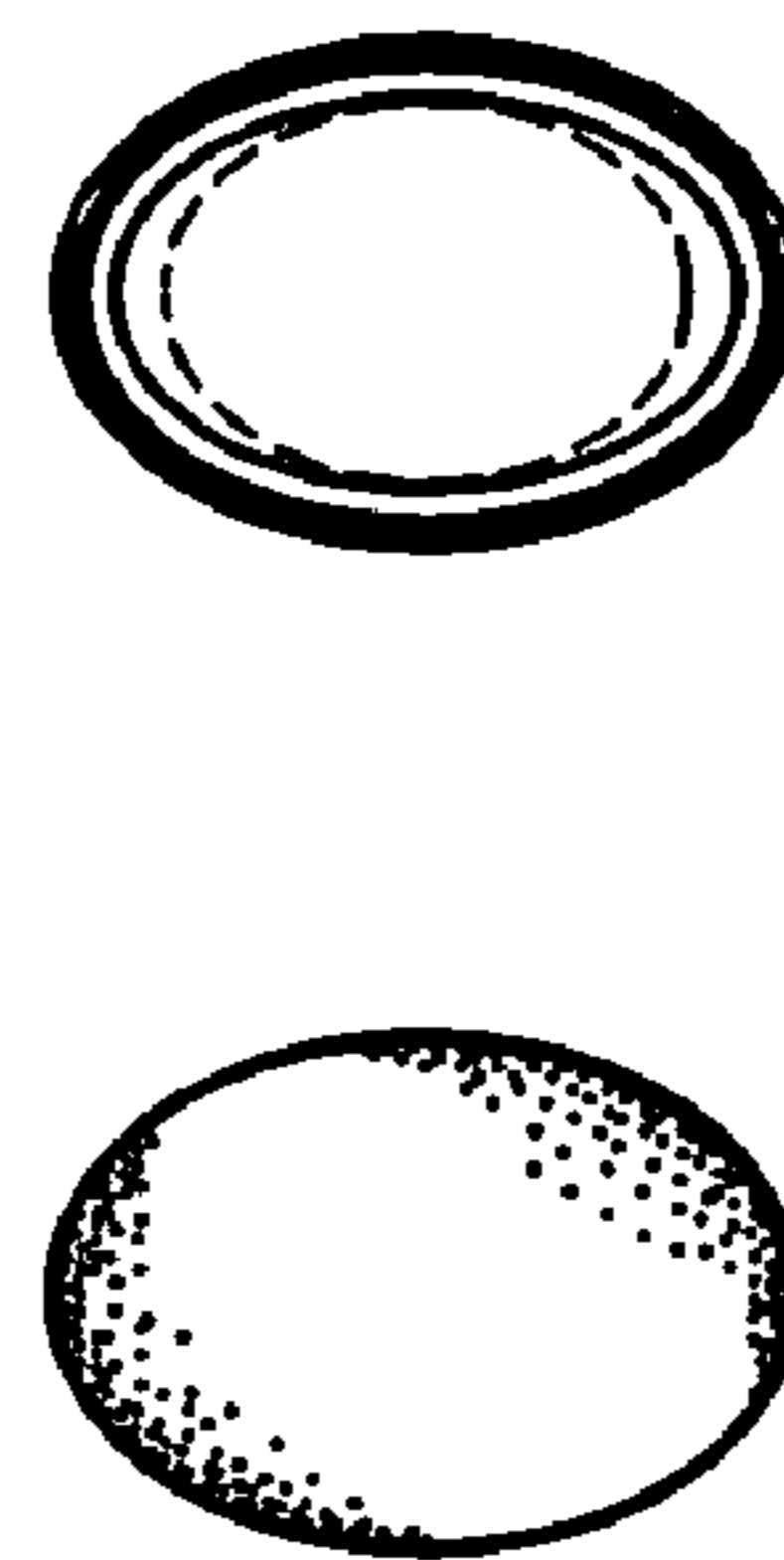
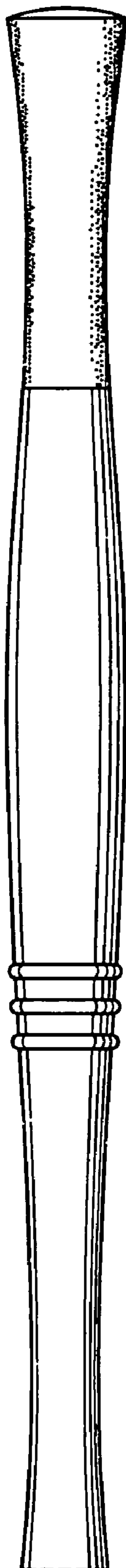


Fig. 4 Fig. 5
