DESCRIPTION

FIG. 1 is a perspective view of a square post surgical table clamp, showing my new design;

FIG. 2 is a front elevational view of the invention; the rear elevational view being mirror image thereof;

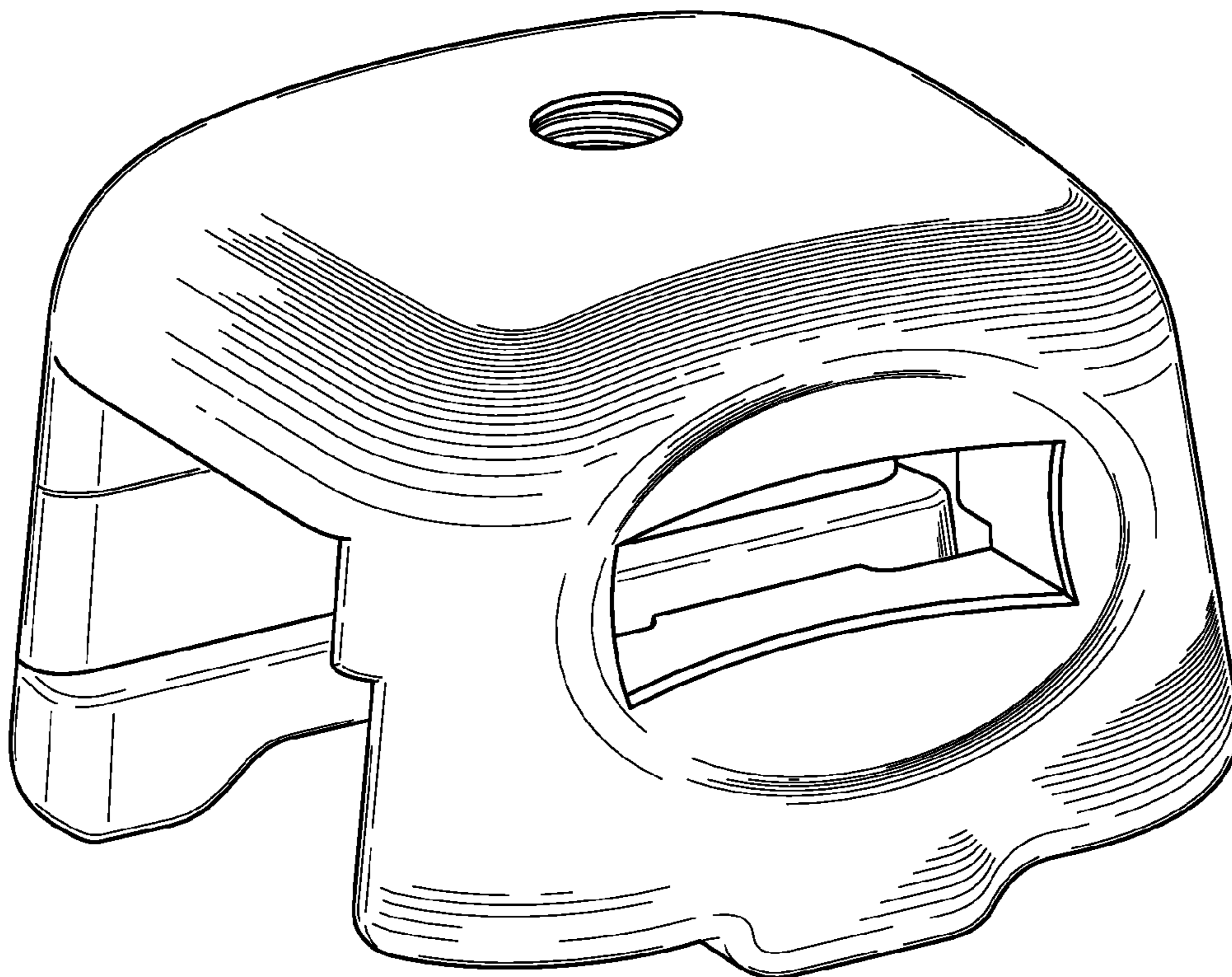
FIG. 3 is a left-side elevational view of the invention;

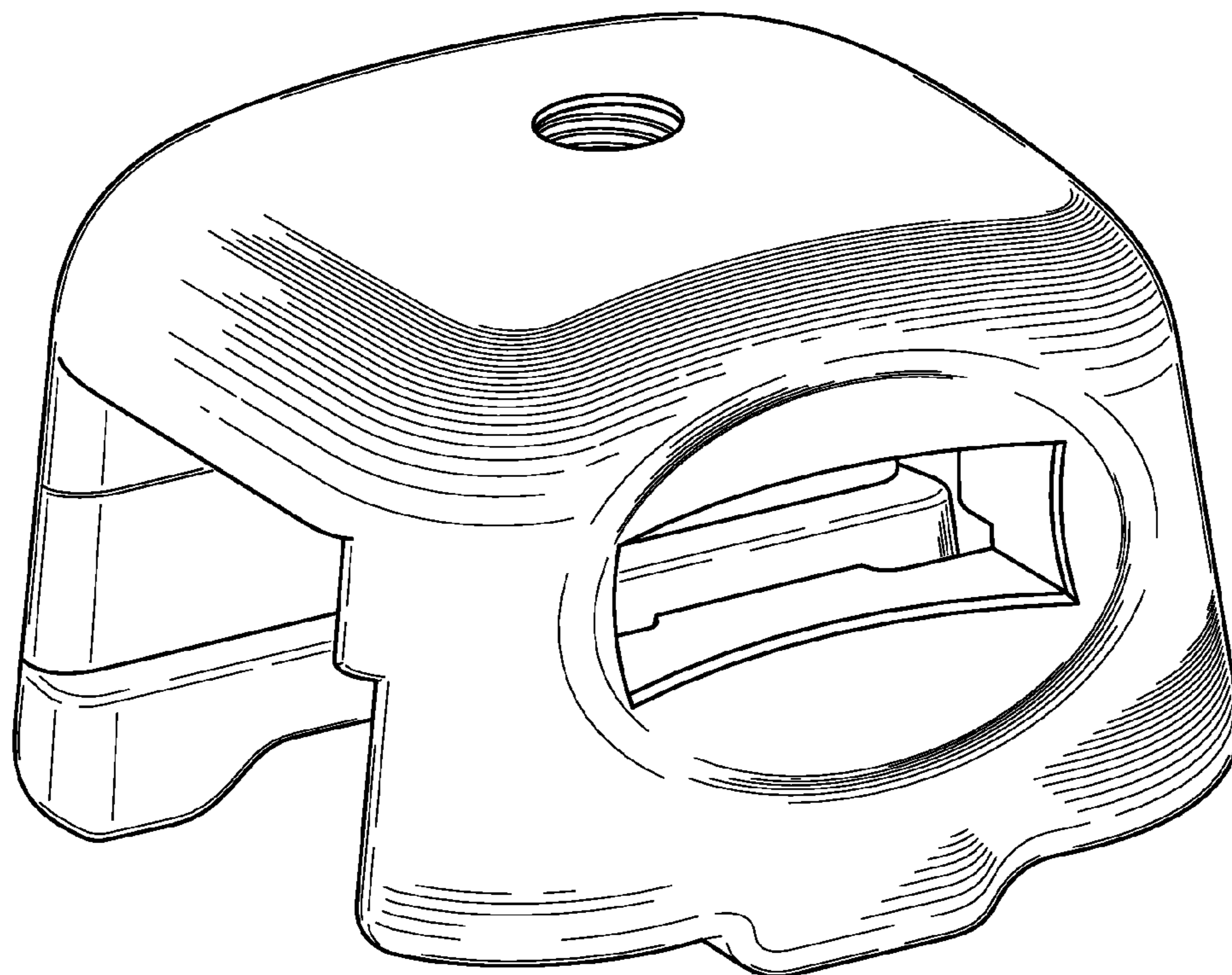

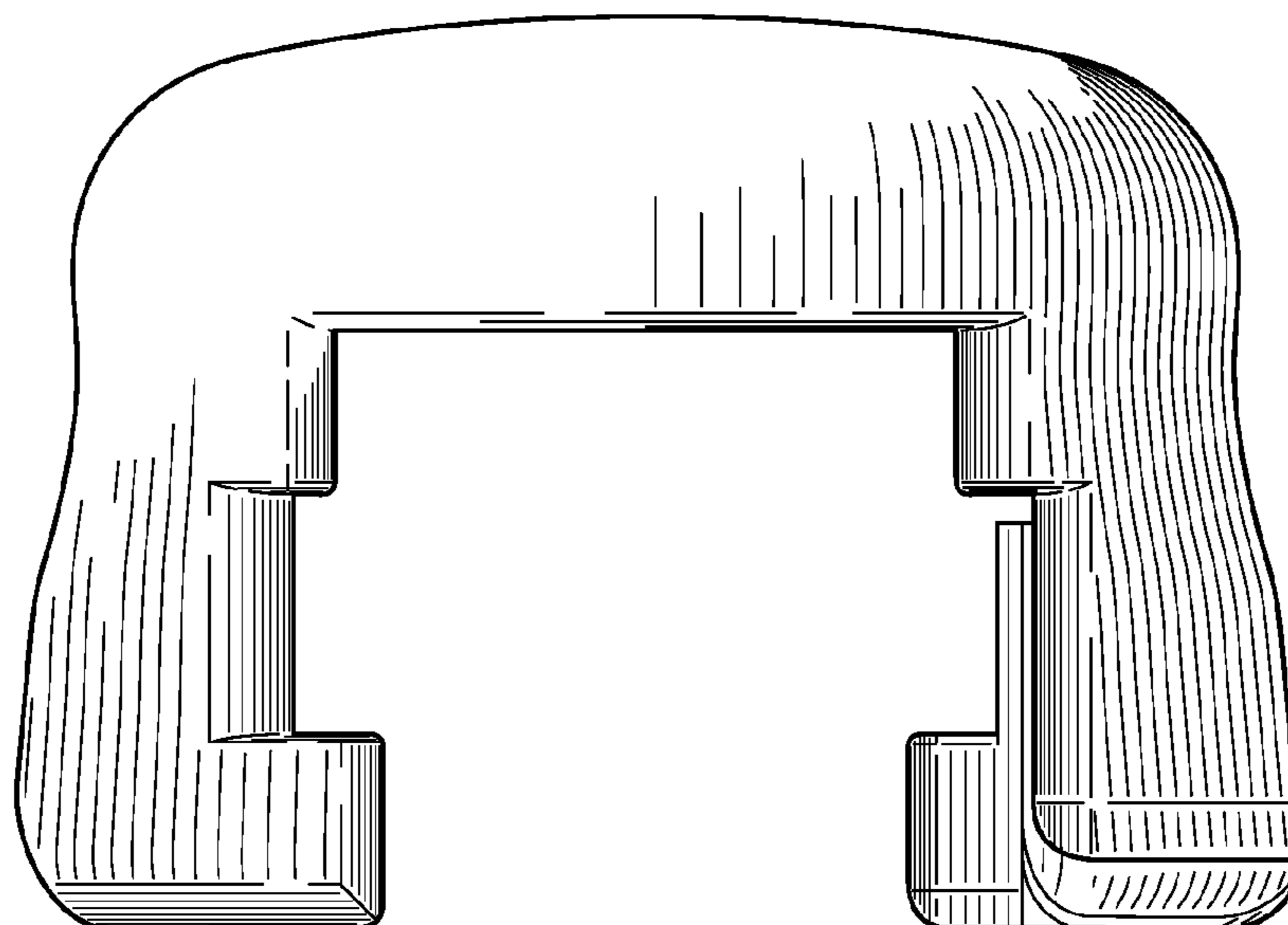

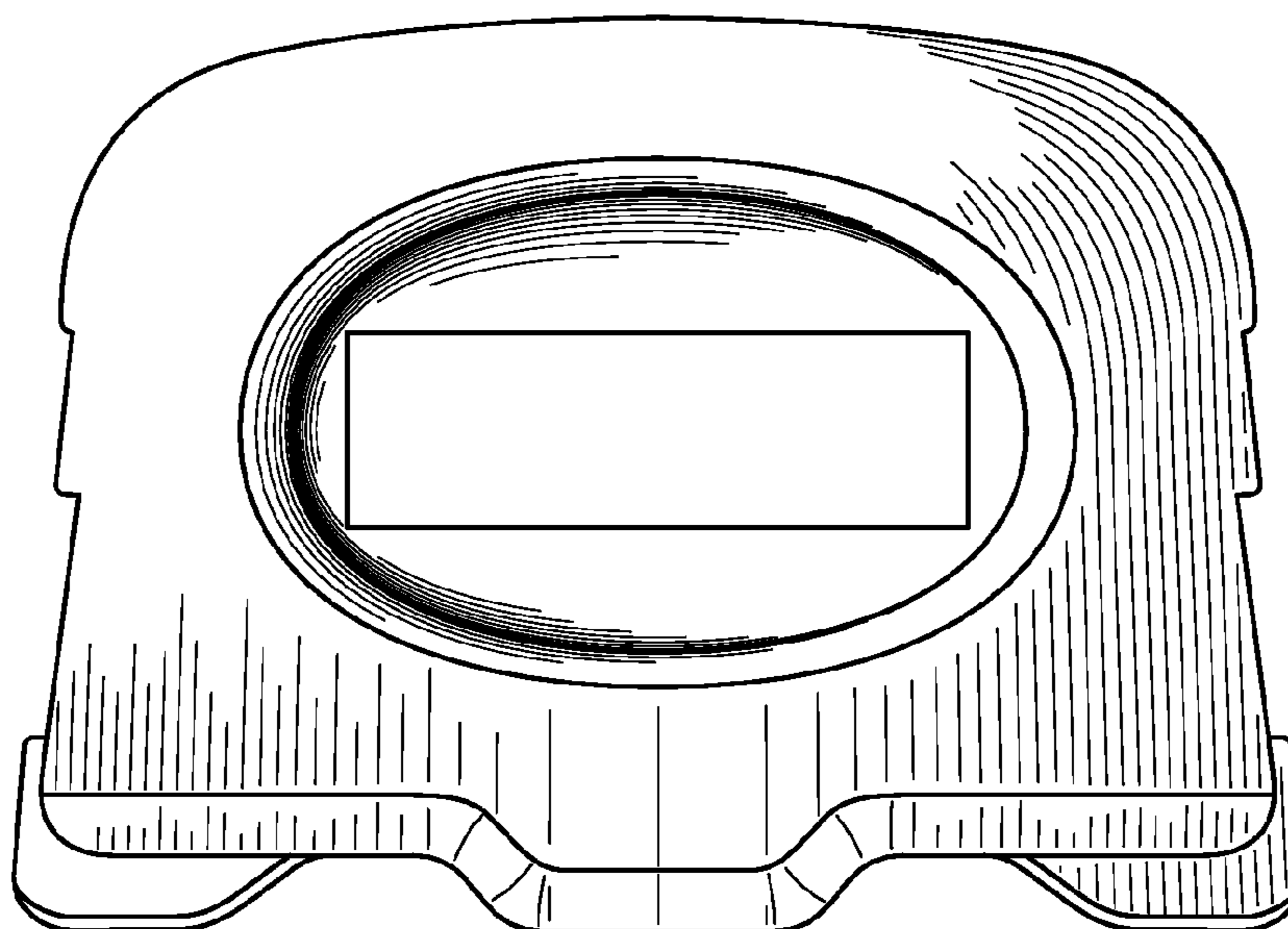

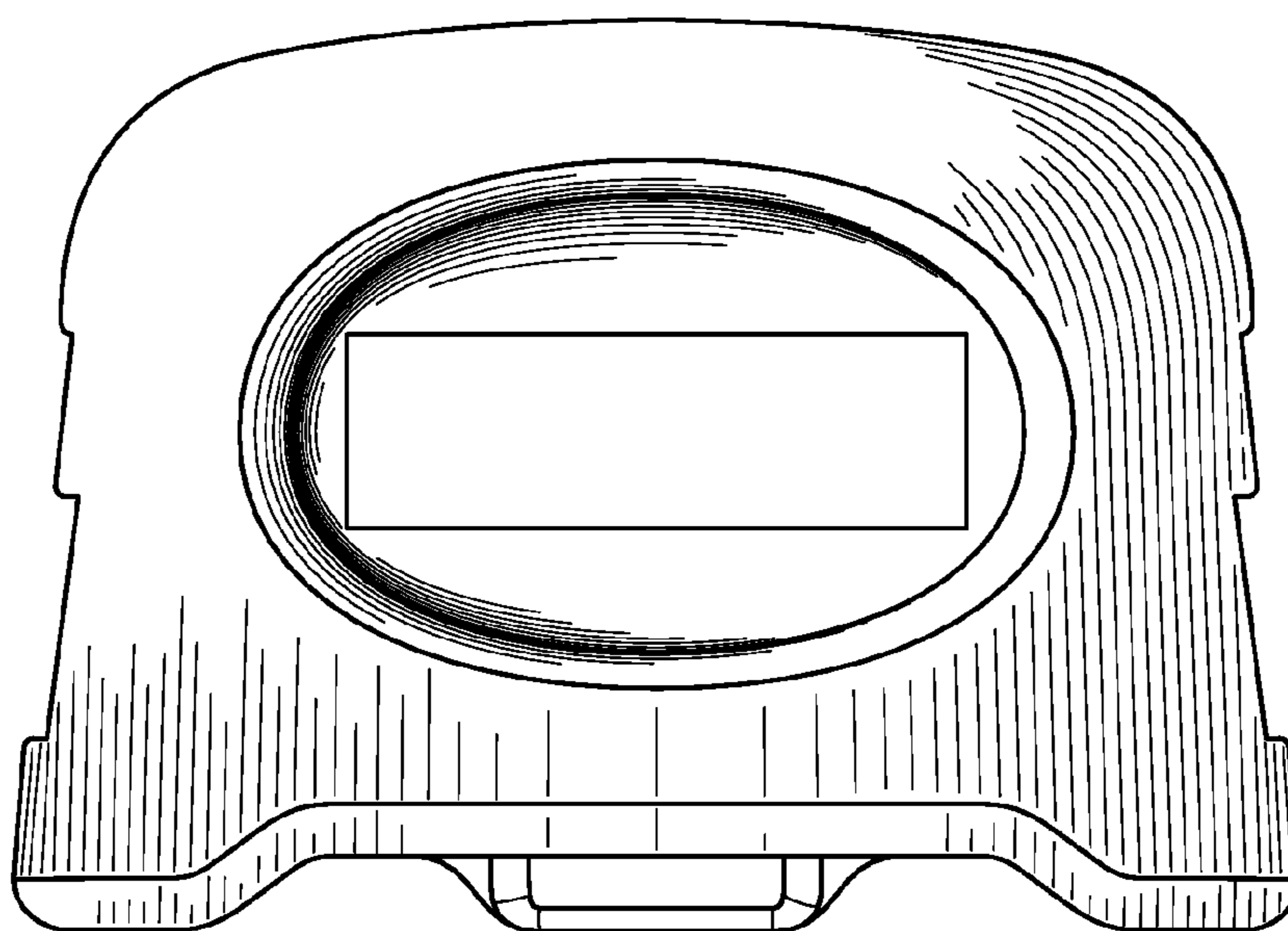

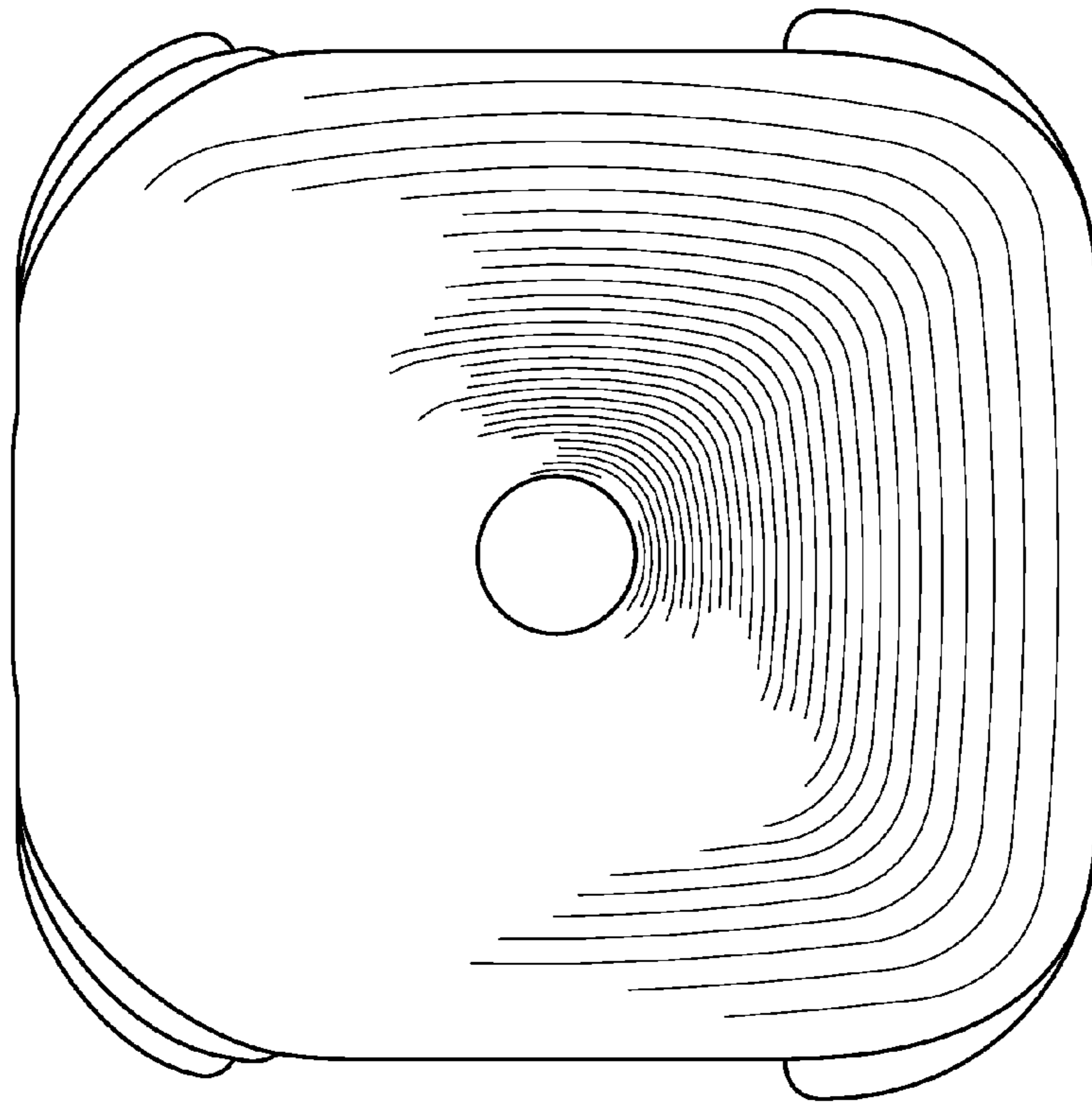

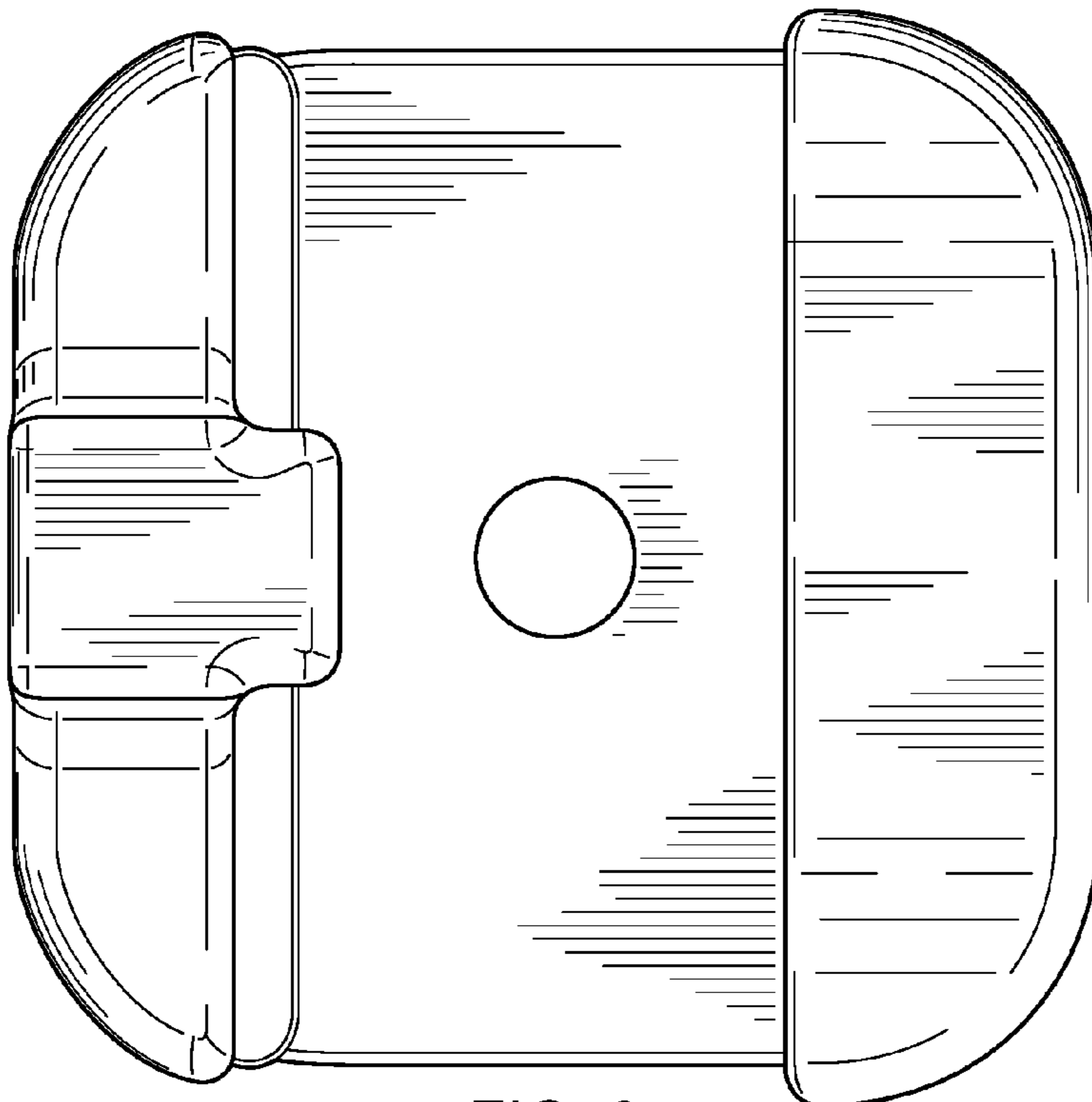
