(57) **CLAIM**

The ornamental design for a retractable utility knife, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a retractable utility knife showing the blade thereof in an extended position.

FIG. 2 is a top plan view thereof;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a left side elevation view thereof;

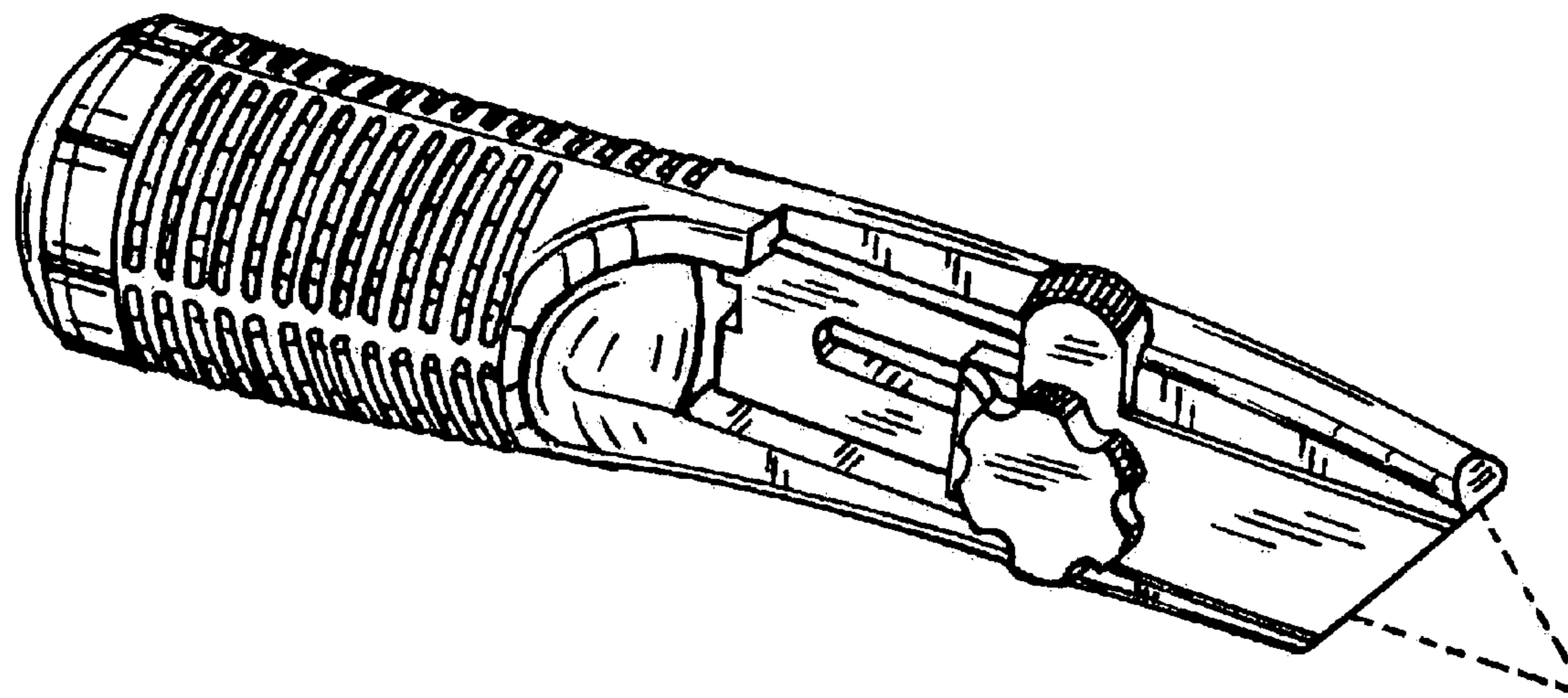
FIG. 5 is a right side elevation view thereof;

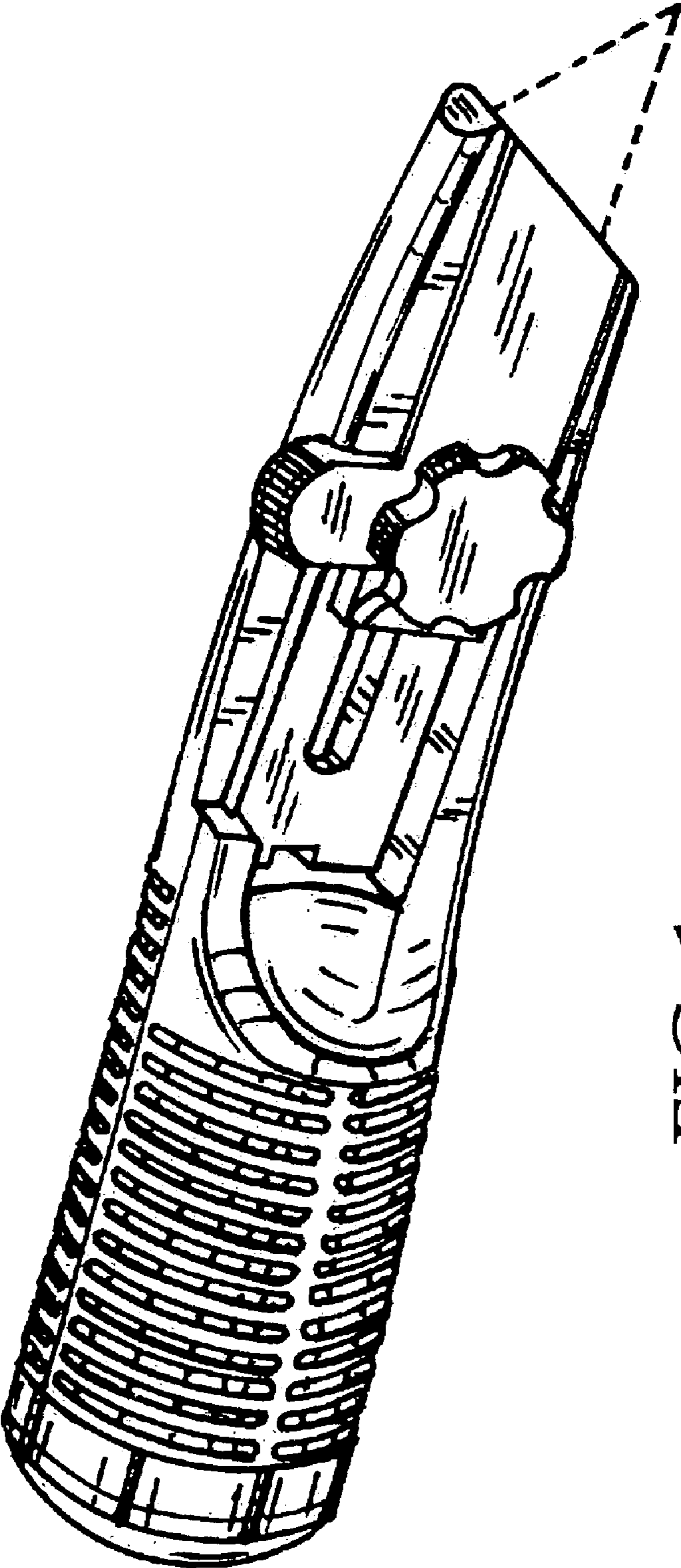

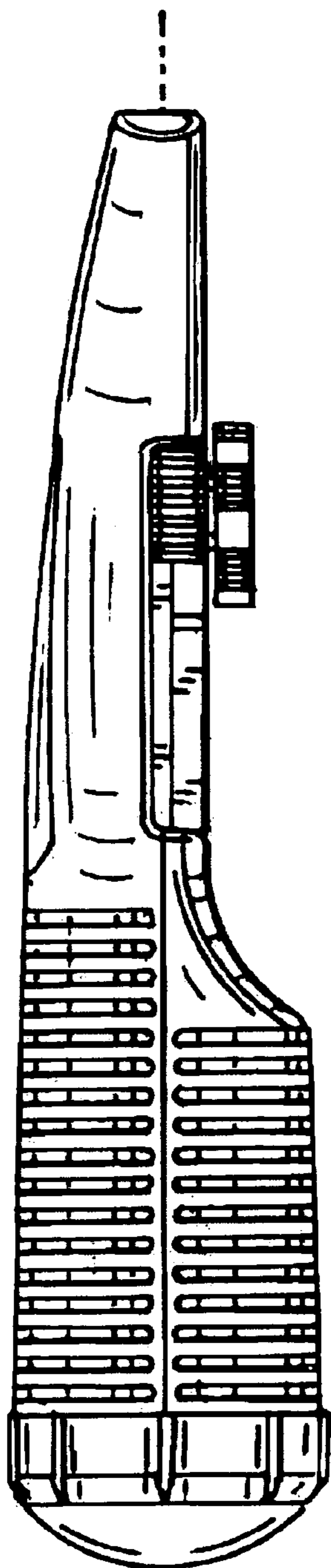

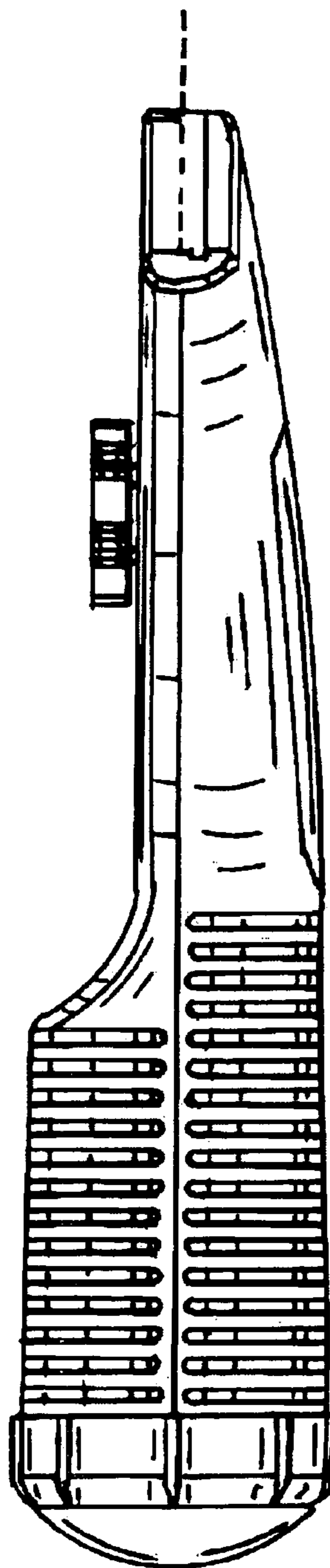

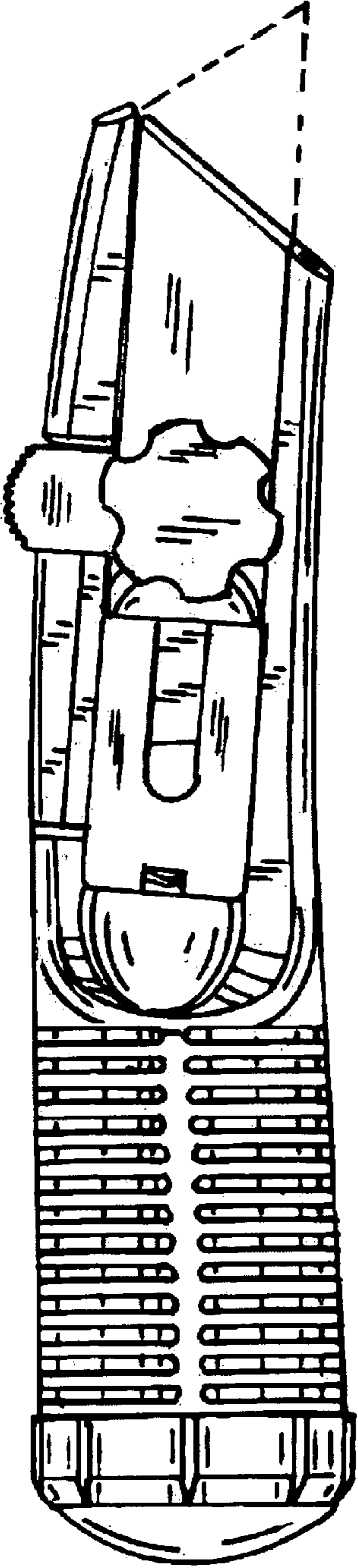

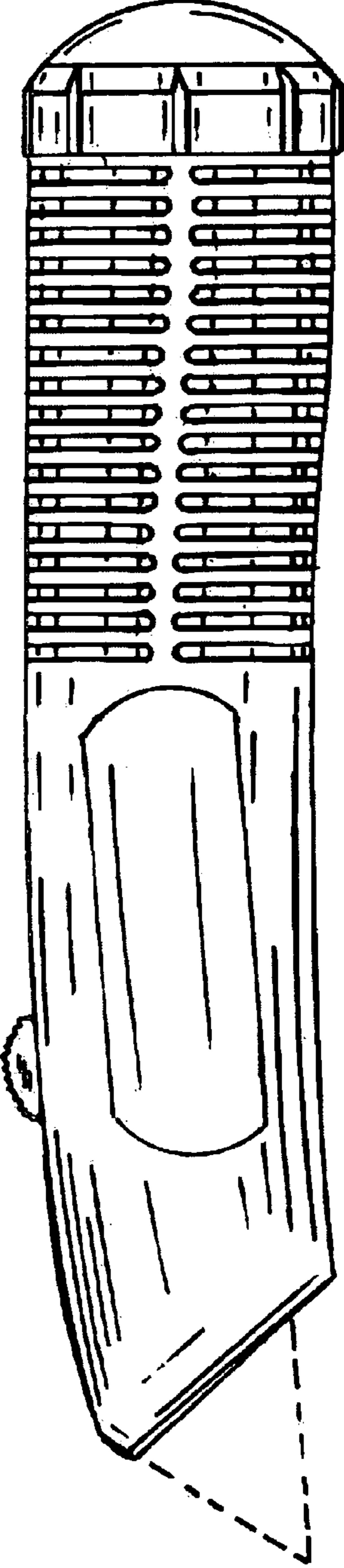

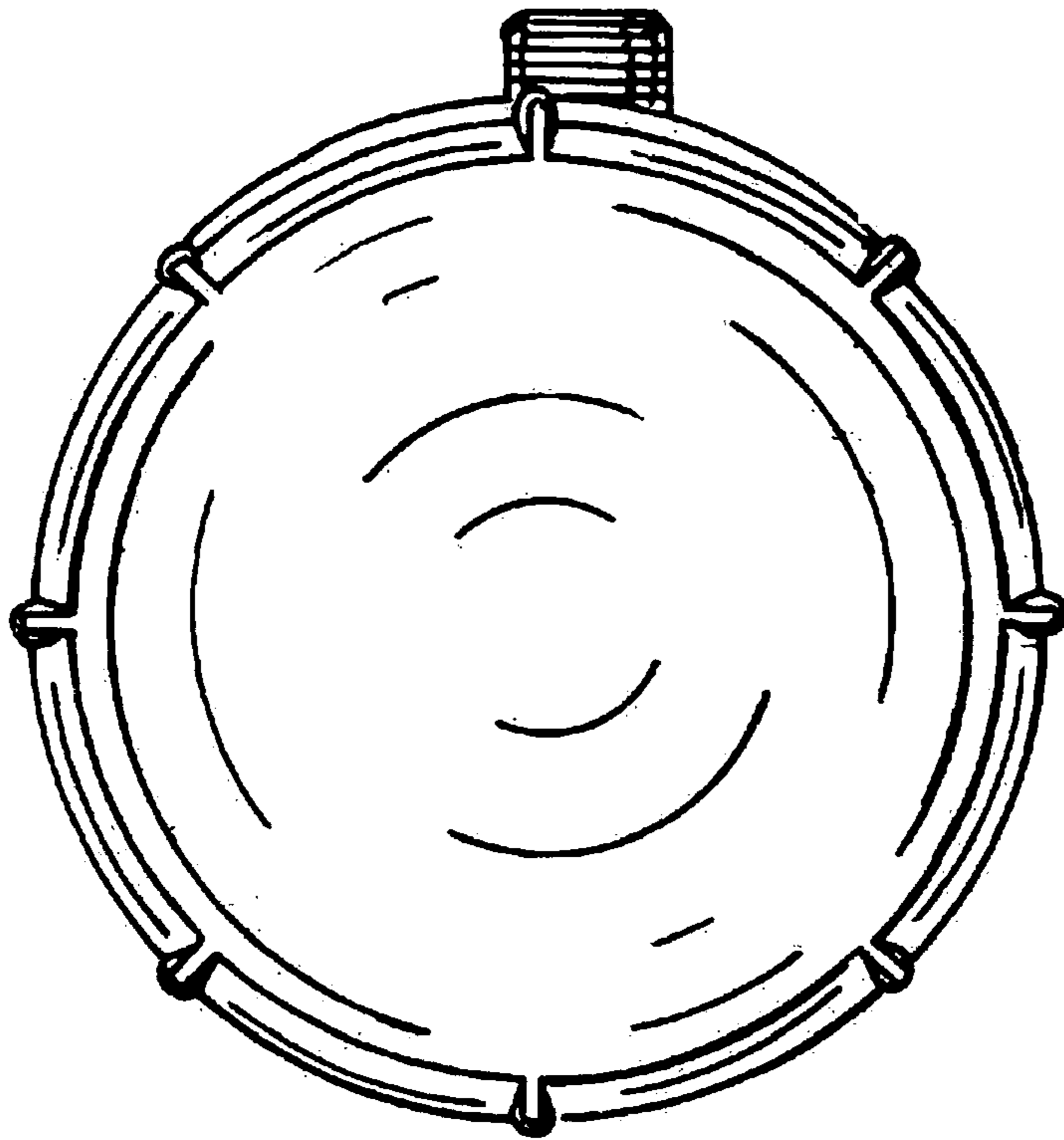

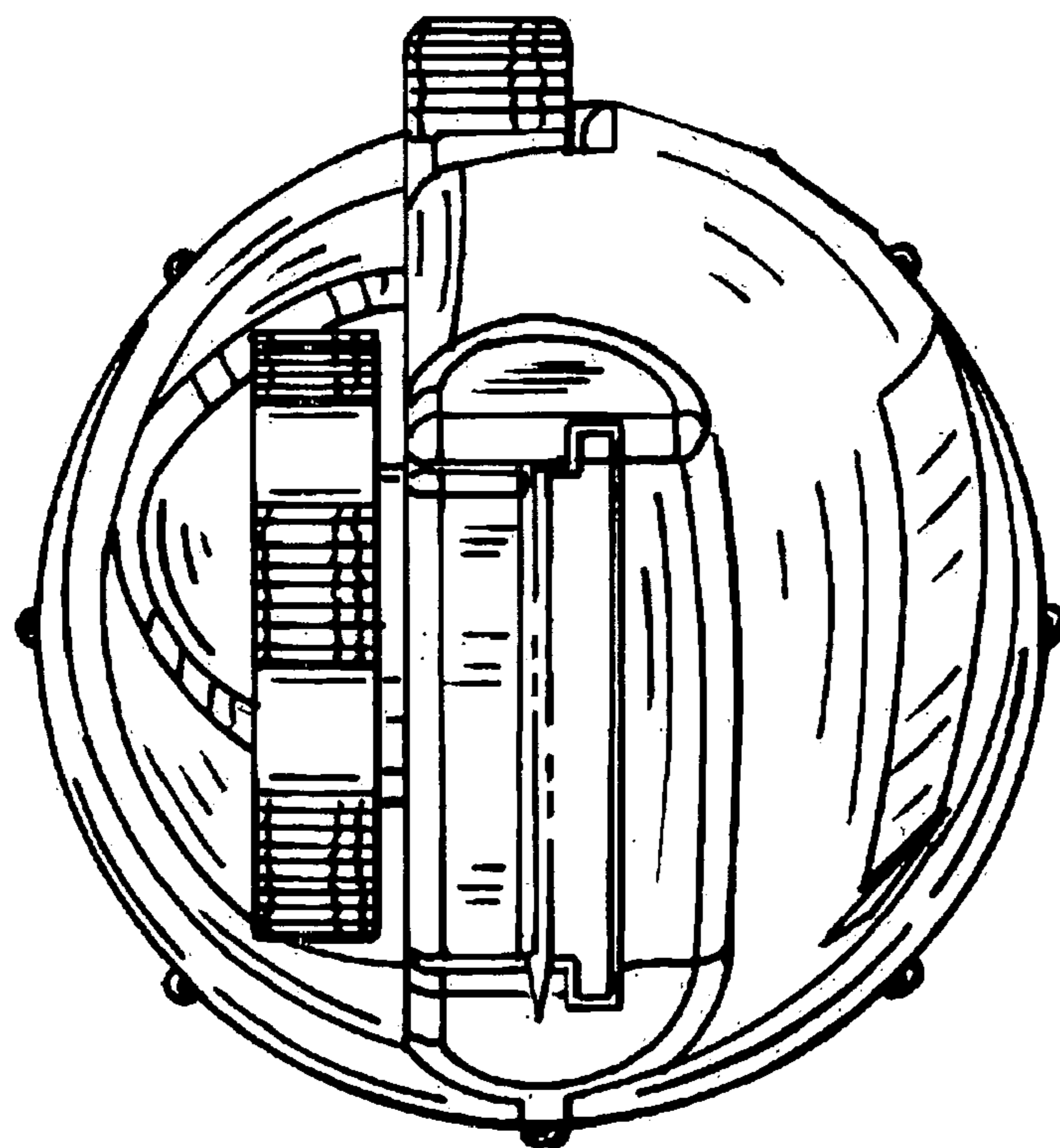
