**DESCRIPTION**

FIG. 1 is a top frontal perspective view of a child resistant container, showing my new design;

FIG. 2 is a right side view thereof, the left side being a mirror image thereto;

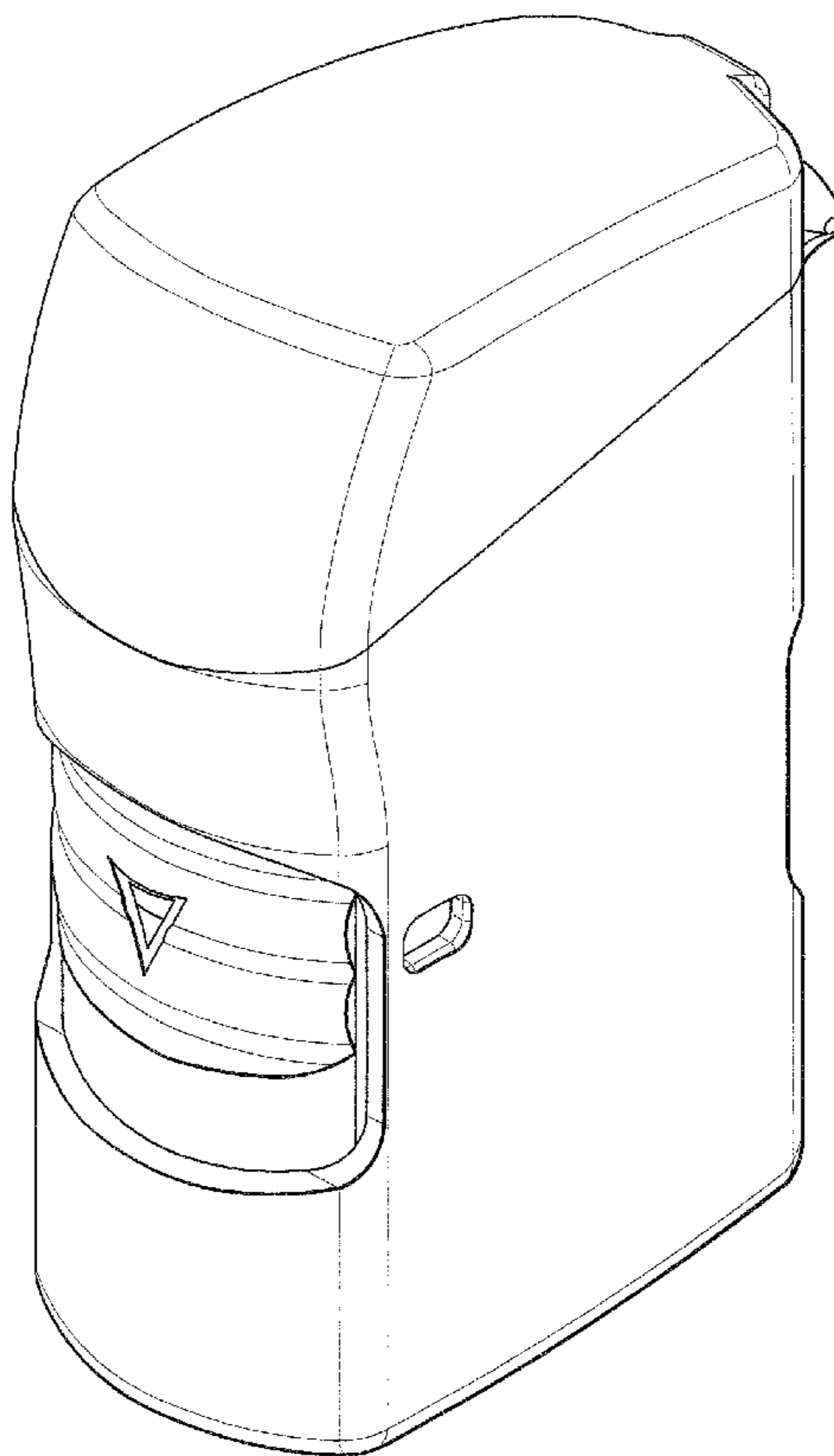
FIG. 3 is a front elevational side view thereof, in a slightly reduced scale;

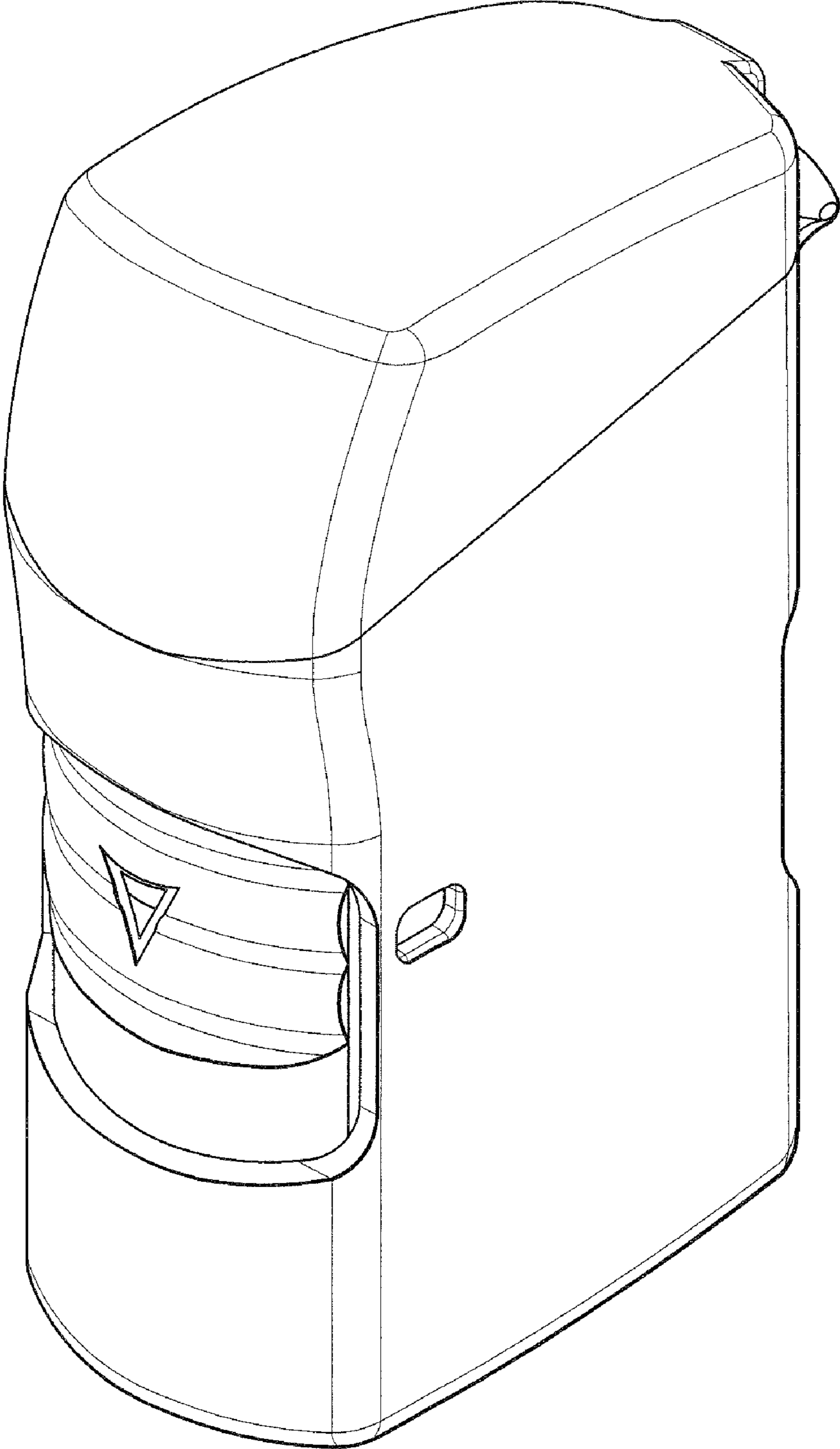

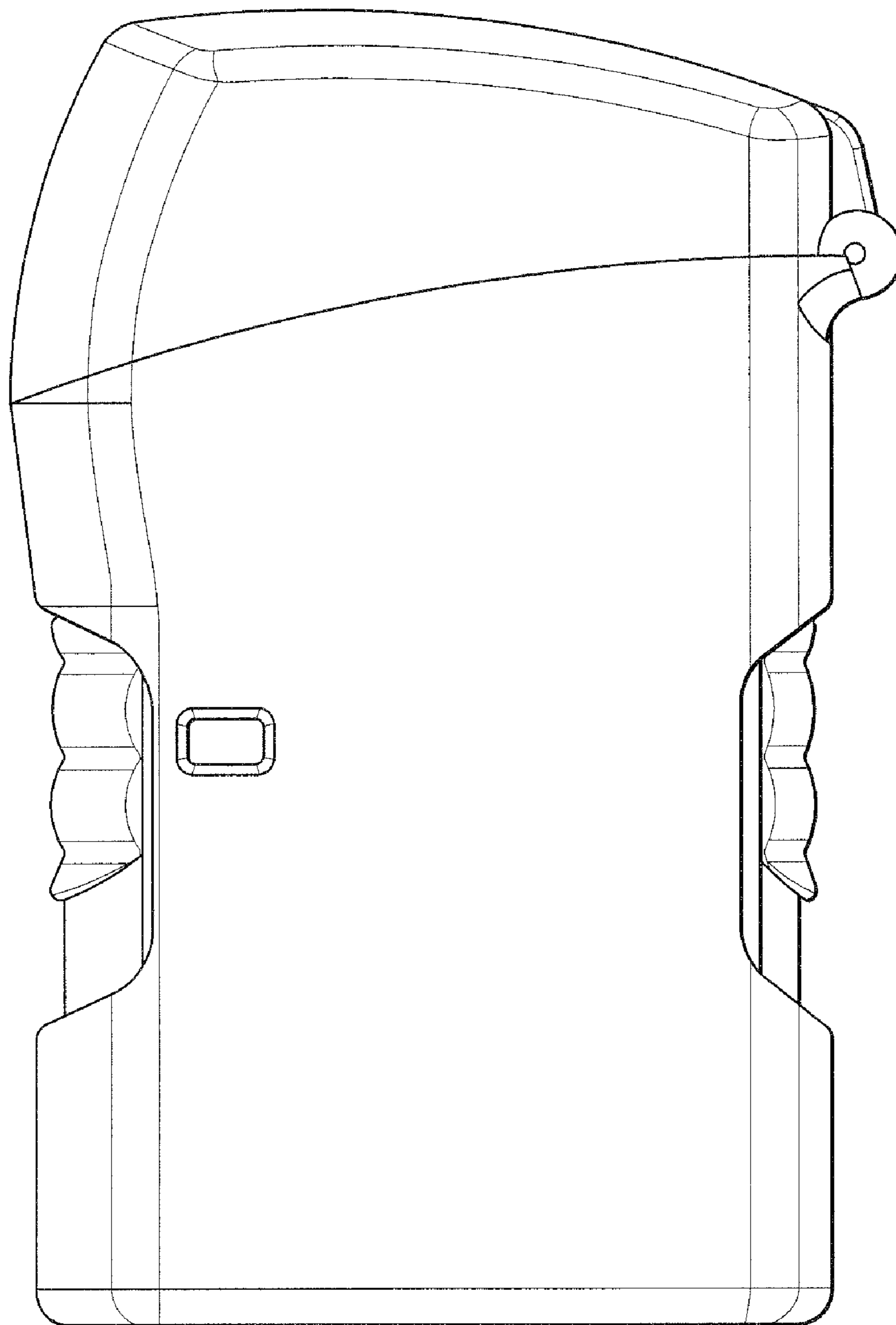

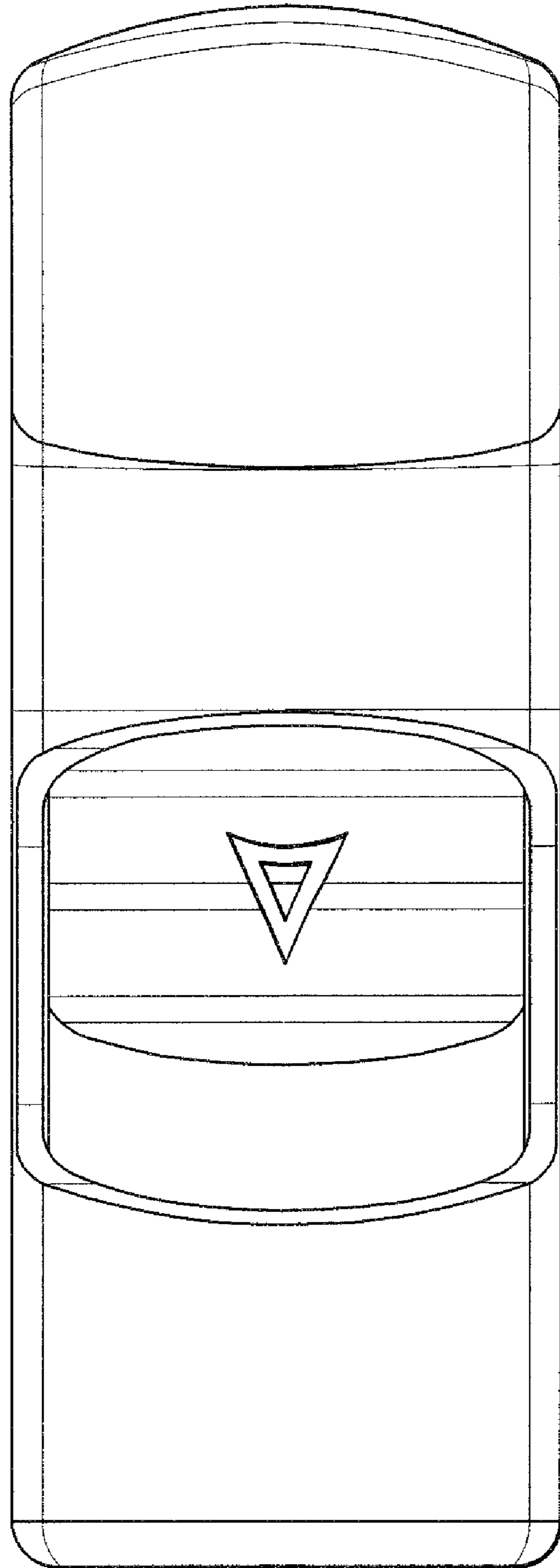

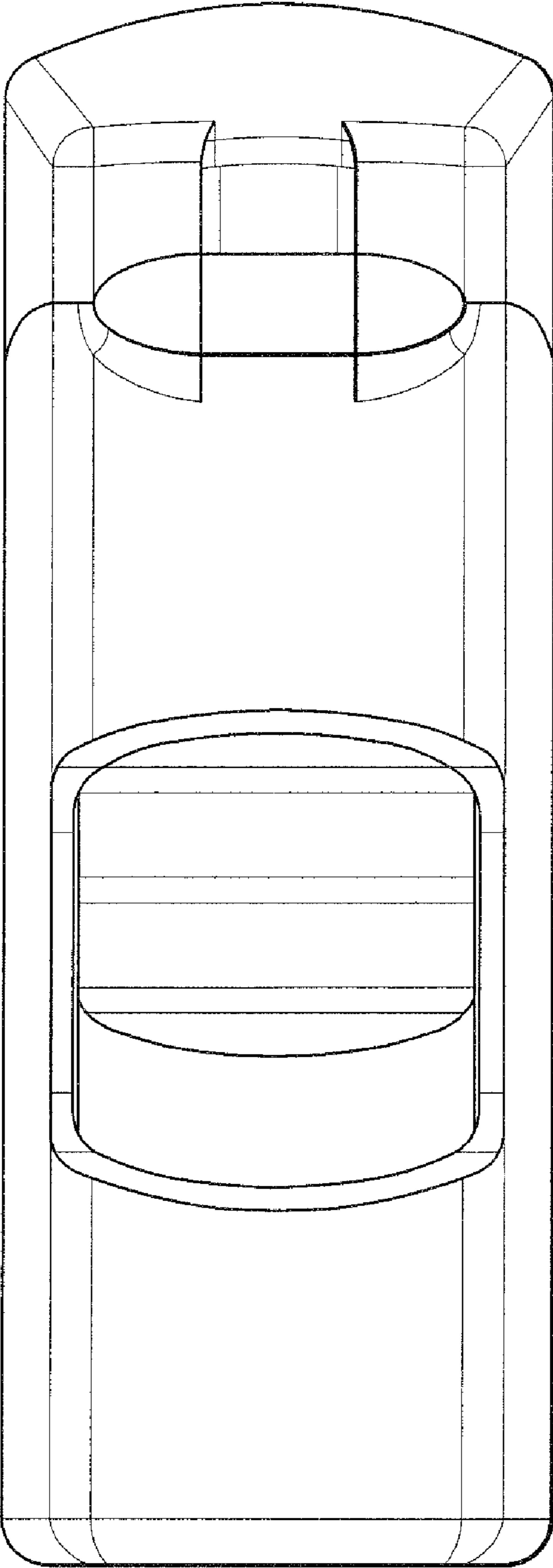

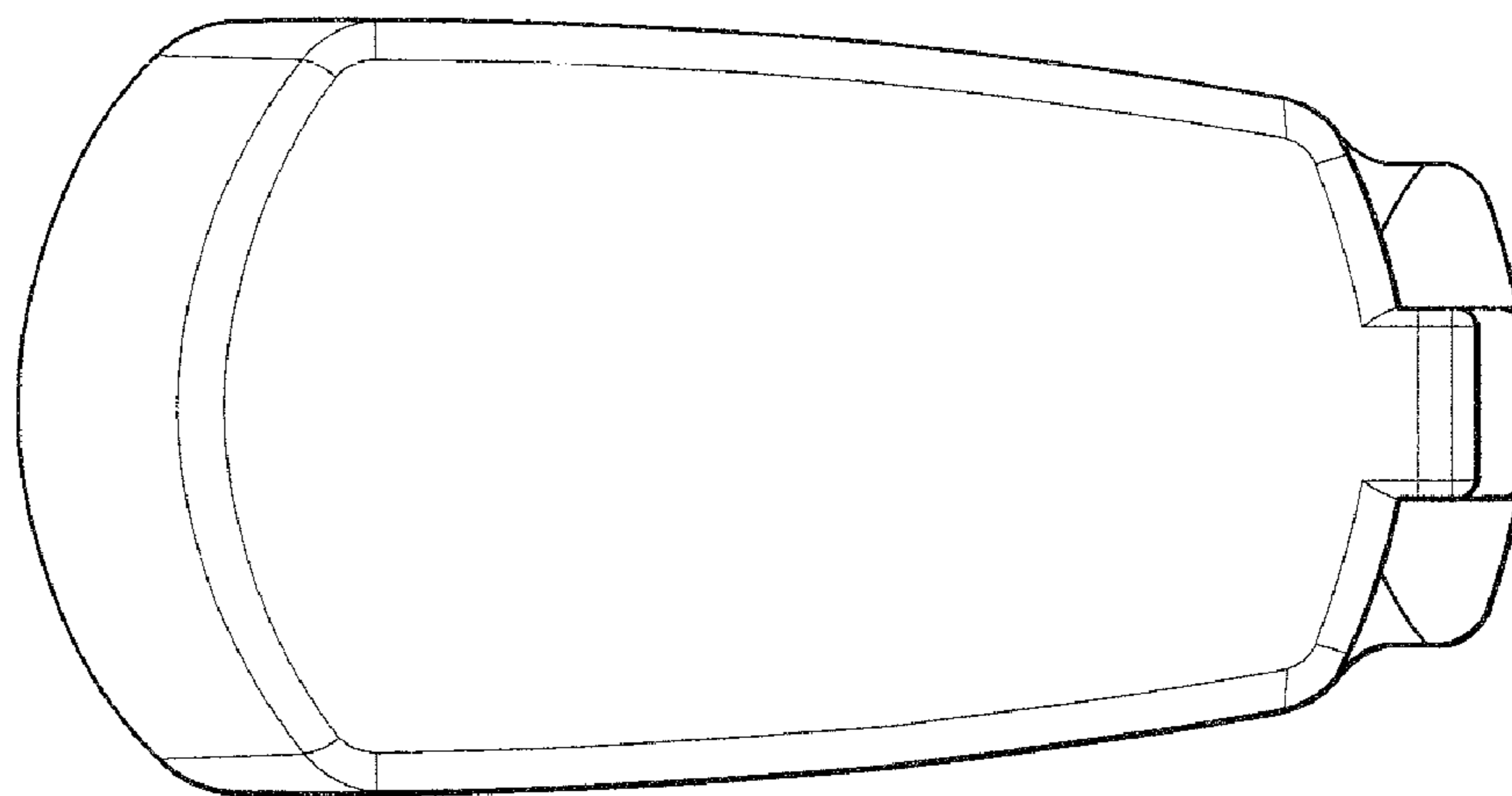

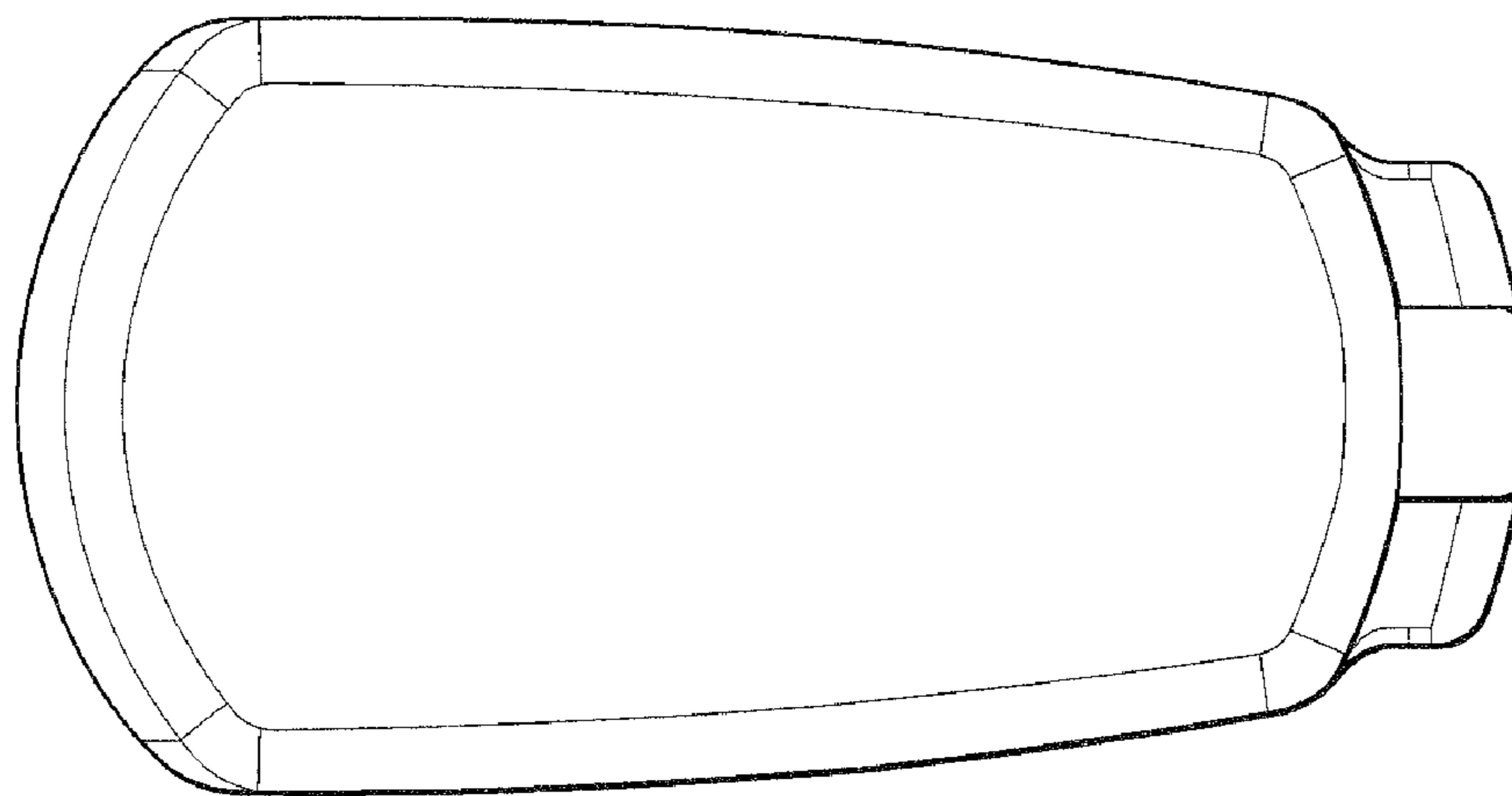
