(57) **CLAIM**

We claim the ornamental design for a blister package, as shown and described.

**DESCRIPTION**

FIG. 1 is a right front perspective view of a blister package showing our new design;

FIG. 2 is a front elevational view thereof, the back elevational view being not shown, nor claimed;

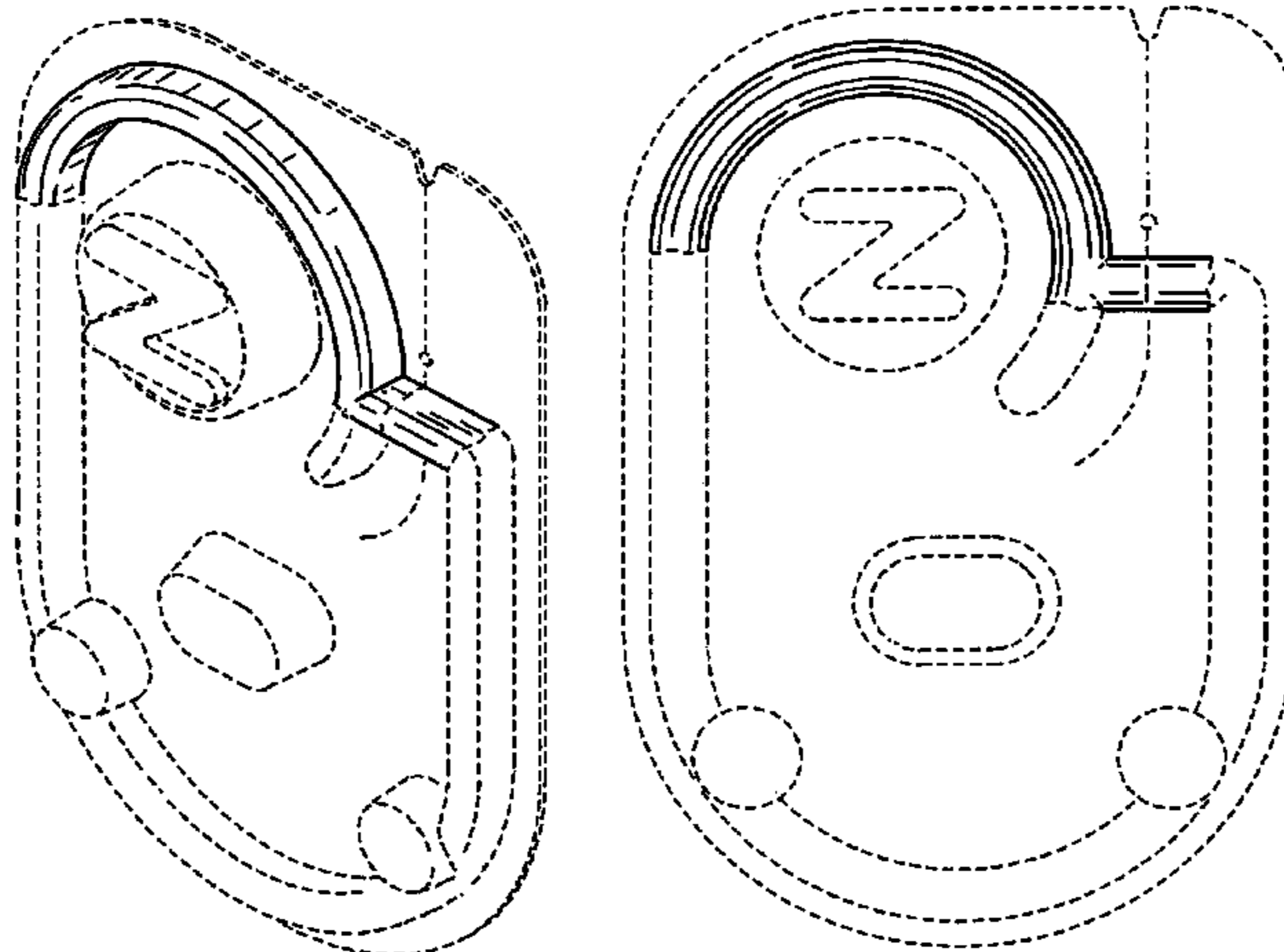
FIG. 3 is a top end view thereof, the bottom end view being not shown, nor claimed;

FIG. 4 is a right side view thereof; and,

FIG. 5 is a left side view thereof.

The broken lines illustrate portions of a blister package which form no part of the claimed design.

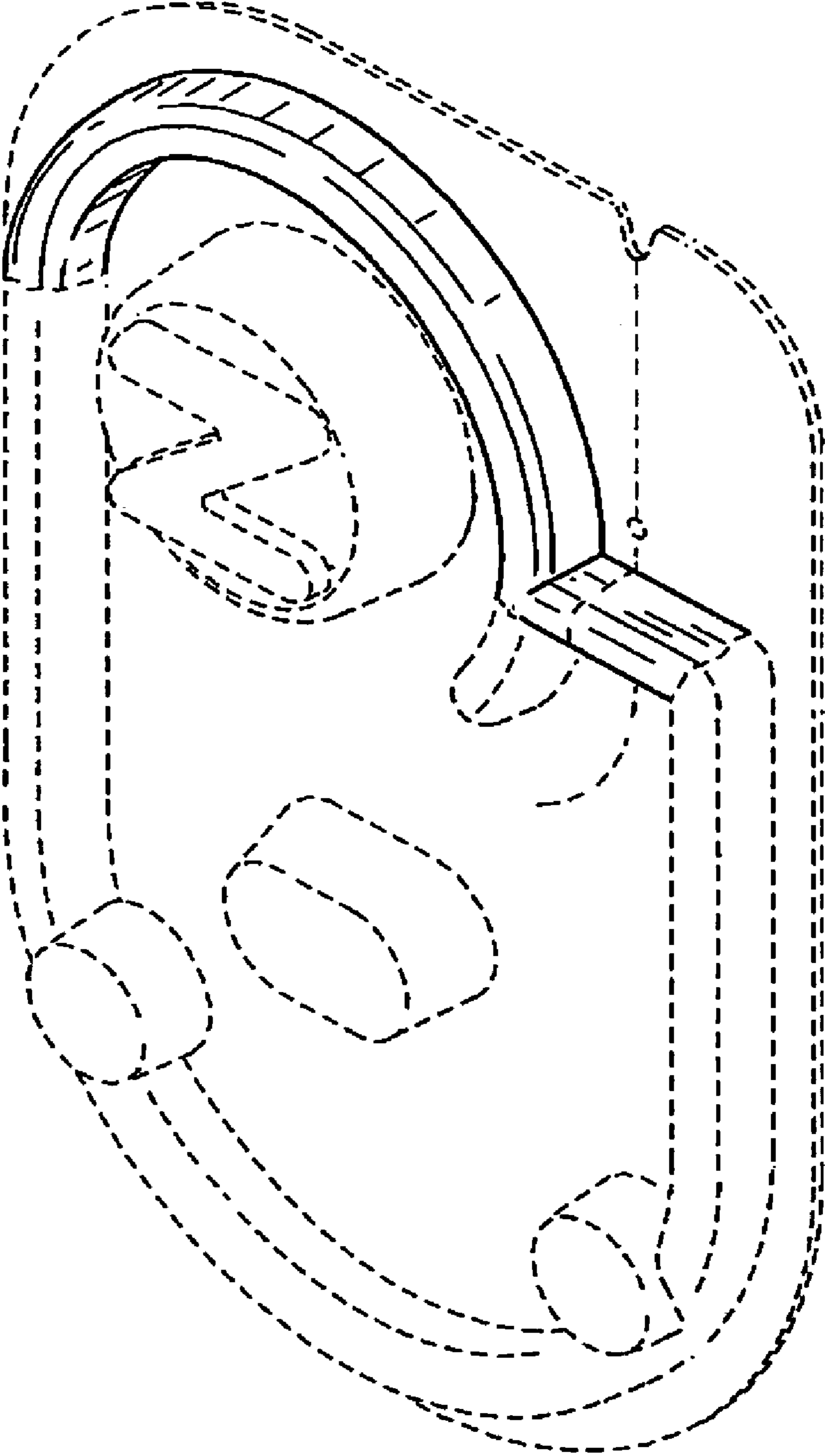

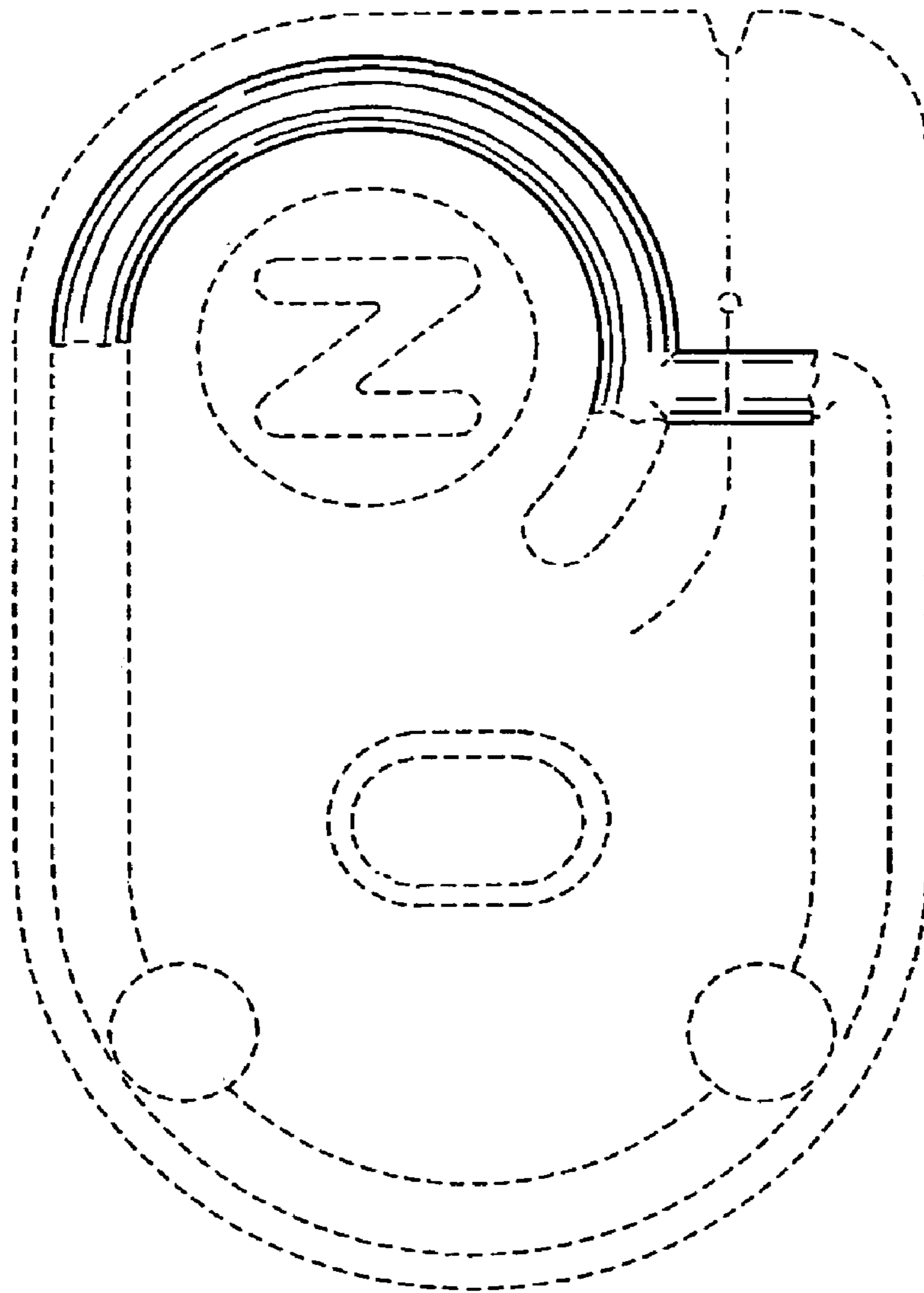

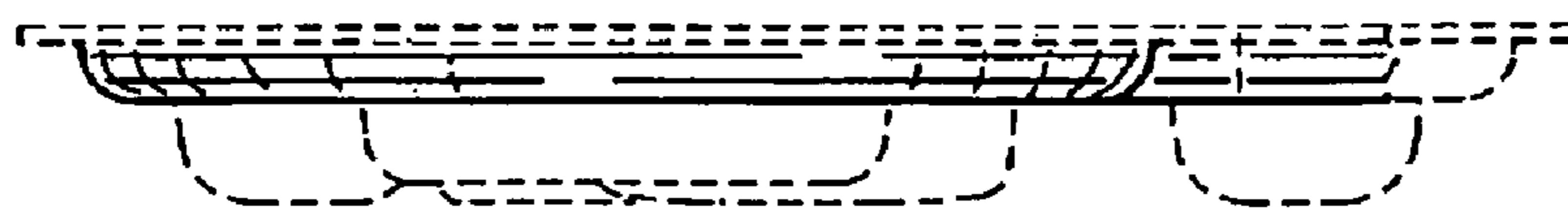

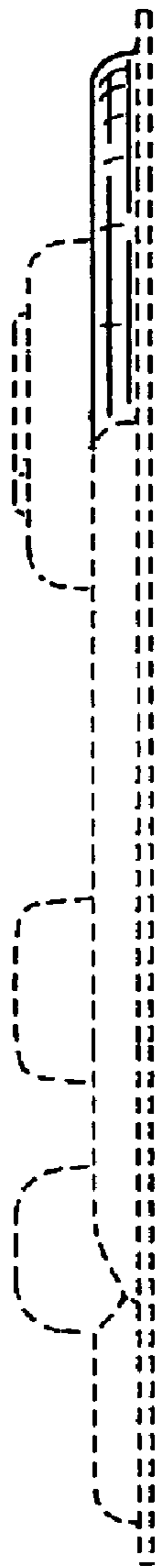

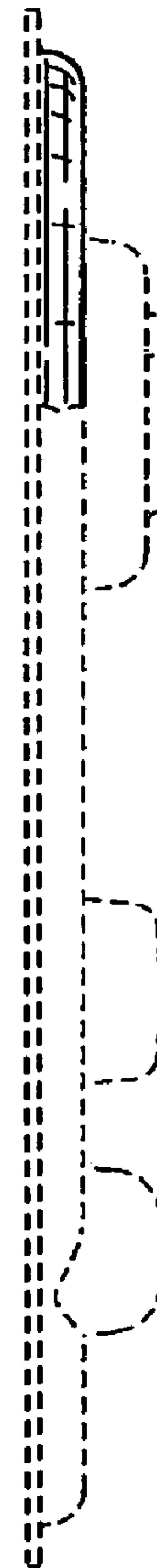
