The ornamental design for a recyclable jewelry box, as shown
and described.

DESCRIPTION

FIG. 1 is a perspective view of the recyclable jewelry box of
the present invention with the lid open;

FIG. 2 is a perspective view of the recyclable jewelry box of
the present invention with the lid closed;

FIG. 3 is a bottom view thereof;

FIG. 4 is a bottom view thereof shown in an alternate con-
figuration of use with the lid folded back;

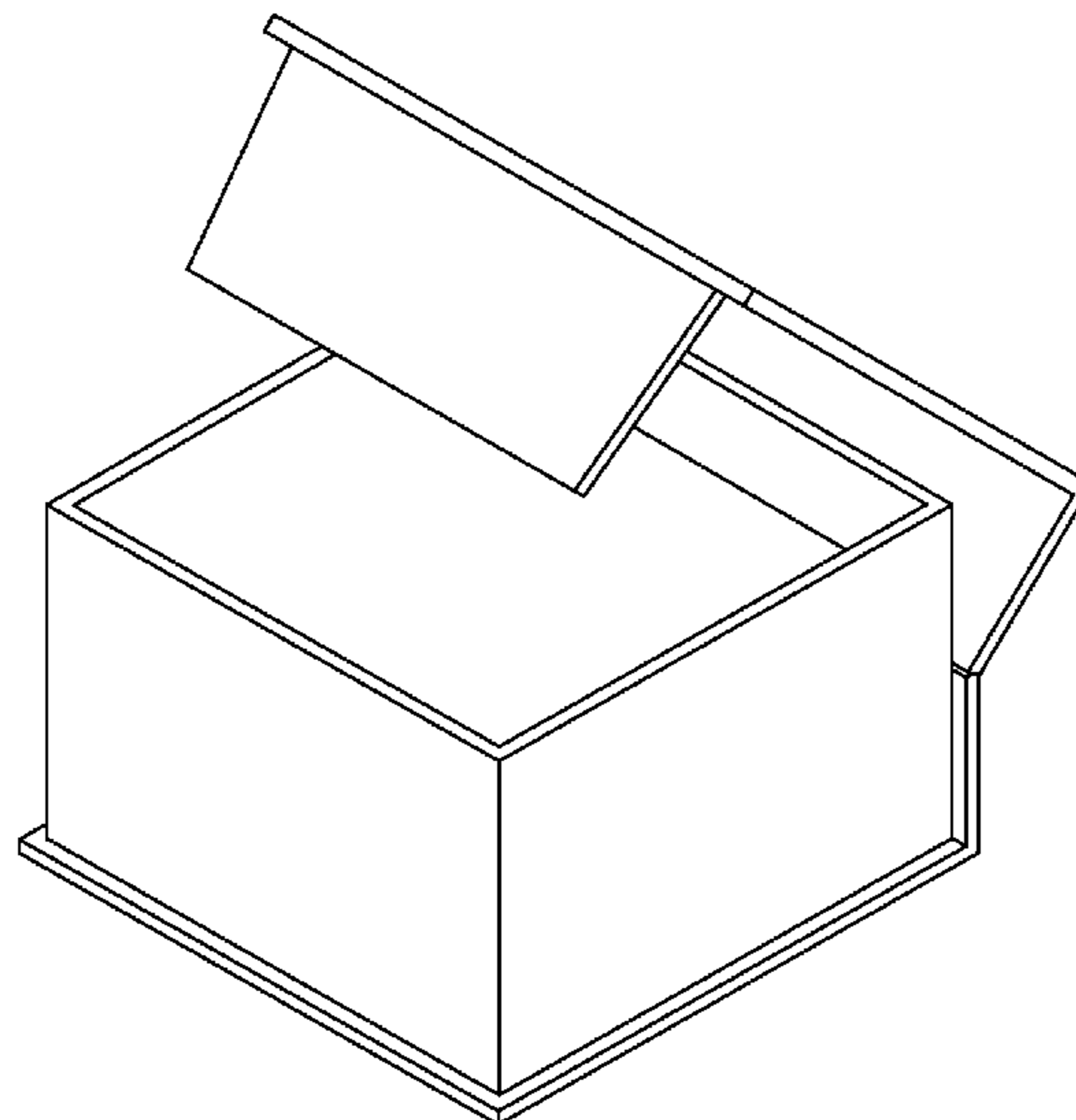
FIG. 5 is a front elevation view of FIG. 2;

FIG. 6 is a back elevation view;

FIG. 7 is a left side elevation view; and,

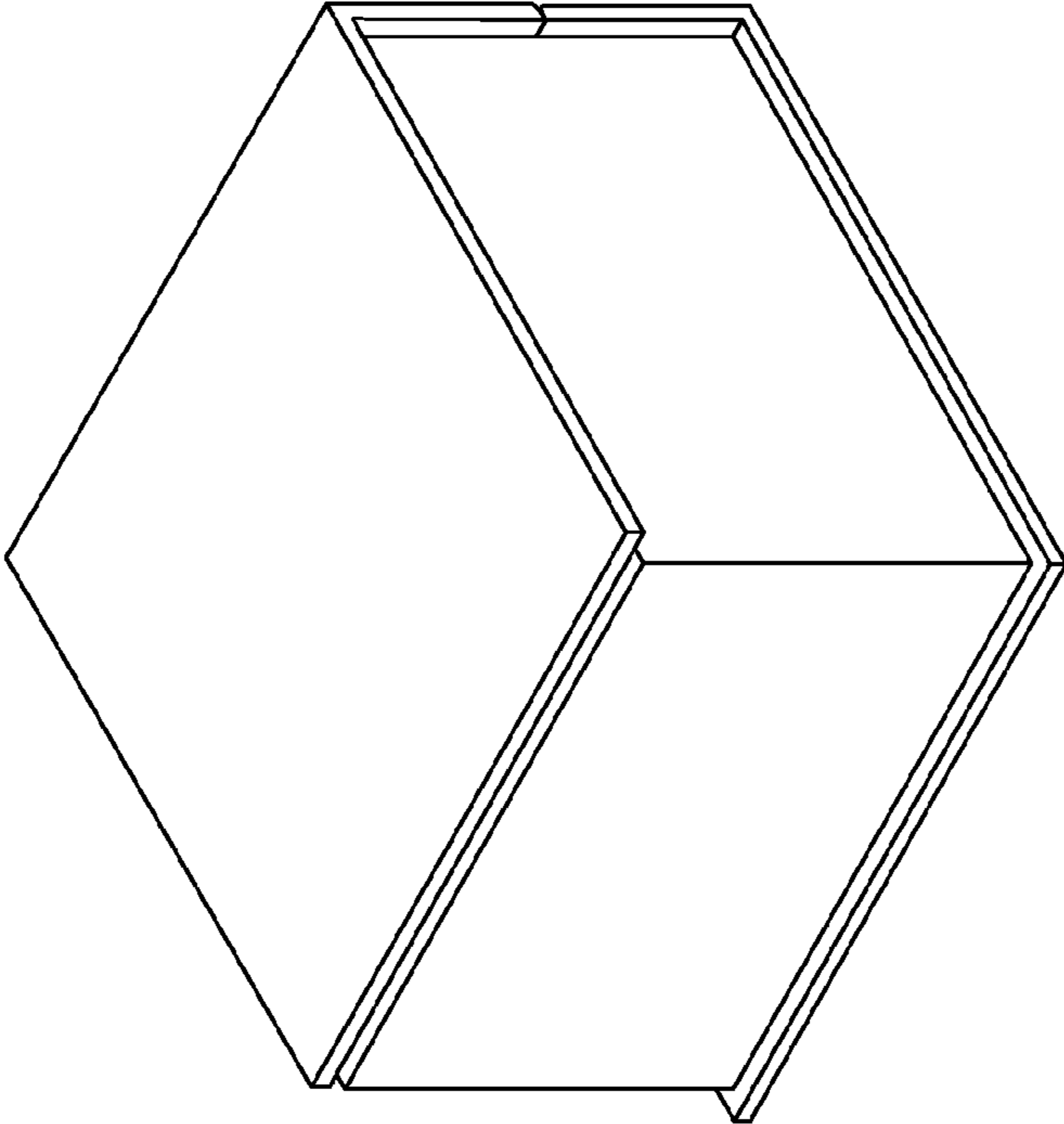

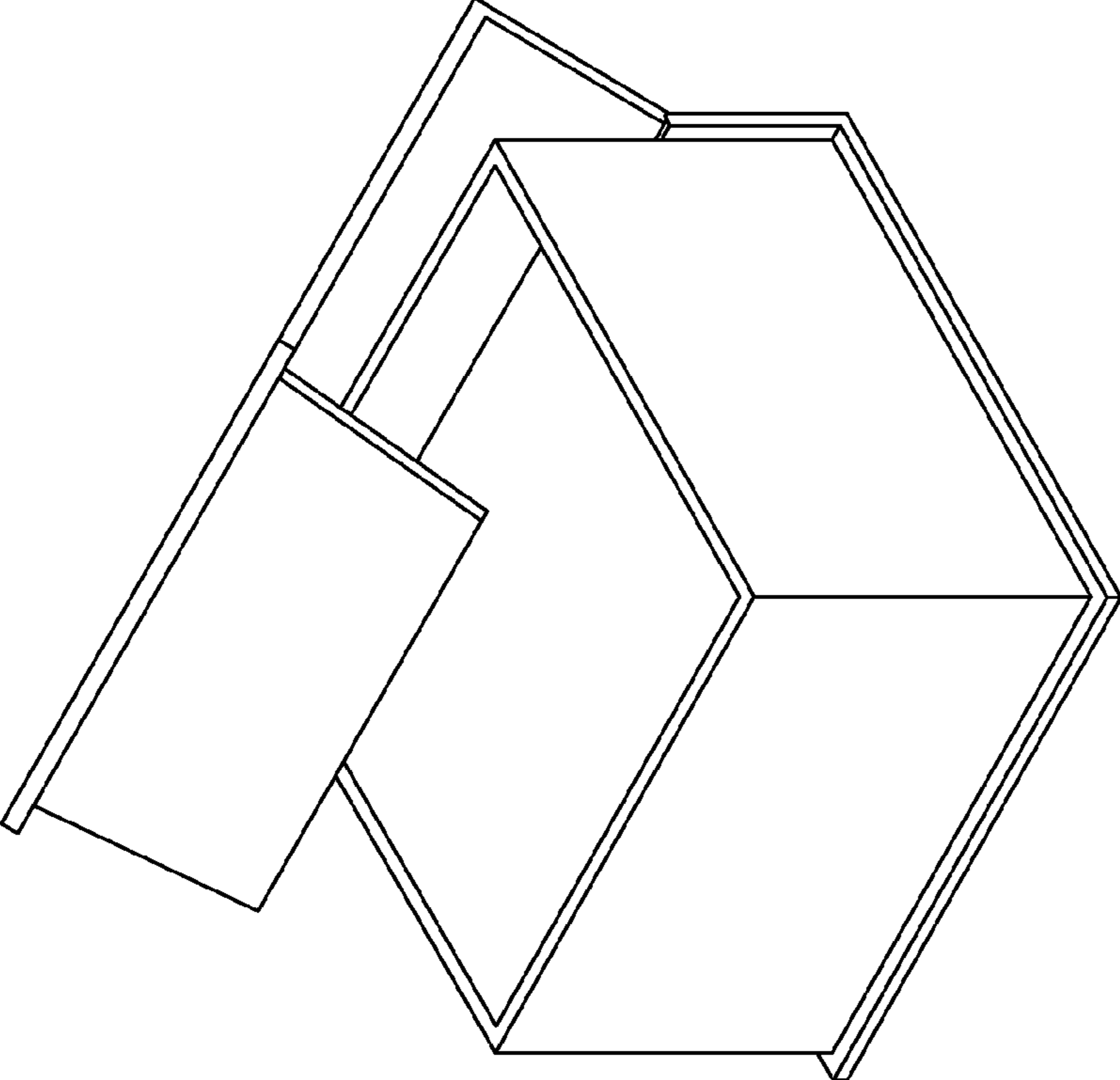

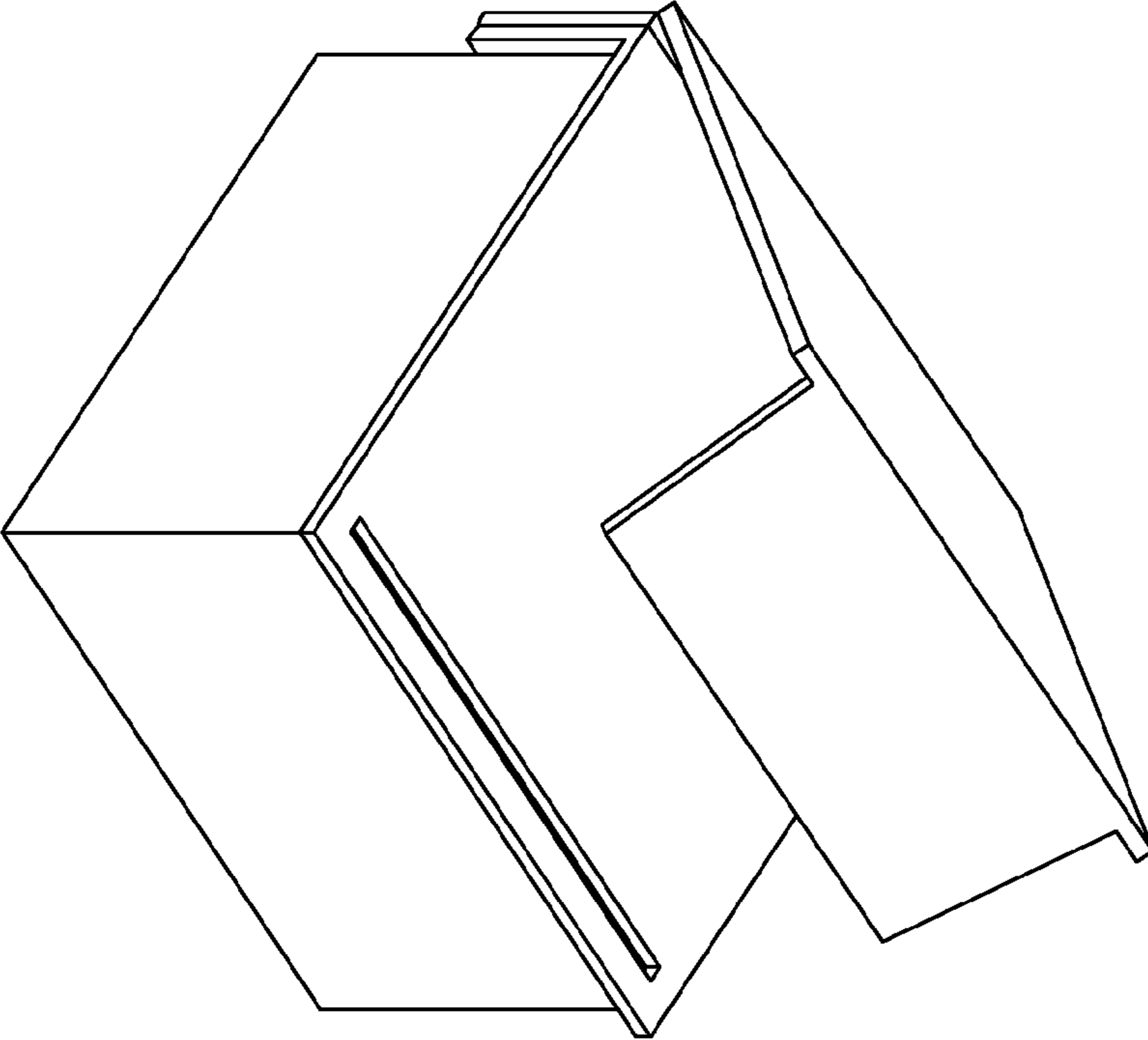

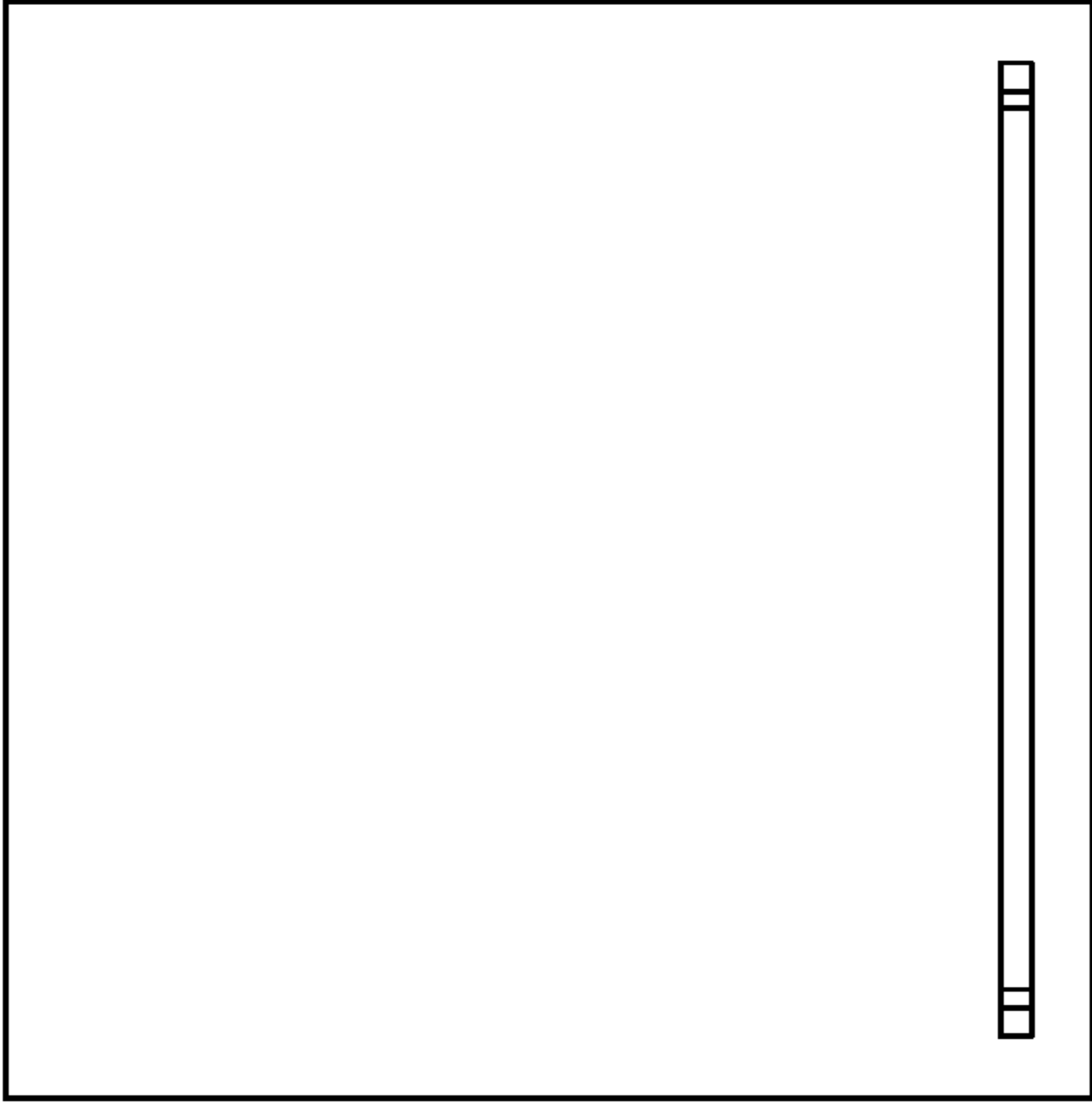

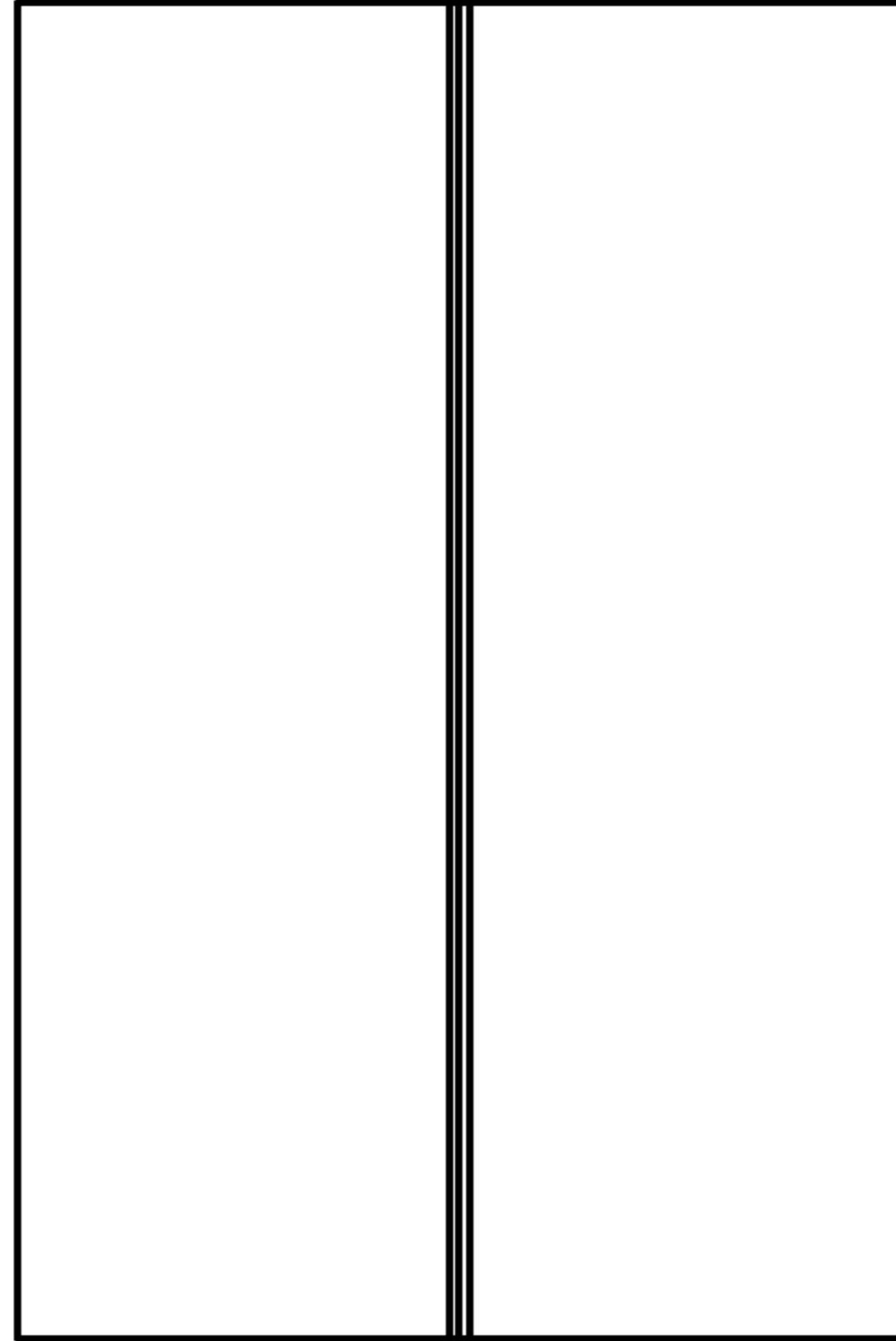

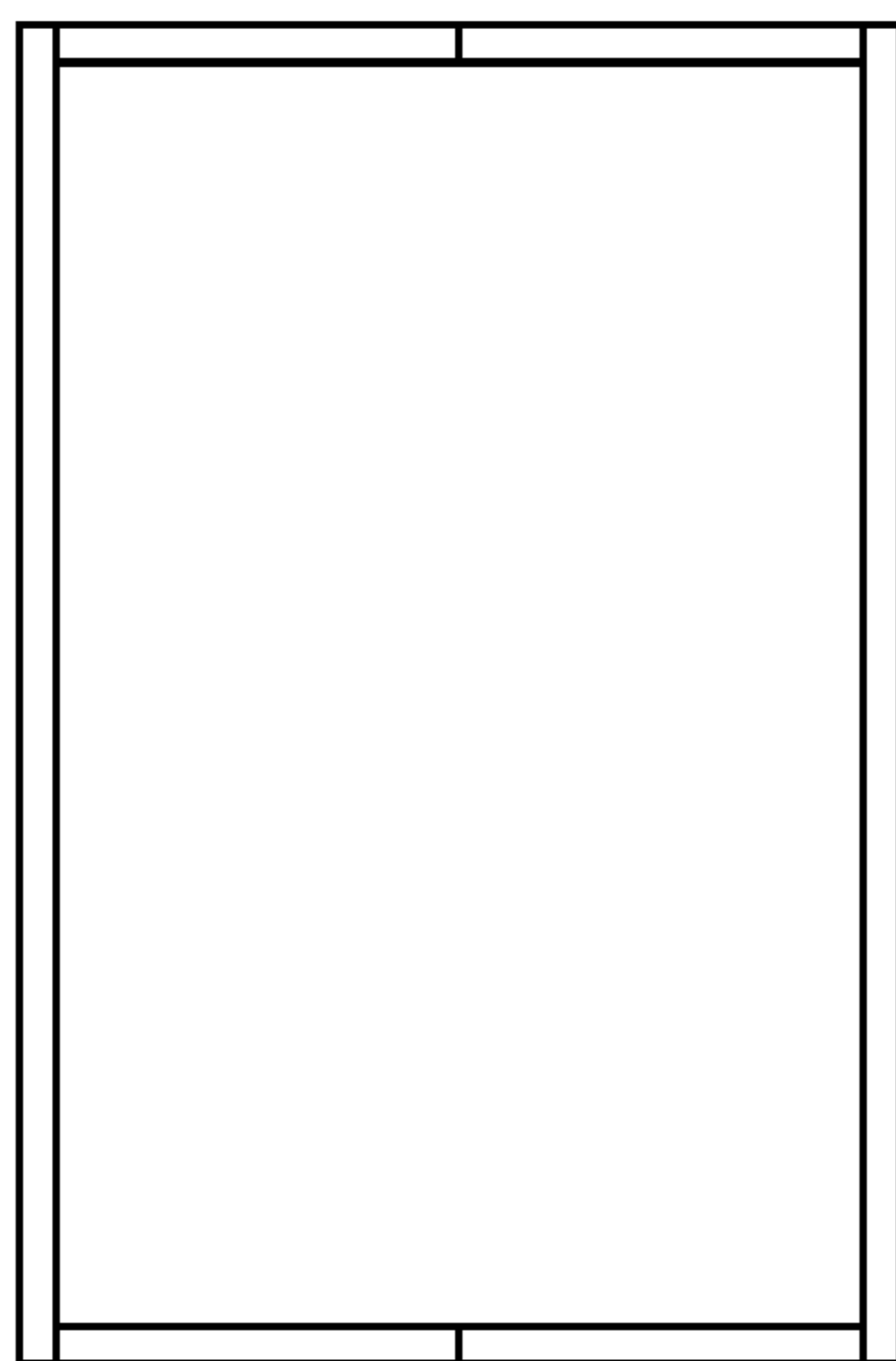

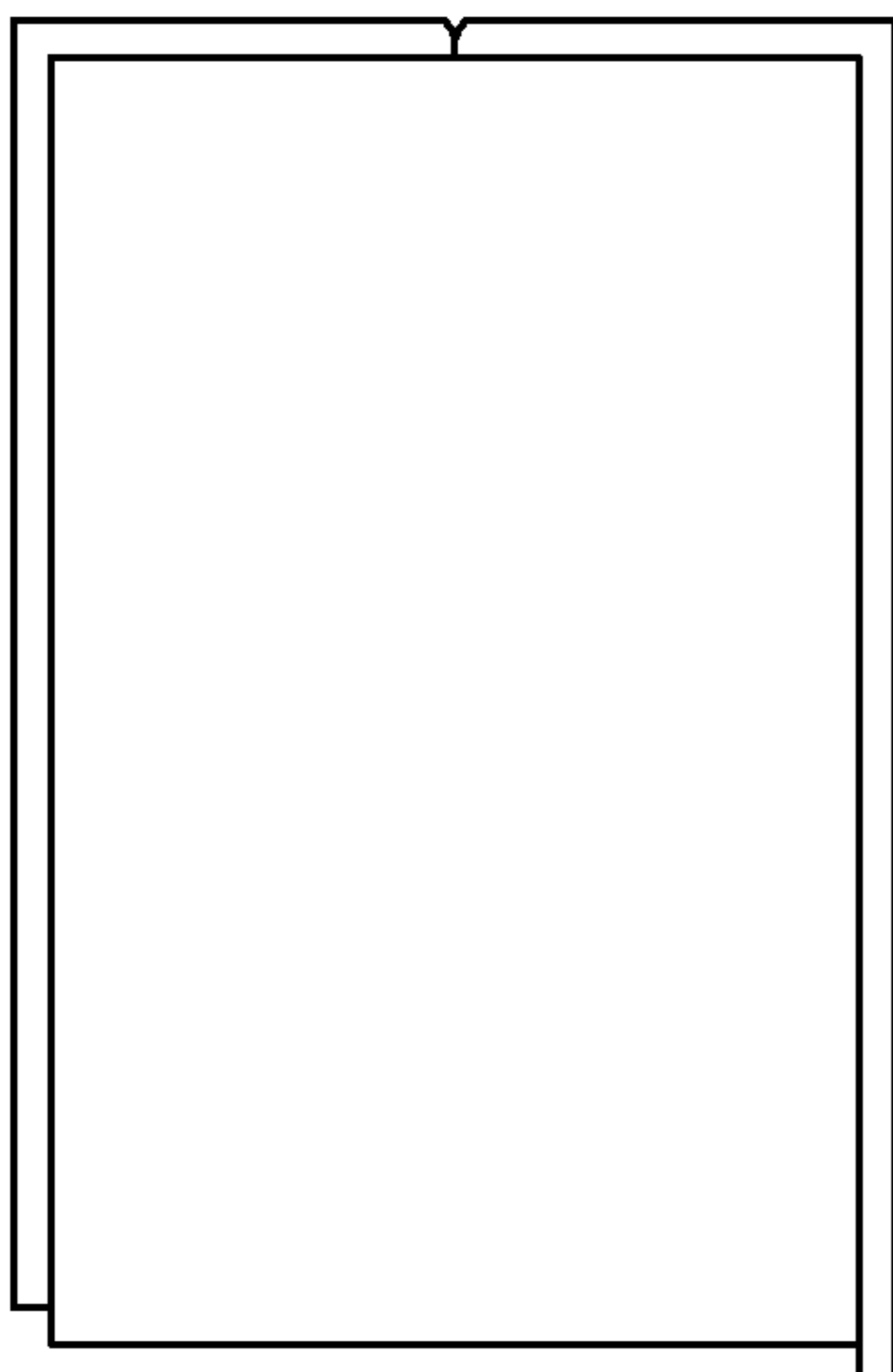

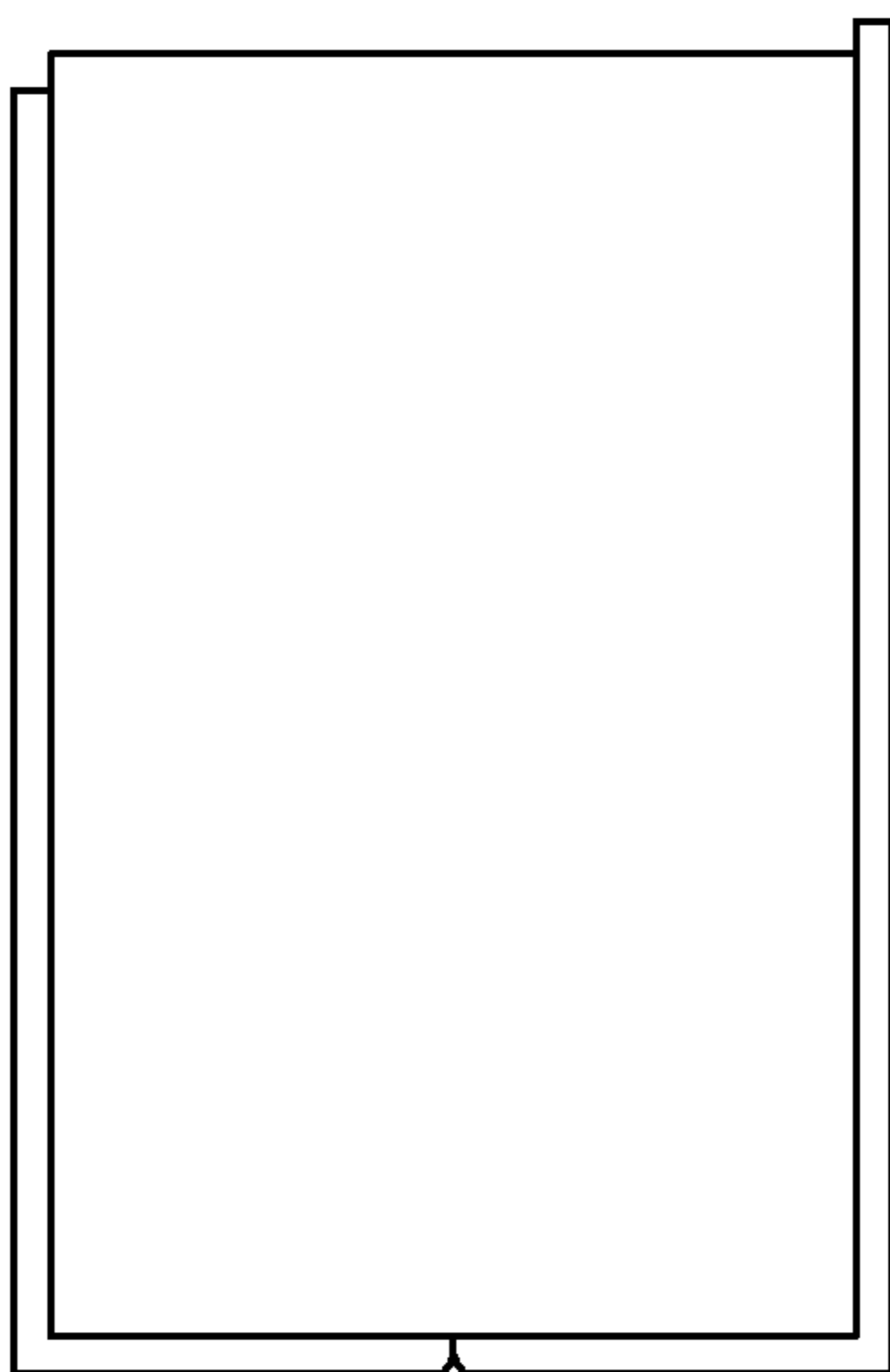
