FIG. 4 is another side view of the compliance dose indicator;

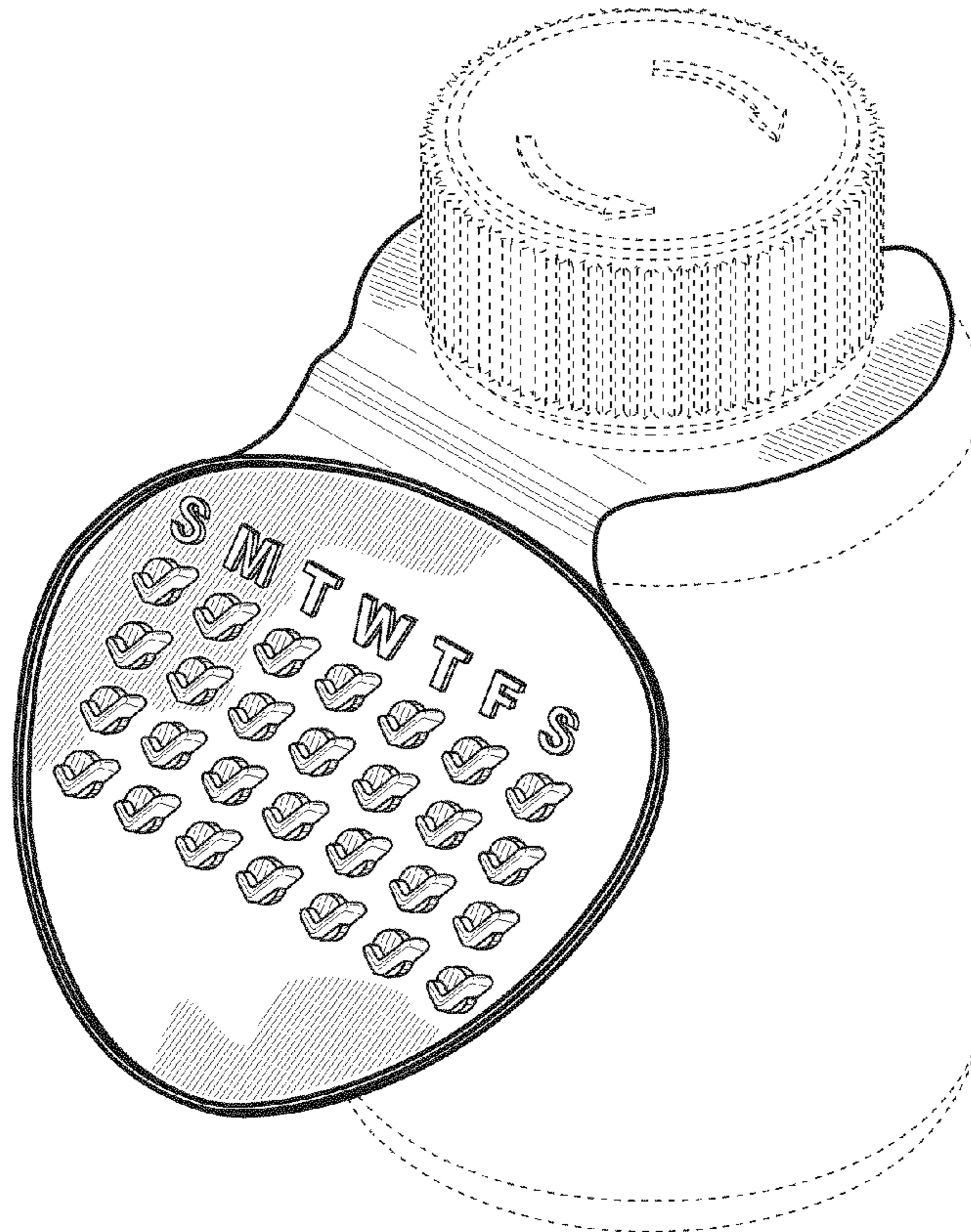
FIG. 5 is a rear view of the compliance dose indicator;

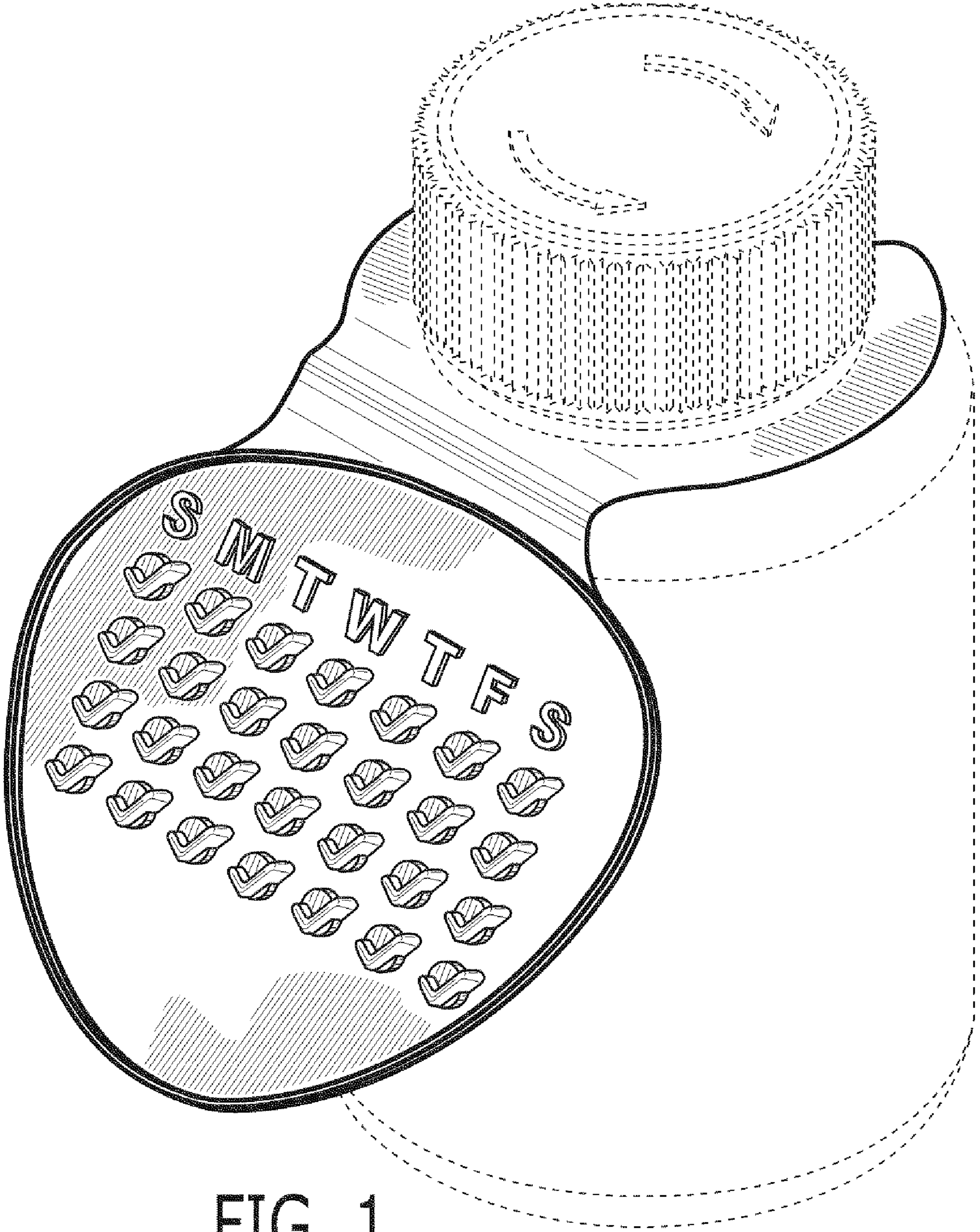

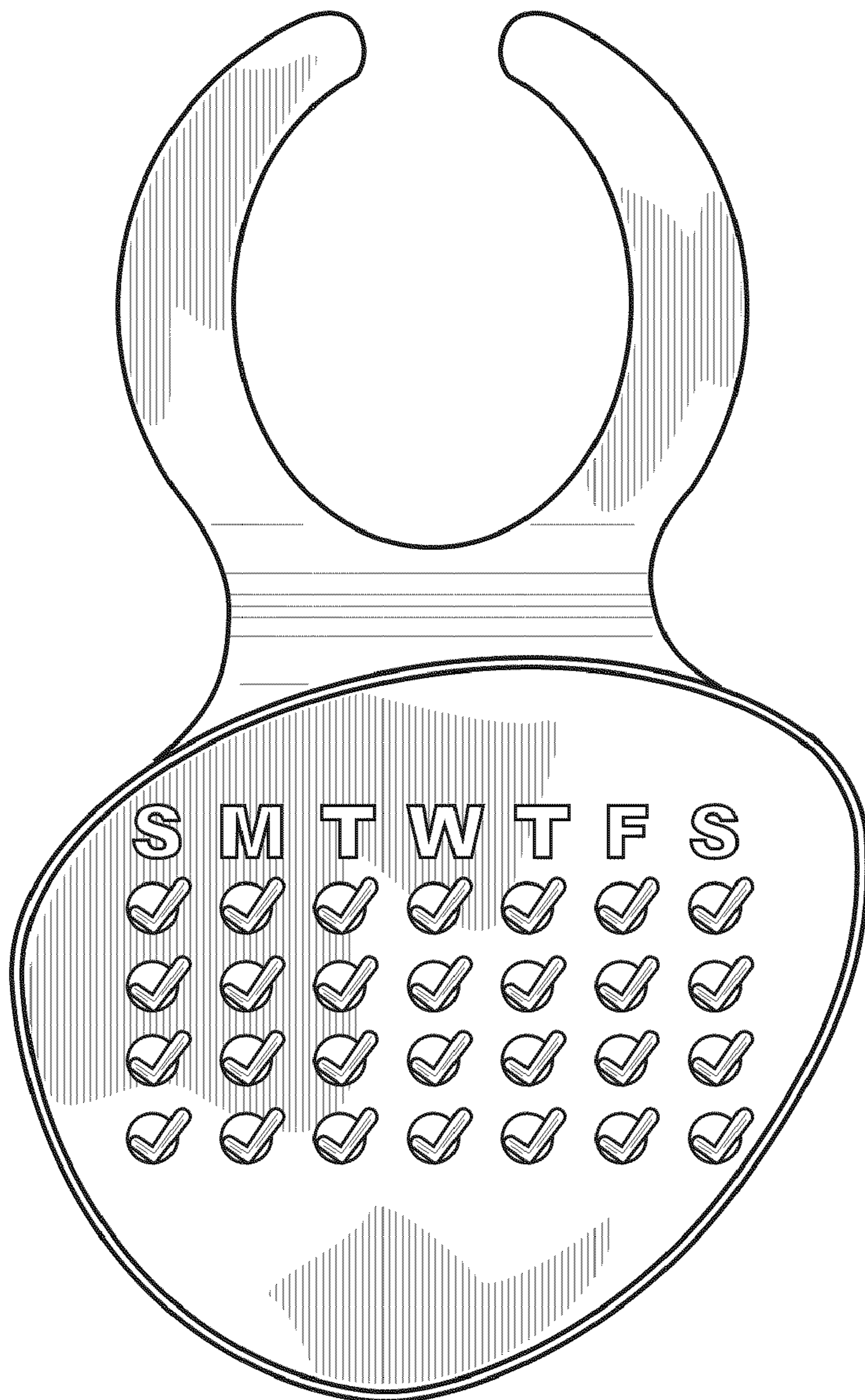

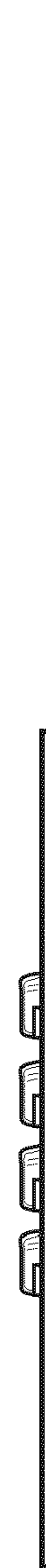

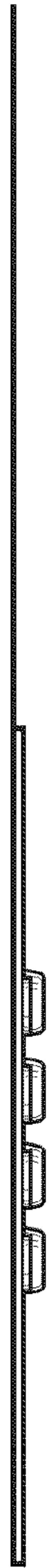

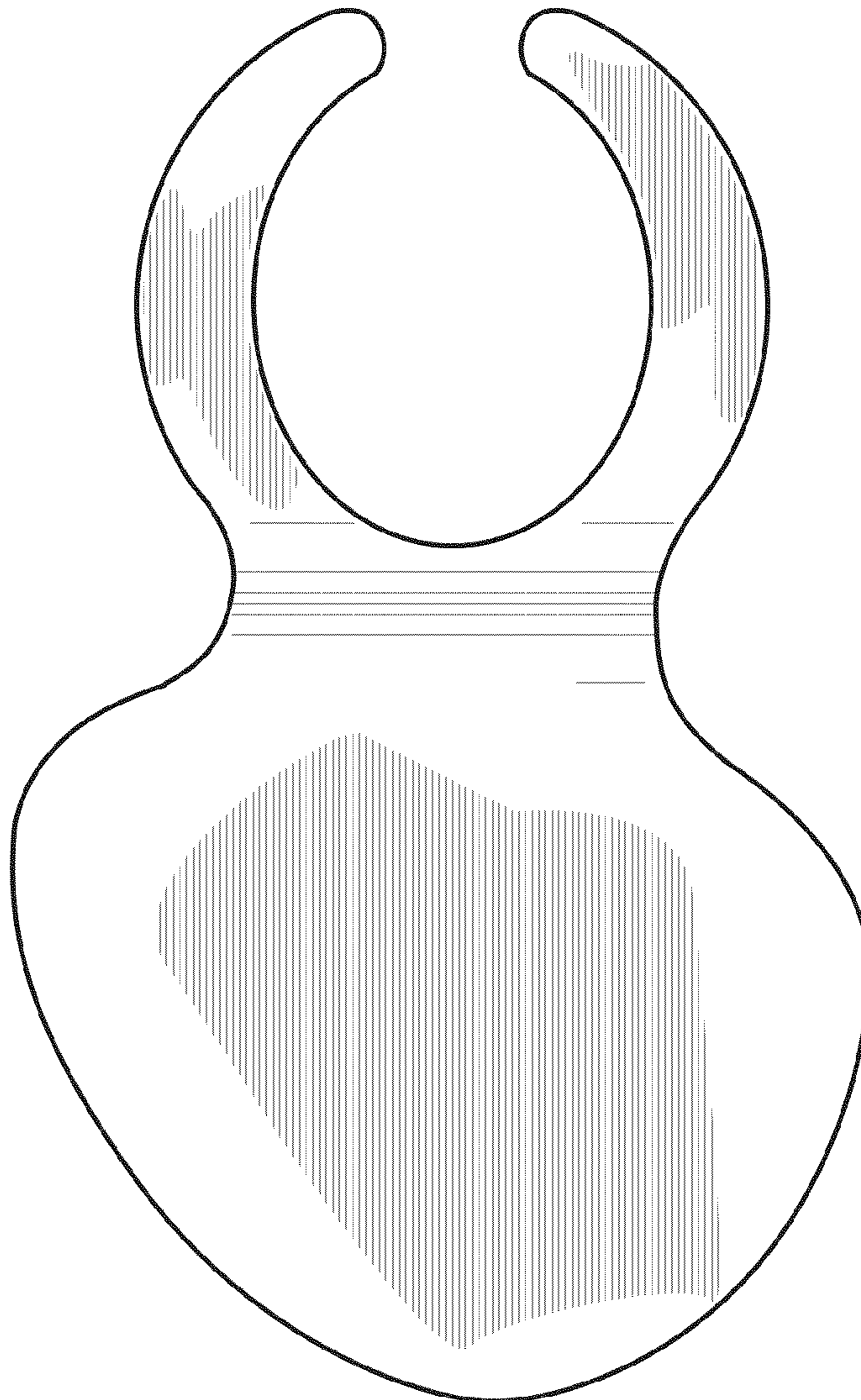

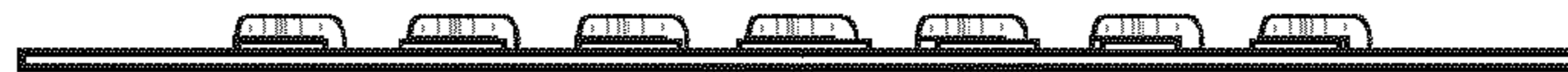

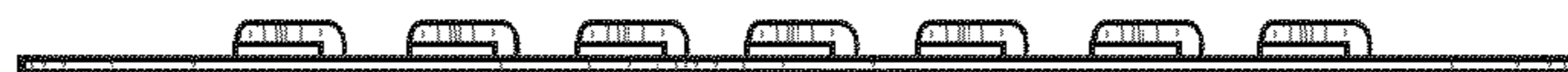
