(57) **CLAIM**

I claim the ornamental design for a closure, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a closure in accordance with one exemplary embodiment of the disclosure.

FIG. 2 is a top plan view of the closure in FIG. 1, the bottom of the closure forming no part of the claimed design.

FIG. 3 is a side elevational view of the closure in FIGS. 1 and 2, taken from the bottom in FIG. 2, the side elevational views from the sides and top of FIG. 2 being identical to FIG. 3.

FIG. 4 is a perspective view of a closure in accordance with another exemplary embodiment of the disclosure.

FIG. 5 is a top plan view of the closure in FIG. 4, the bottom of the closure forming no part of the claimed design.

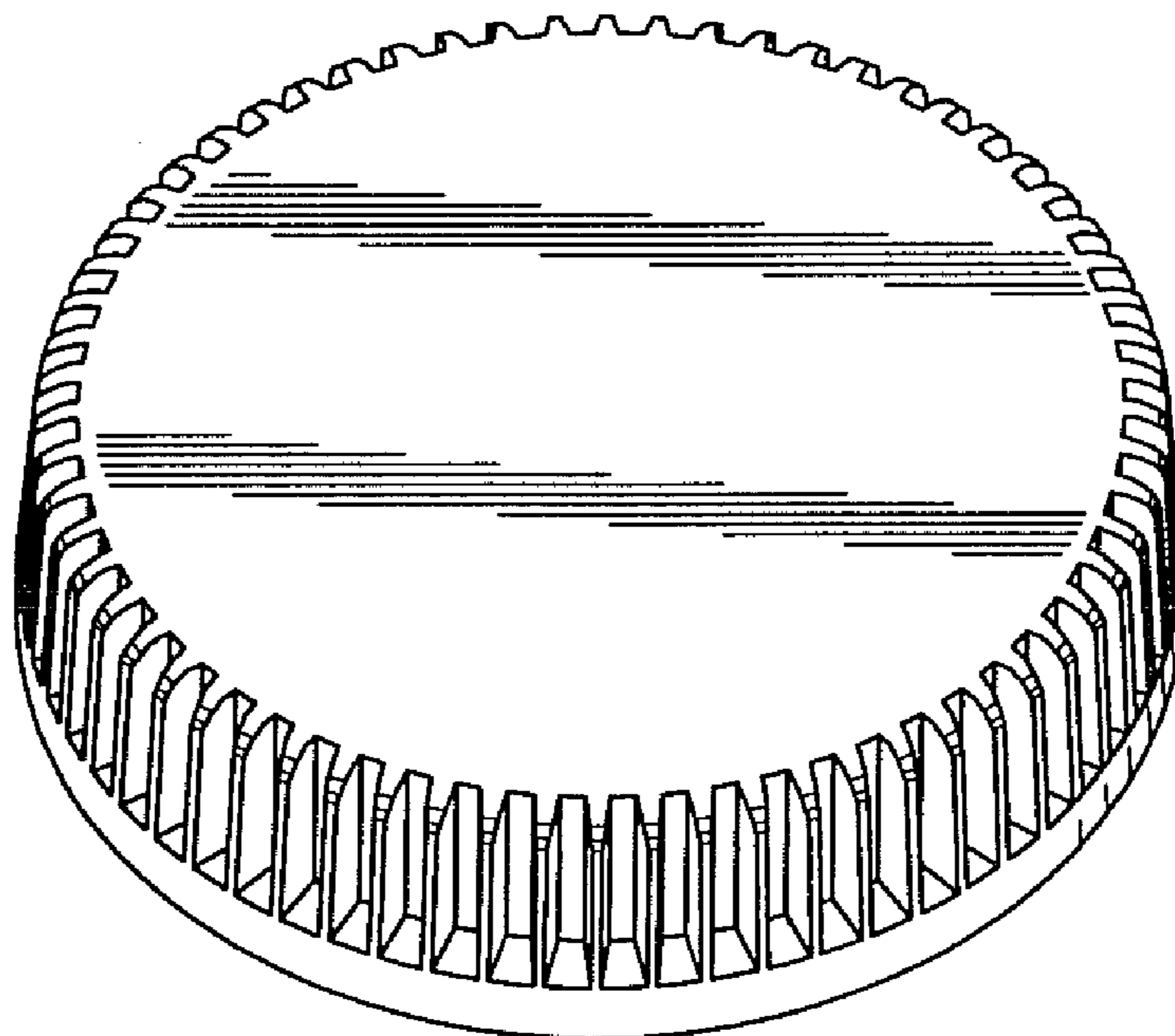
FIG. 6 is a side elevational view taken from the bottom in FIG. 5, the side elevational views from the top and sides in FIG. 5 being identical to FIG. 6.

FIG. 7 is a perspective view of a closure in accordance with a further exemplary embodiment of the disclosure.

FIG. 8 is a top plan view of the closure in FIG. 7, the bottom of the closure forming no part of the claimed design; and,

FIG. 9 is a side elevational view taken from the bottom in FIG. 8, the elevational views from the sides and top in FIG. 8 being identical to FIG. 9.

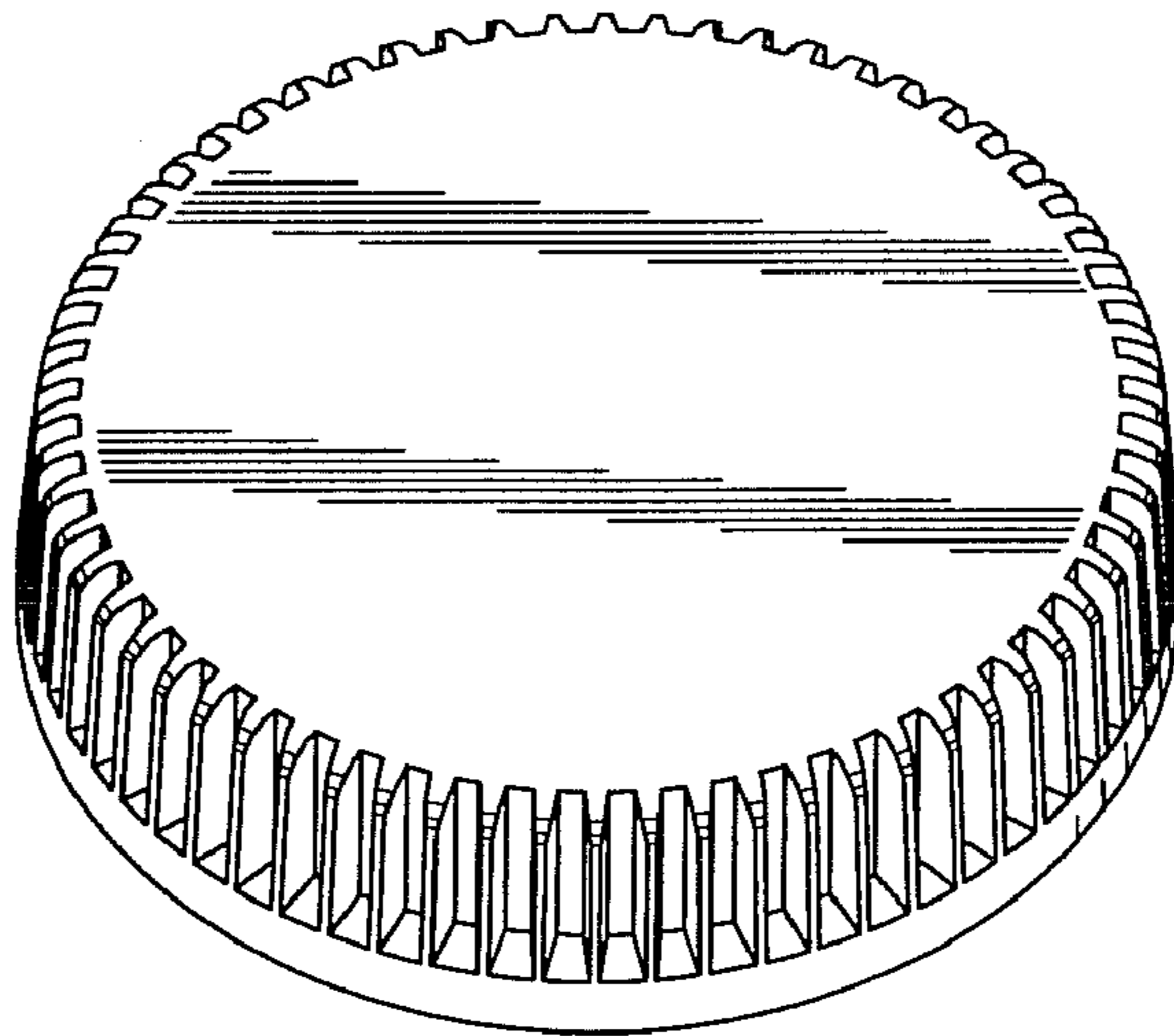

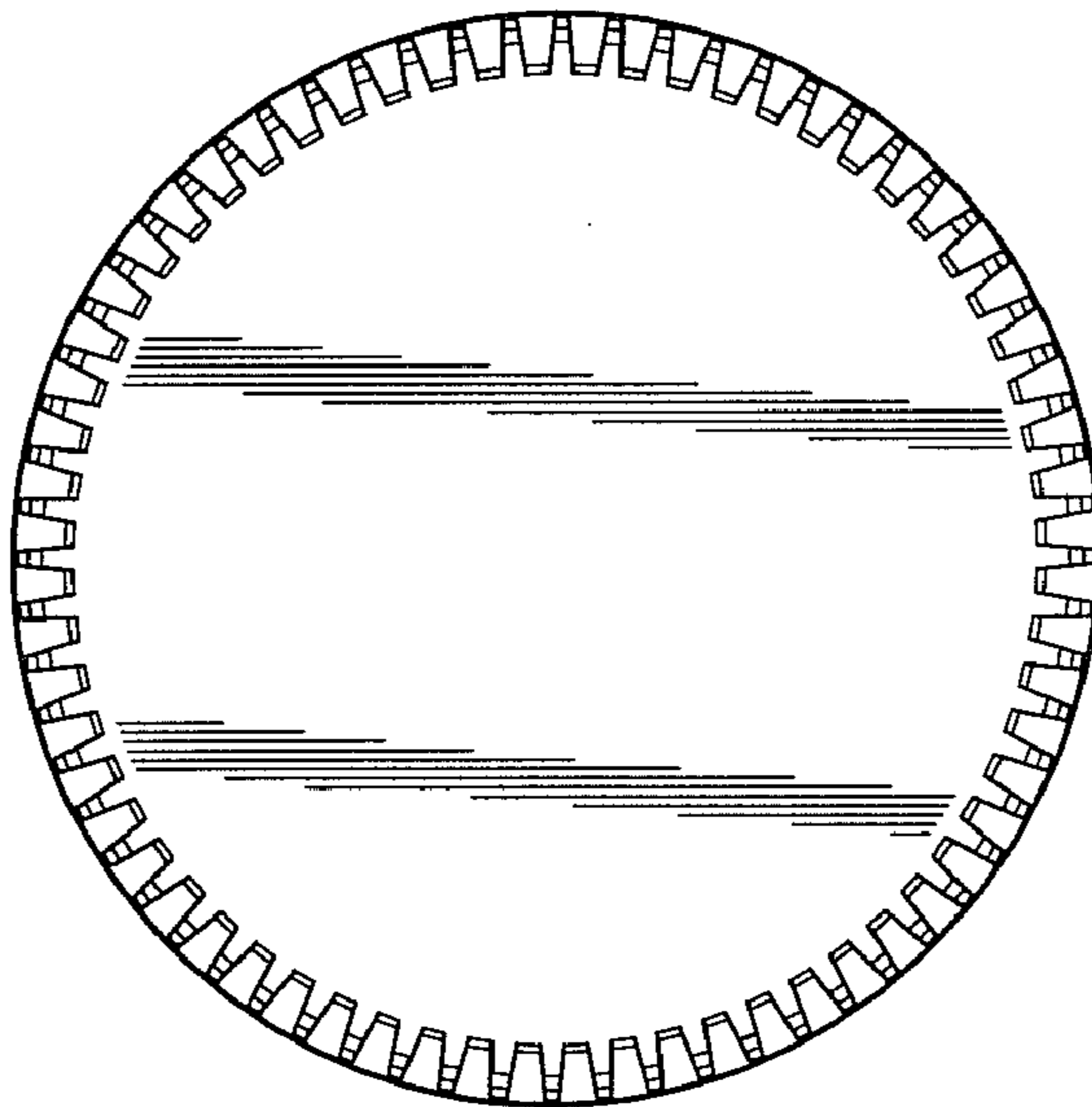

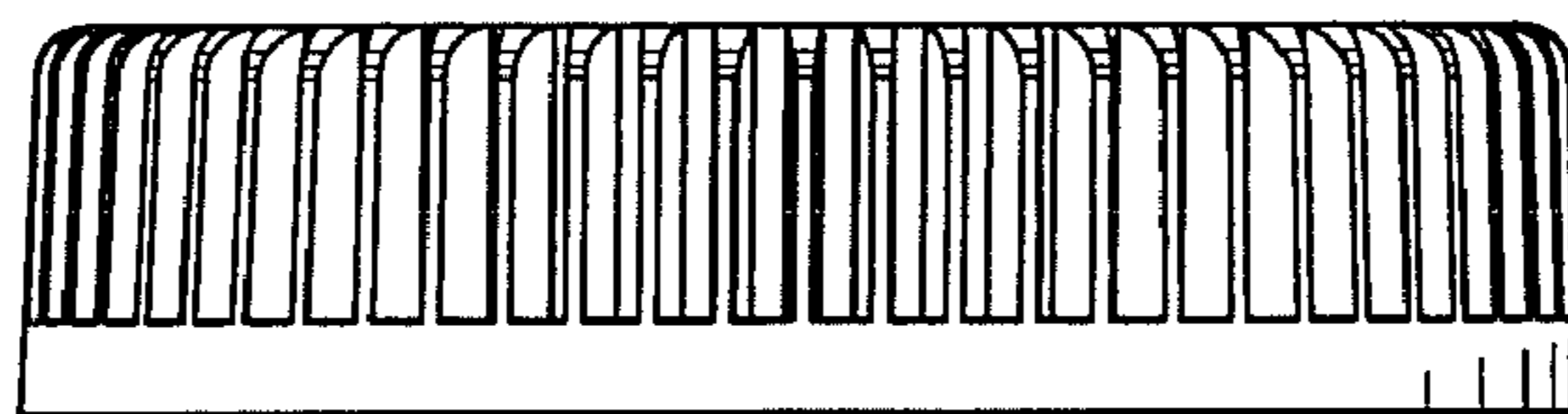

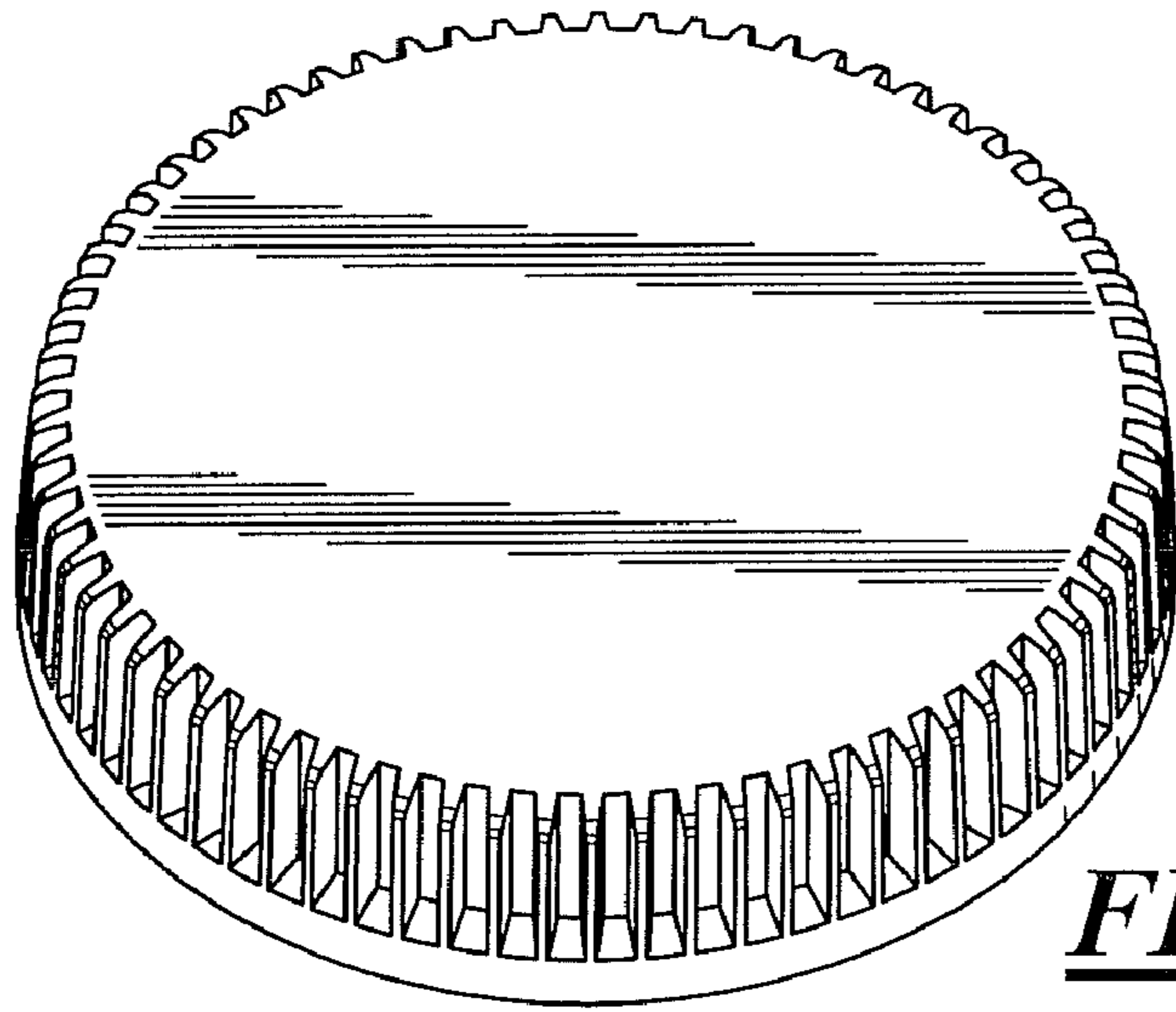

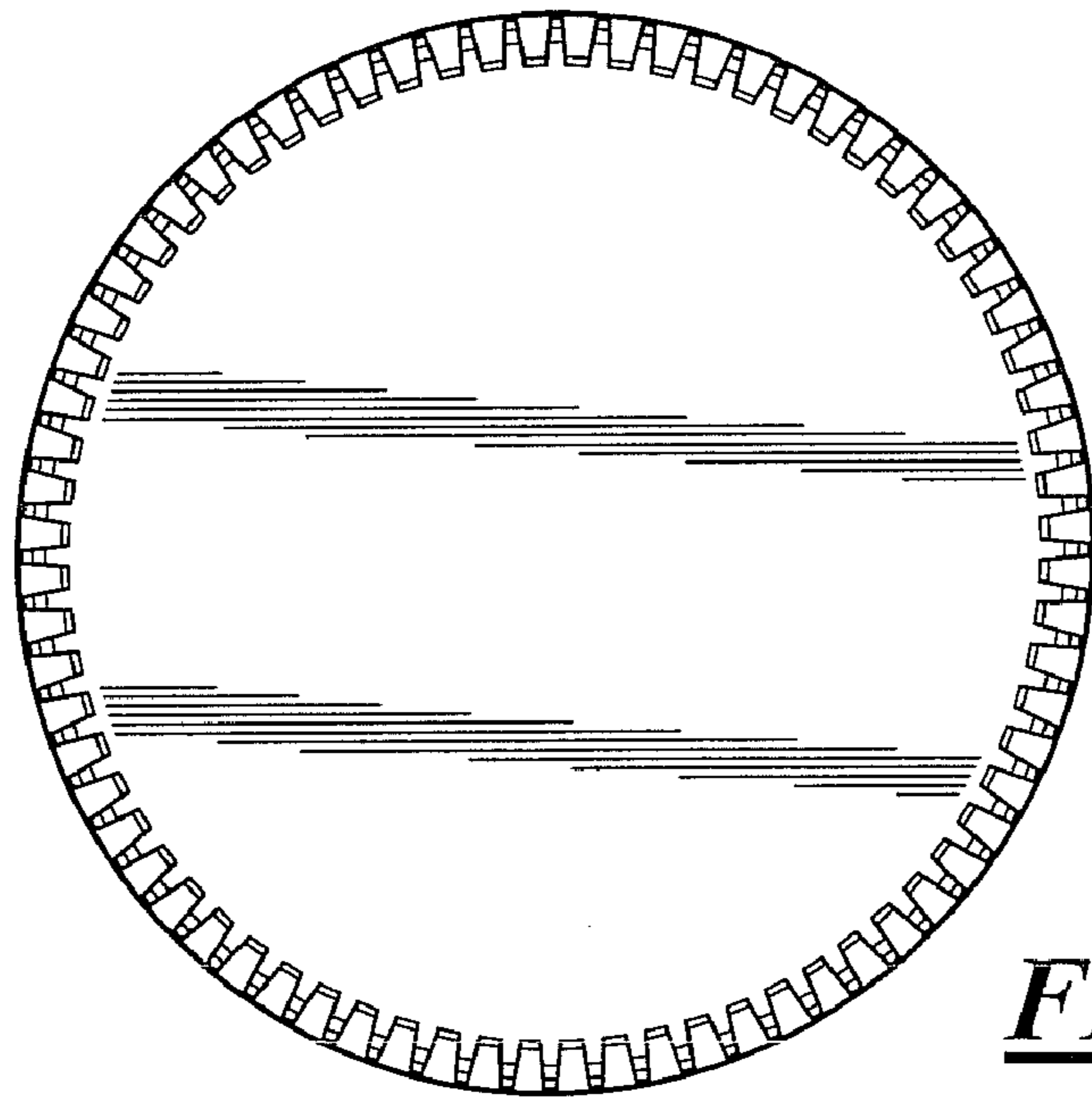

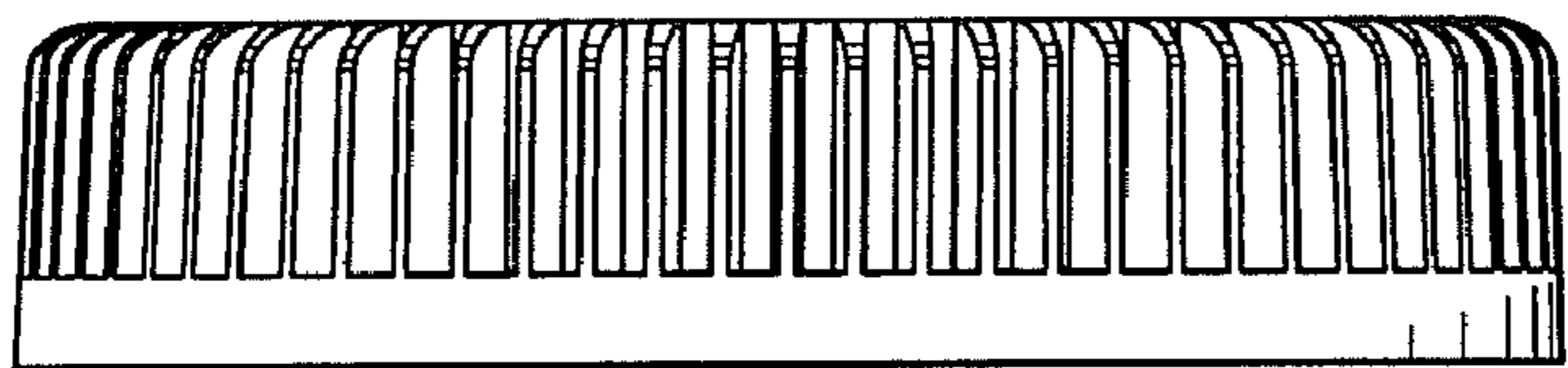

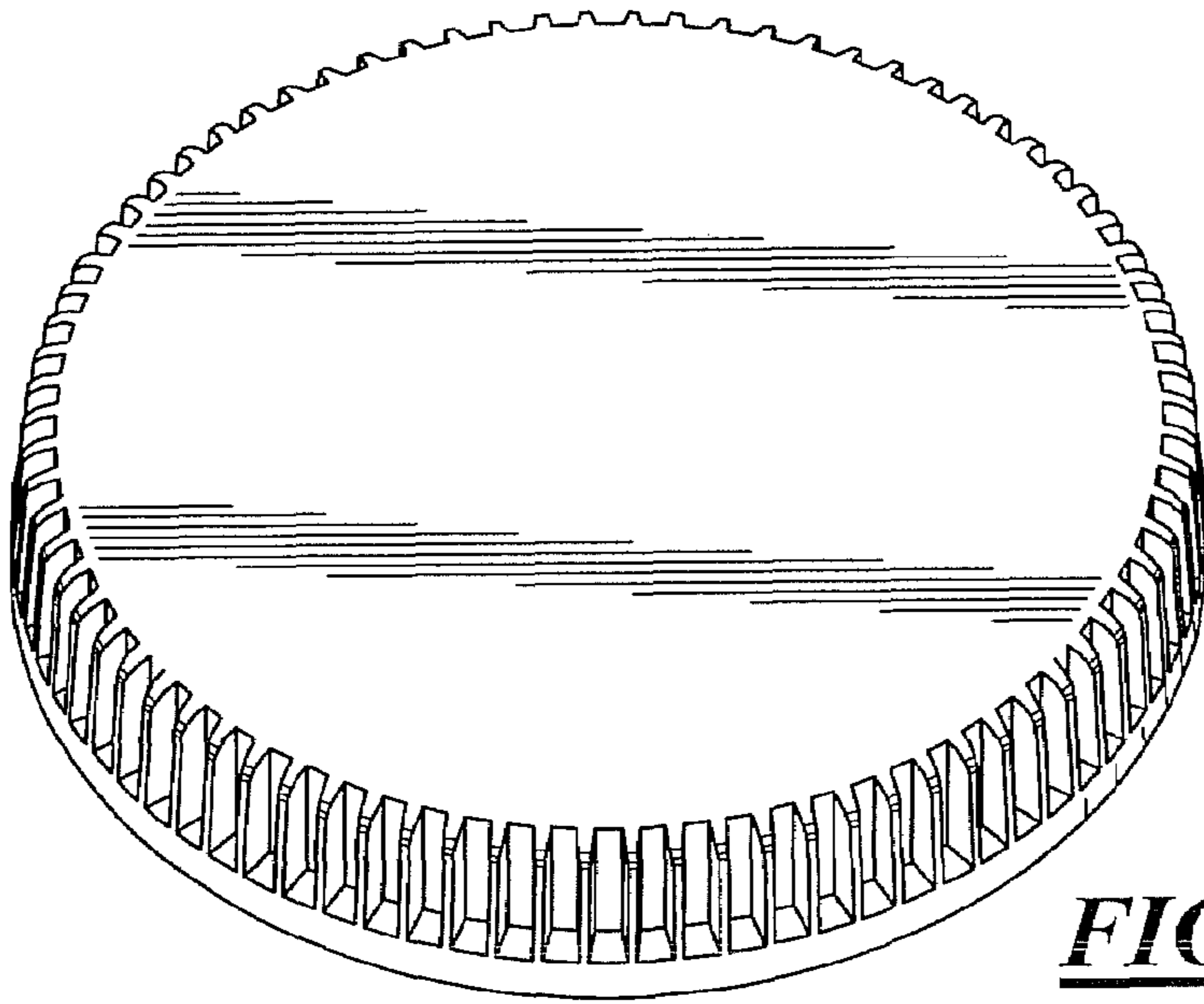

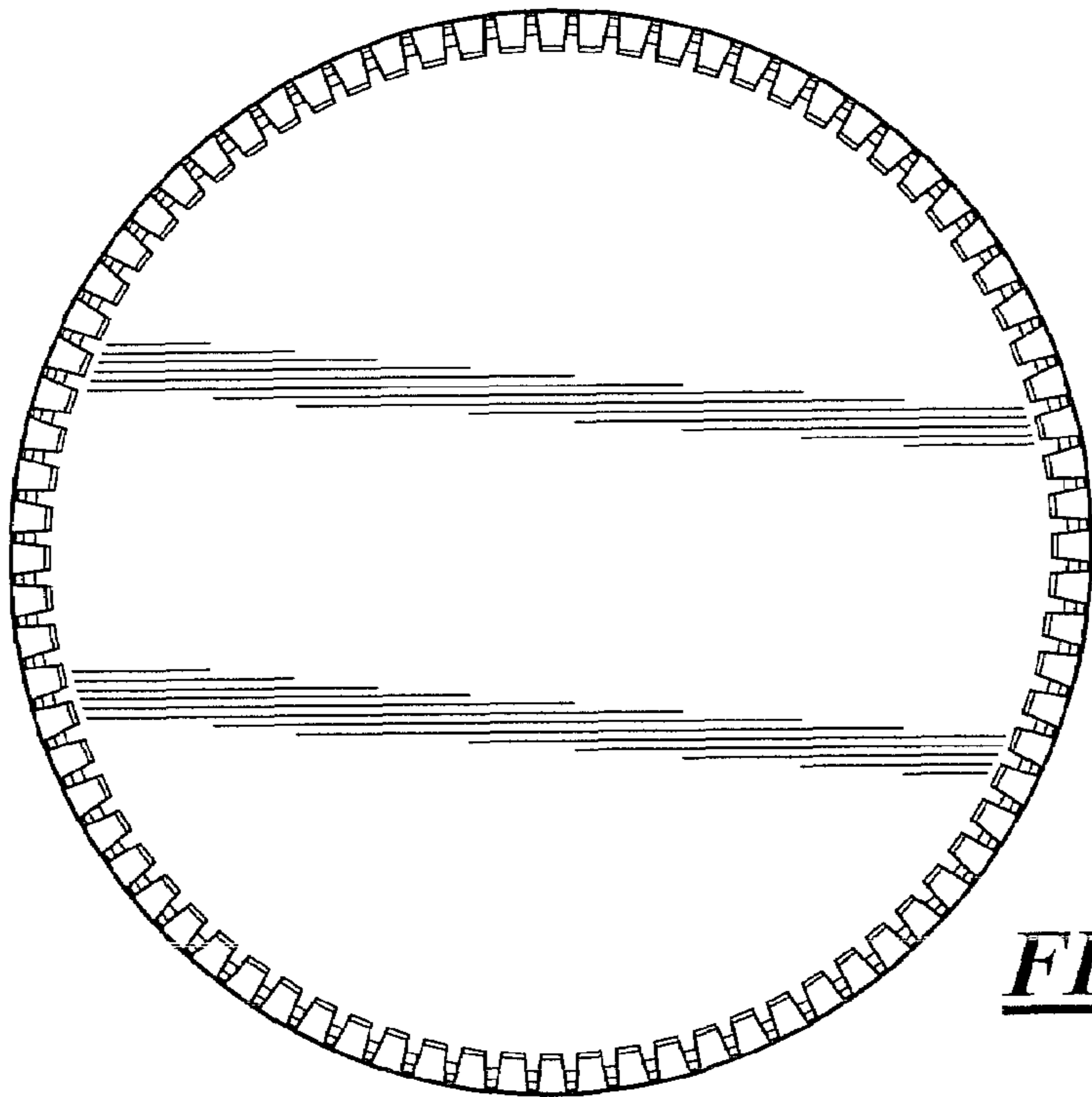

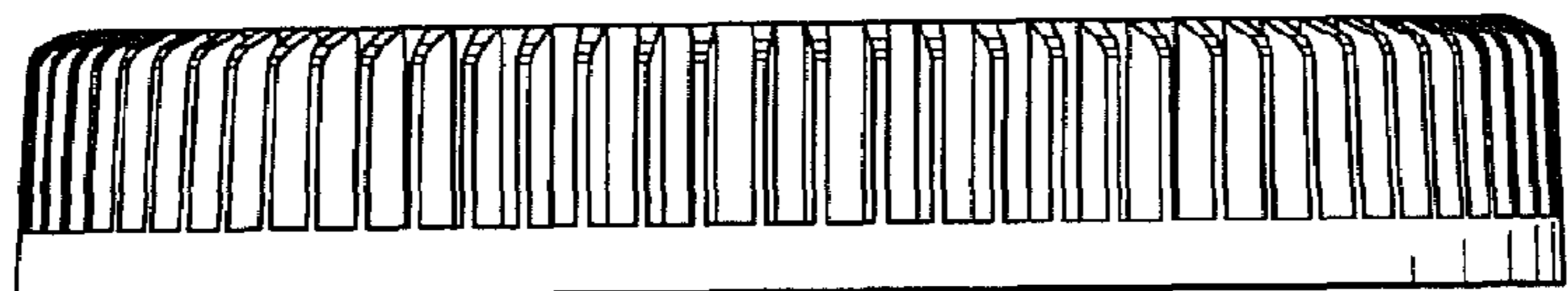
