FIG. 5 is a front view of the design with open cover-lid without bottle;

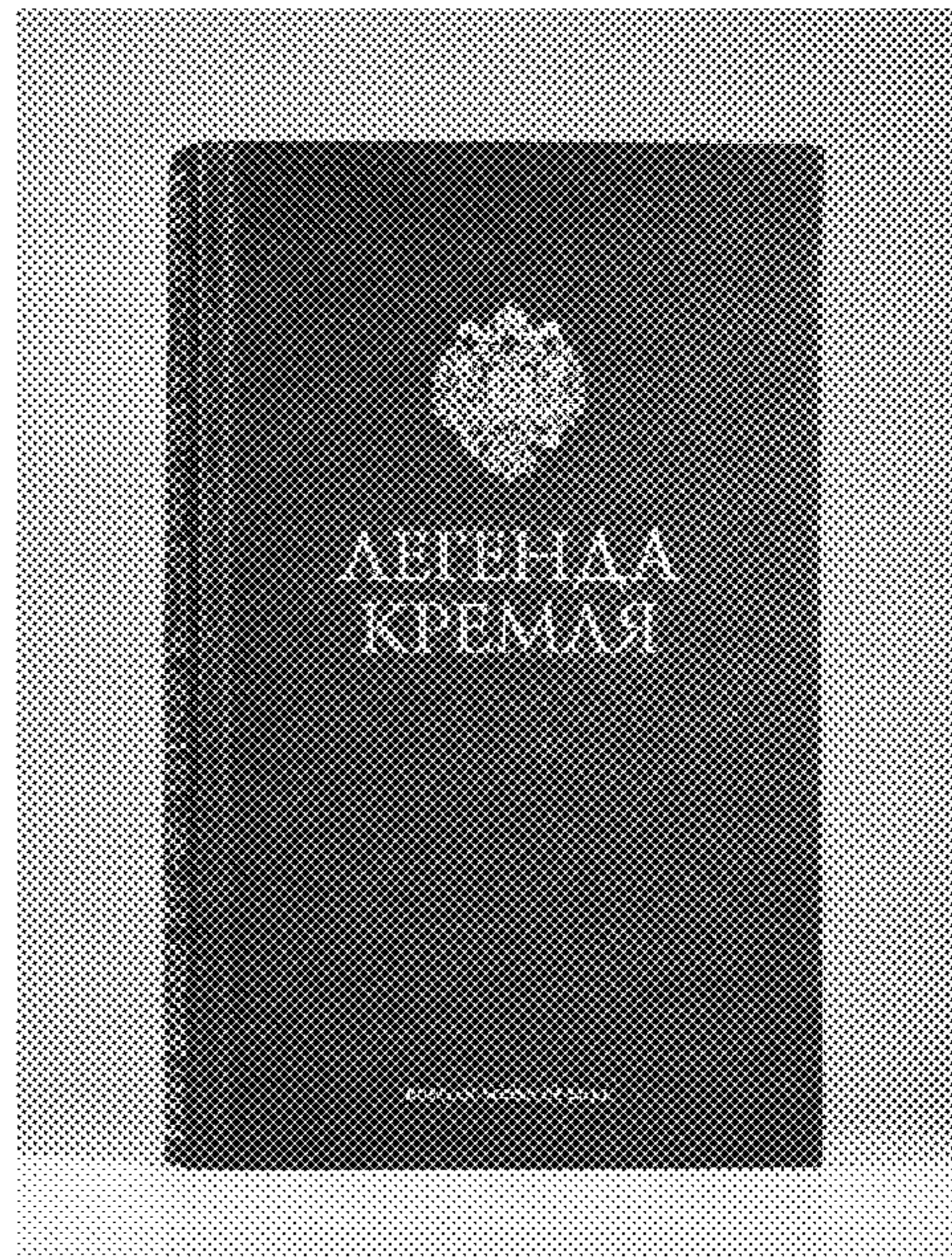
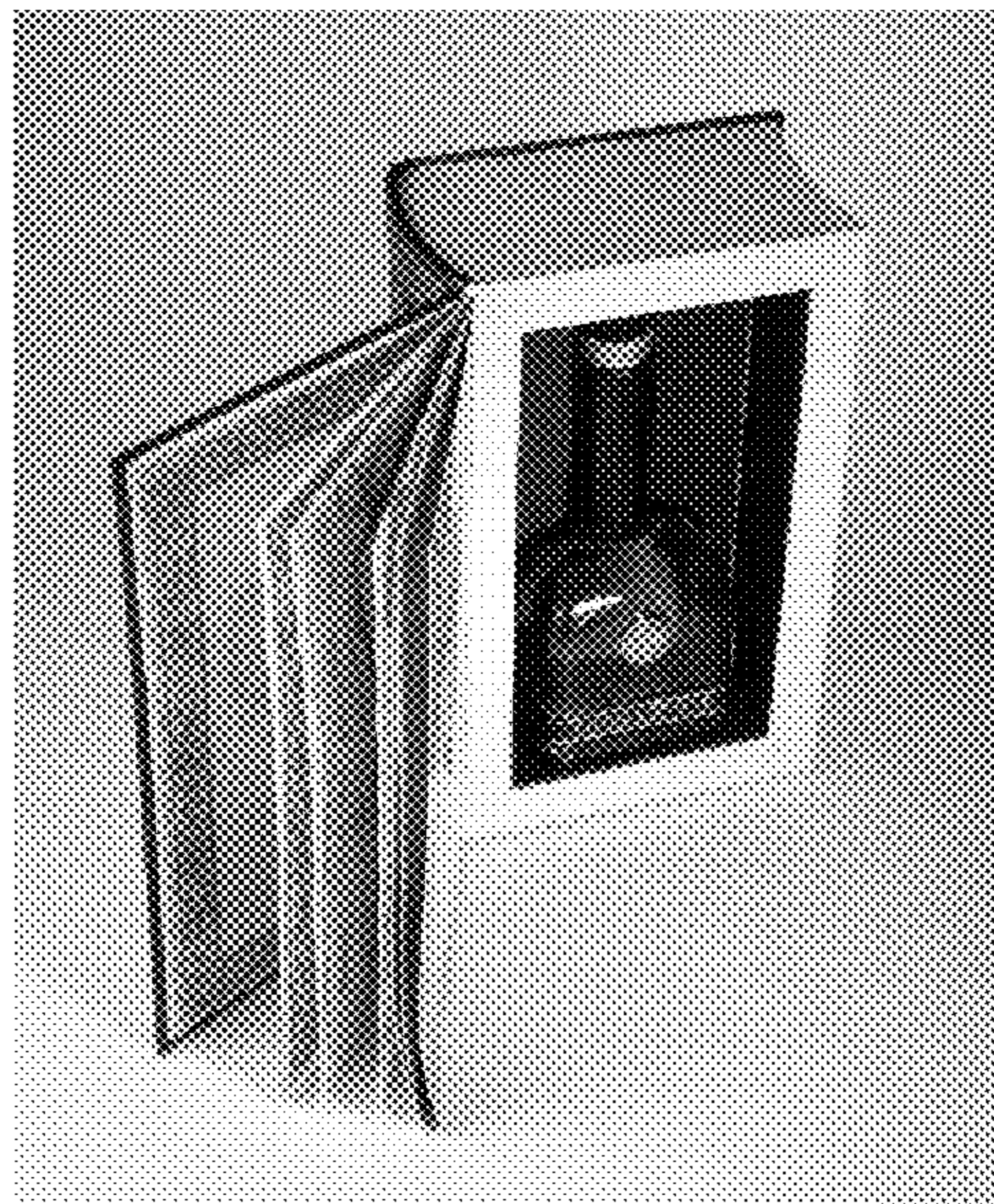
FIG. 6 is a left view of the design;

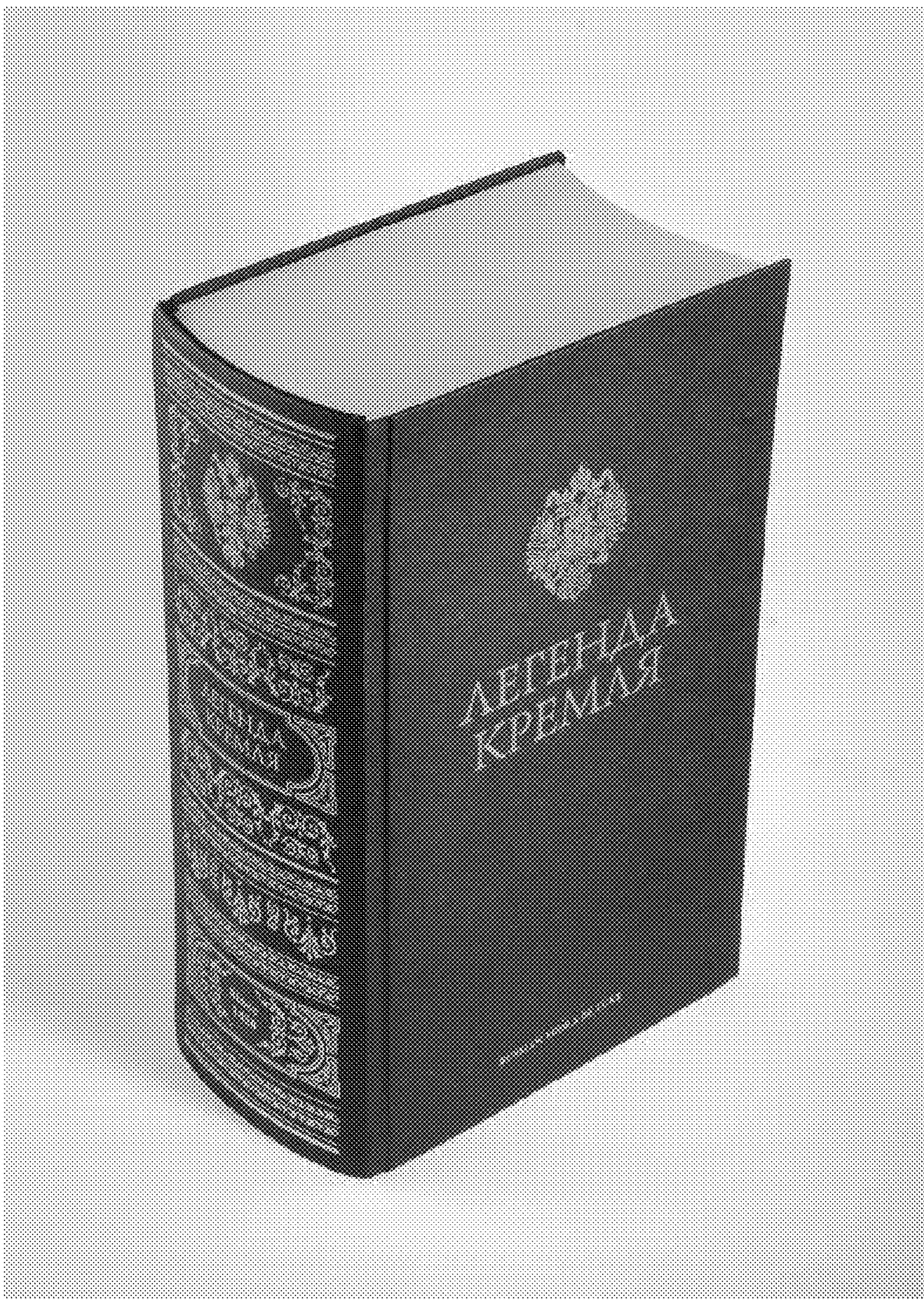

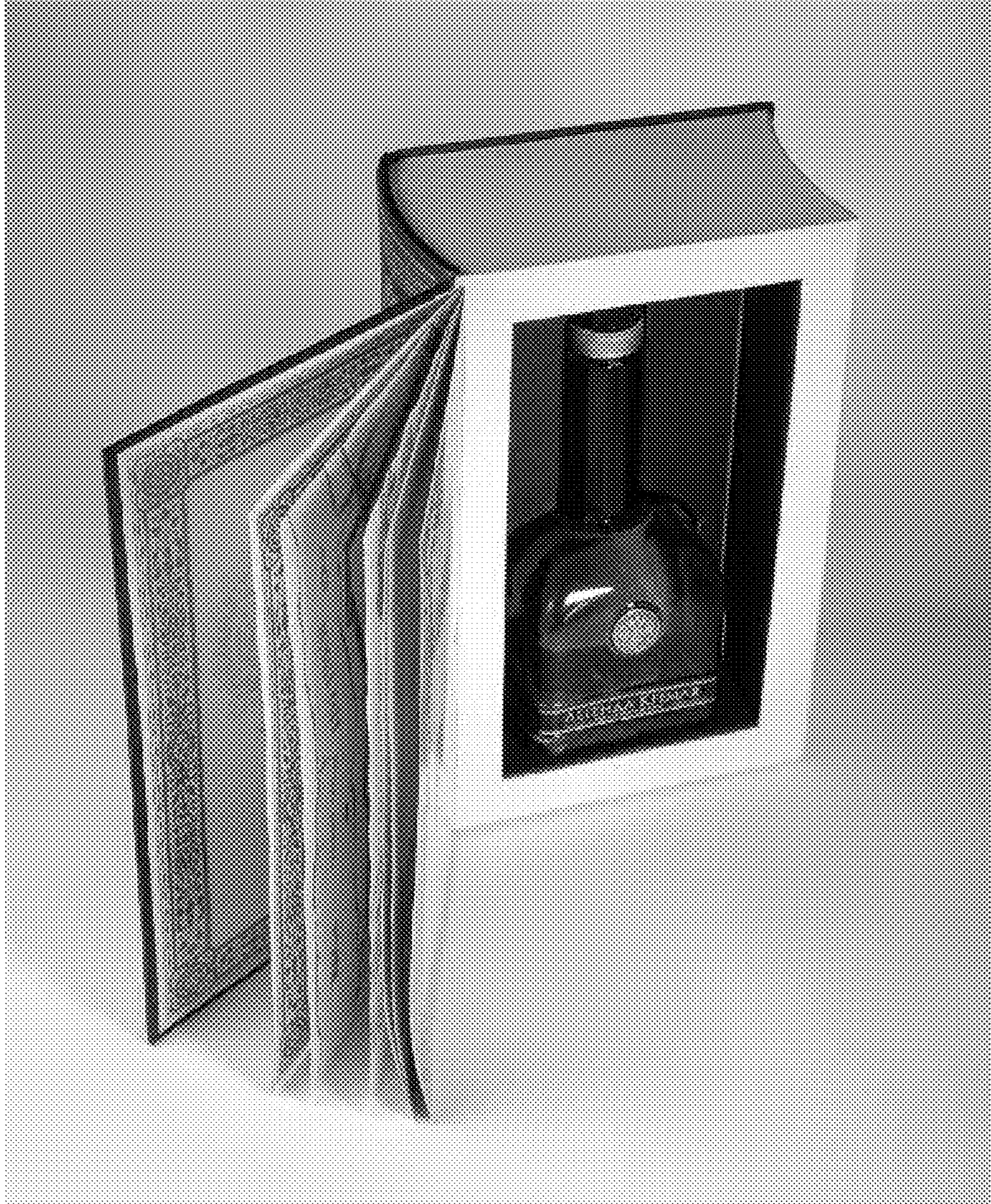

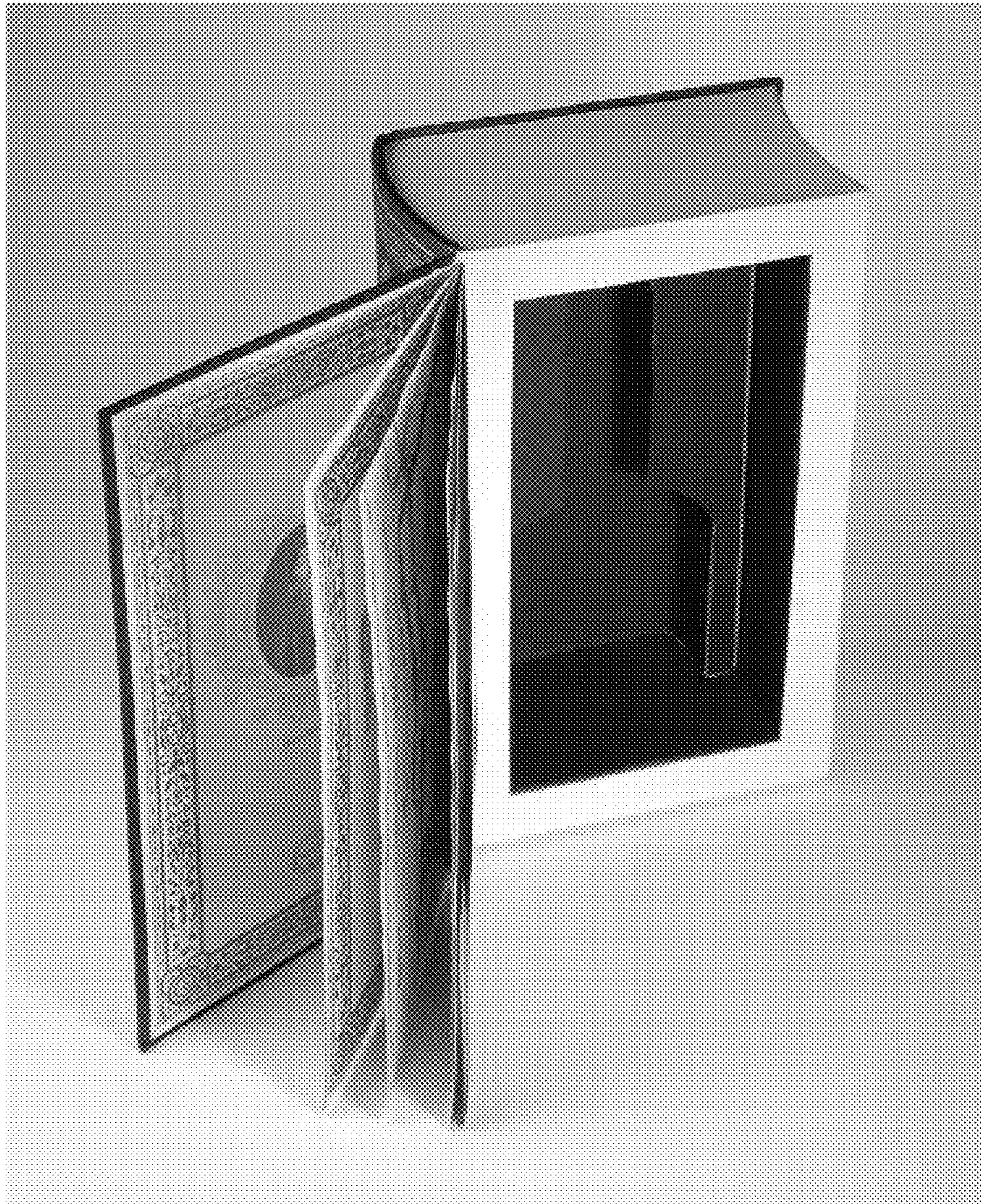

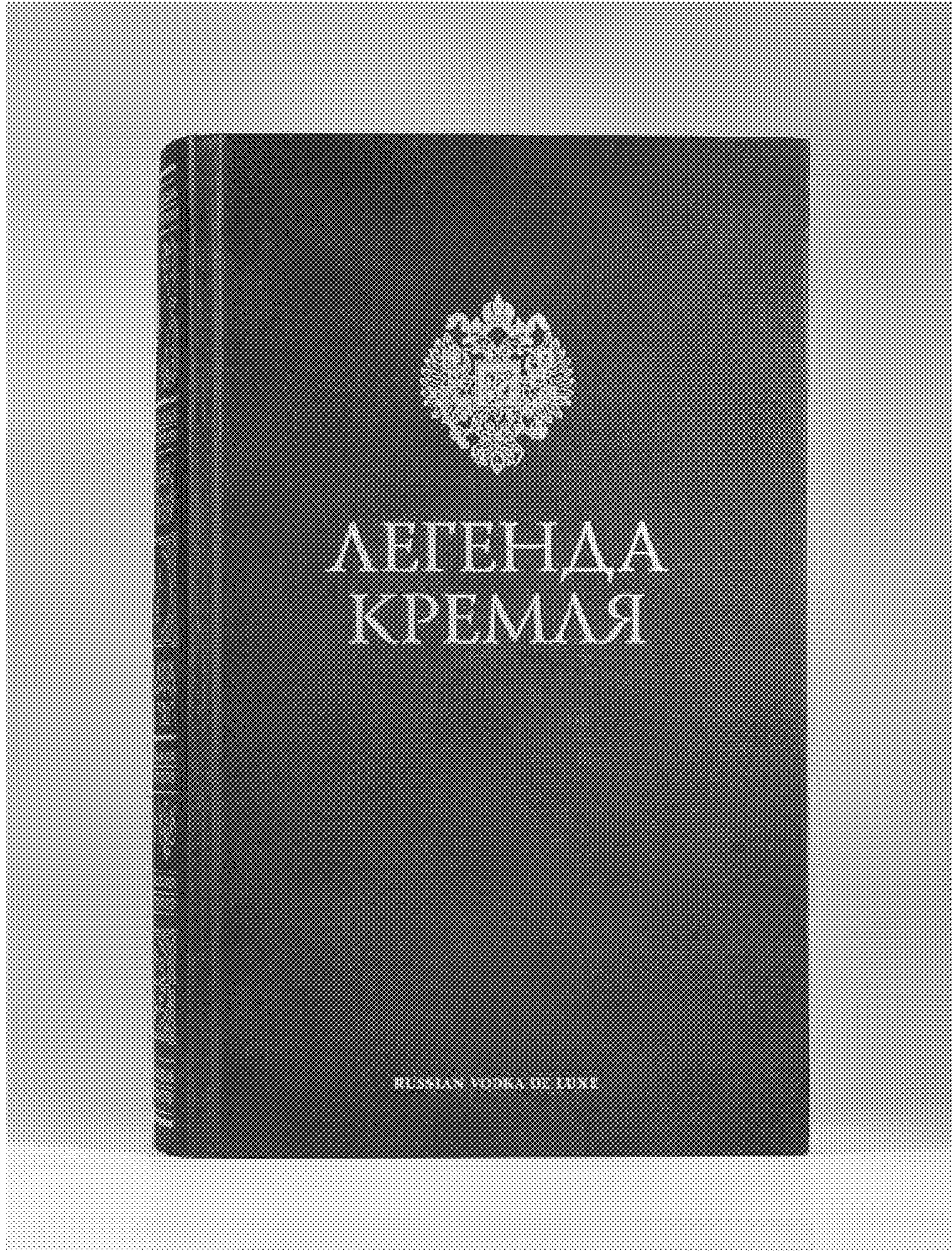

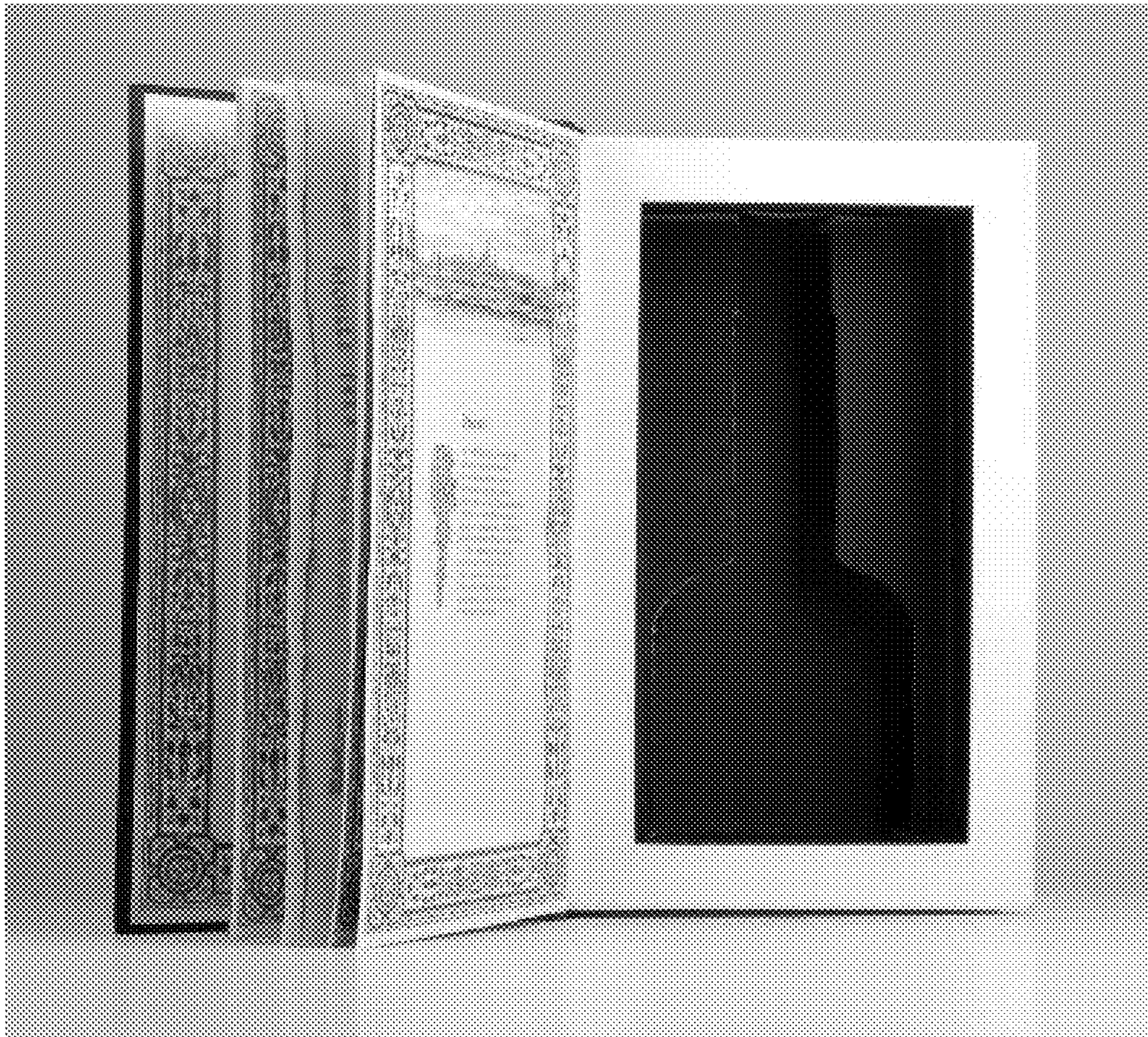

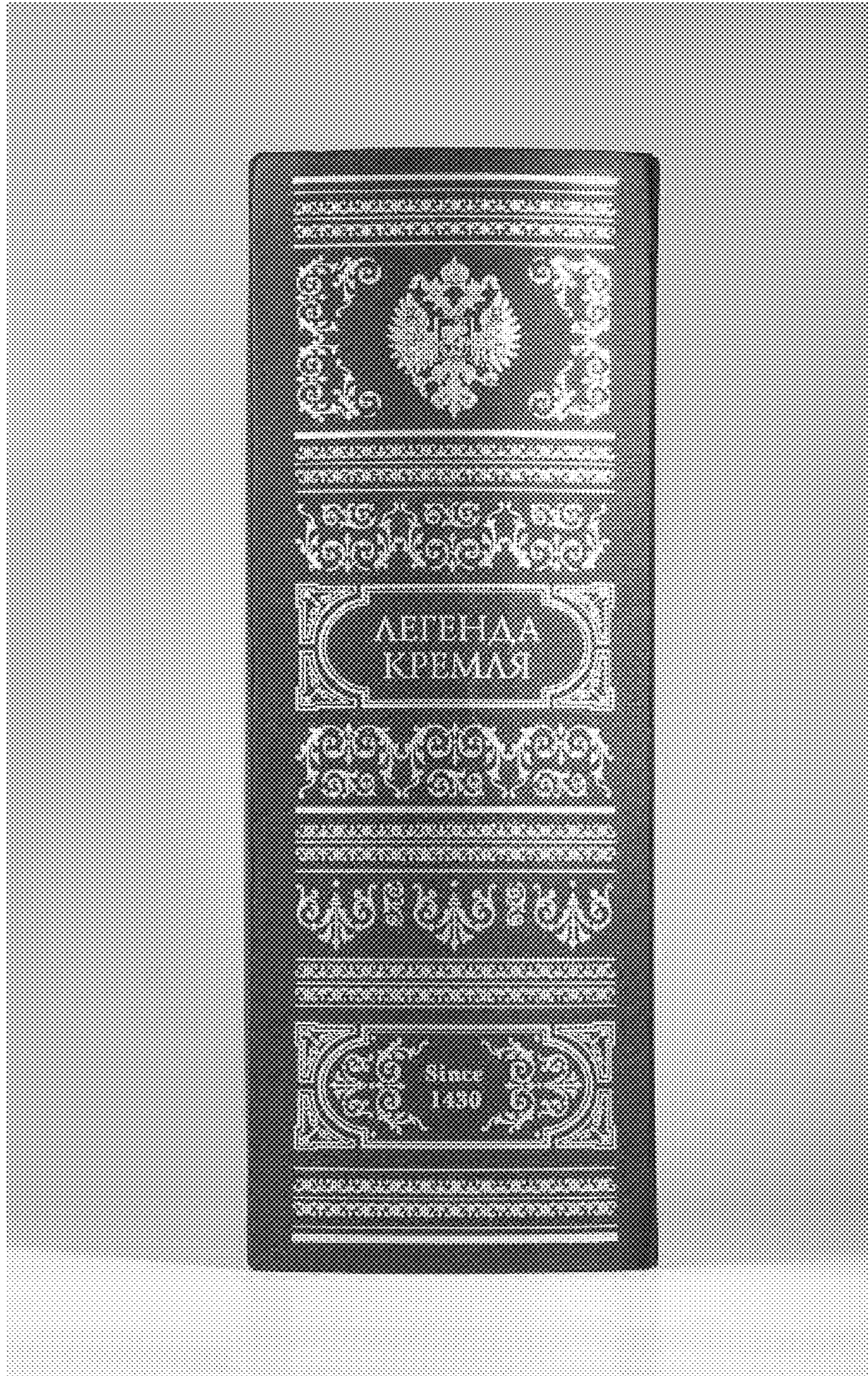

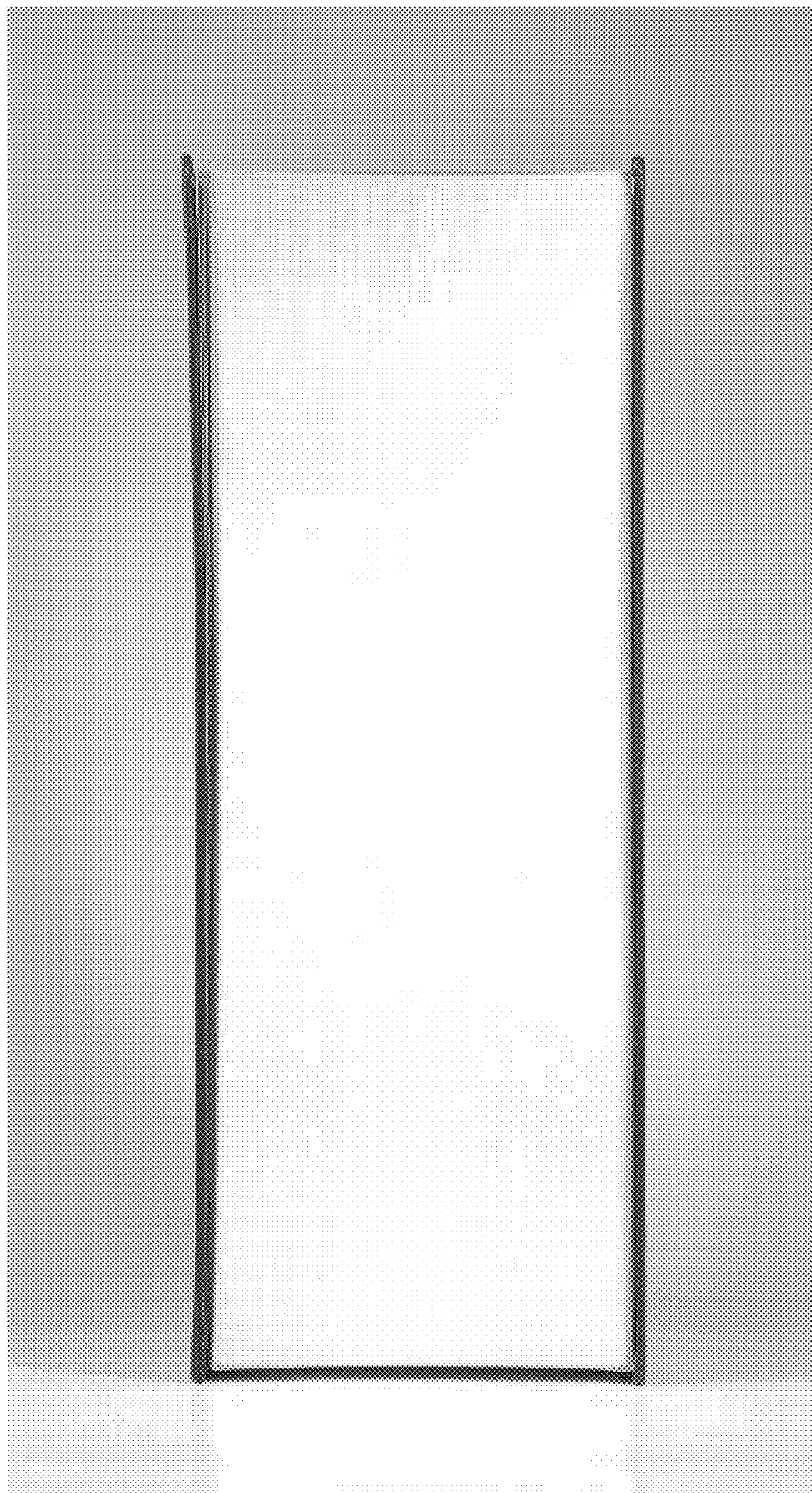

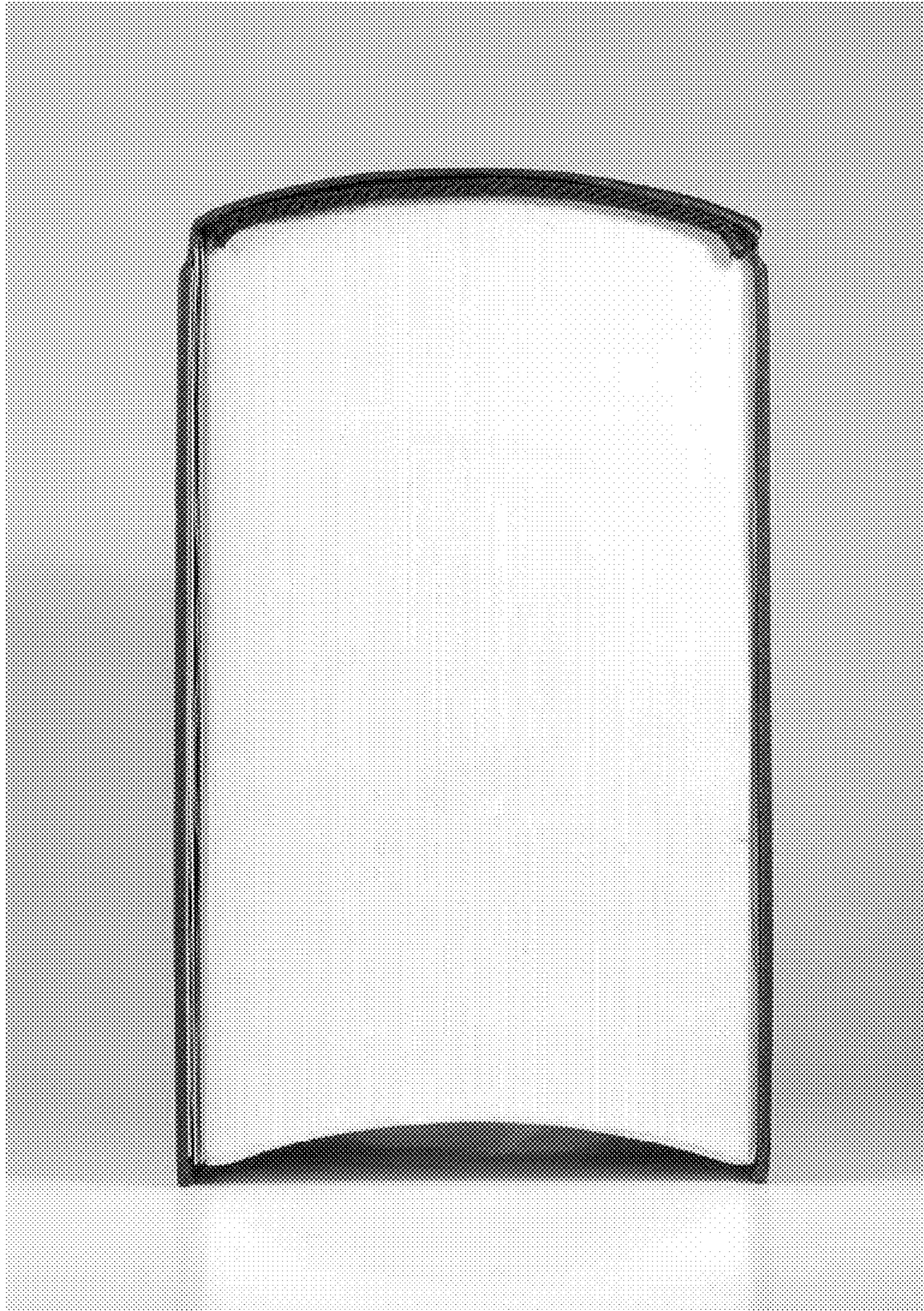

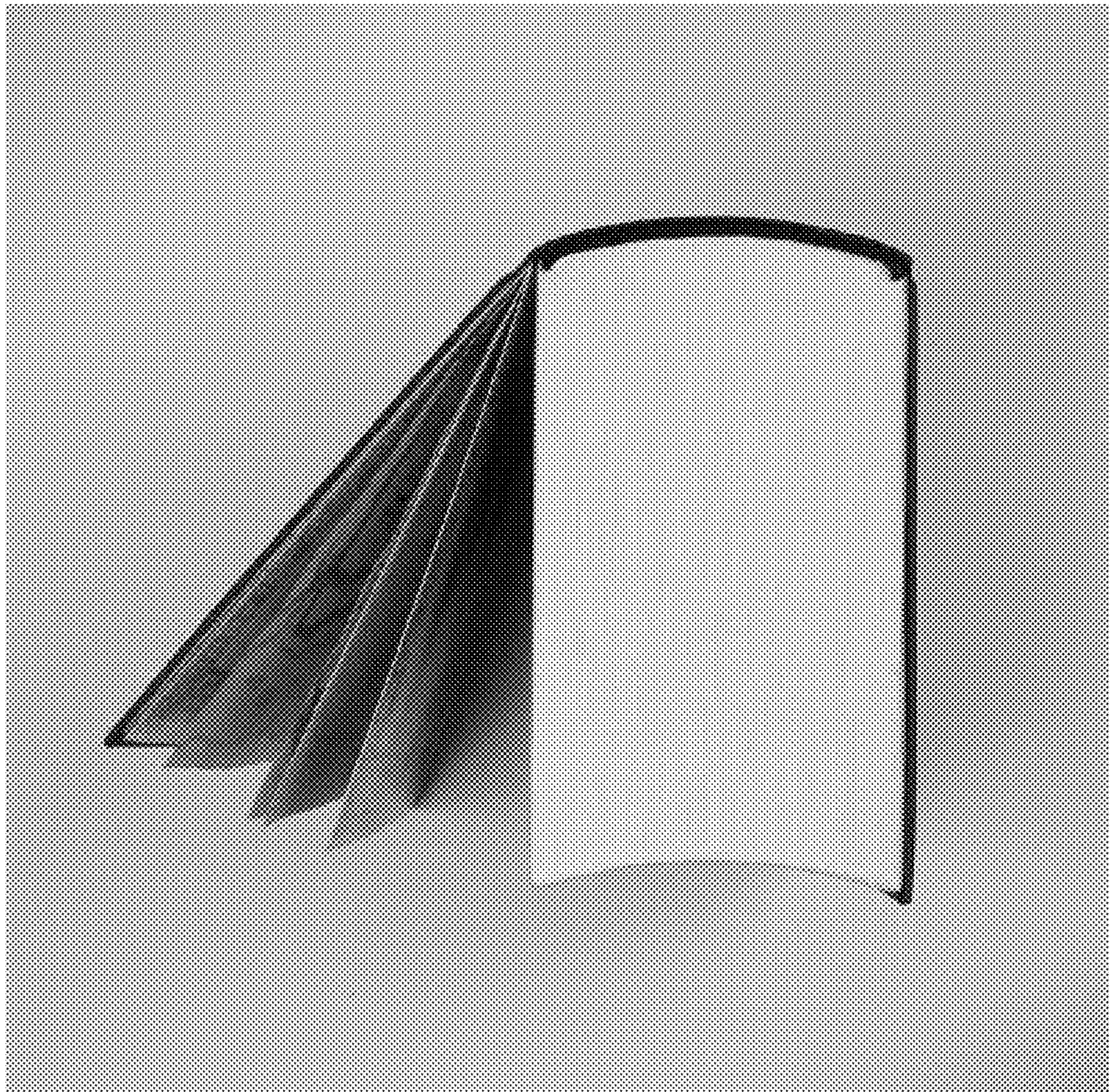
