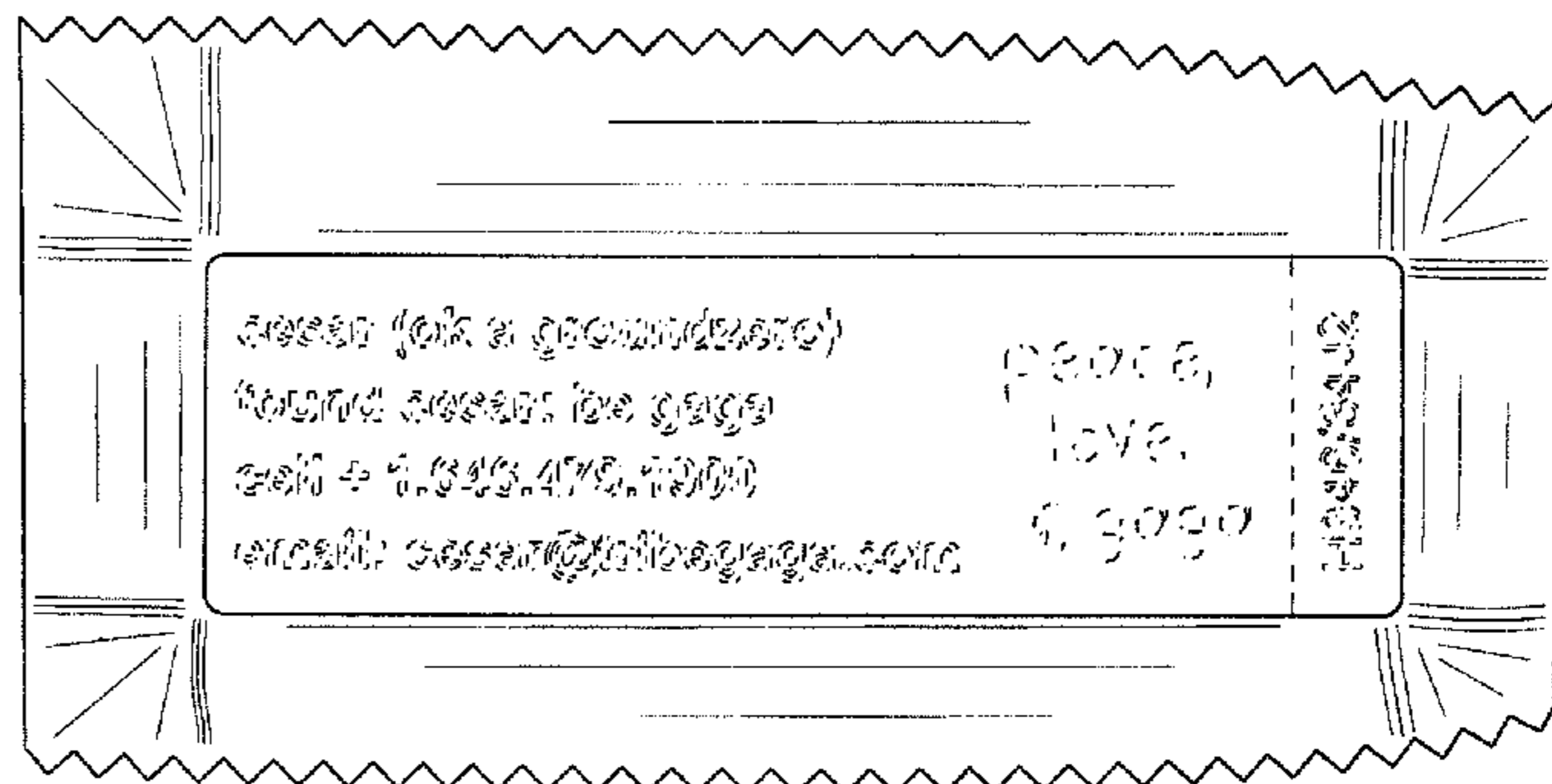
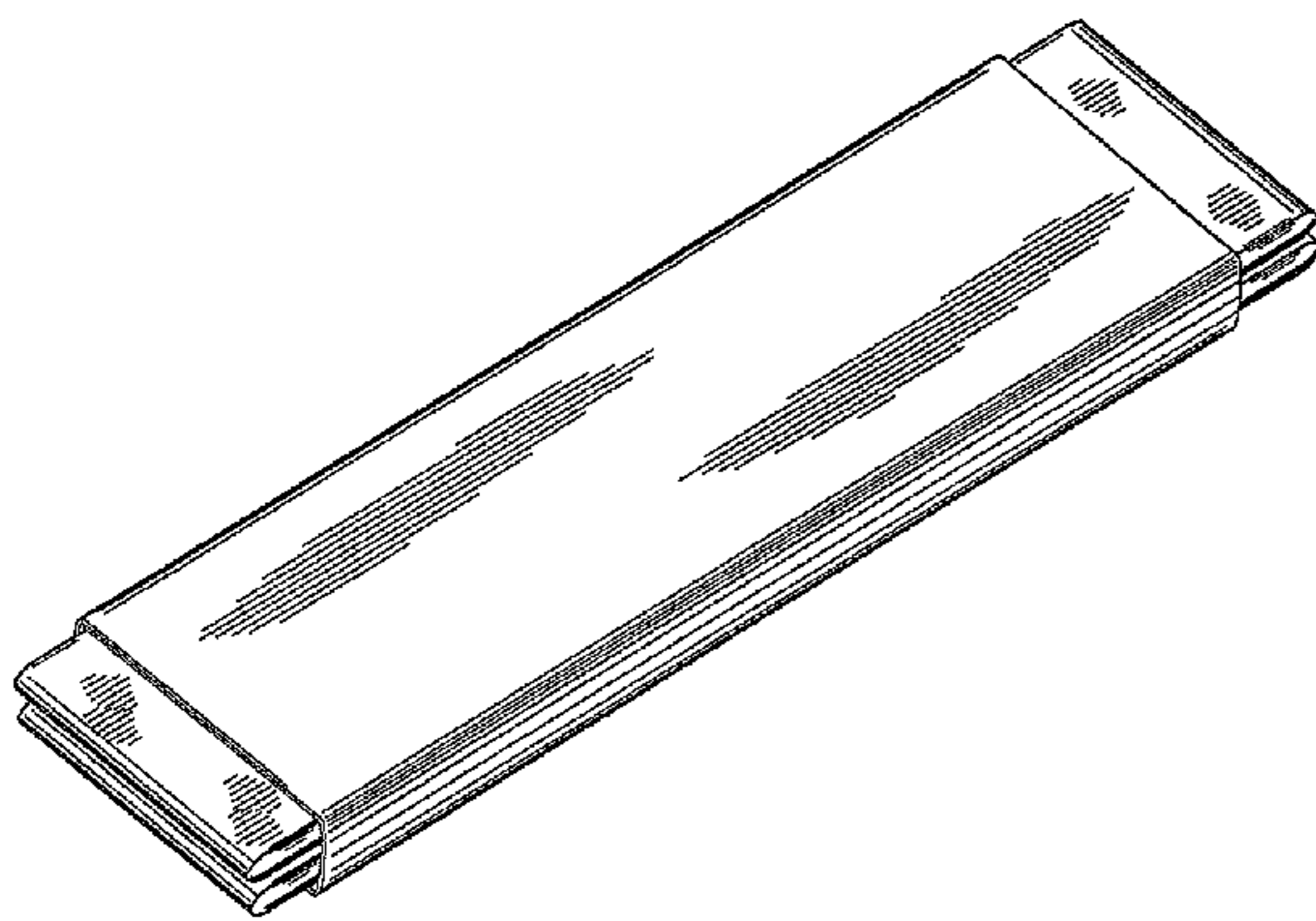
FIG. 7 is an elevational view of the rear of the device of FIG. 2.

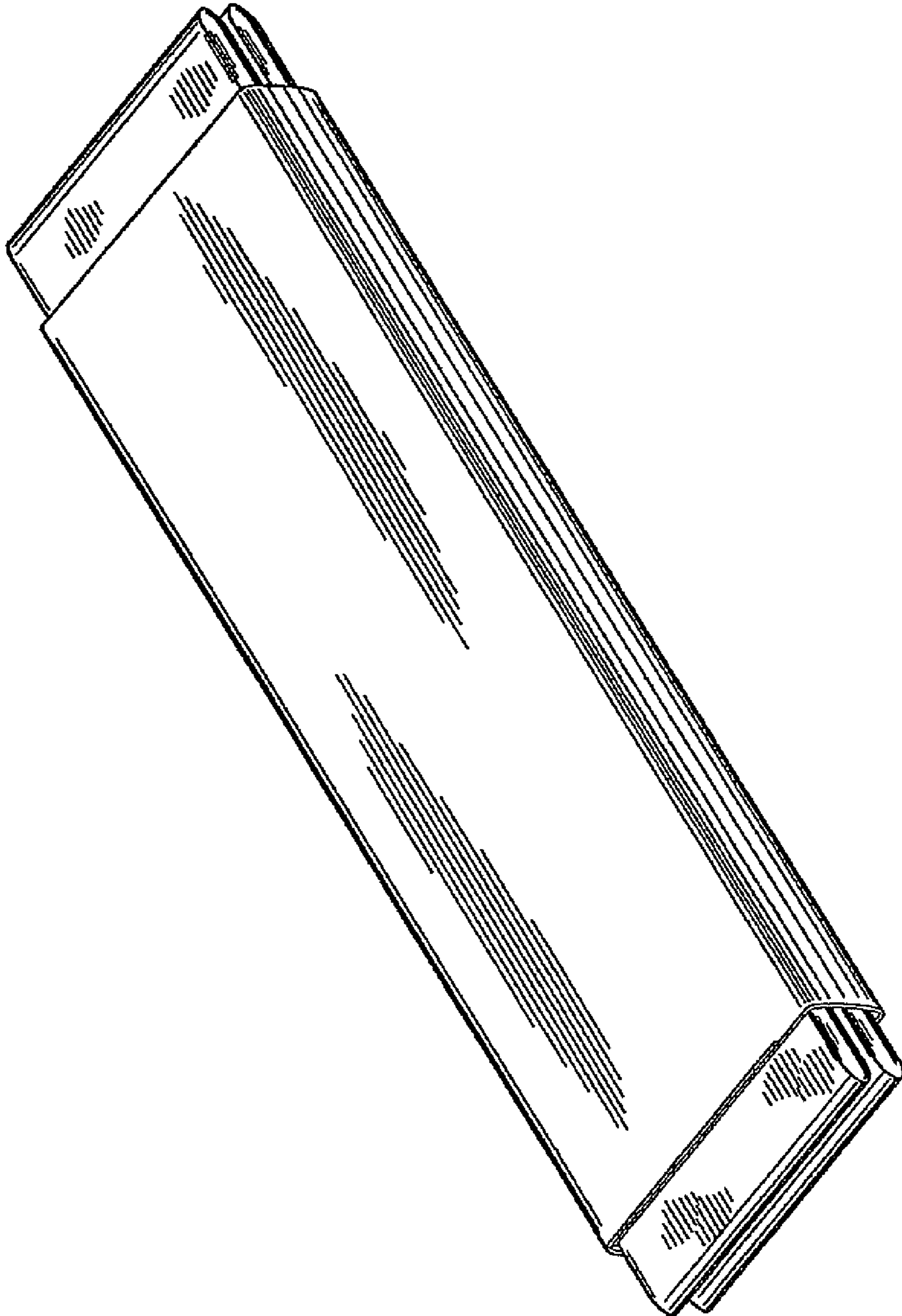

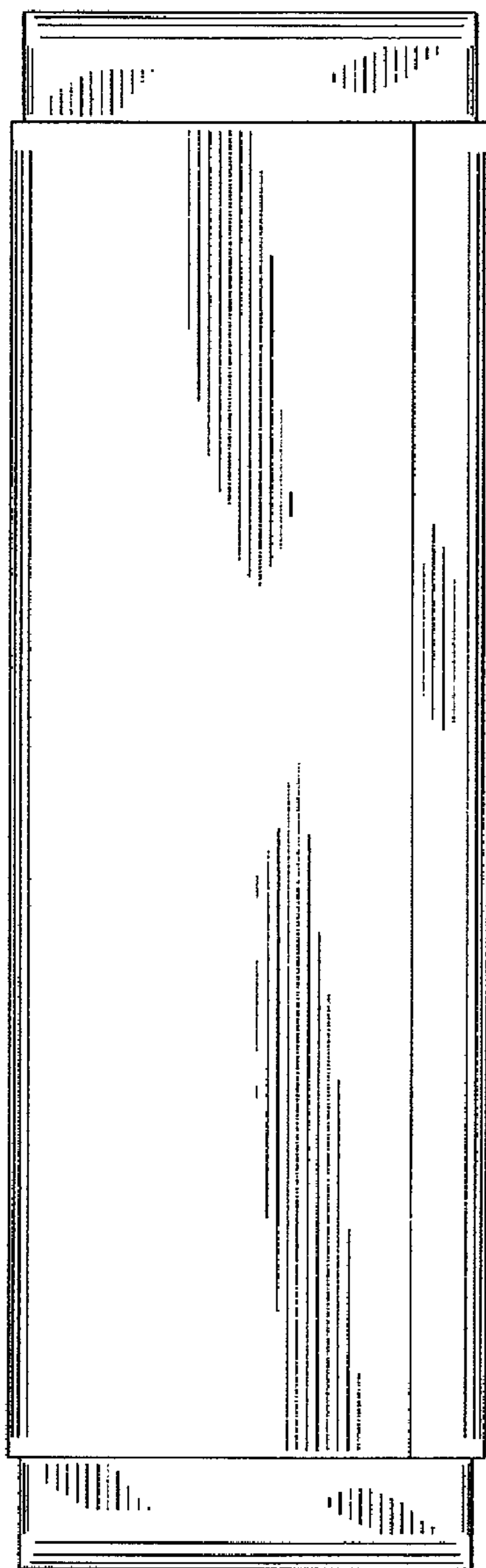

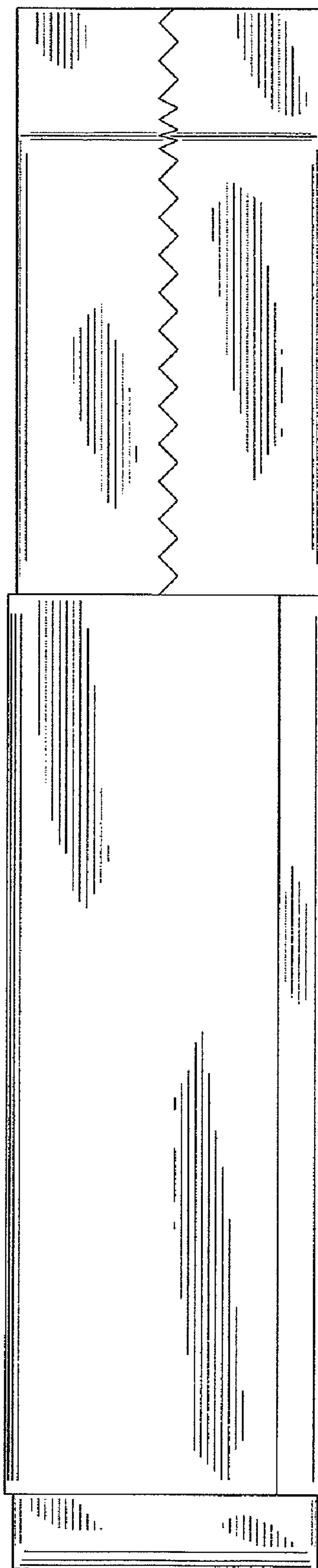

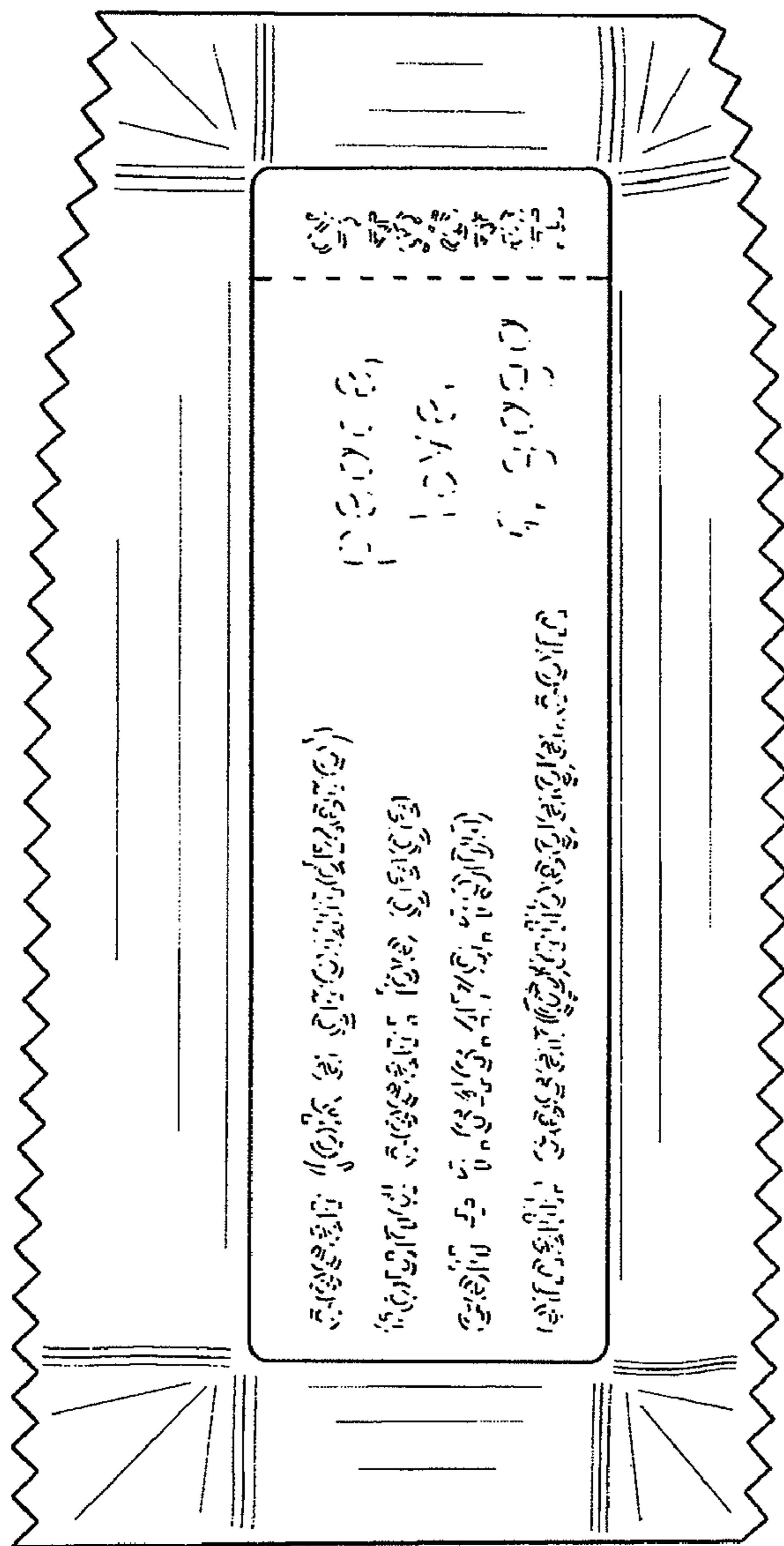

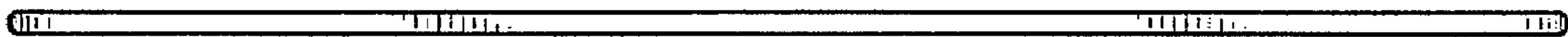
