FIG. 4 shows a back side view of same;

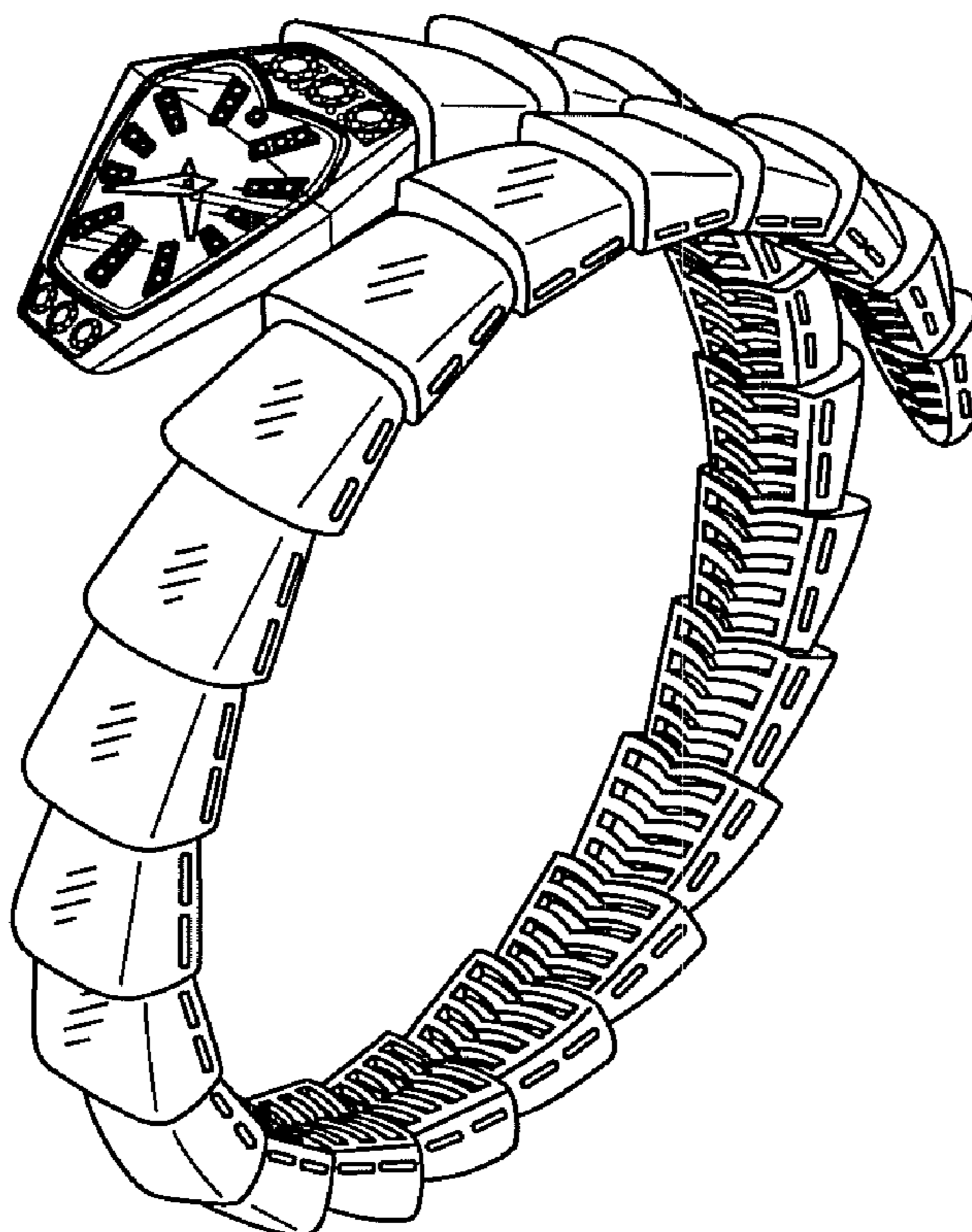
FIG. 5 shows a right side view of same;

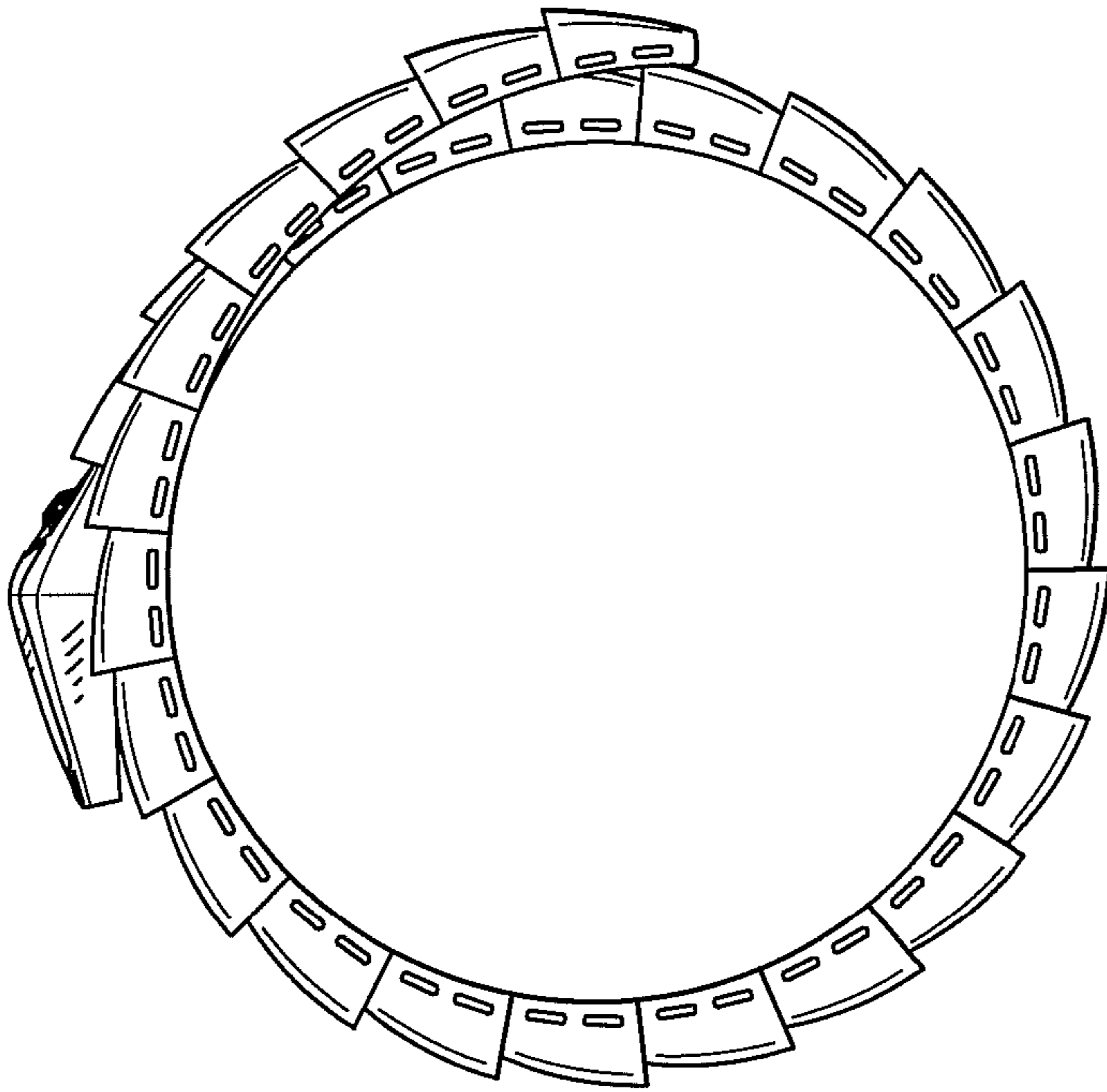

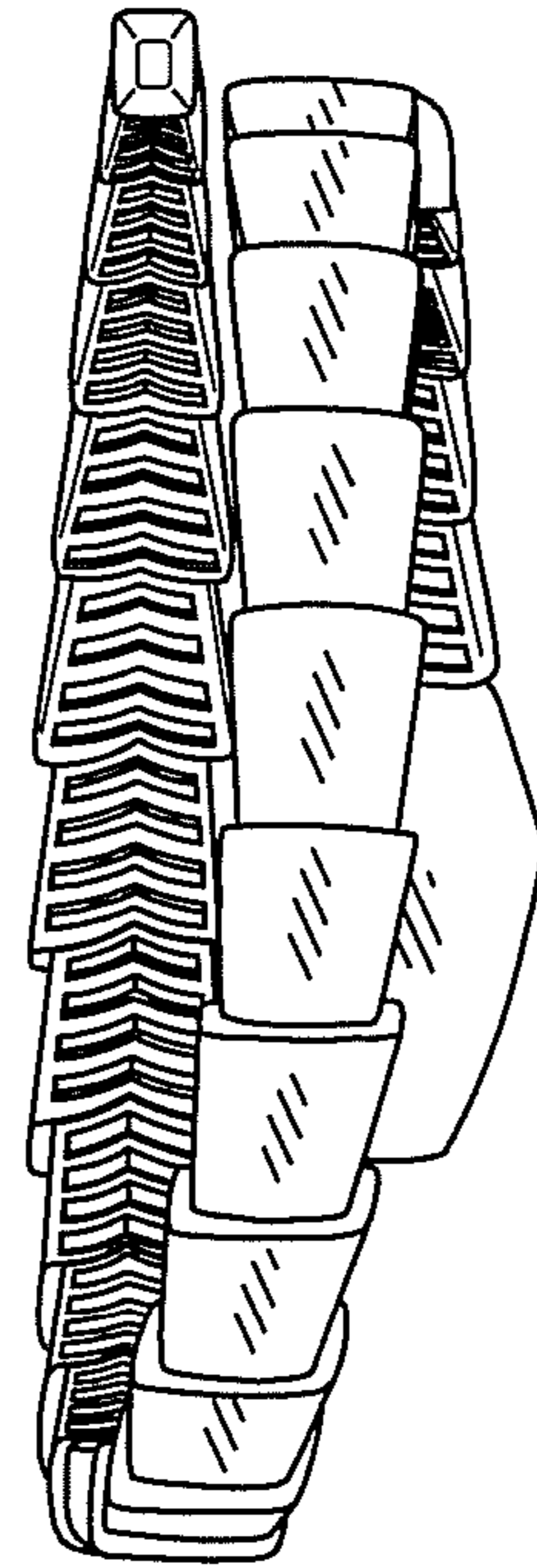

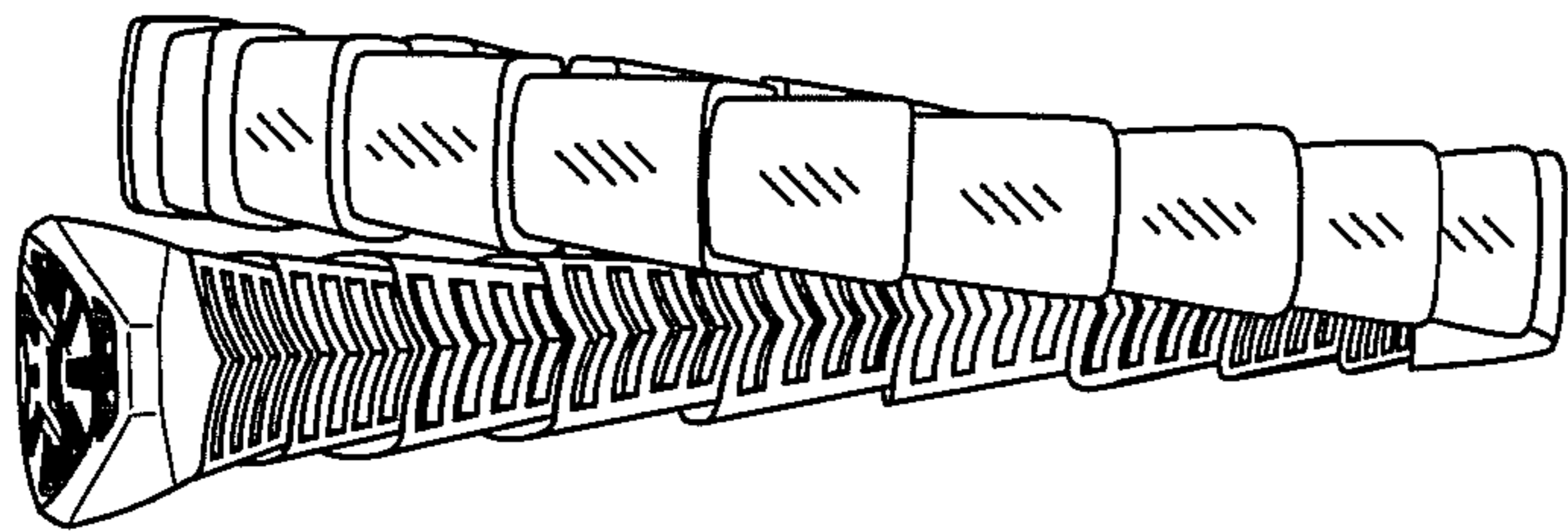

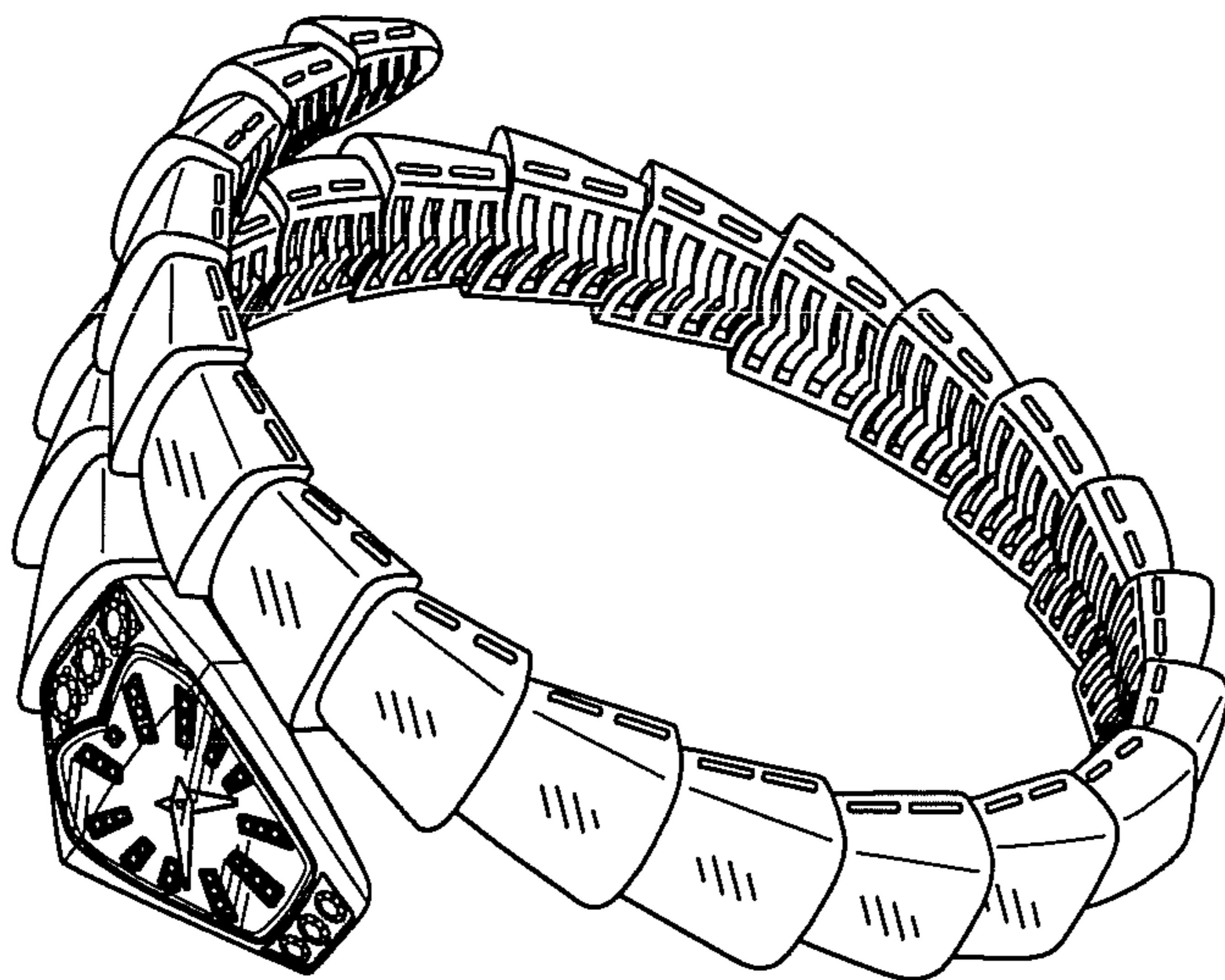

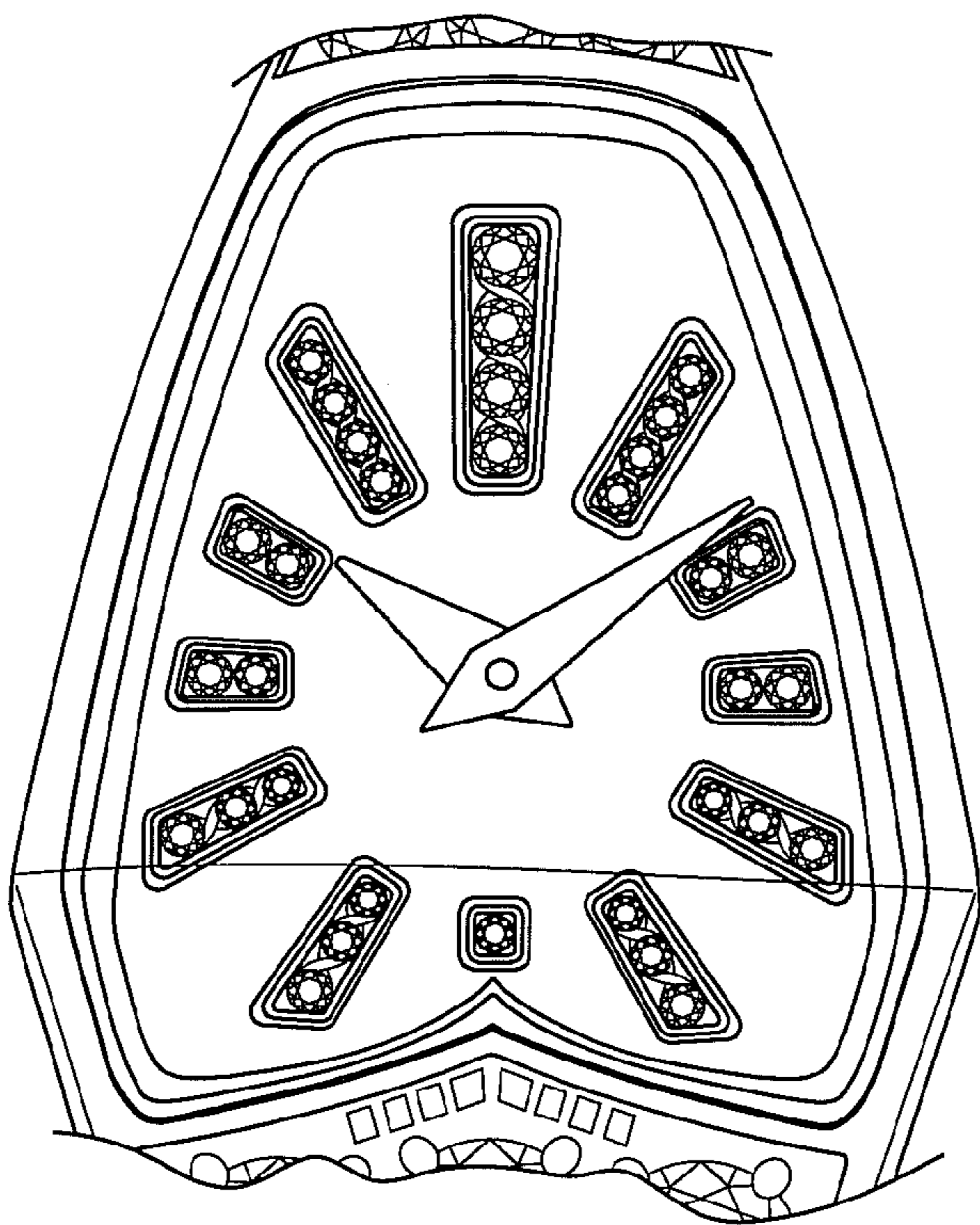

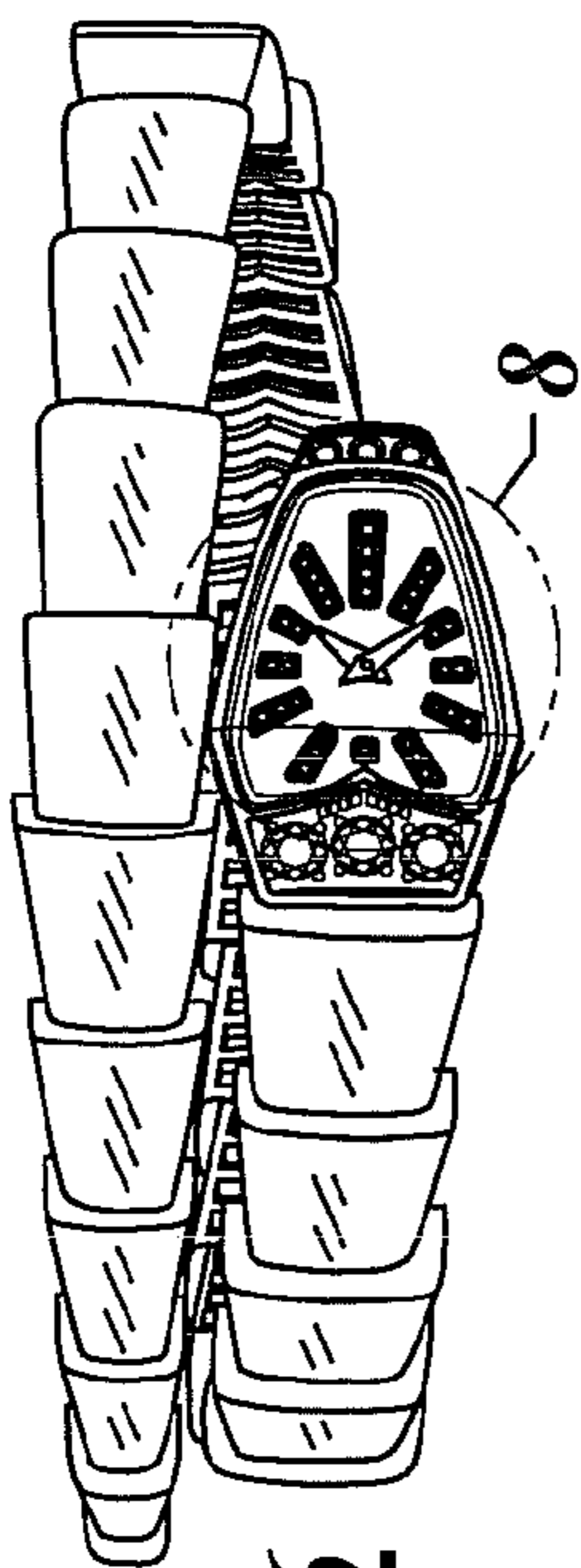

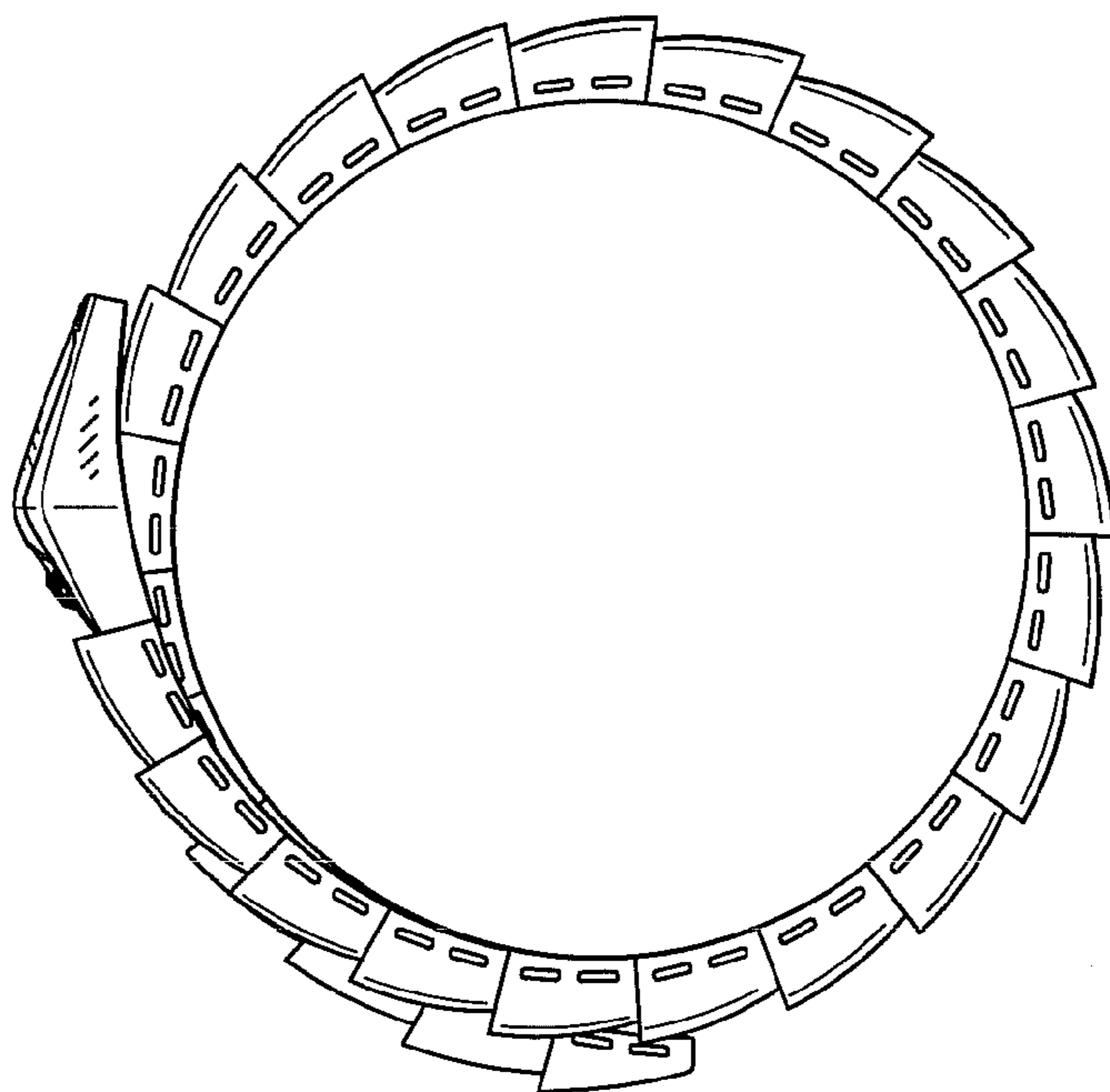

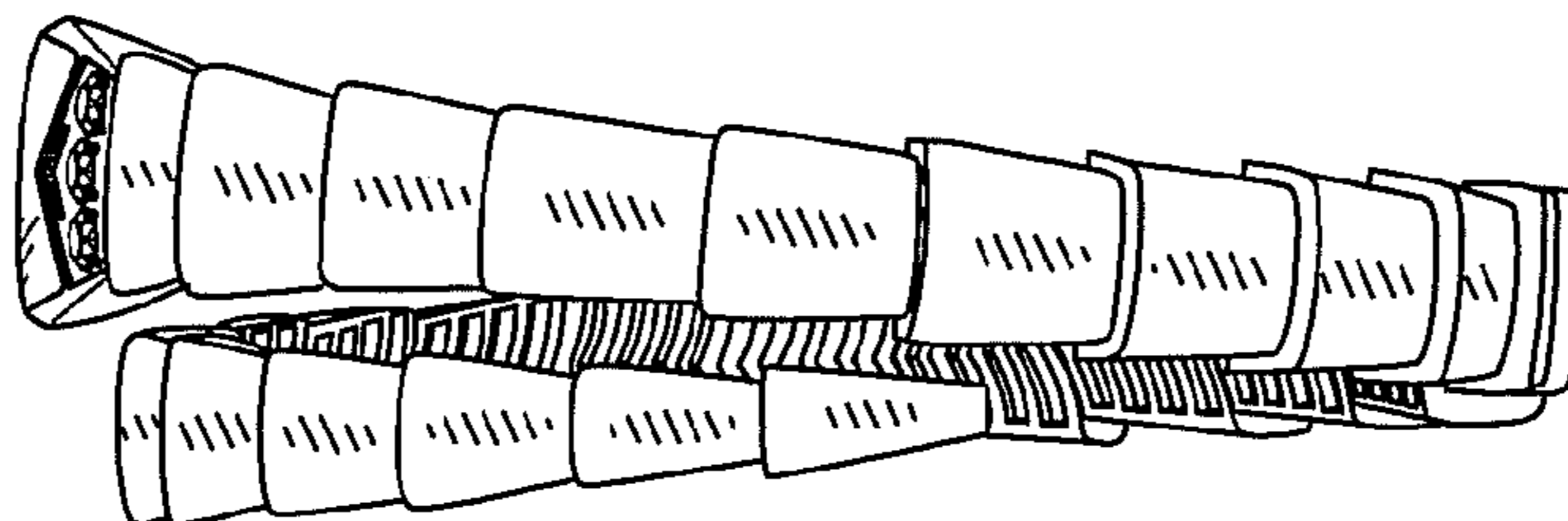
