The ornamental design for a wheelchair for bath and hygiene purposes, as shown and described.

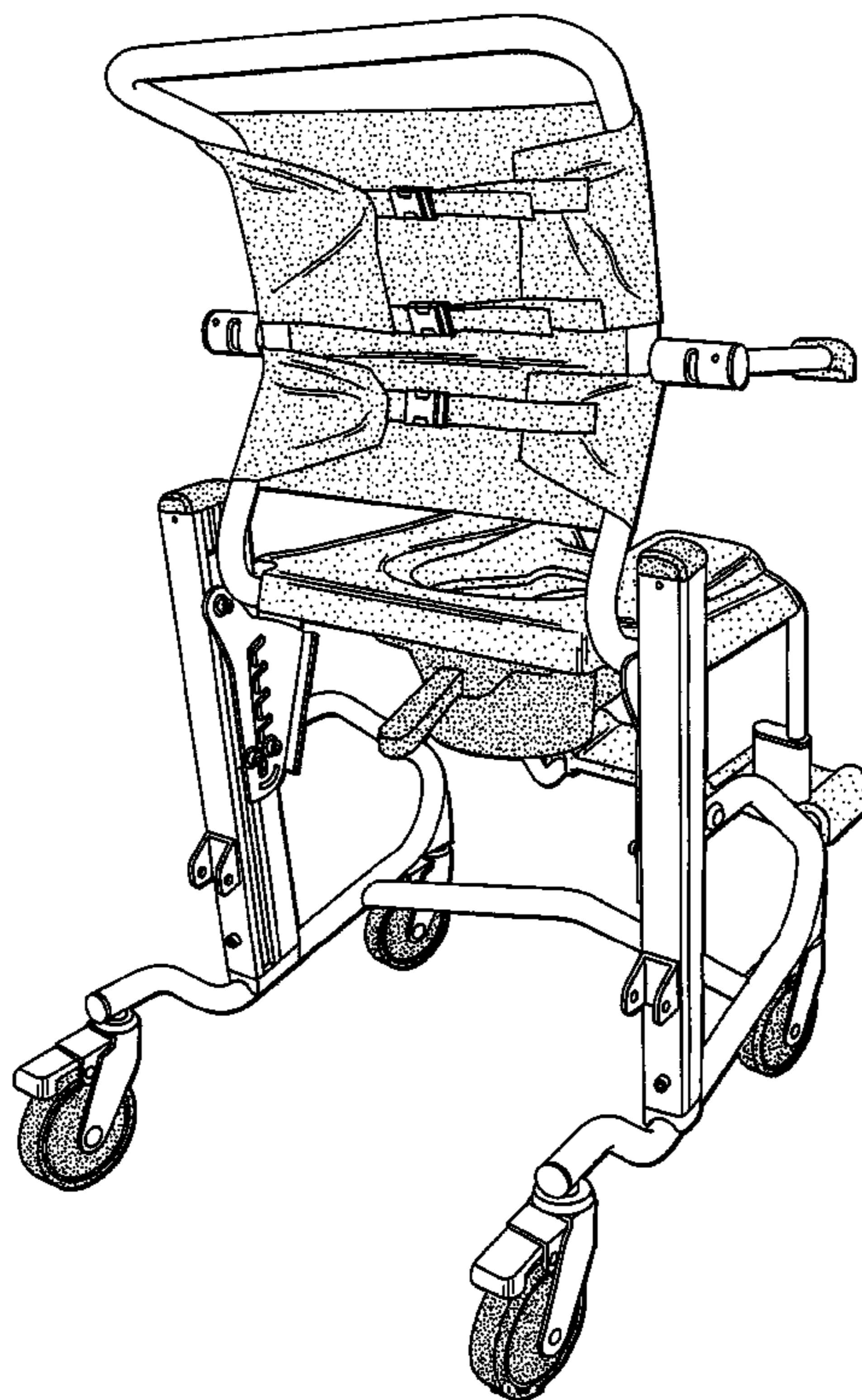
DESCRIPTION

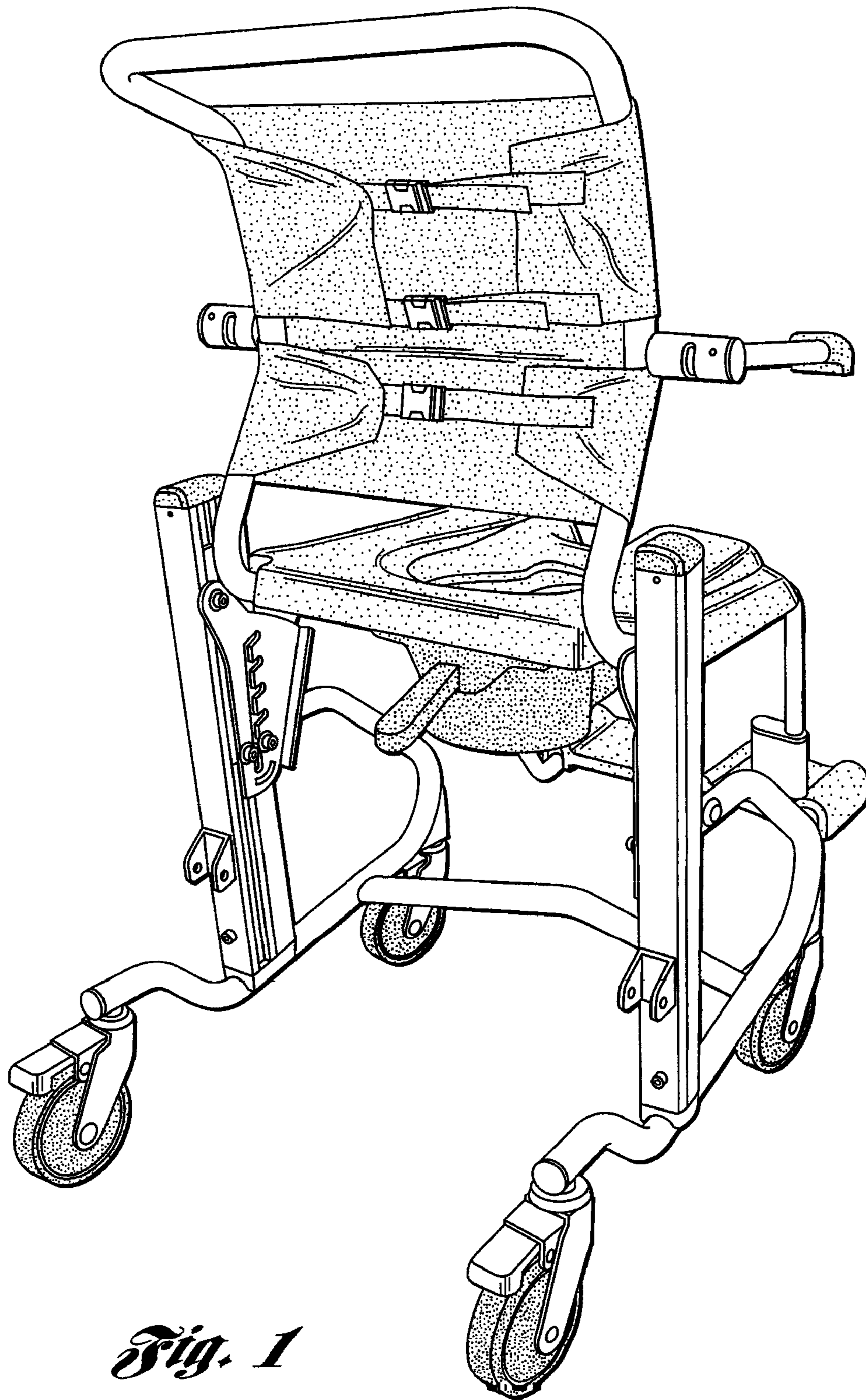
FIG. 1 is a rear perspective view of a wheelchair for bath and hygiene purposes;

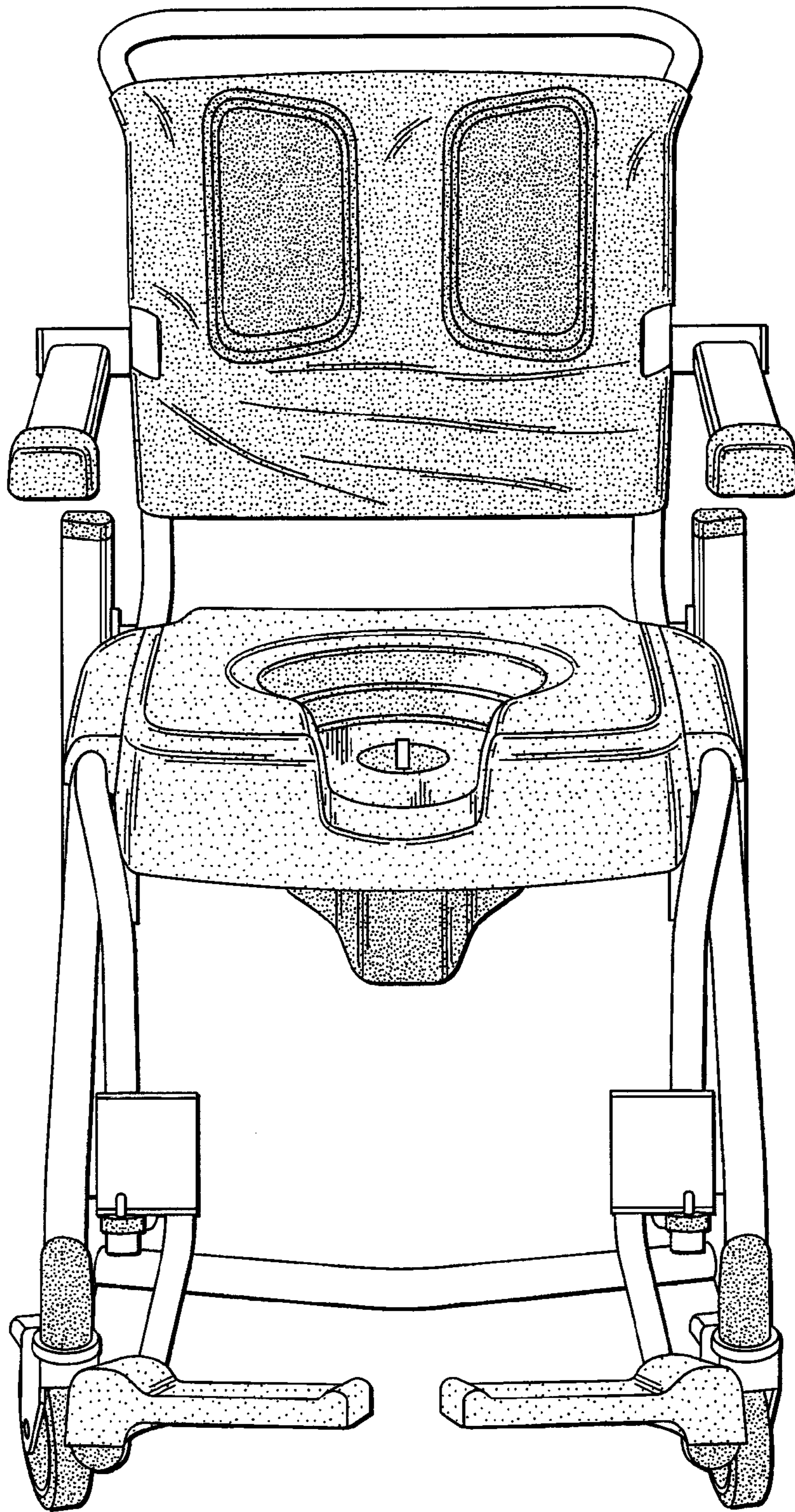

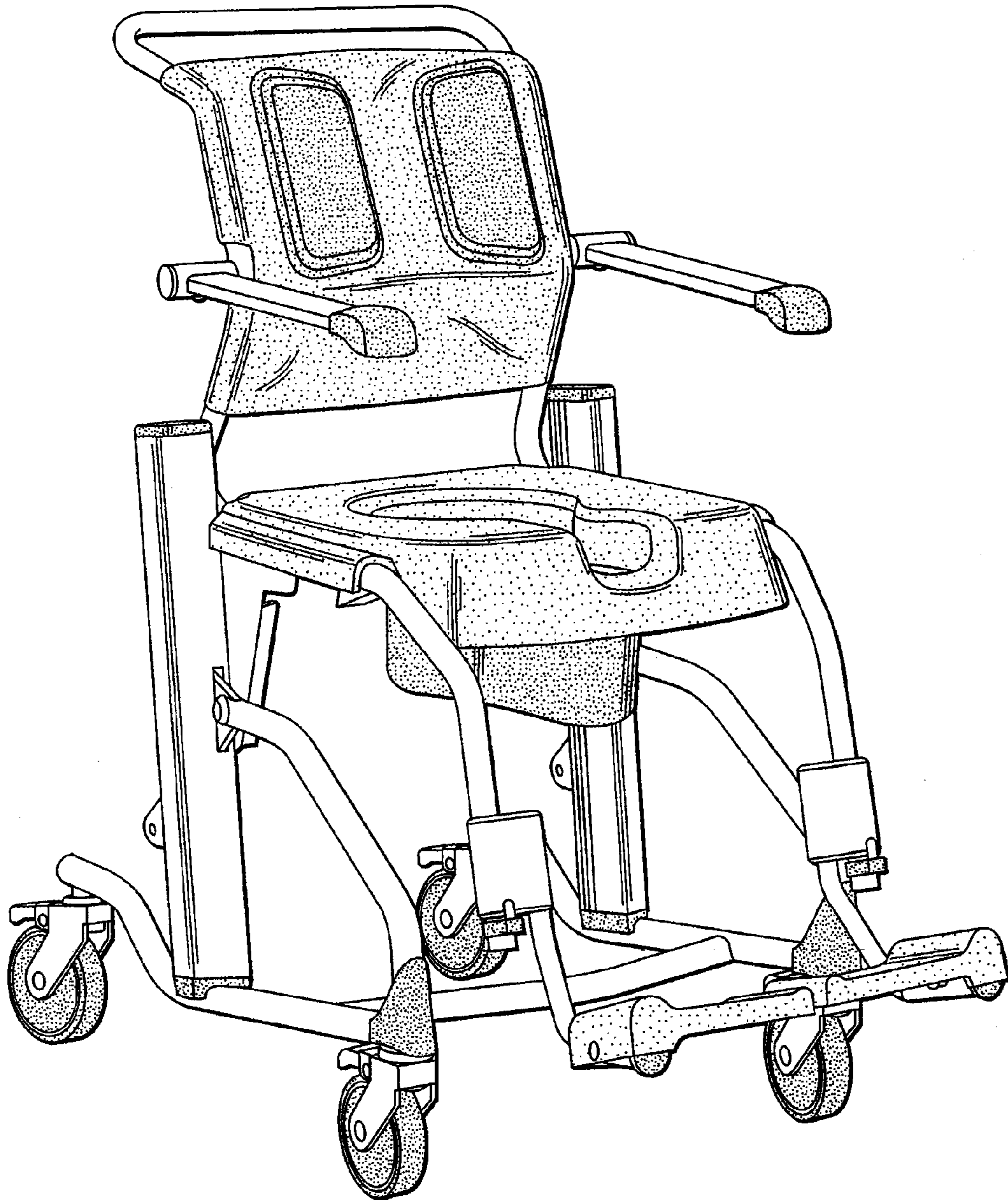
