(57) **CLAIM**

I claim, the ornamental design for an automobile tire, as shown and described.

DESCRIPTION

This application is related to co-pending application Ser. No. 29/336,807, entitled “Automobile Tire”, filed on the same date as this application, which is herein incorporated by reference.

FIG. 1 is a perspective view of an automobile tire, showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is an enlarged cross-sectional elevational view taken along line -8—8- of FIG. 2; and,

FIG. 9 is a partially enlarged view of the front elevational view taken between lines -9—9- of FIG. 2.

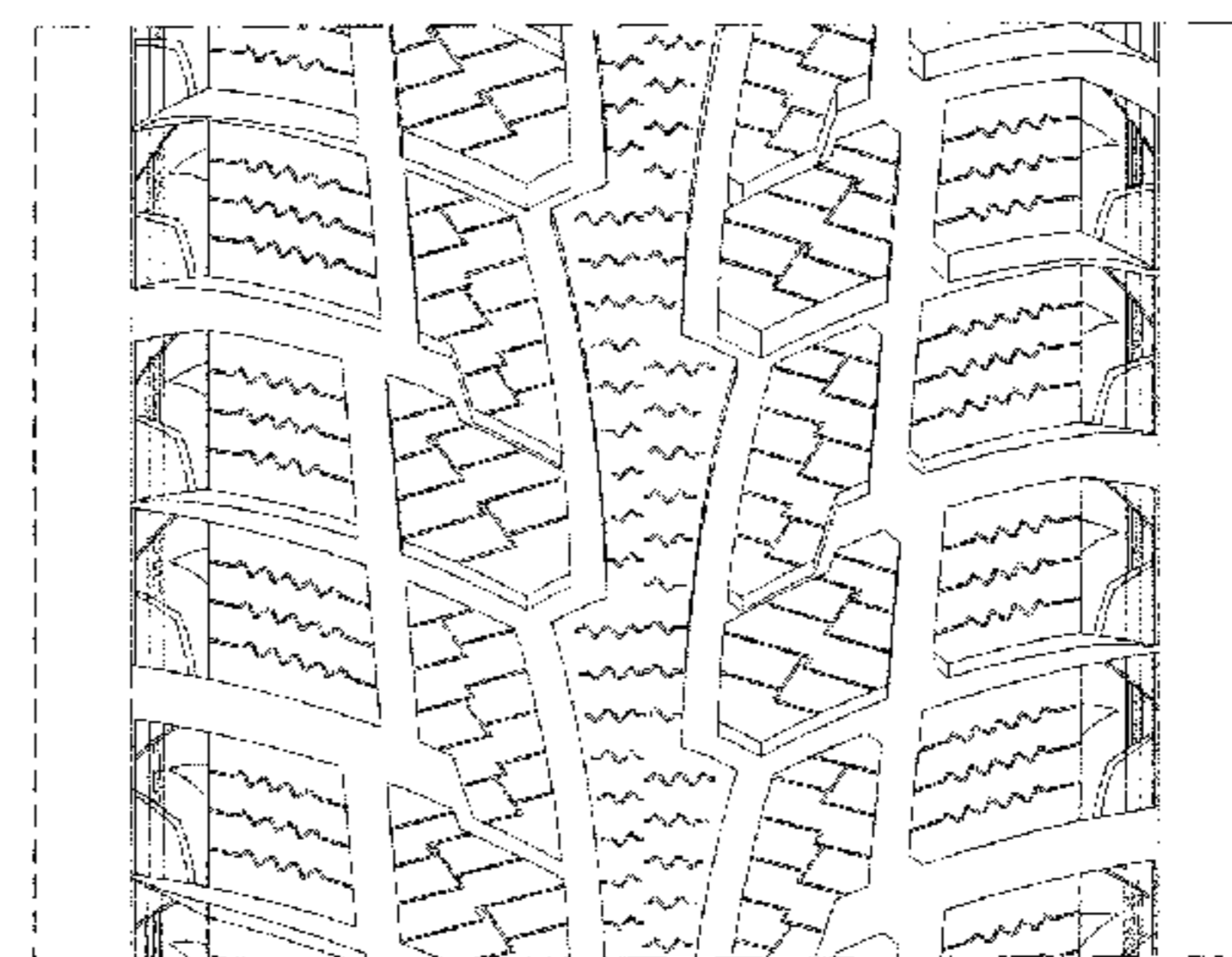
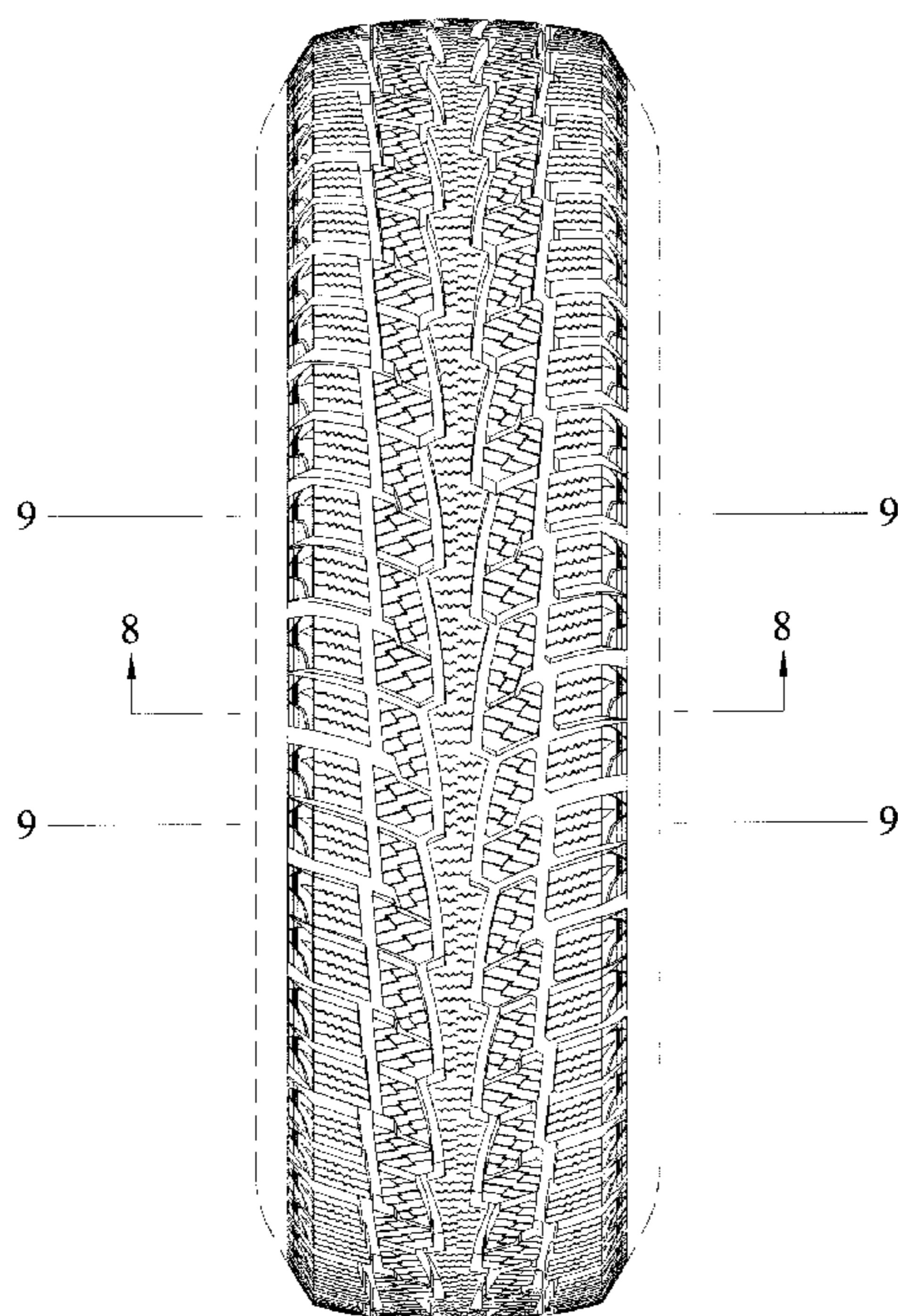

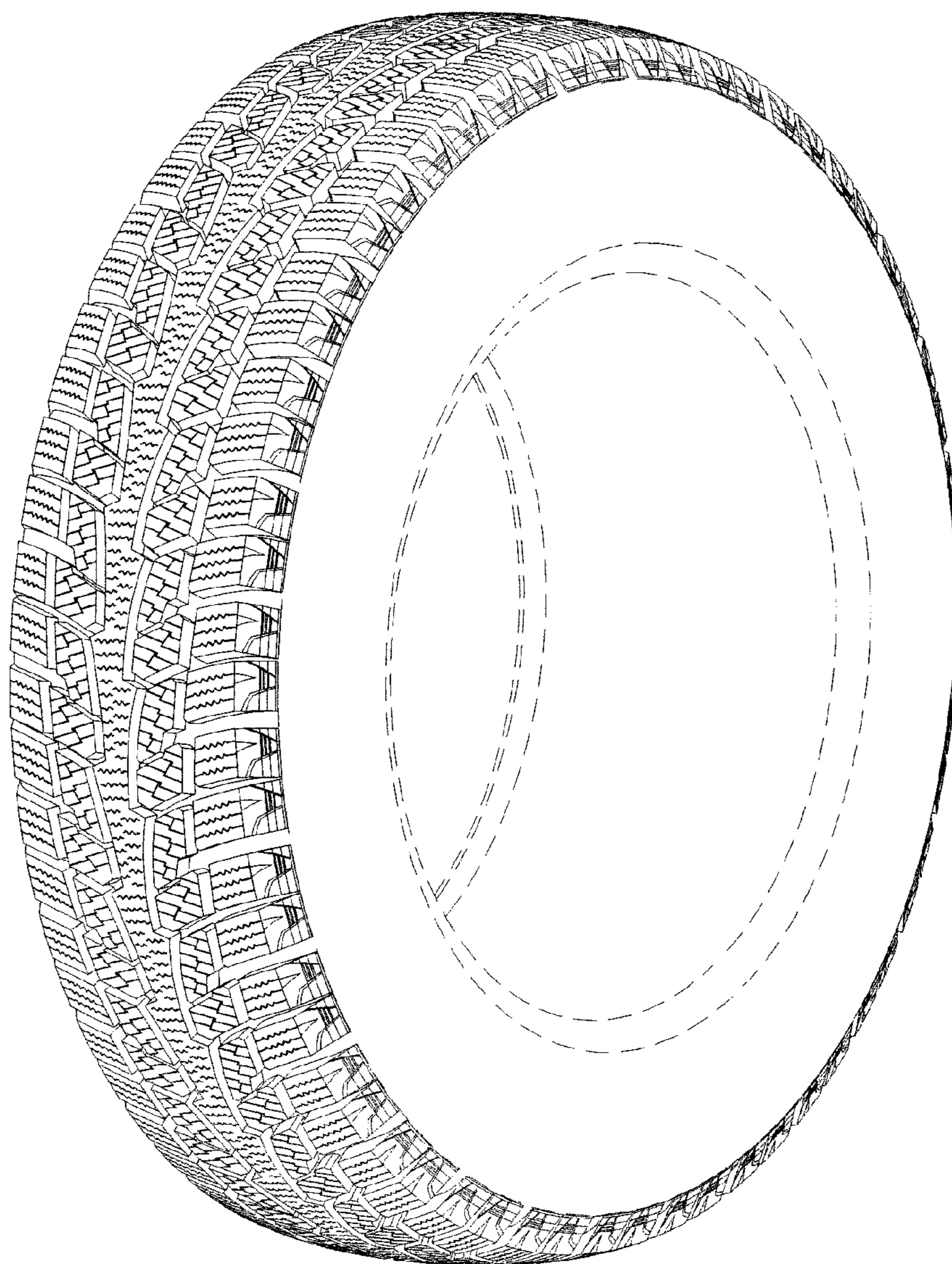

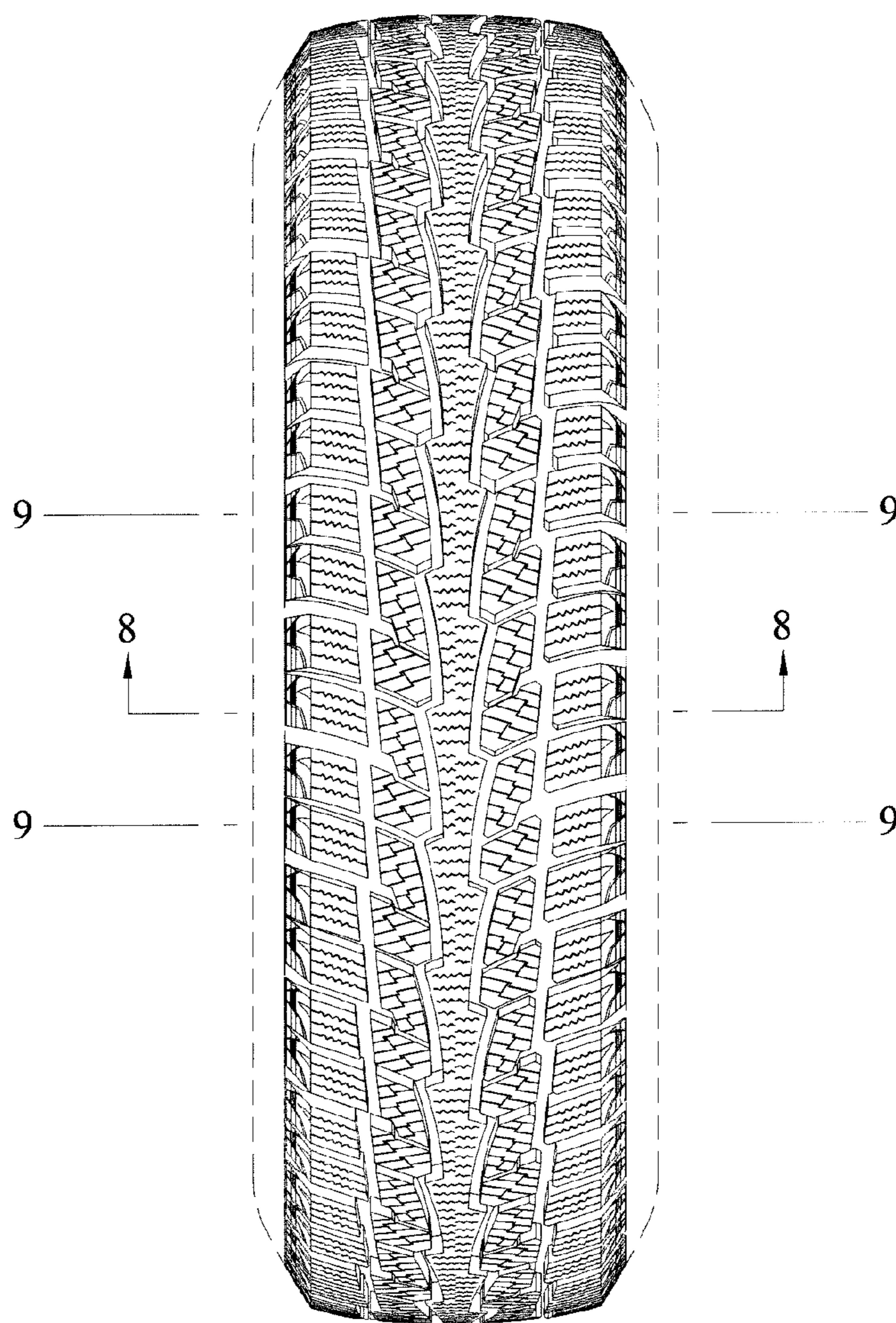

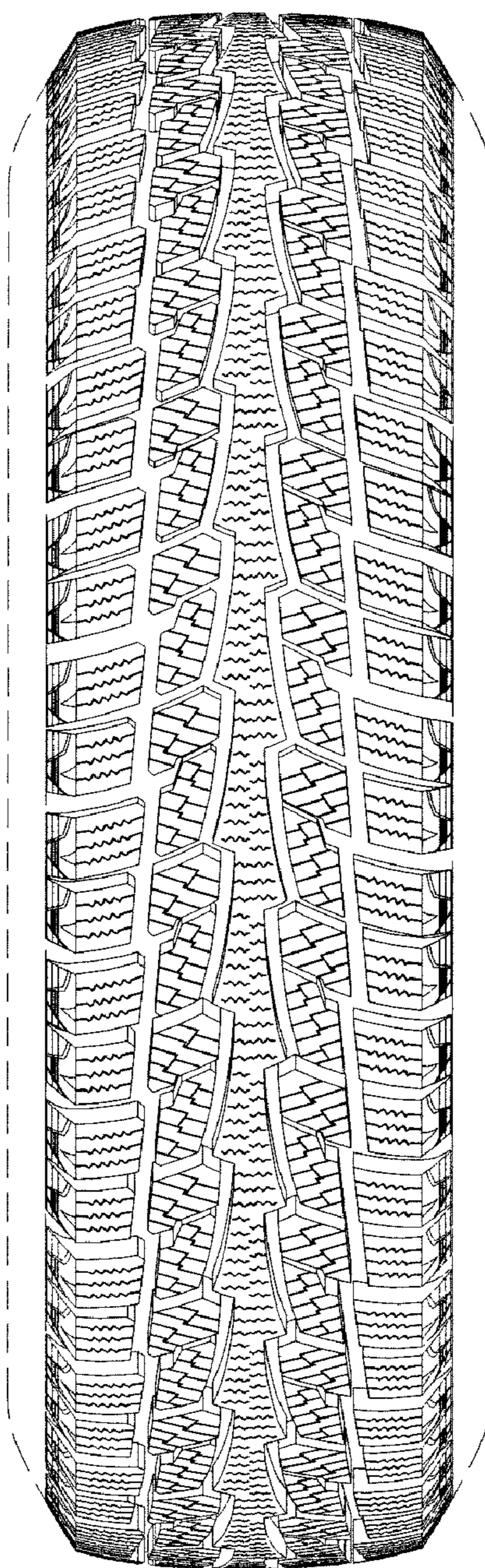

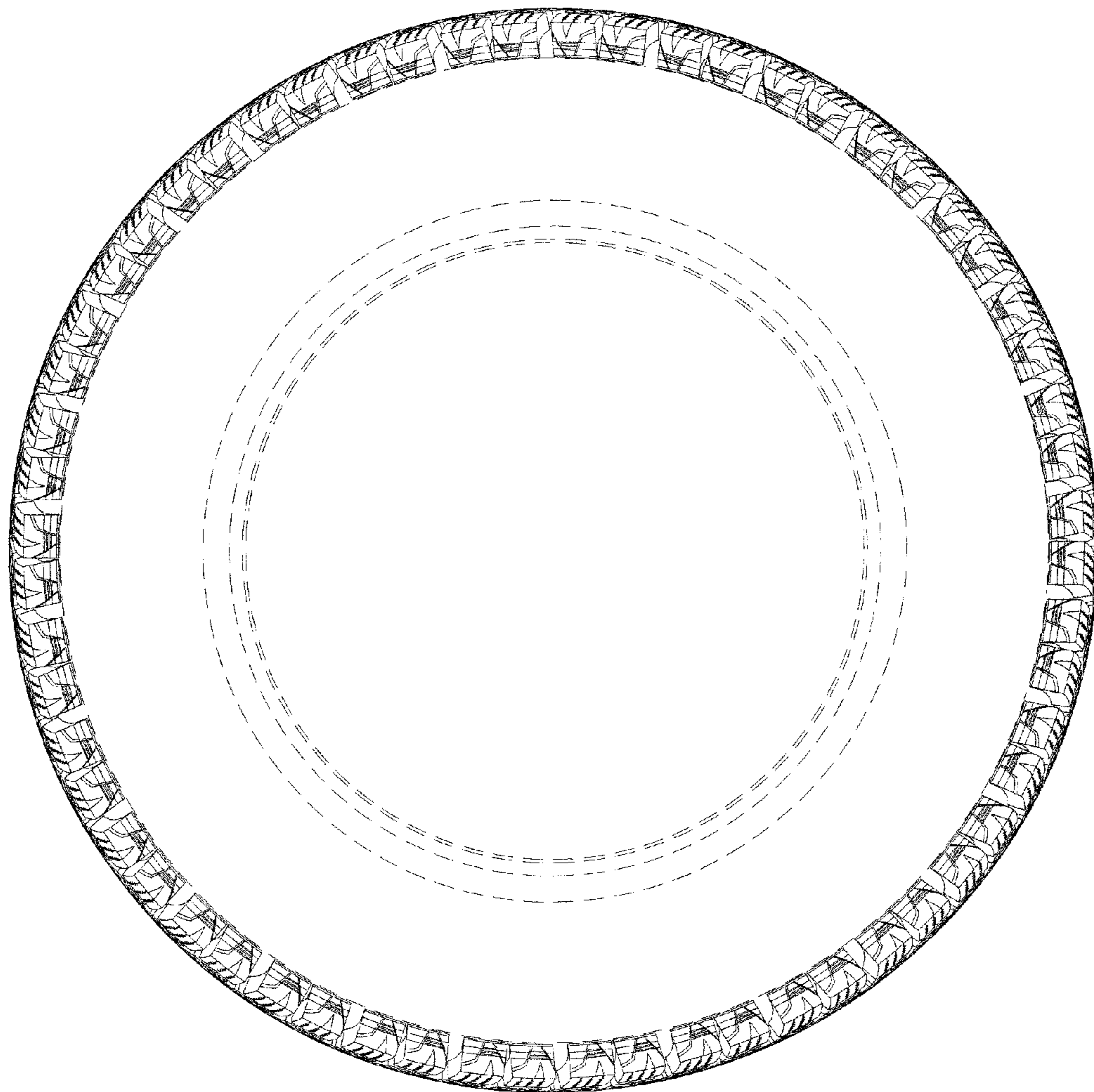

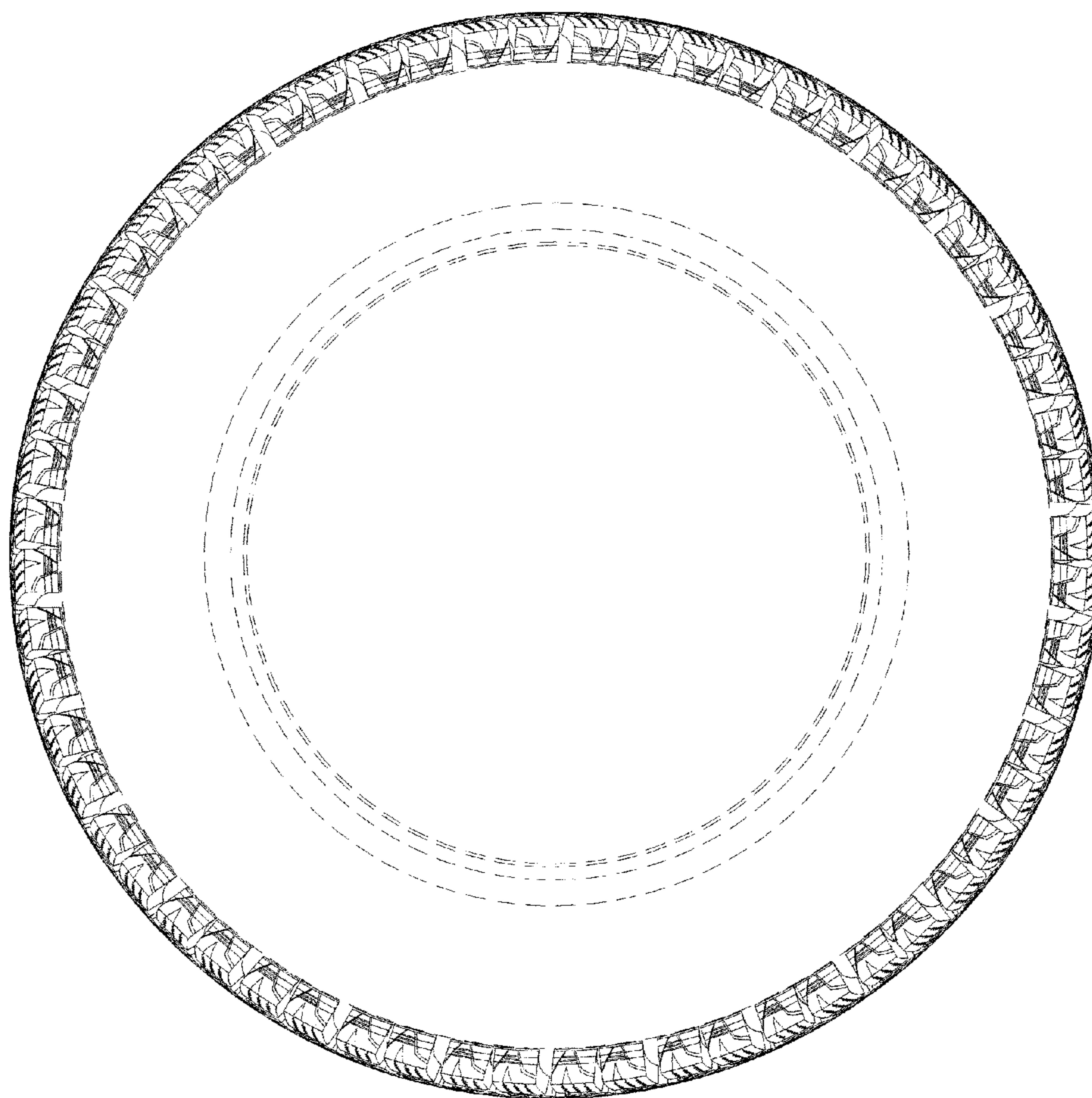

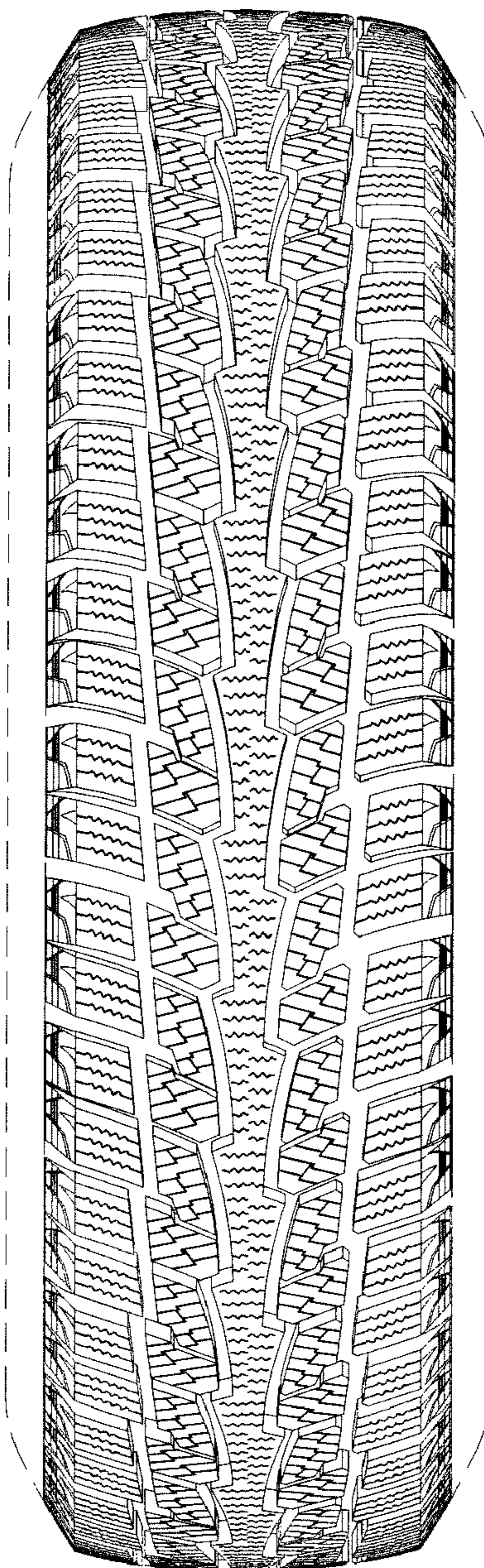

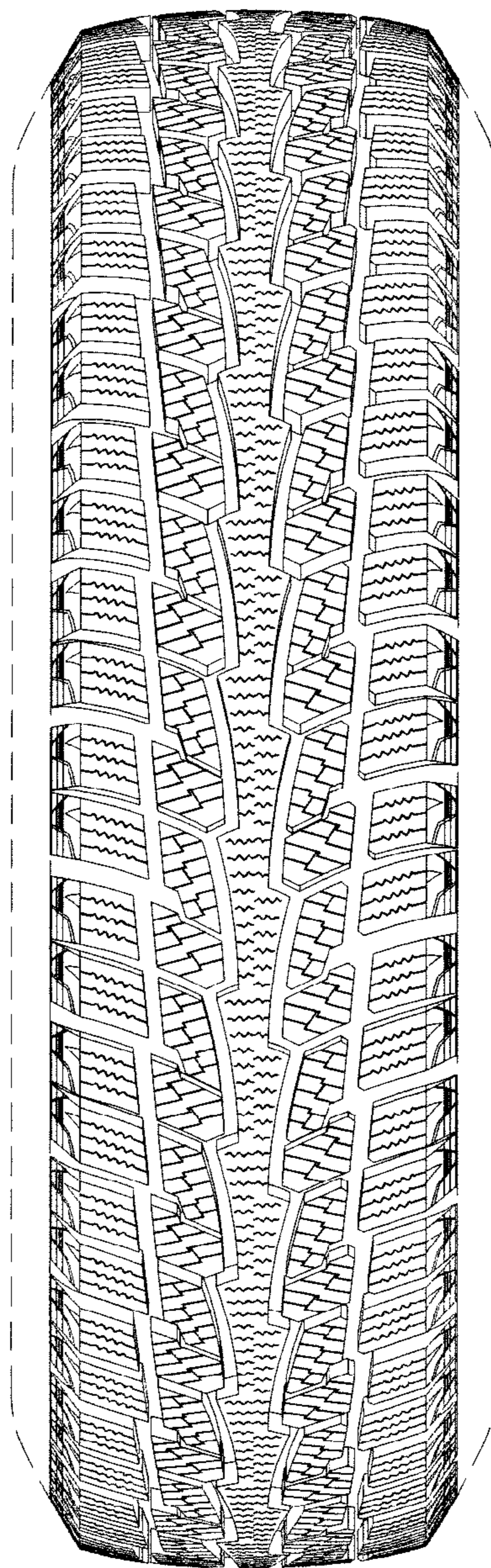

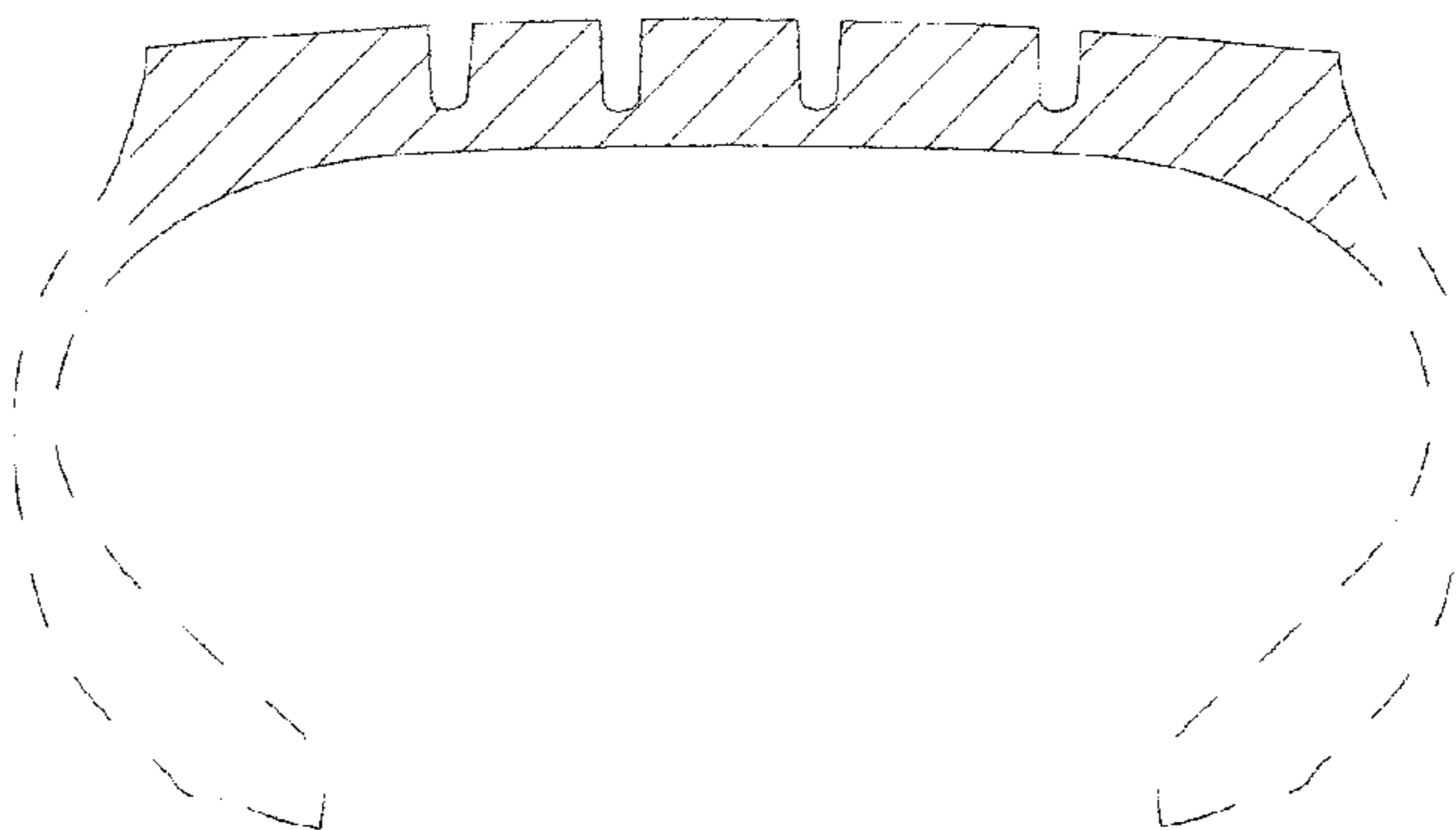
