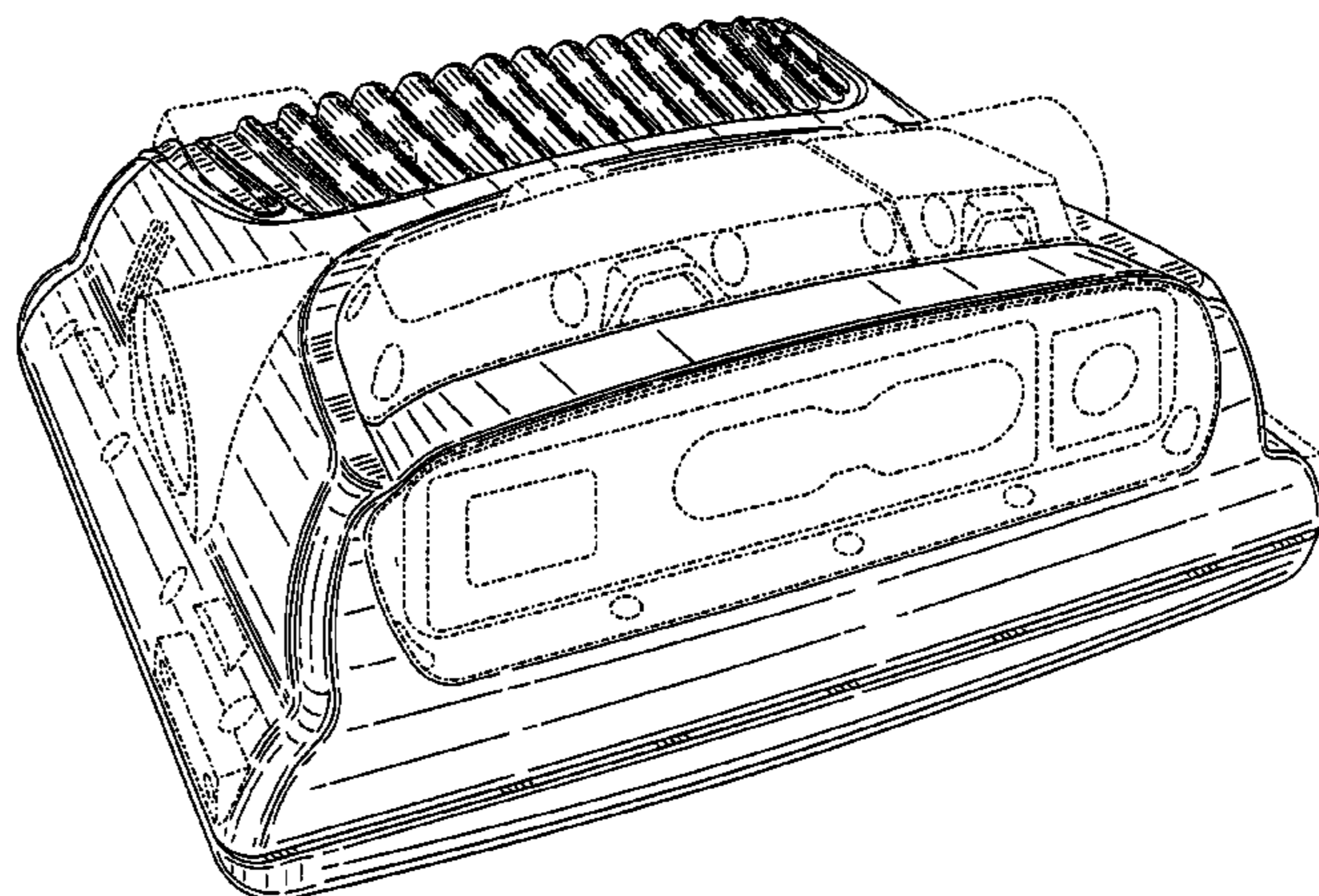
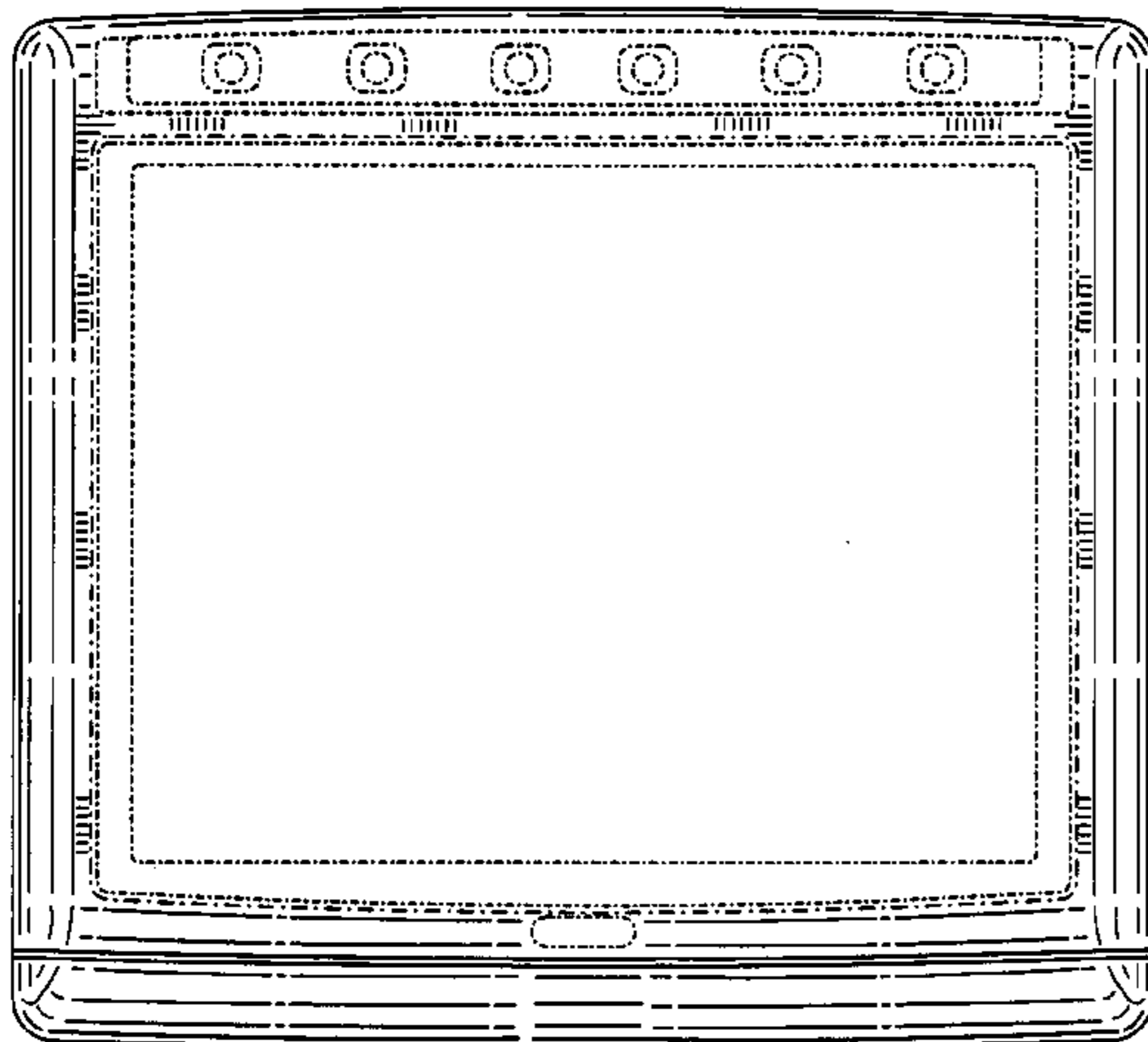
The ornamental design for a housing of a computing device,

DESCRIPTION

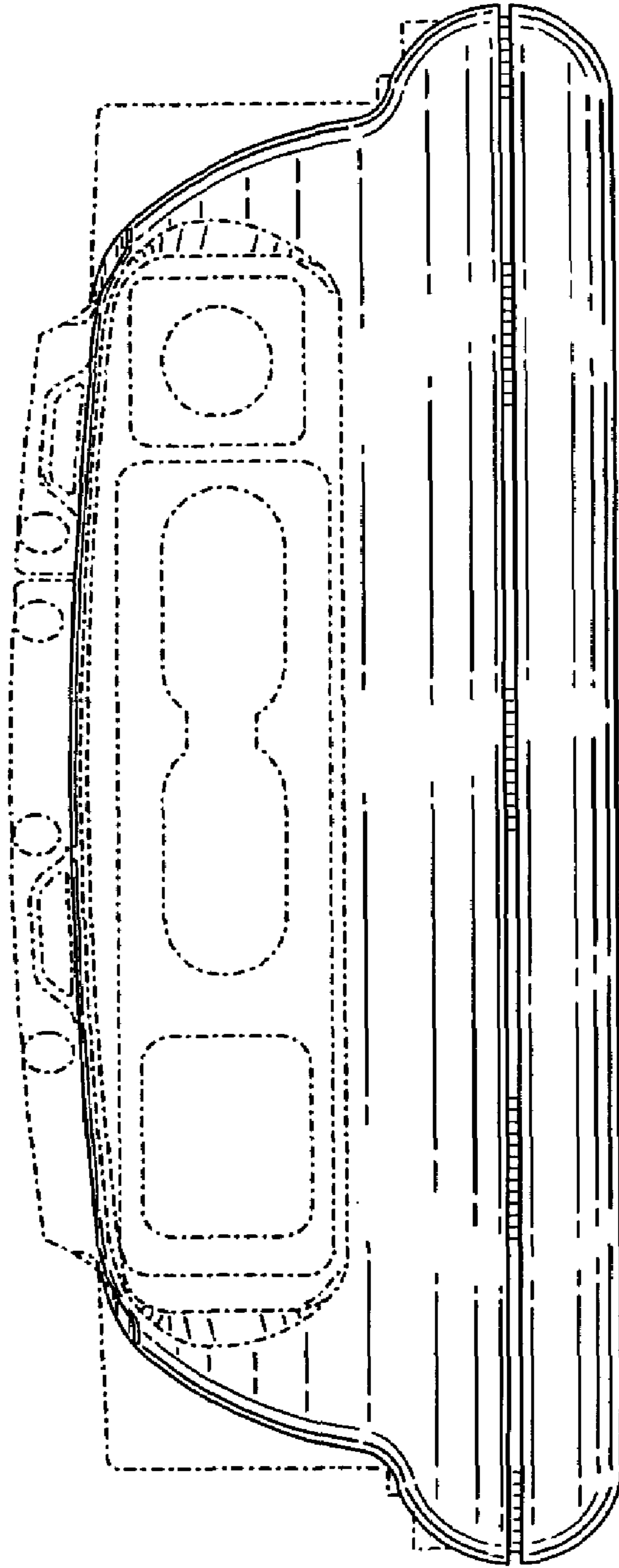

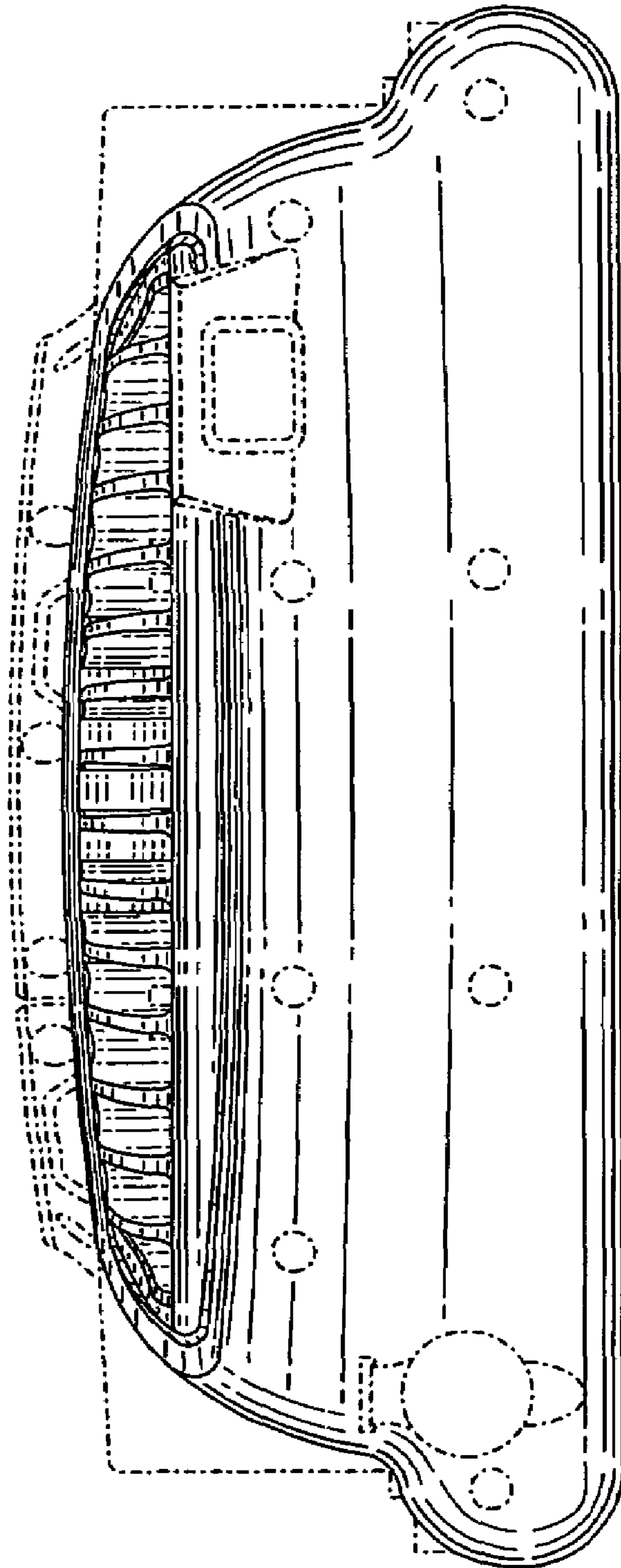

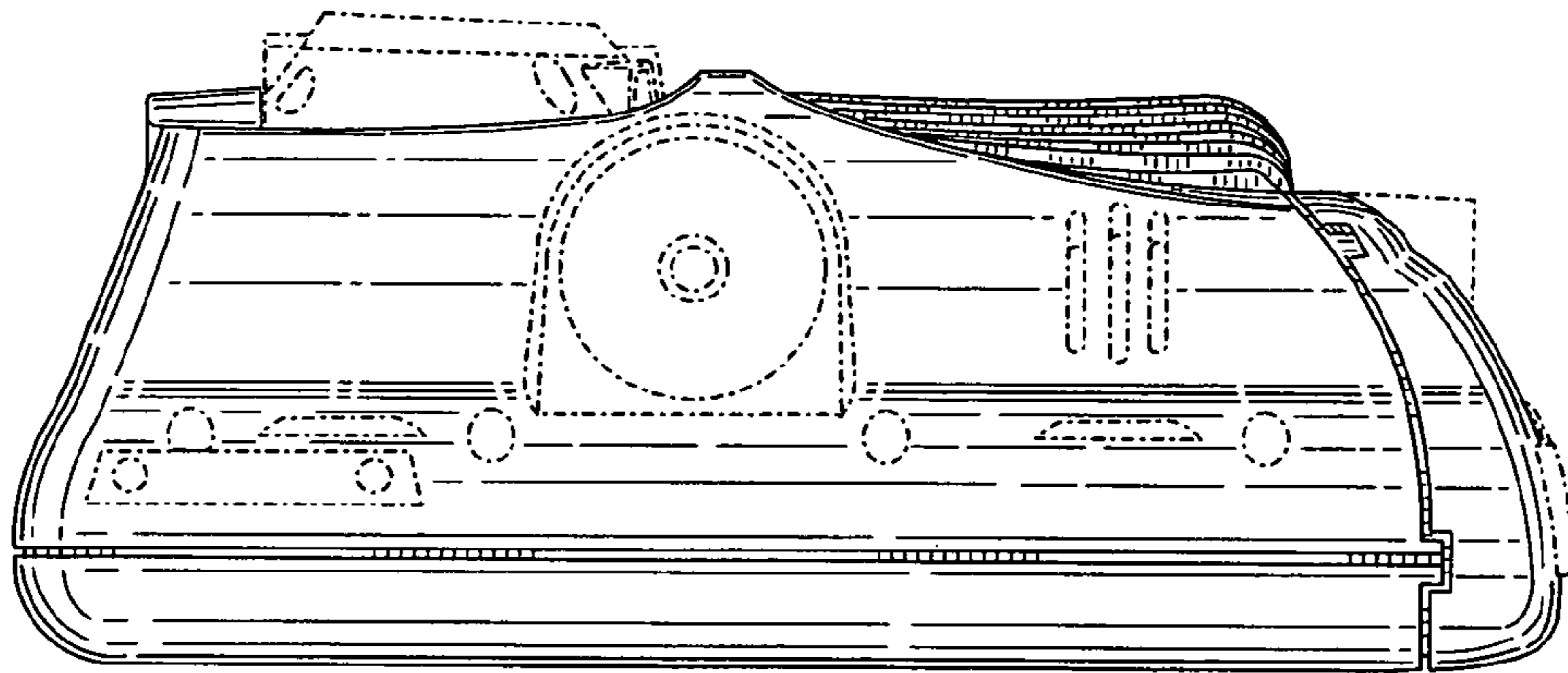

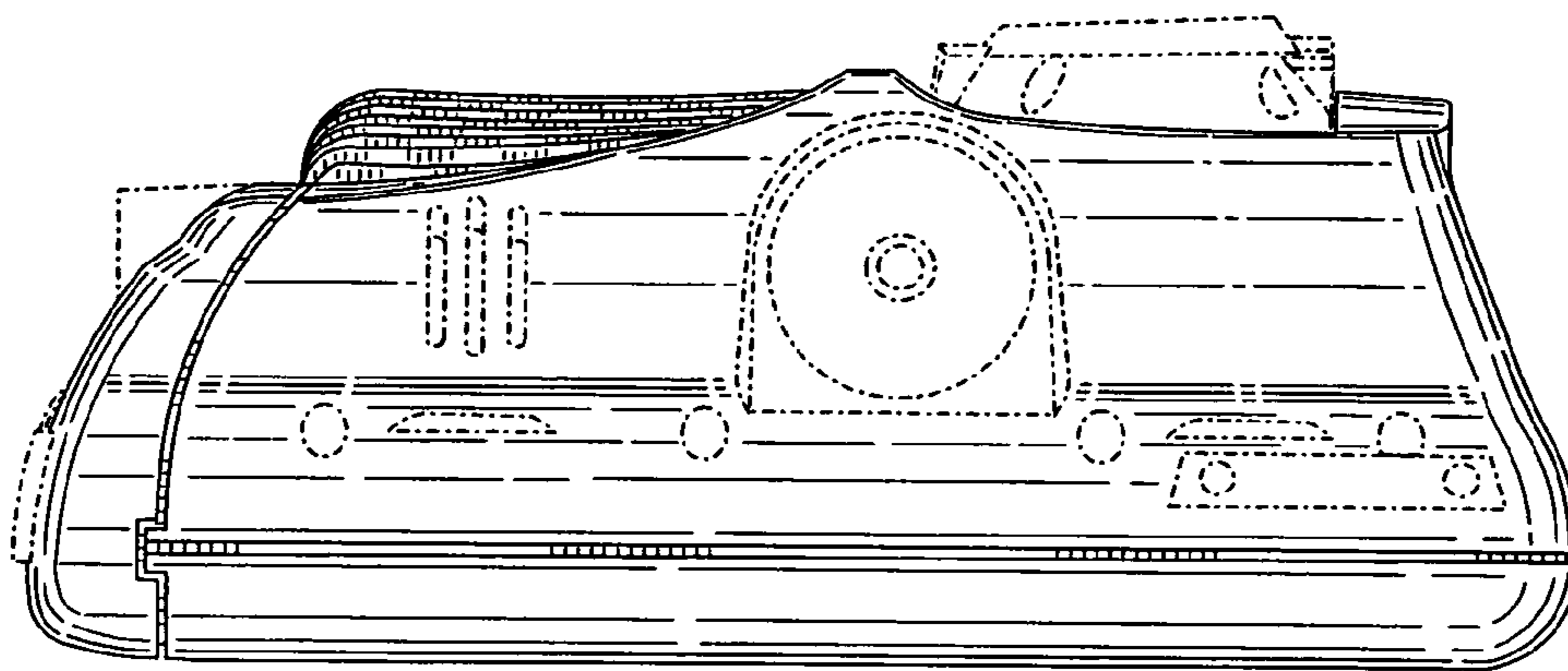

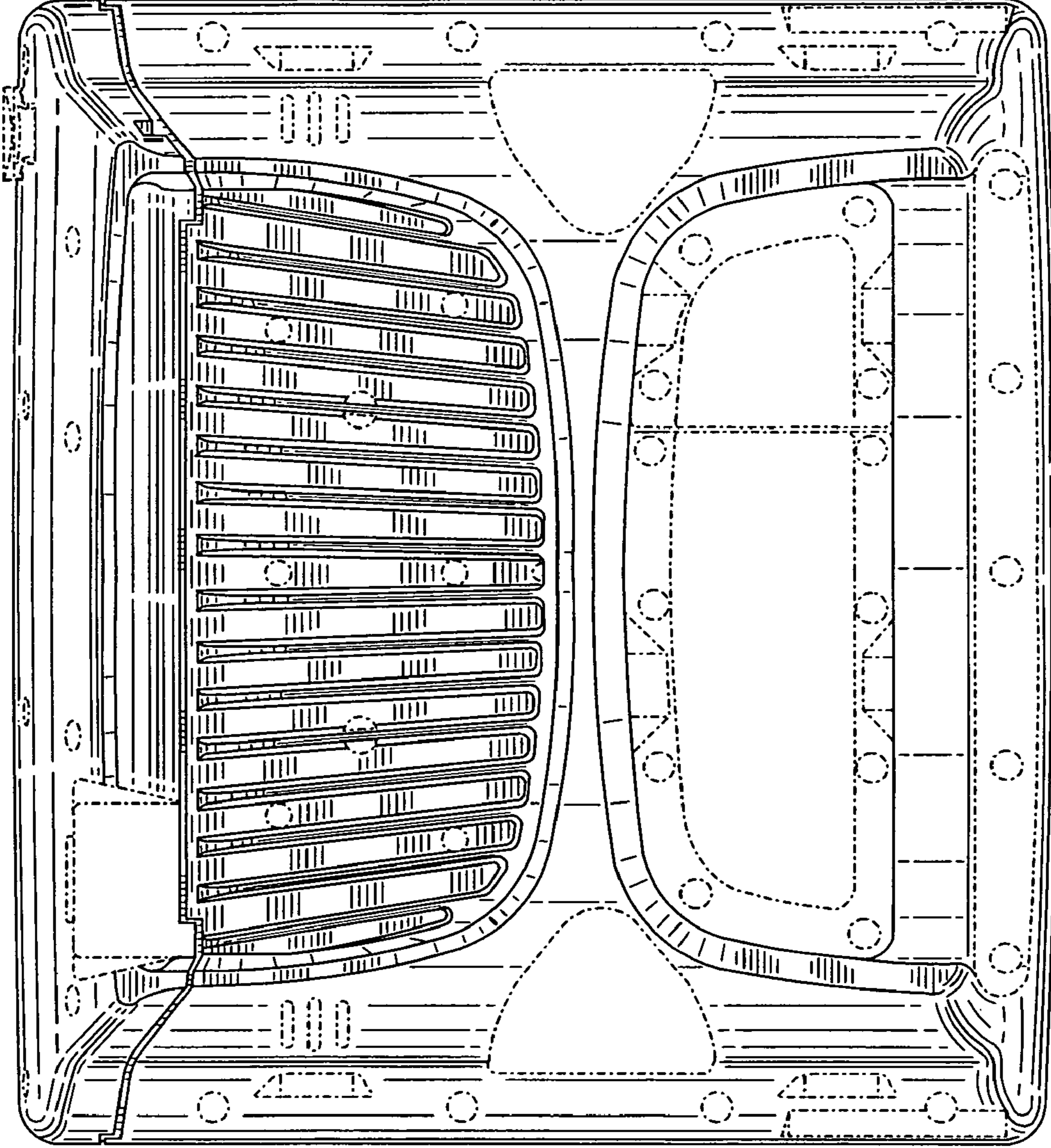

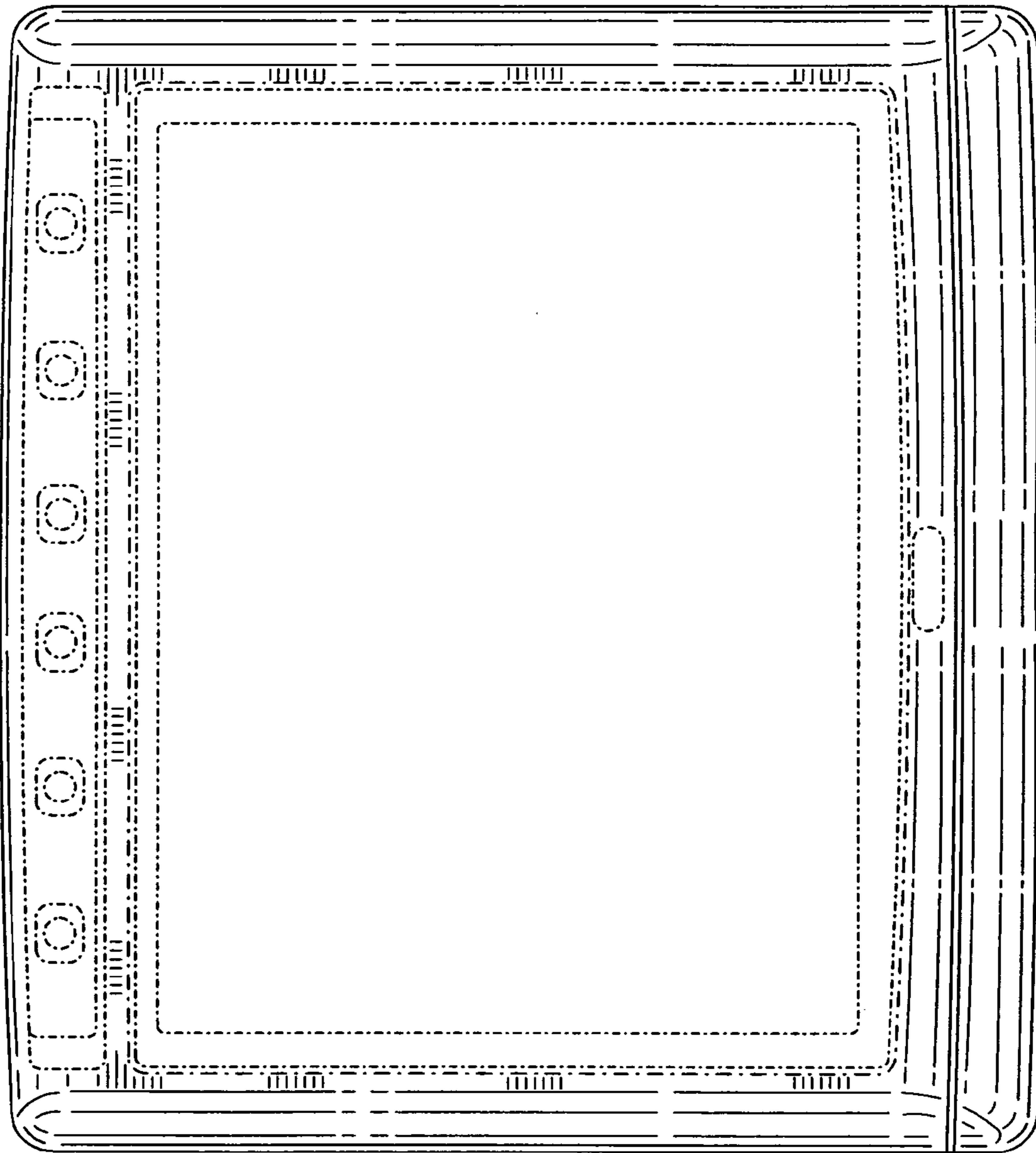

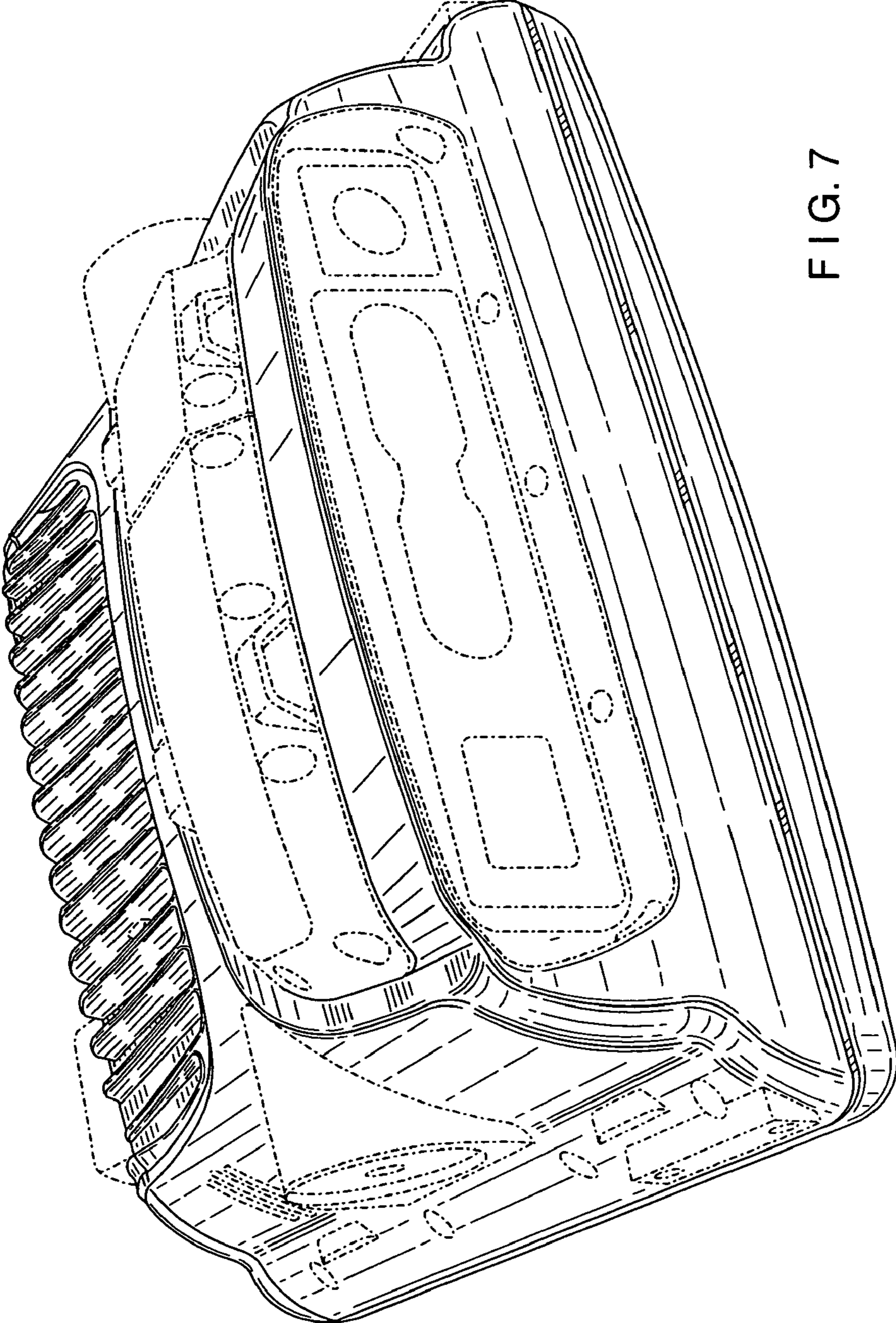

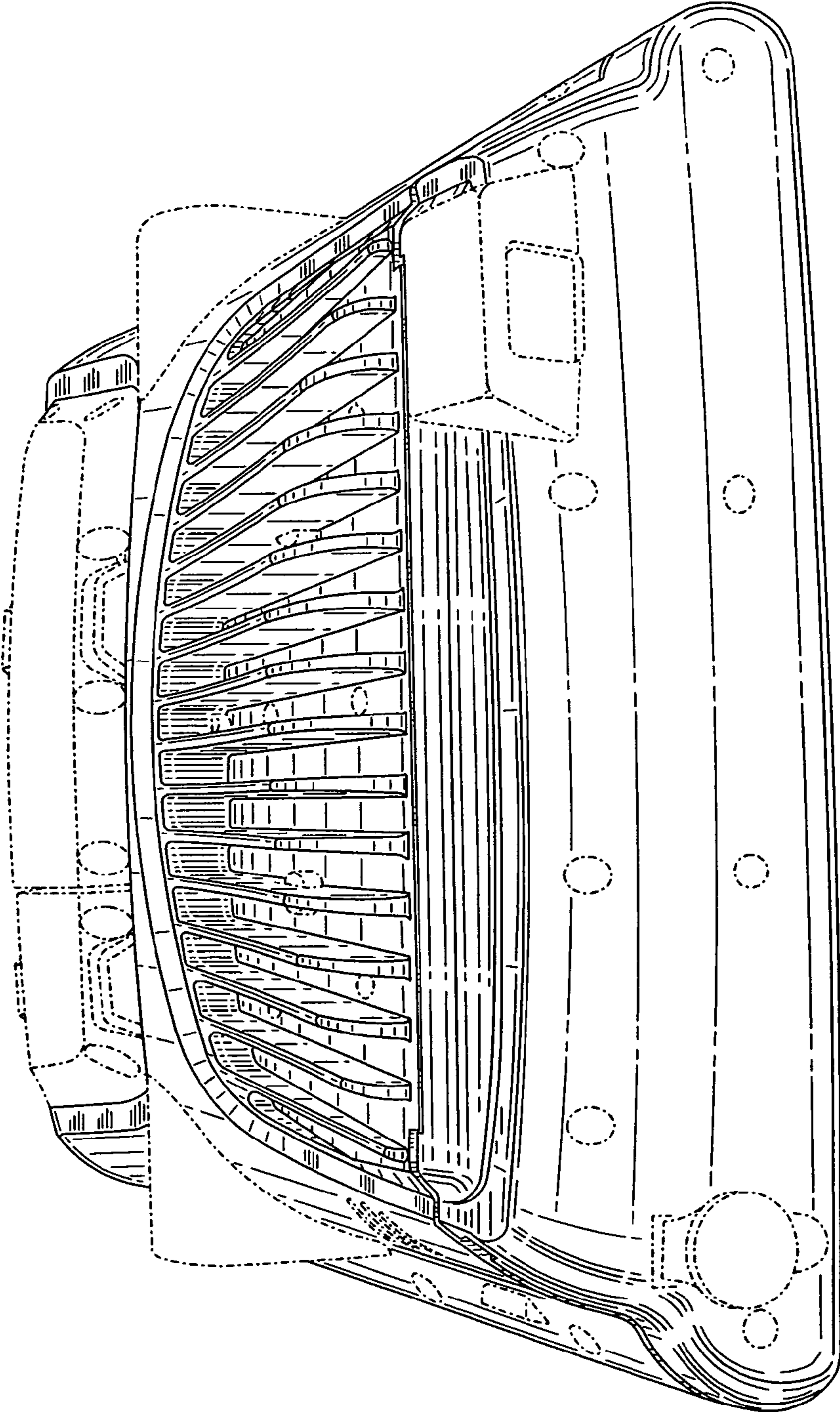
